(57) **CLAIM**

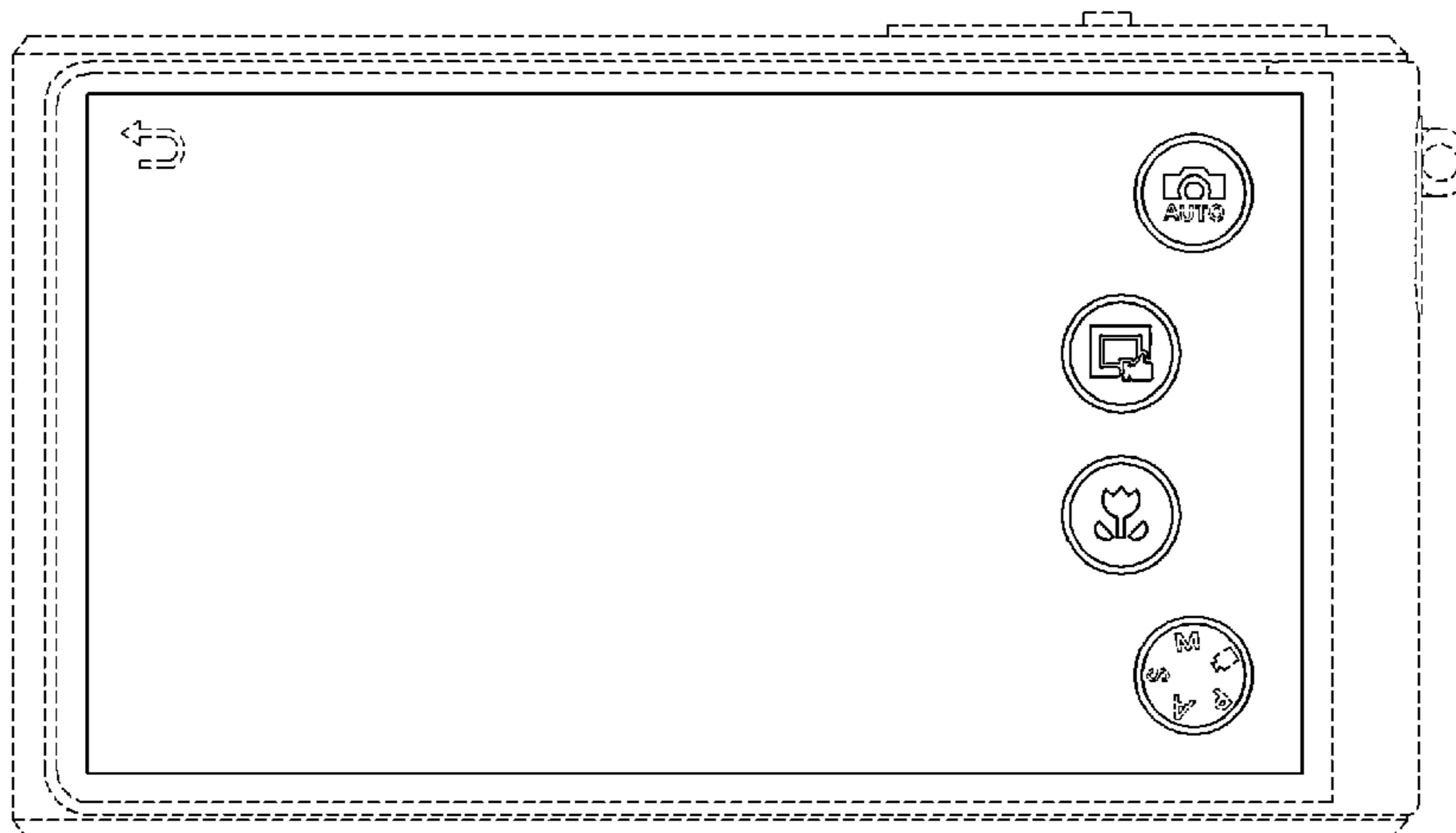
We claim the ornamental design for a digital camera with a graphical user interface, as shown and described.
