(57) **CLAIM**

I claim the ornamental design for a portable electronic device with animated GUI, as shown and described.

DESCRIPTION

FIG. 1 is the first image in a sequence for a portable electronic device with animated GUI, showing our new design; FIG. 2 is a second image thereof; FIG. 3 is a third image thereof; and, FIG. 4 is a fourth image thereof. The broken lines shown in the figures, including the symbols, letters, and numbers, are for the purpose of illustrating portions of the article, and form no part of the claimed design.

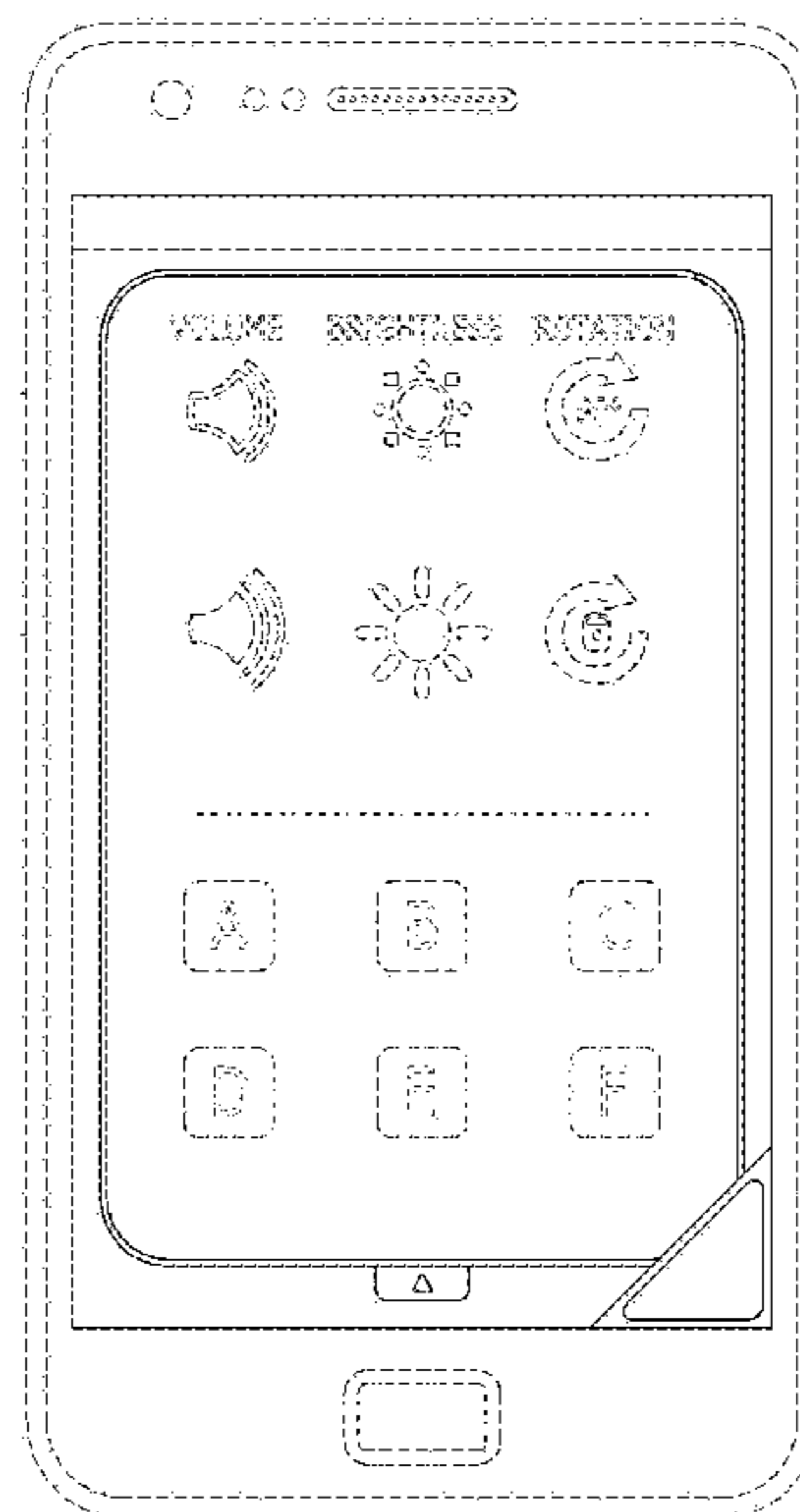
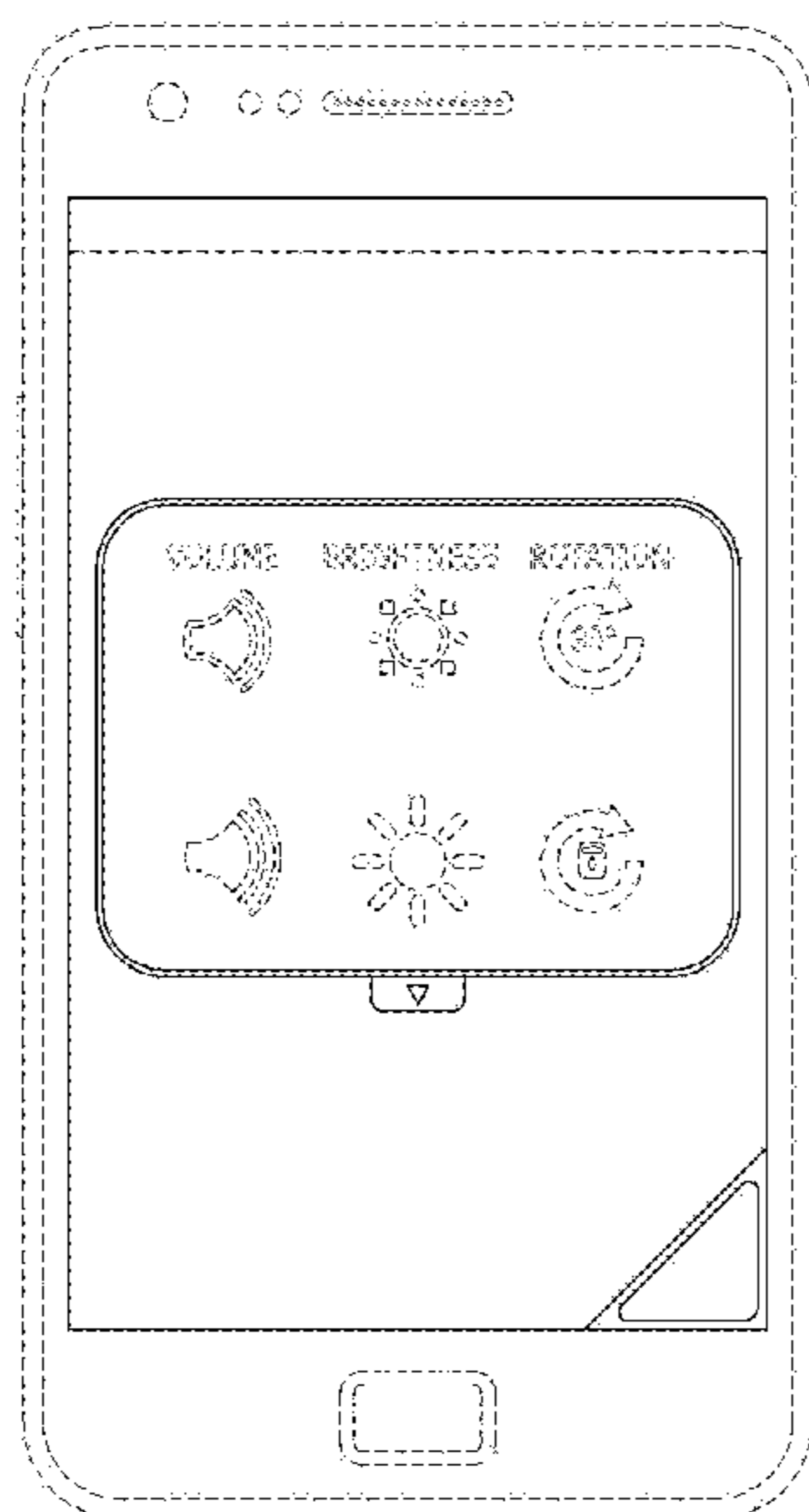

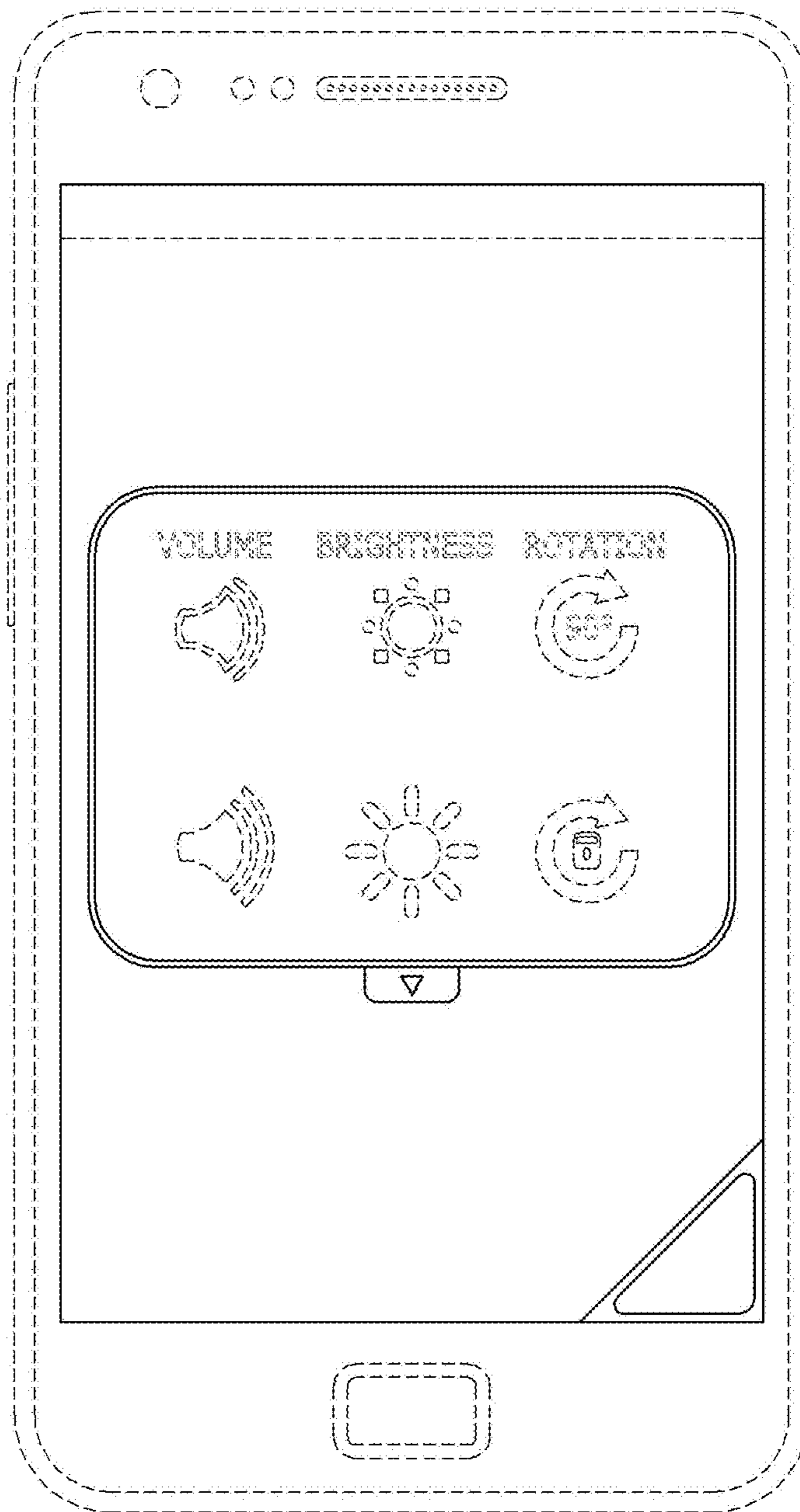

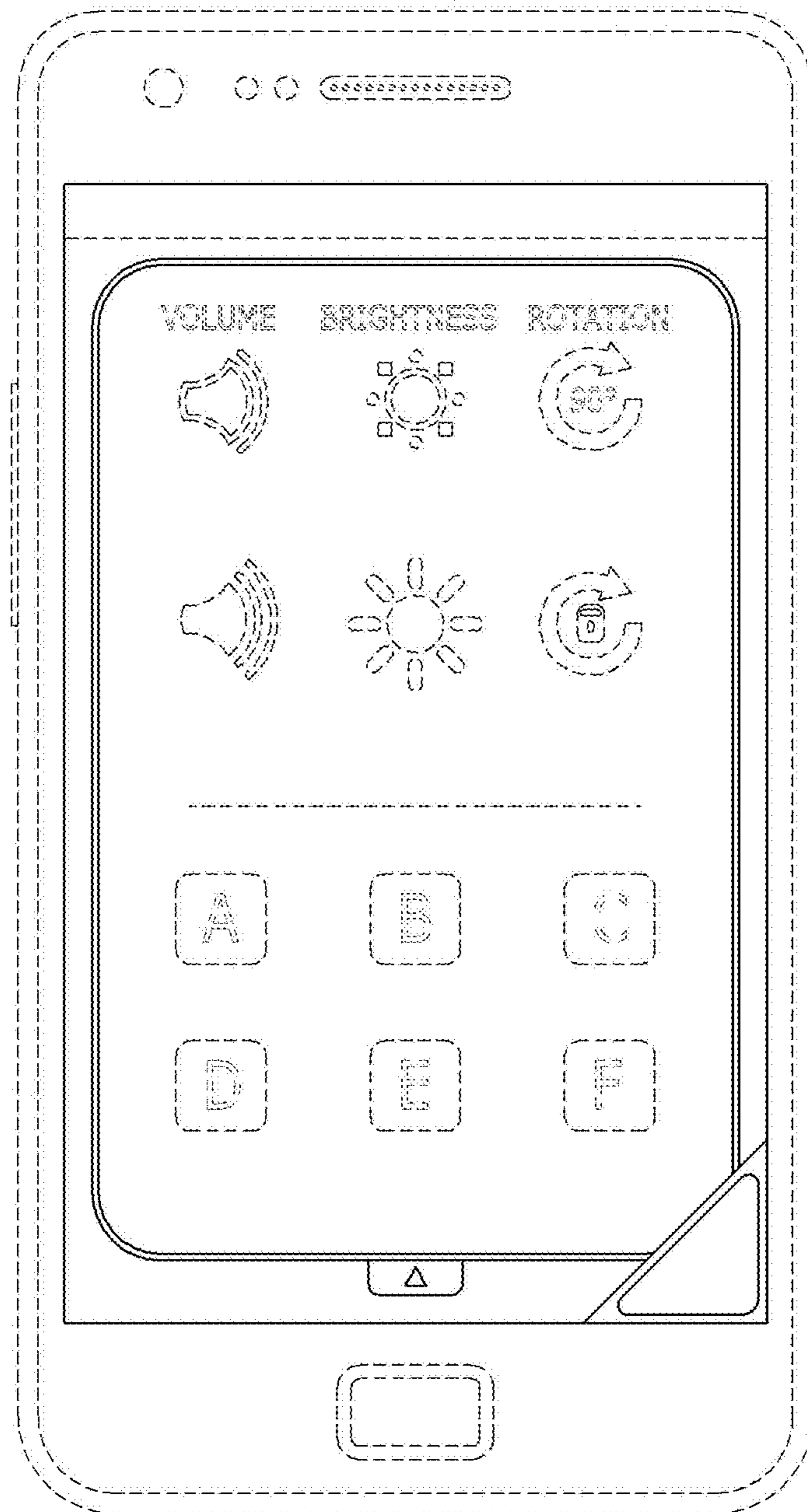

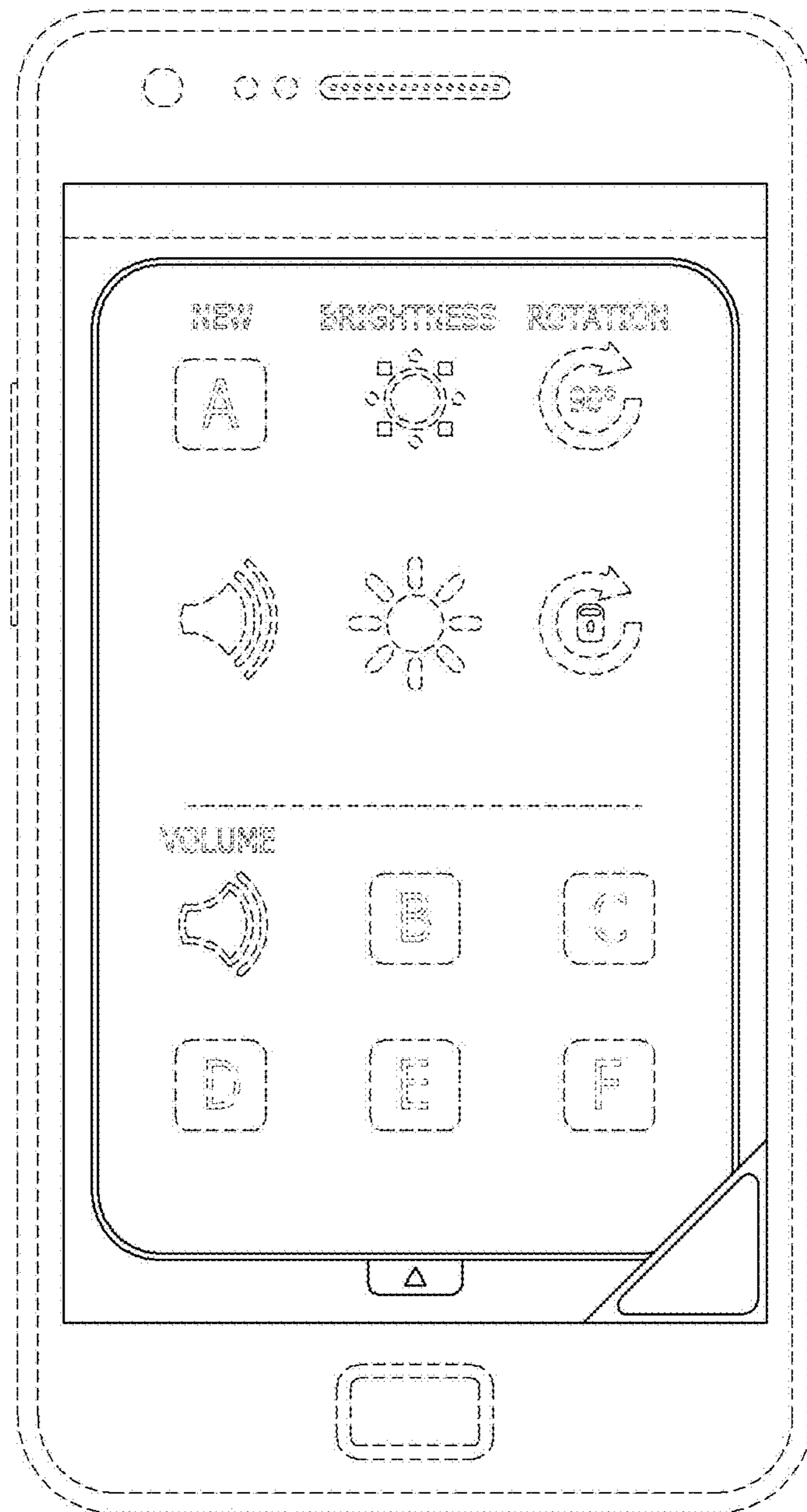
