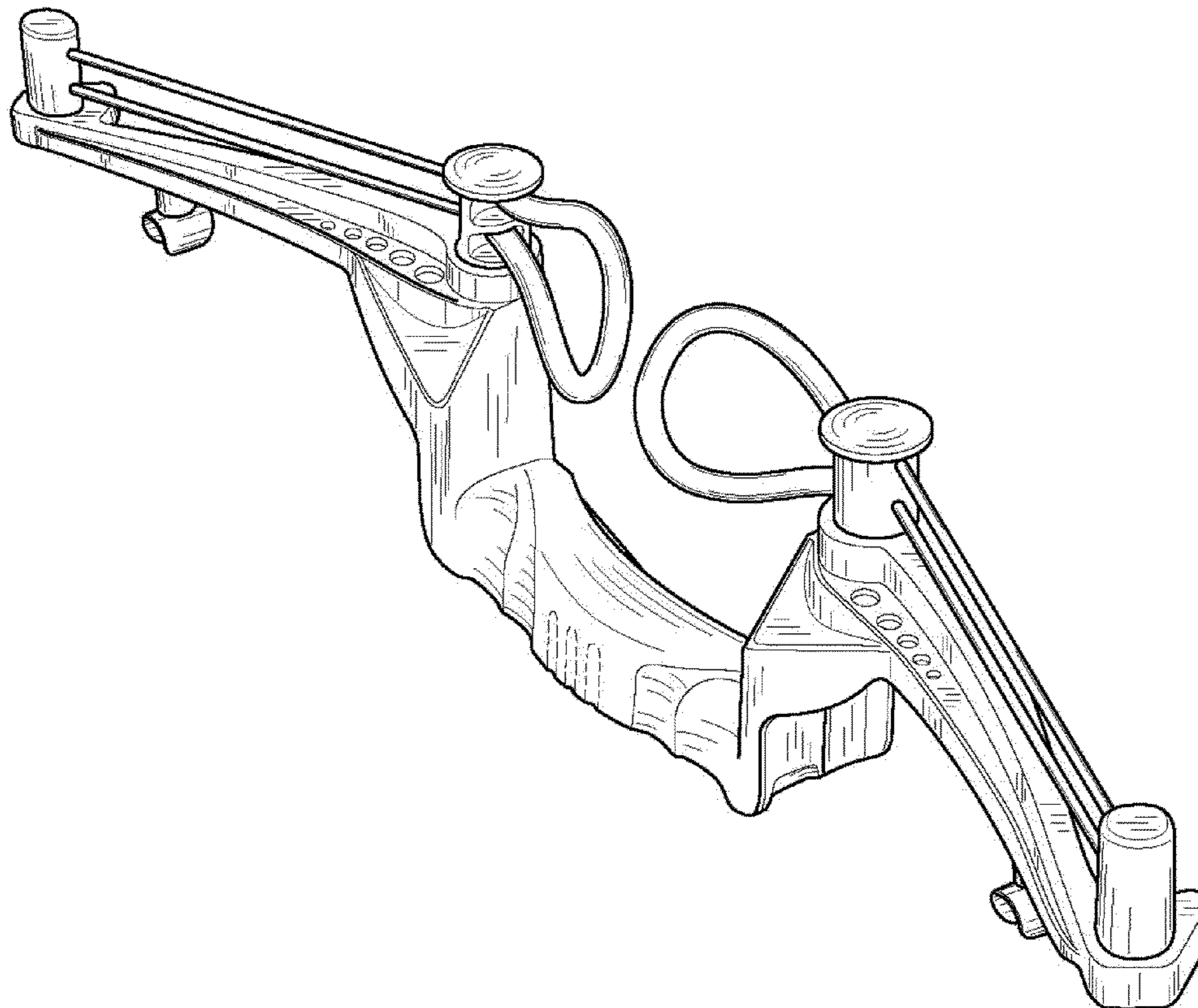
(57) **CLAIM**

The ornamental design for an elastic band toy launcher with bow configuration, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an elastic band toy launcher with bow configuration;
FIG. 2 is a rear view thereof;

FIG. 4 is a top view, the bottom view being a mirror image thereof;

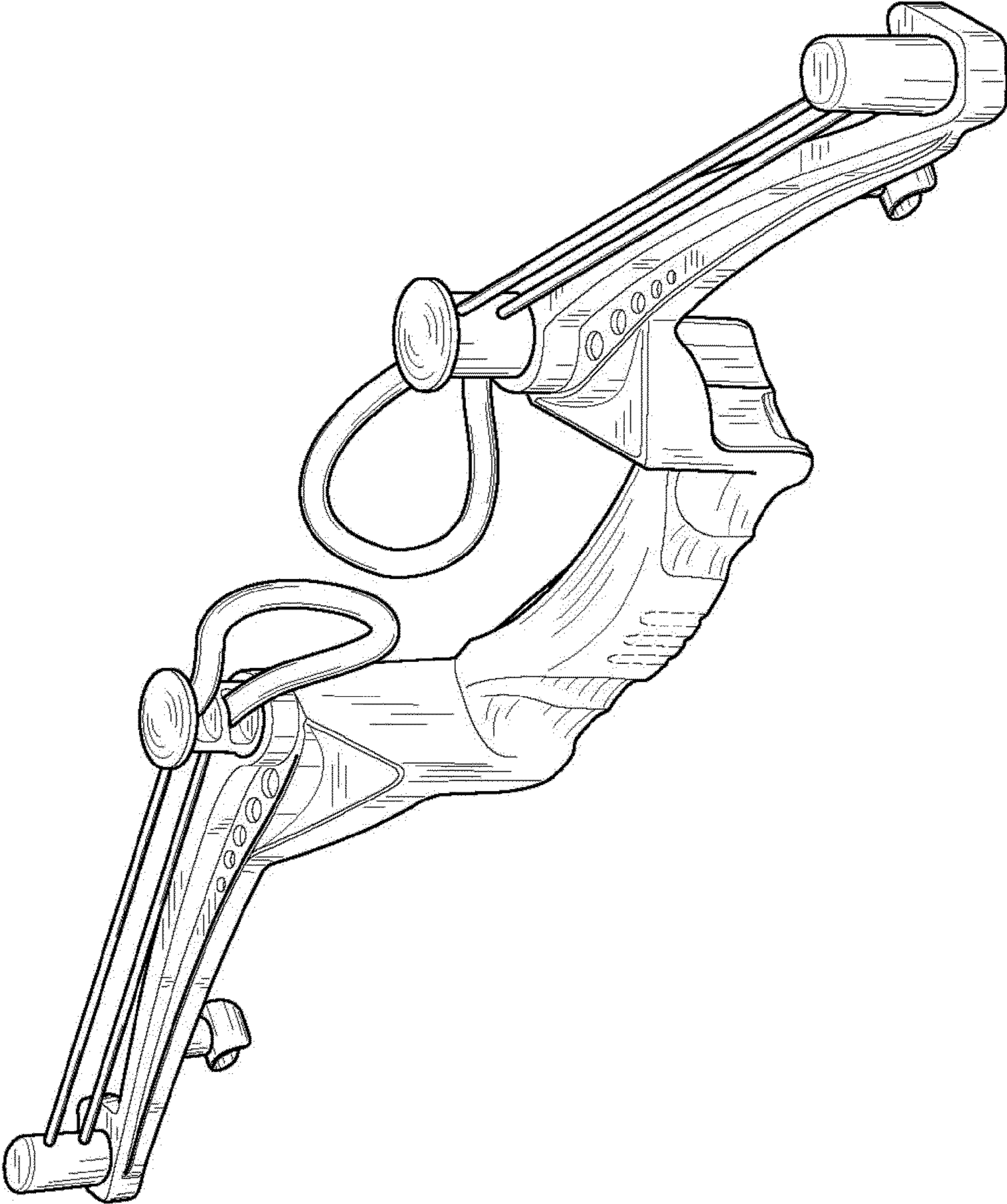

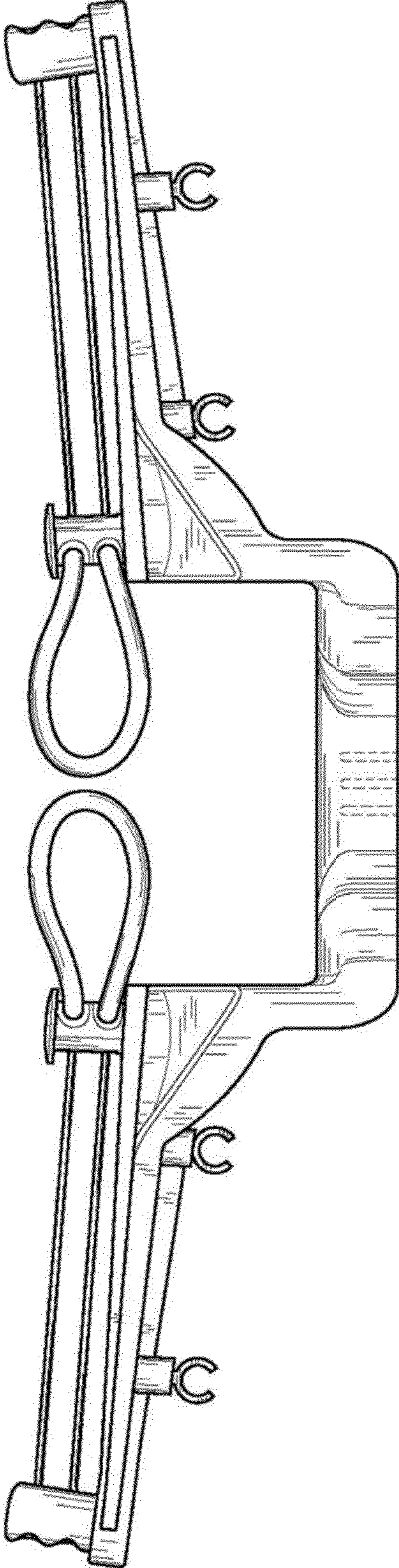

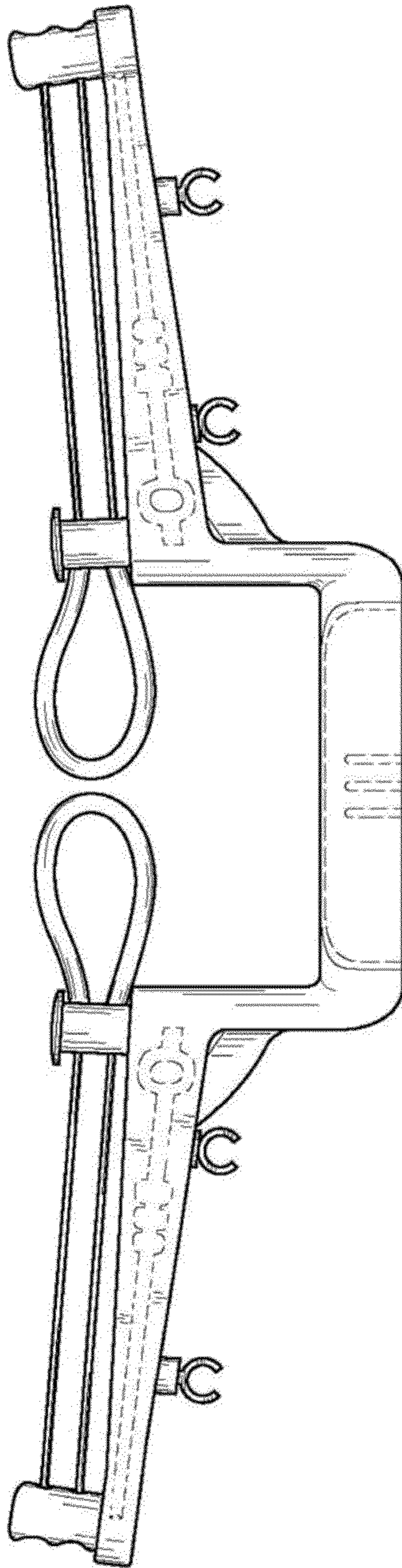

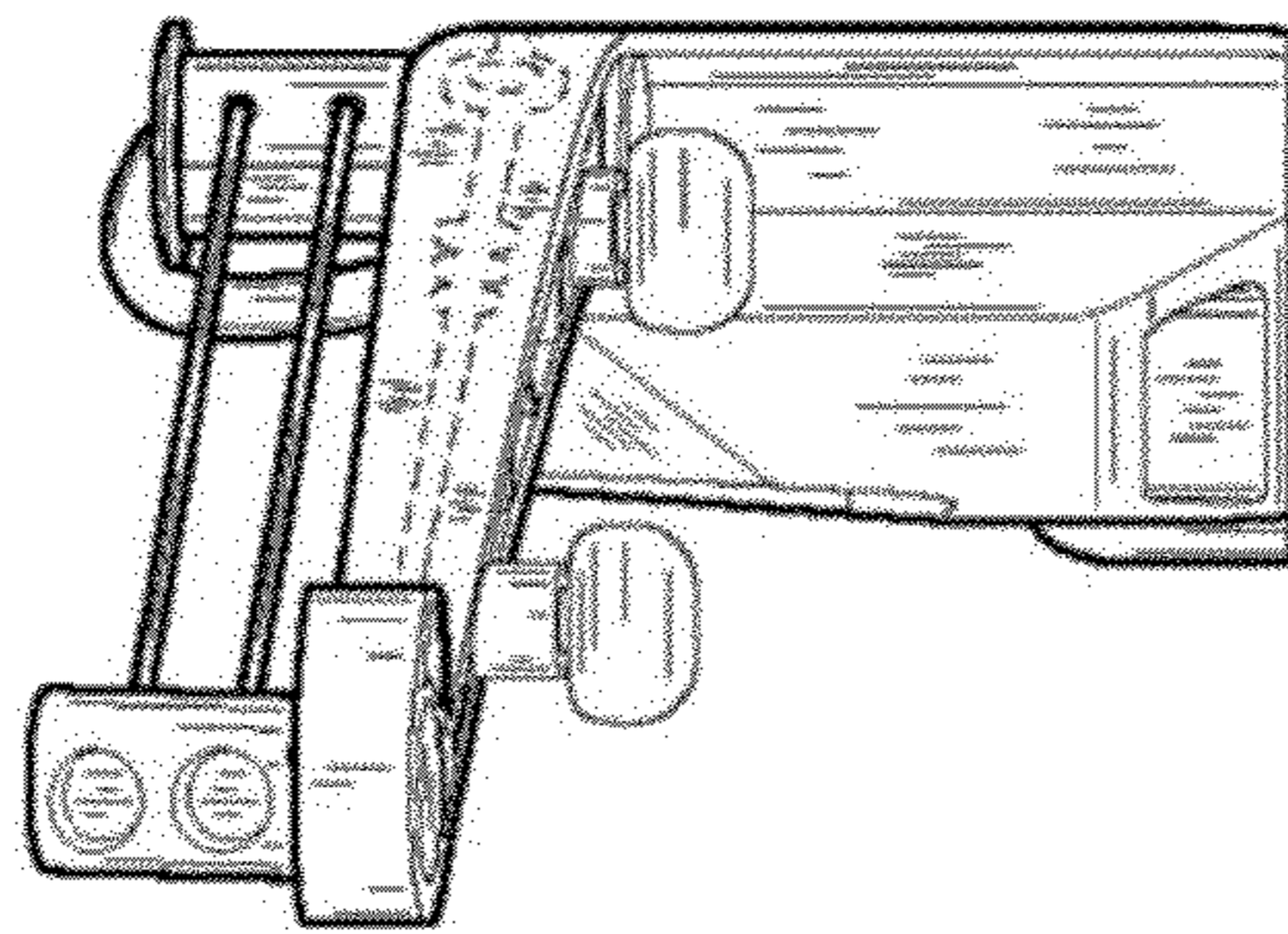

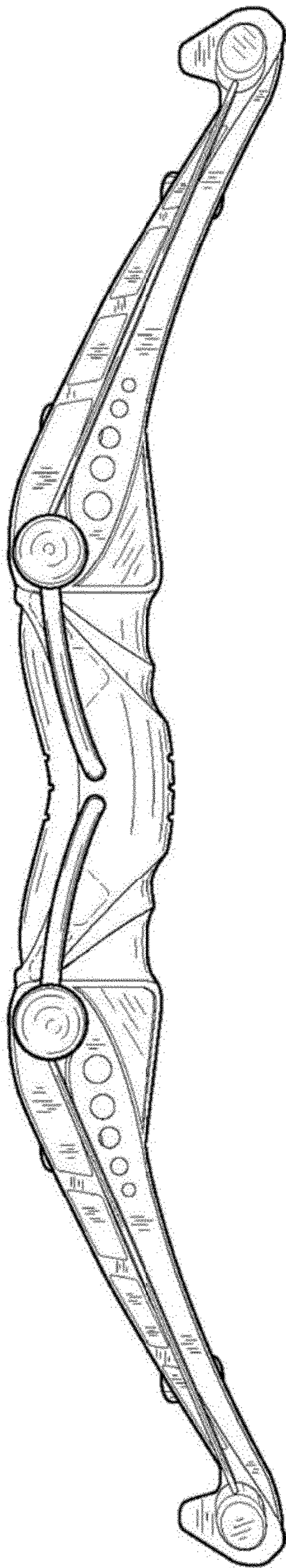

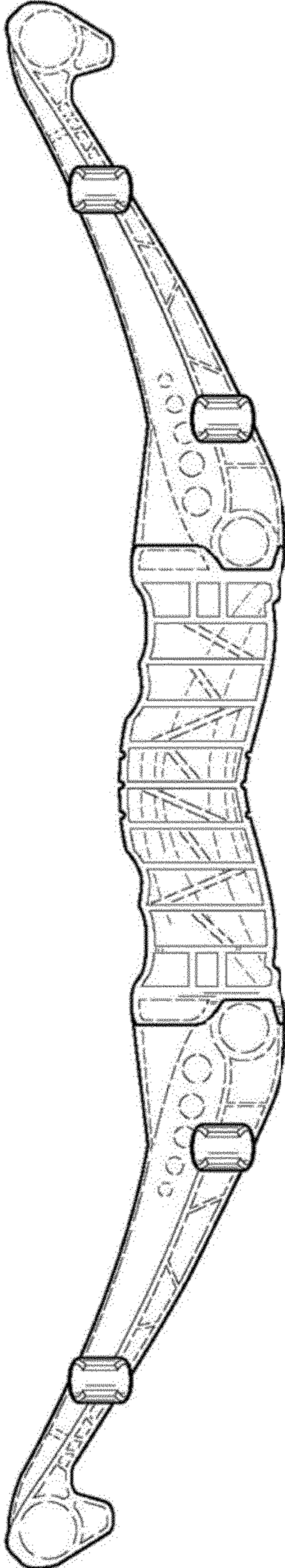
