FIG. 10 is a bottom view of the resistance trainer of FIG. 8;

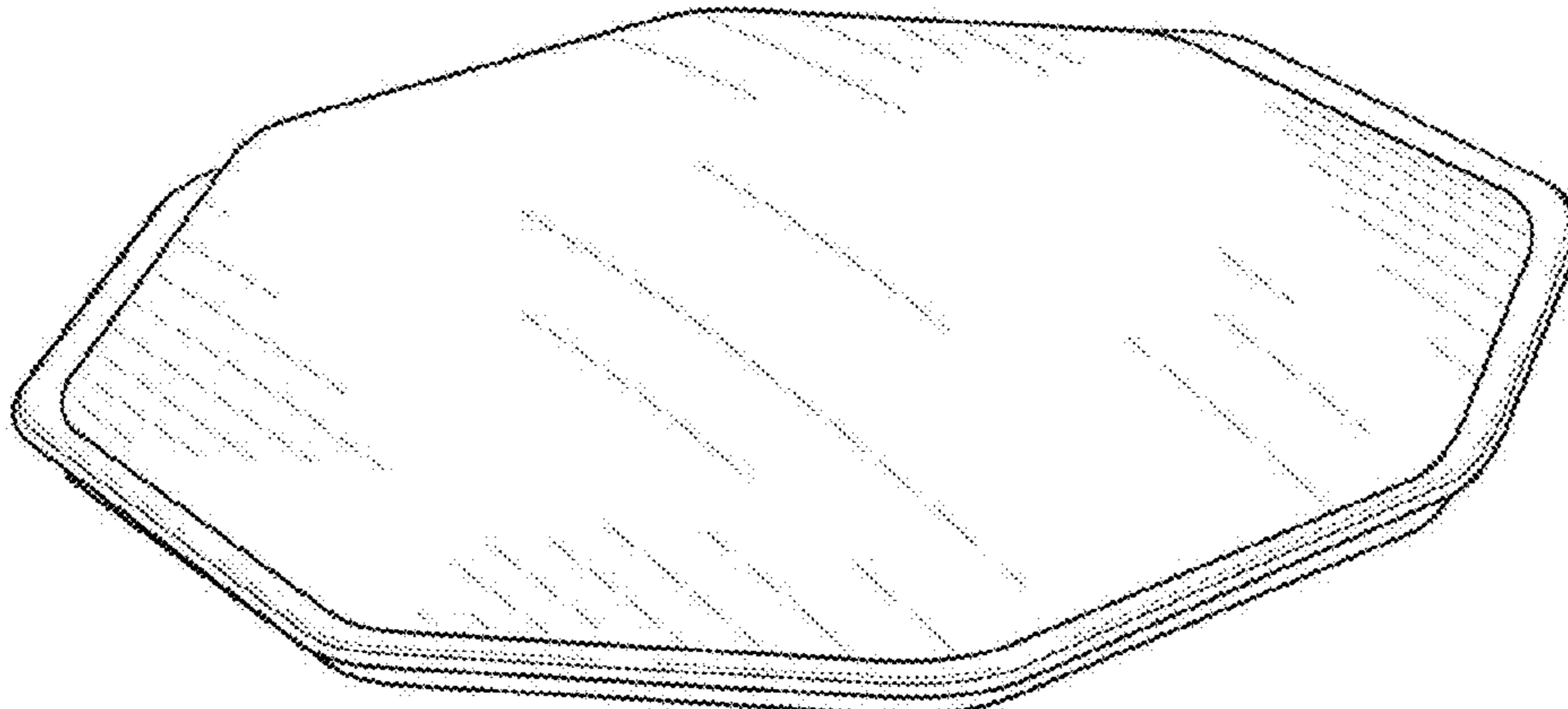
FIG. 11 is a side view of the resistance trainer of FIG. 8;

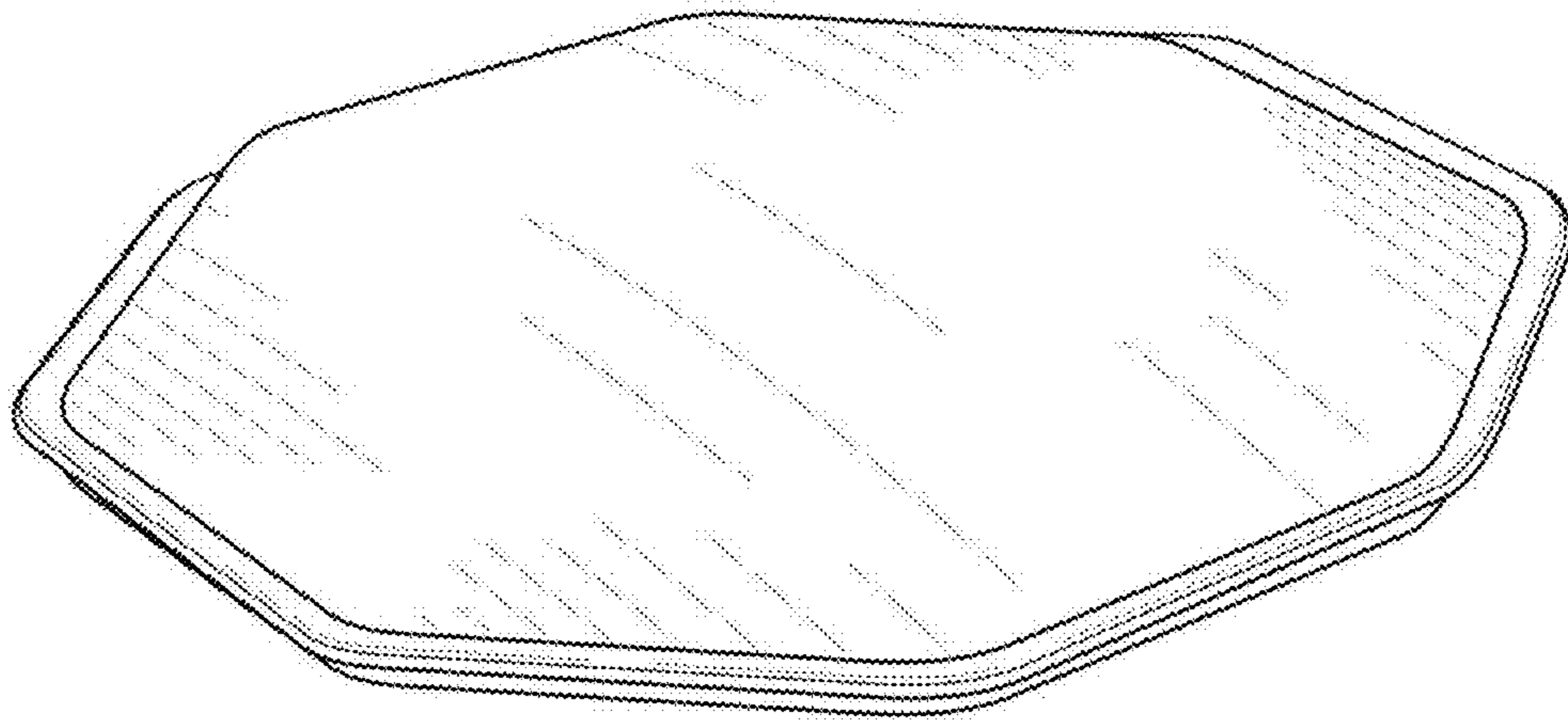

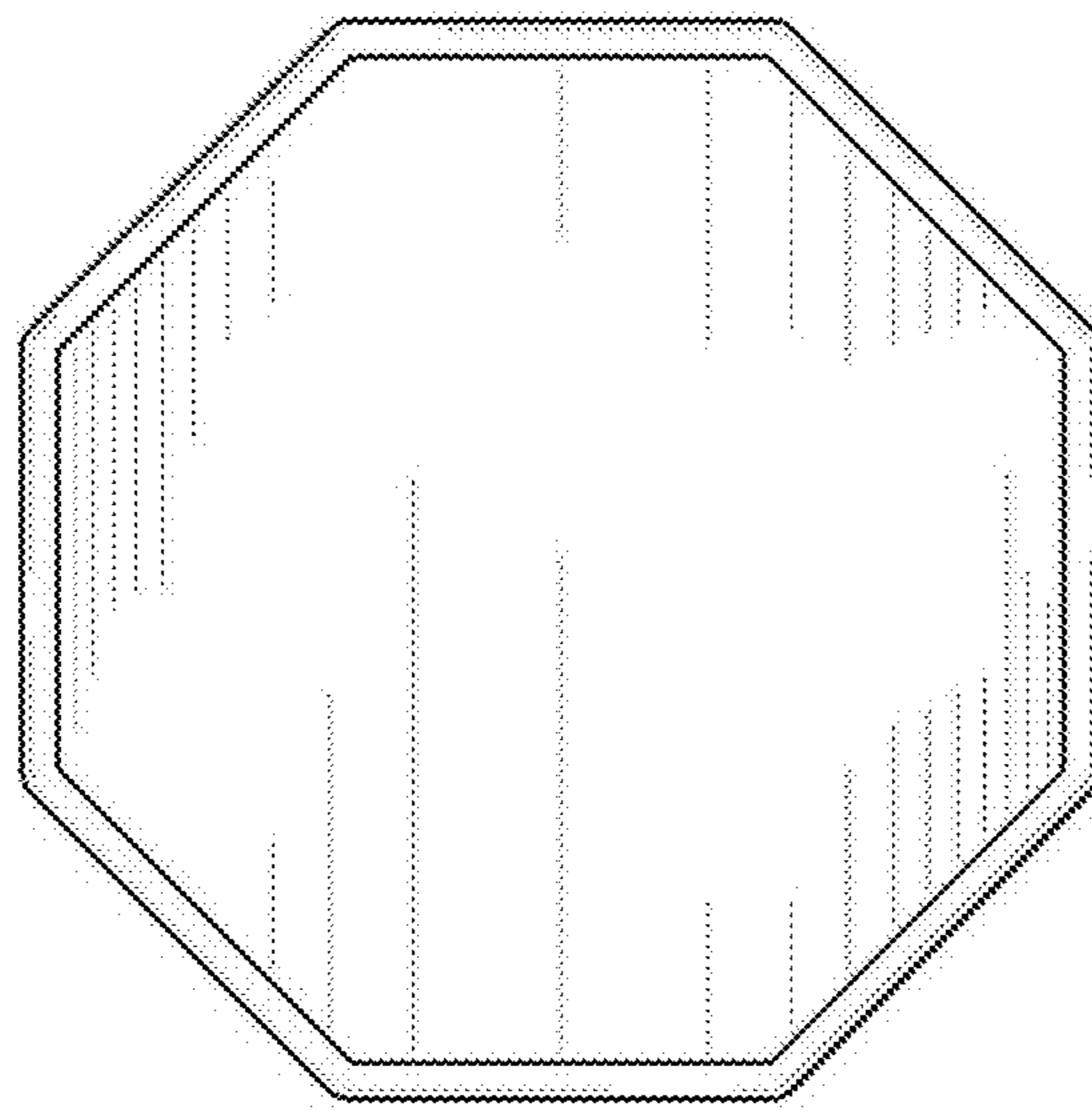

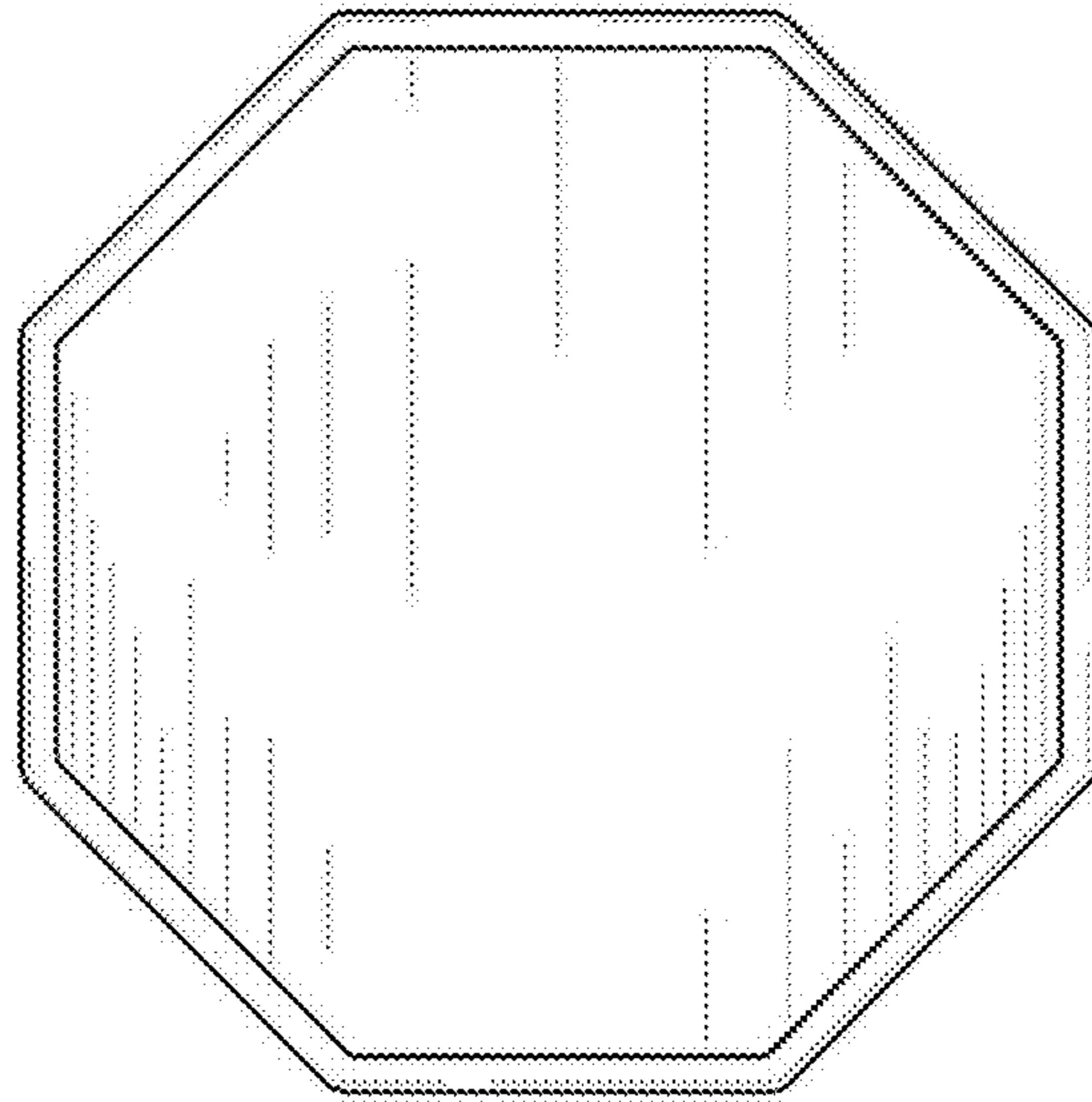
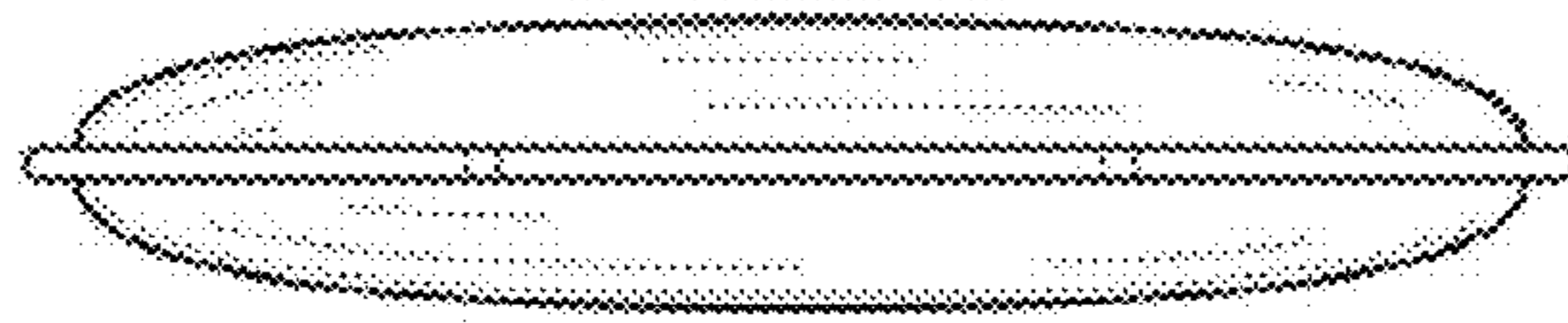

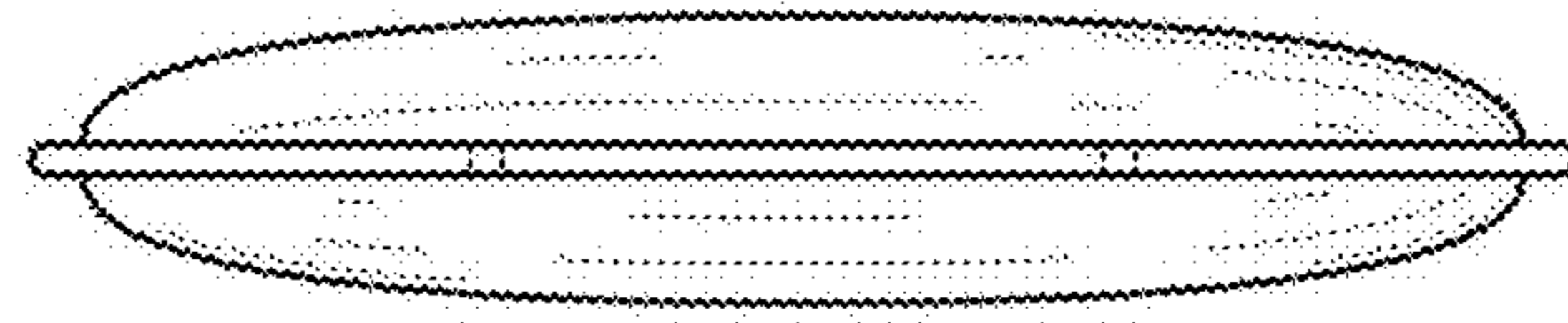
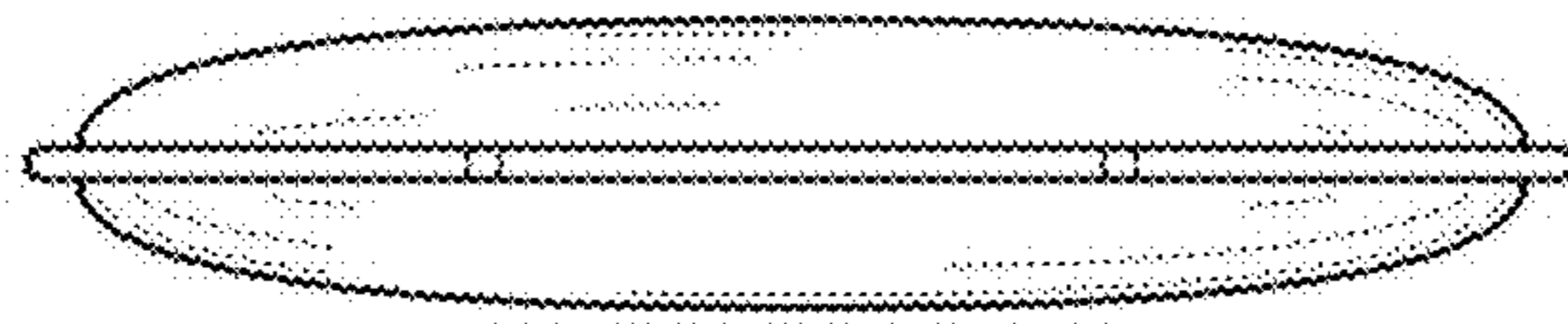

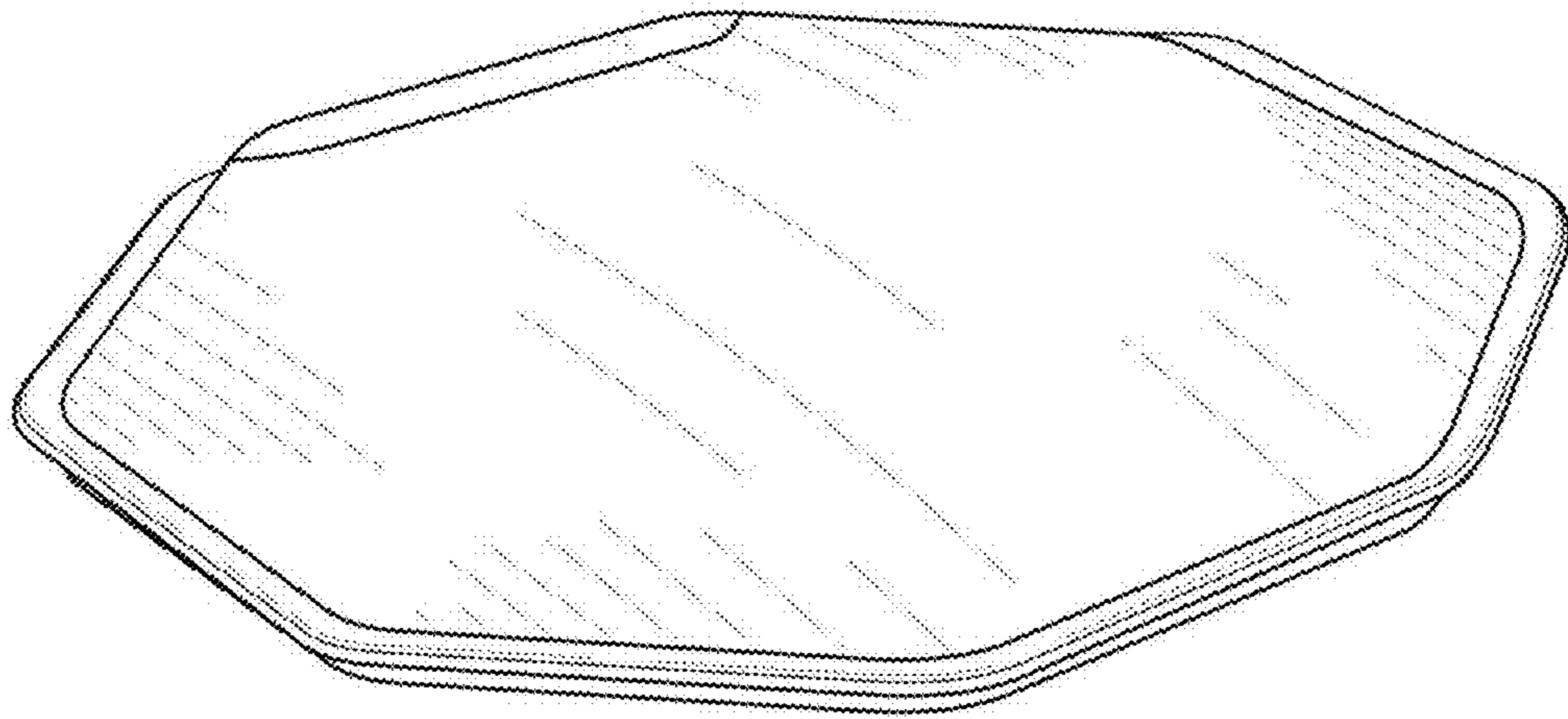

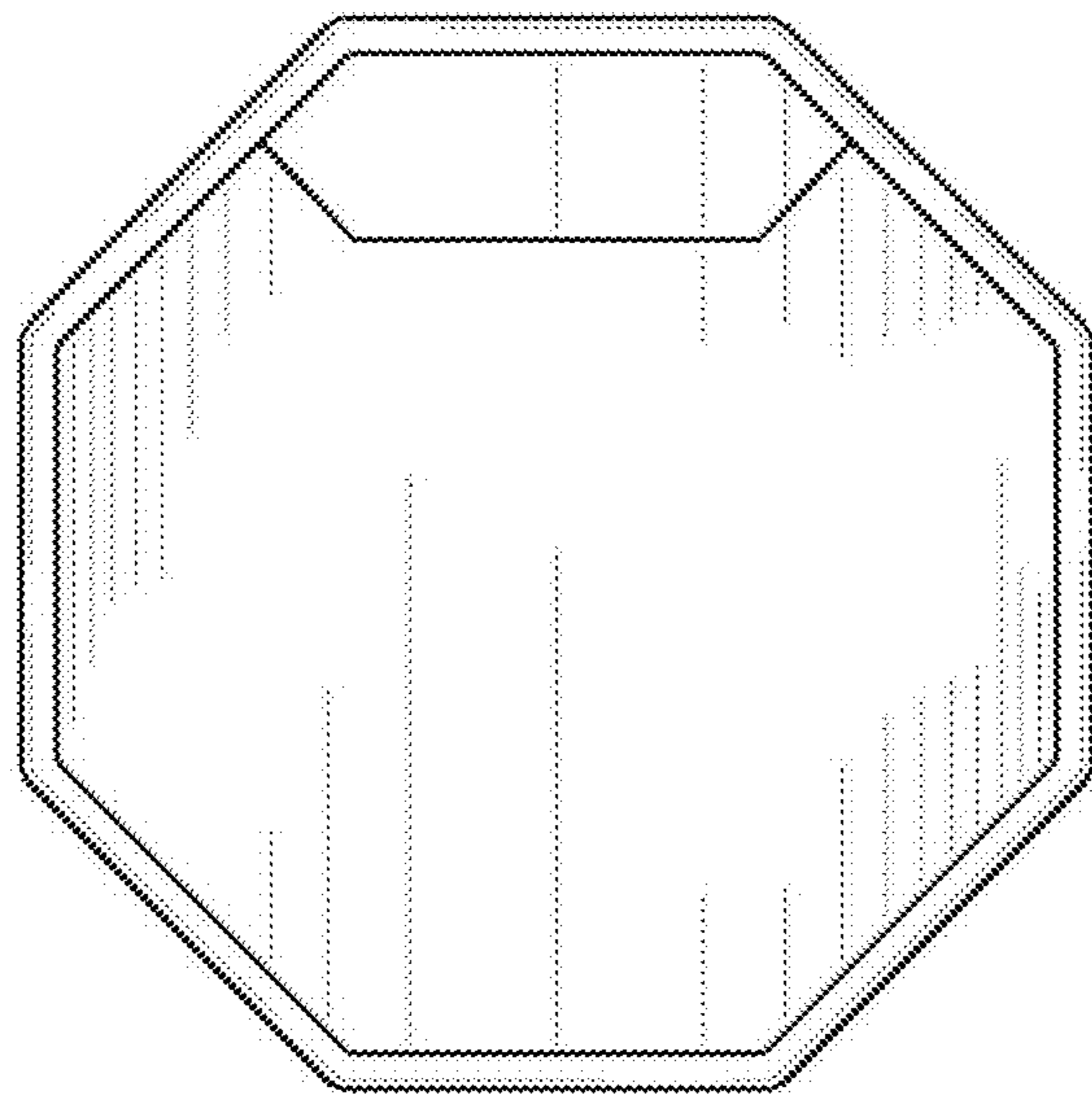
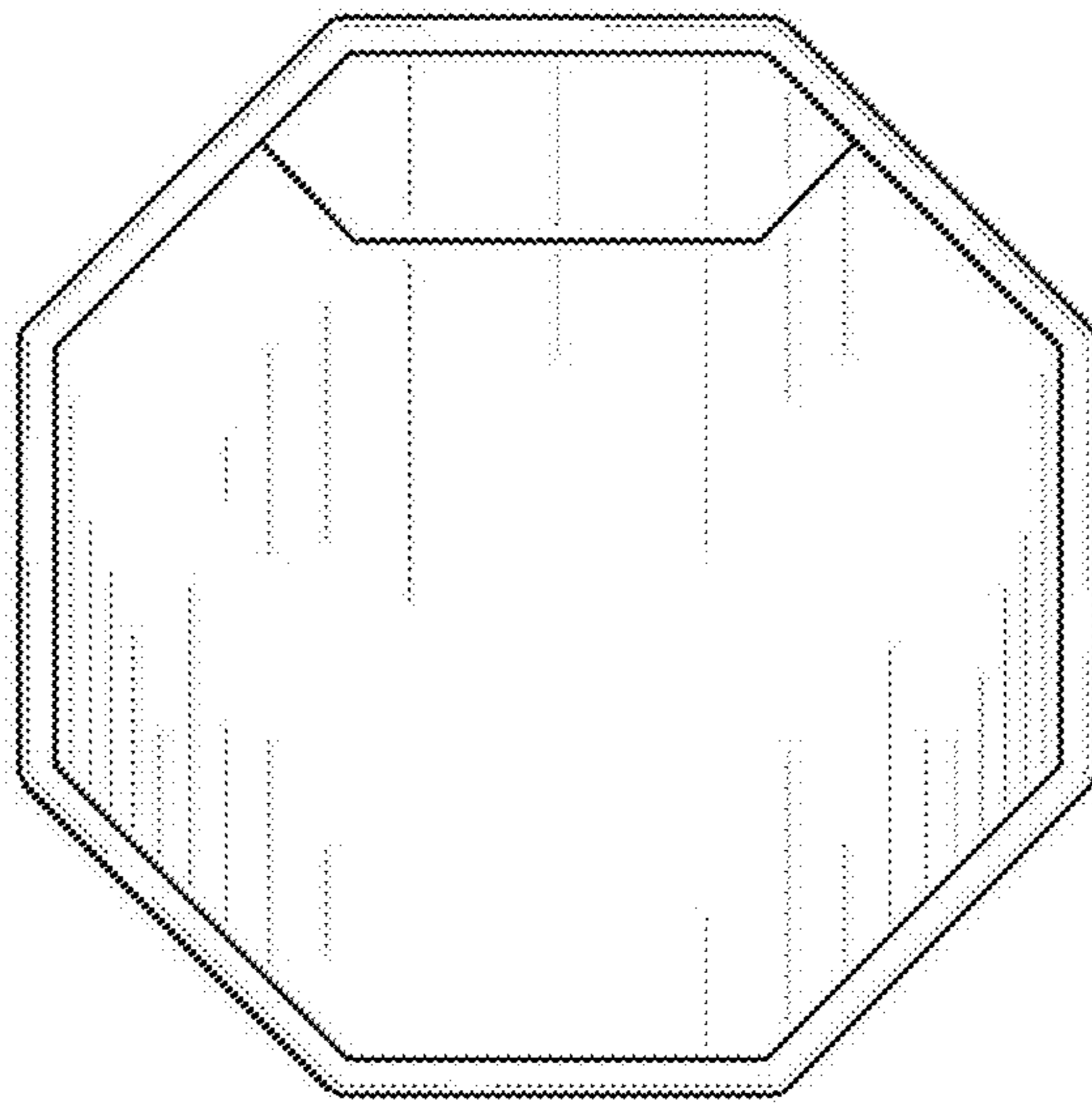

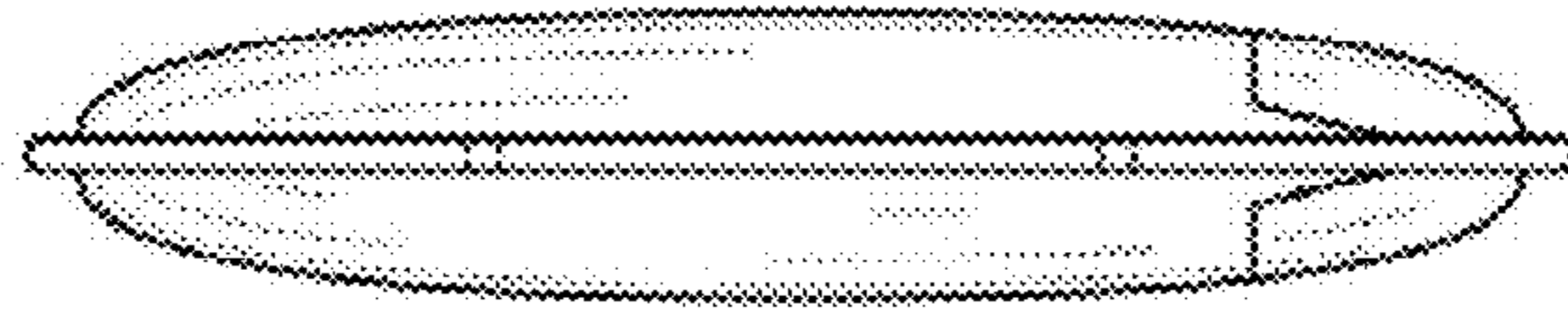

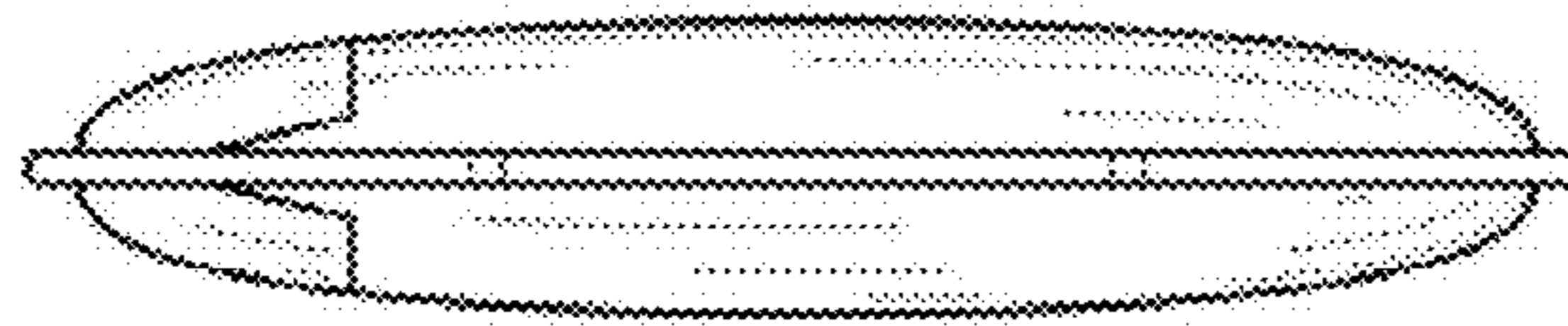
