FIG. 1 is a perspective view of the practice ball showing our new design;

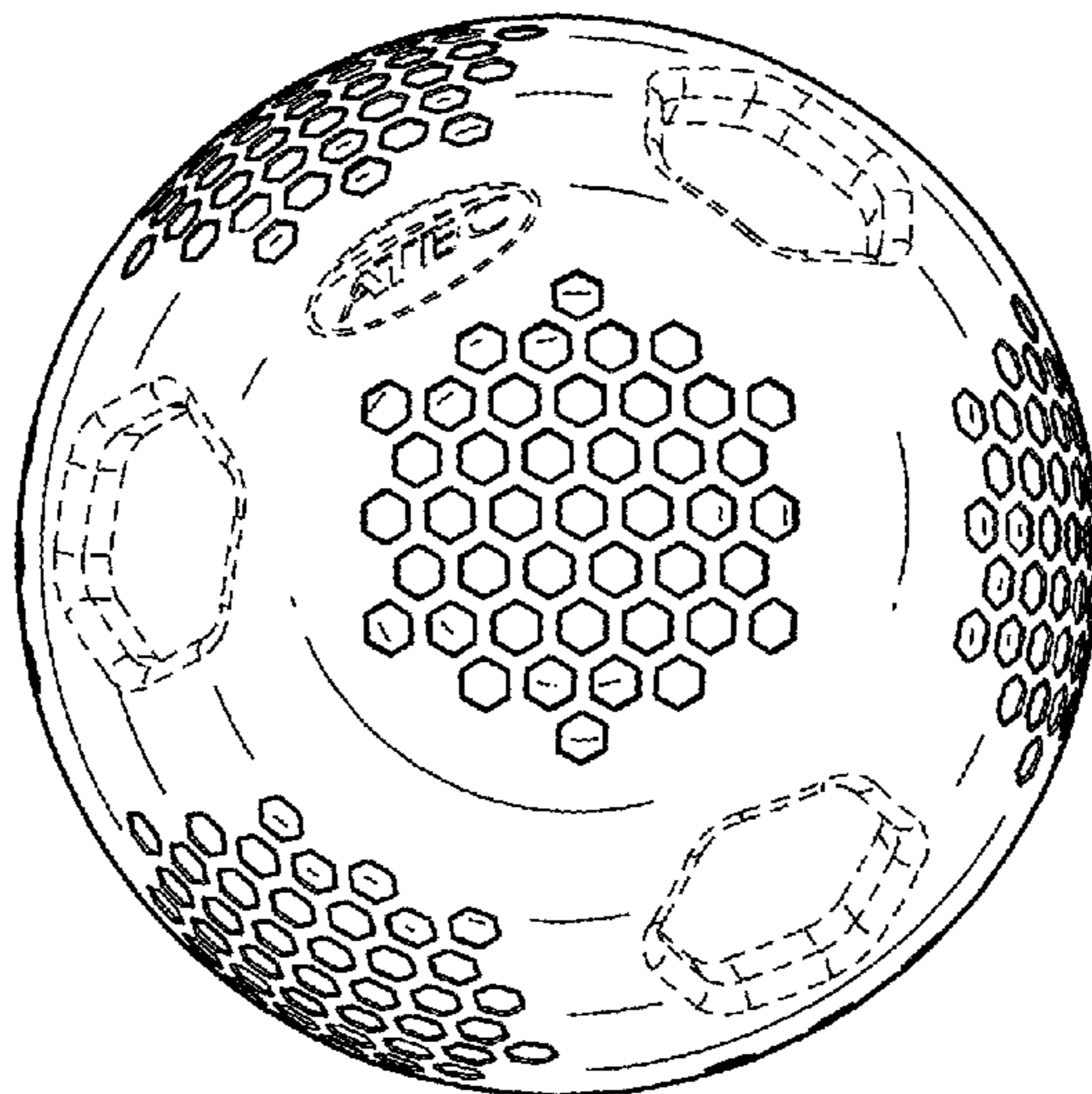
FIG. 2 is a side view thereof;

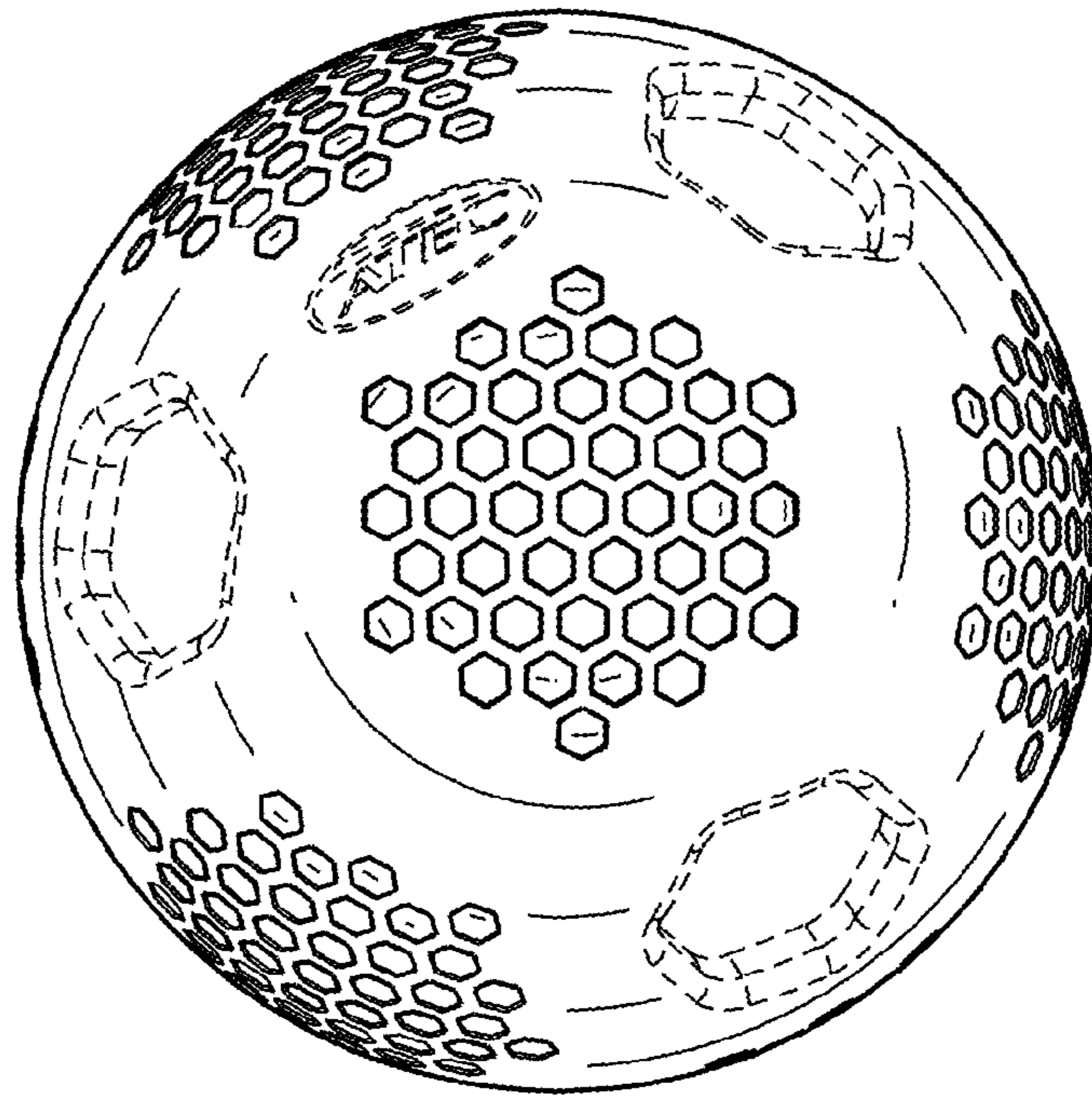

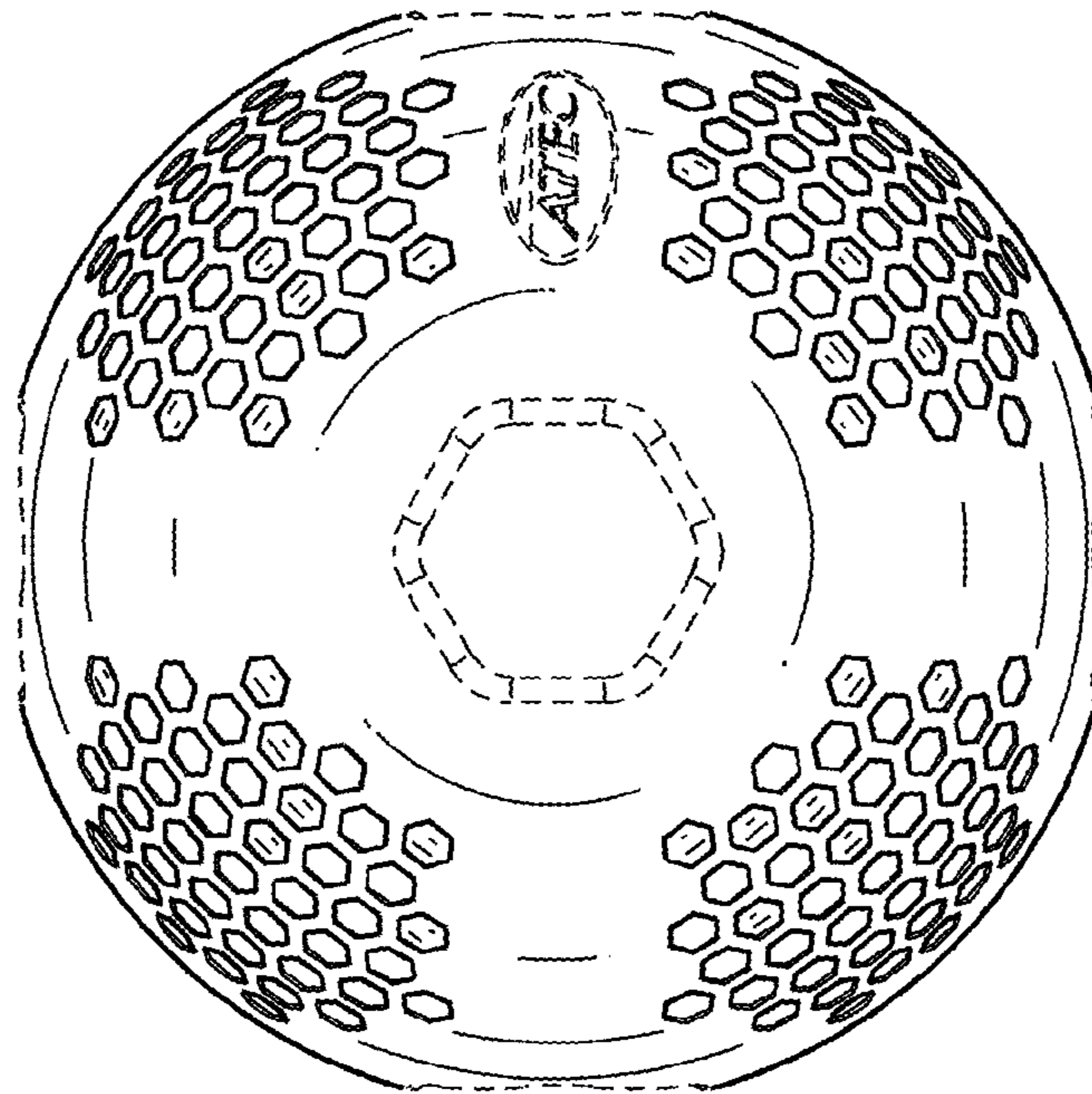

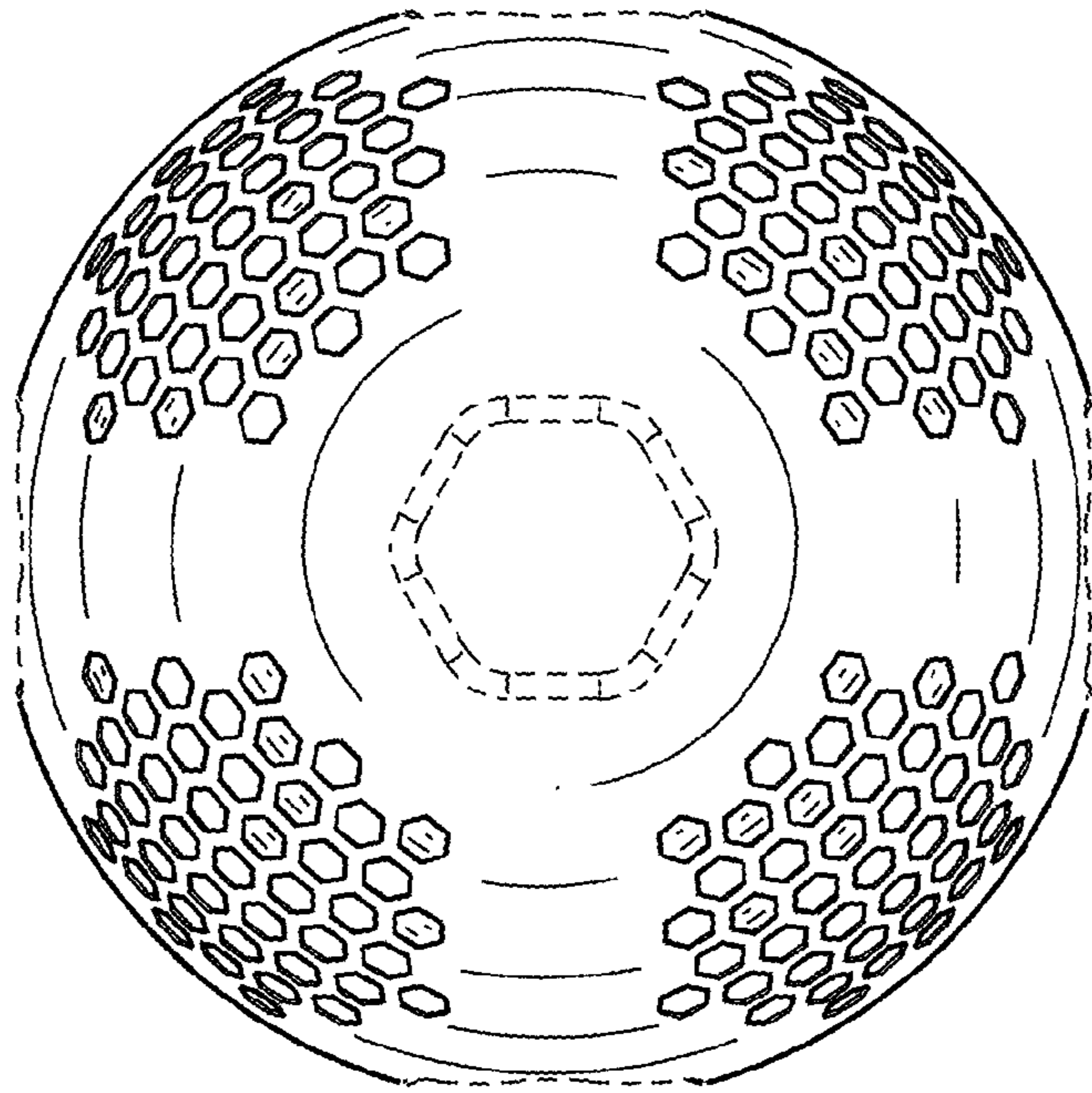

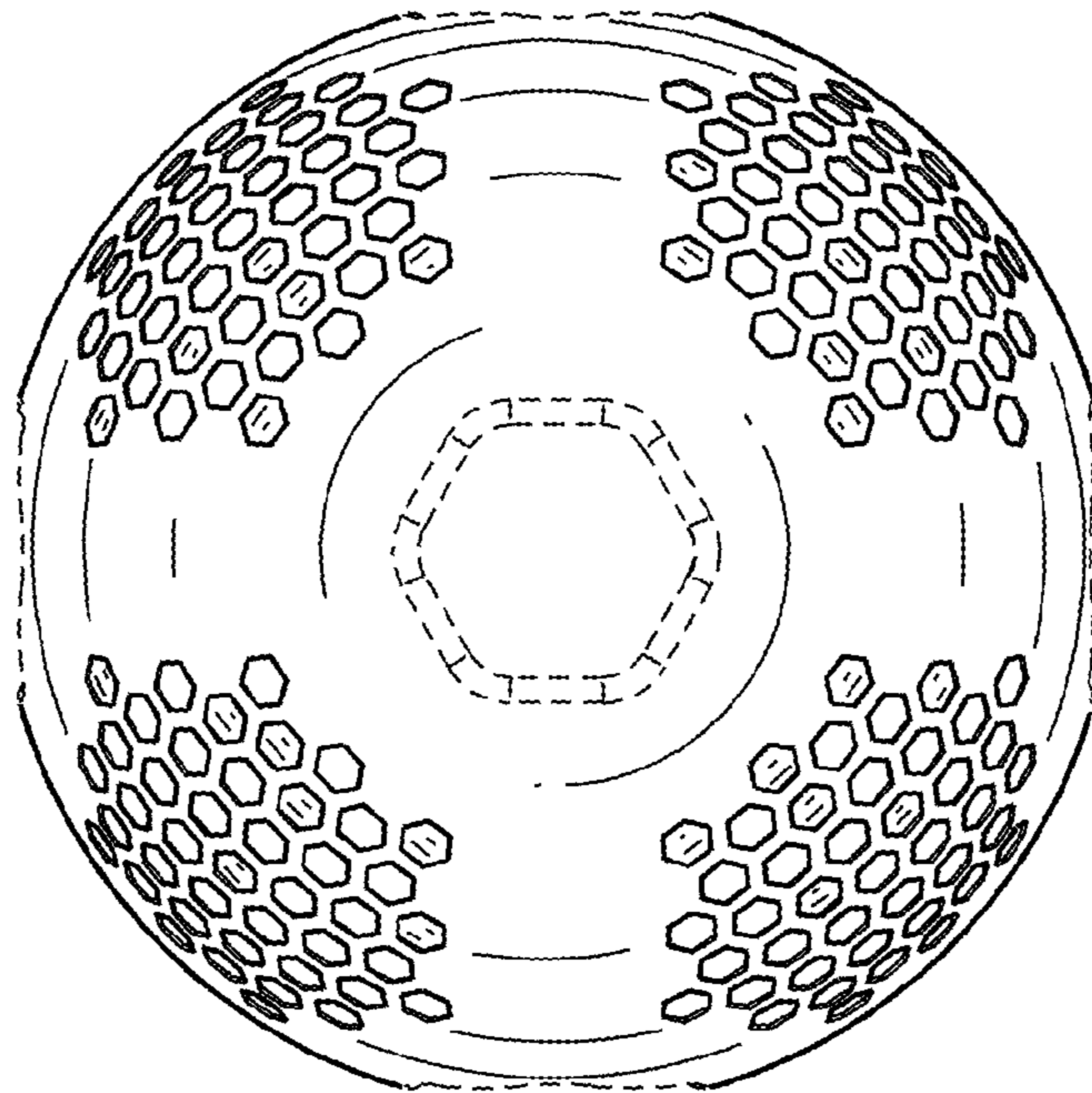
