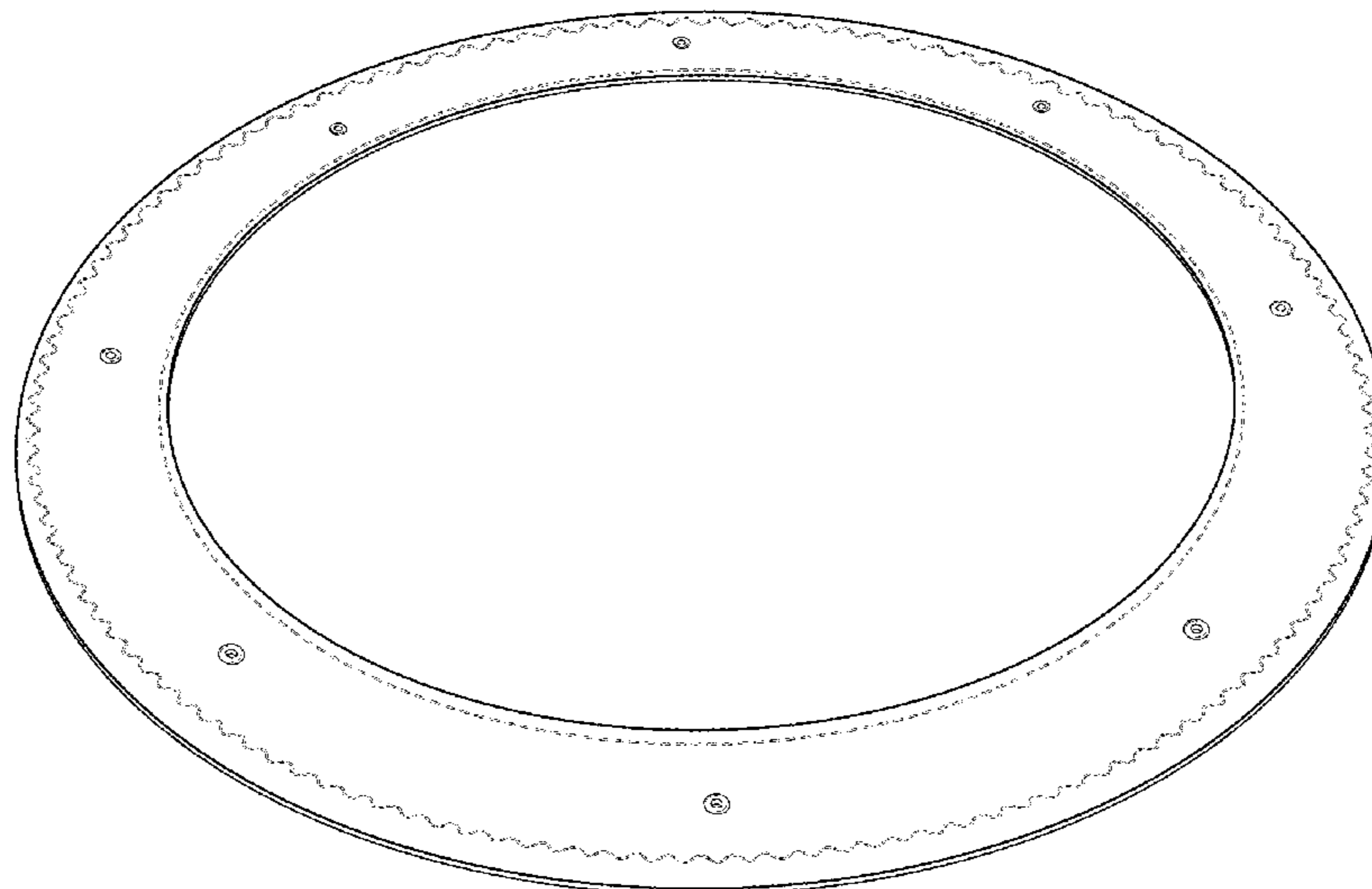
(57) **CLAIM**

I claim the ornamental design for a golf ball target for chipping and putting, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf ball target for chipping and putting showing my new design;

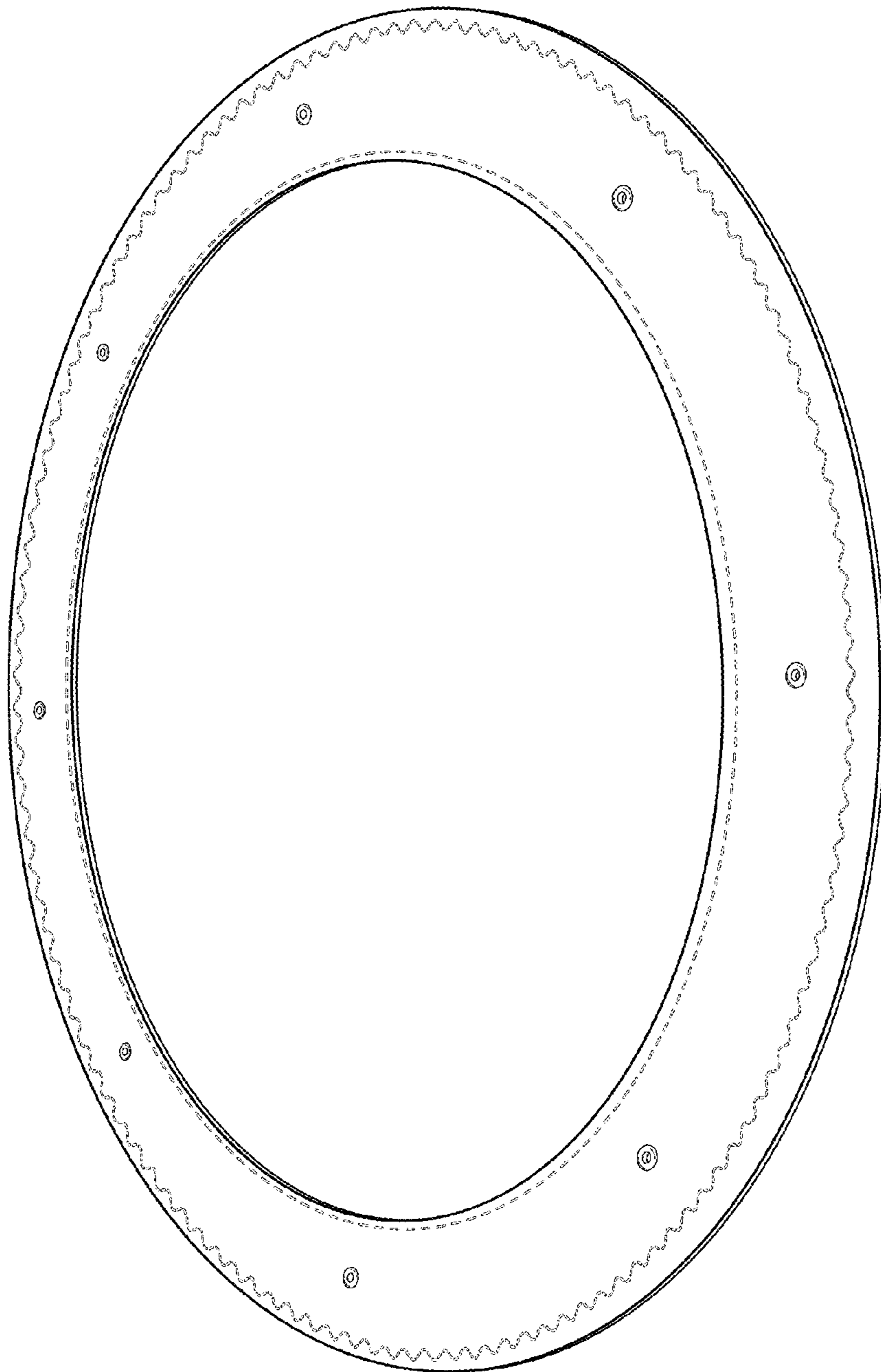

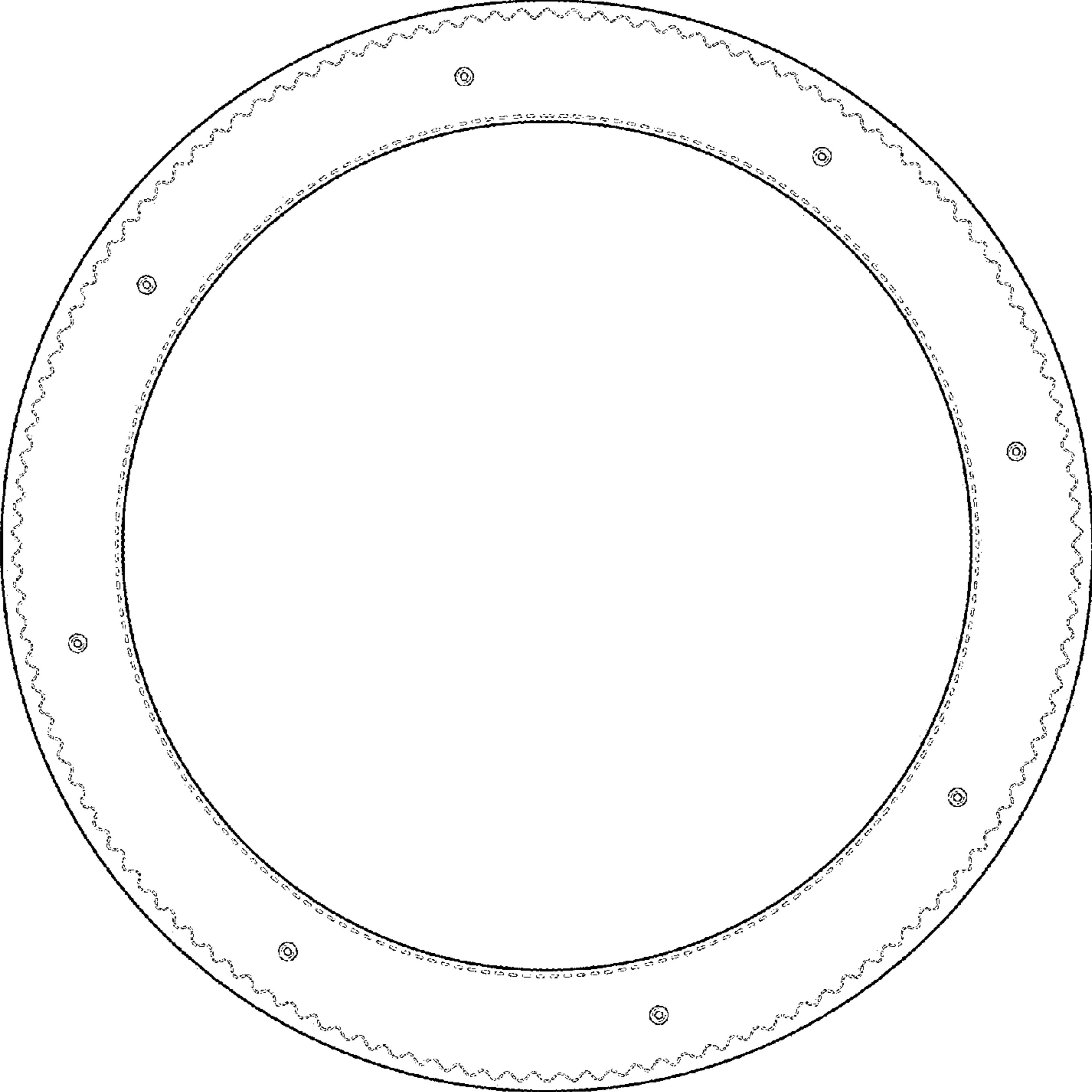

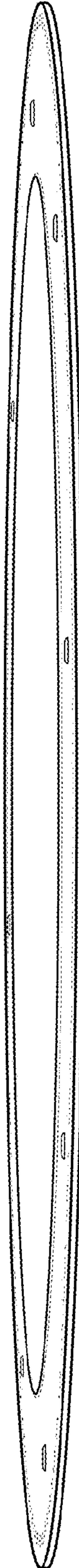

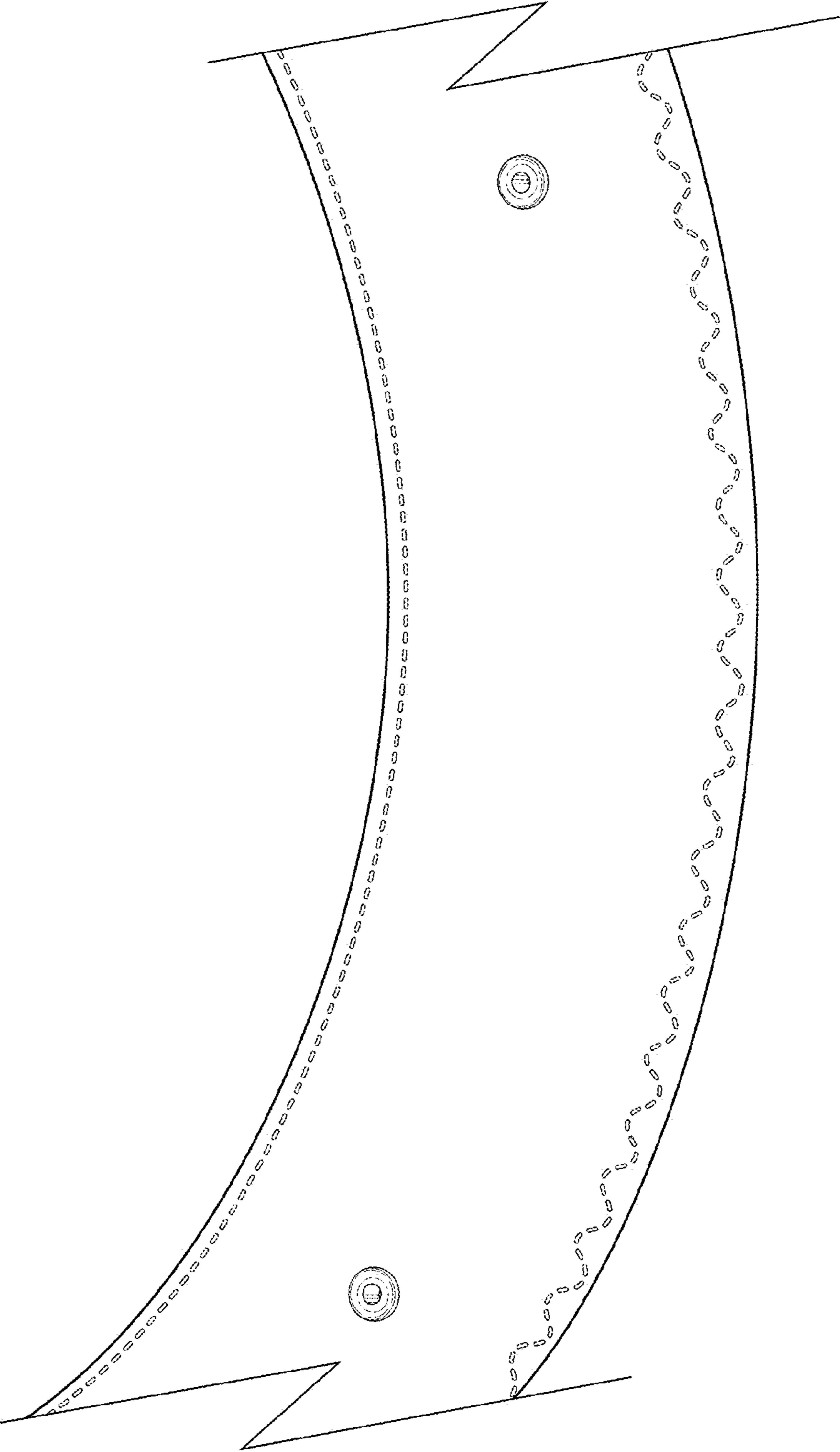

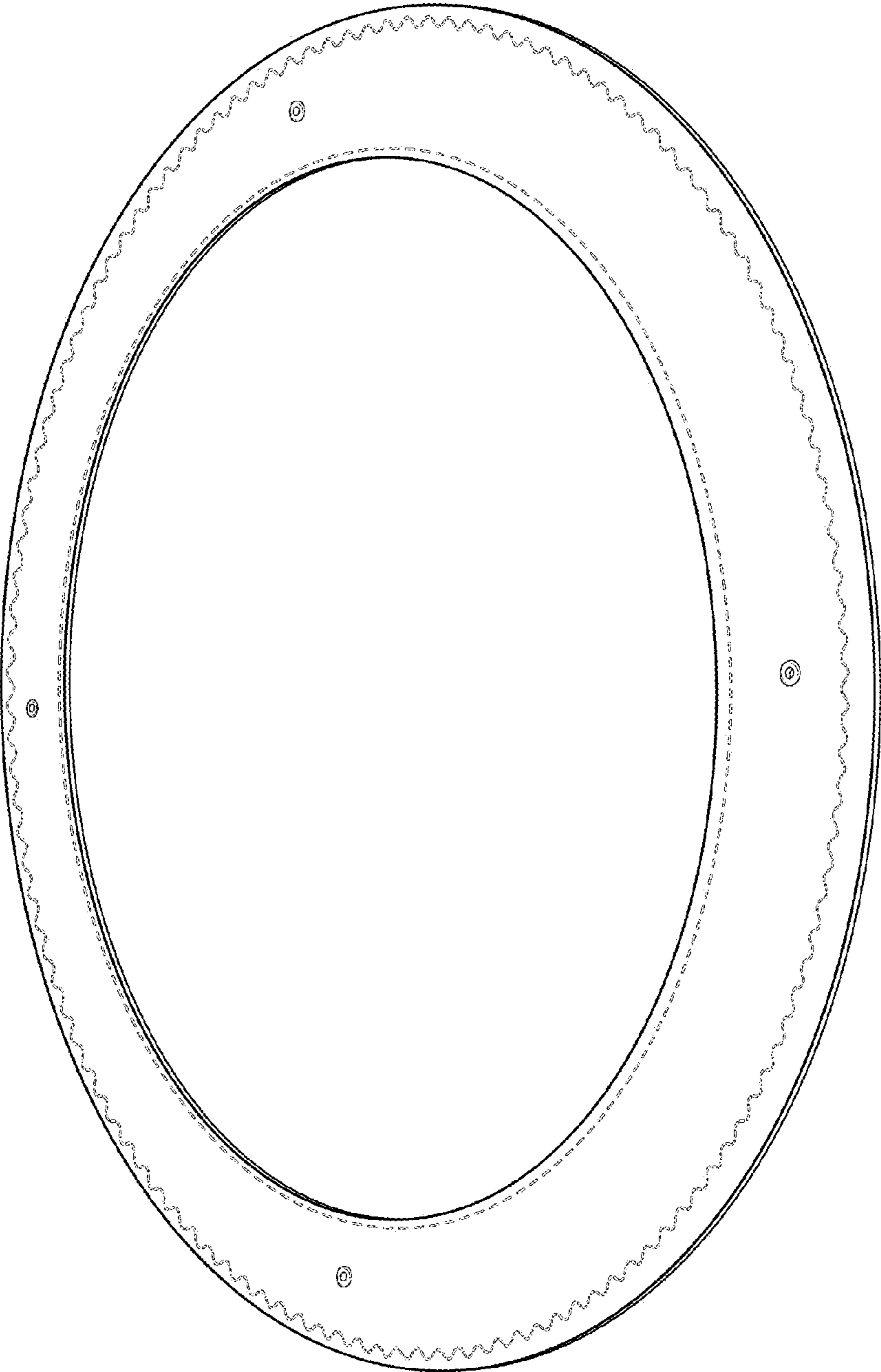

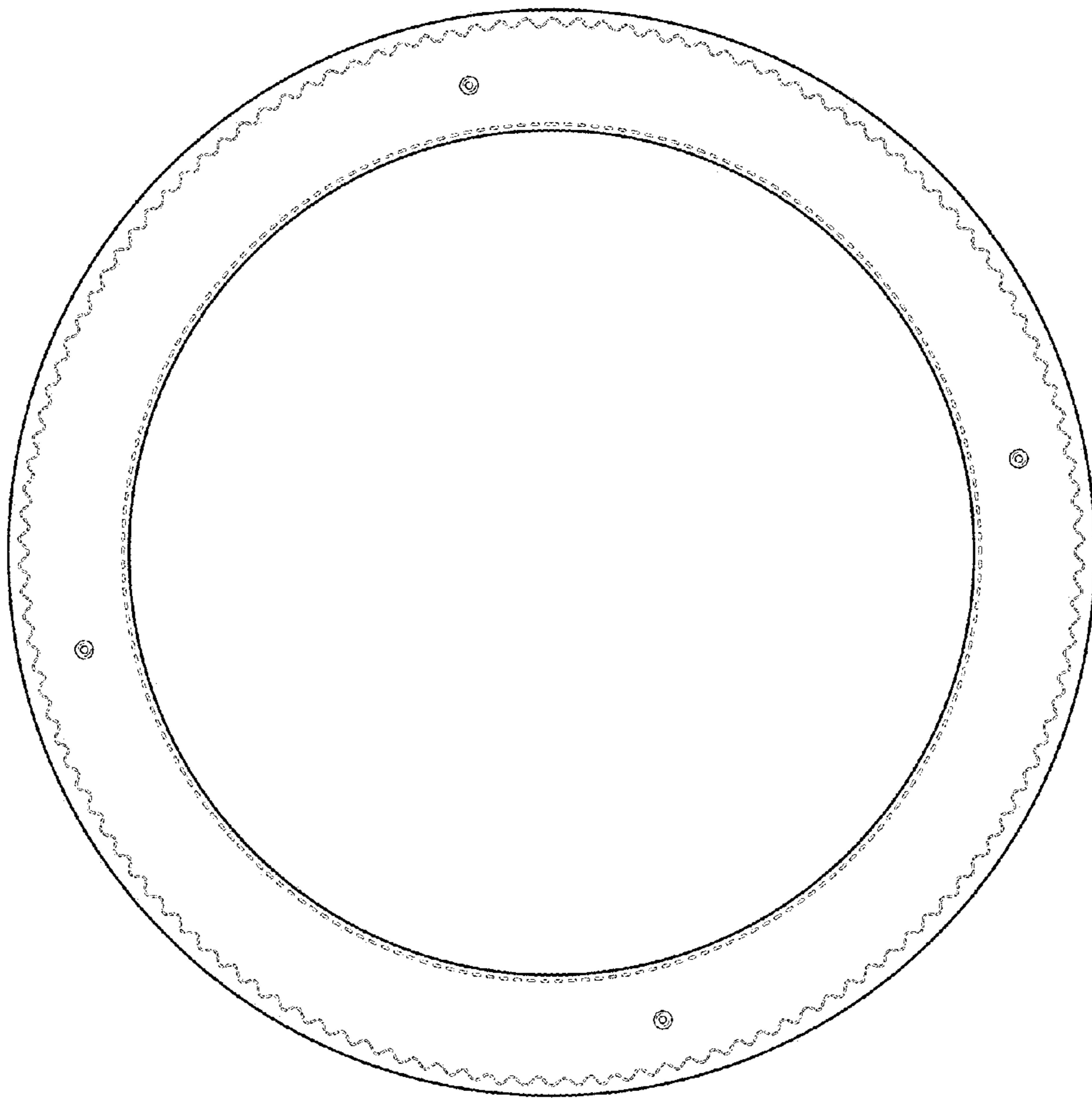

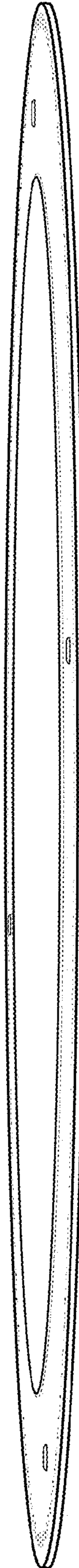

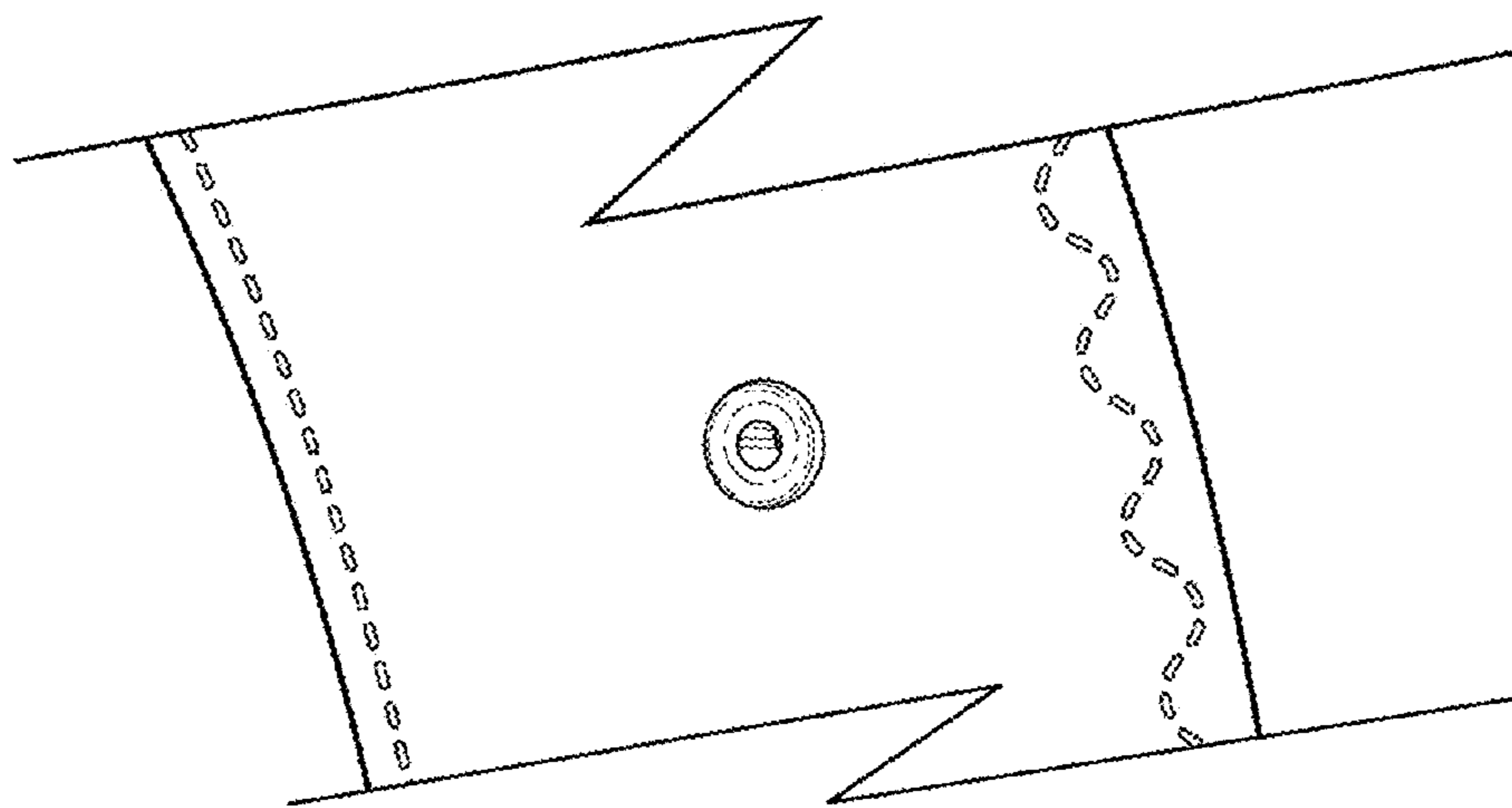

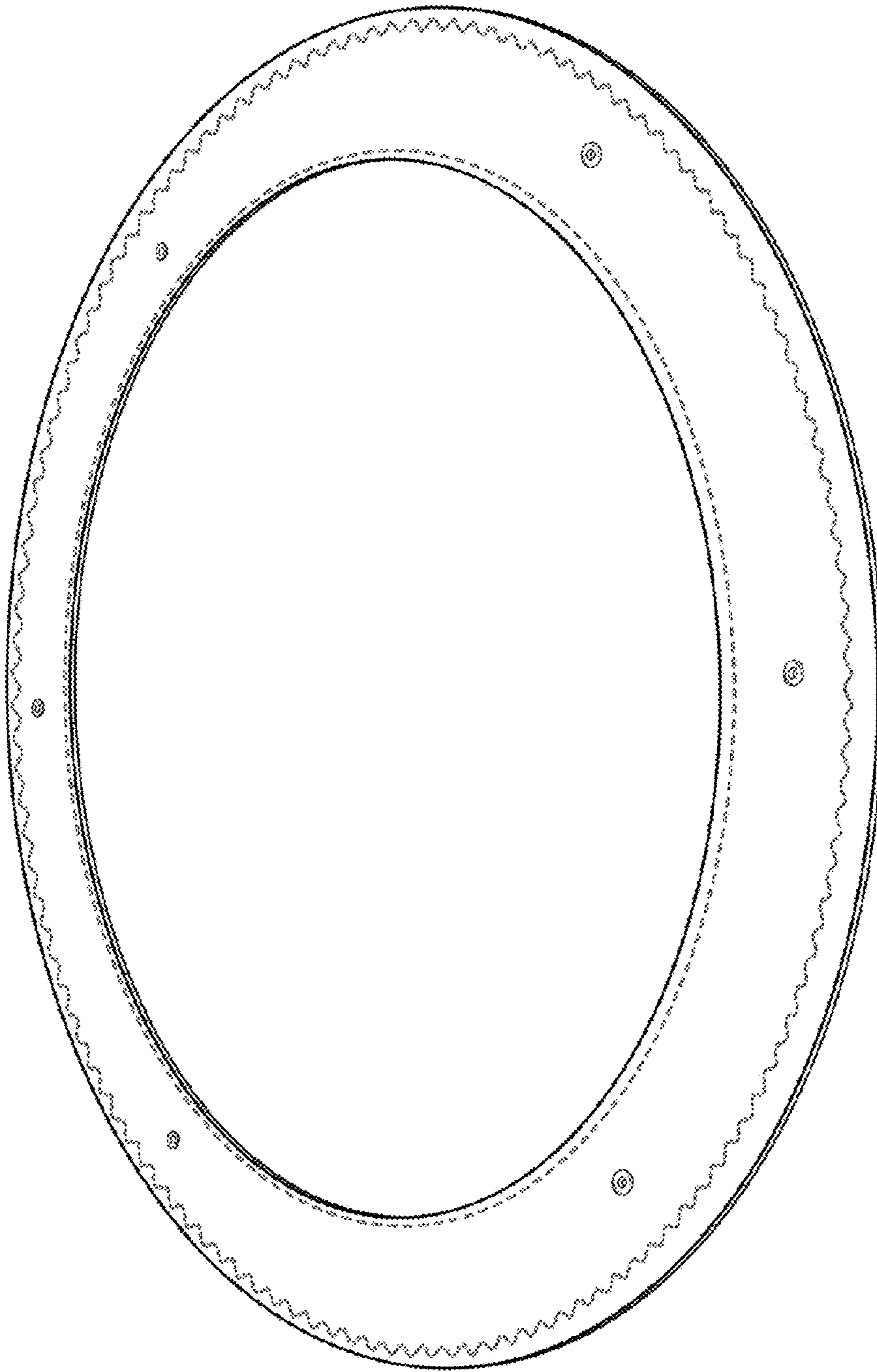

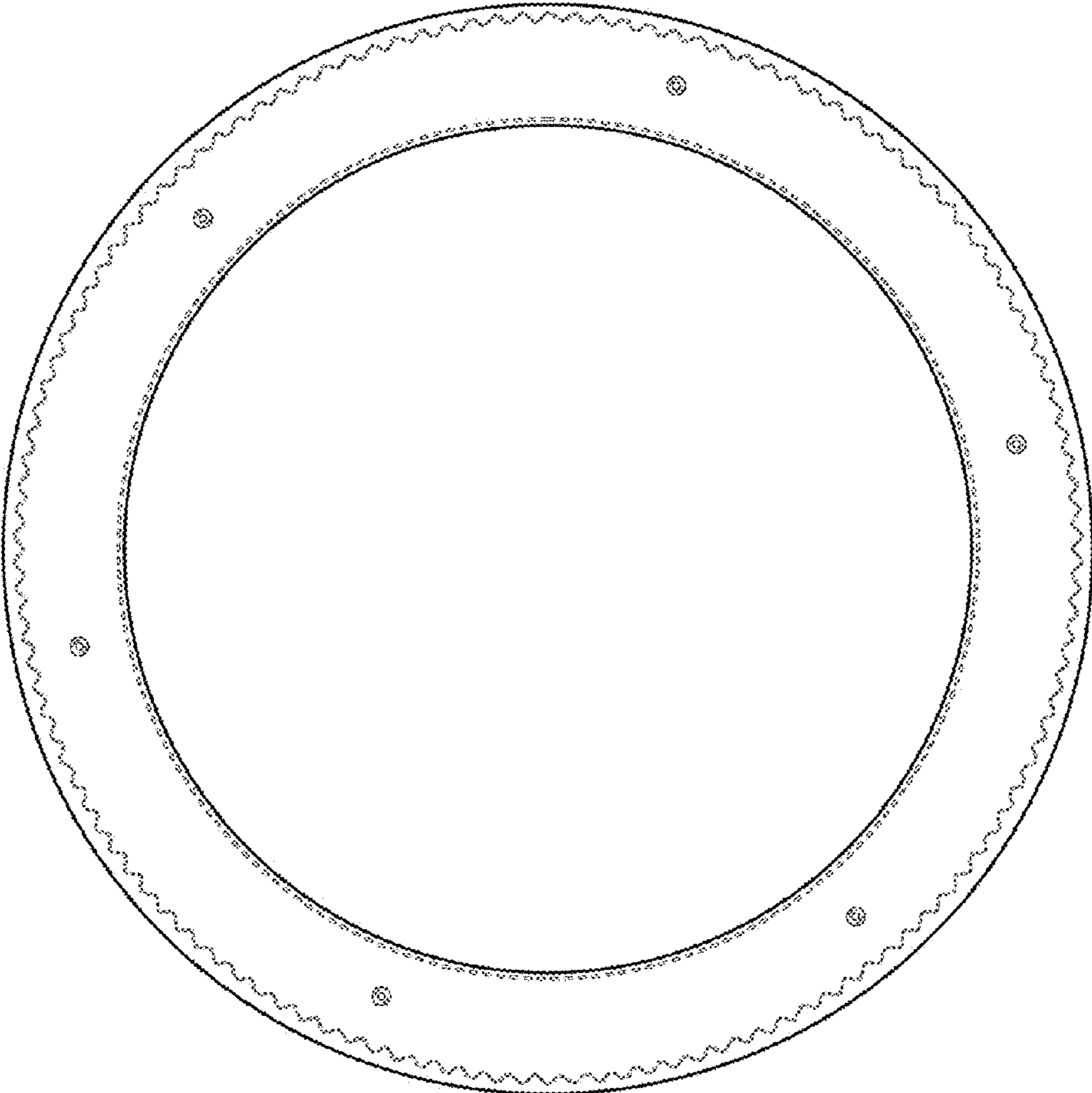

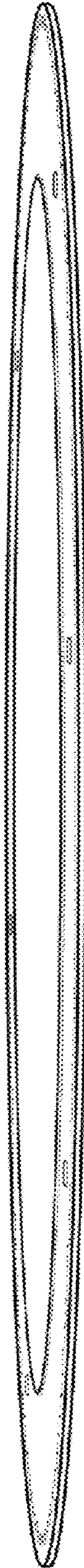

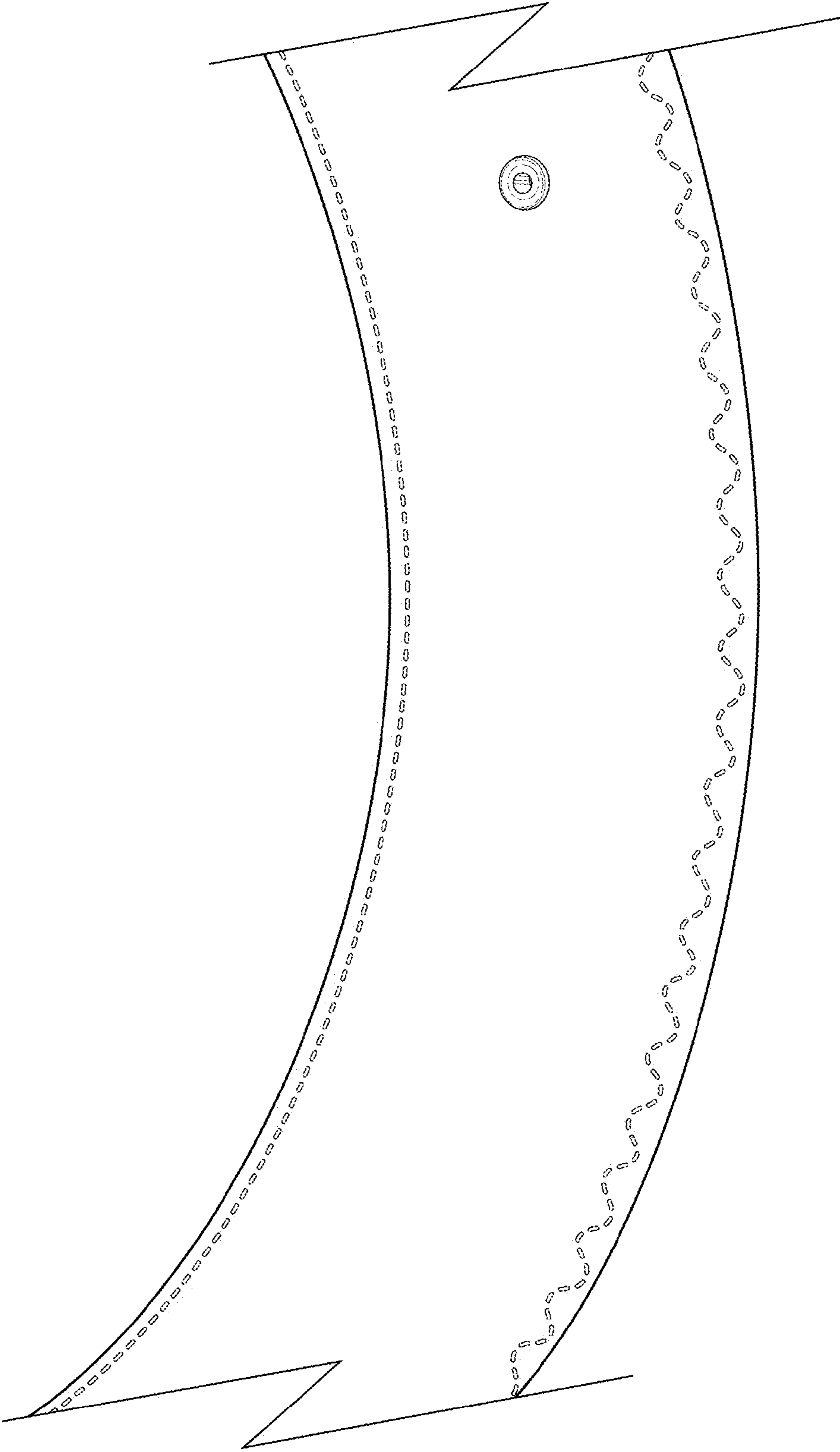
