FIG. 5 is a front view

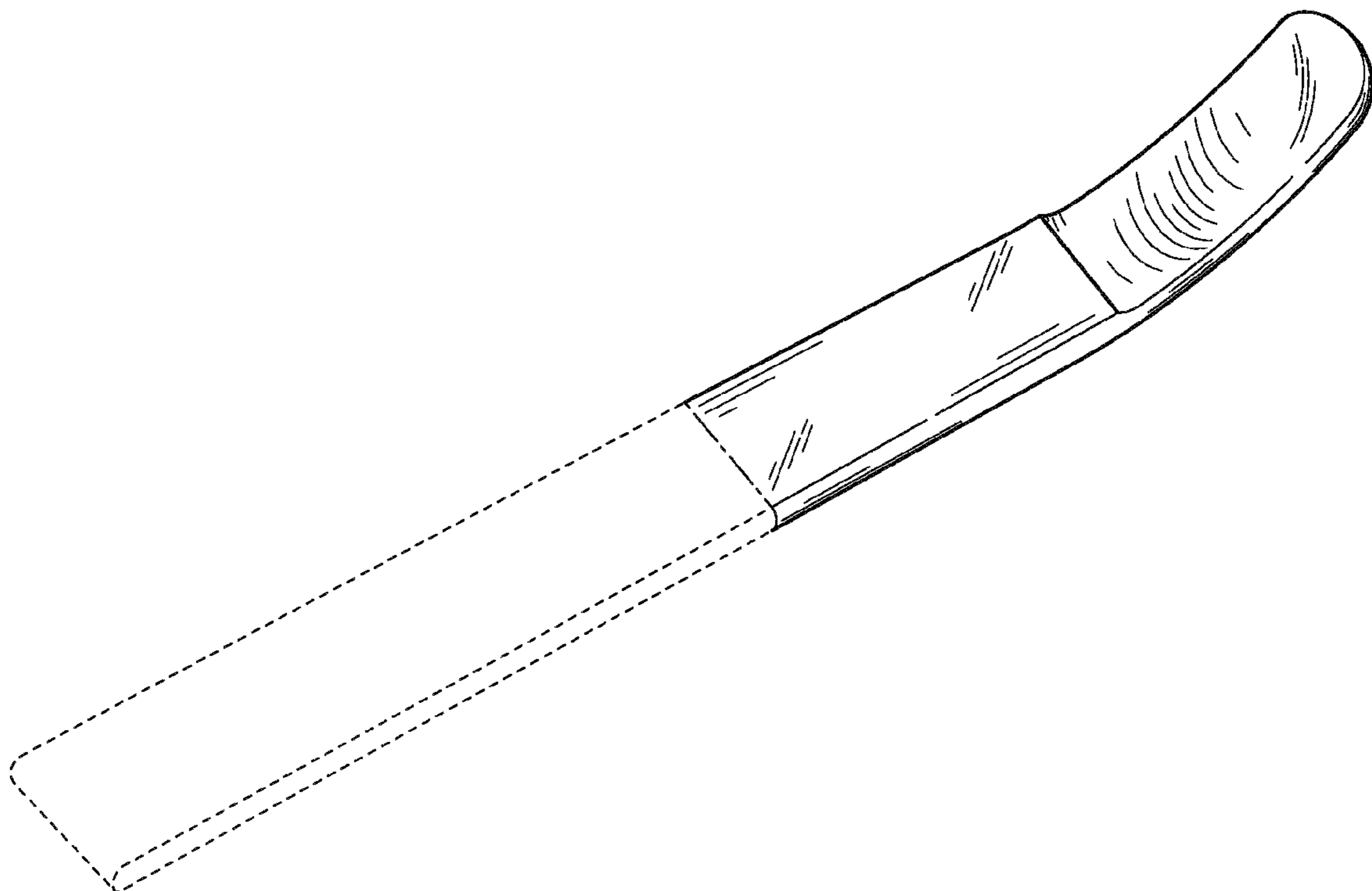
FIG. 6 is a top view; and,

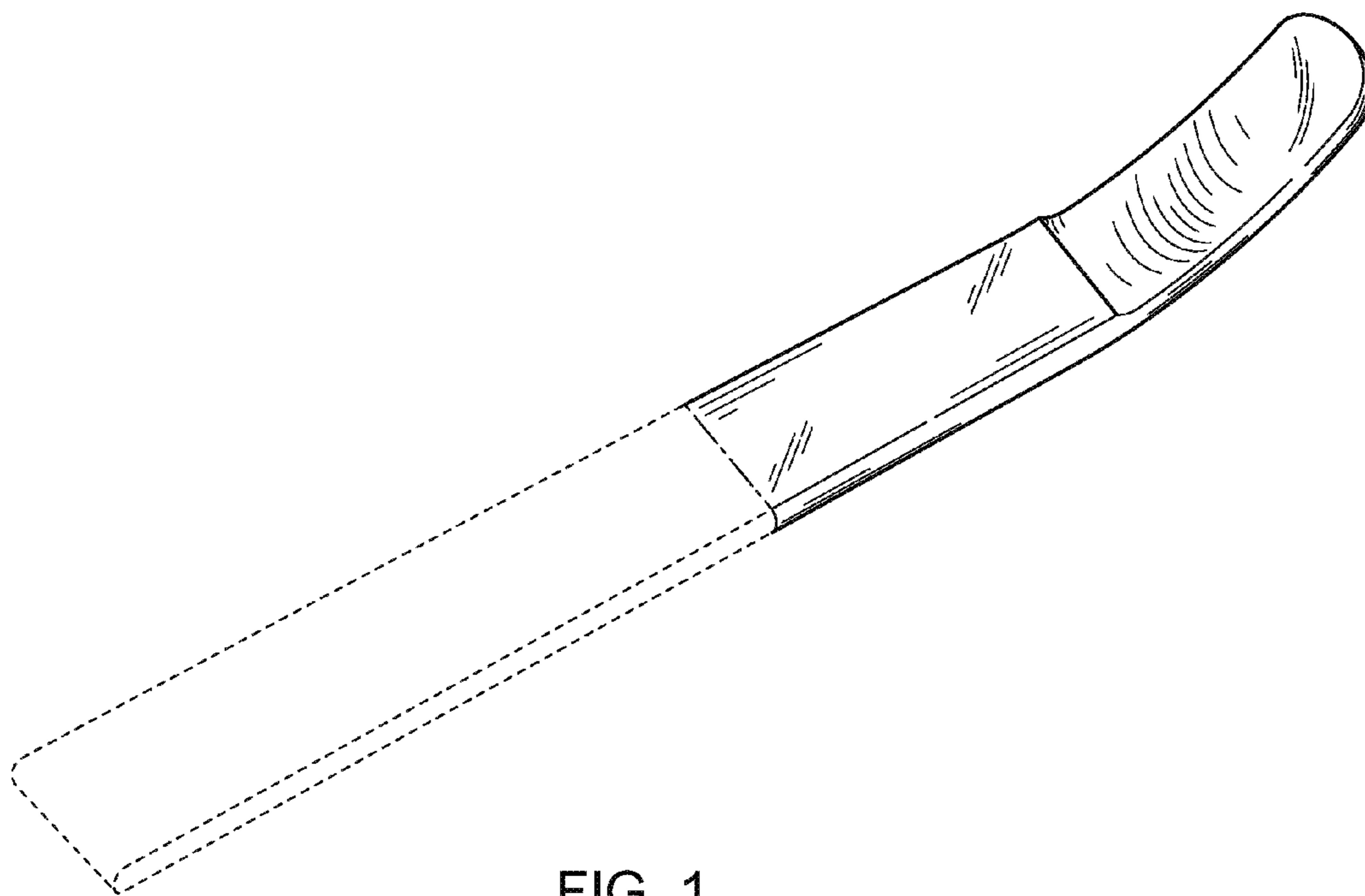

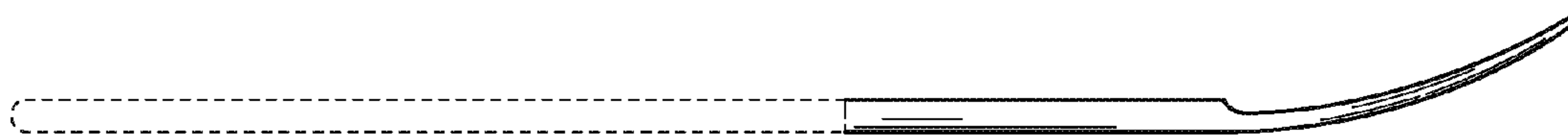

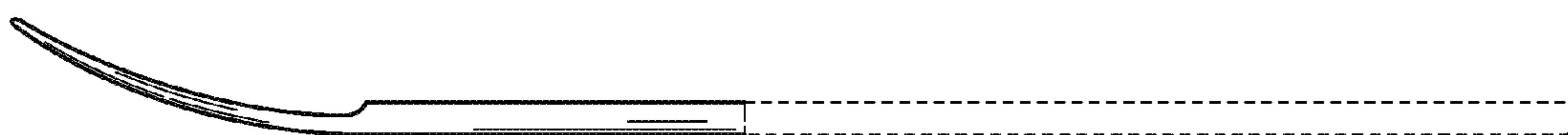

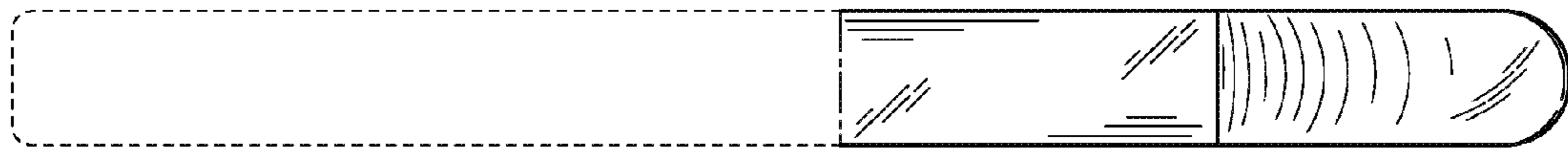

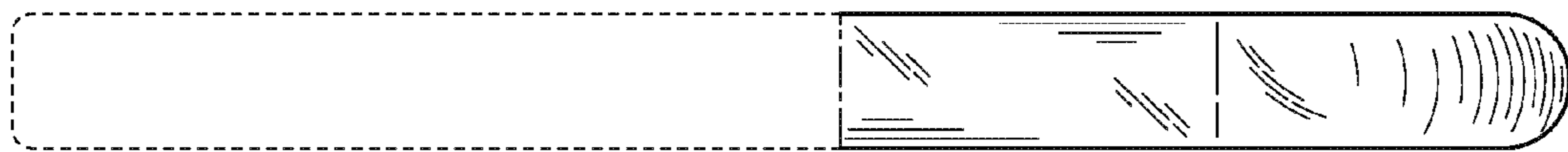
