FIG. 2 is a bottom plan view thereof;
FIG. 3 is a side elevation view thereof, all four sides being identical;
FIG. 4 is a cross-section view thereof taken along a line indicated on FIG. 1;
FIG. 5 is a side elevation view with the only difference from the embodiment portrayed in FIG. 3 being an unclaimed height;
FIG. 6 is a top plan view of a round embodiment of a marble lamp;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a side elevation view thereof, all side views being identical;
FIG. 9 is a cross-section view thereof taken along a line indicated on FIG. 6; and,
FIG. 10 is a side elevation view with the only difference from the embodiment portrayed in FIG. 3 being an unclaimed height.

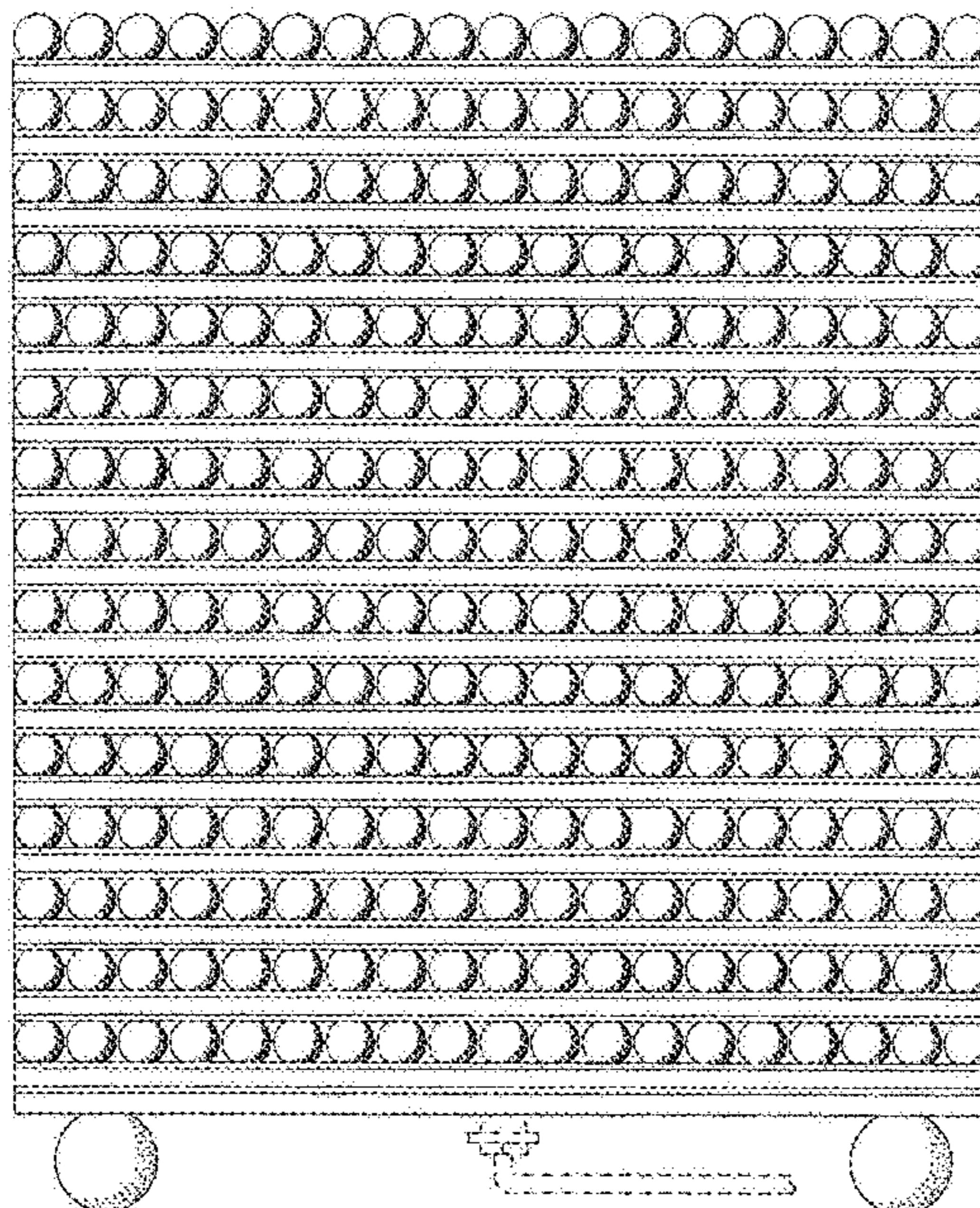

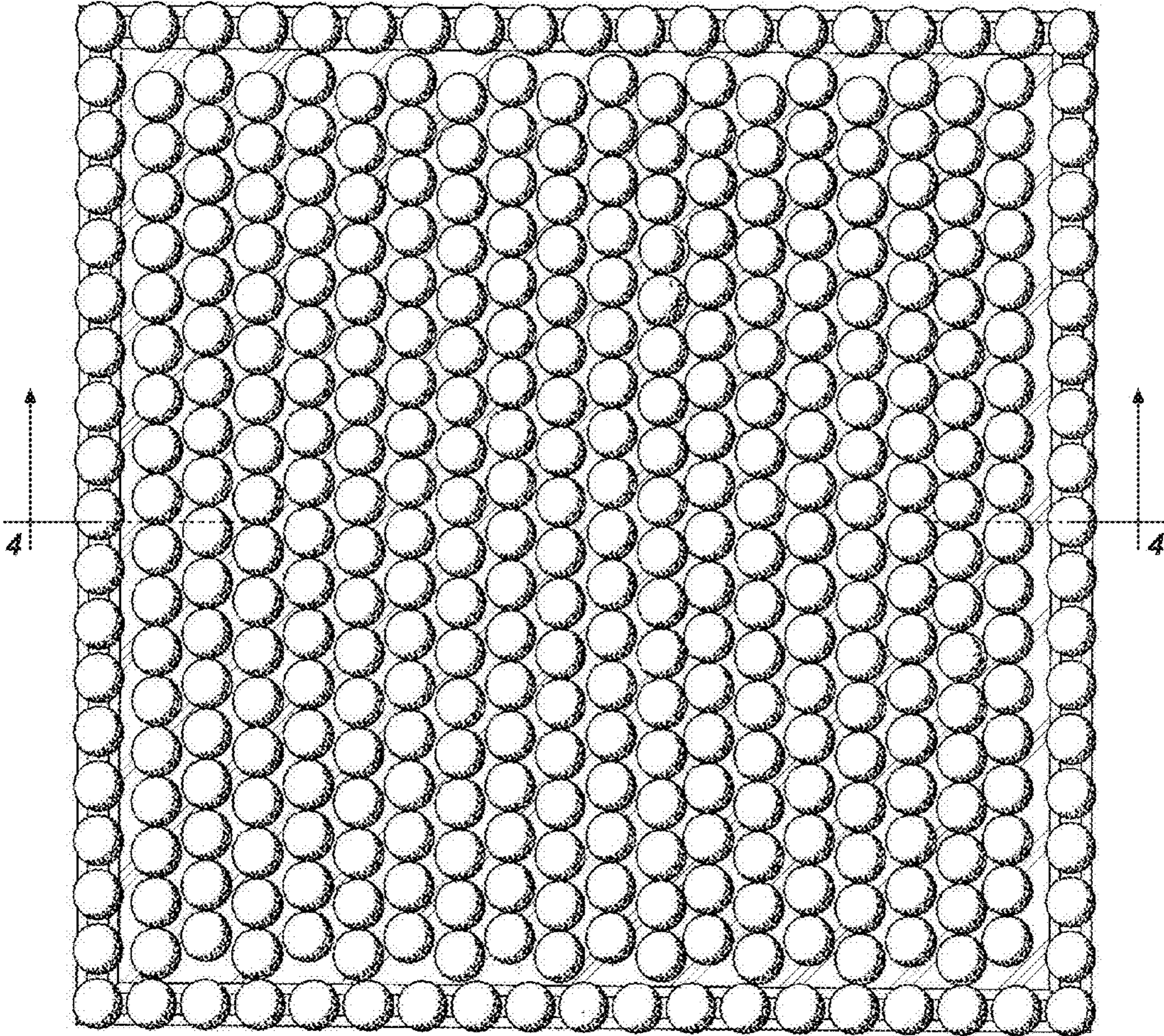

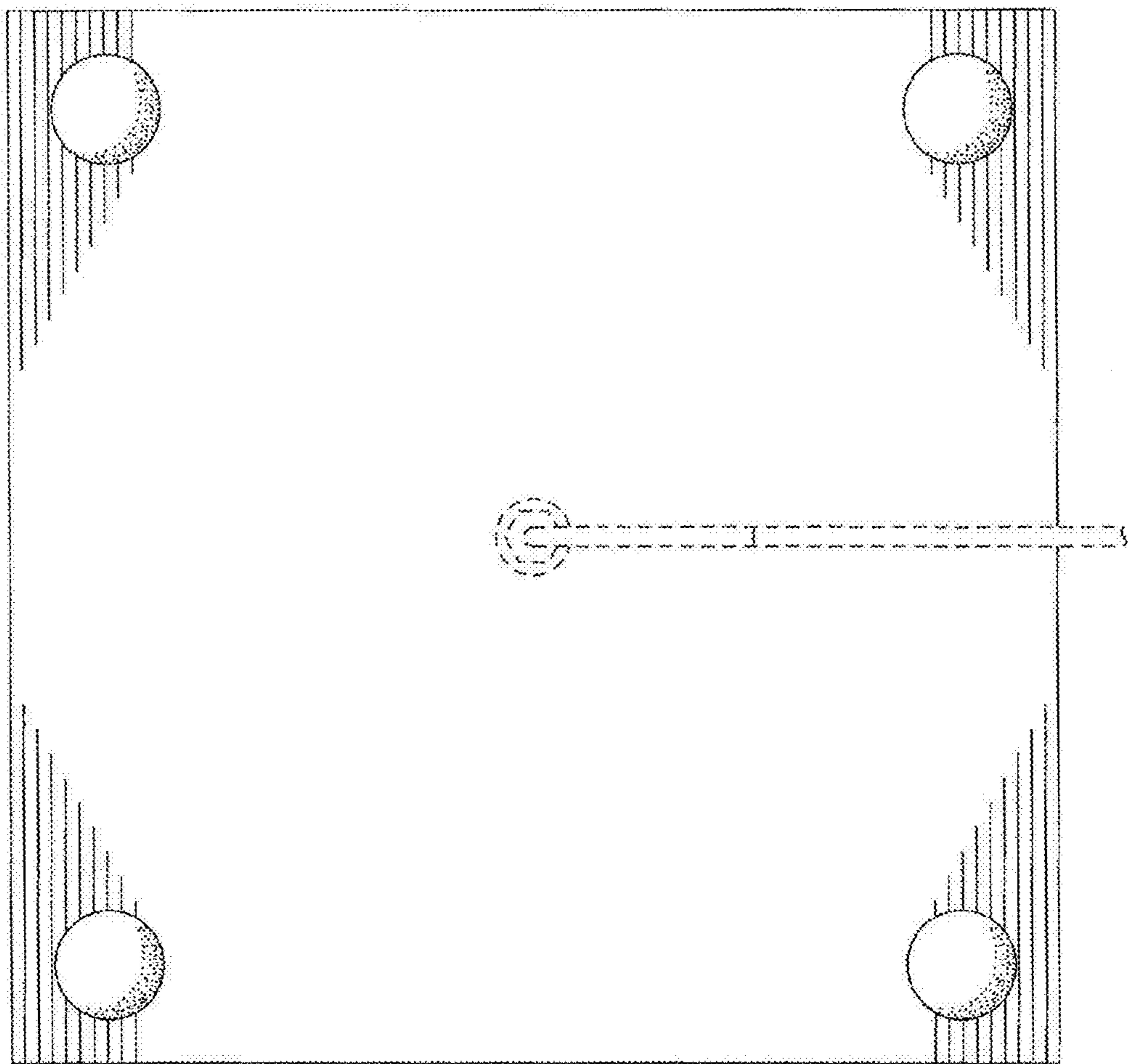

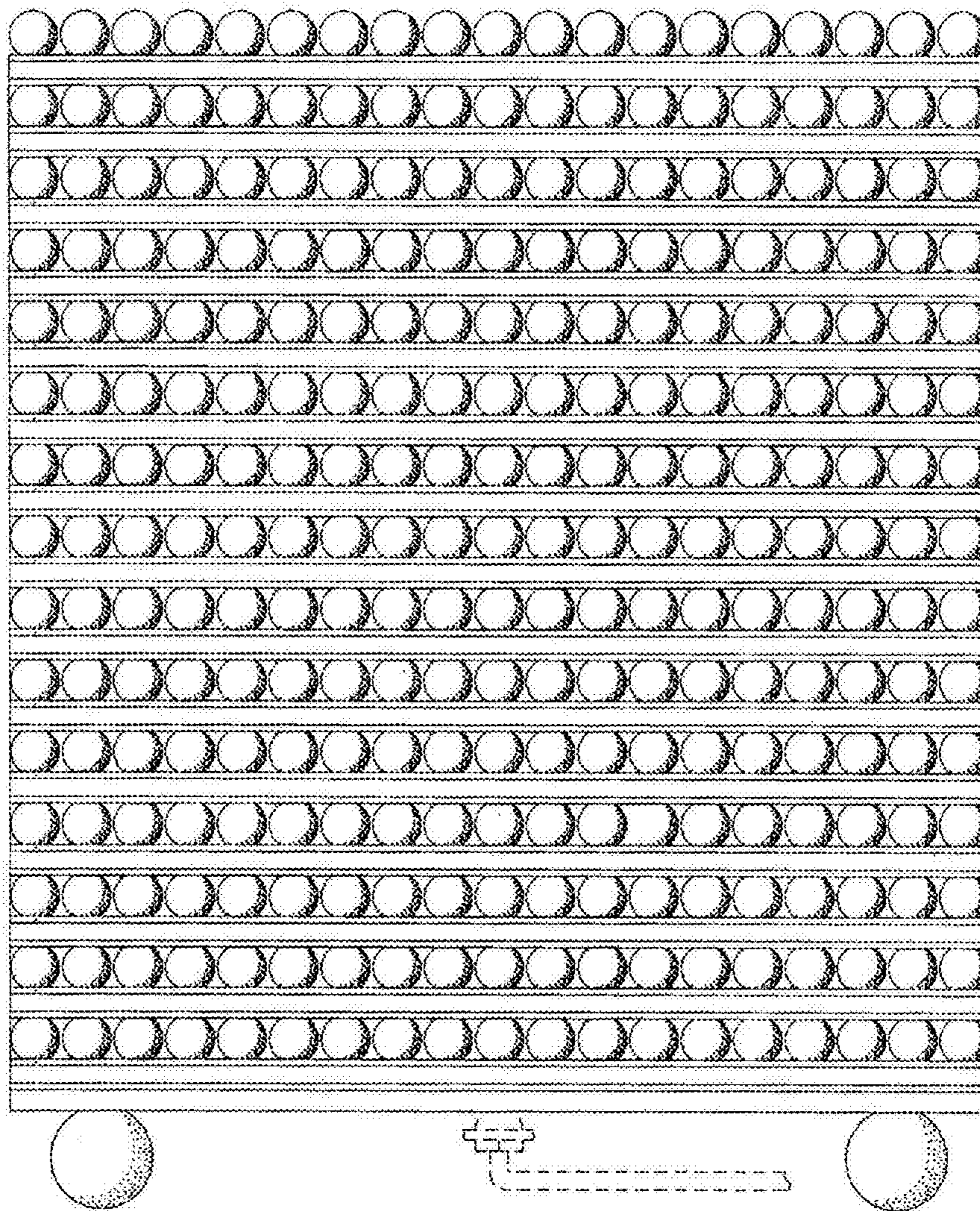

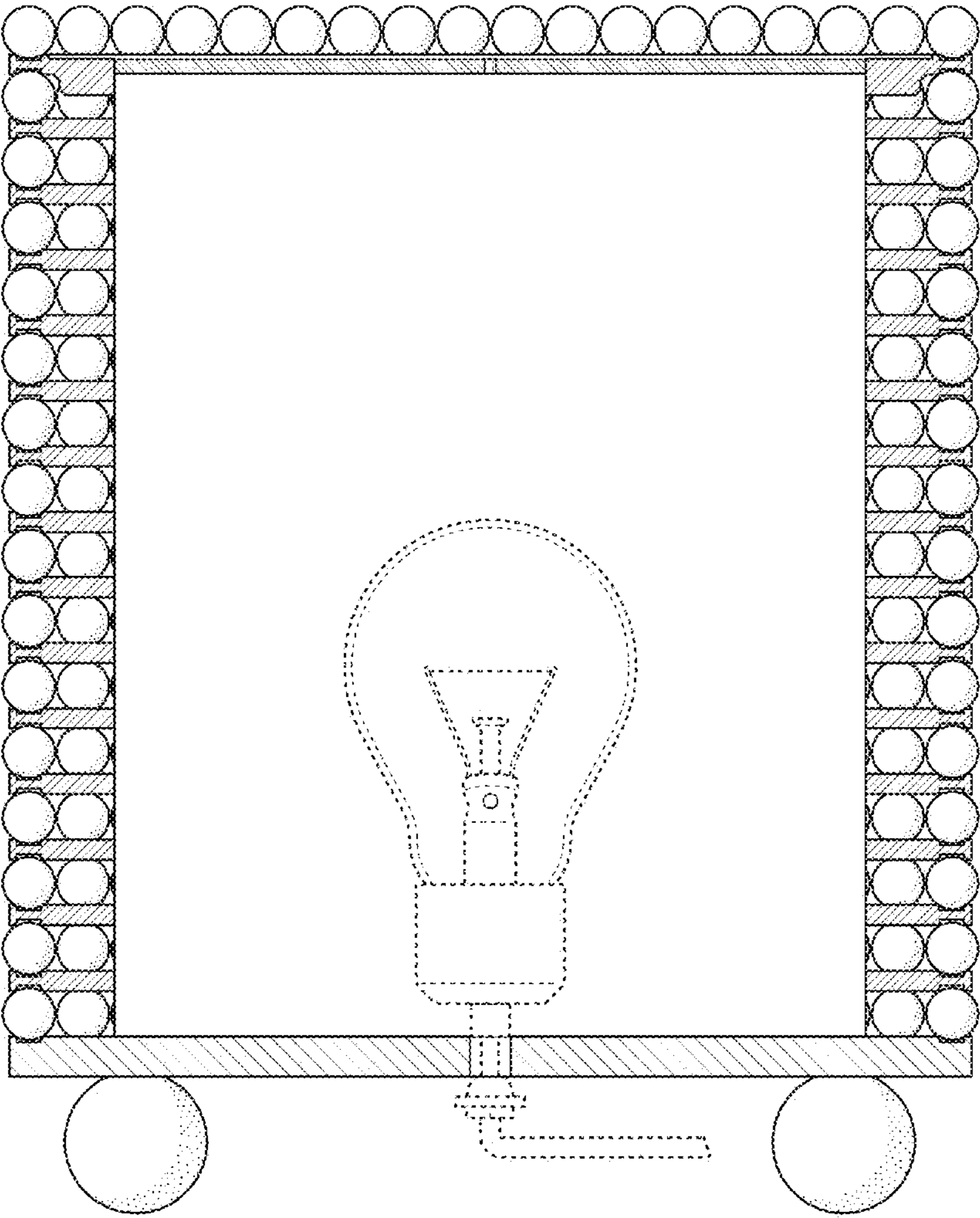

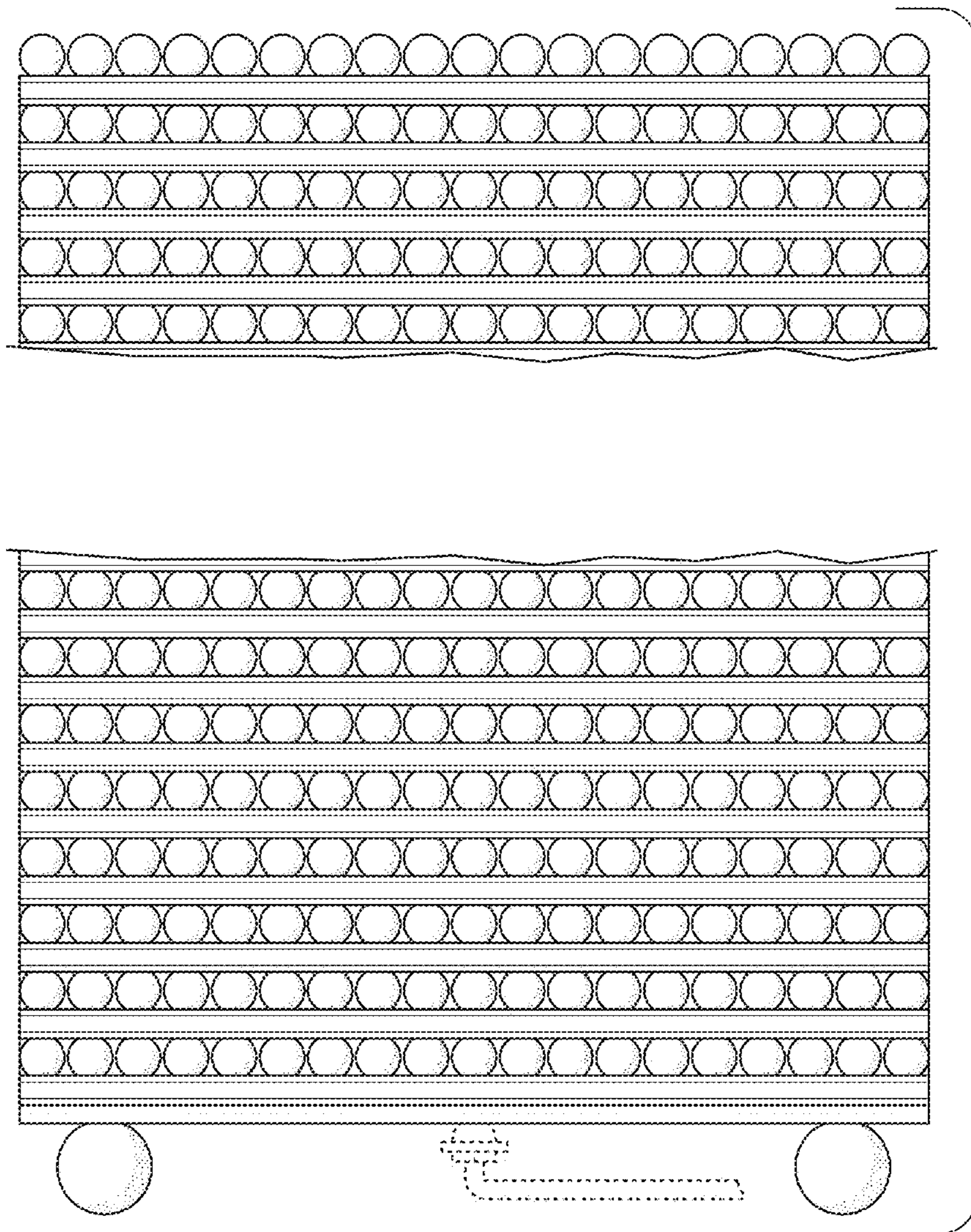

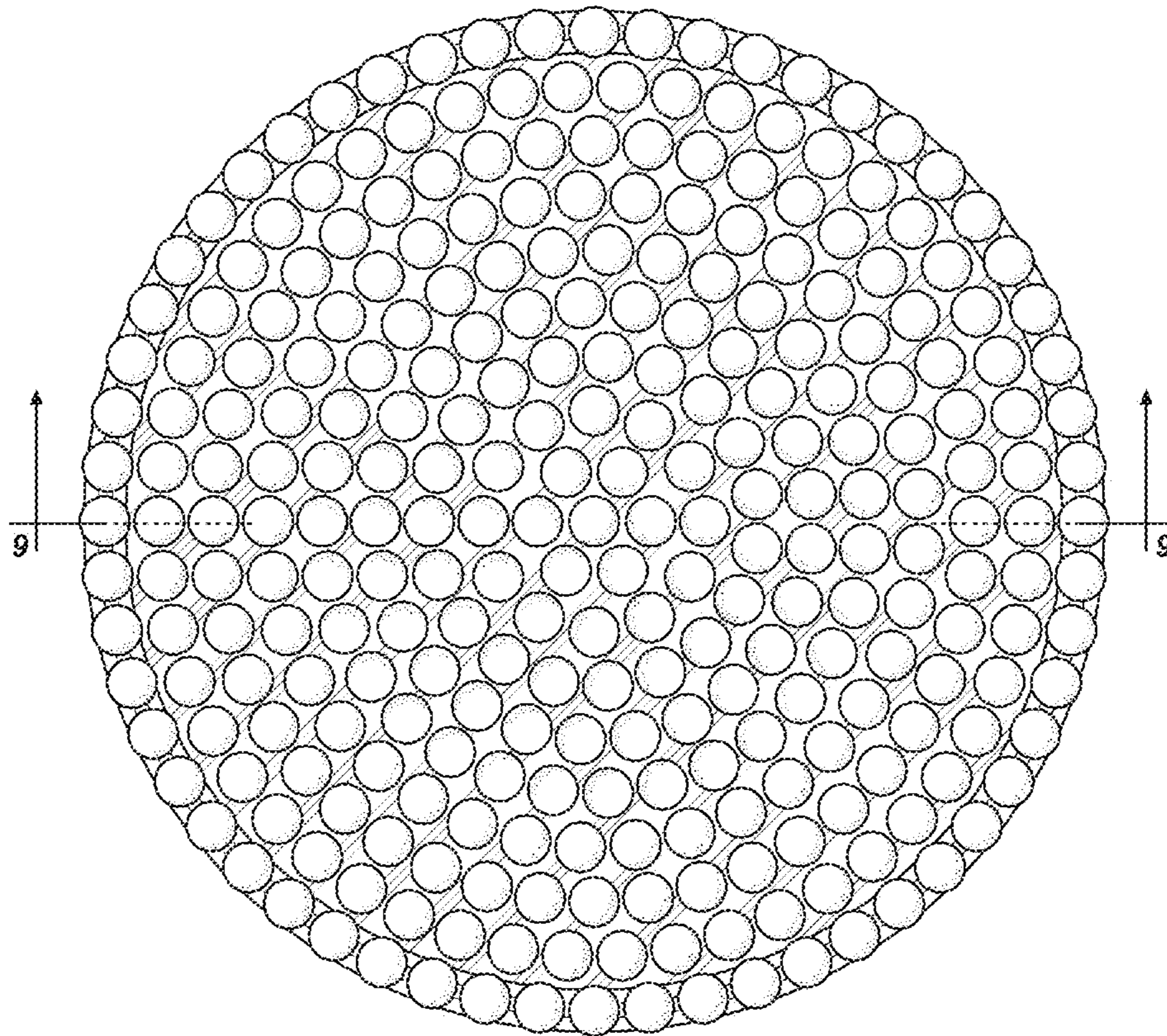

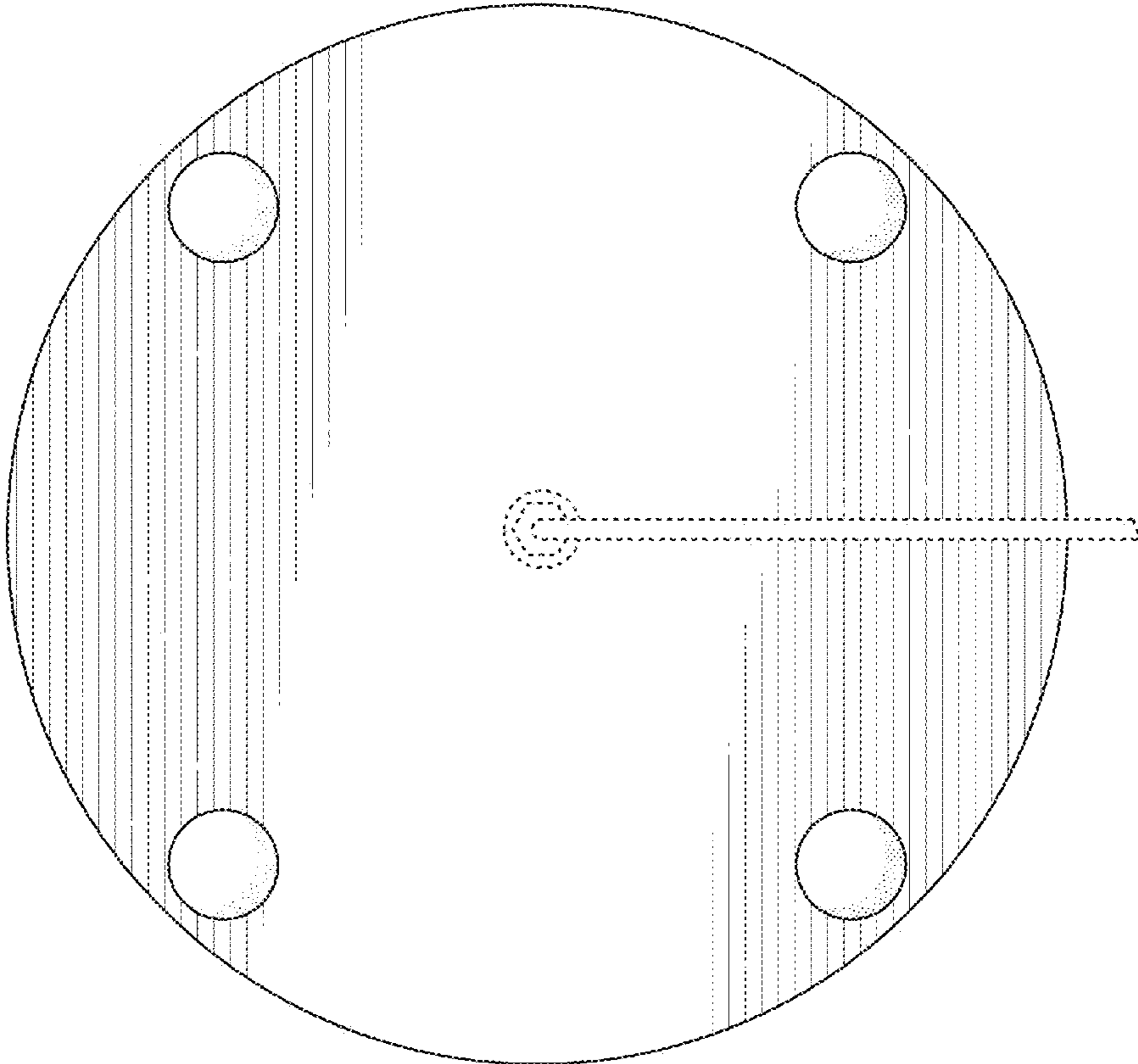

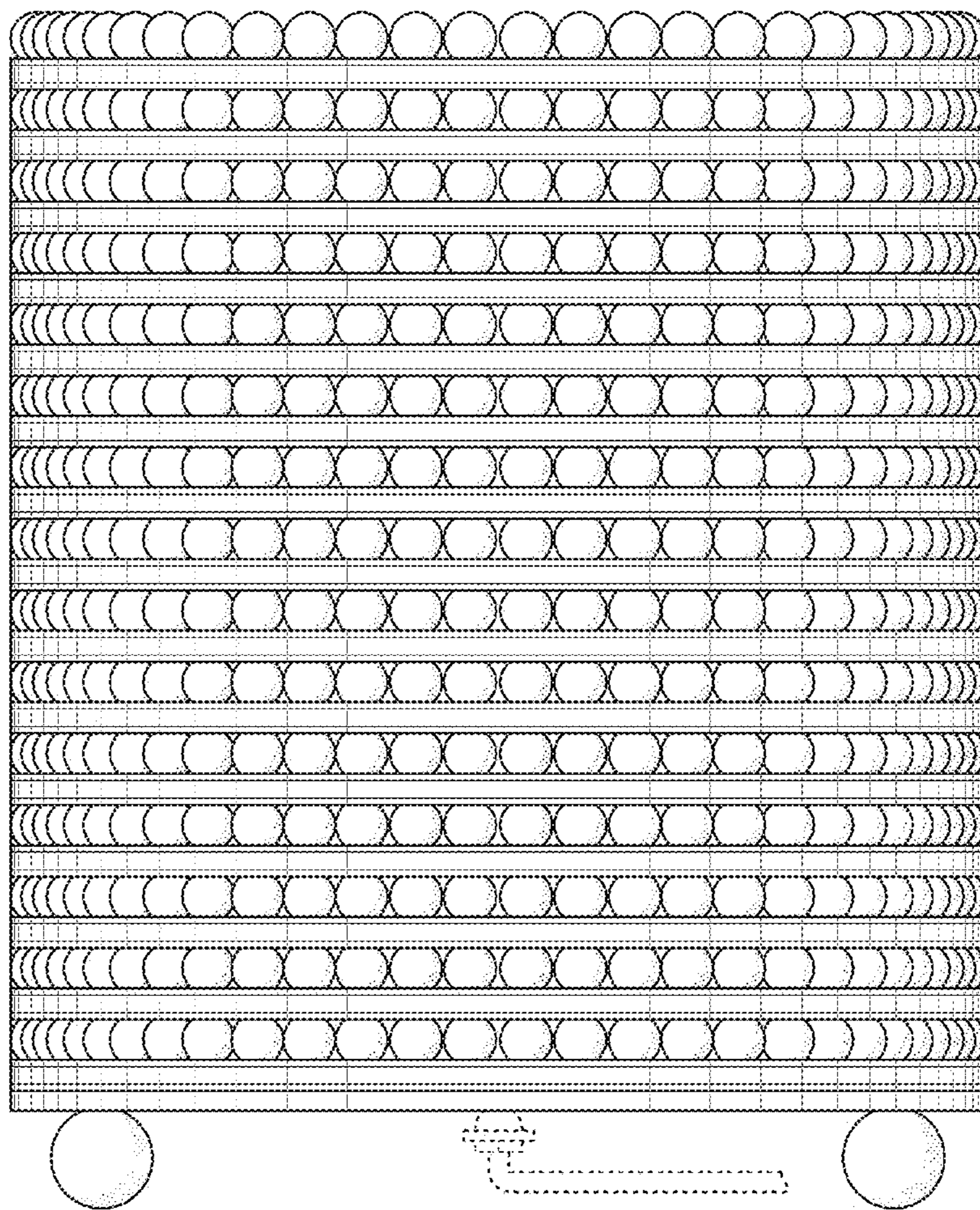

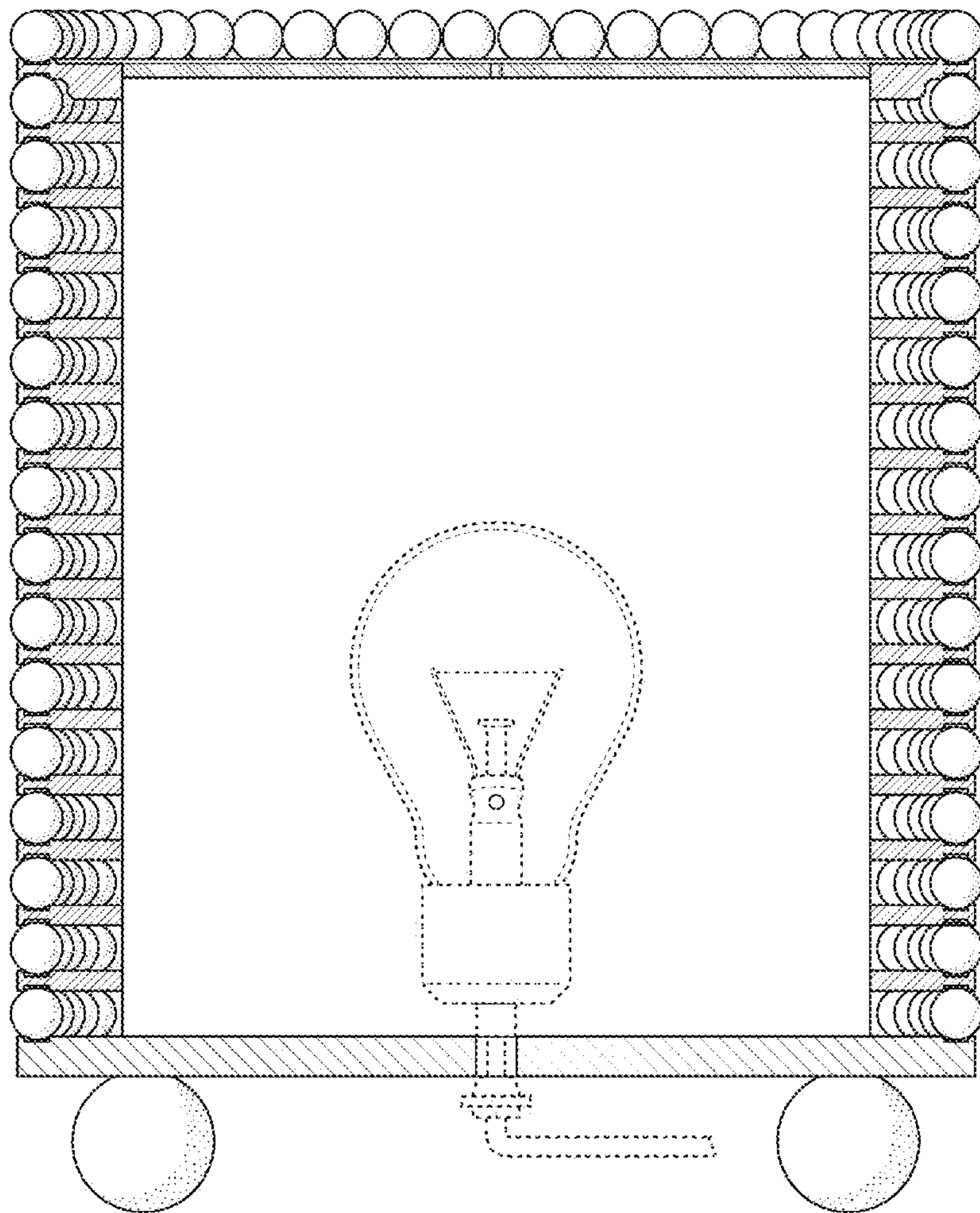
