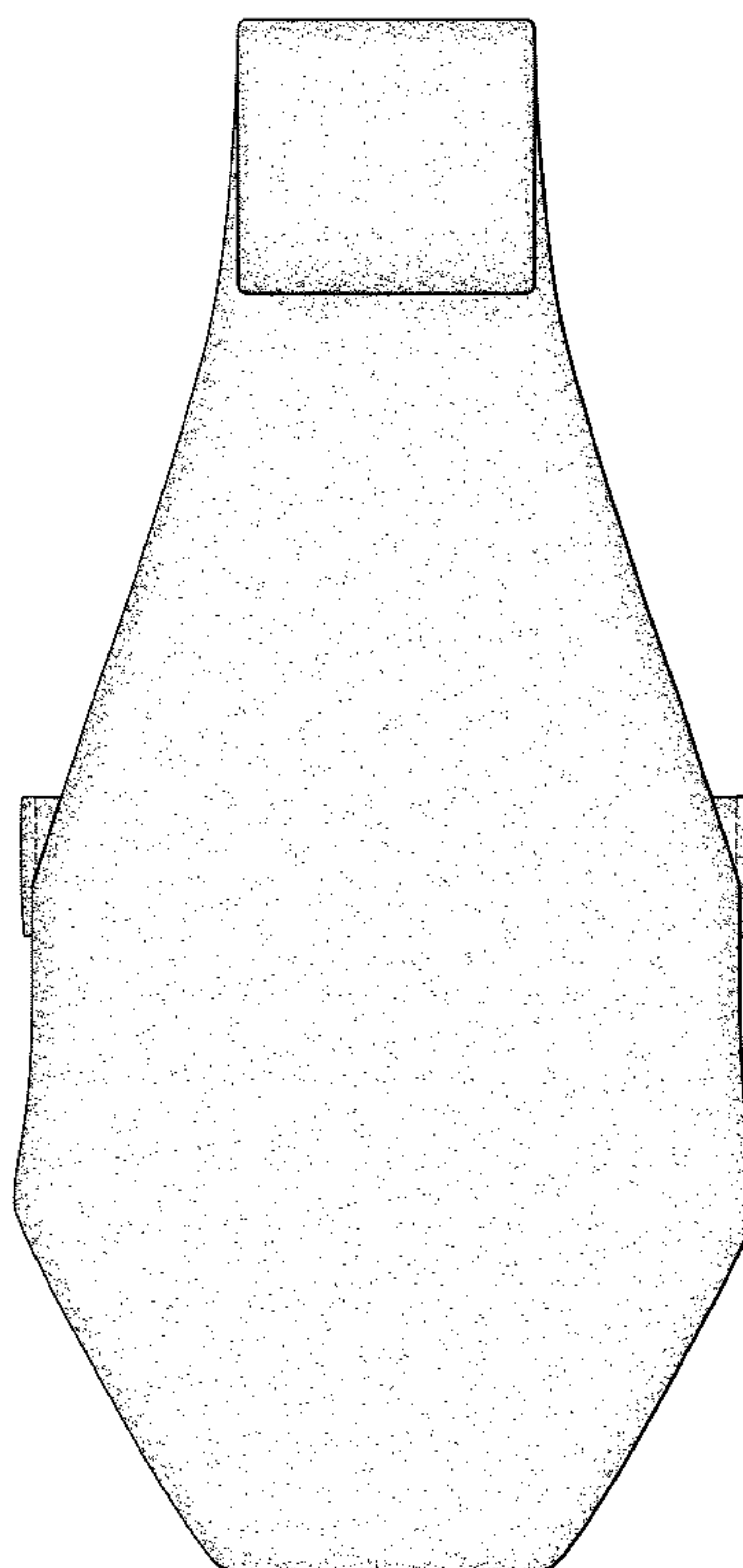
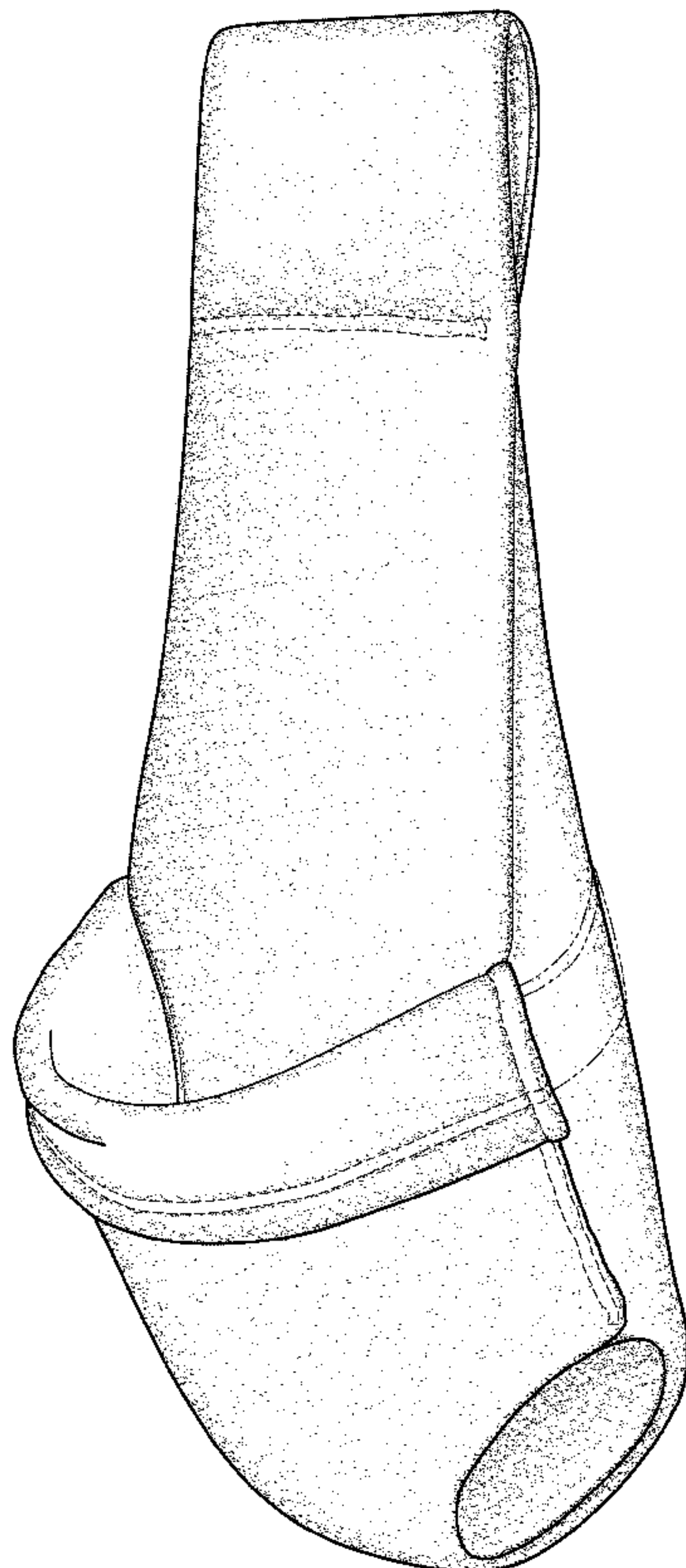
The ornamental design for a baby walking support, as shown and described.

DESCRIPTION

FIG. 1 is a front-right perspective view of a baby walking support in accordance with the present design;
FIG. 2 is a front view of the baby walking support shown in FIG. 1;
FIG. 3 is a rear view of the baby walking support shown in FIG. 1;
FIG. 4 is a left side view of the baby walking support shown in FIG. 1, which is the same as the right side view; and,
FIG. 5 is a top plan view of the baby walking support shown in FIG. 1.

The broken lines represent stitching, which forms no part of the claimed design.

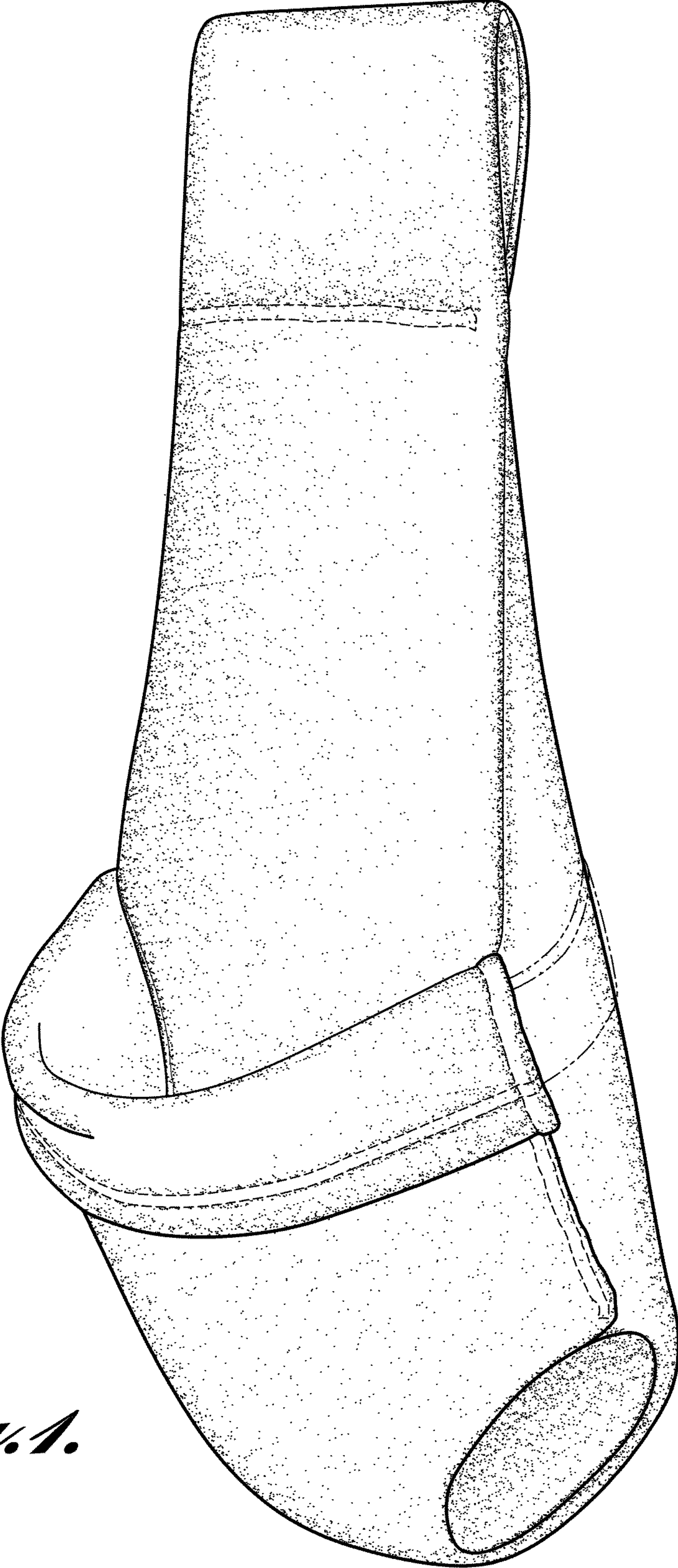

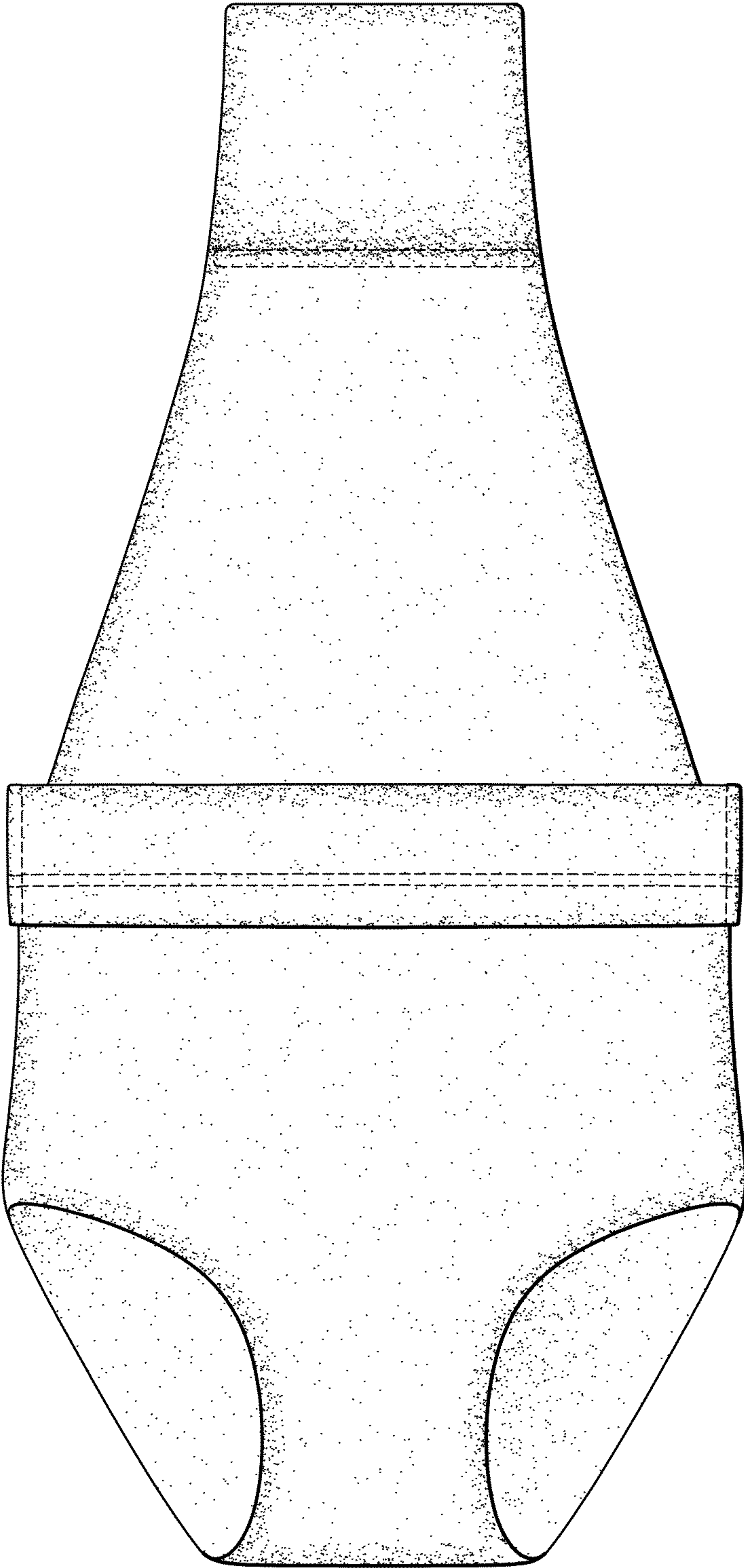

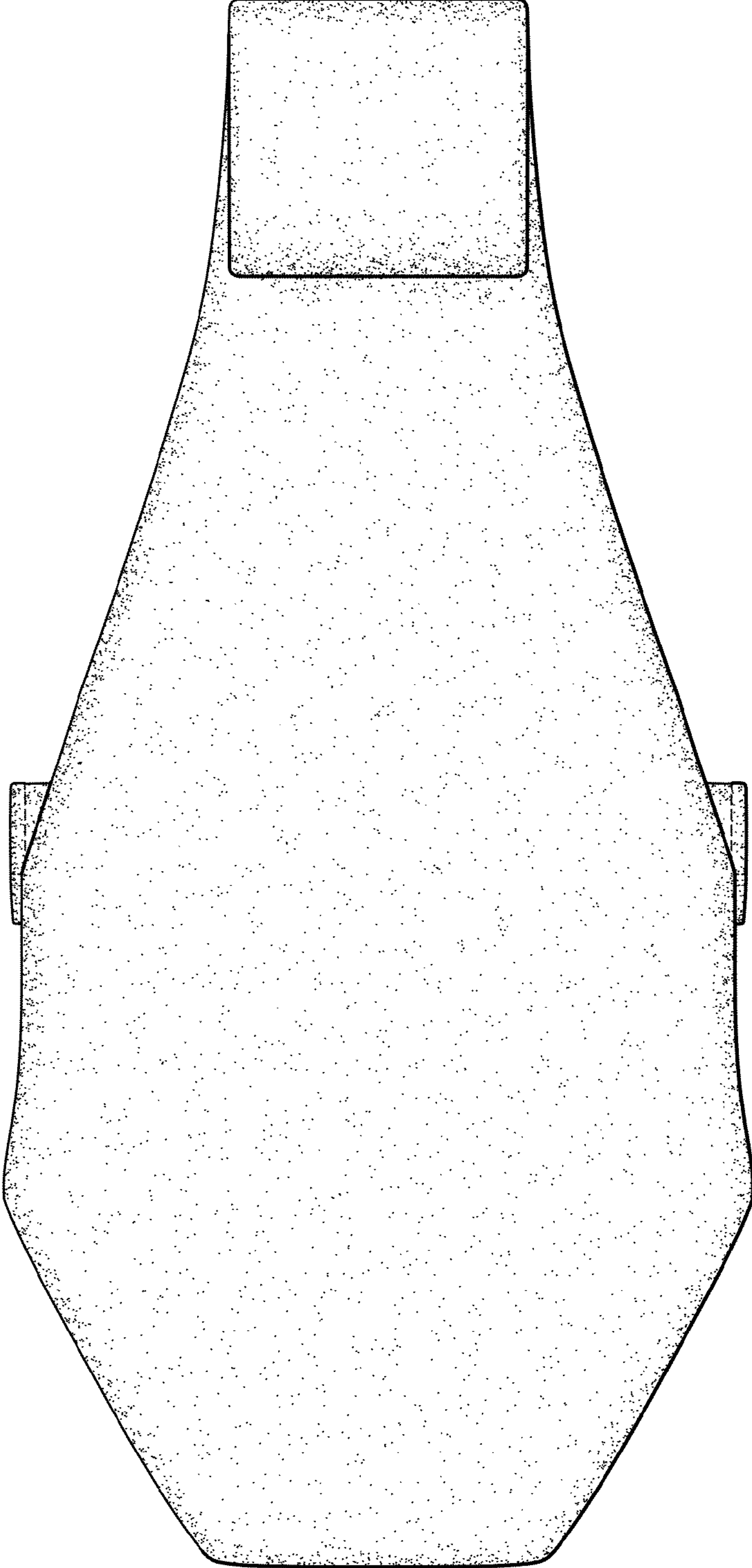

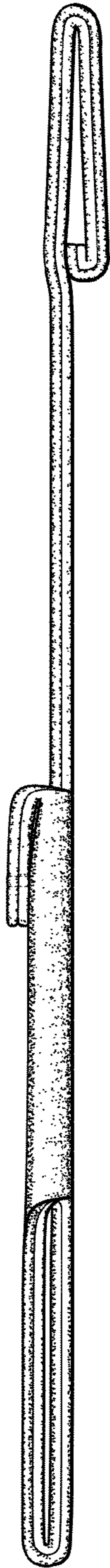

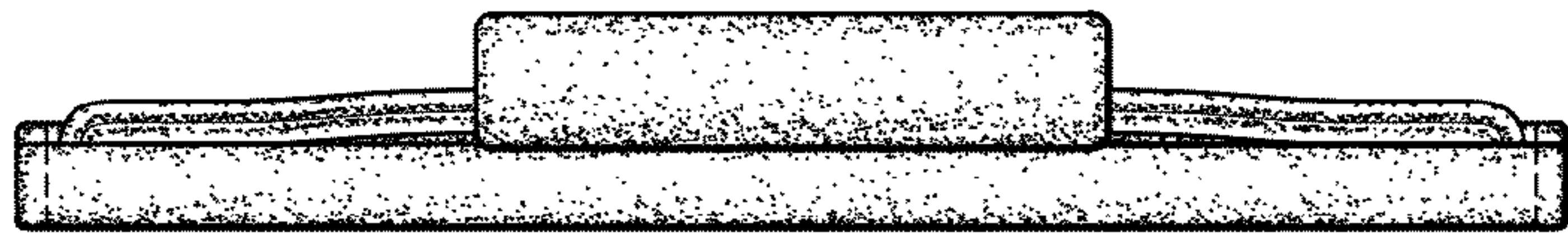
