DESCRIPTION

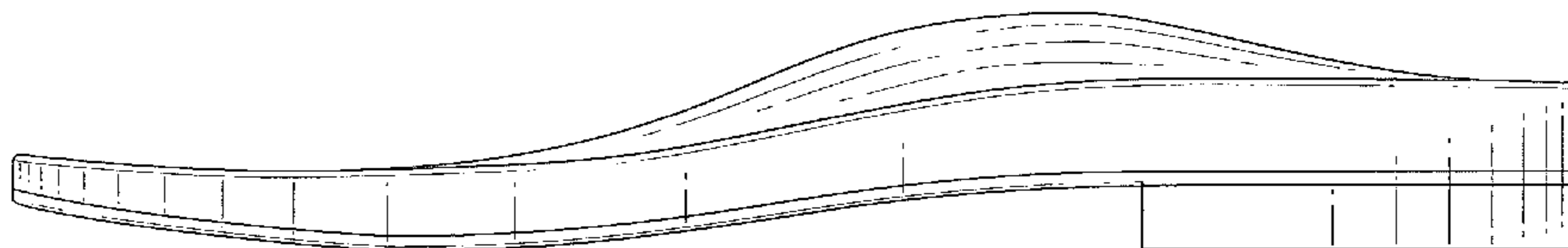
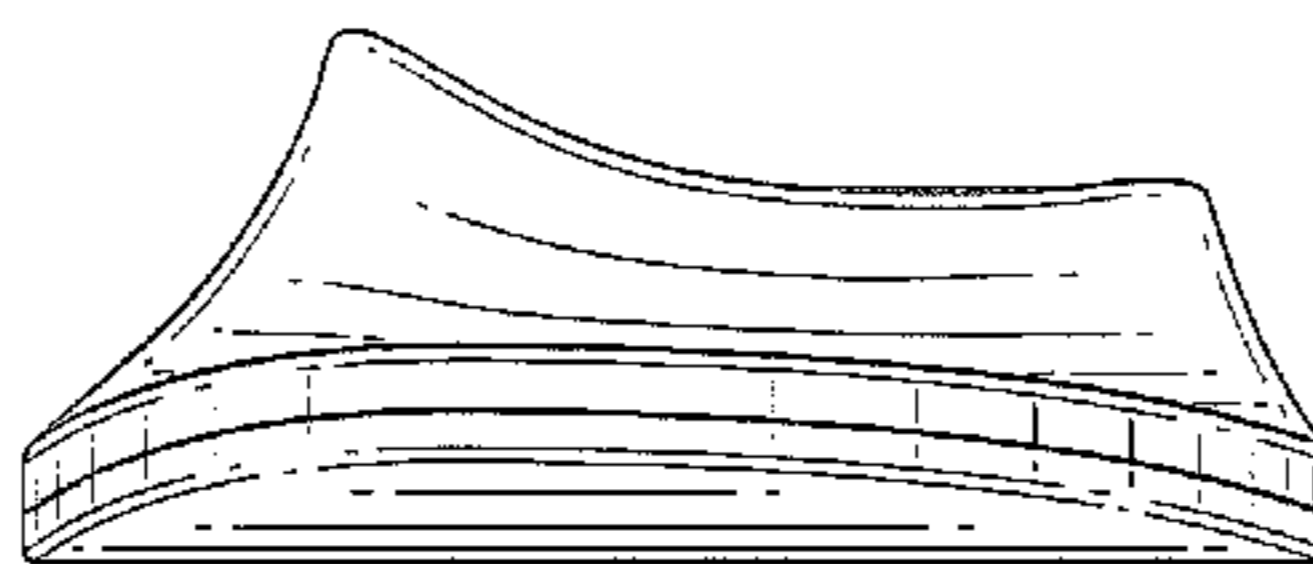
FIG. 1 is a perspective view of my ornamental design for a shoe midsole with heel;

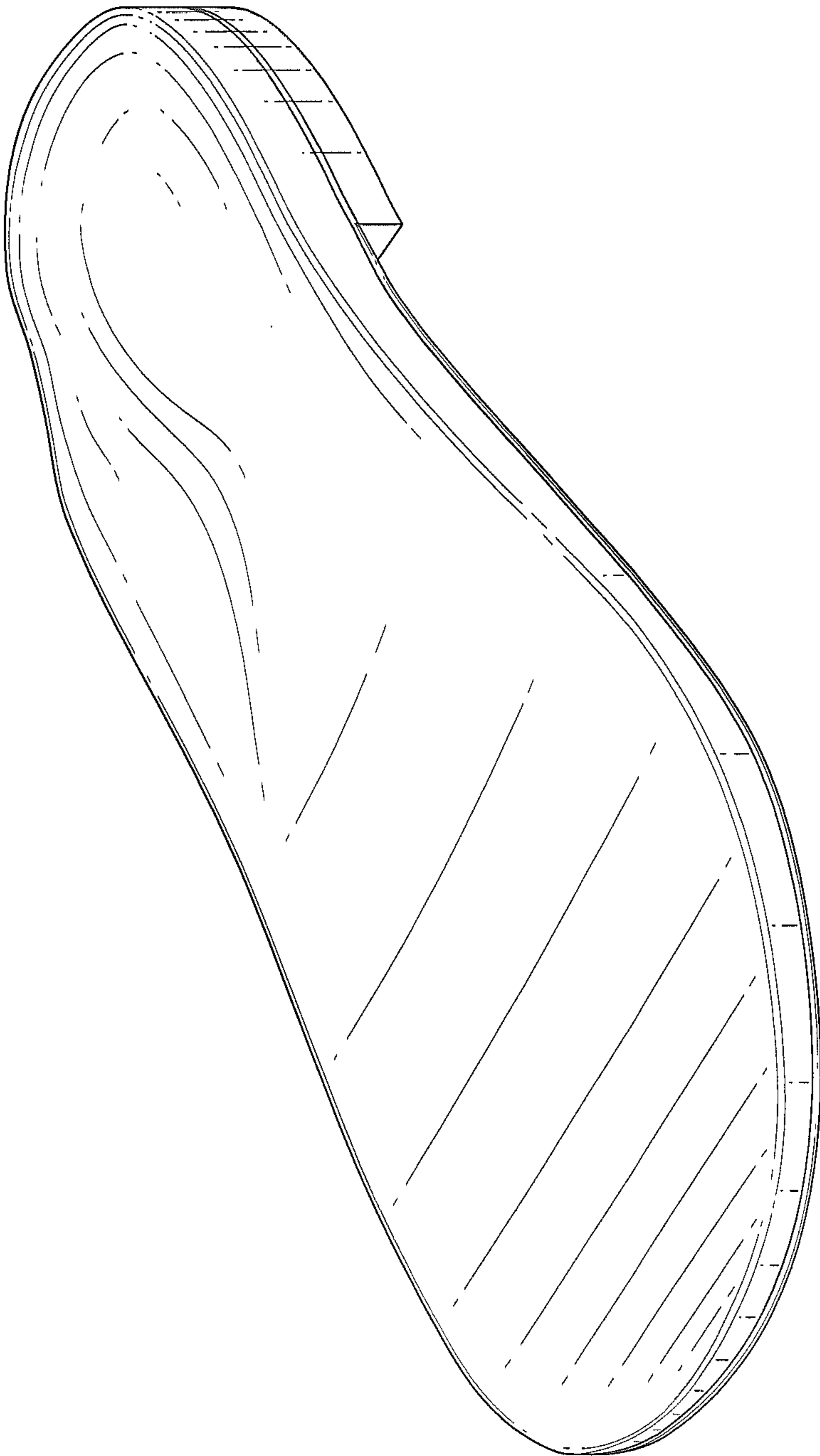

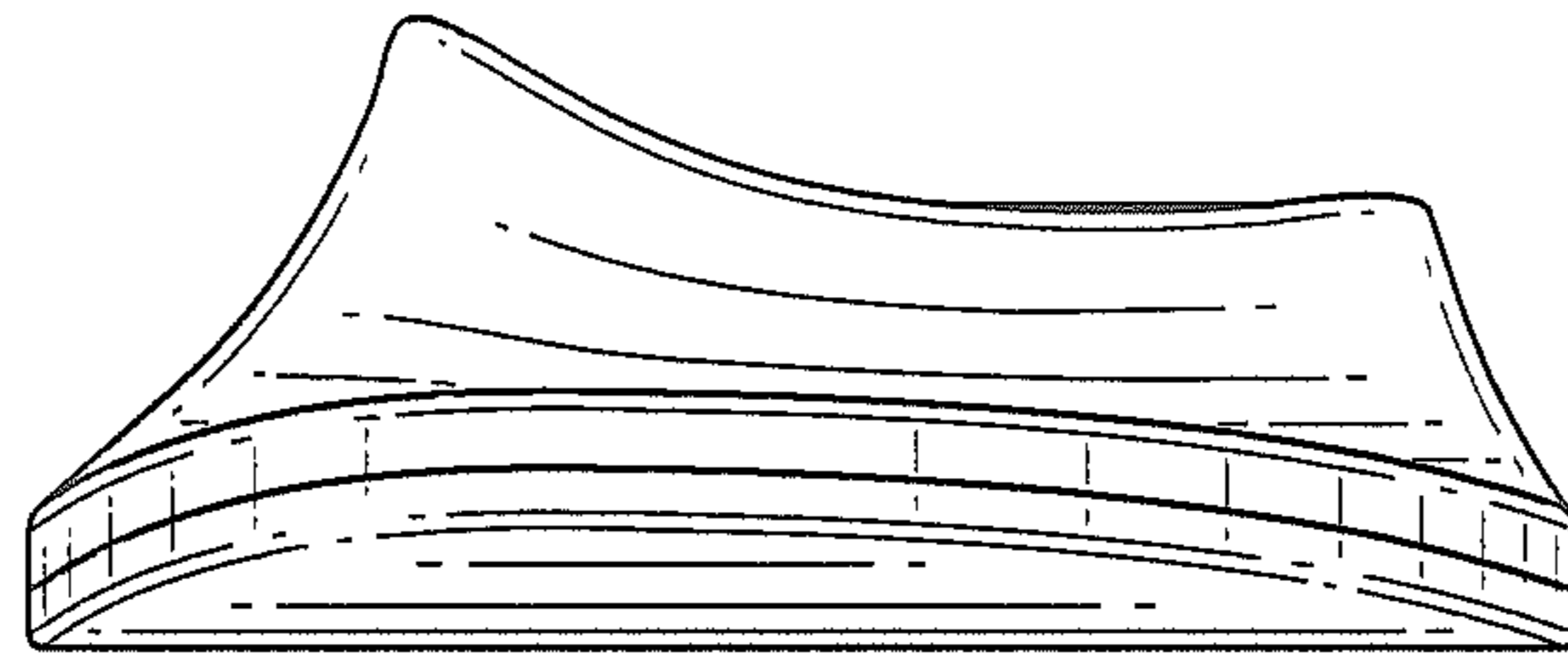

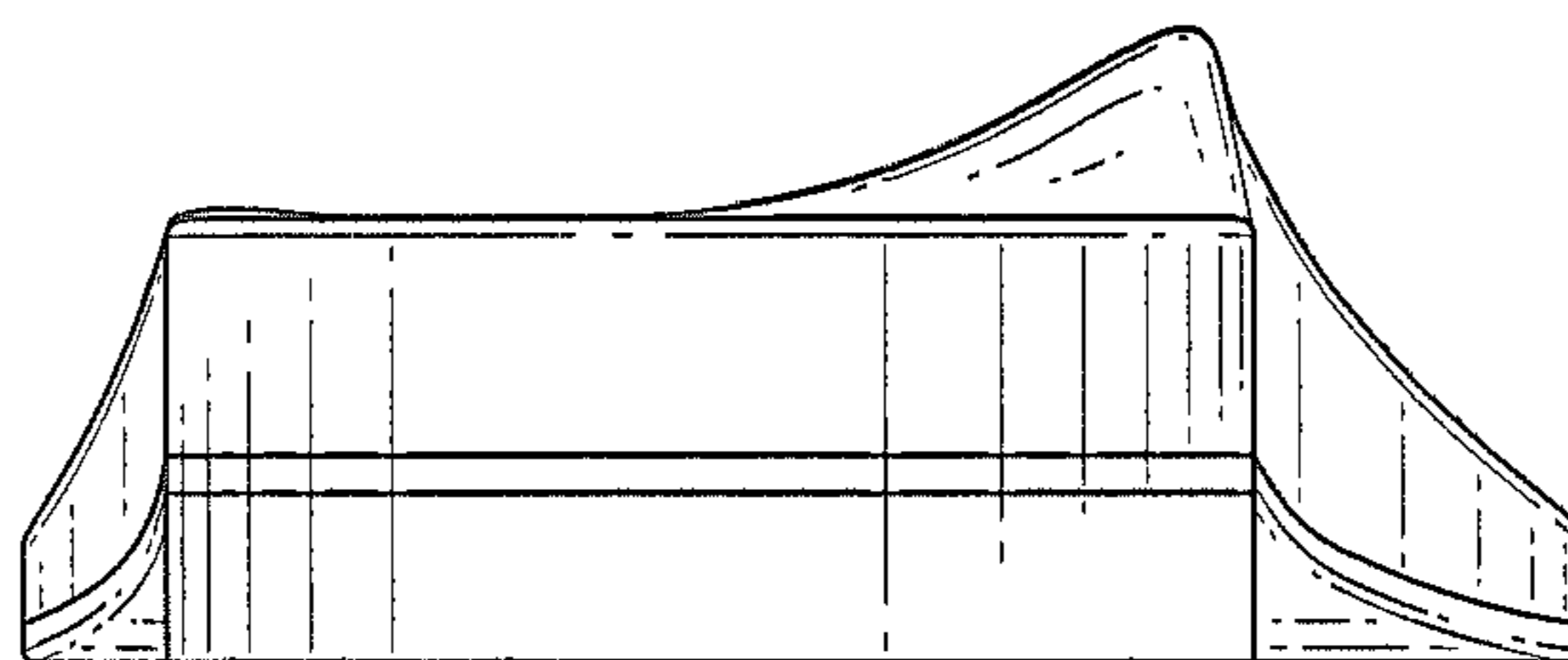

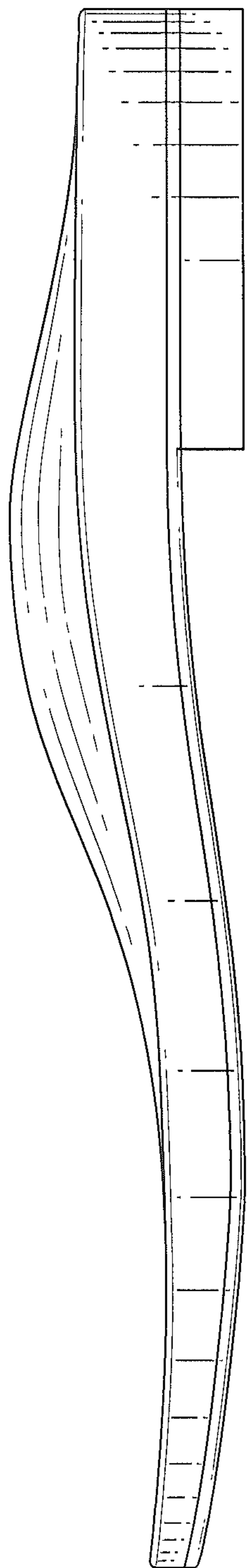

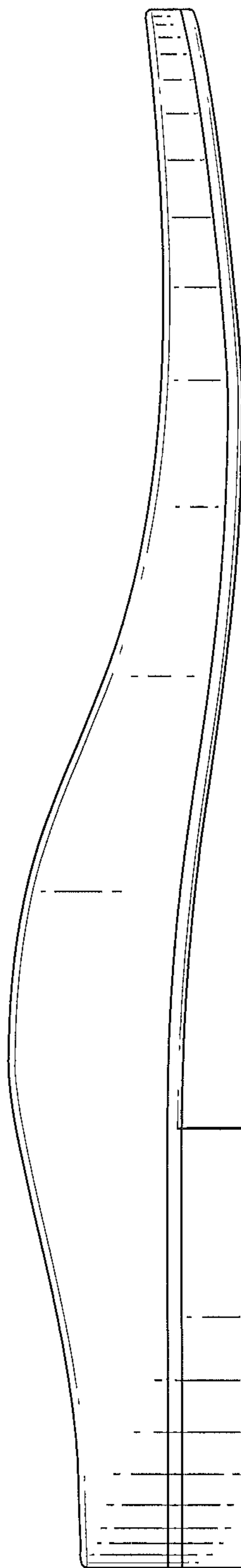

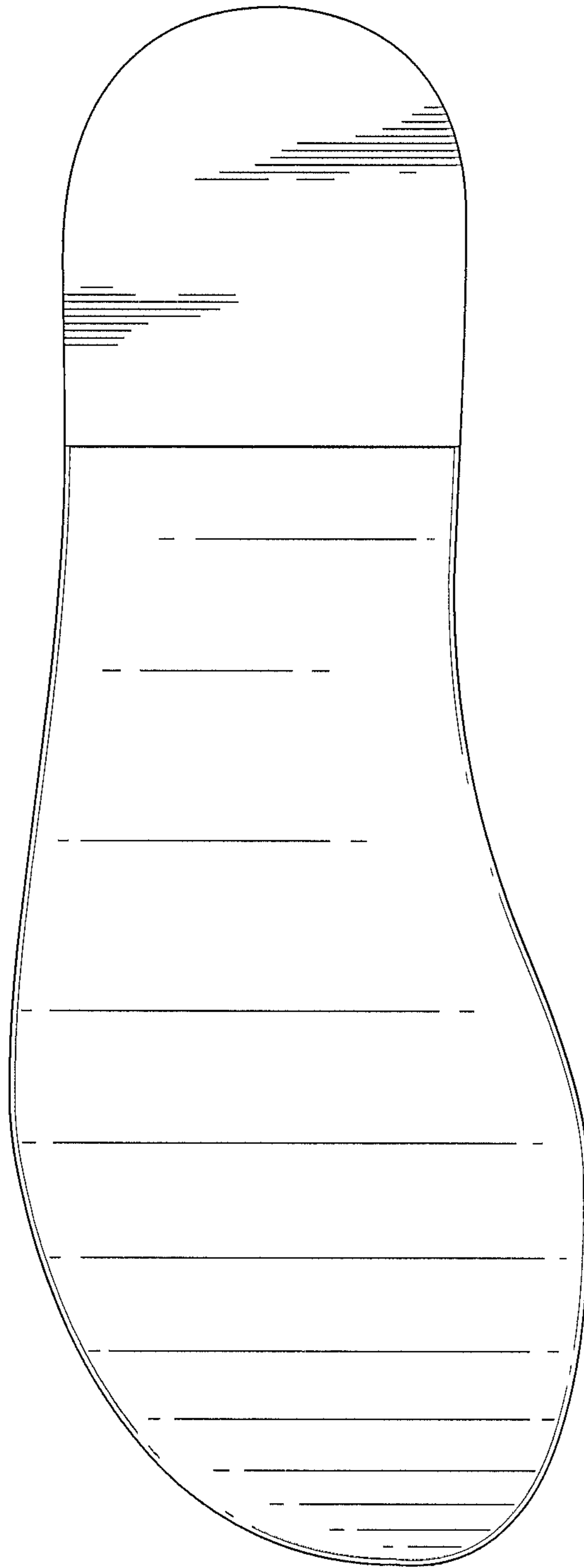
