(57) **CLAIM**

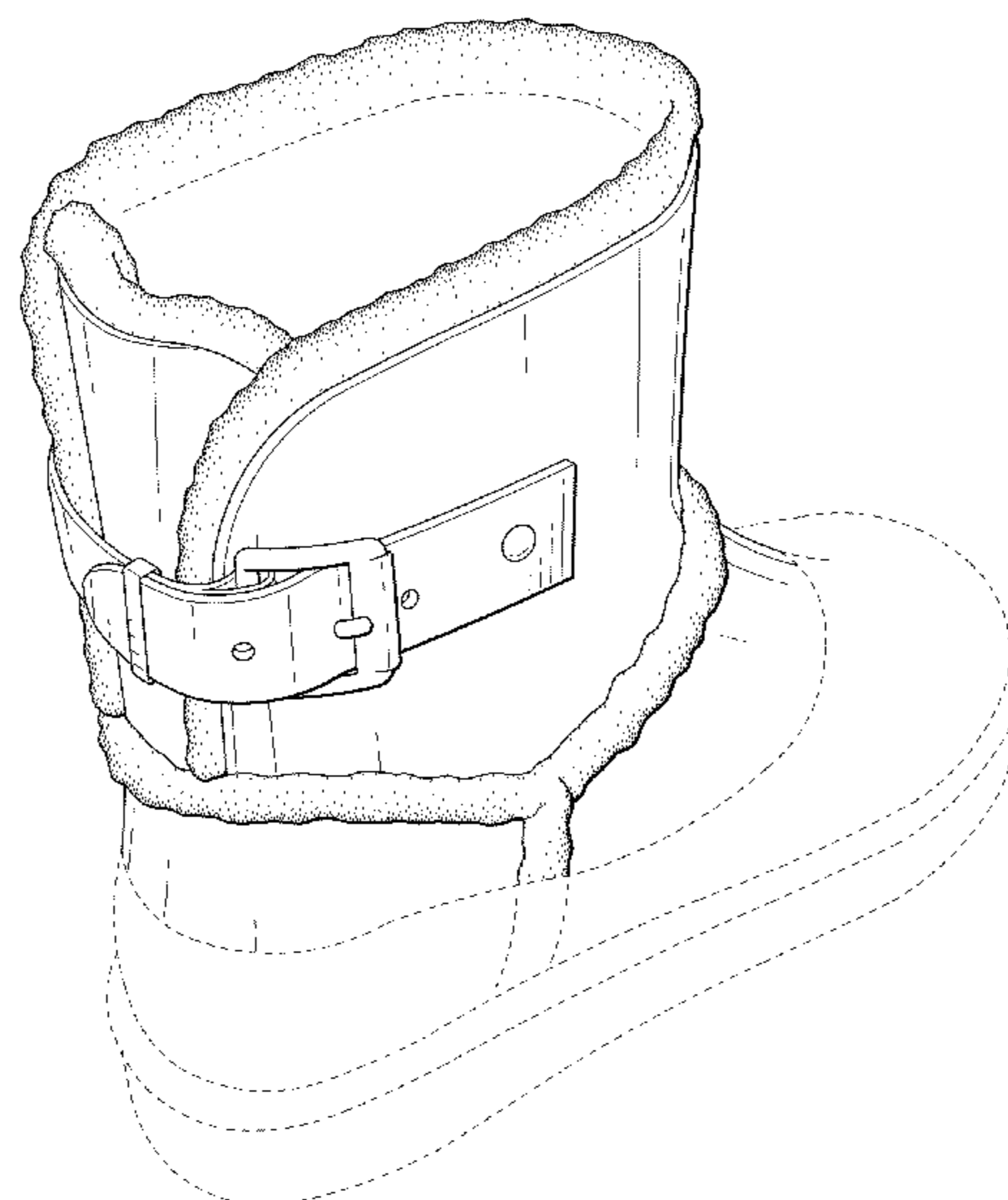
The ornamental design for a footwear upper, as shown and

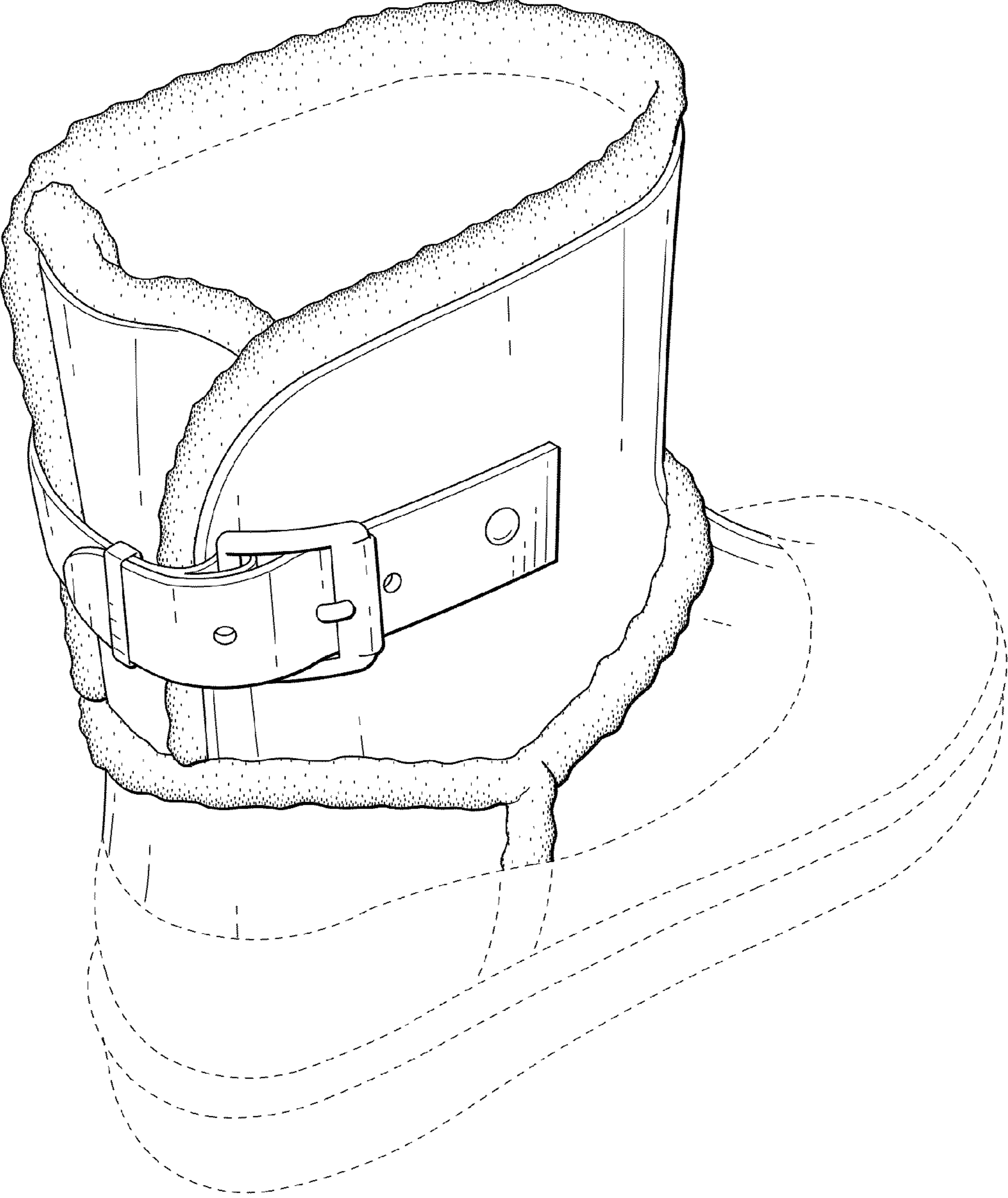

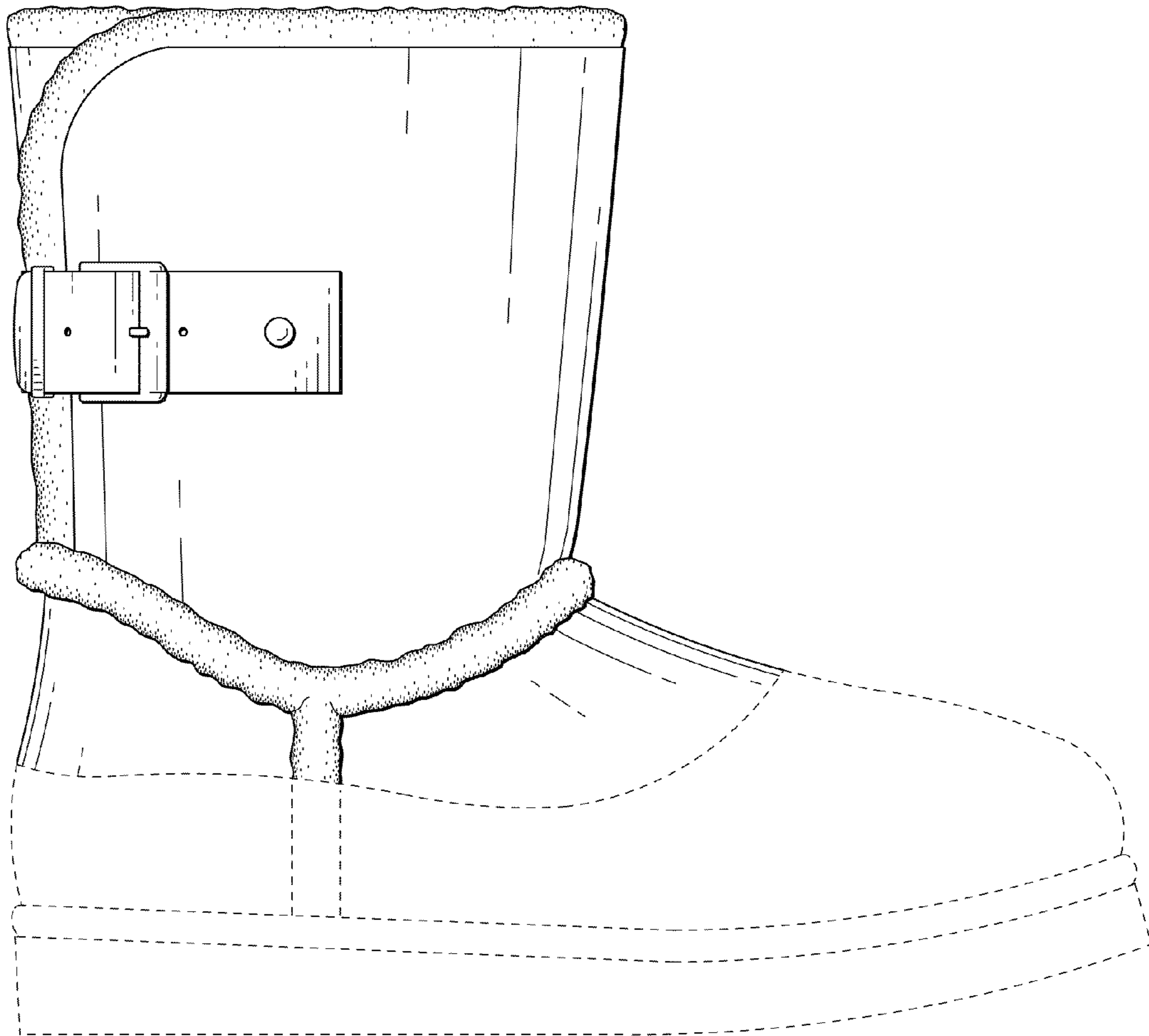

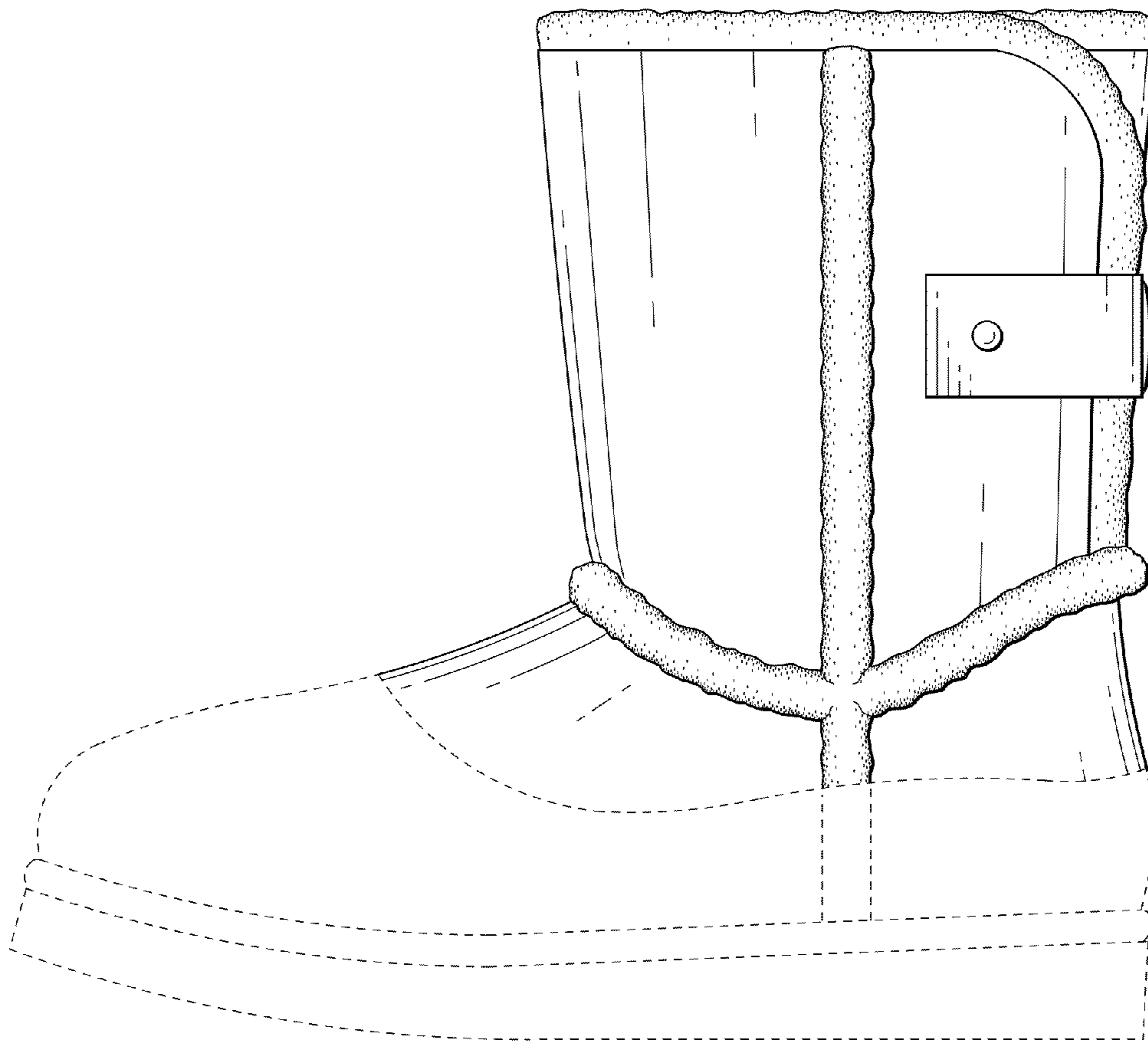

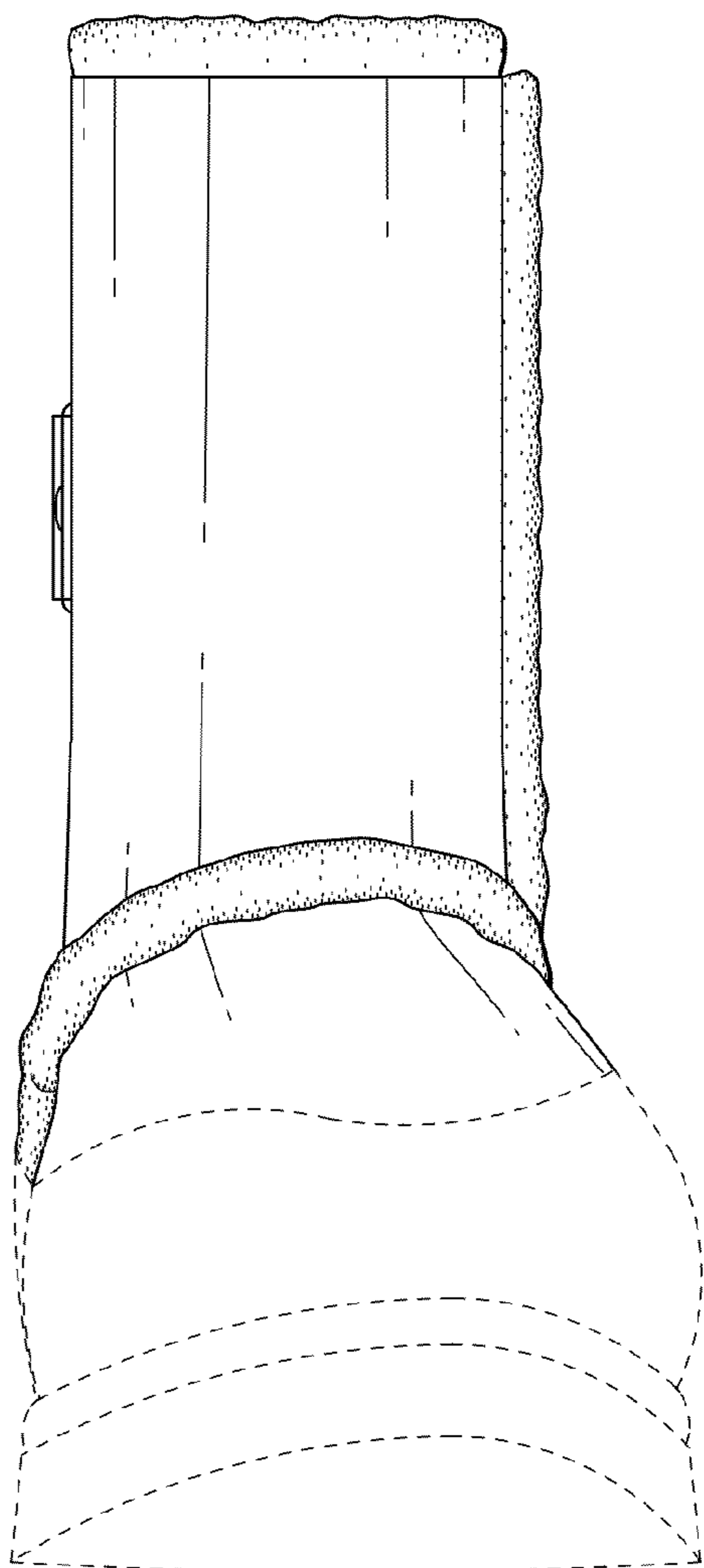

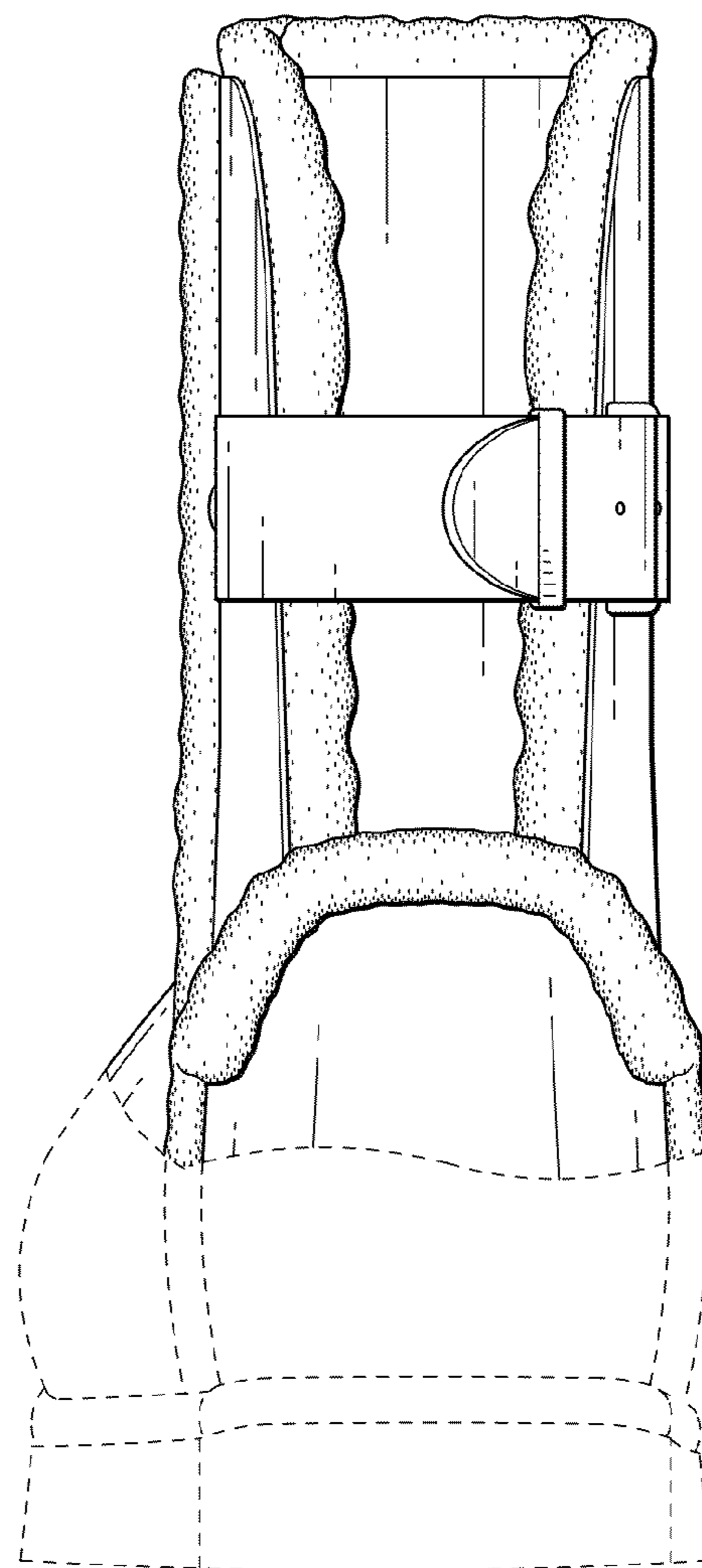

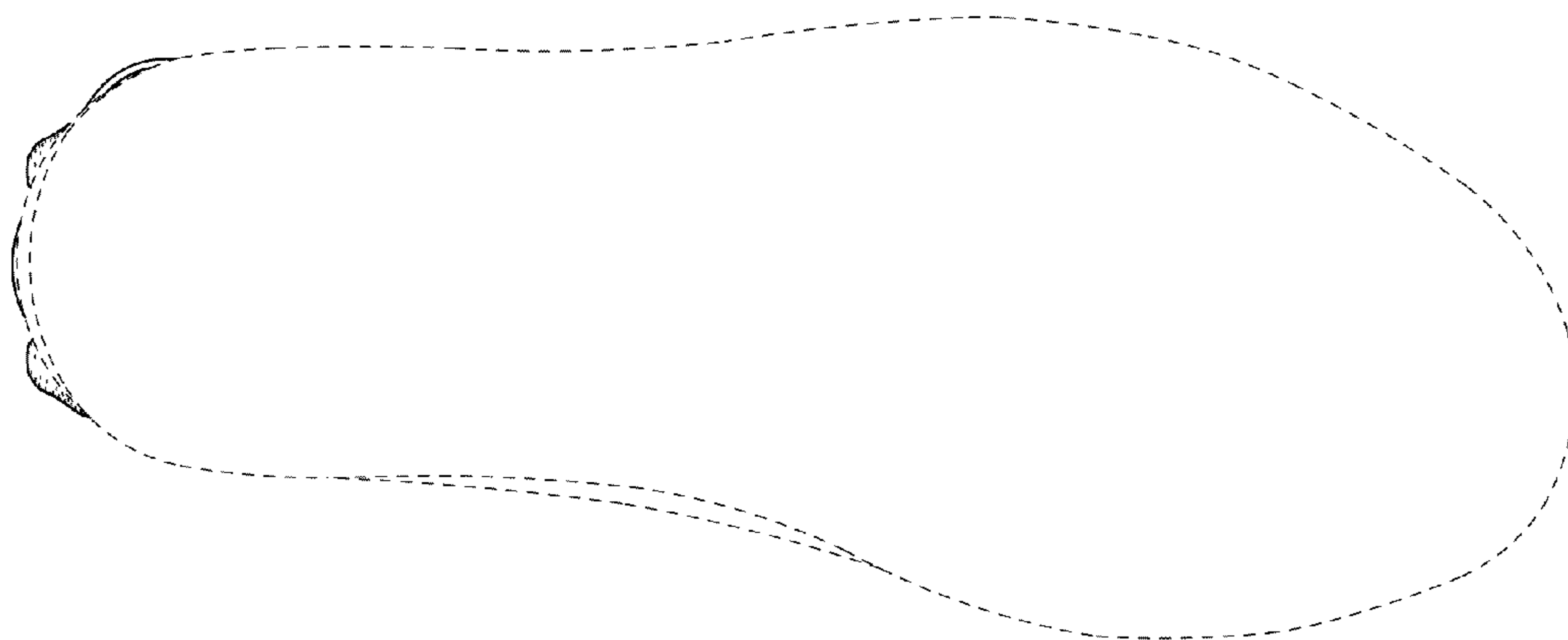

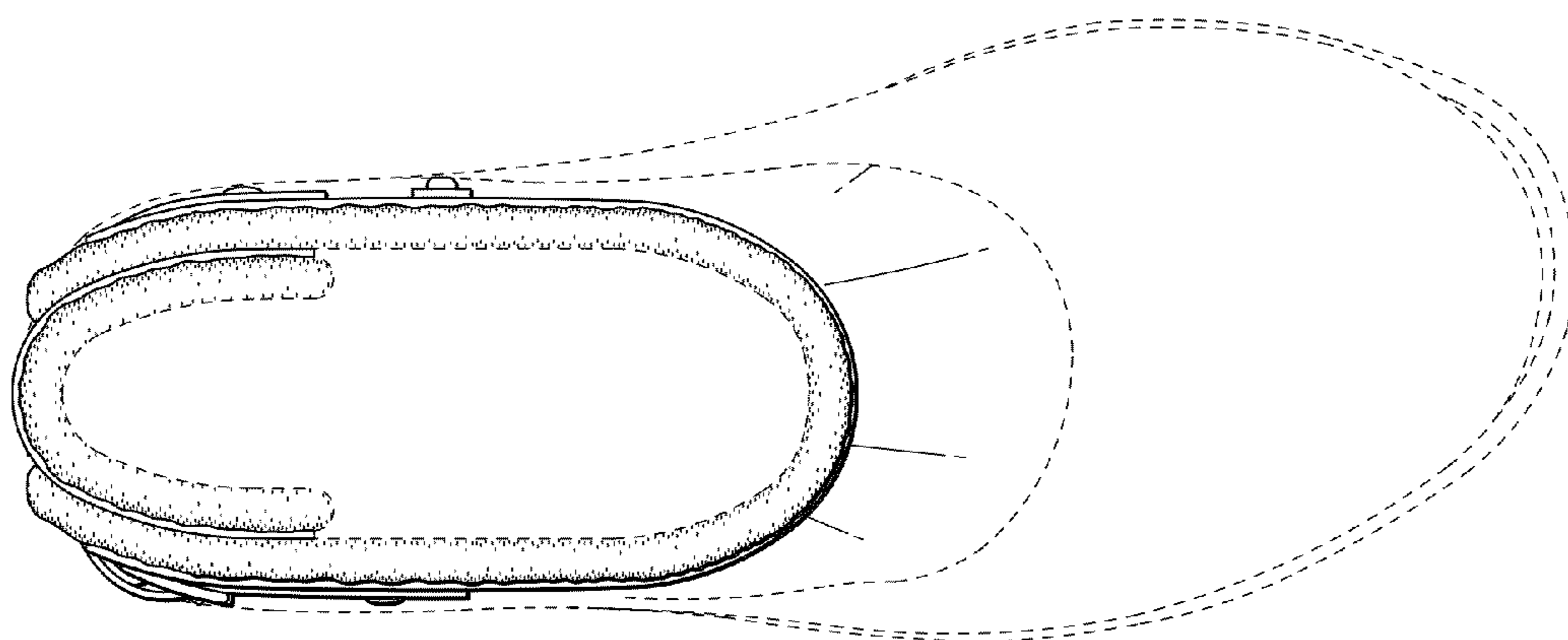
