The ornamental design for a glue brush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the glue brush.

FIG. 2 is a side plan view thereof, the sides being symmetric.

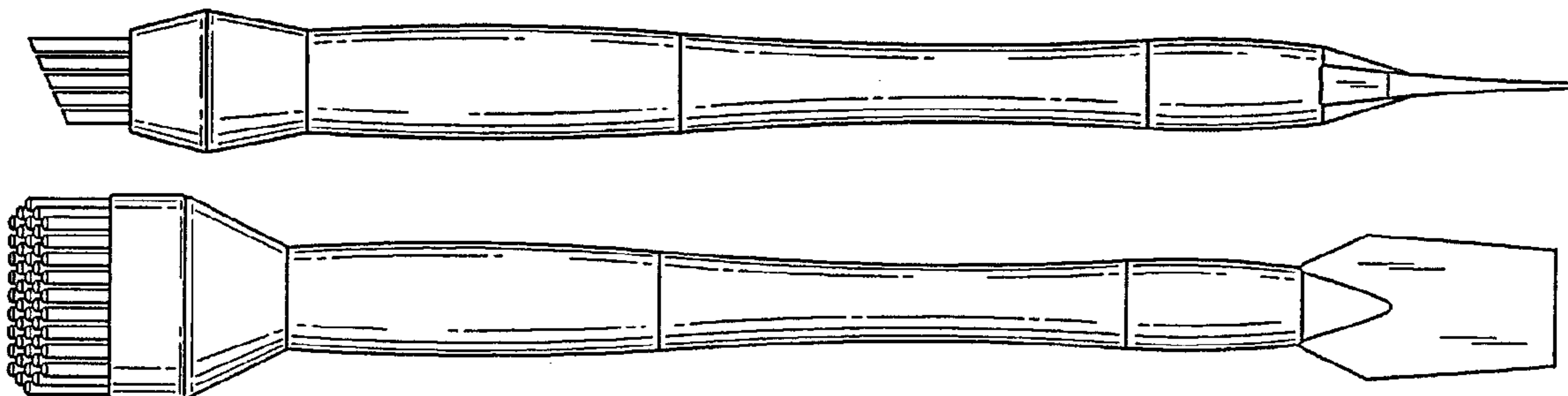
FIG. 3 is a top plan view thereof.

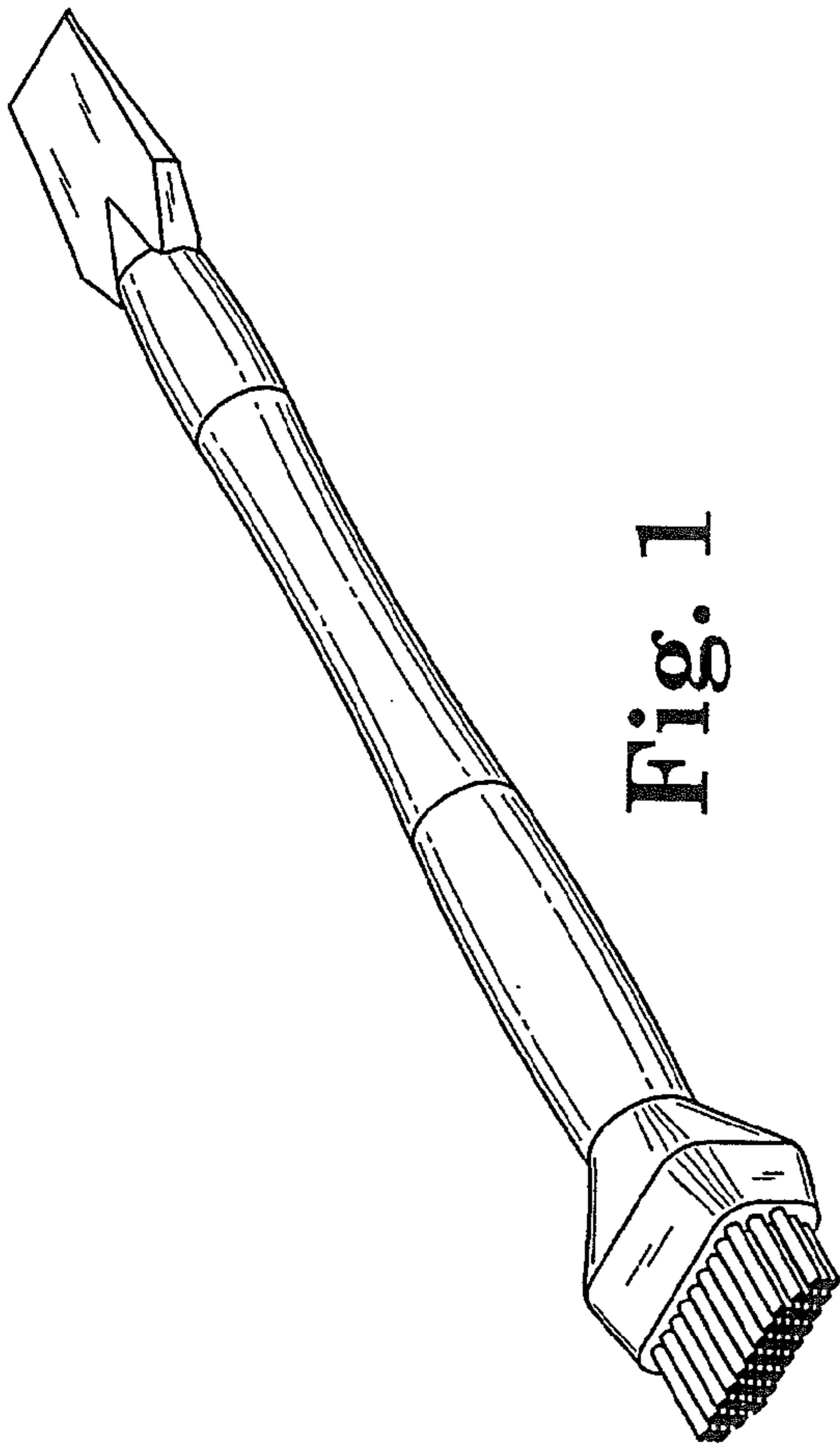

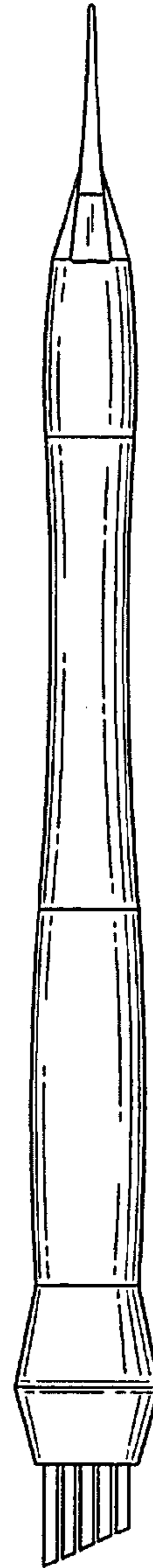

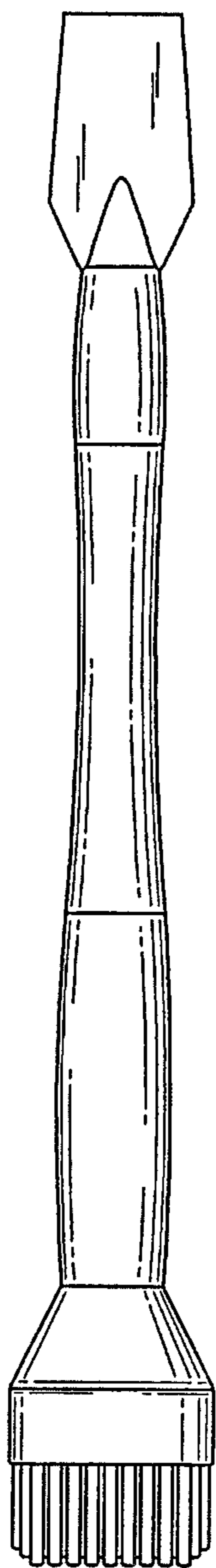

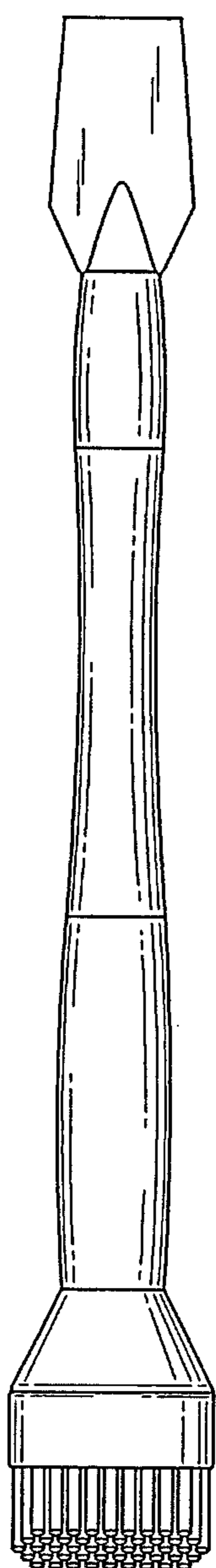

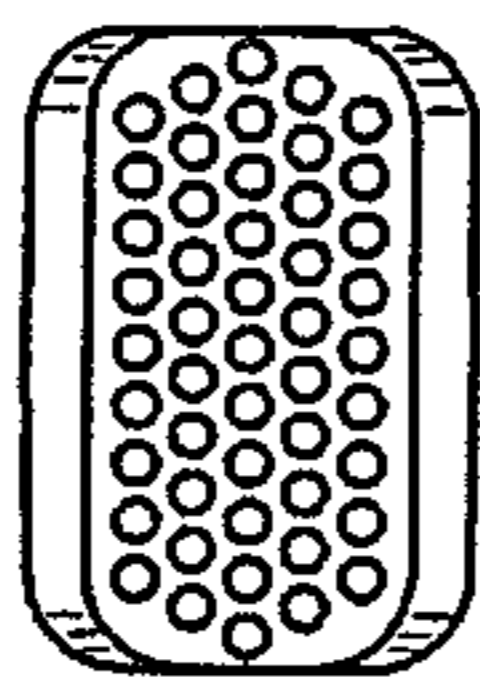
