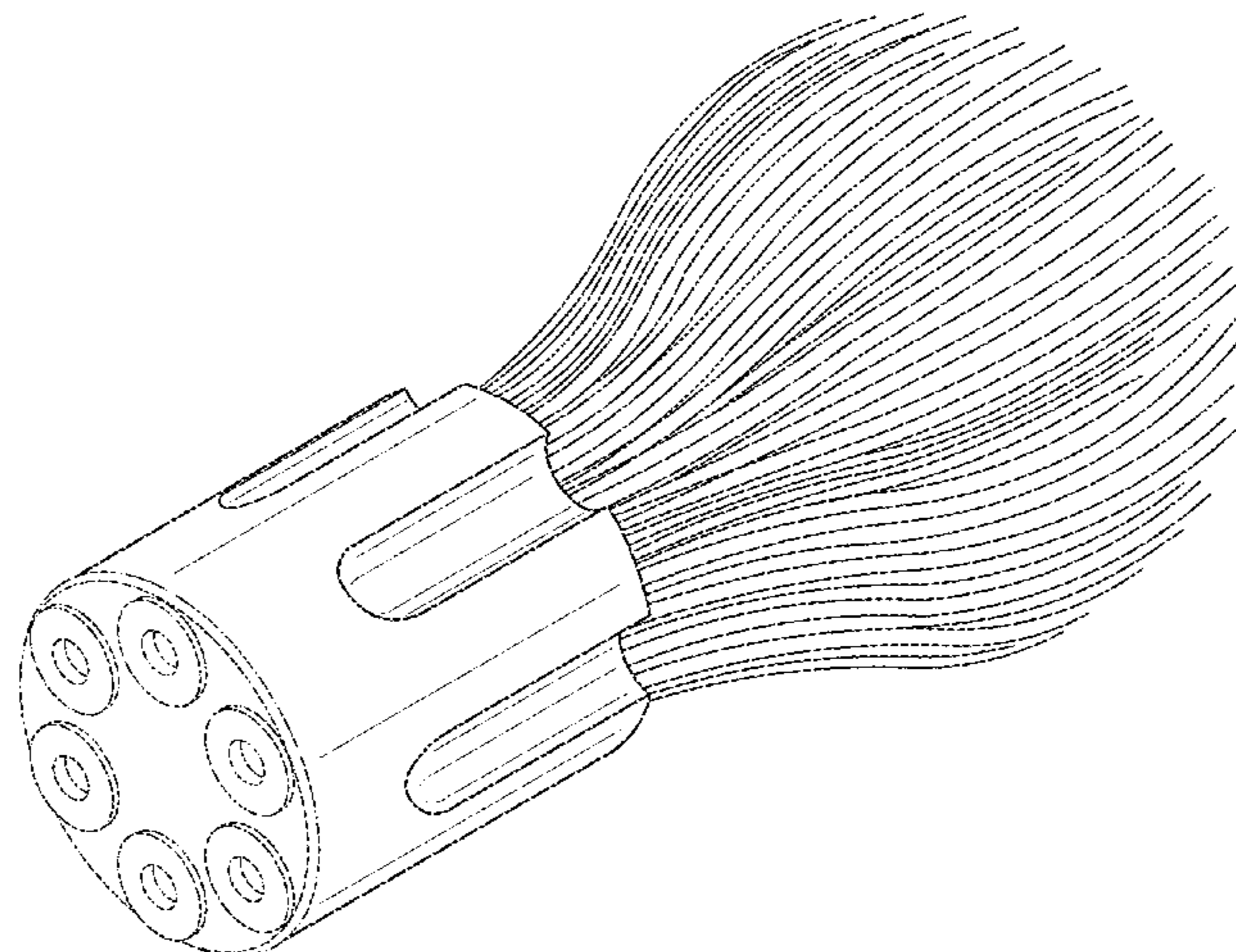
**CLAIM**

The ornamental design for a shaving cream applicator brush,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shaving cream applicator  
brush showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof; and,  
FIG. 5 is a side view thereof.  
The dash-dot-dash broken lines shown in FIGS. 1, 2, 4, and 5  
represent the bounds of the claim and form no part thereof.  
The dash-dash broken lines shown in FIGS. 1, 2, 4, and 5  
illustrate portions of the shaving cream applicator brush that  
form no part of the claimed design.

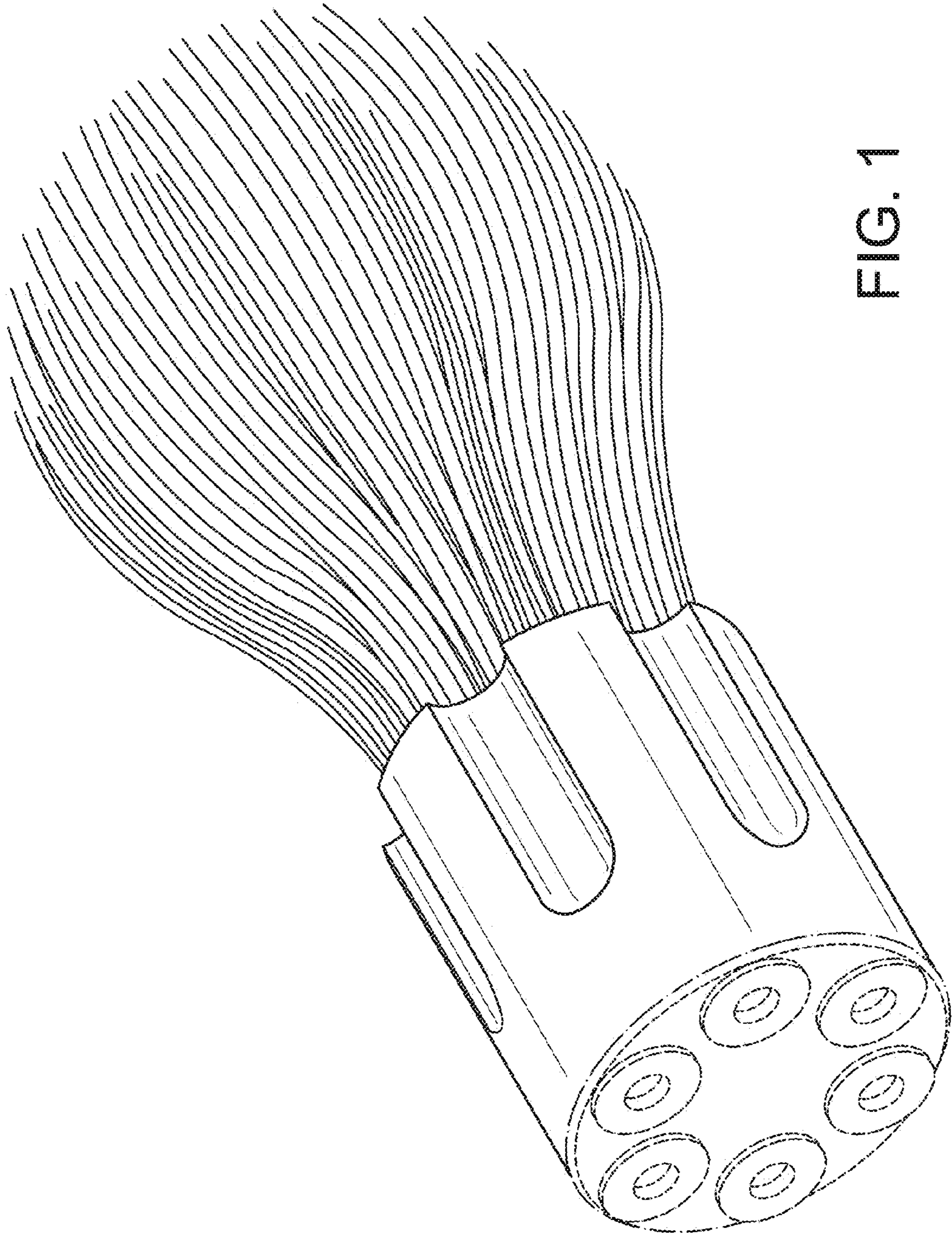

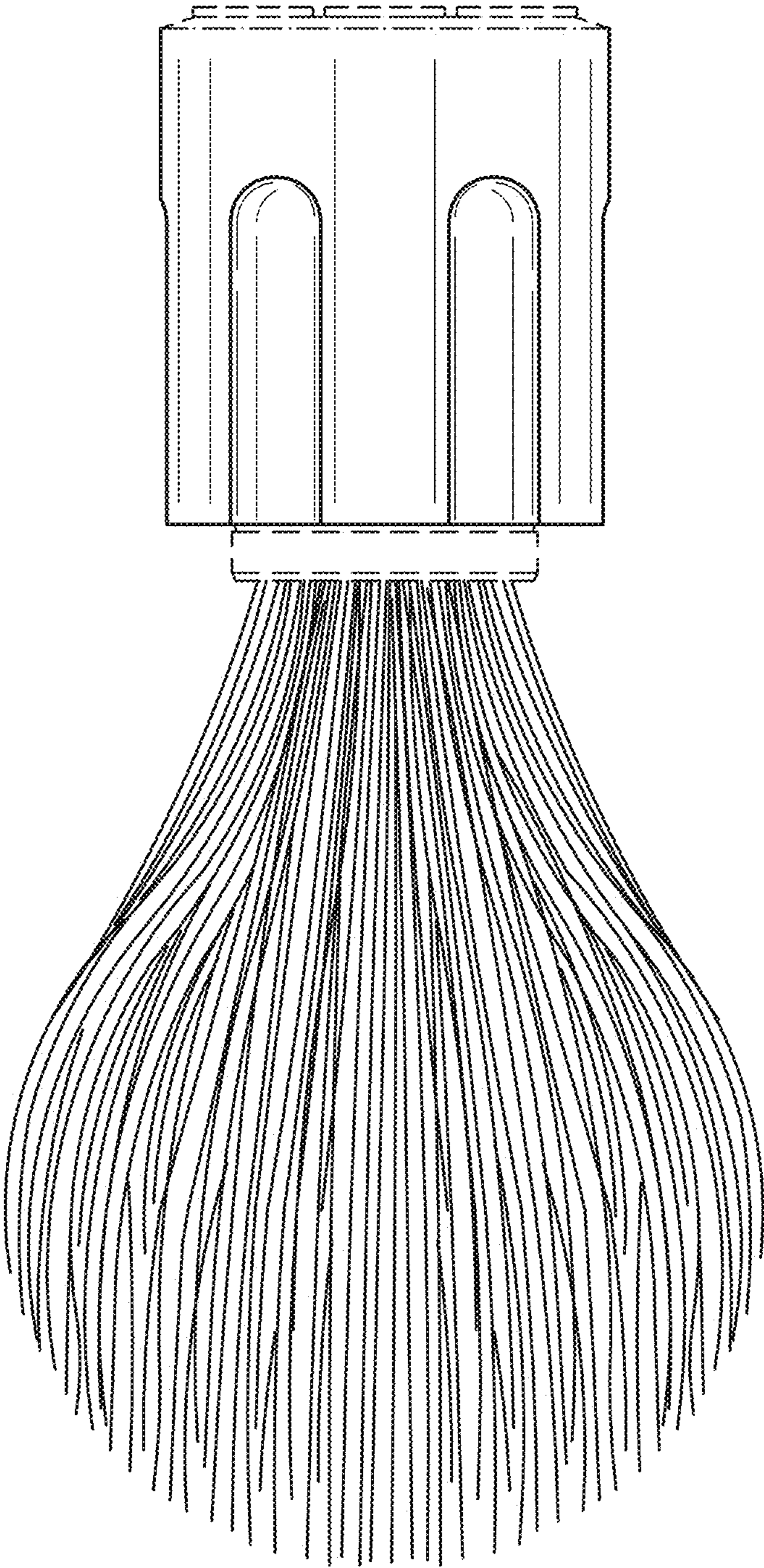

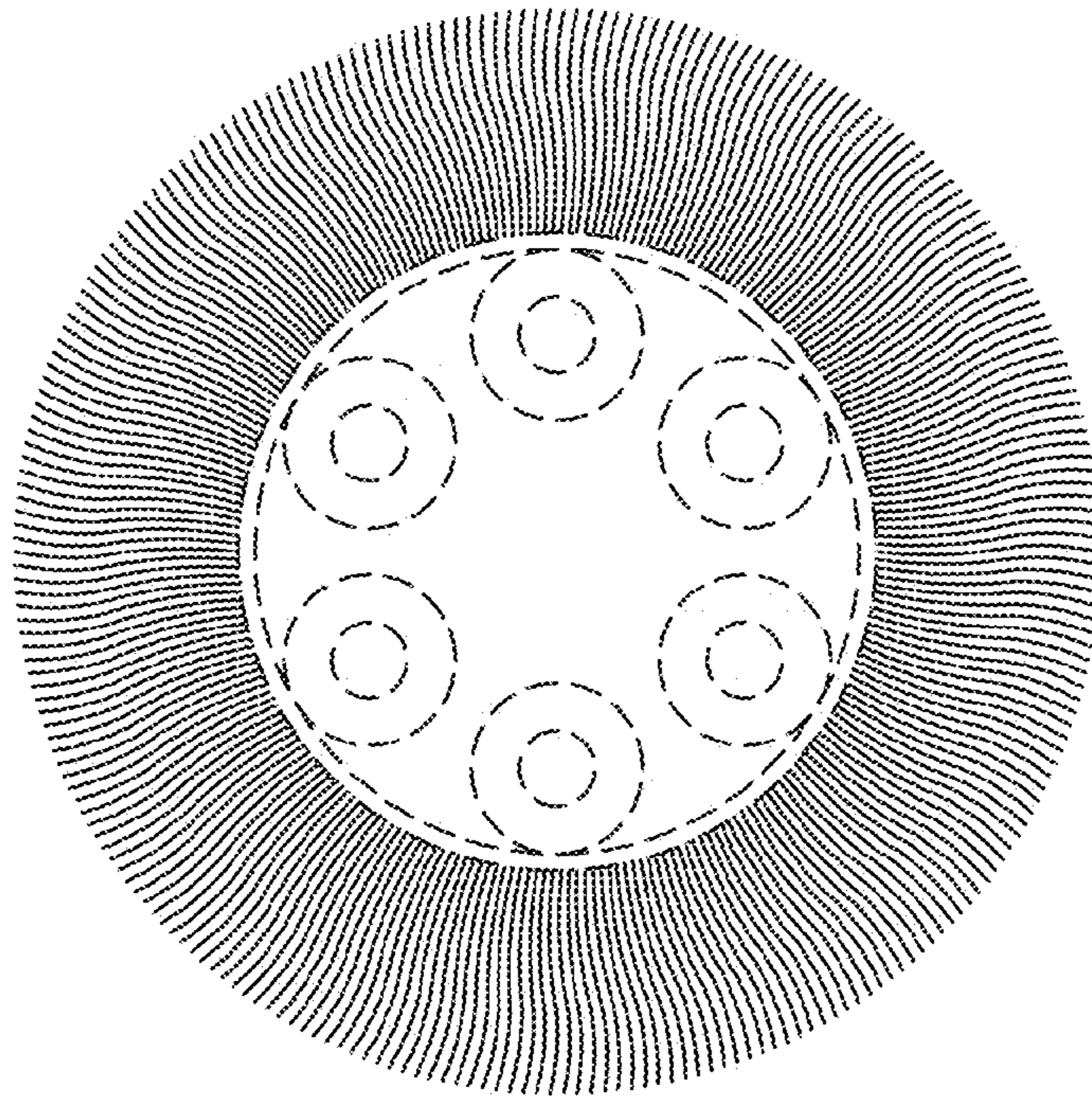

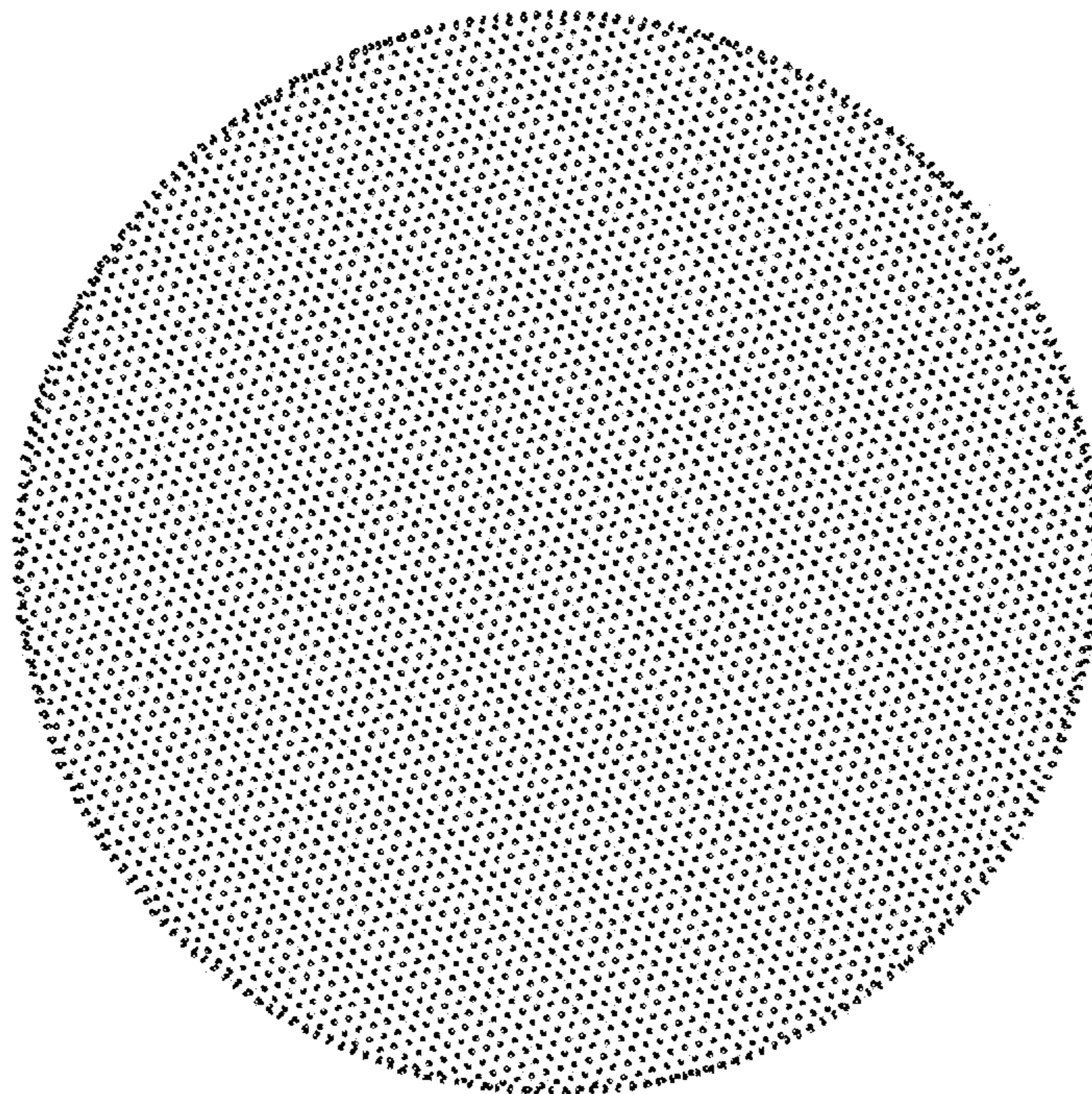

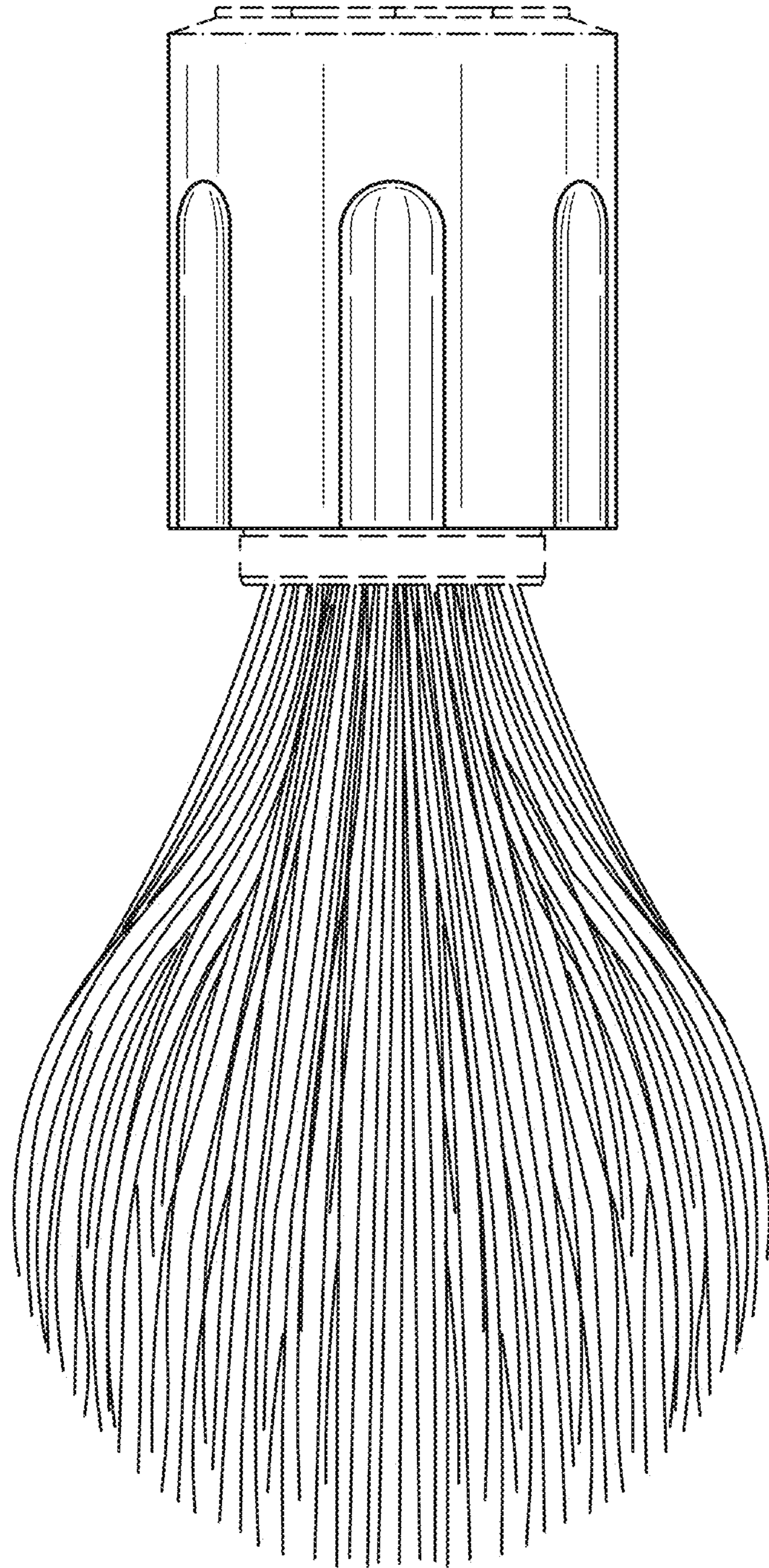
