DESCRIPTION

FIG. 1 is an isometric view of a mug showing my new design;
FIG. 2 is a rear elevational view thereof;

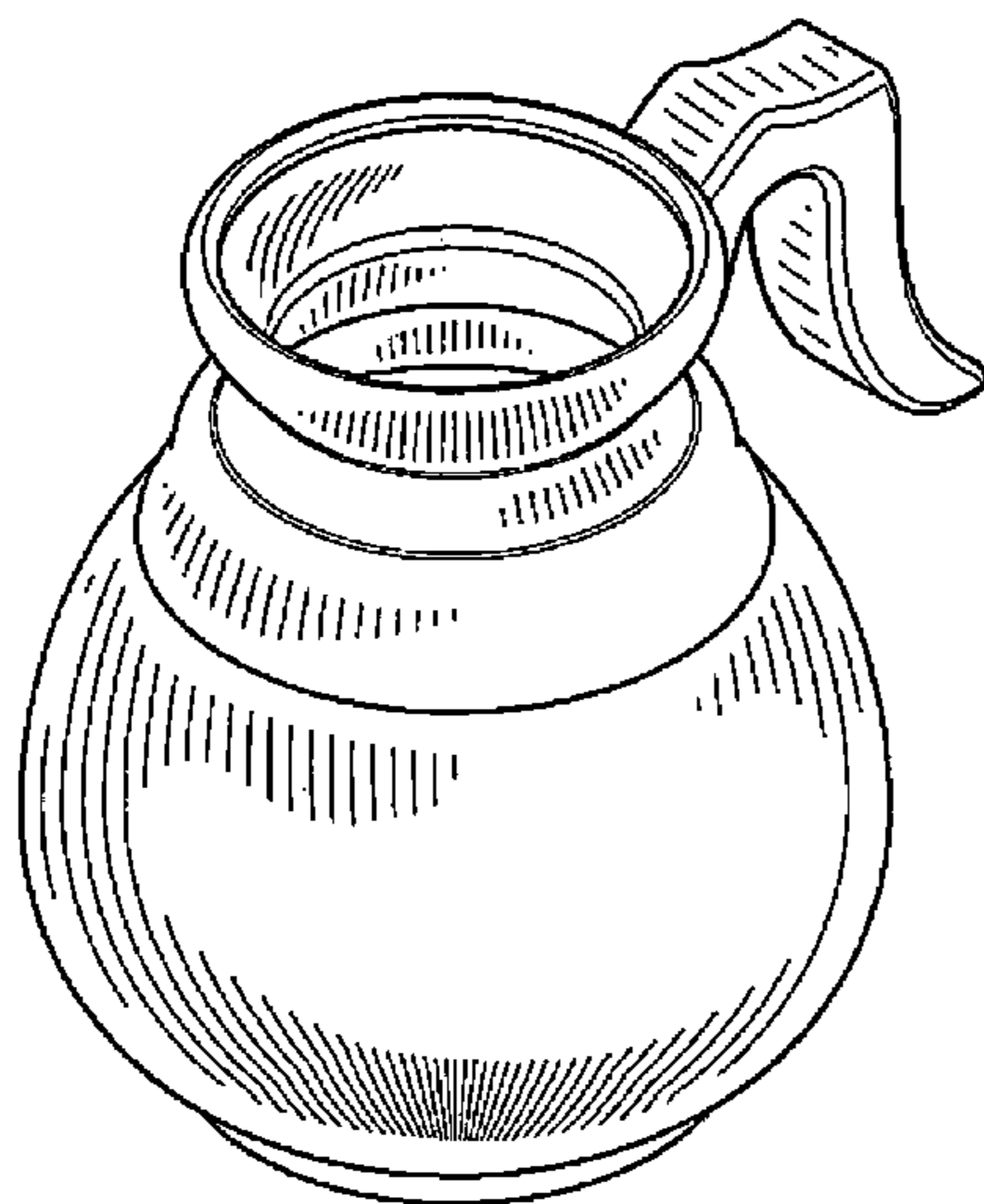

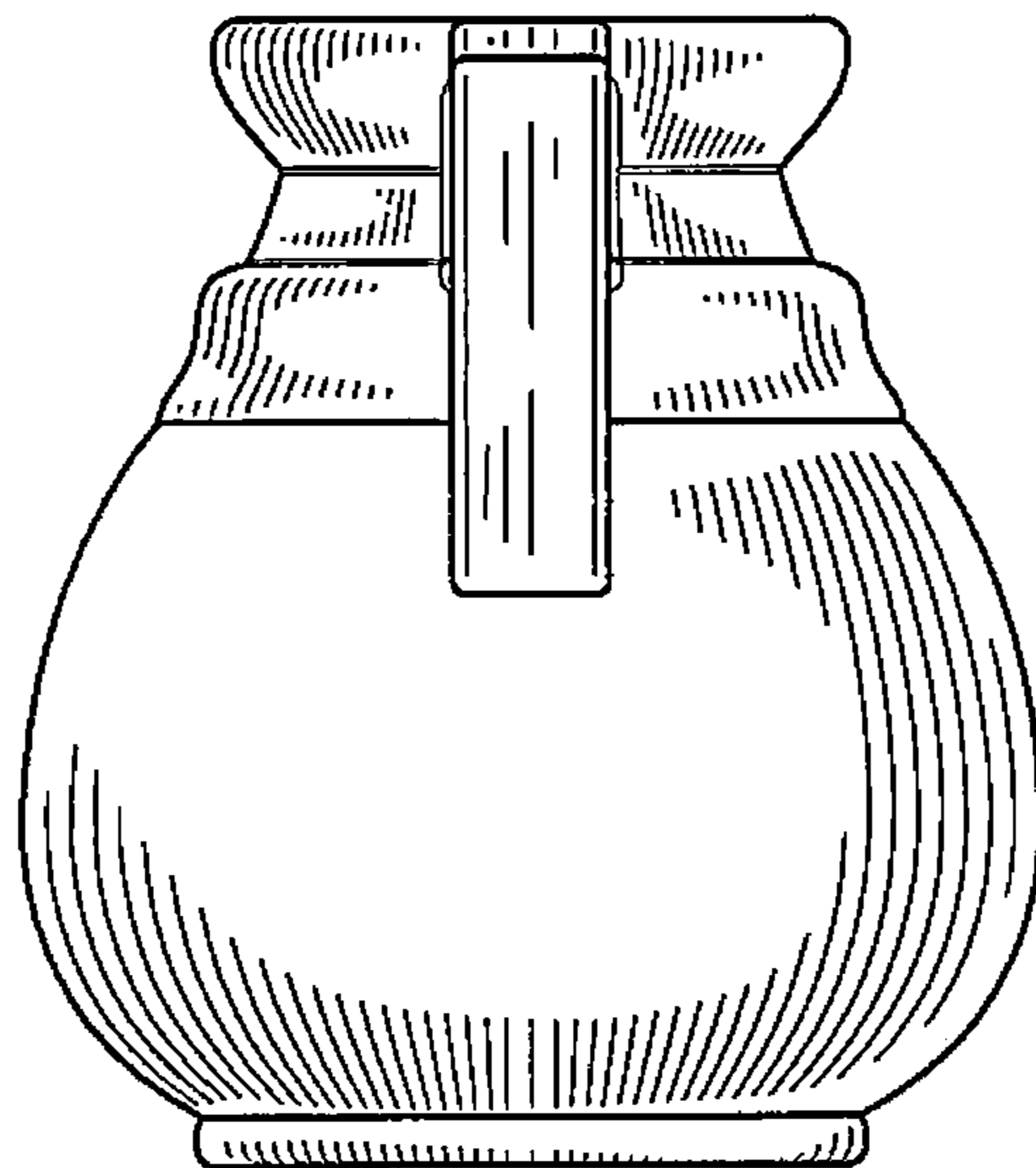

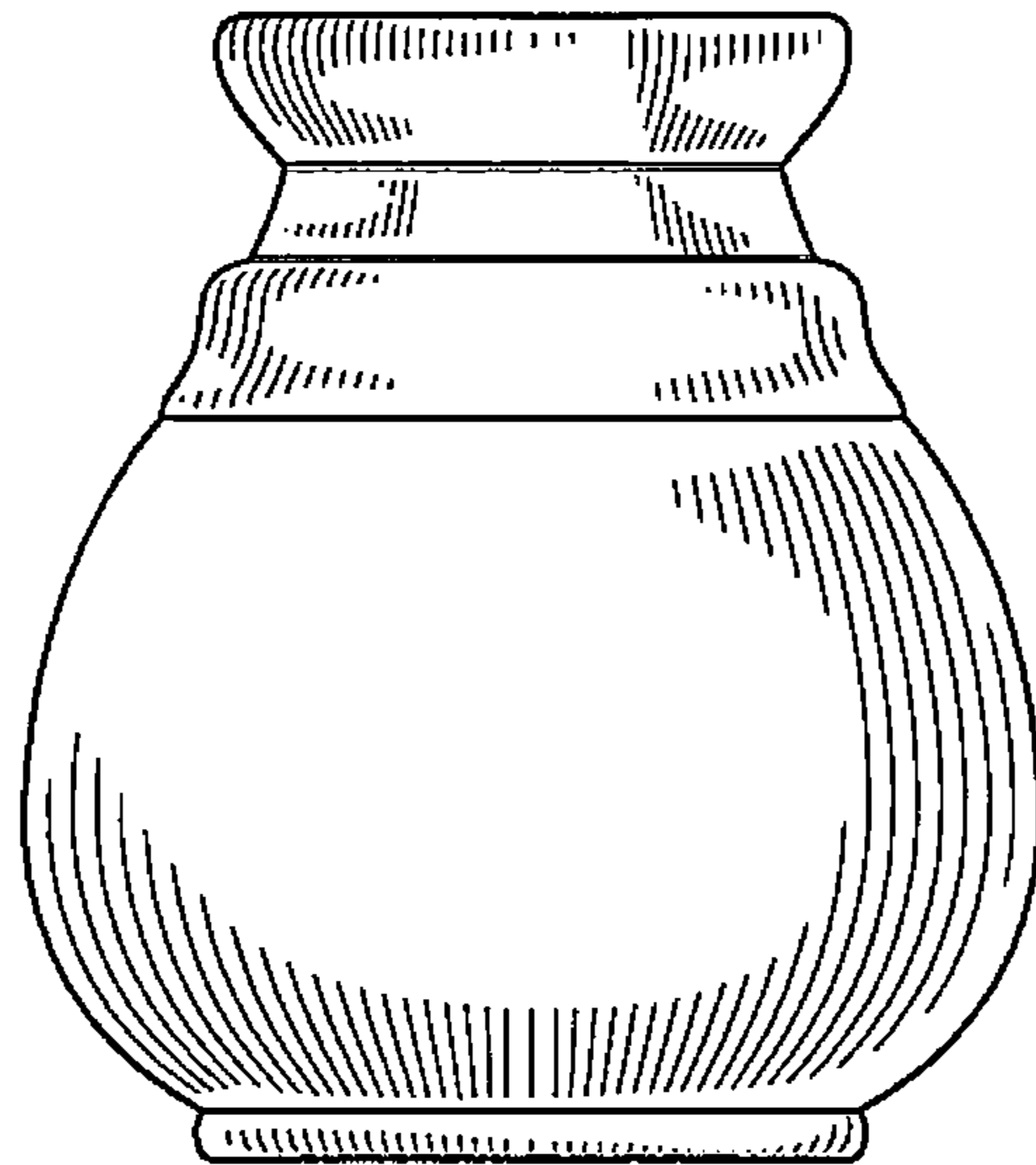

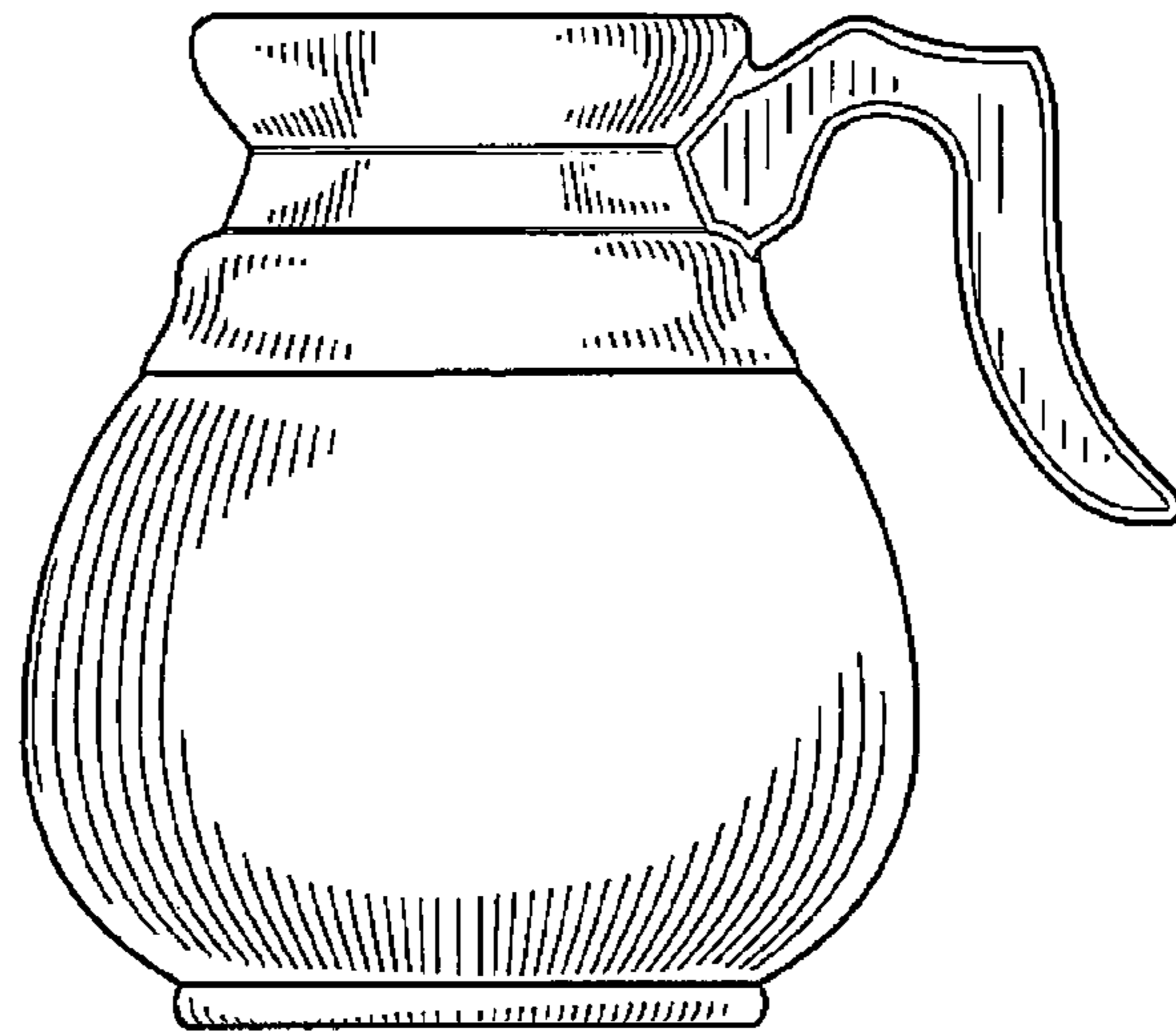

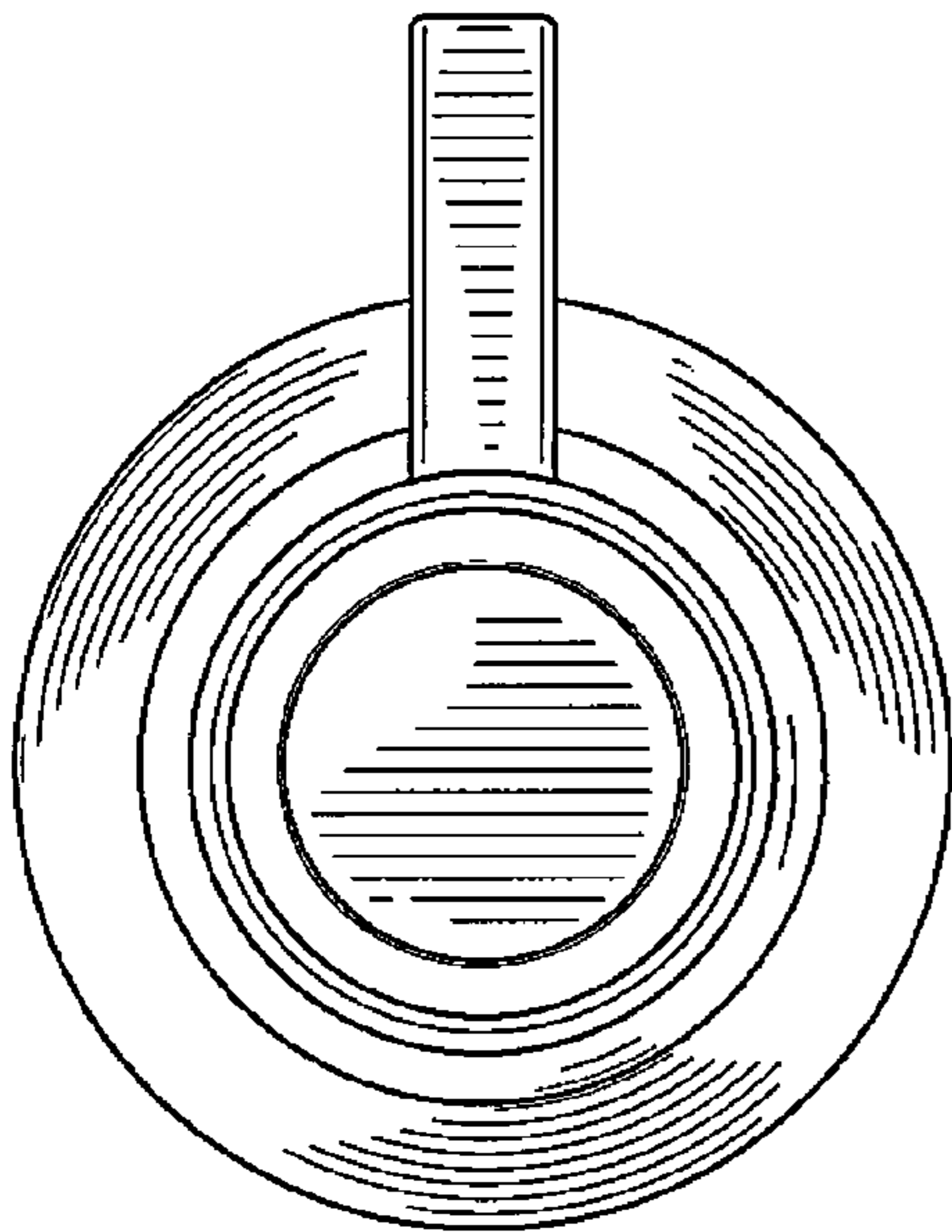

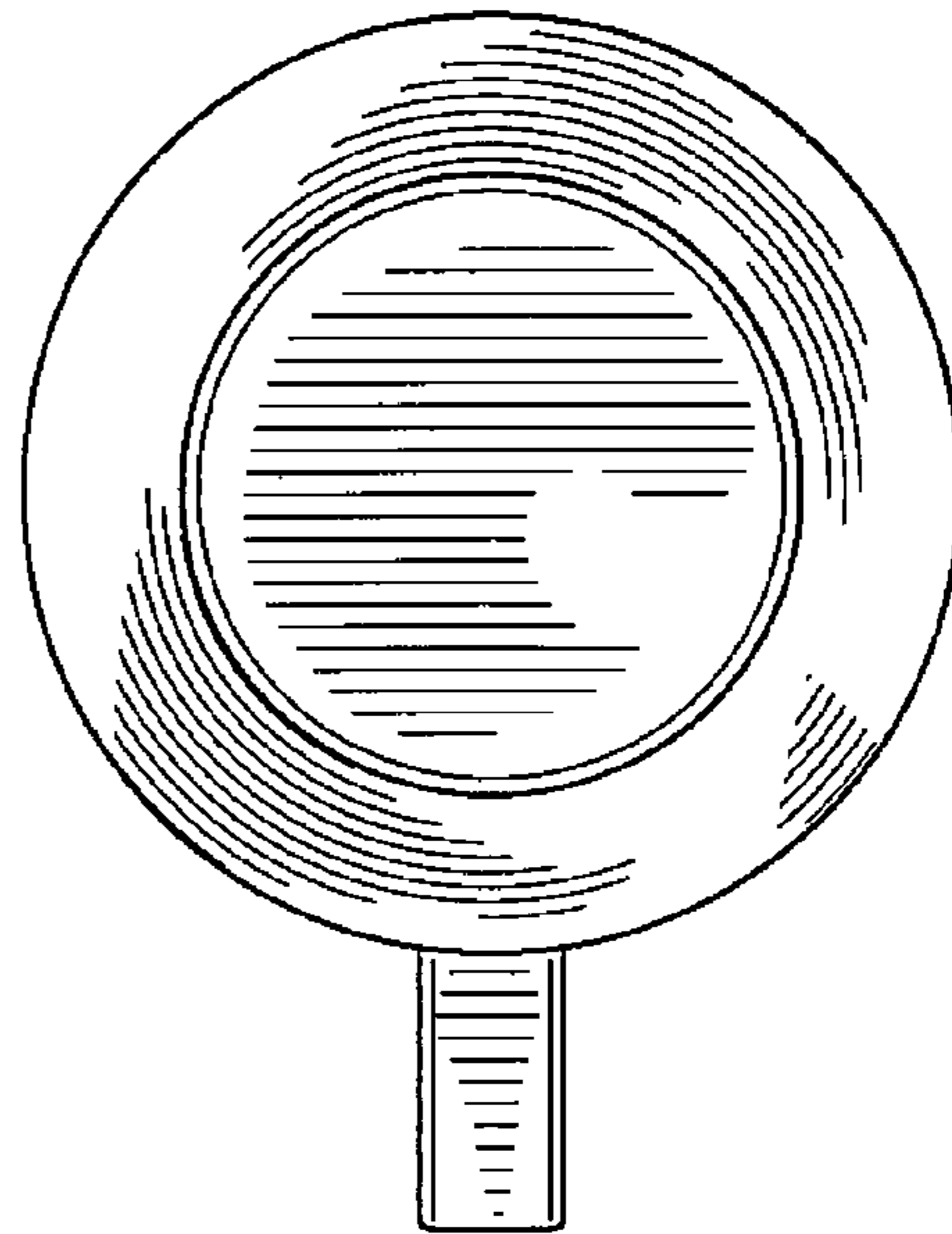
