(57) **CLAIM**

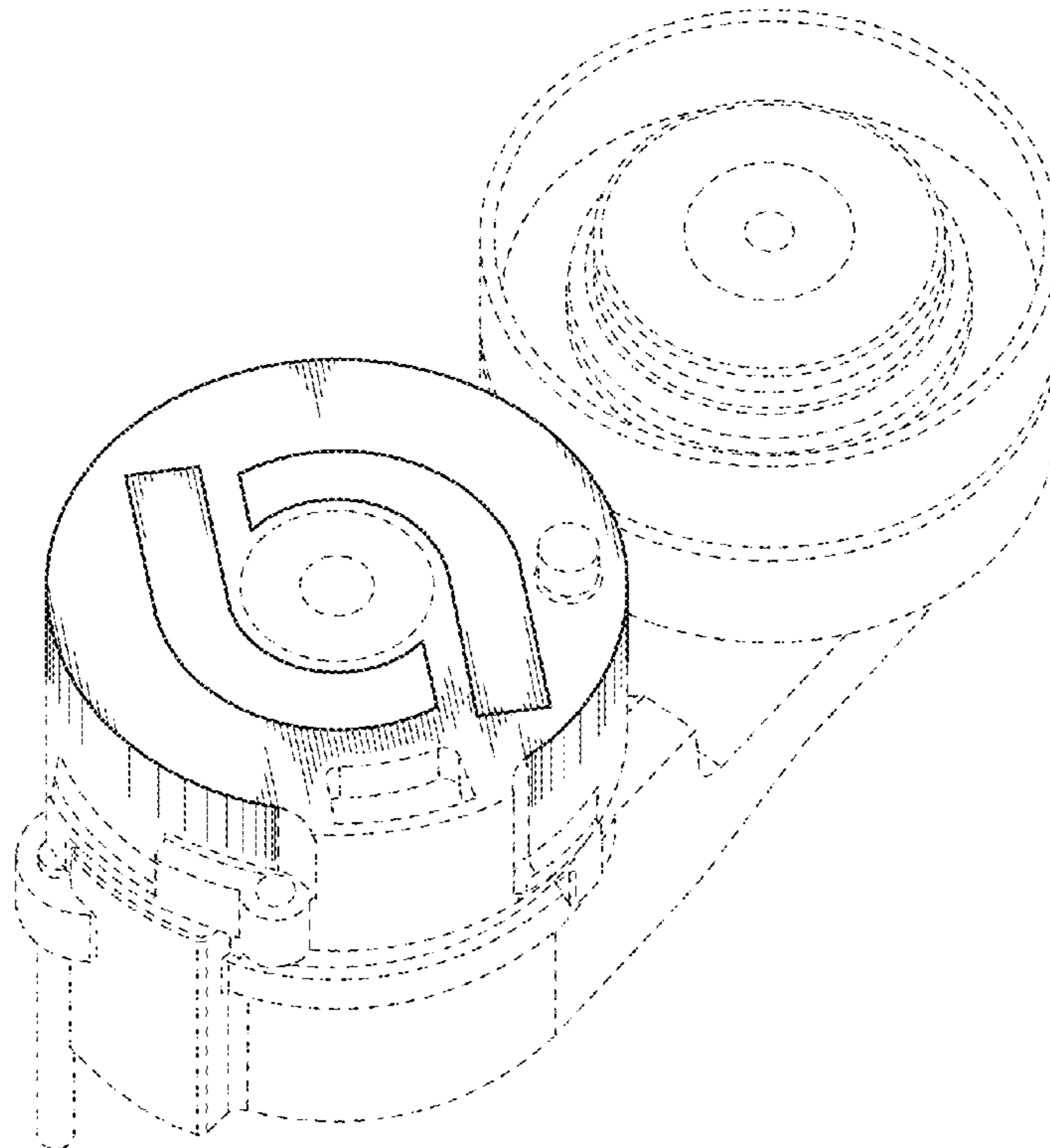
The ornamental design for a tensioner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below and to one side of the new design for a tensioner;
FIG. 2 is a bottom view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a rear elevation view thereof; and,
FIG. 6 is a front elevation view thereof.

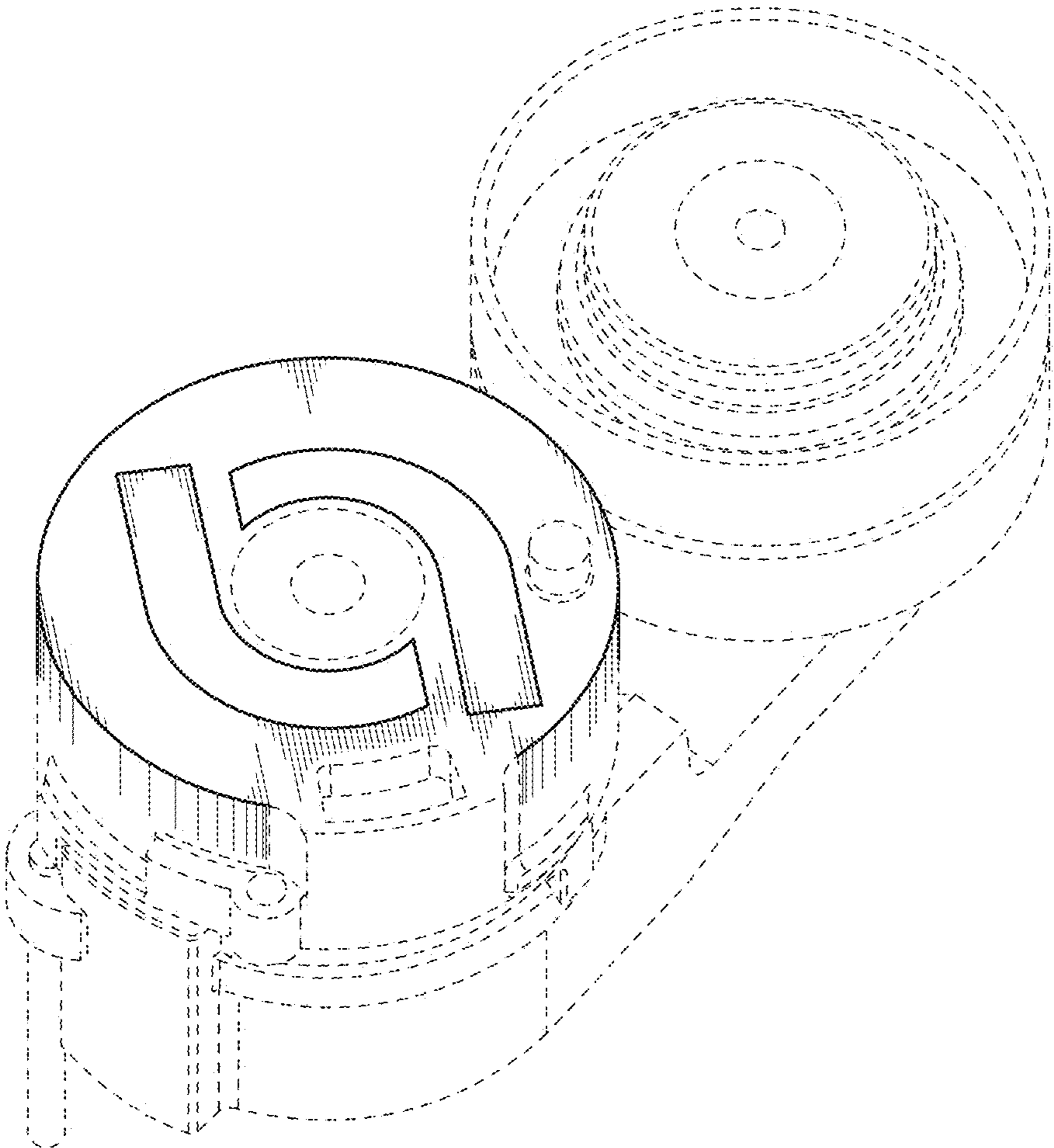

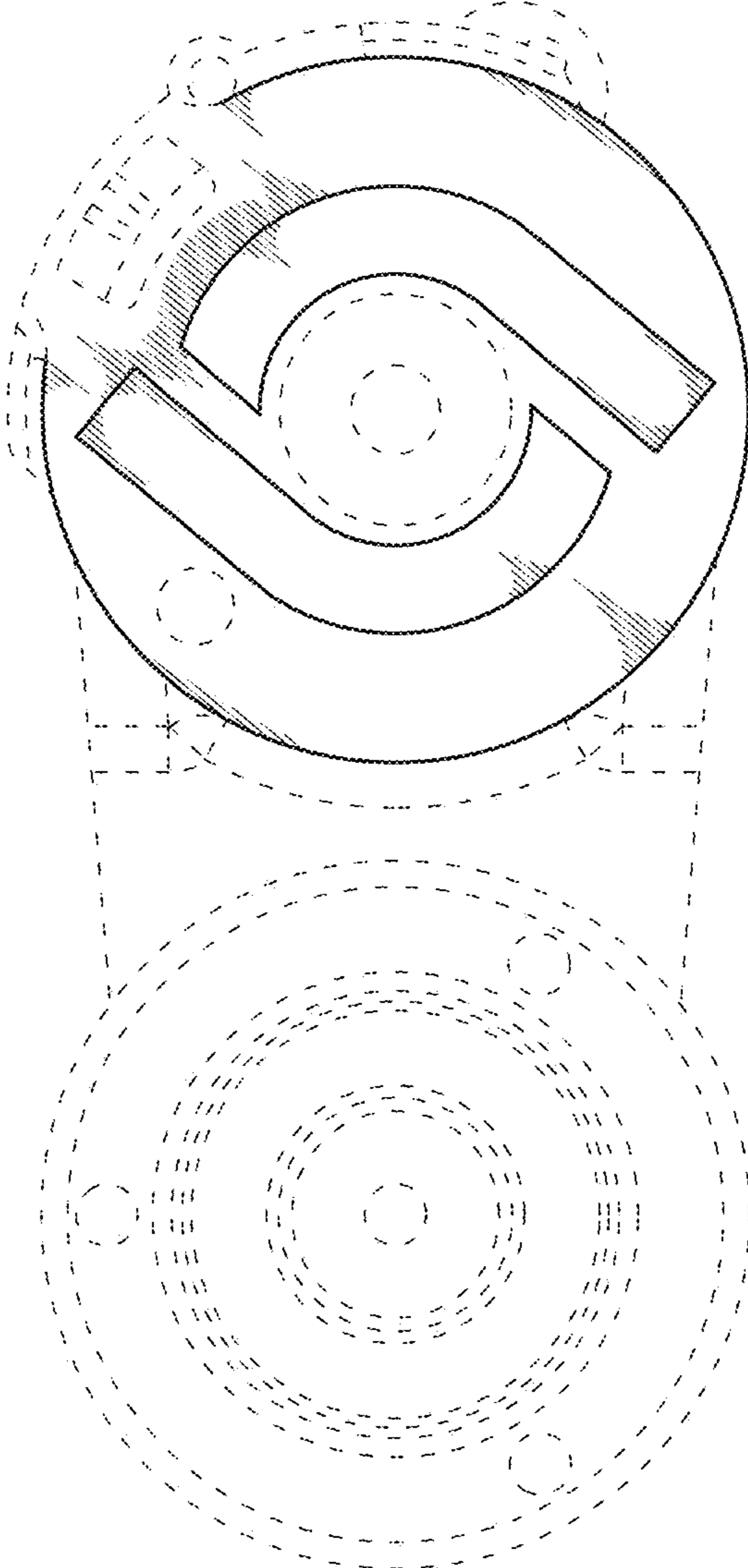

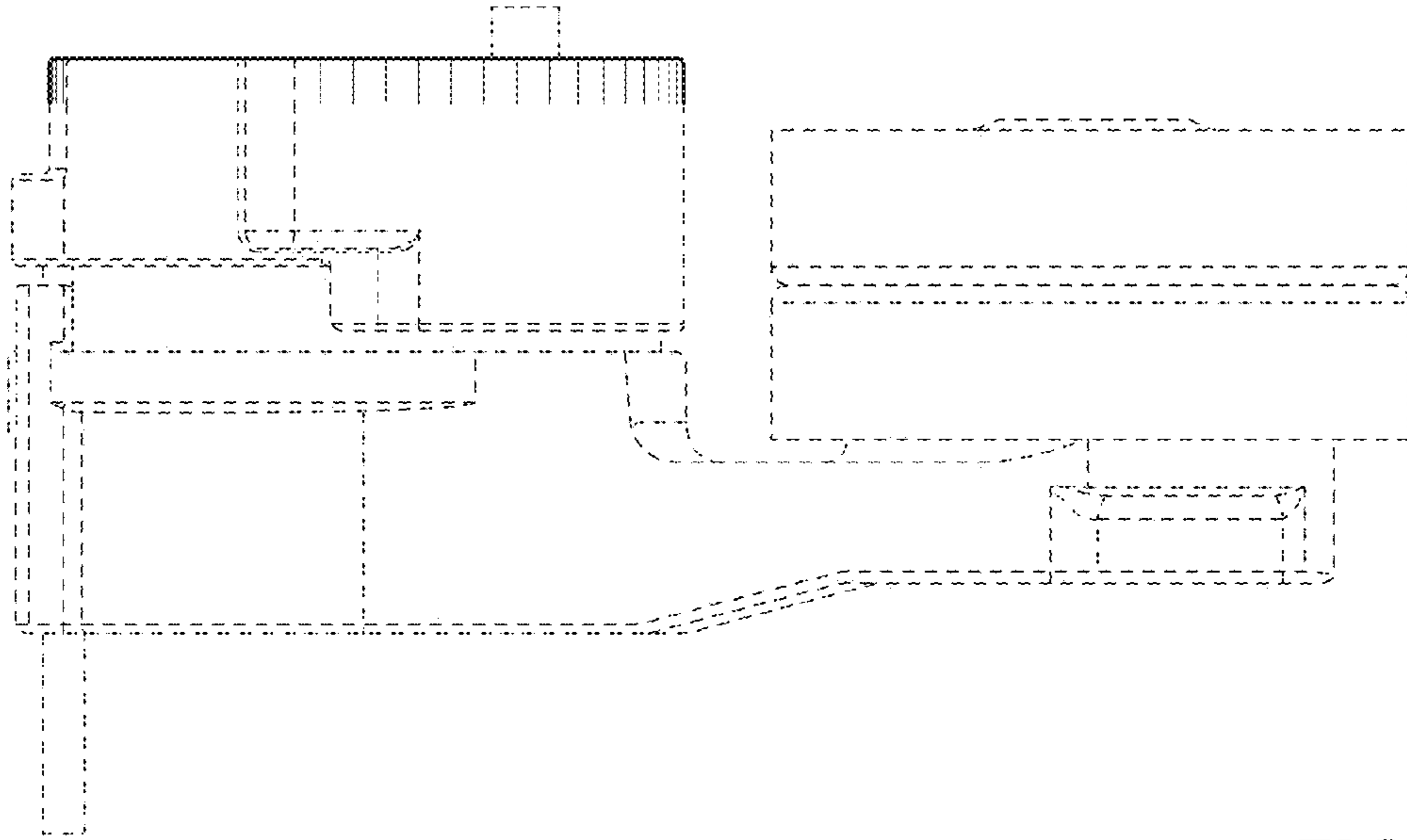

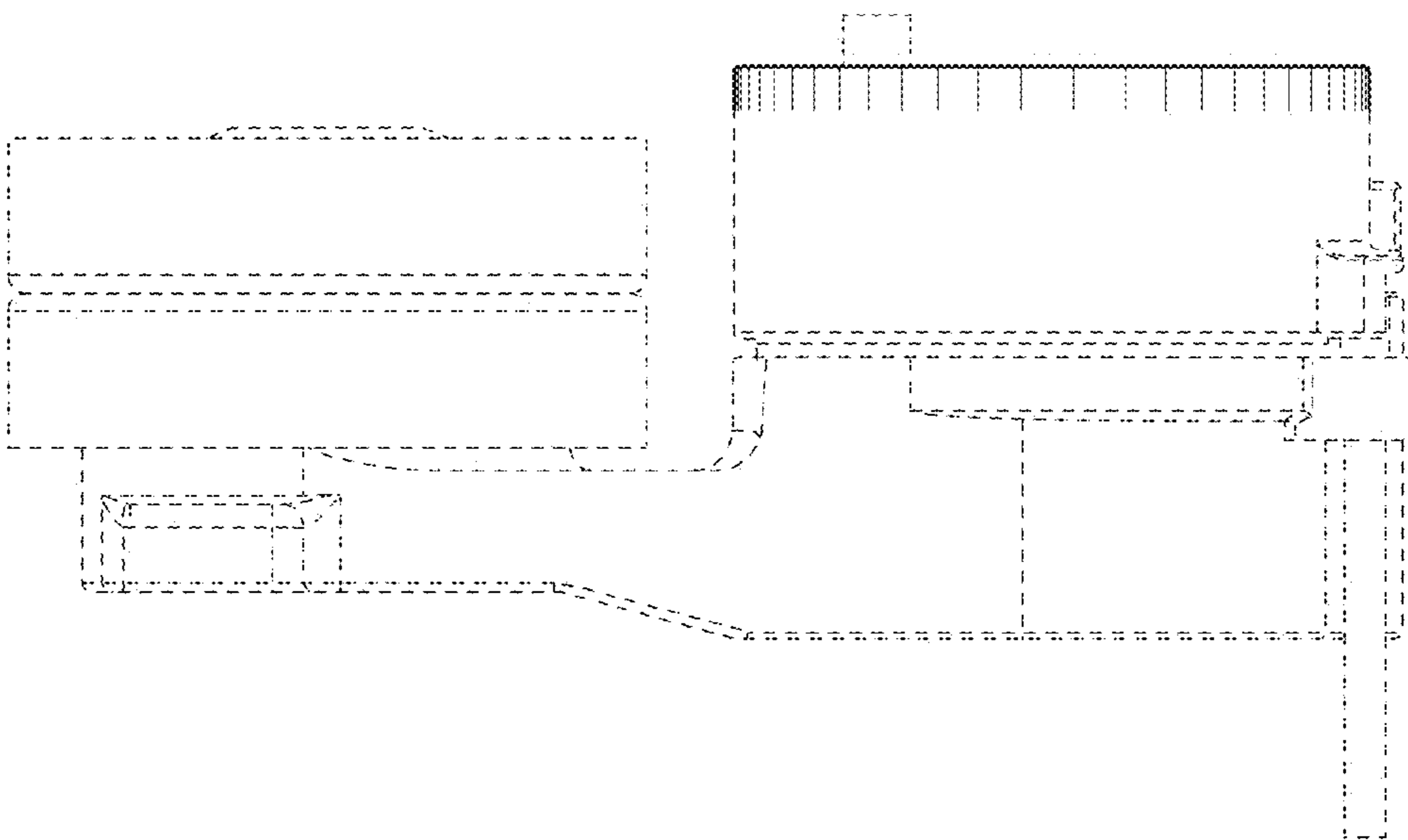

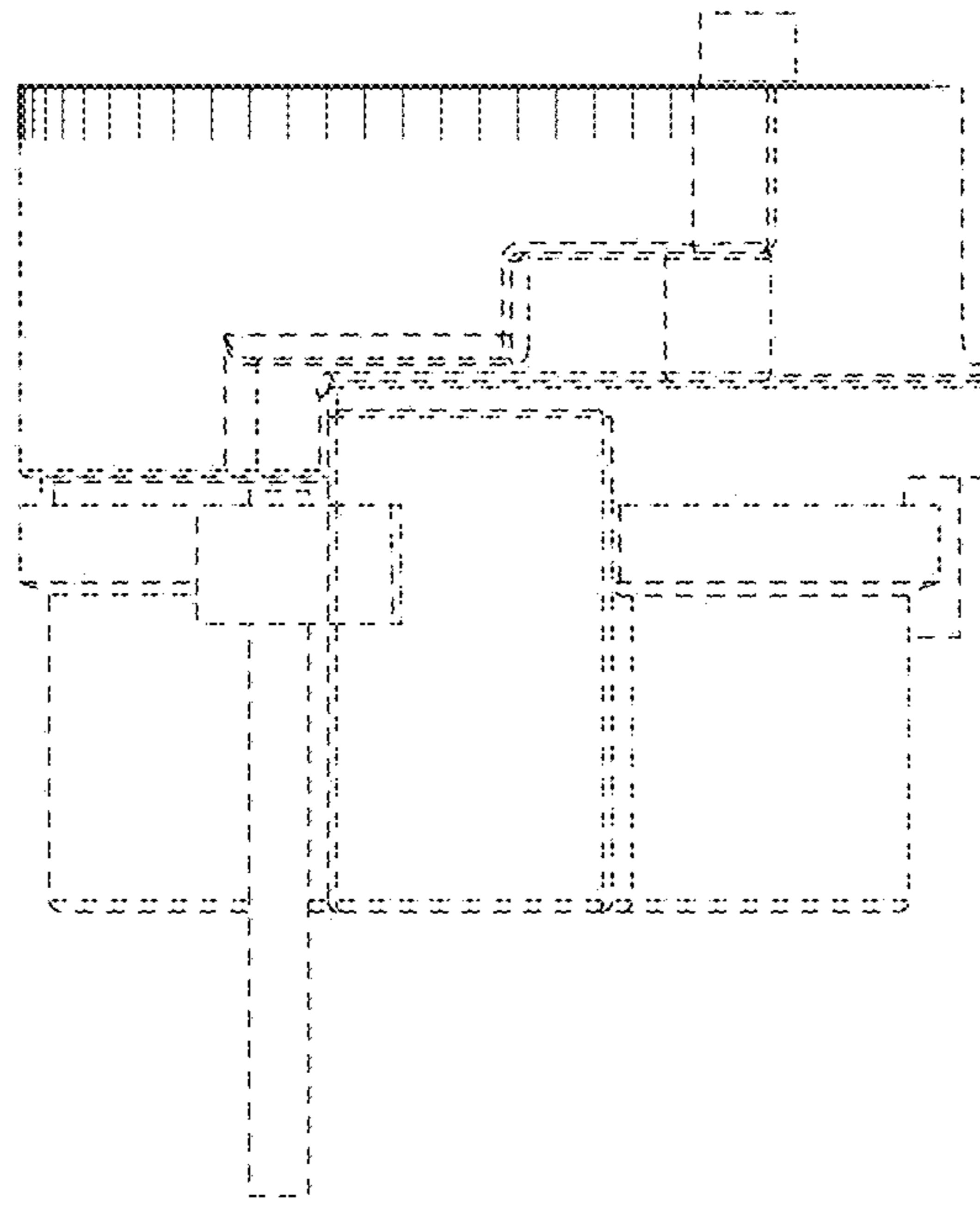

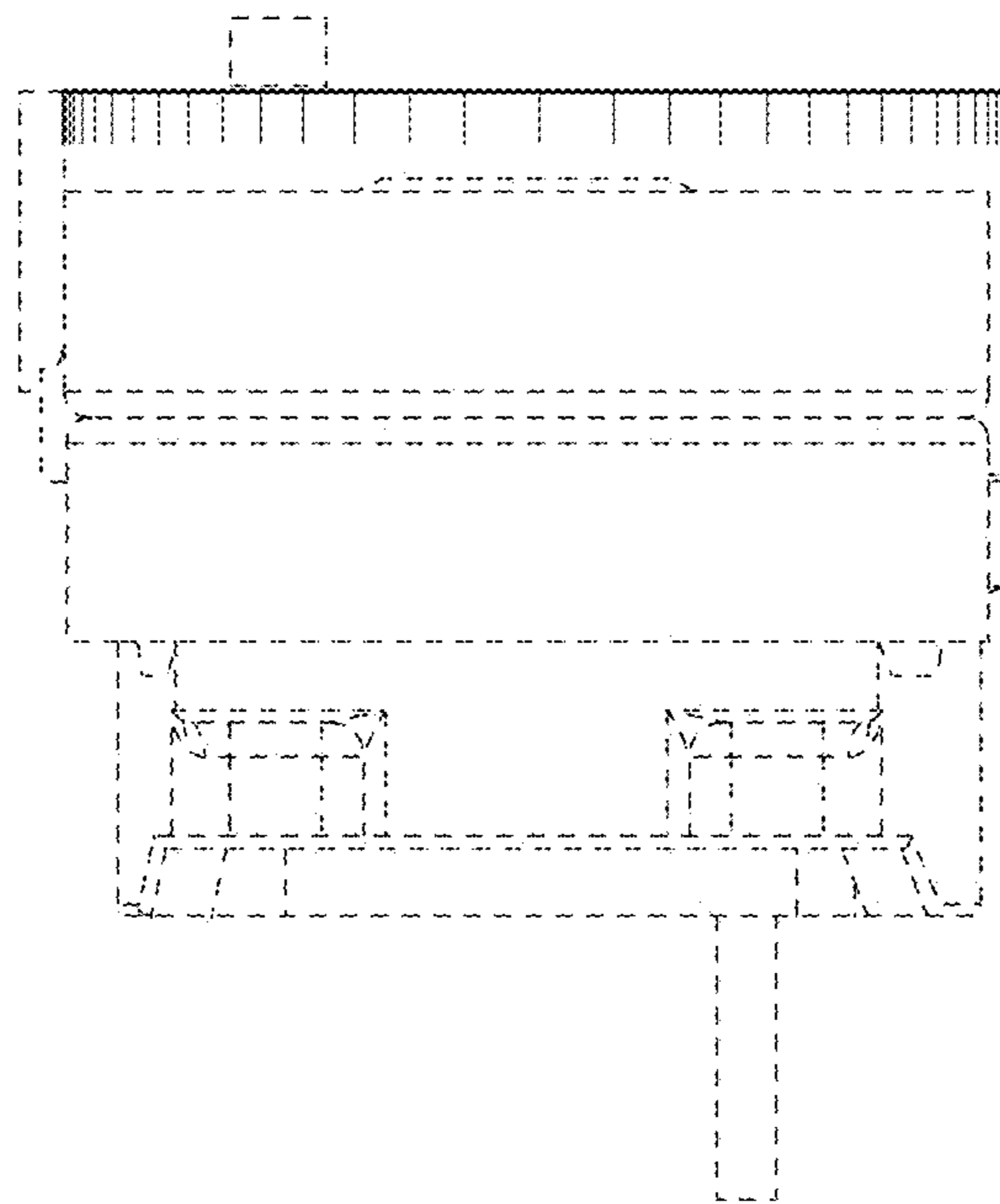
