**DESCRIPTION**

FIG. 1 is a perspective view of a packaging box, showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left-side view thereof;

FIG. 5 is a right-side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan thereof;

FIG. 8 is another perspective view of the packaging box of

FIG. 1, in which the cover of the packaging box is removed to

show the panel portion (shown separately in FIG. 12) and an

insert portion (shown separately in FIG. 13) thereof;

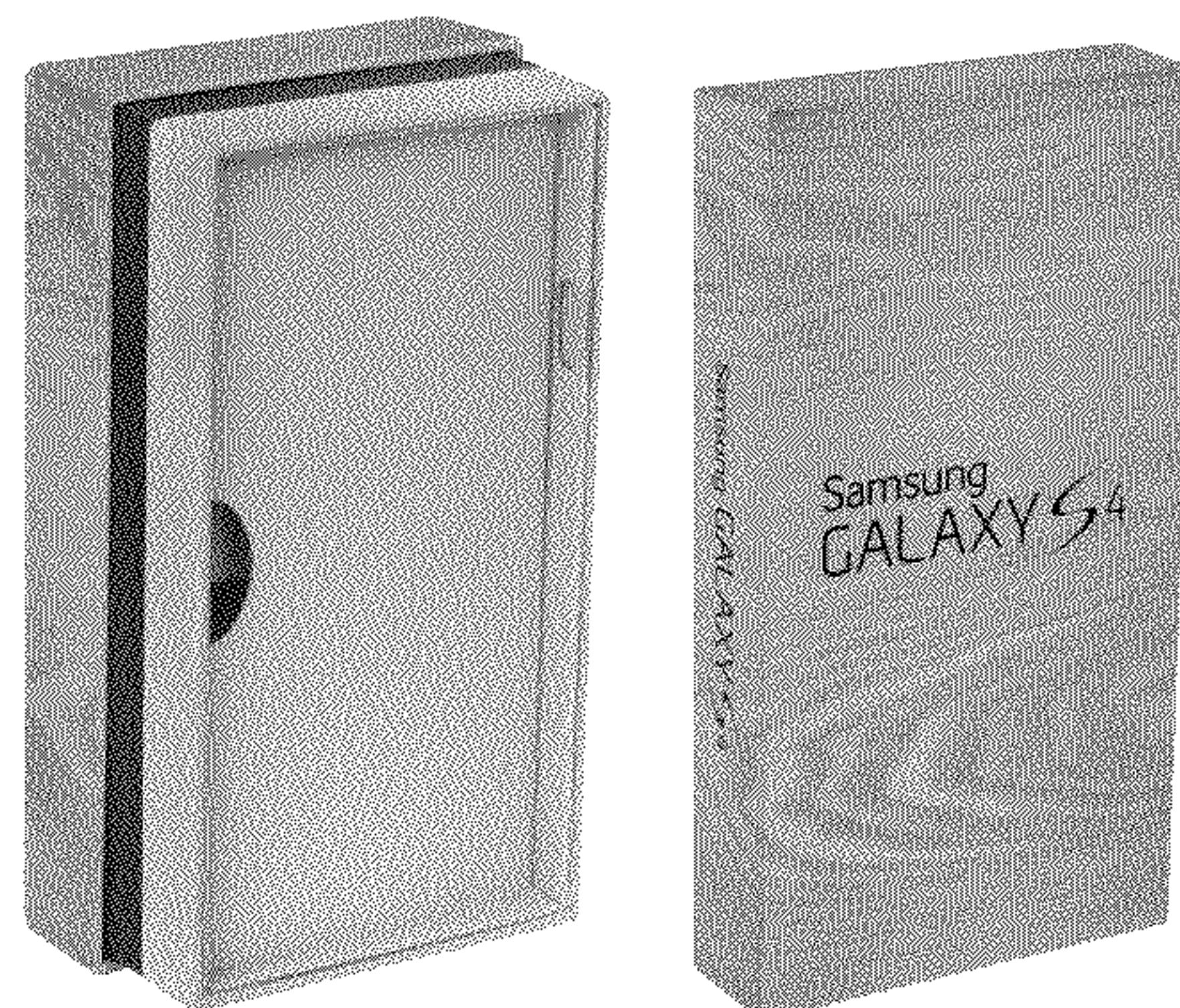

to show the panel portion (shown separately in FIG. 25) and the insert portion (shown separately in FIG. 26) thereof;

FIG. 22 is another perspective view of the packaging box of FIG. 14, in which the cover of the packaging box is has been removed from the view for ease of illustrating the interior appearance of the packaging box;

FIG. 23 is another perspective view of the packaging box of FIG. 22, in which the lid of the panel portion of the packaging box is in an open position;

FIG. 24 is another perspective view of the packaging box of FIG. 22, in which the panel portion of the packaging box is removed from the view for ease of illustration;

FIG. 25 is a top plan view of the panel portion of the claimed packaging box of FIG. 14;

FIG. 26 is a perspective view of the insert portion of the claimed packaging box of FIG. 14; and,

FIG. 27 is an exploded perspective view of the packaging box of FIG. 14, showing the cover of the packaging box, the panel portion and the insert portion separated from each other for ease of illustration.

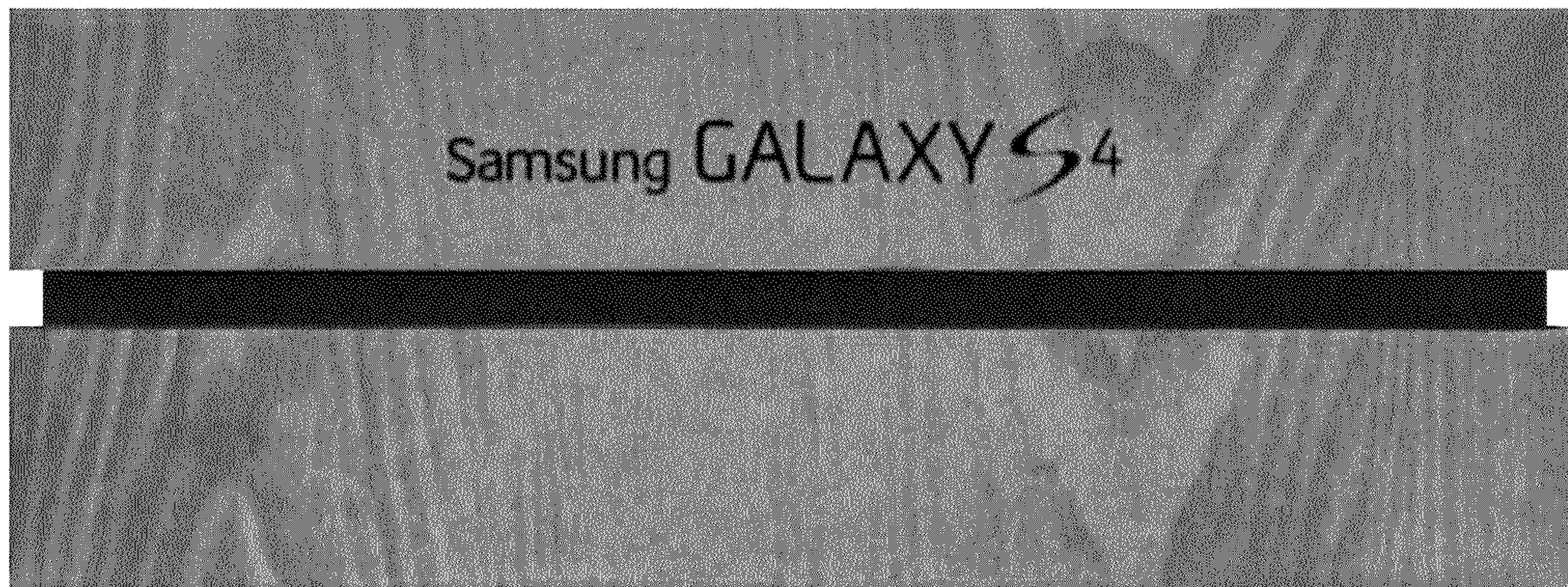

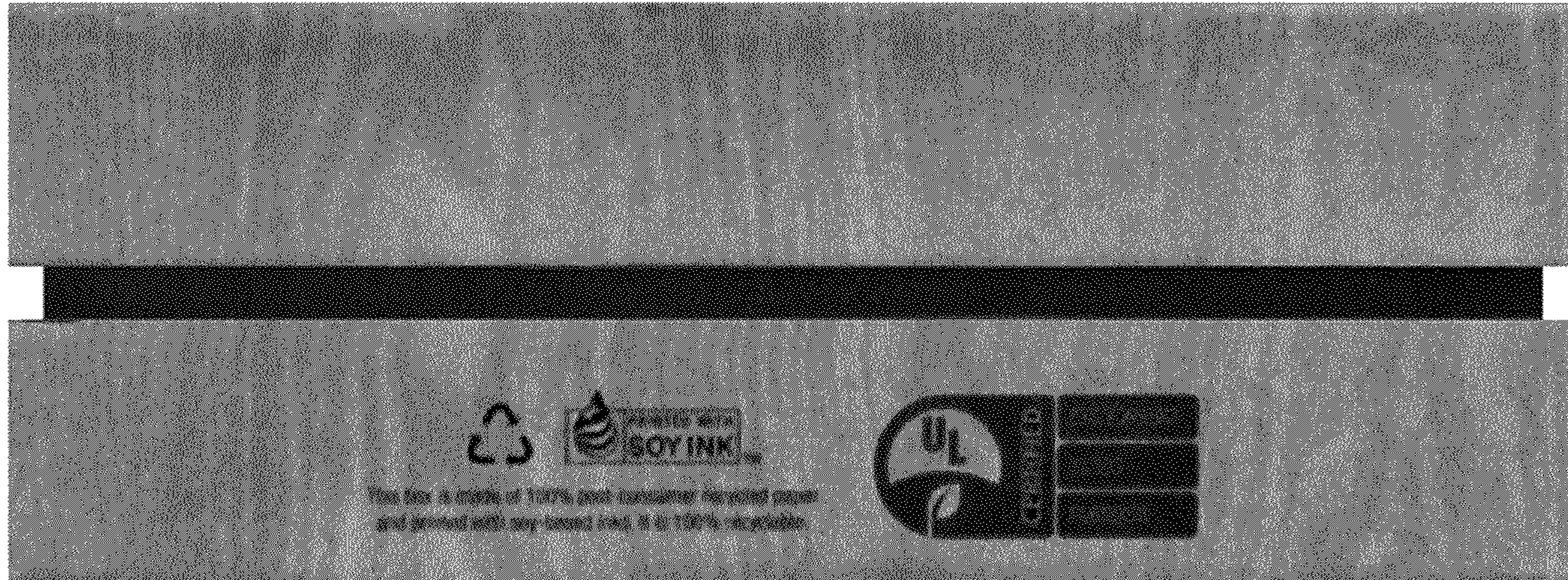

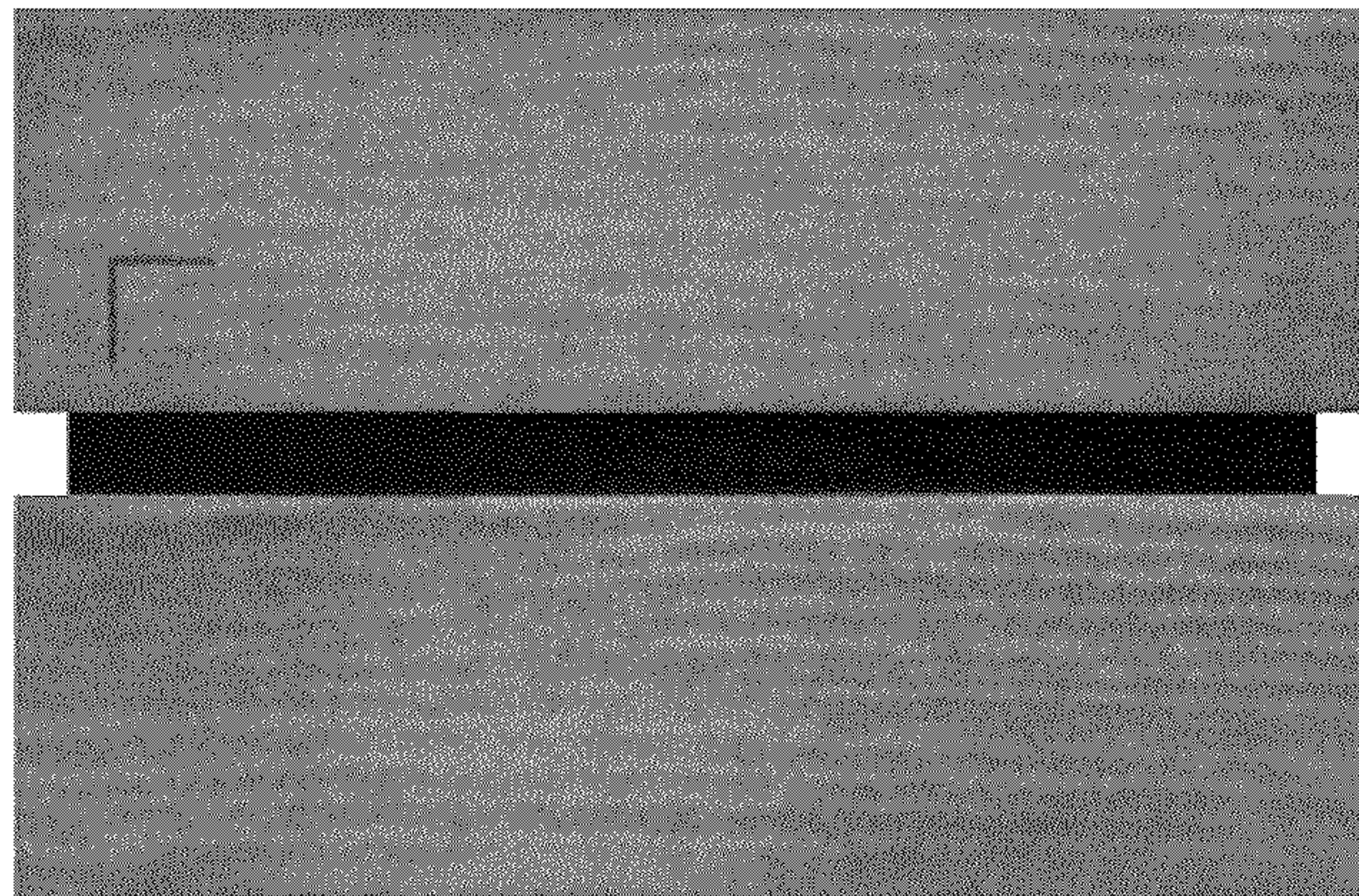

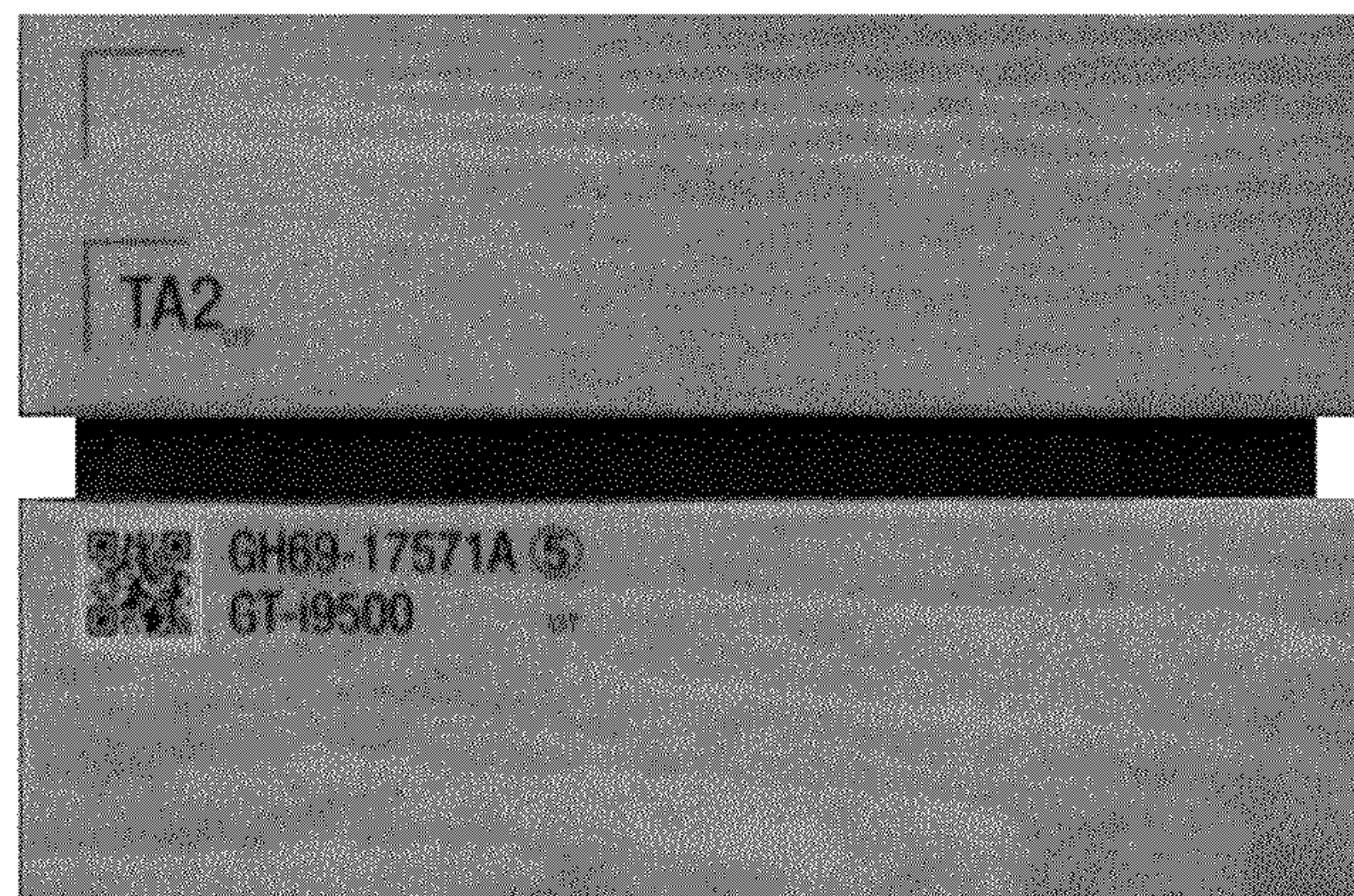

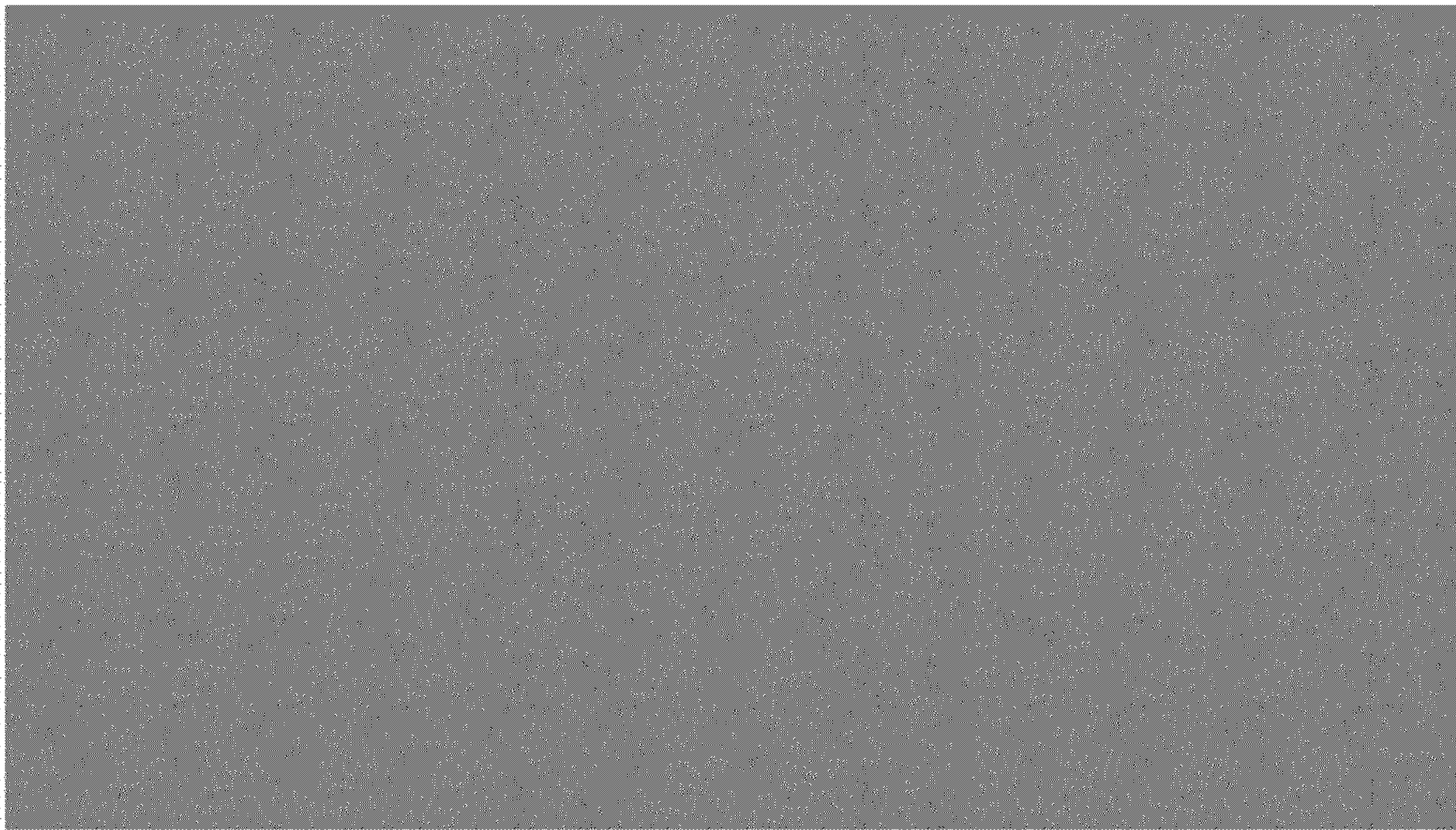

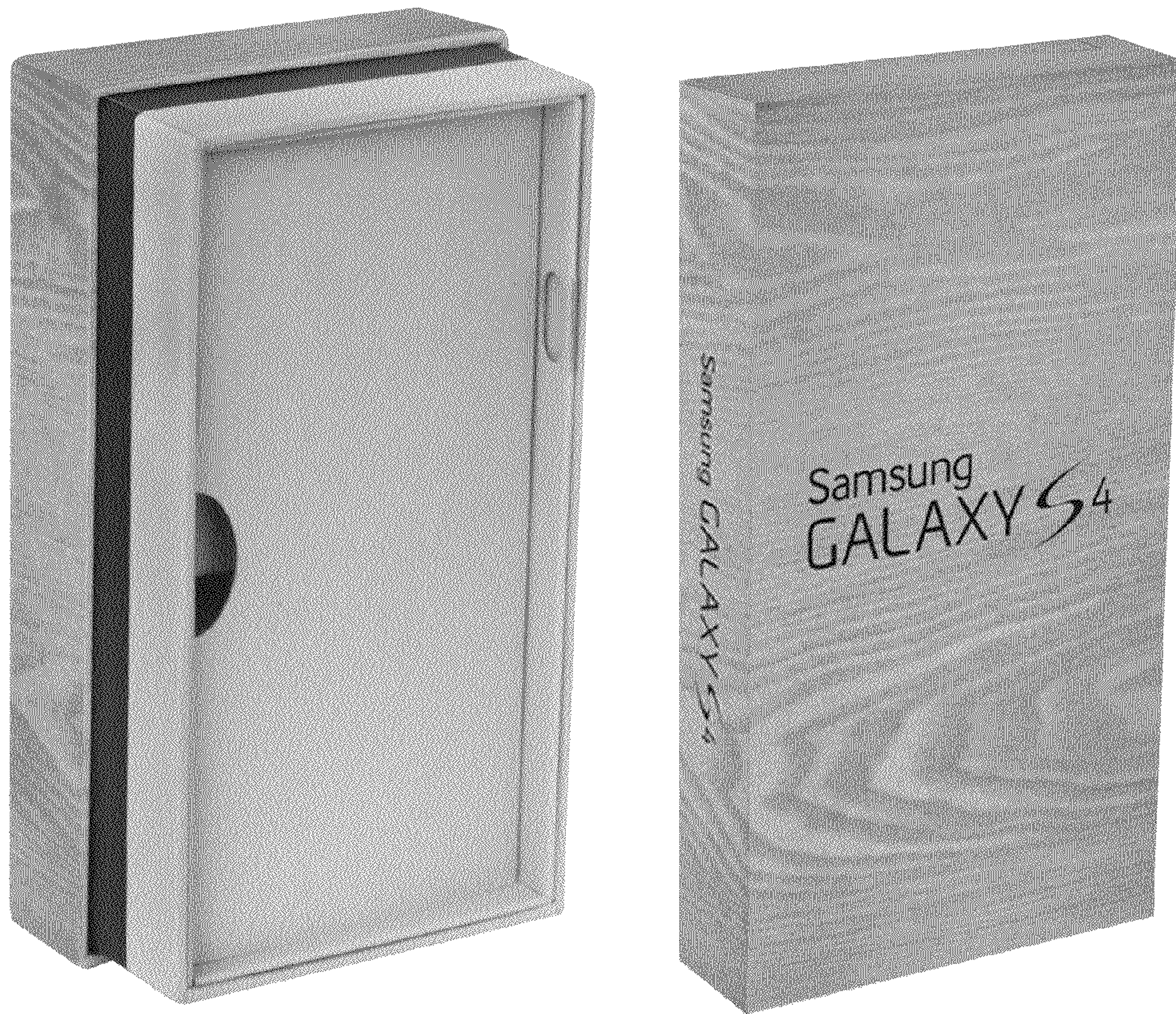

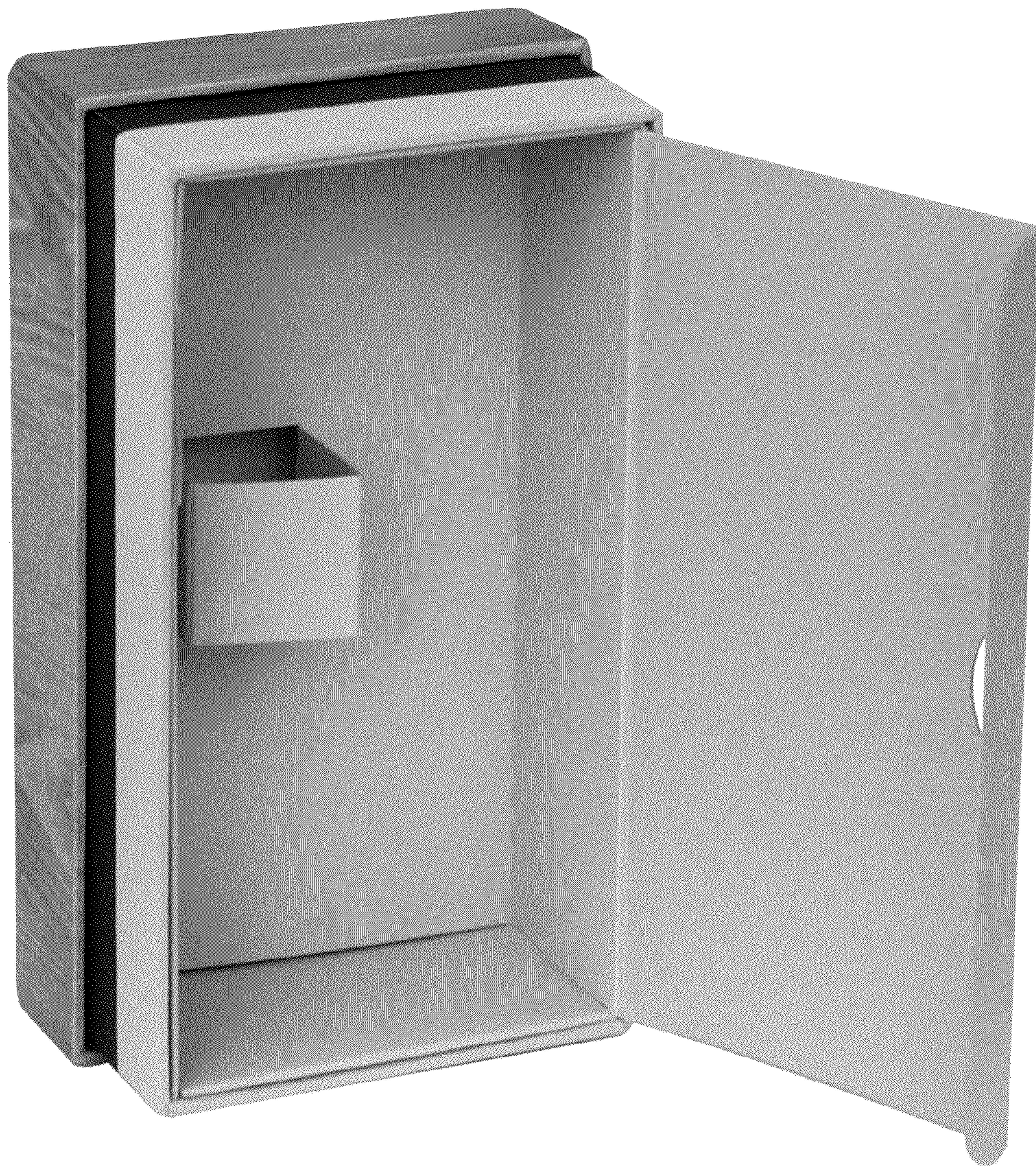

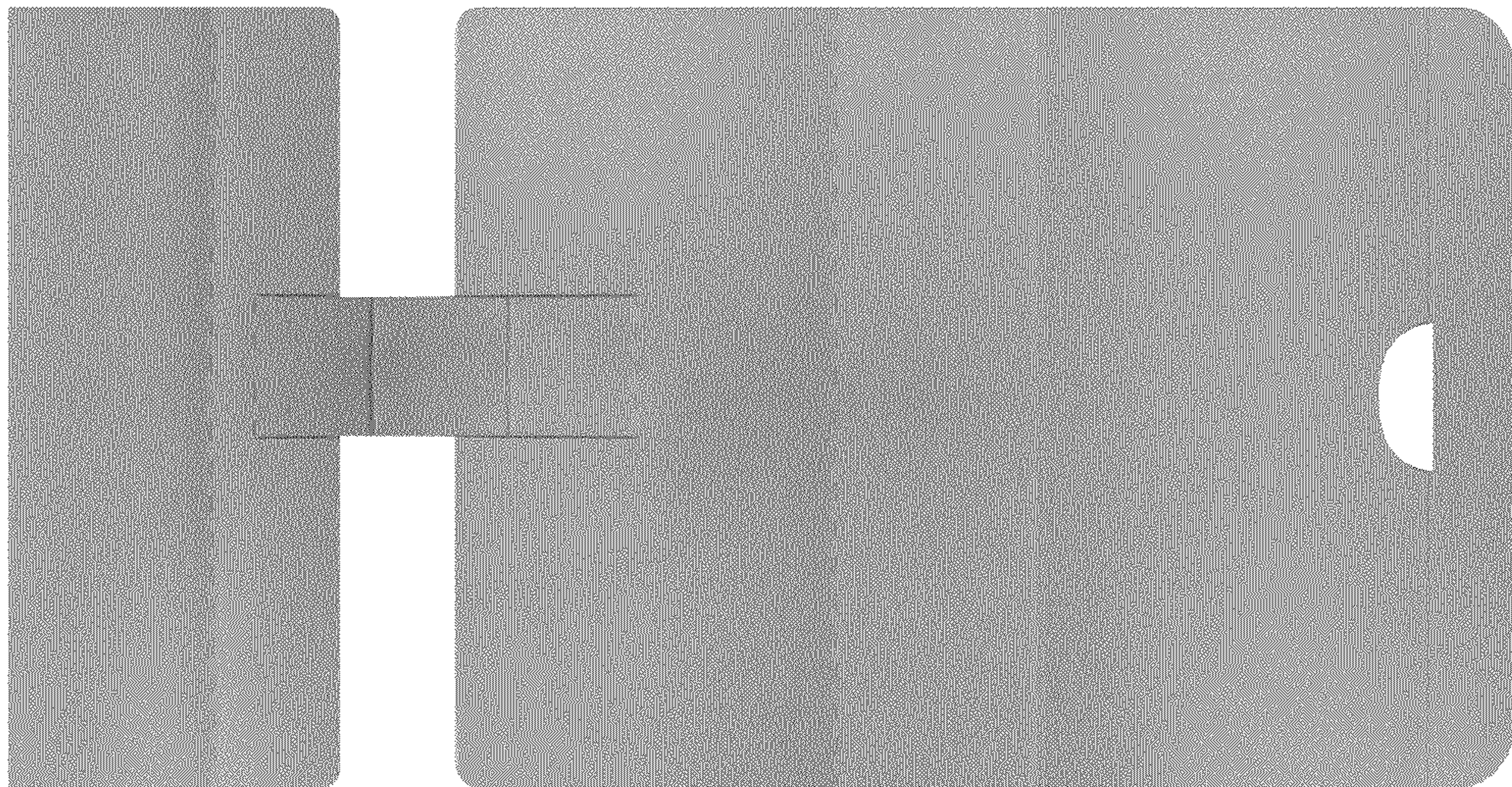

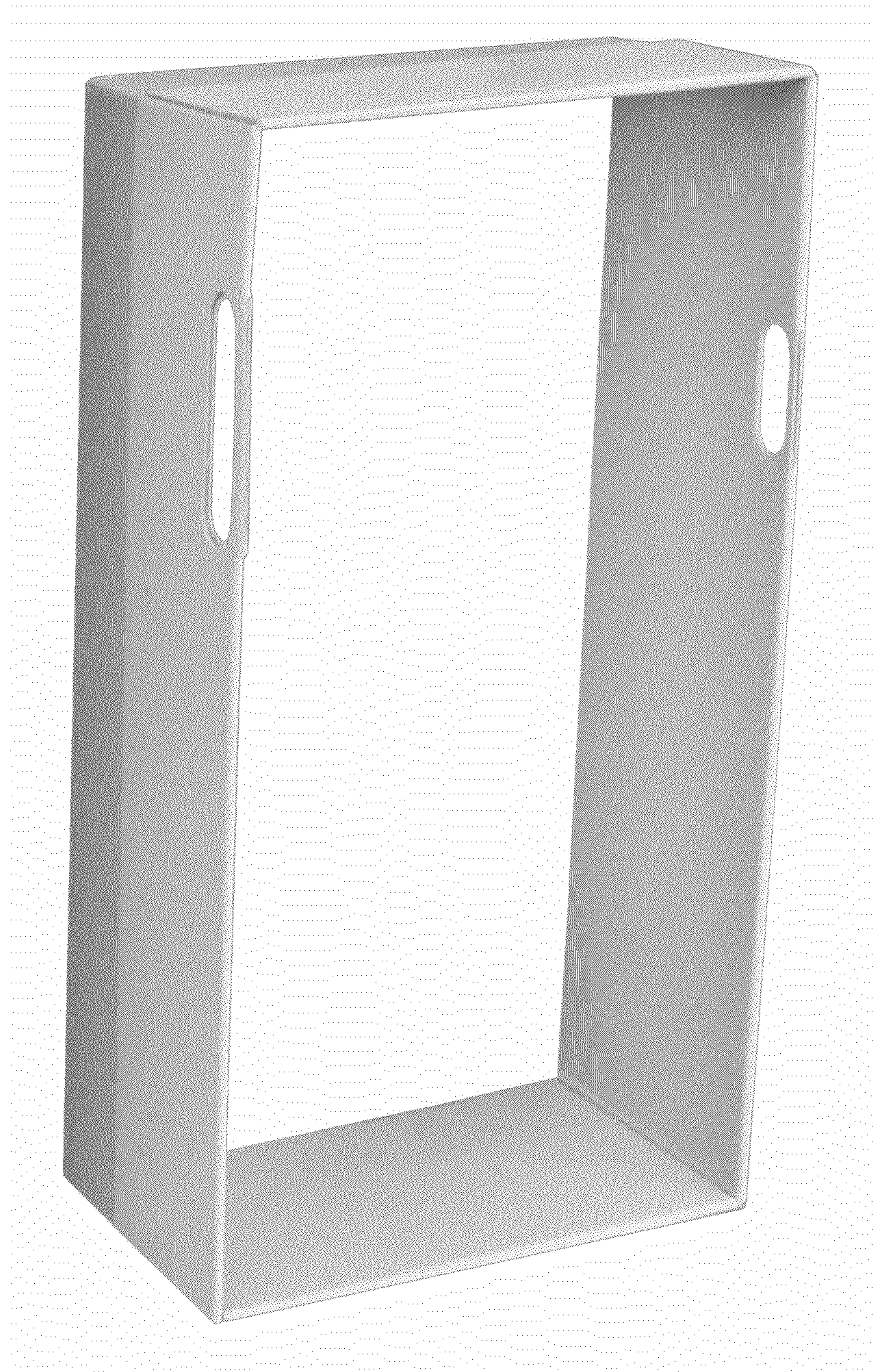

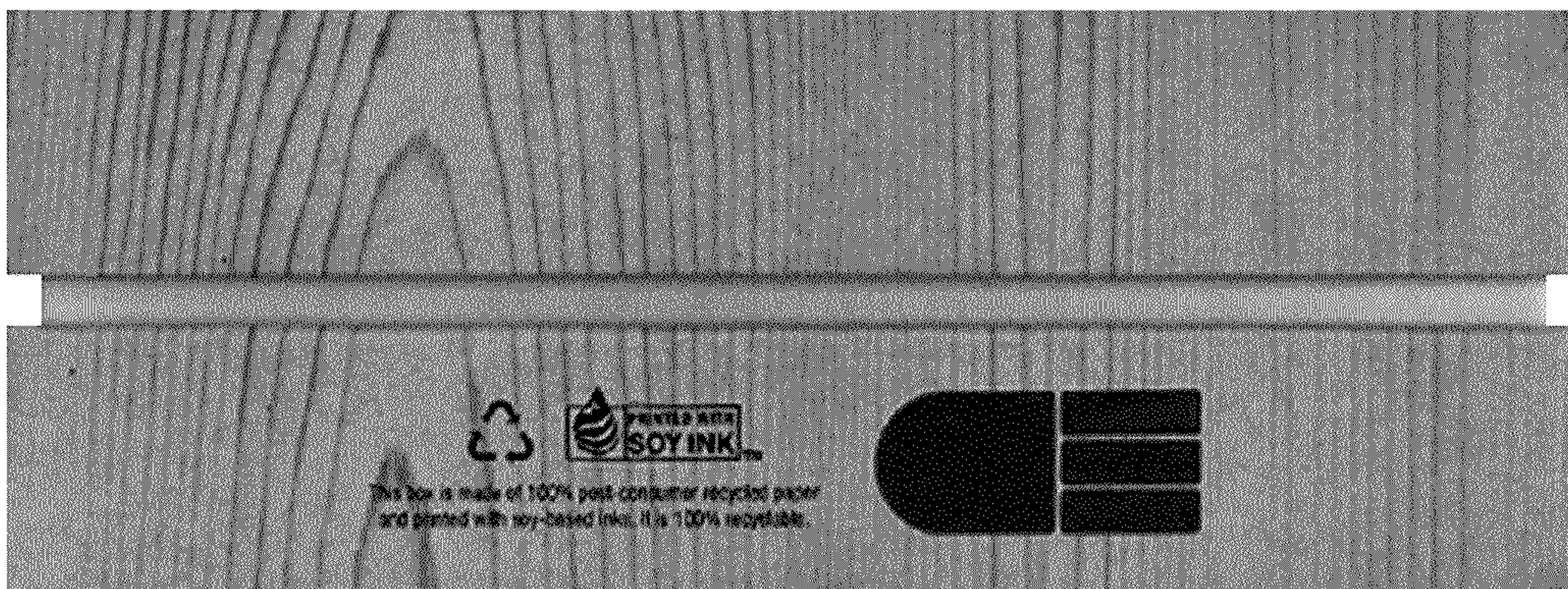

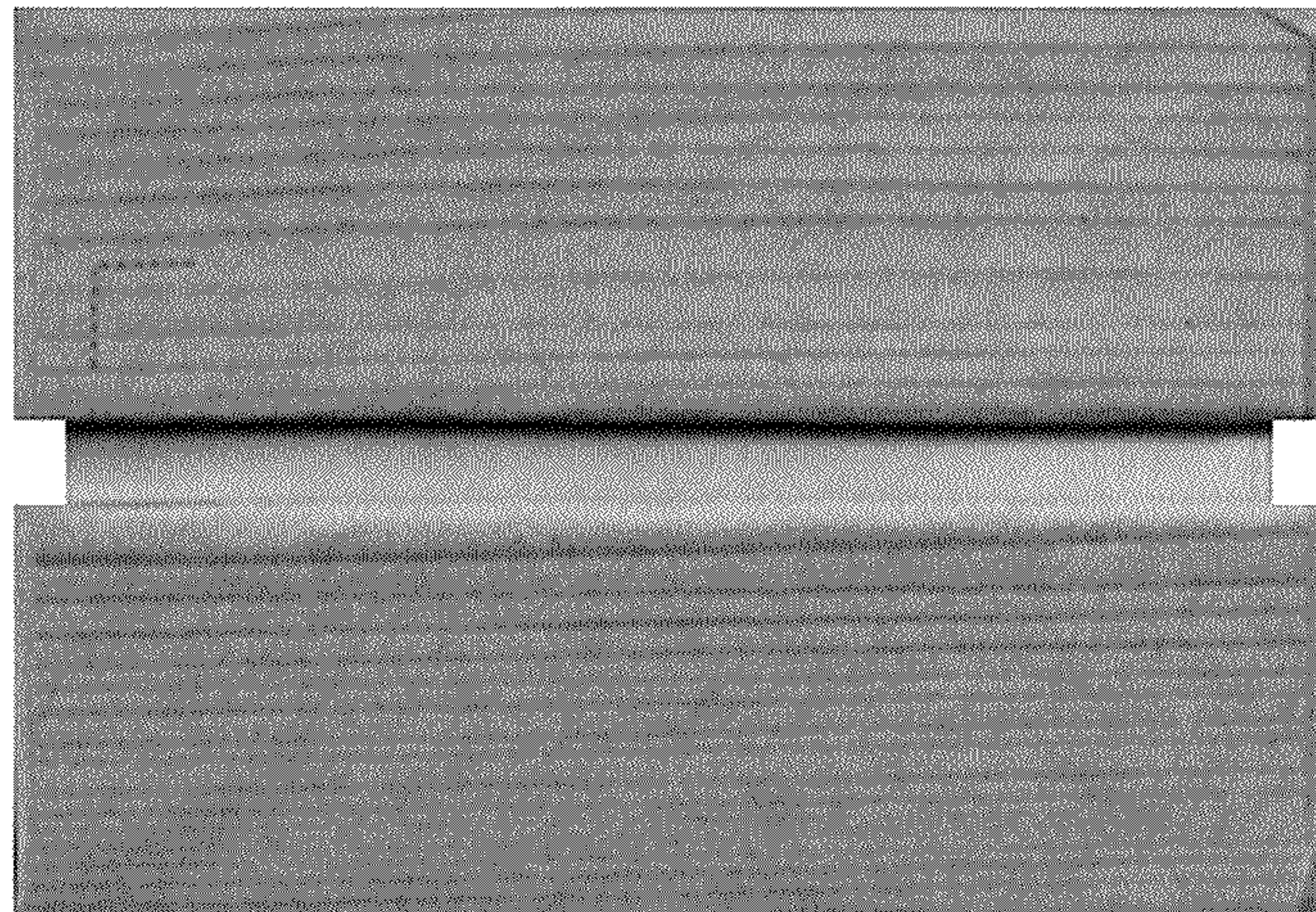

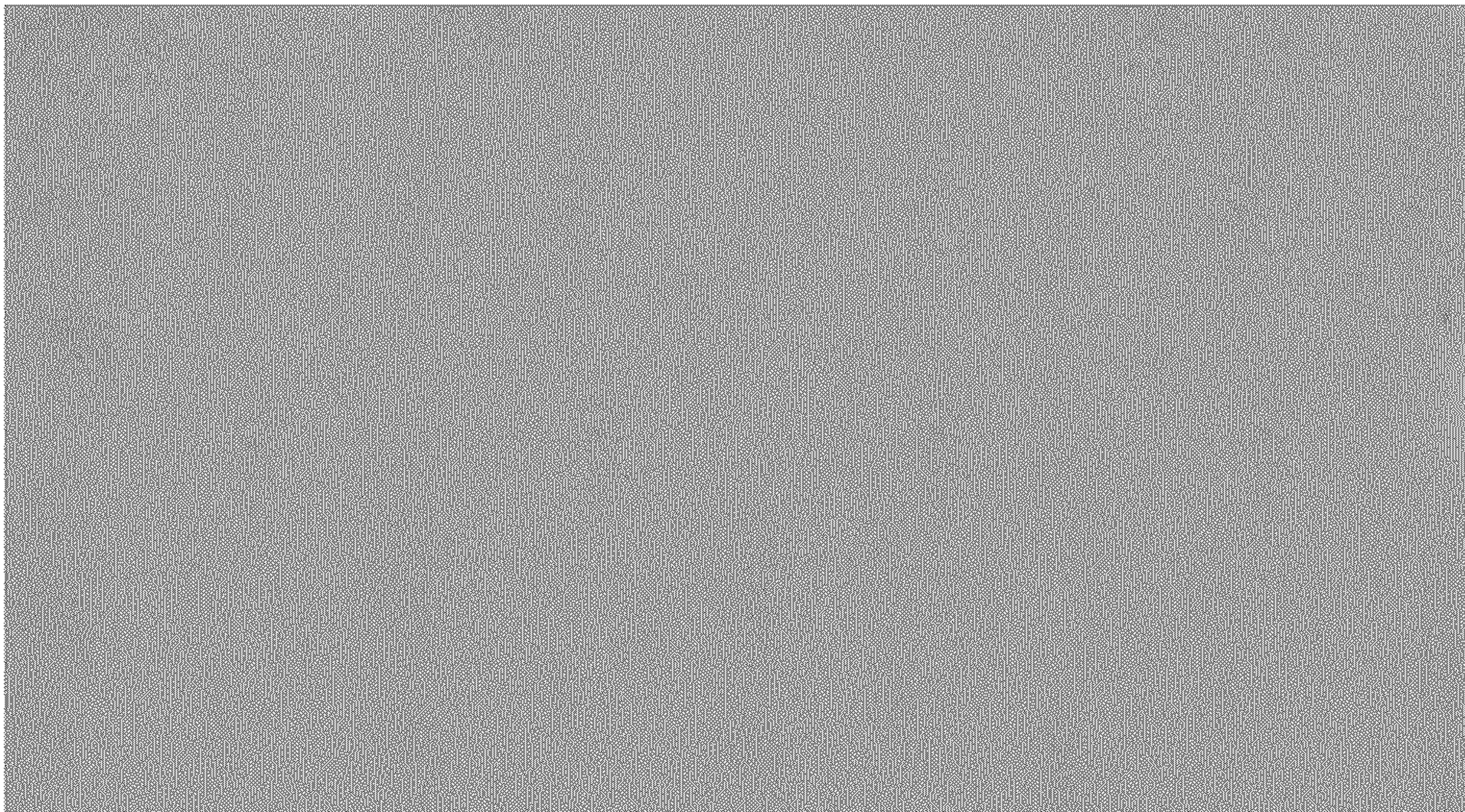

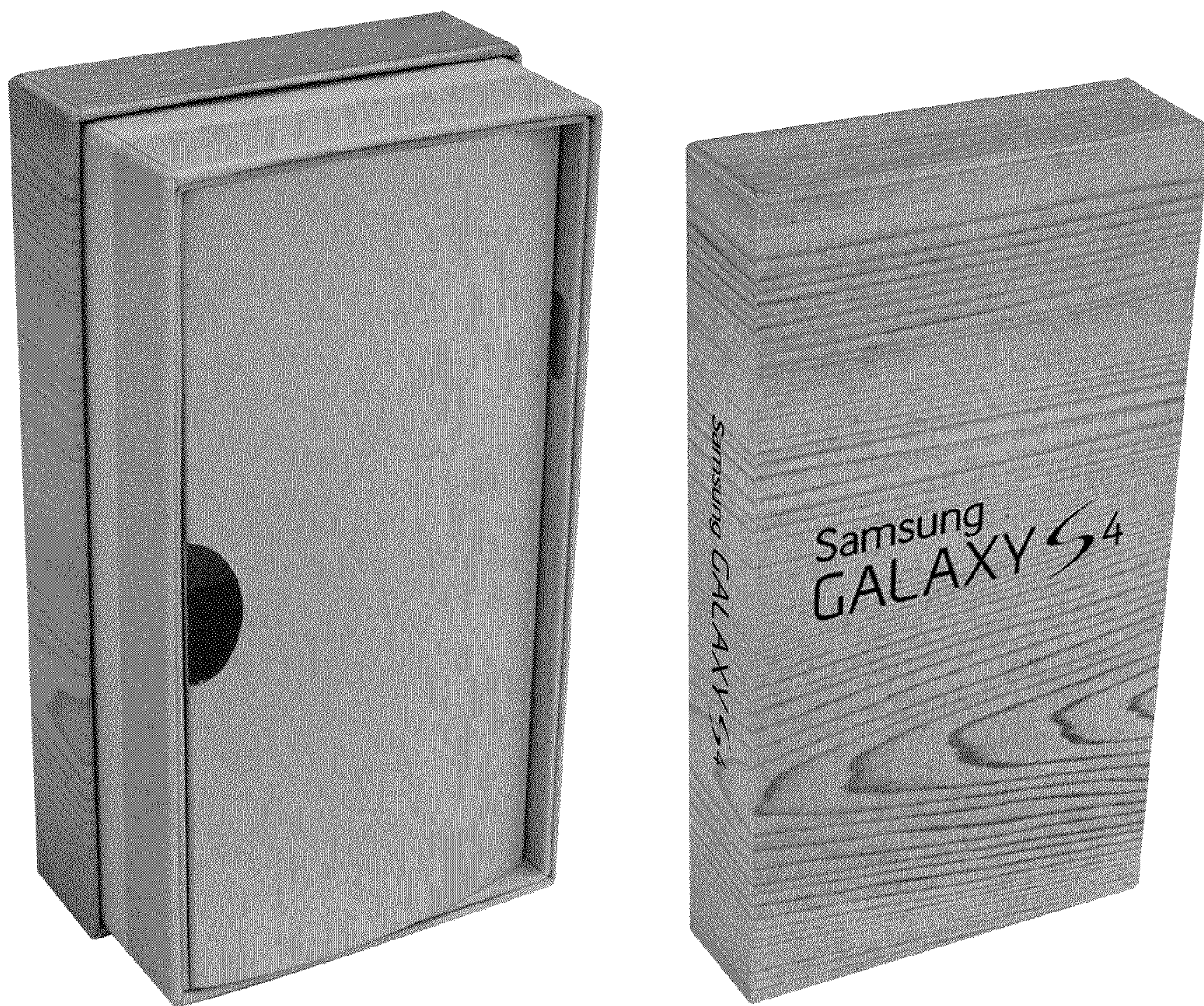

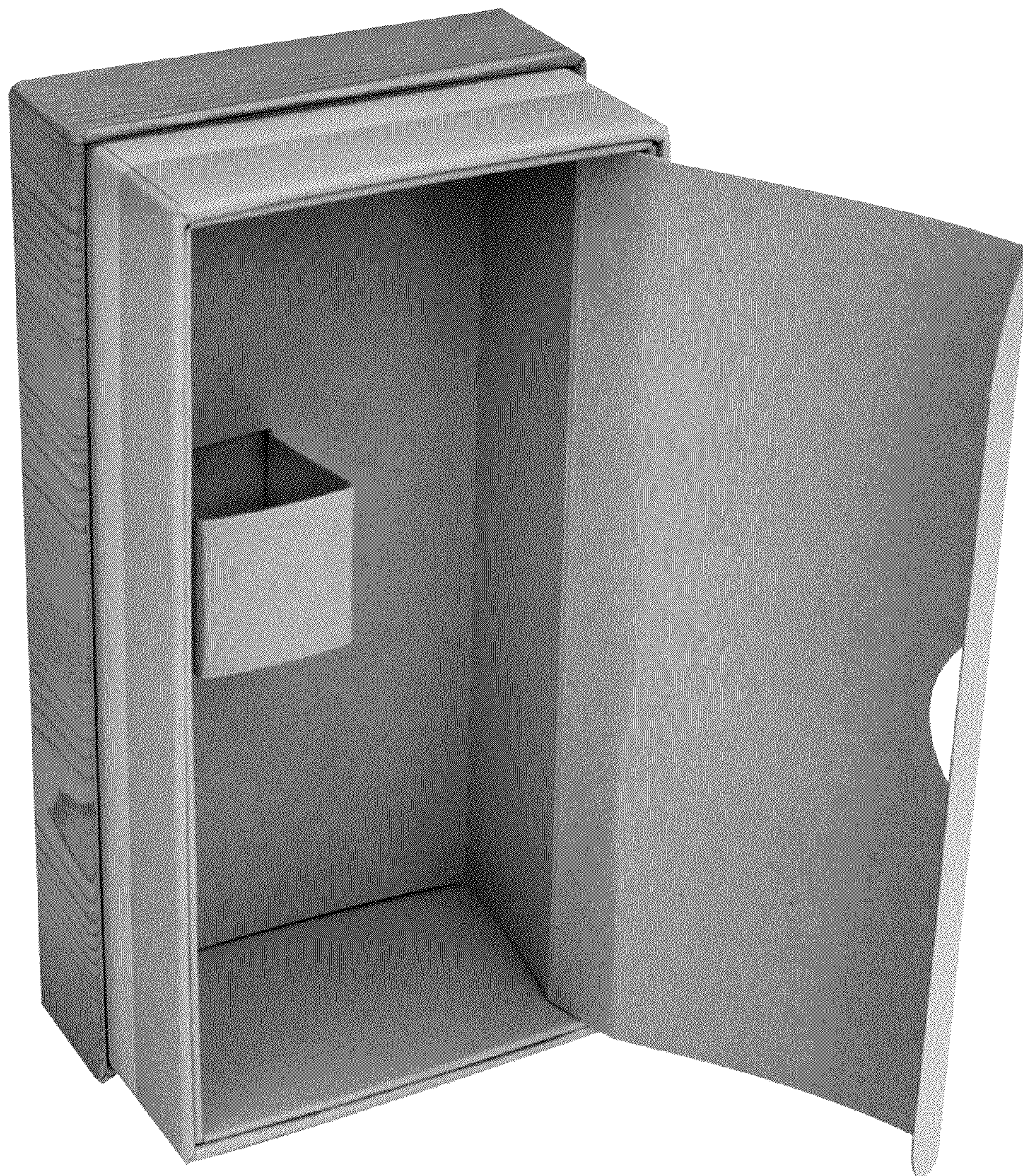

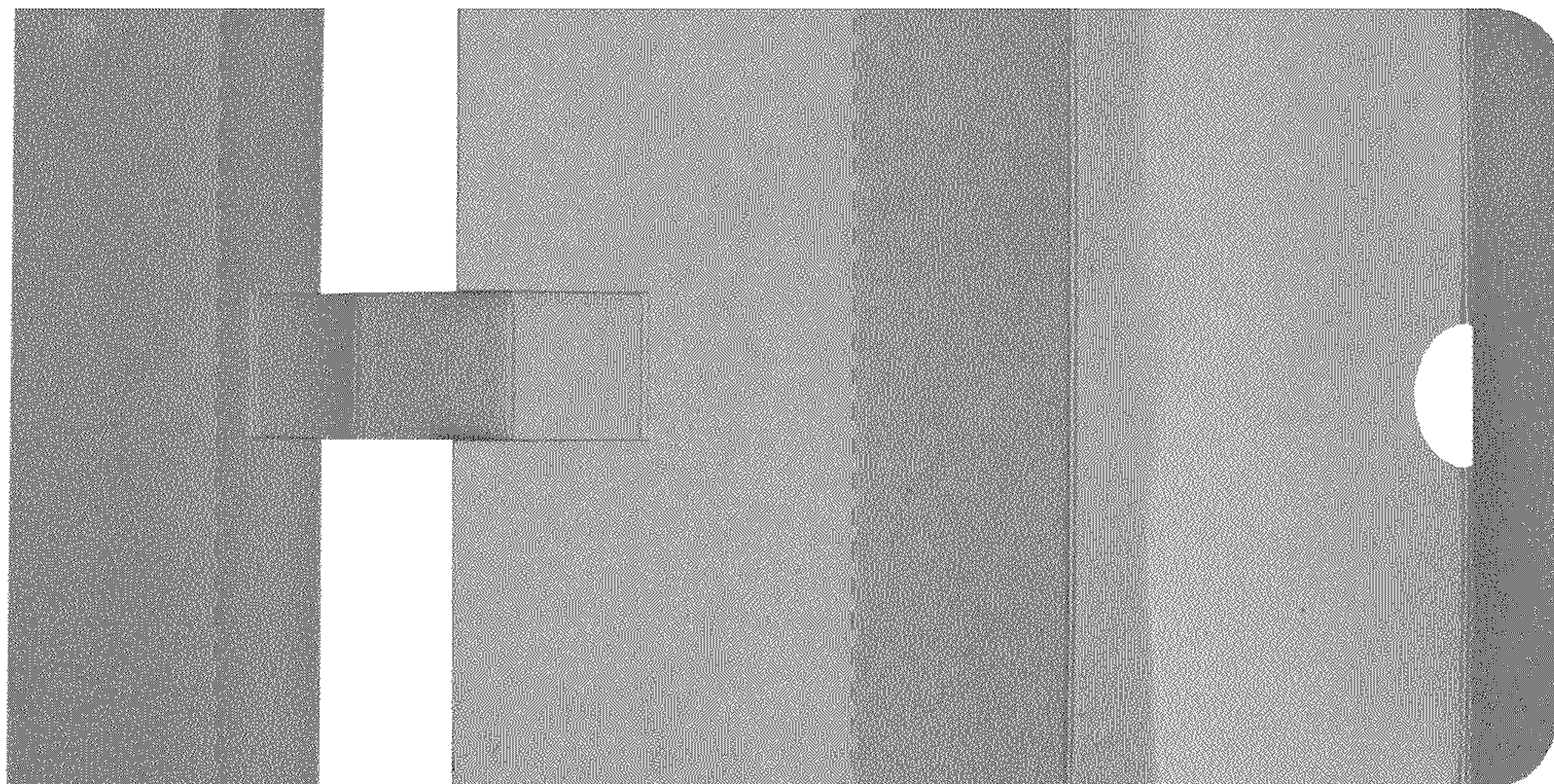

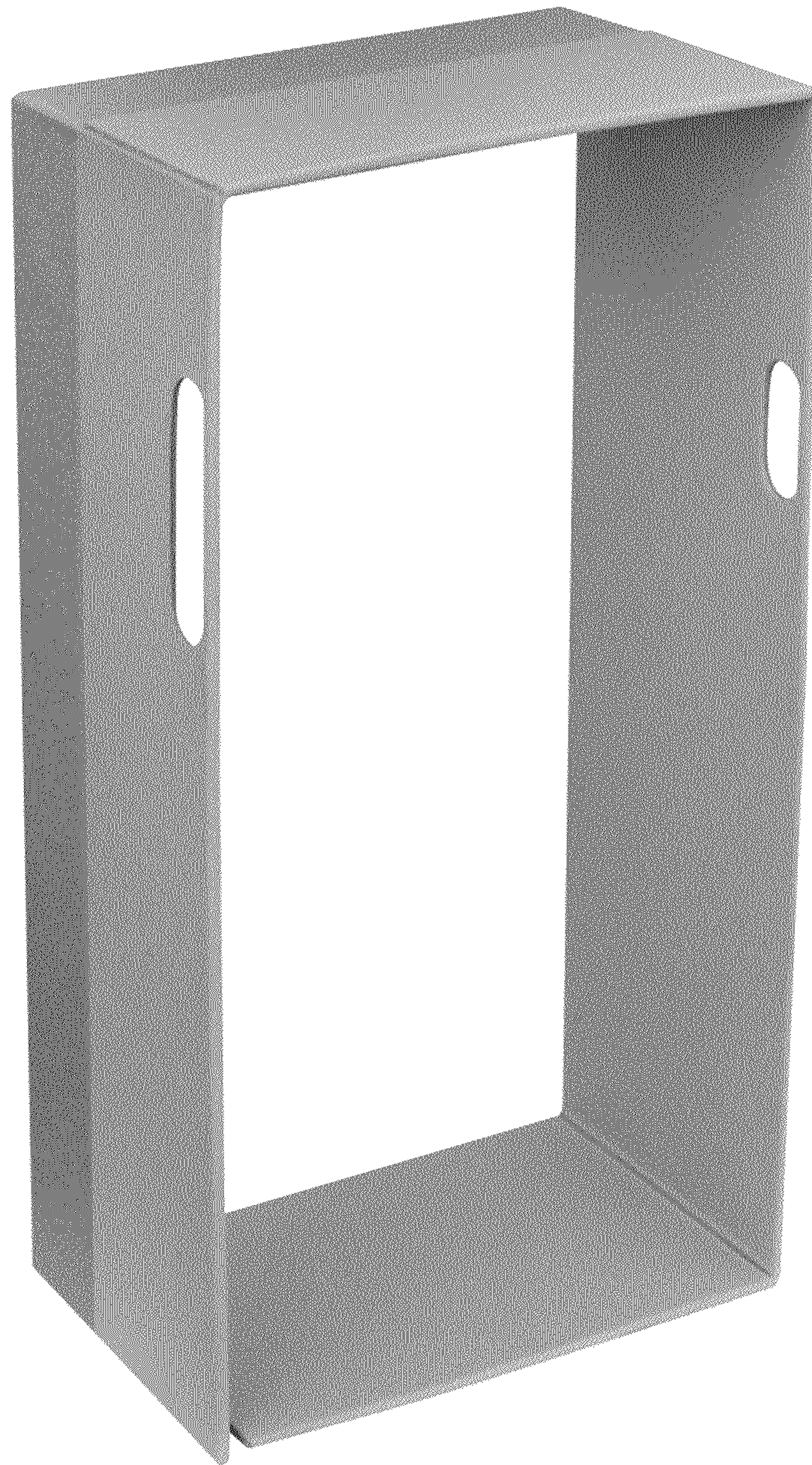
