DESCRIPTION

FIG. 4 is a back view of the toothpaste package as shown in FIG. 1;

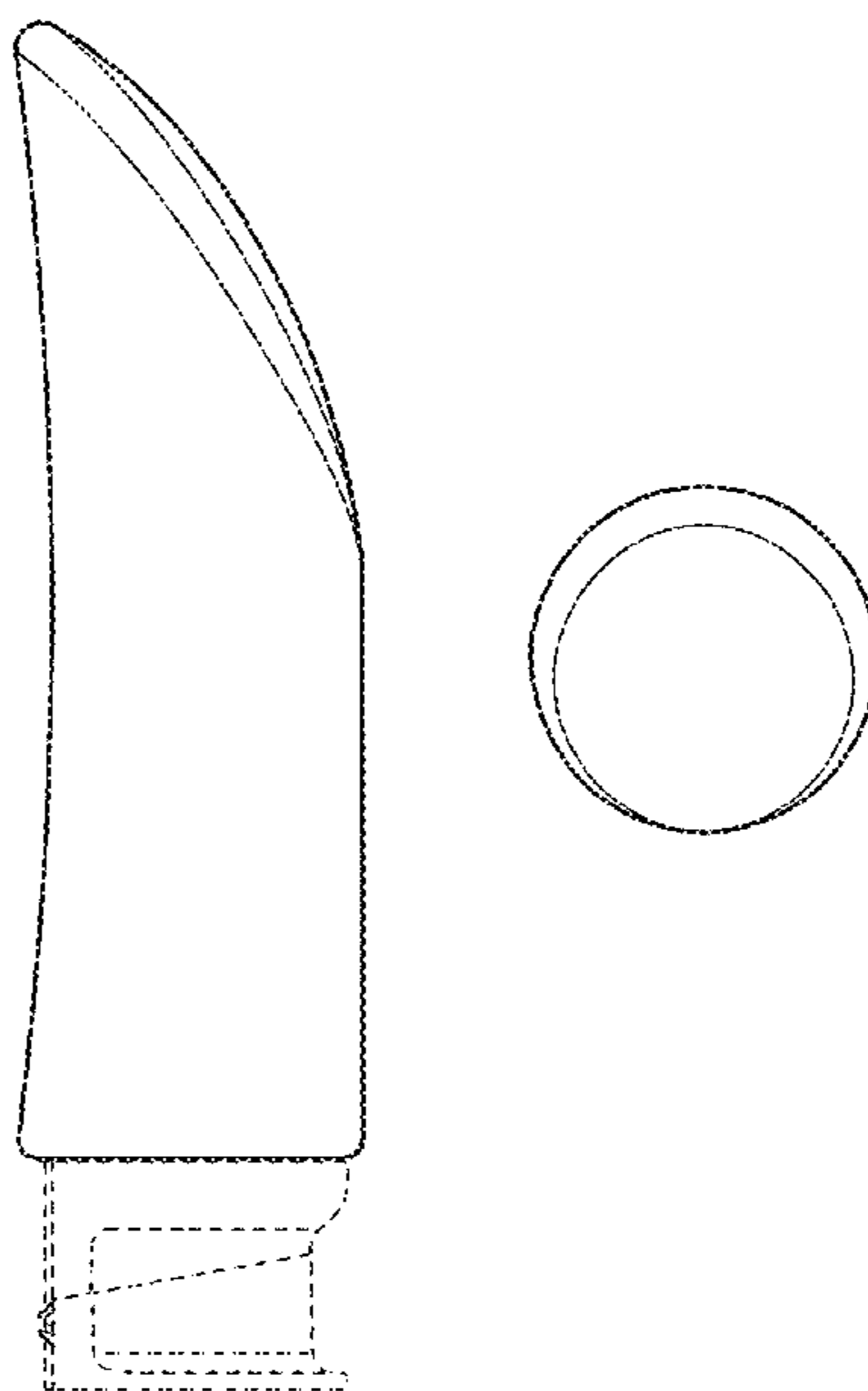
FIG. 5 is a left side view of the toothpaste package as shown in FIG. 1;

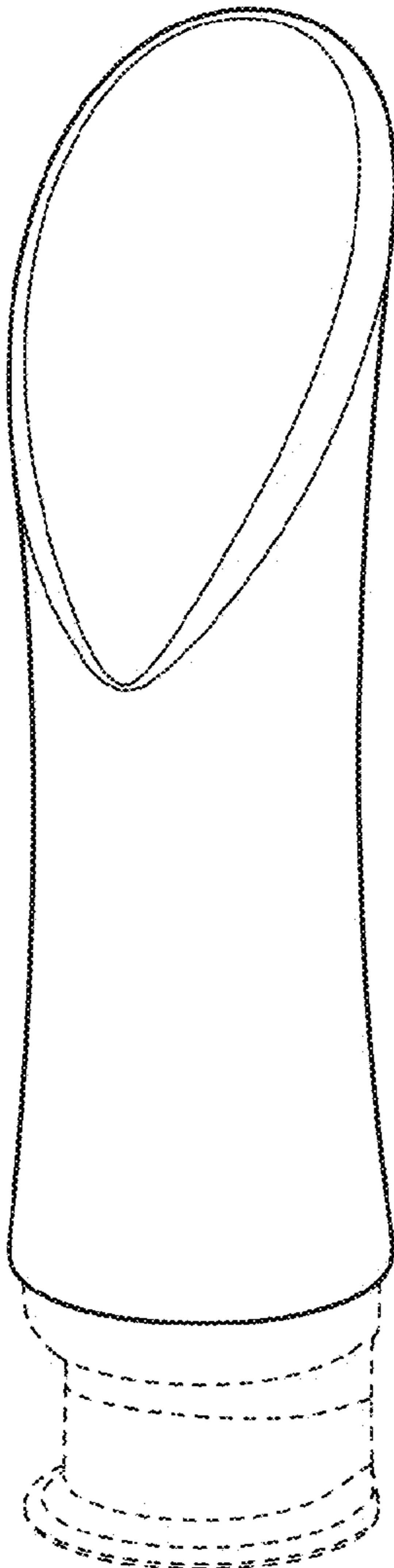

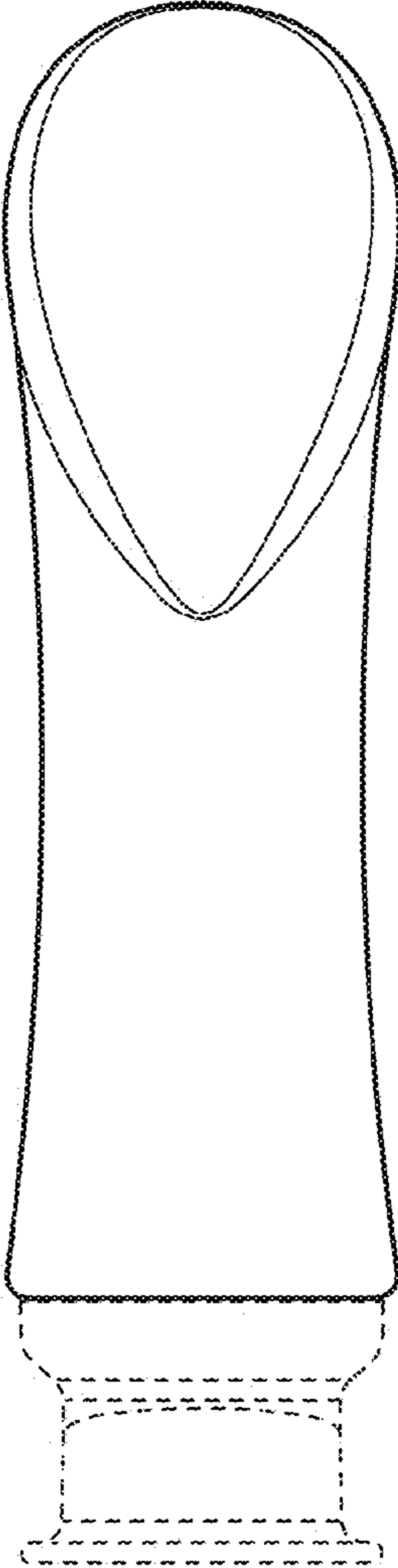

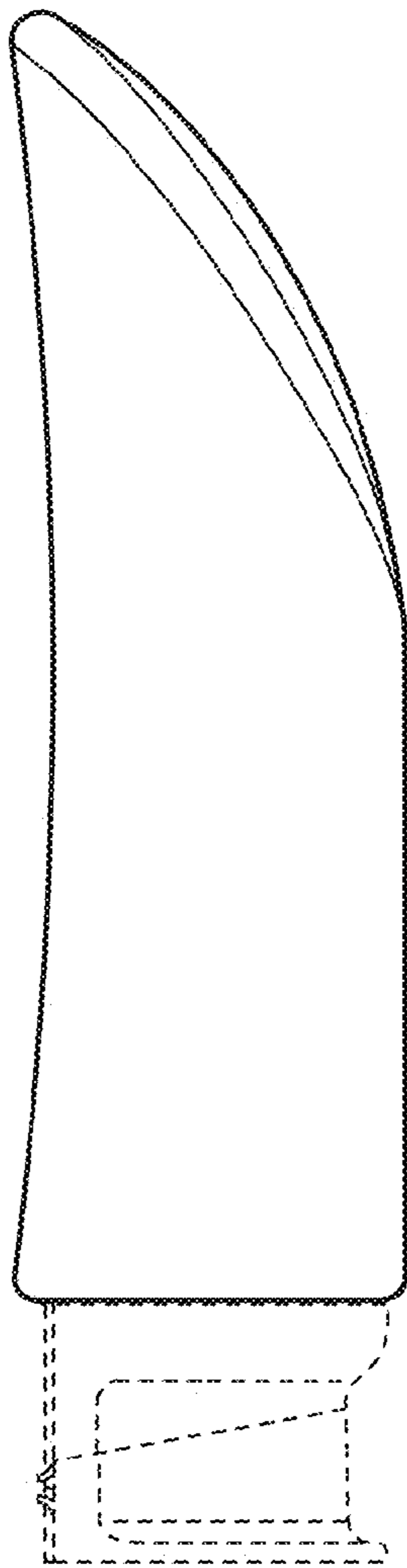

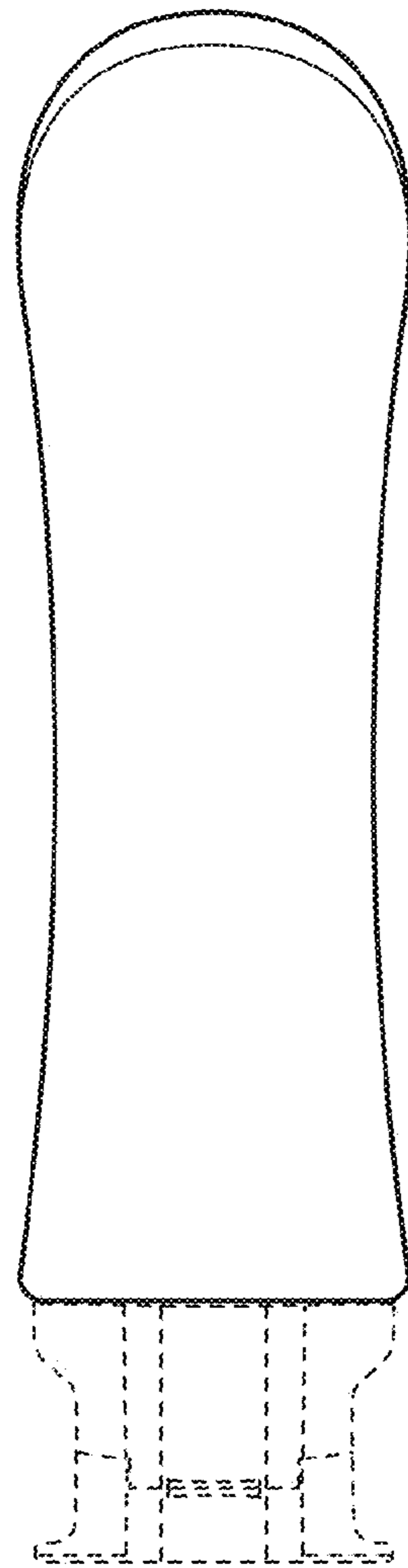

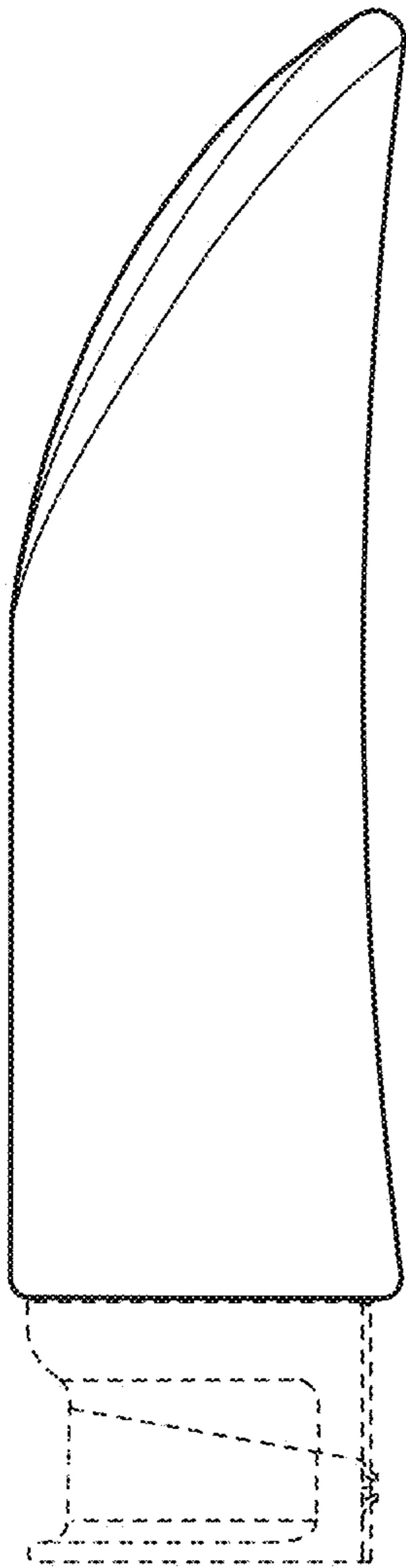

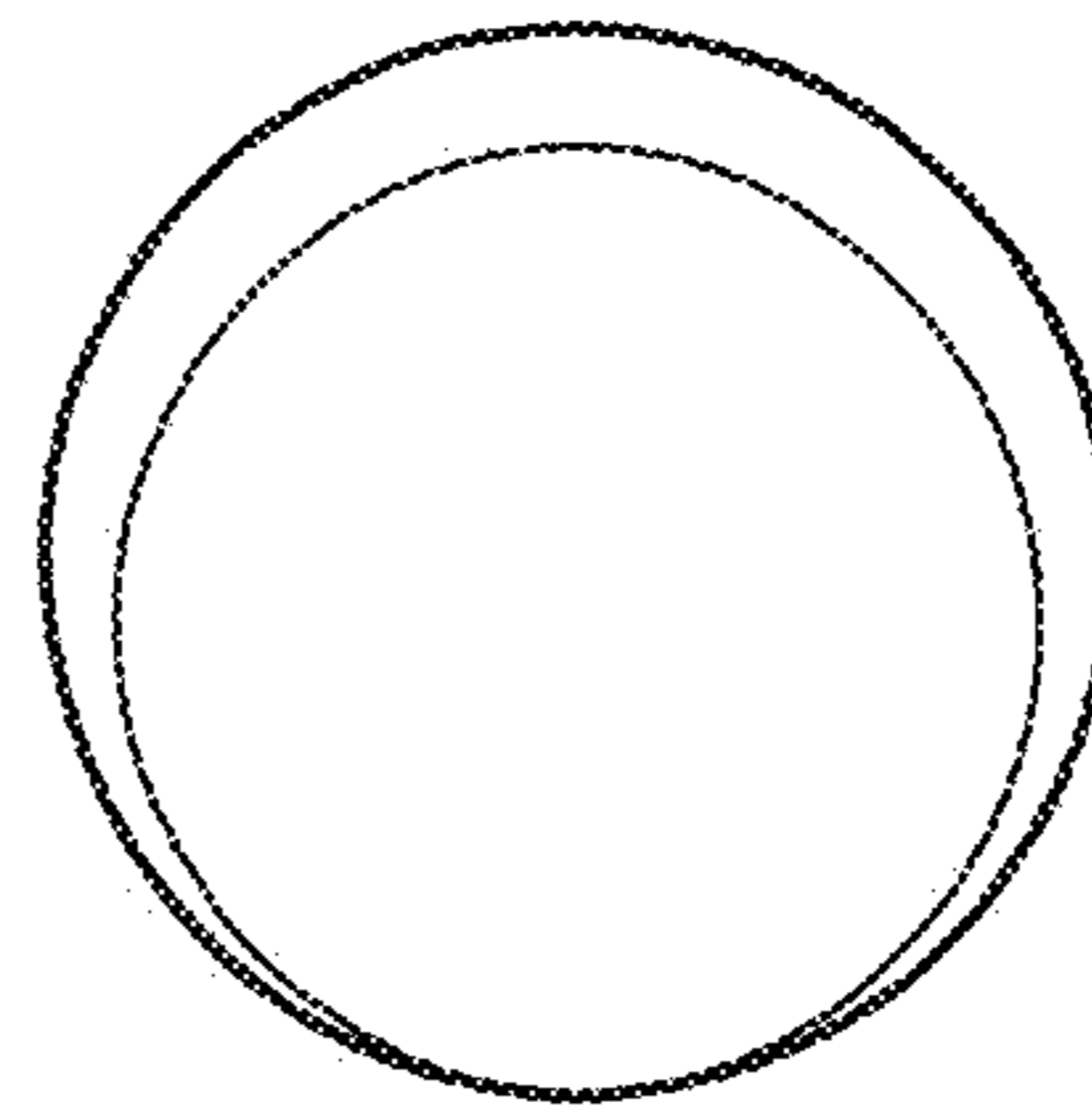

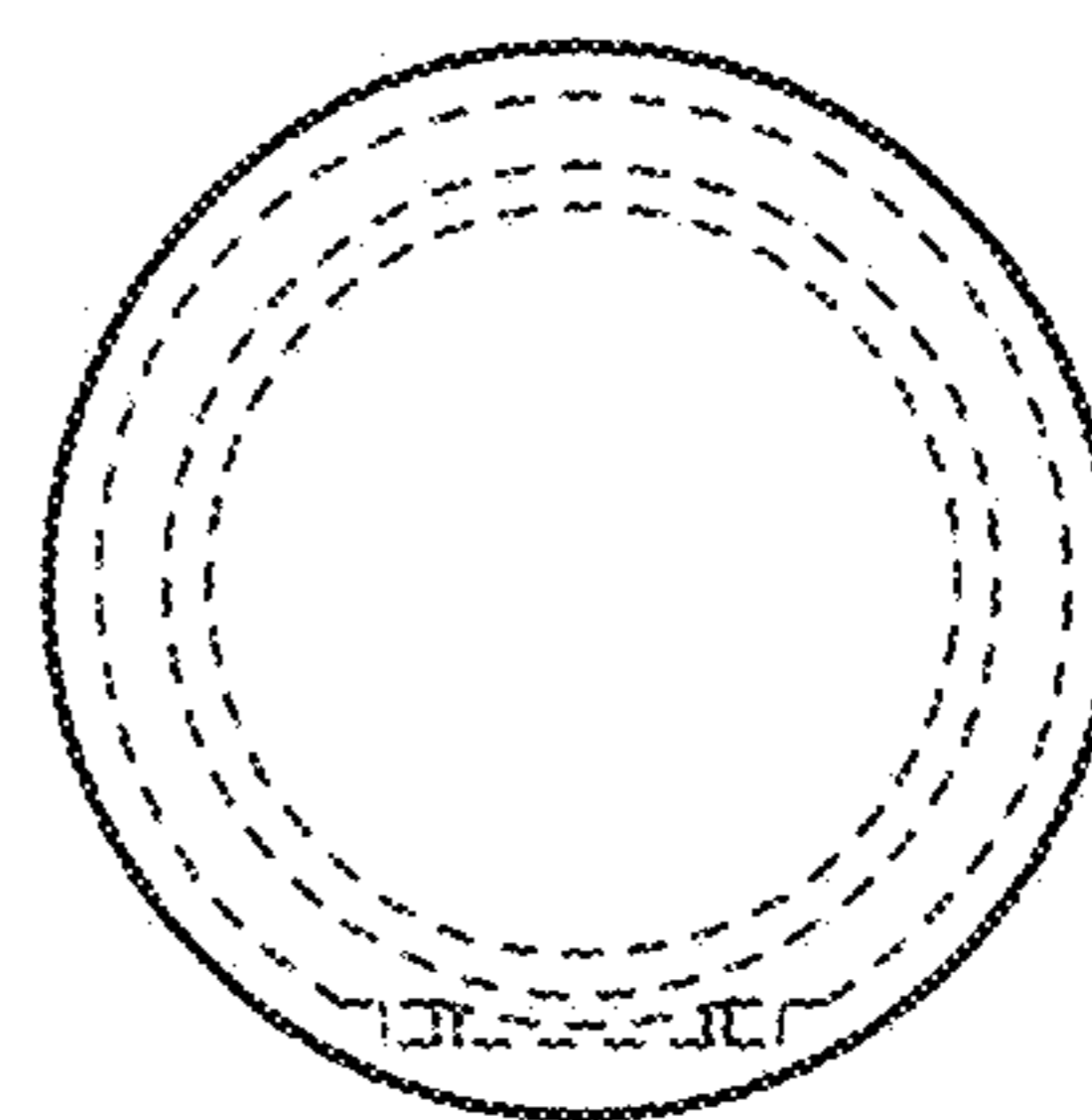
