**DESCRIPTION**

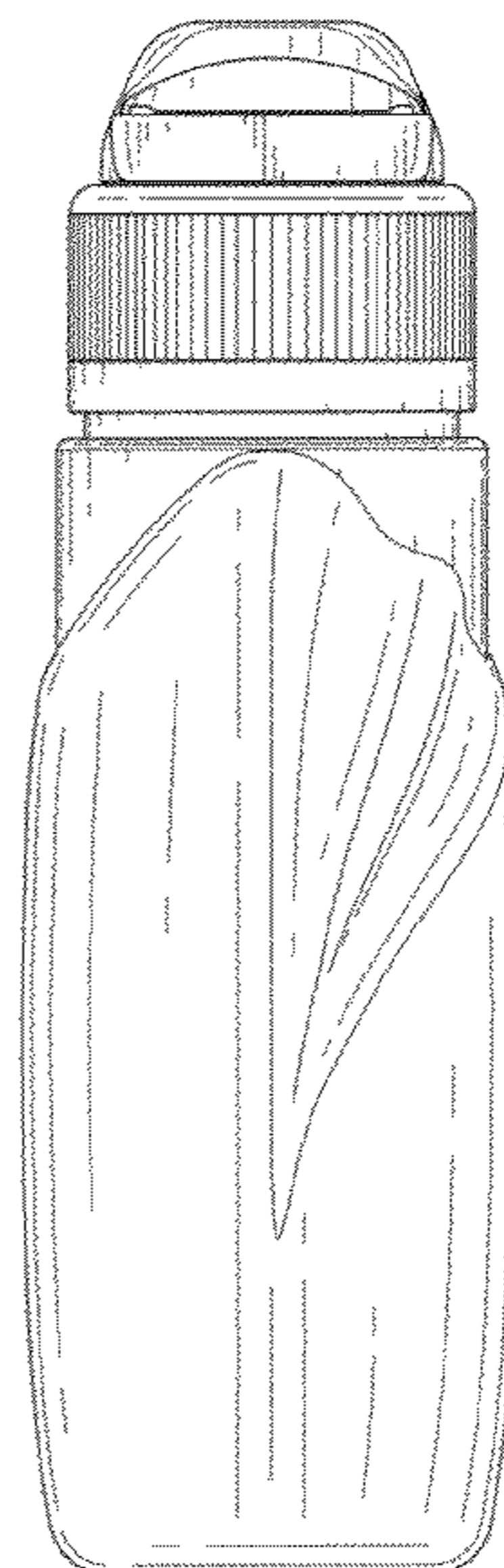
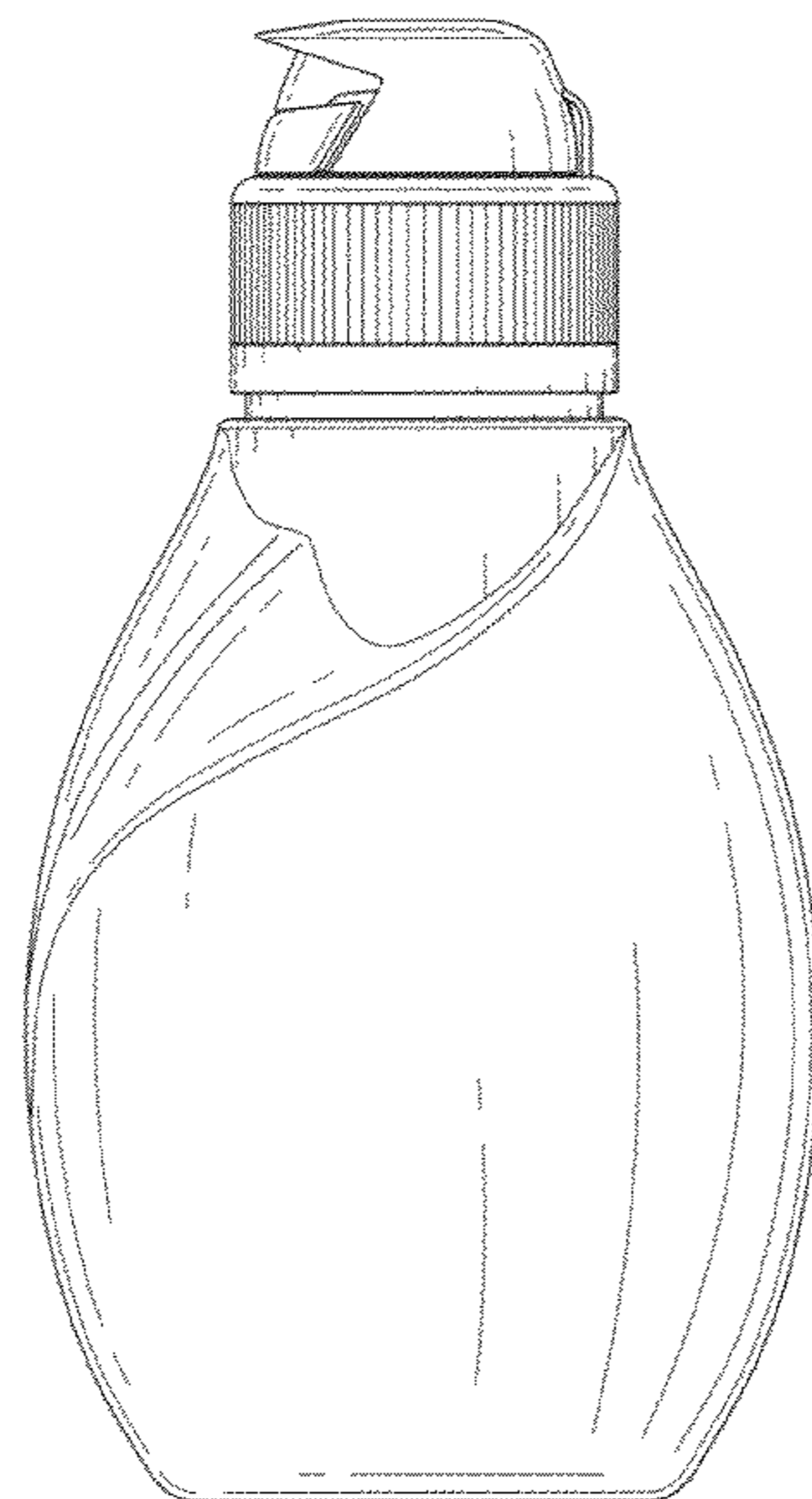

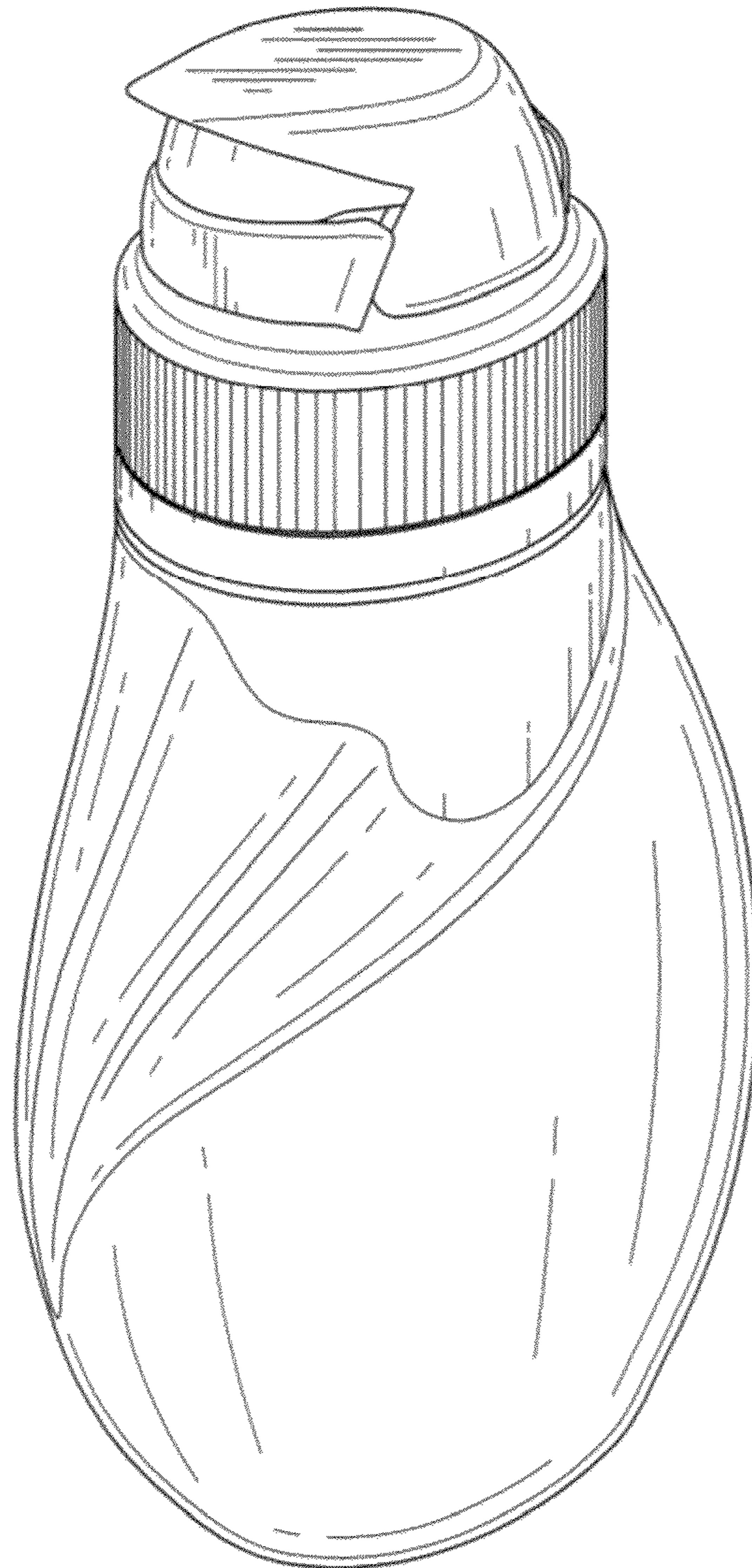

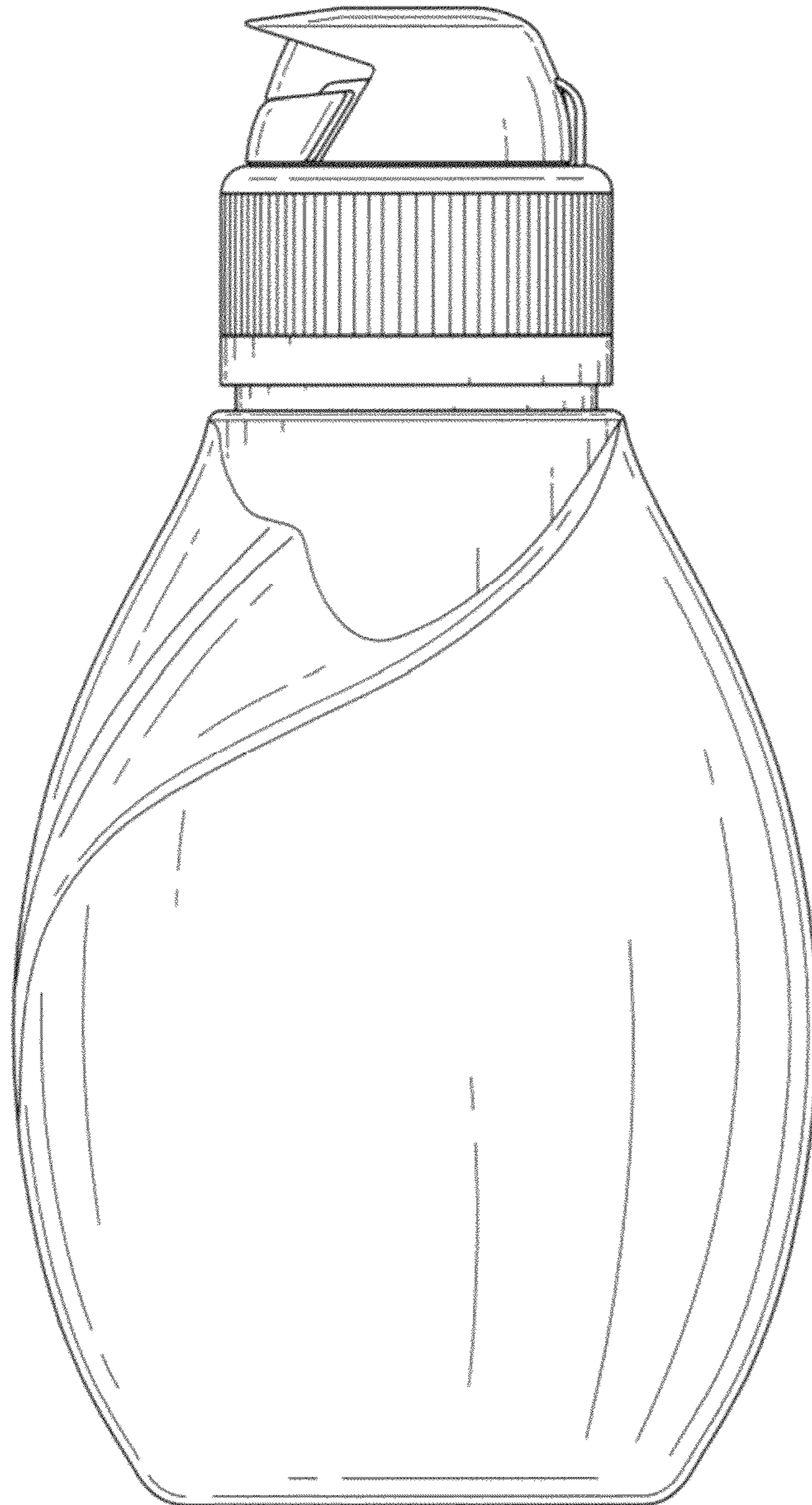

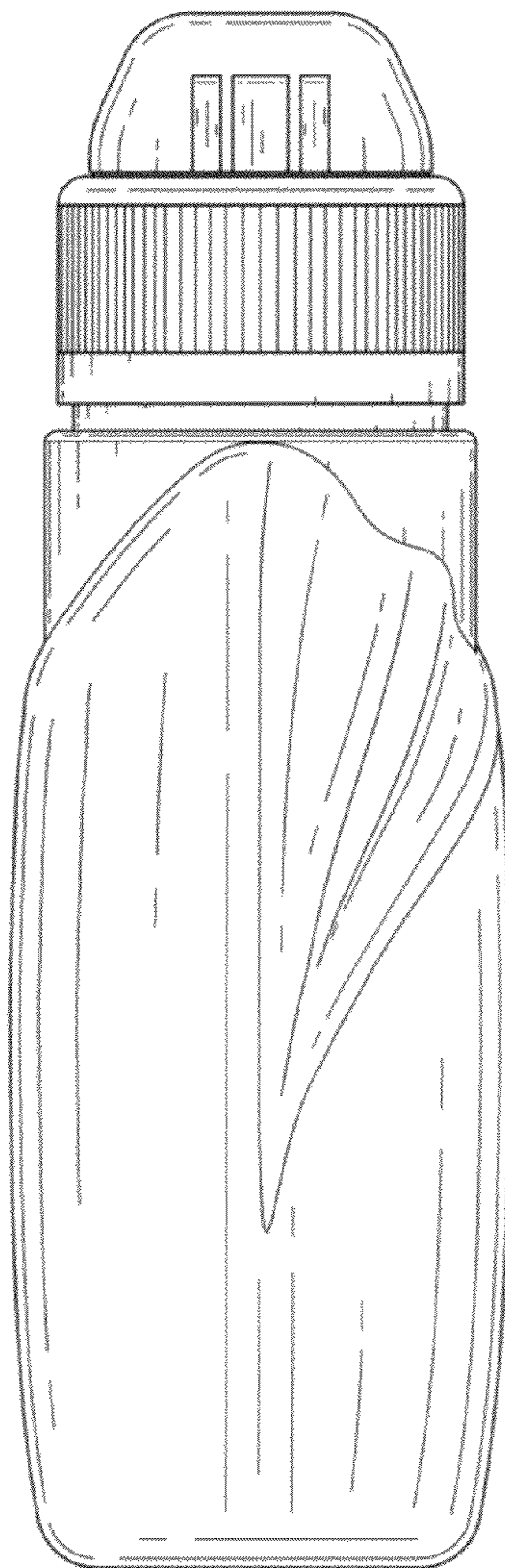

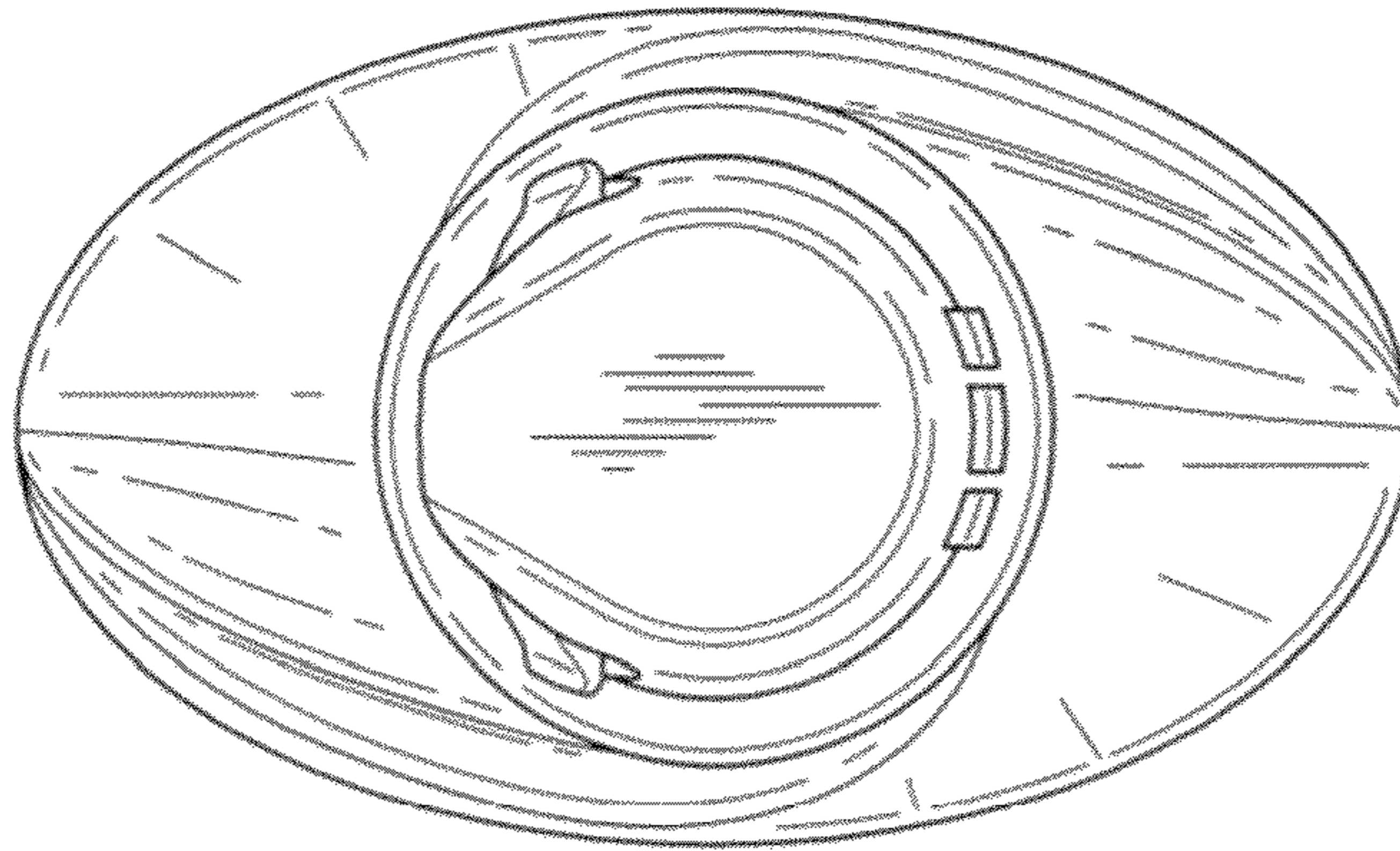
