(57) **CLAIM**

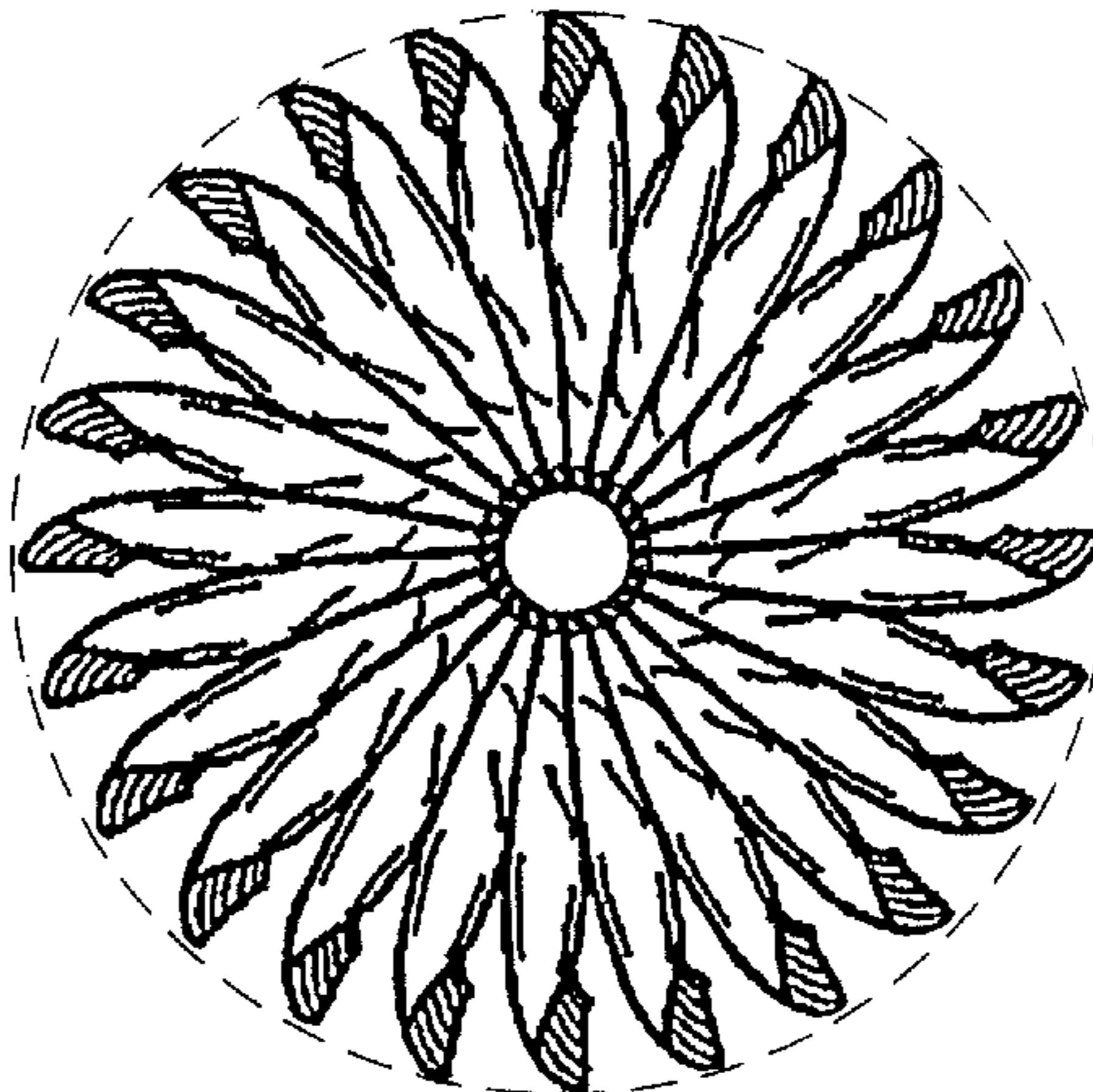
The ornamental design for a snuff box with snuff bags, as shown and described.
