FIG. 7 is a bottom view thereof.

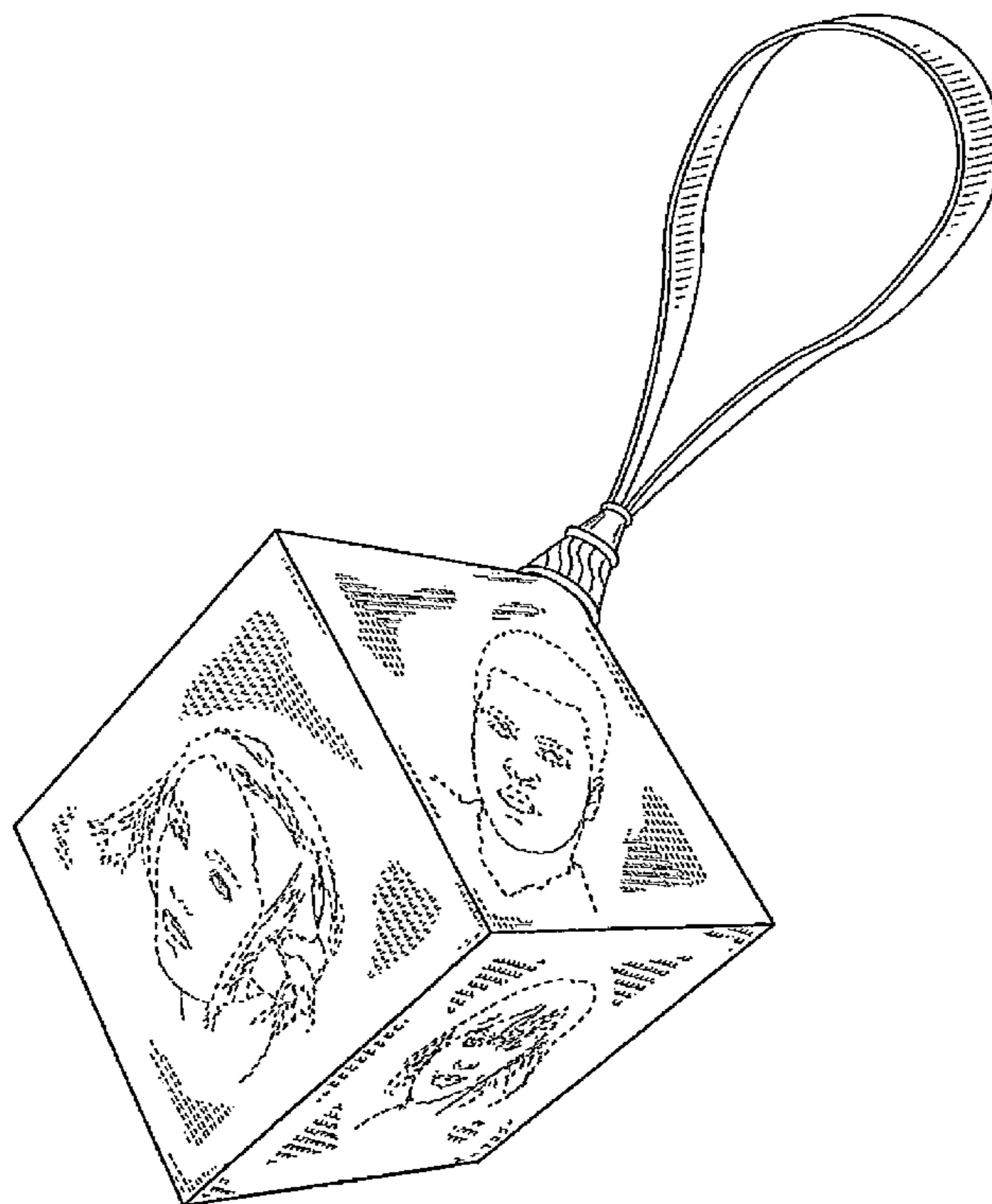
The broken lines showing the hanging-personalized-cube ornament, or portion thereof, are not a part of the claimed design.

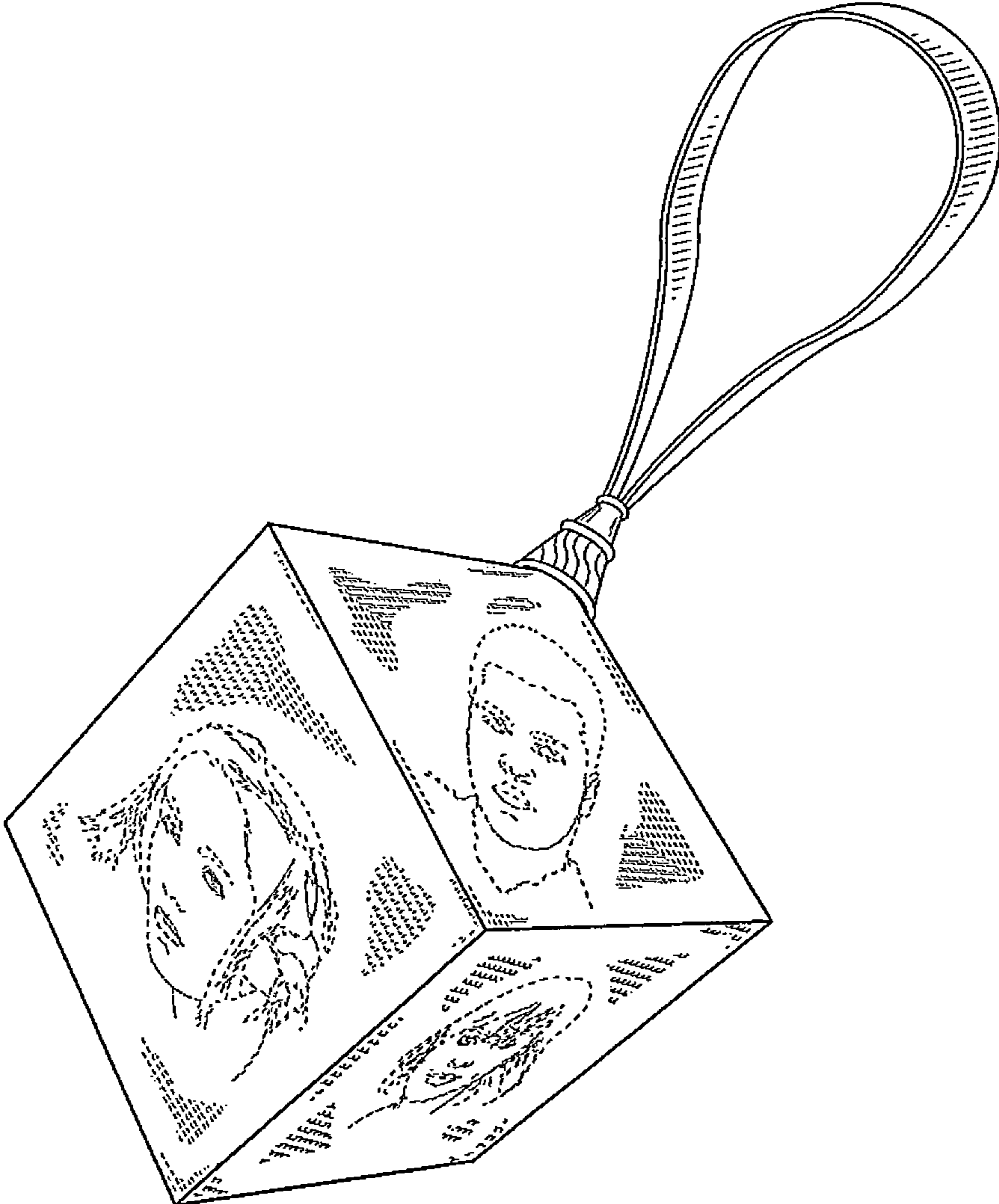

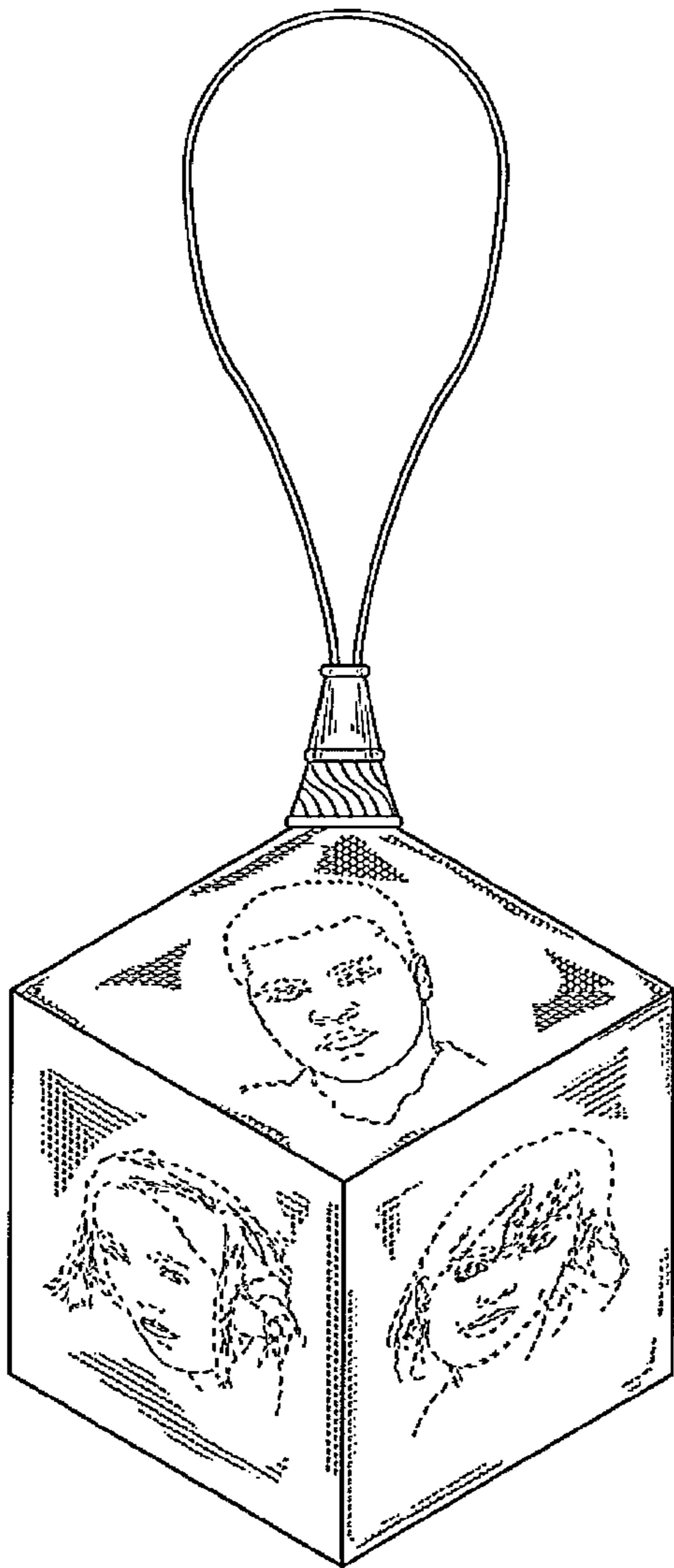

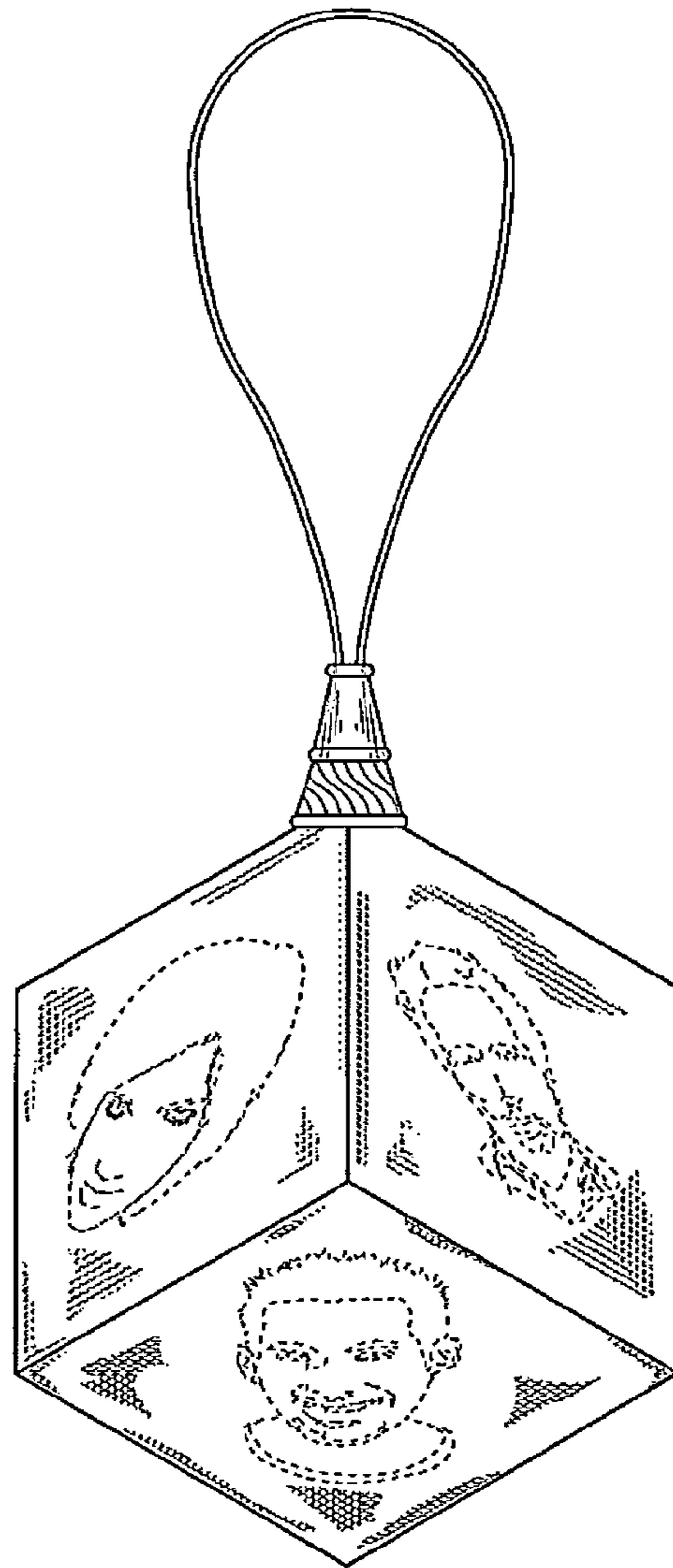

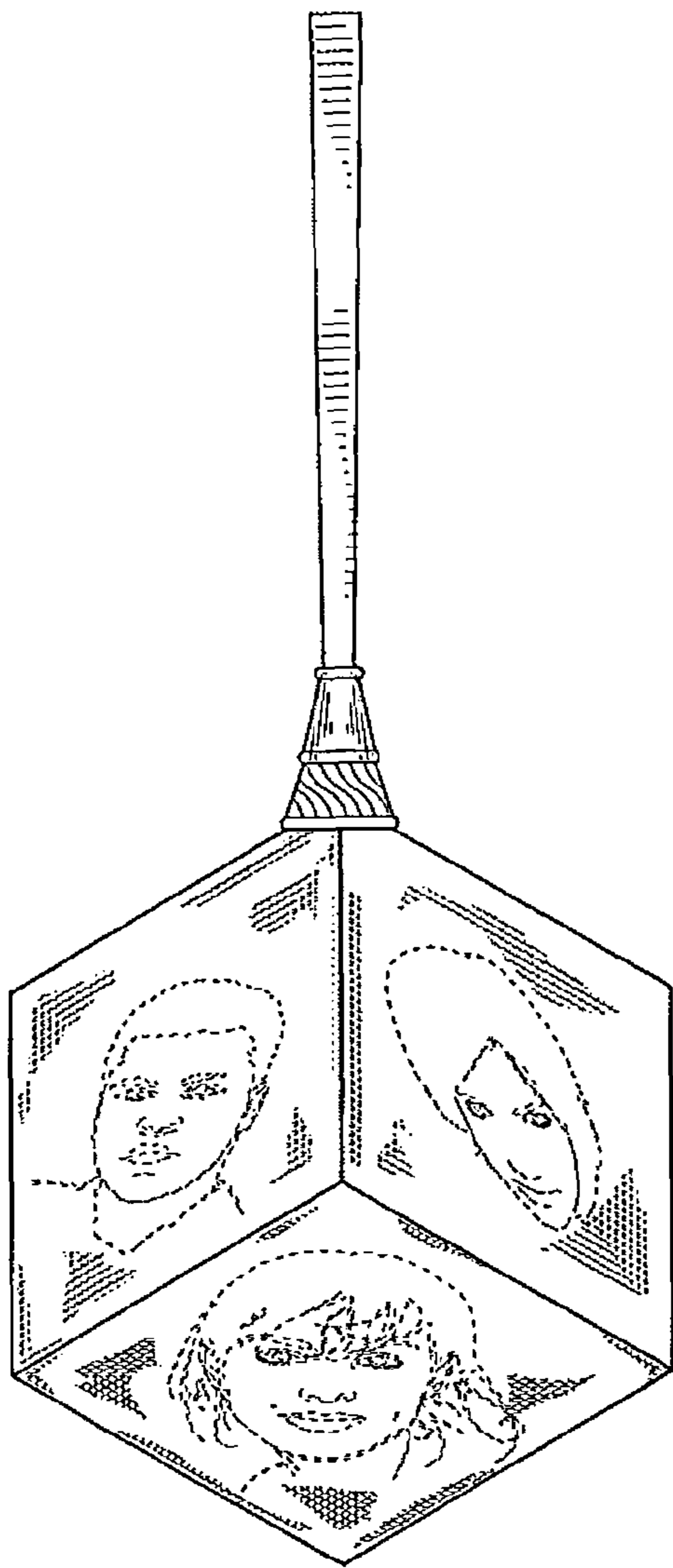

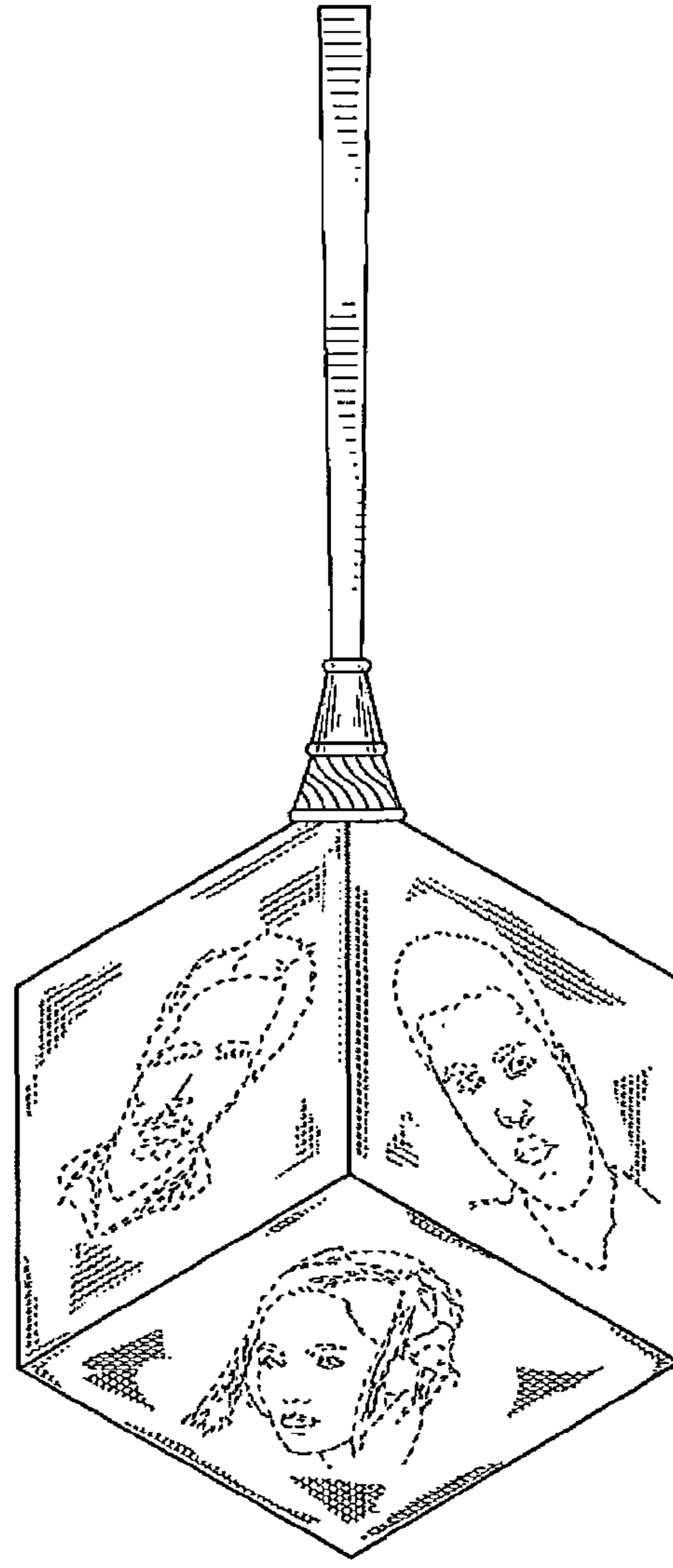

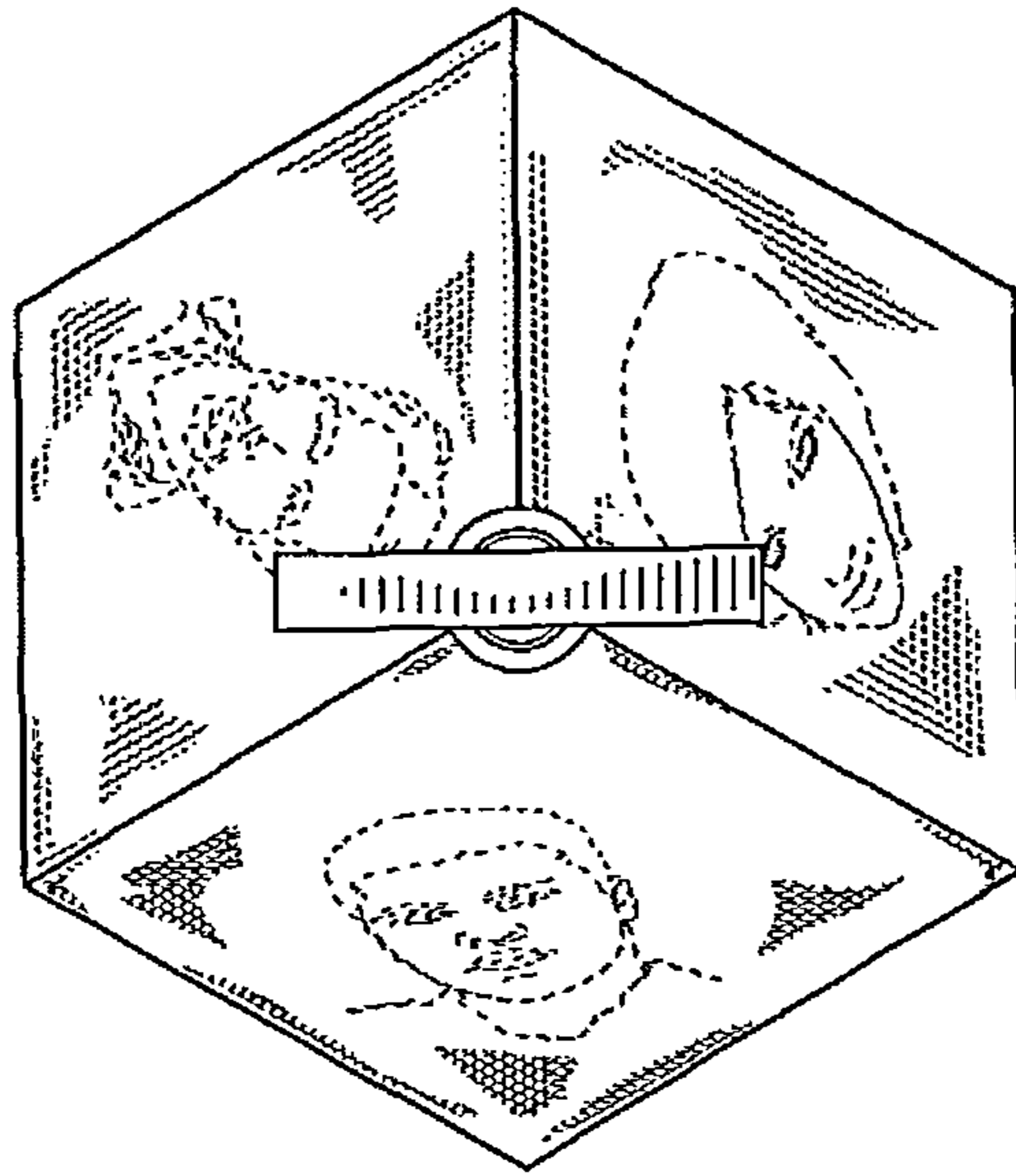

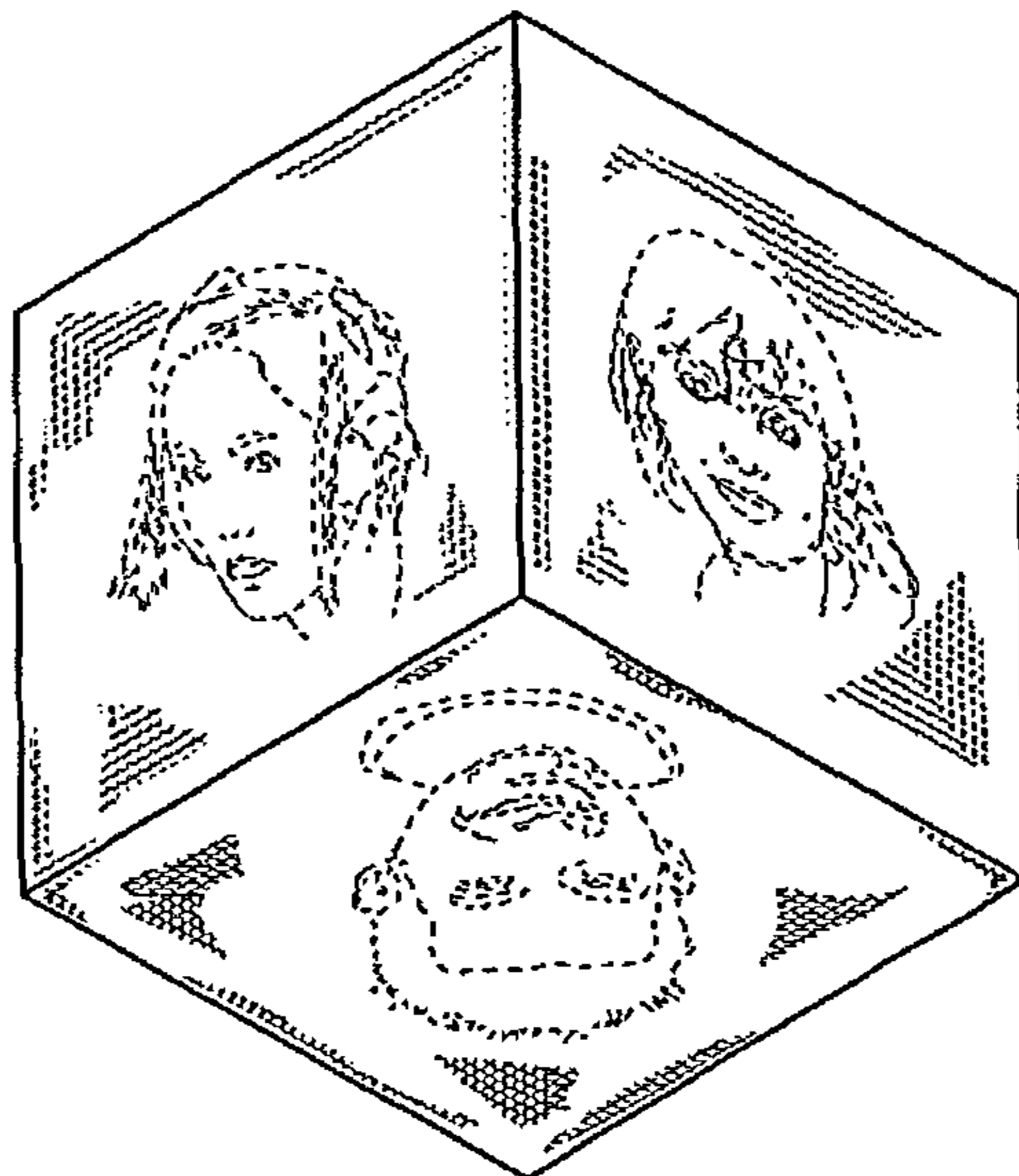
