(57) **CLAIM**

The ornamental design for a tricycle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of the design for a tricycle;

FIG. 2 is a lateral/side elevation view of the embodiment of the design of FIG. 1;

FIG. 3 is lateral/side elevation view of the embodiment of the design of FIG. 1 on the opposite side of the side depicted in FIG. 2;

FIG. 4 is a front elevation view of the embodiment of the design of FIG. 1;

FIG. 5 is a rear elevation view of the embodiment of the design of FIG. 1;

FIG. 6 is a bottom plan view of the embodiment of the design of FIG. 1; and,

FIG. 7 is a top plan view of the embodiment of the design of FIG. 1.

The tricycle, e.g., an elliptical tricycle, is for, e.g., transportation, leisure and/or physical activity.

Any components or portions in the accompanying drawings shown in broken lines form no part of the claimed design or a specified embodiment thereof.

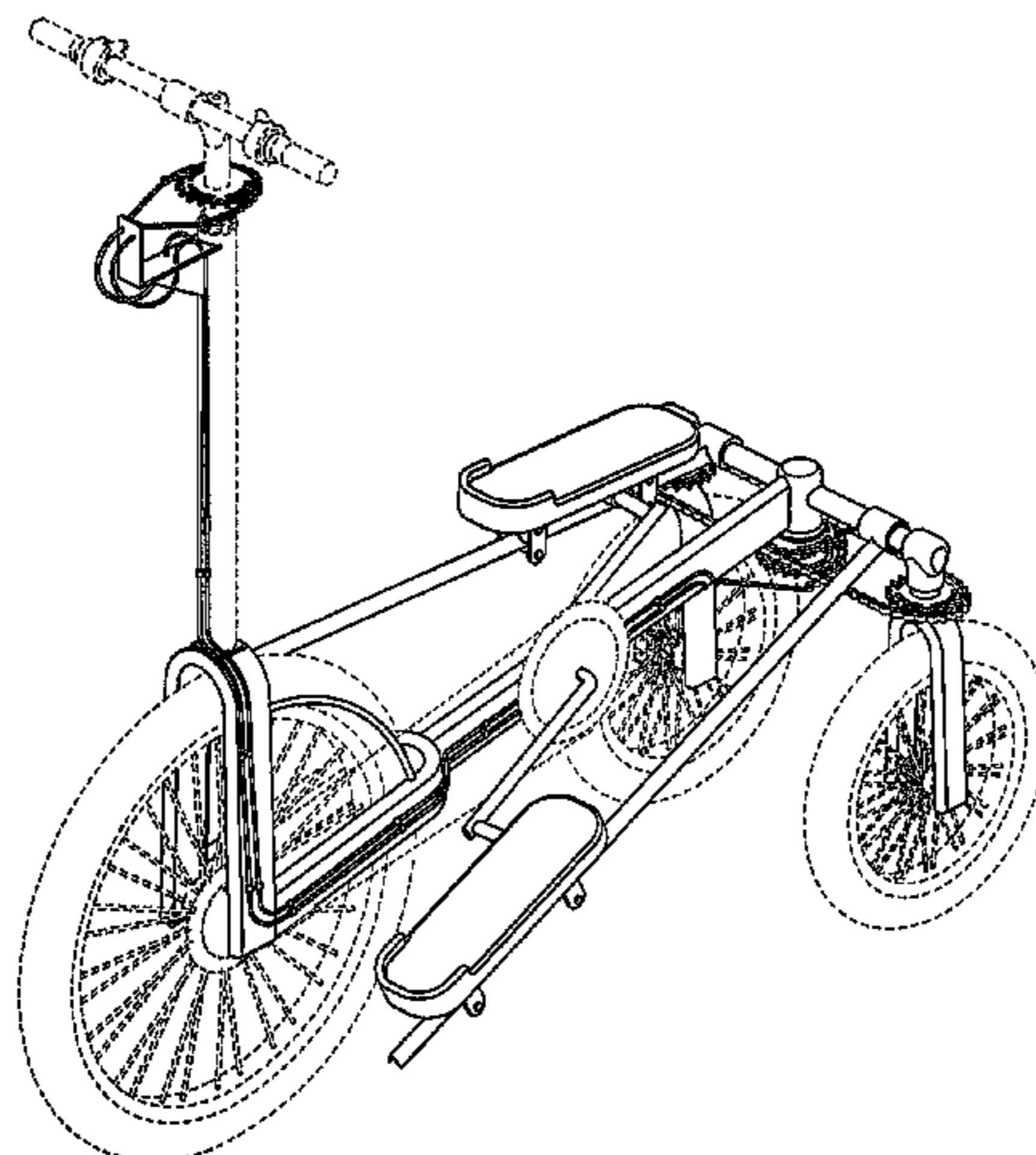

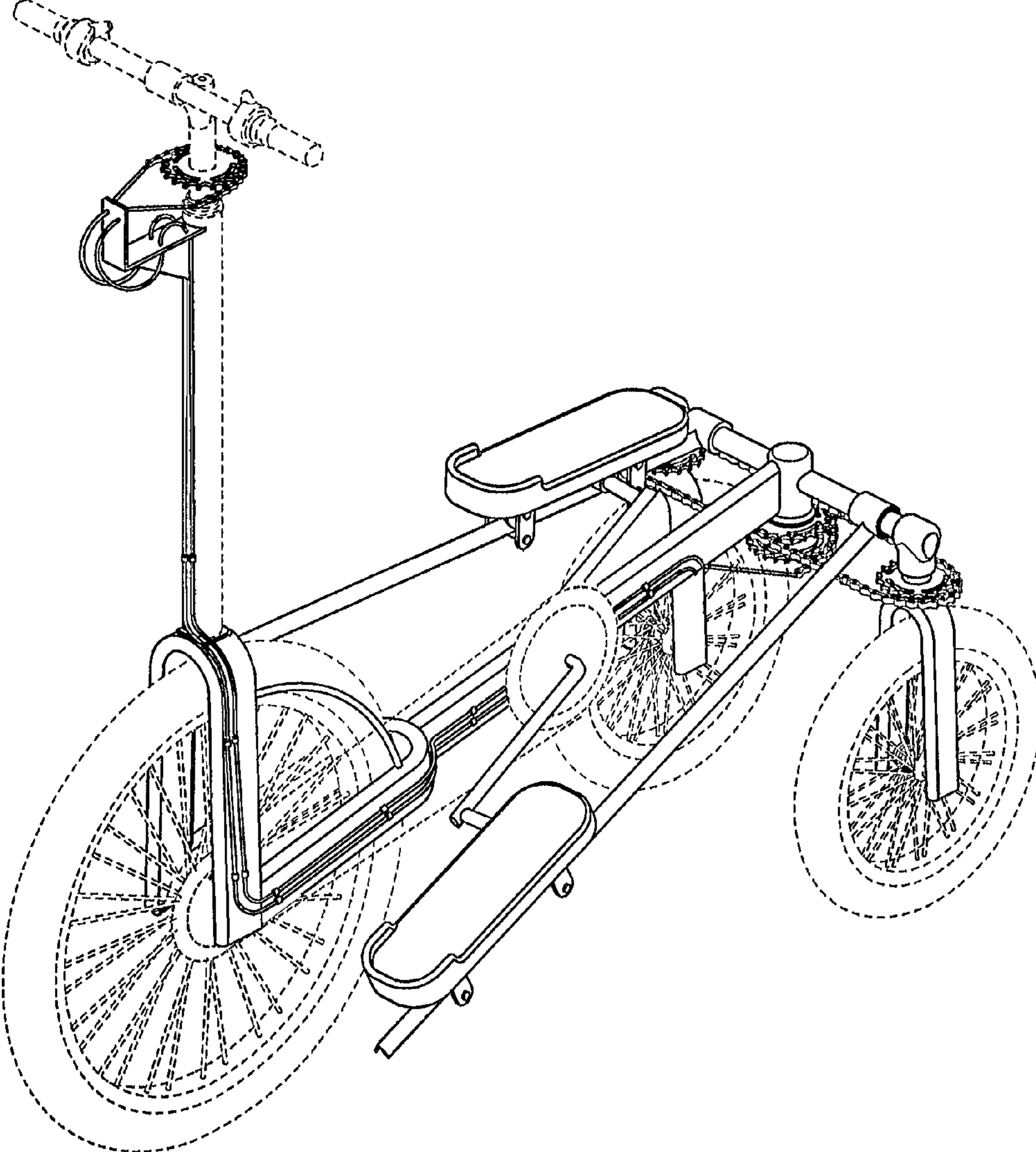

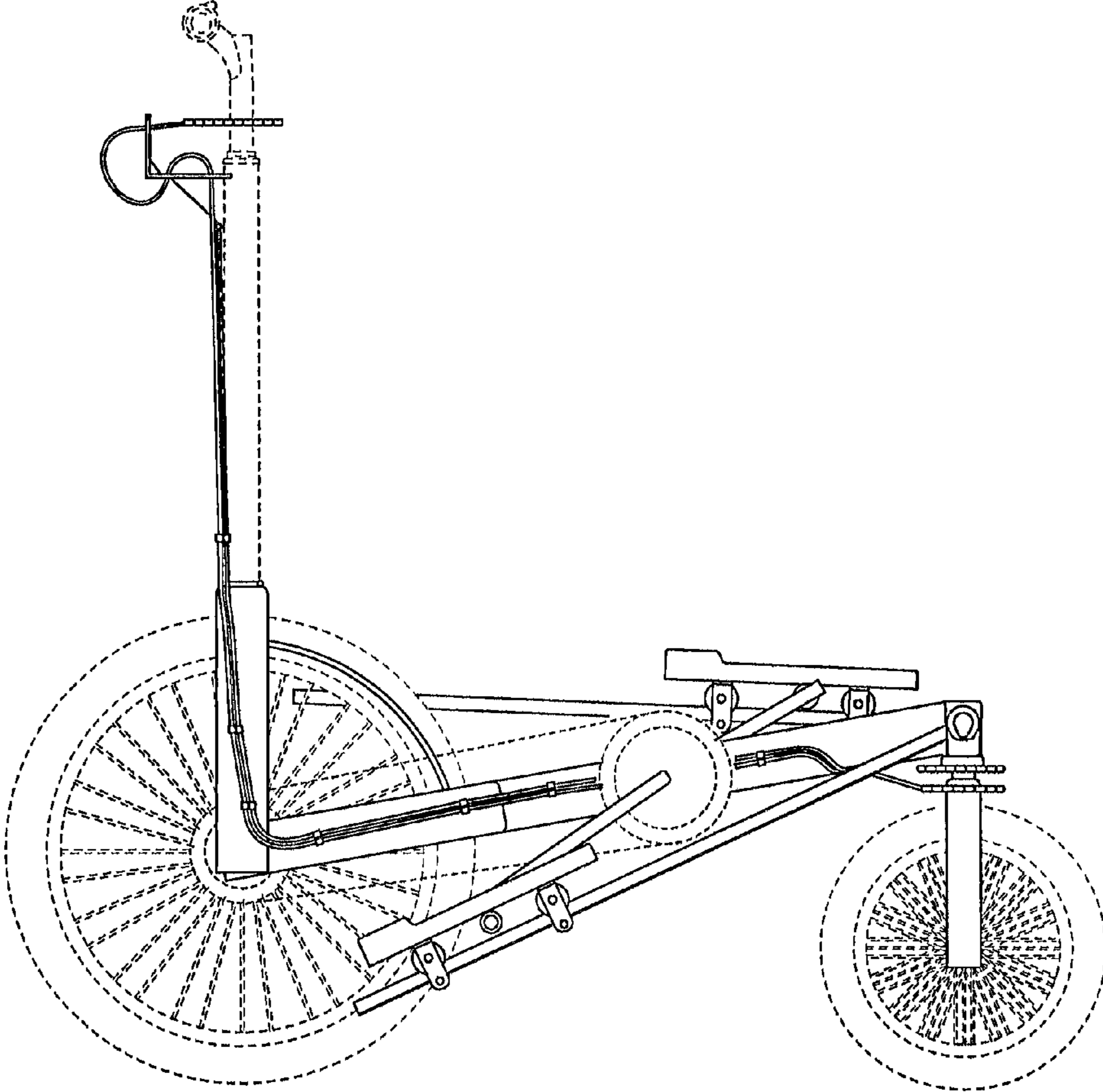

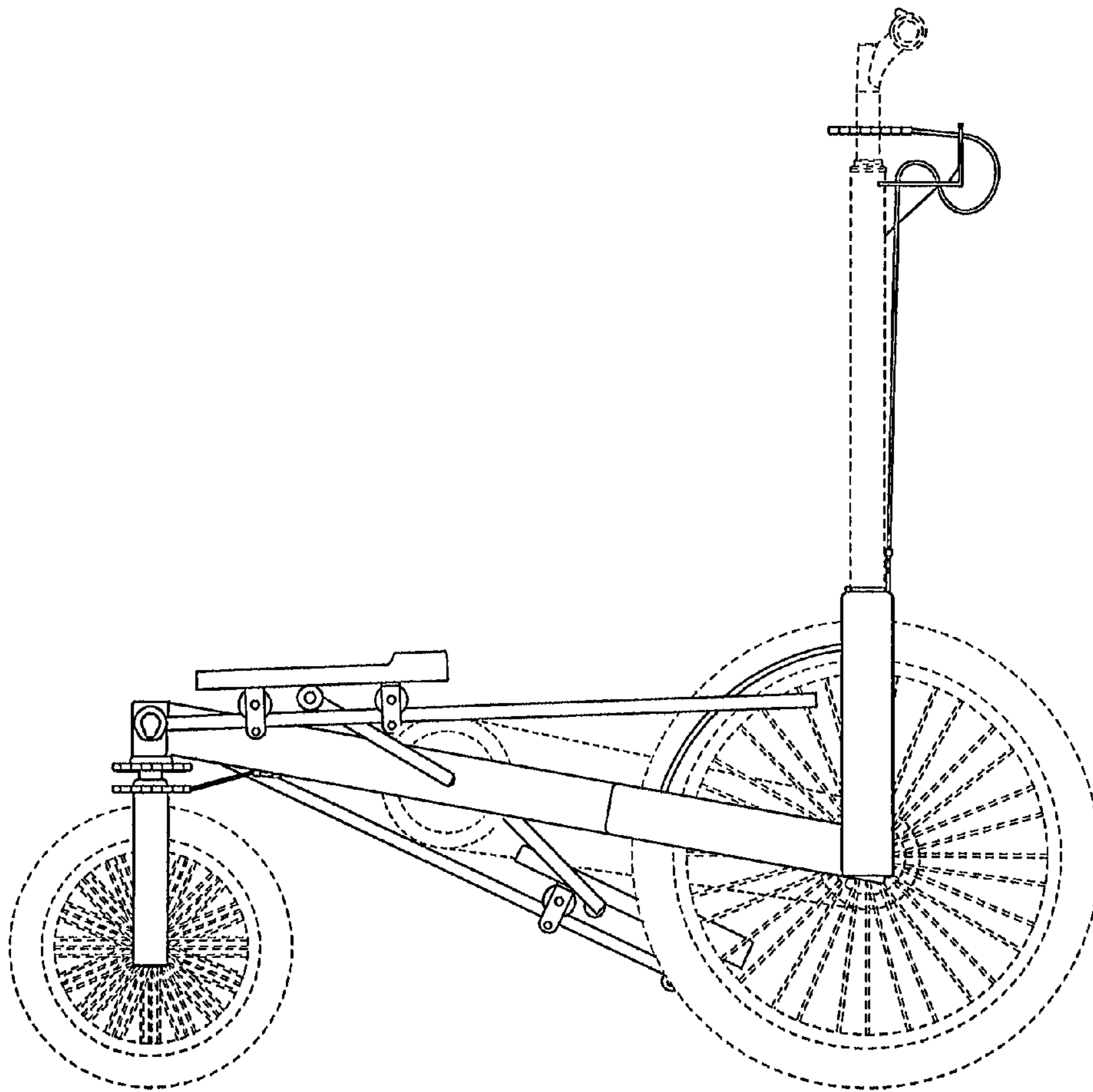

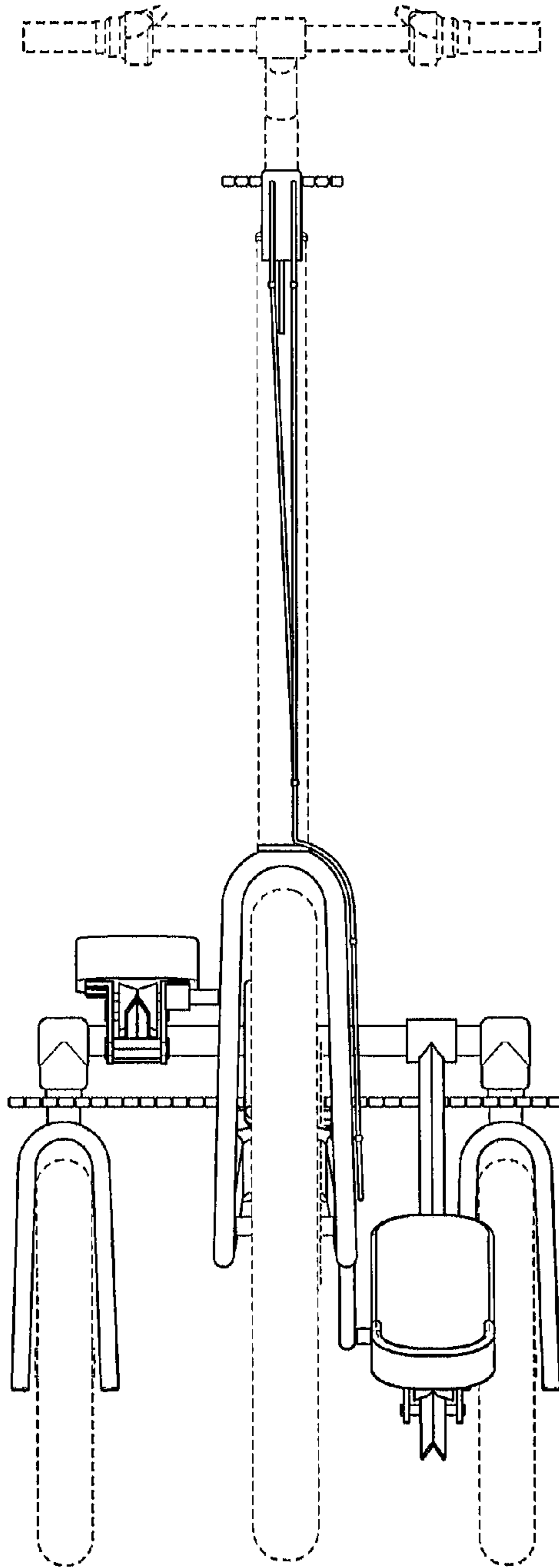

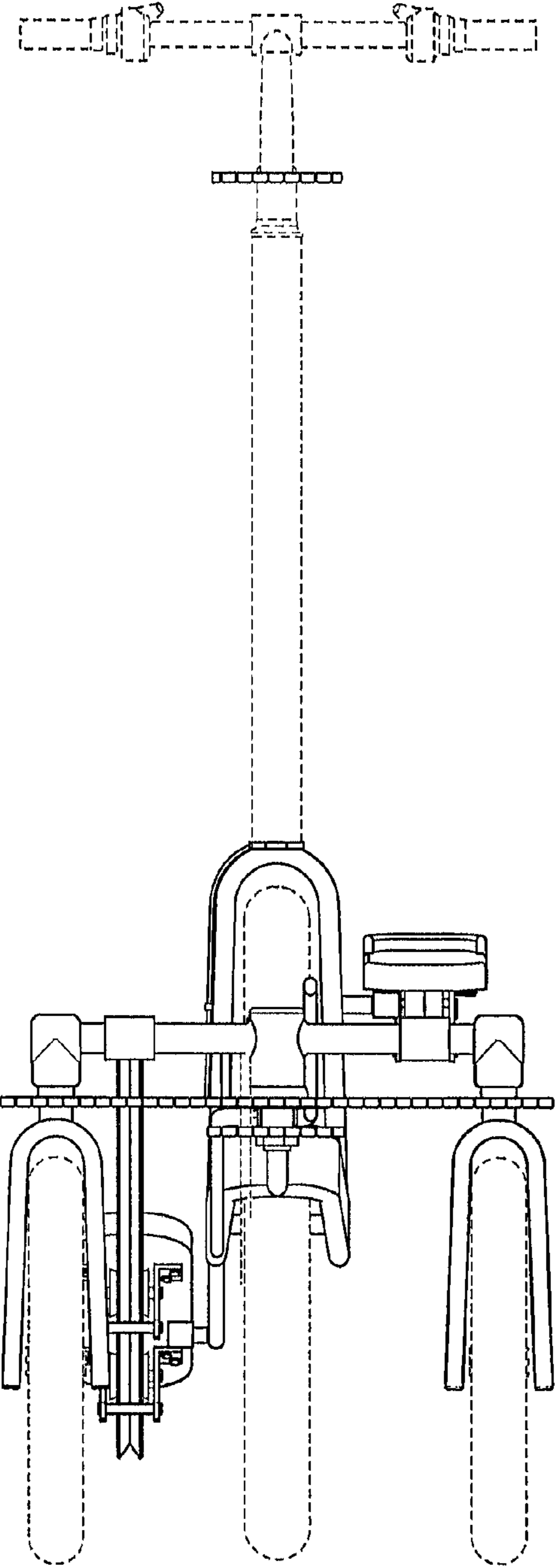

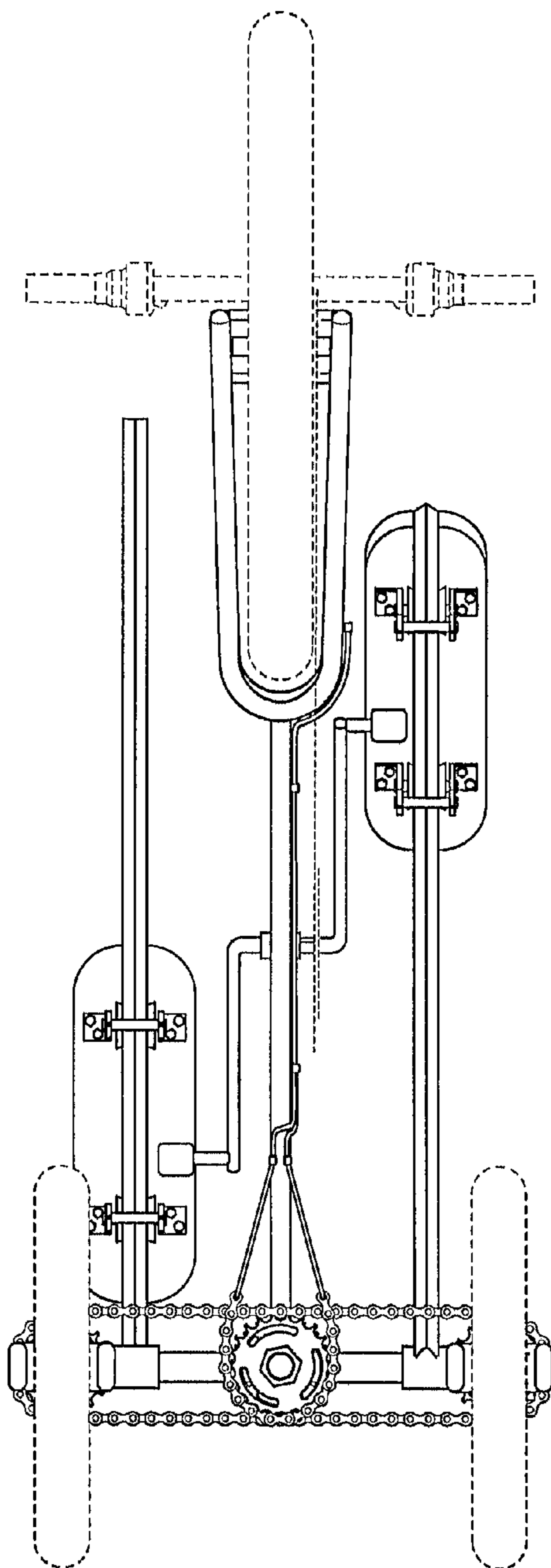
