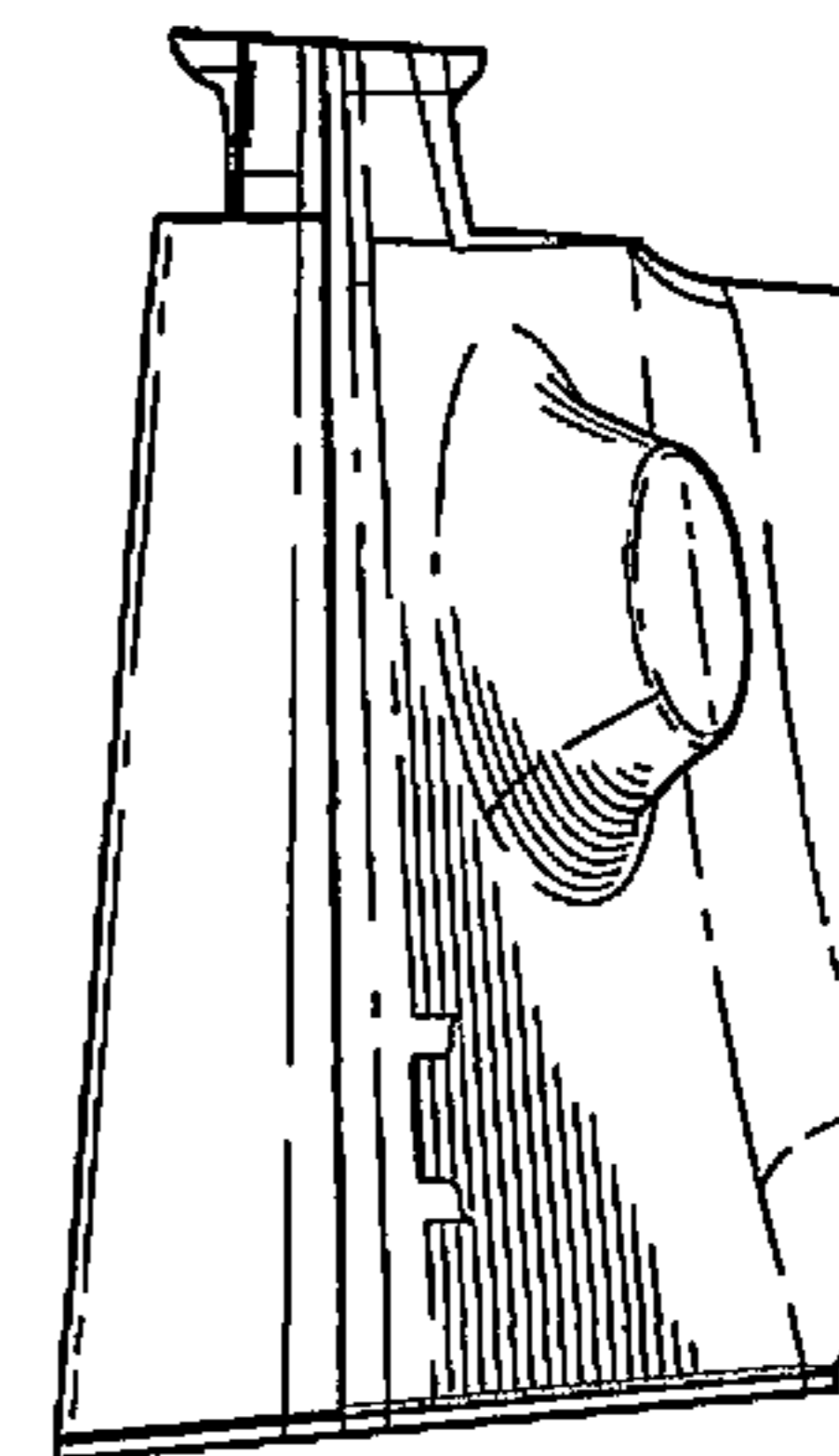
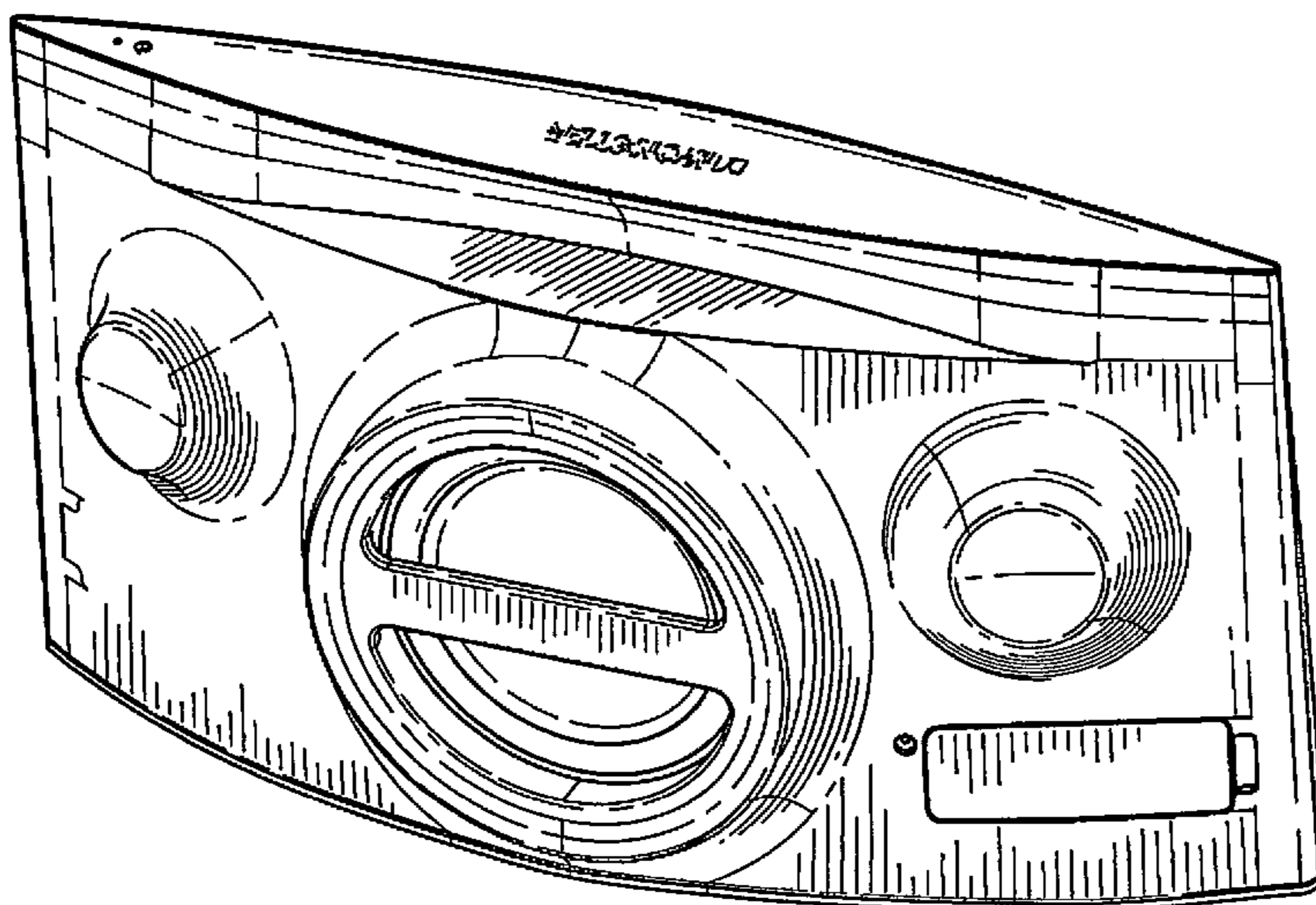
The ornamental design for a speaker, as shown and described.

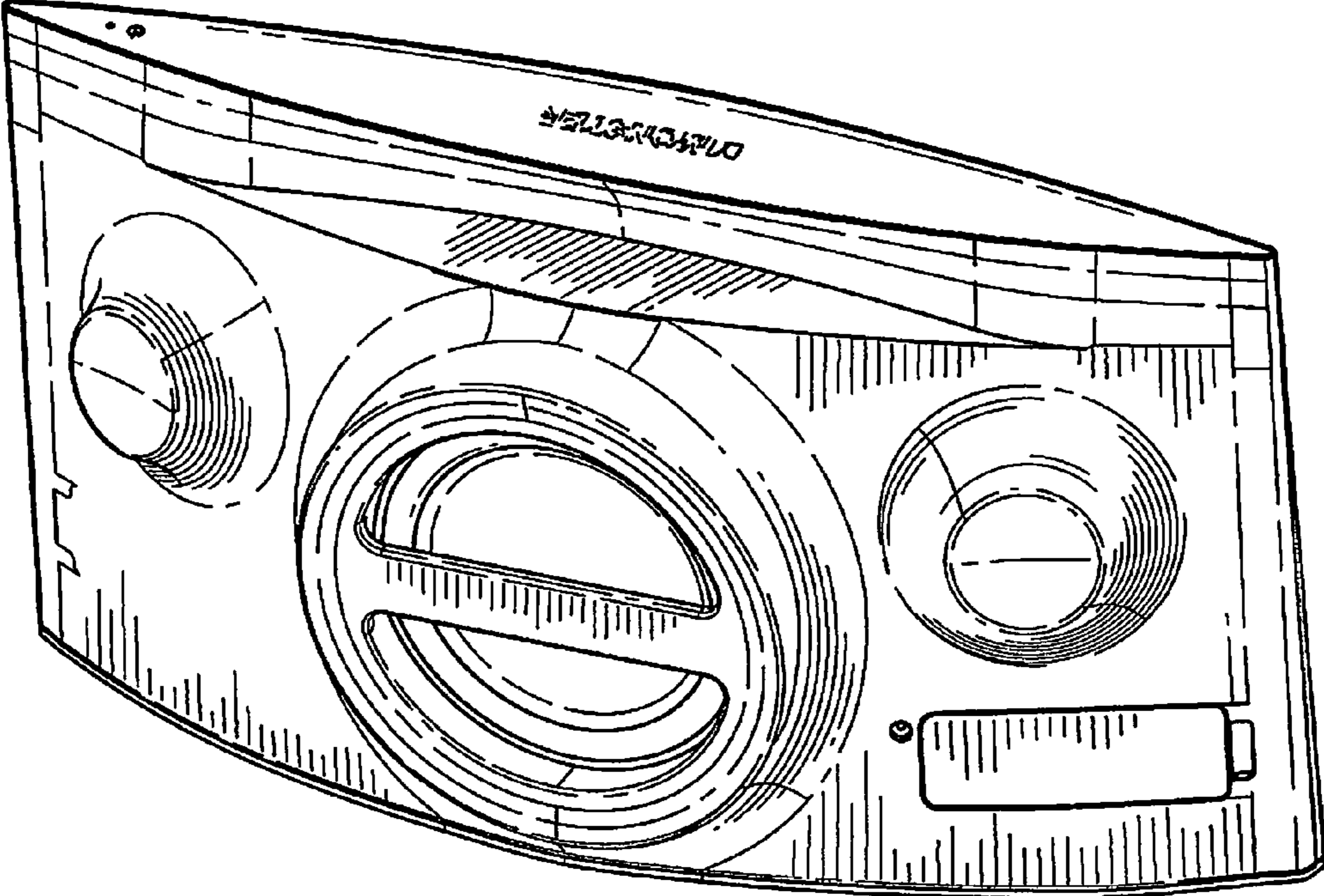

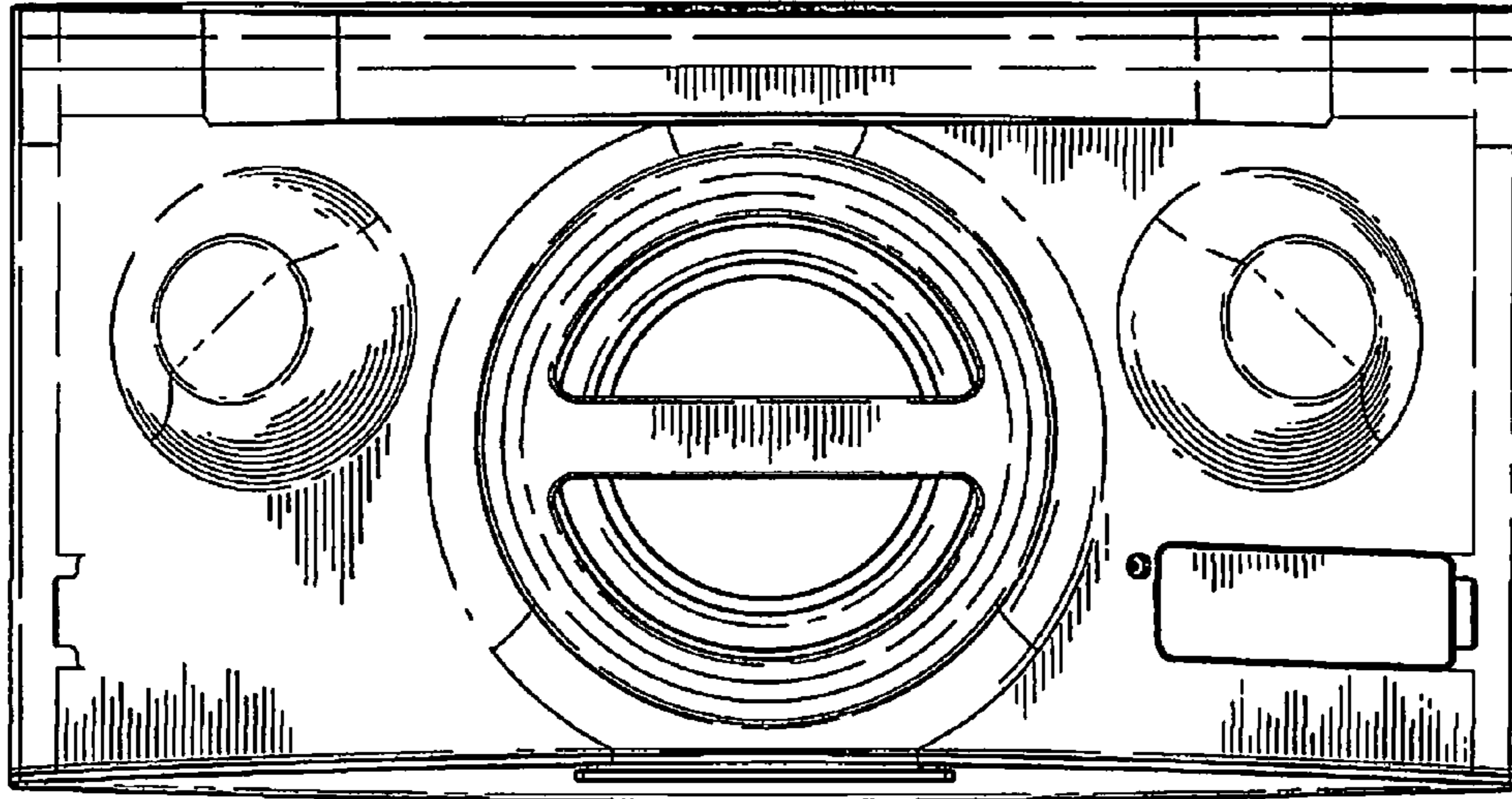

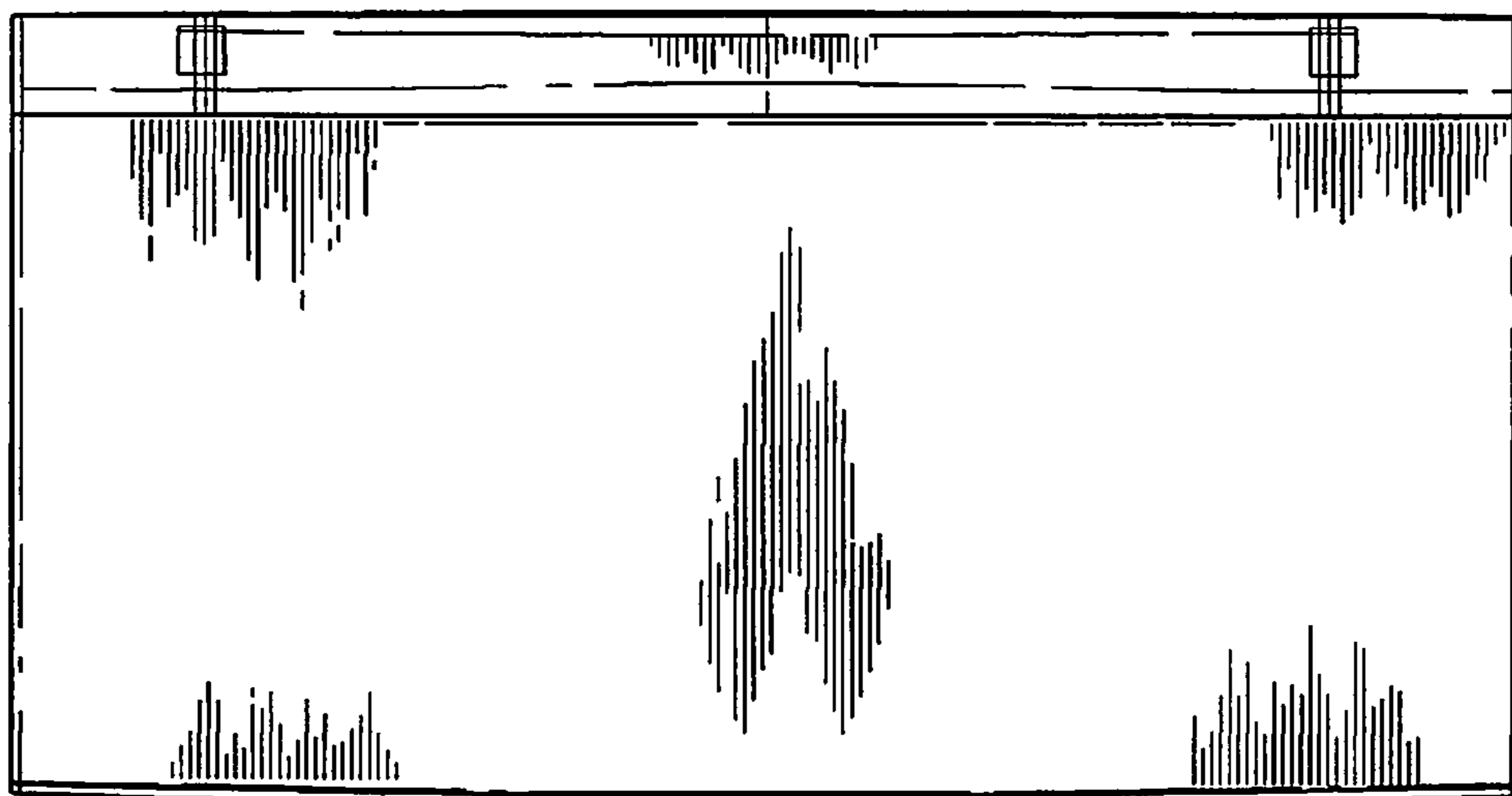

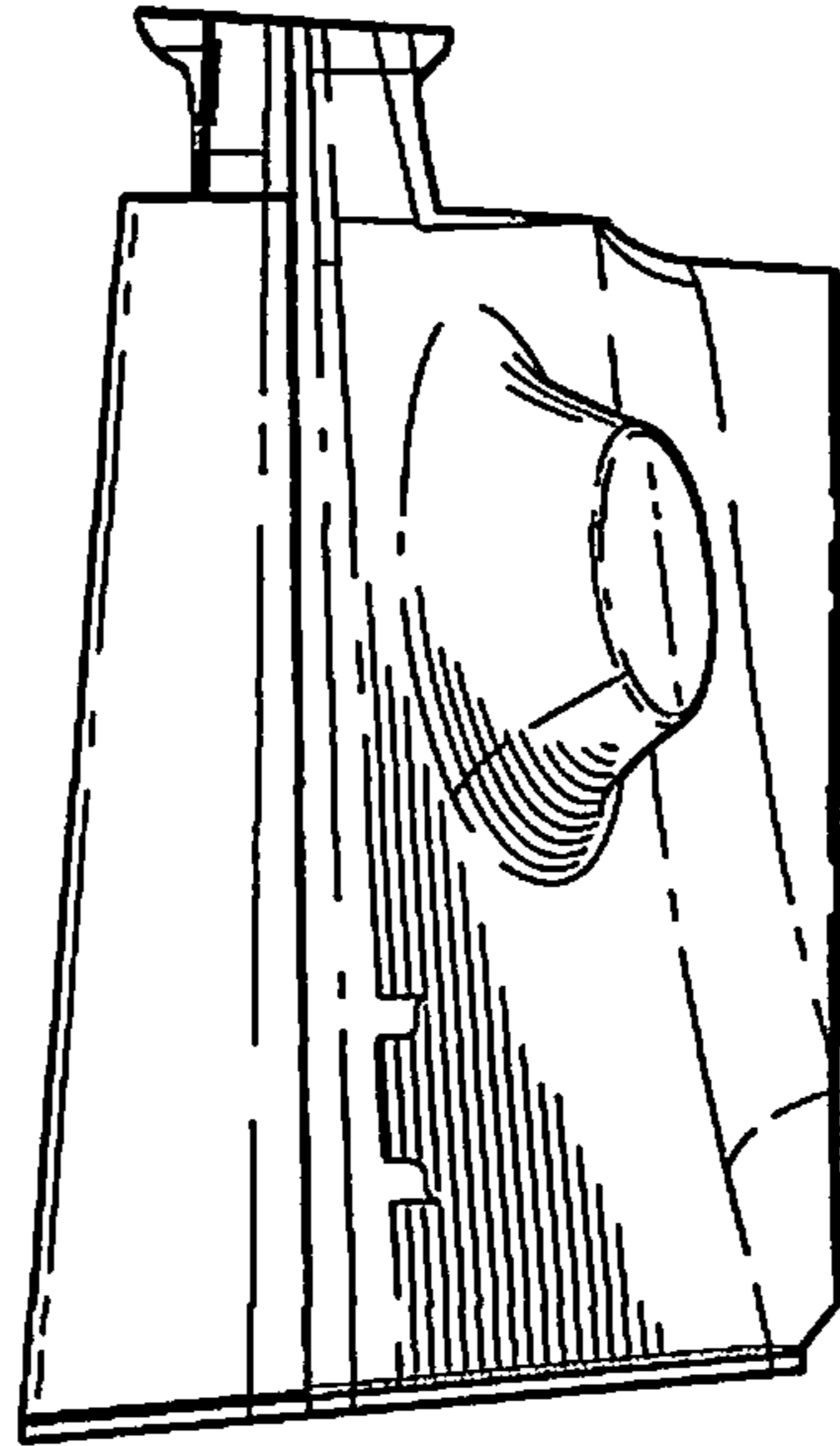

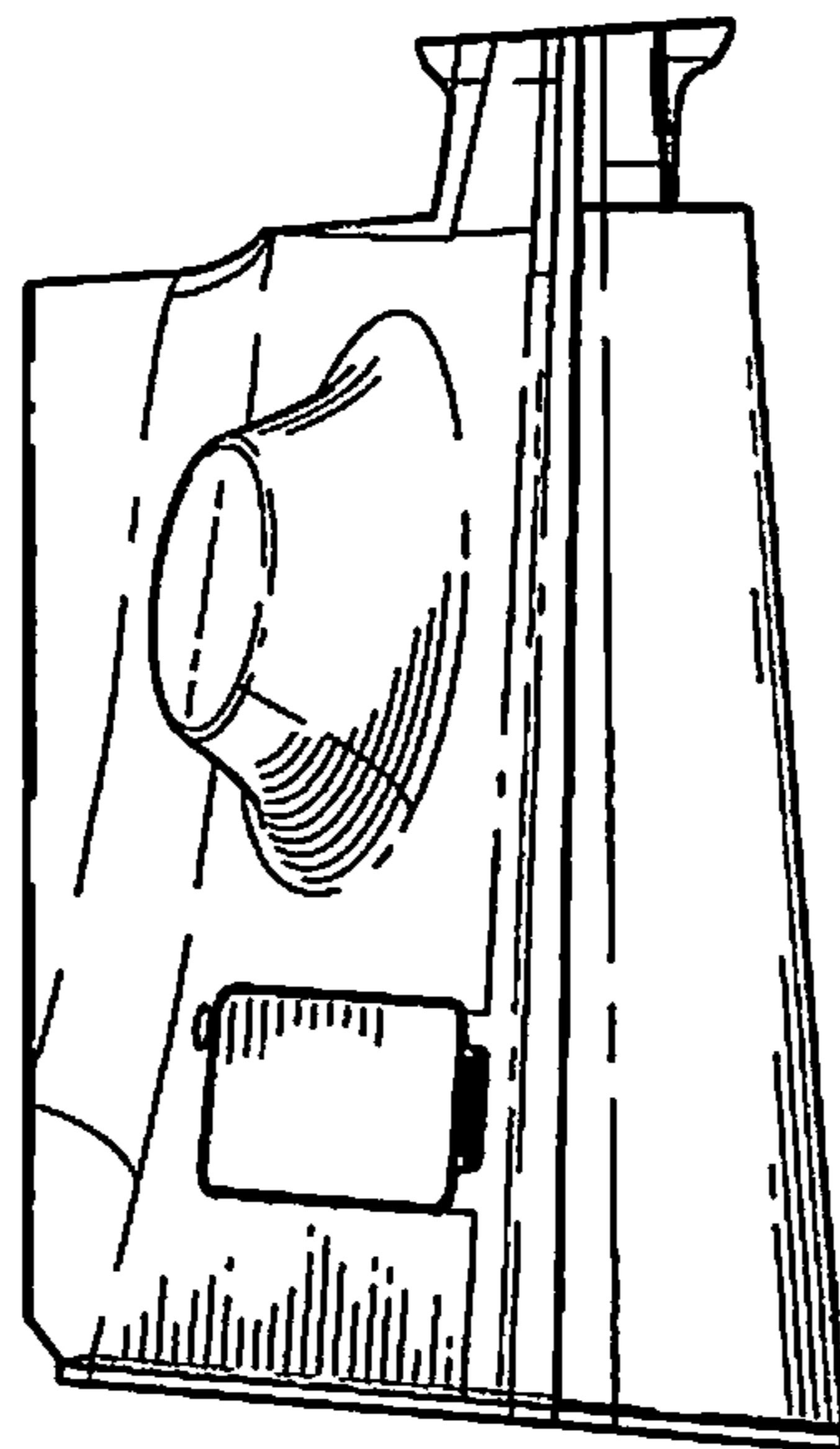

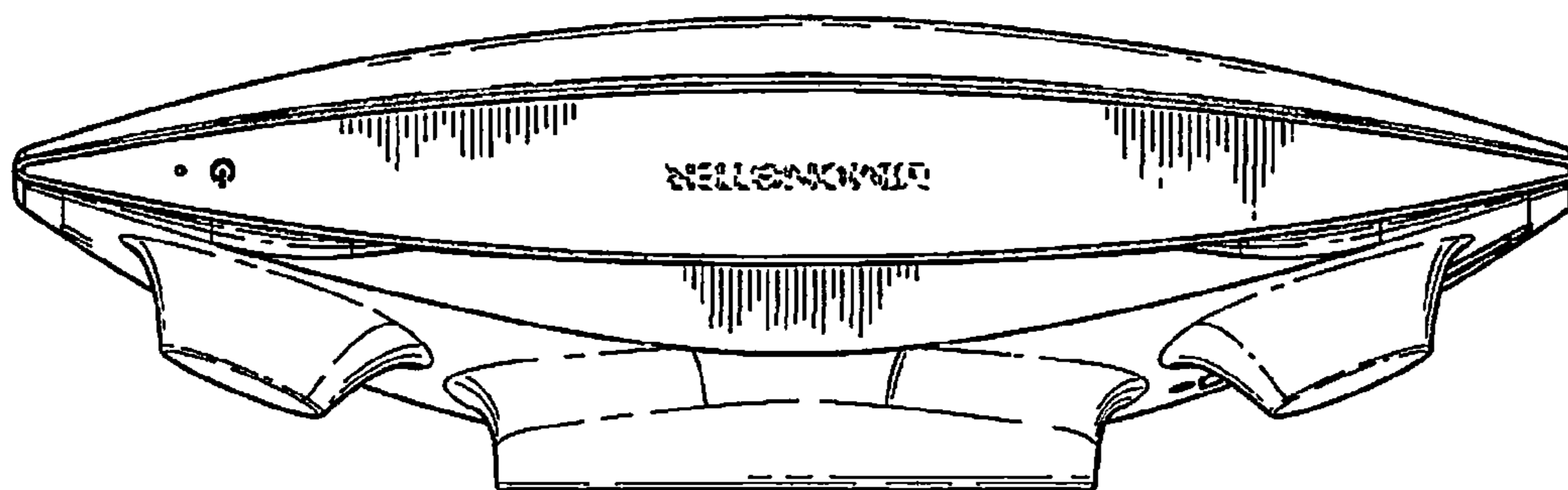

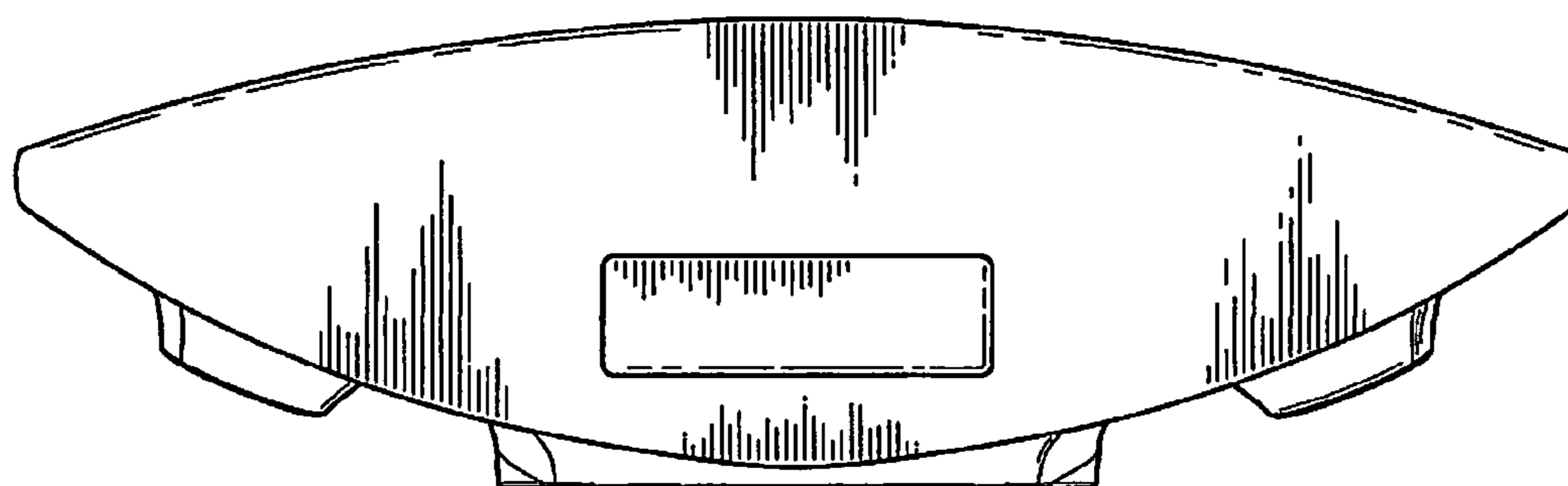
