The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

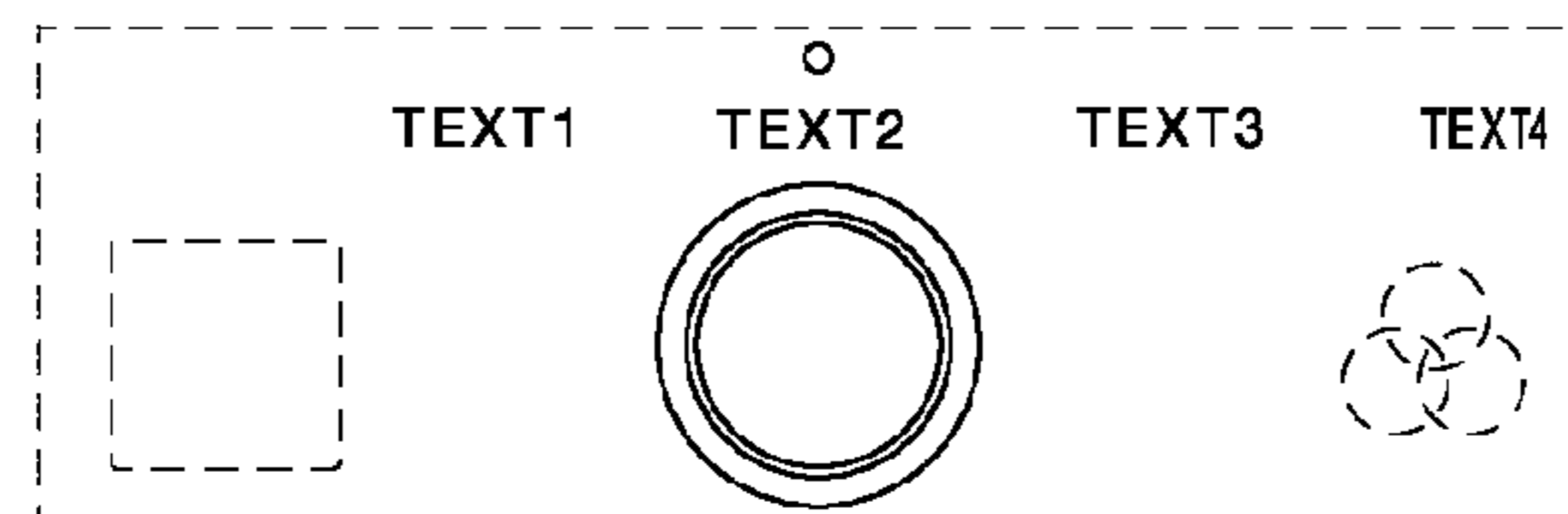
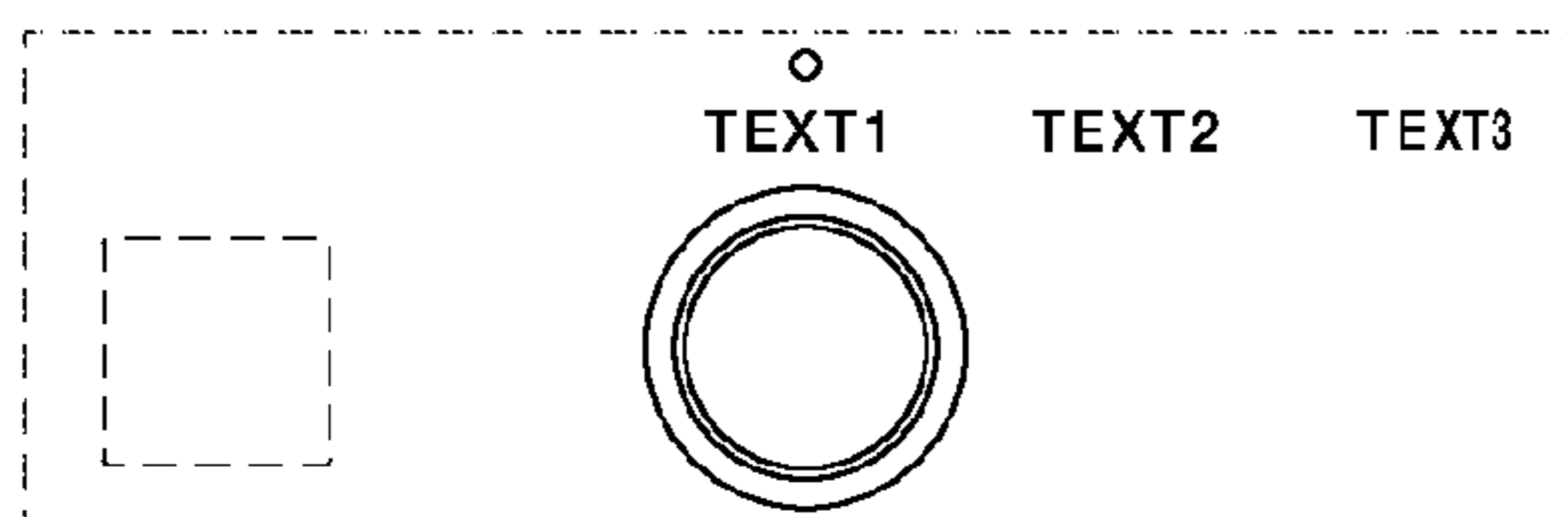
**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image in the sequence showing our new design;

FIG. 5 is a front view of a first image in another embodiment thereof;  
FIG. 6 is a second image thereof;

The broken lines around the Figures show a boundary of a display screen or portion thereof, and form no part of the claimed design. The broken lines within the Figures show portions of the graphical user interface that form no part of the claimed design.

The appearance of the animated images sequentially transitions between the images shown in FIGS. 1 through 4 and 5 through 8. The process or period in which one image transitions to another forms no part of the claimed design.

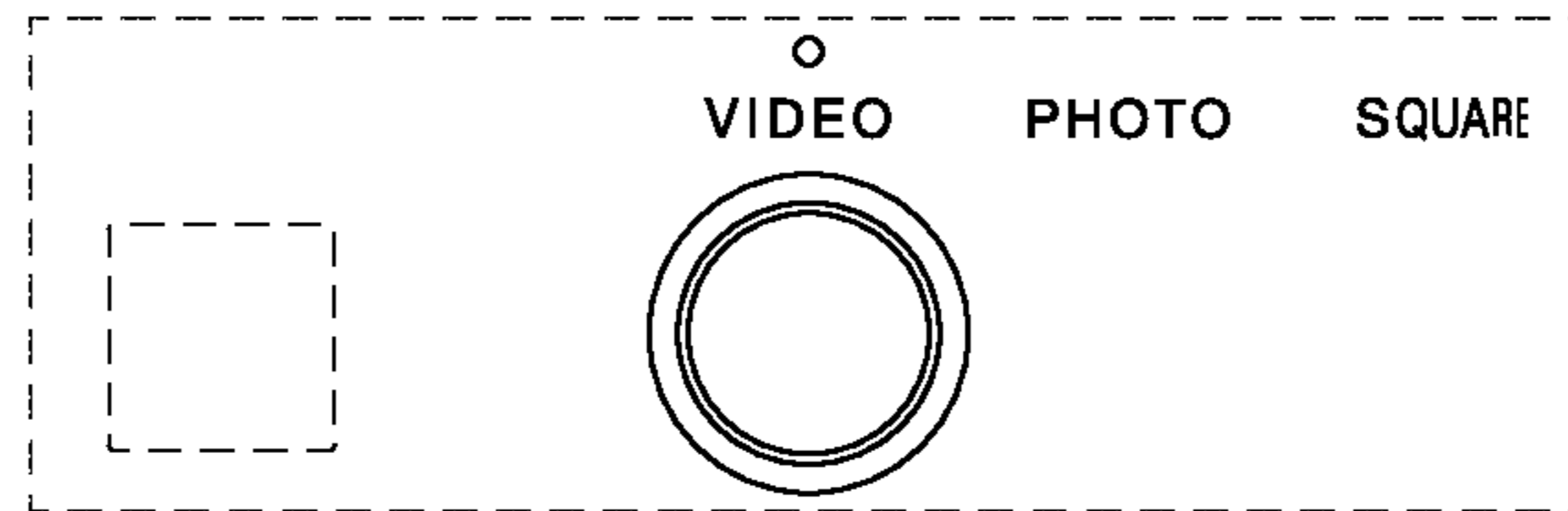

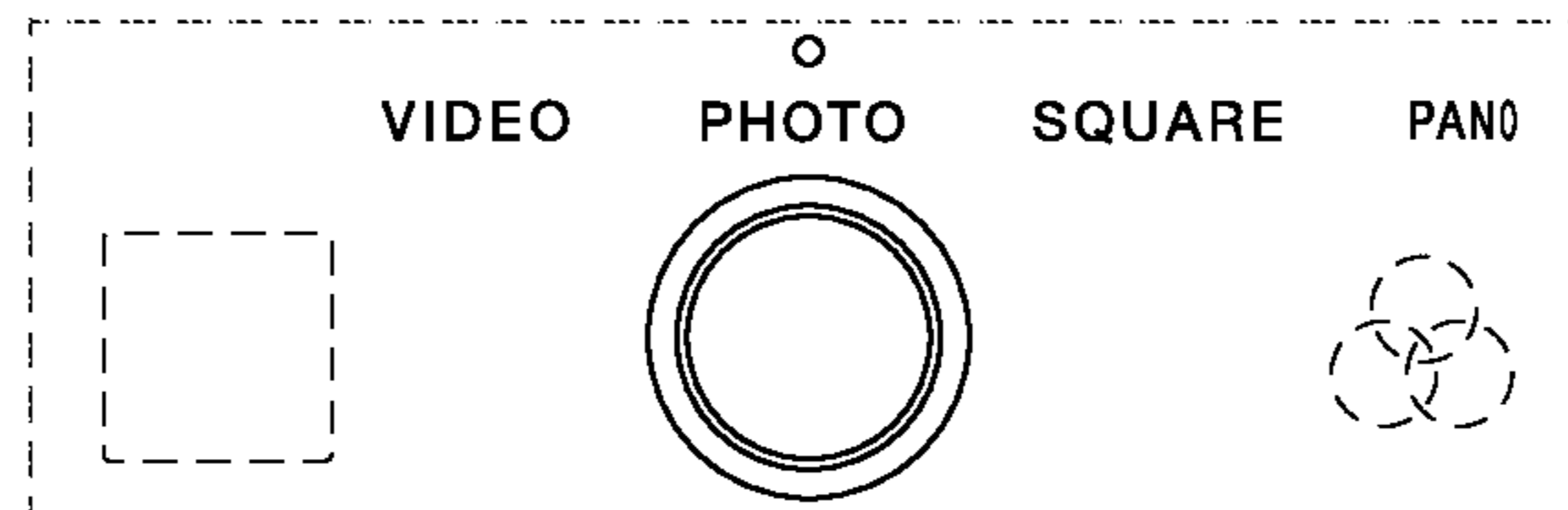

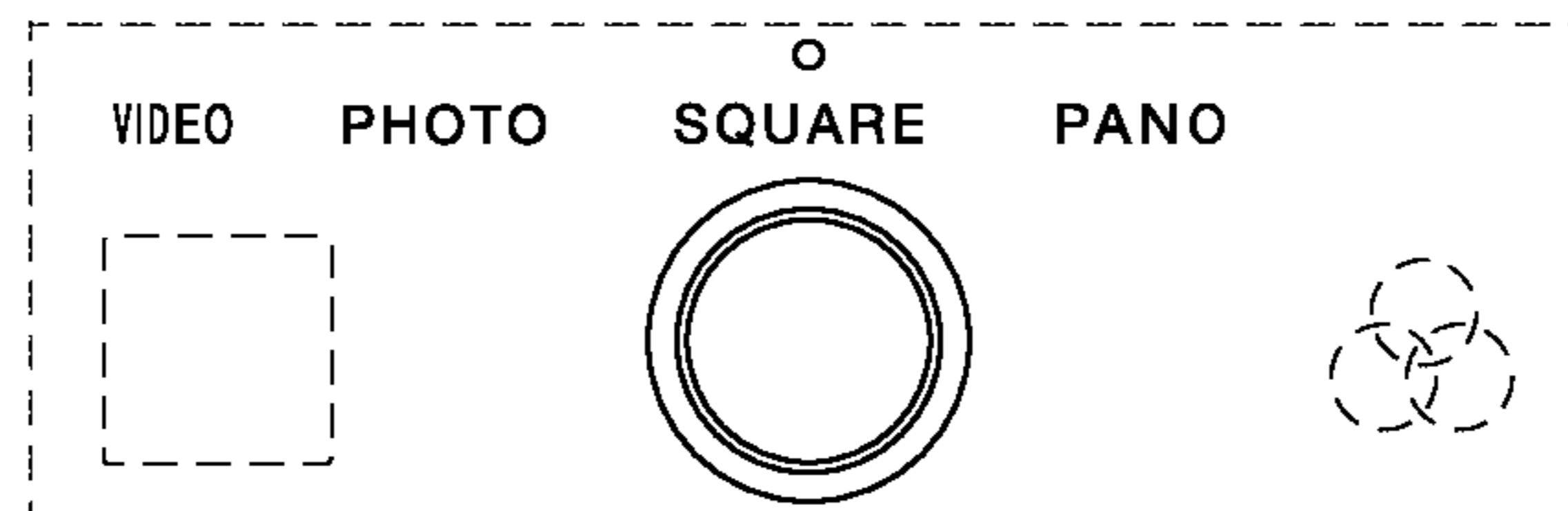

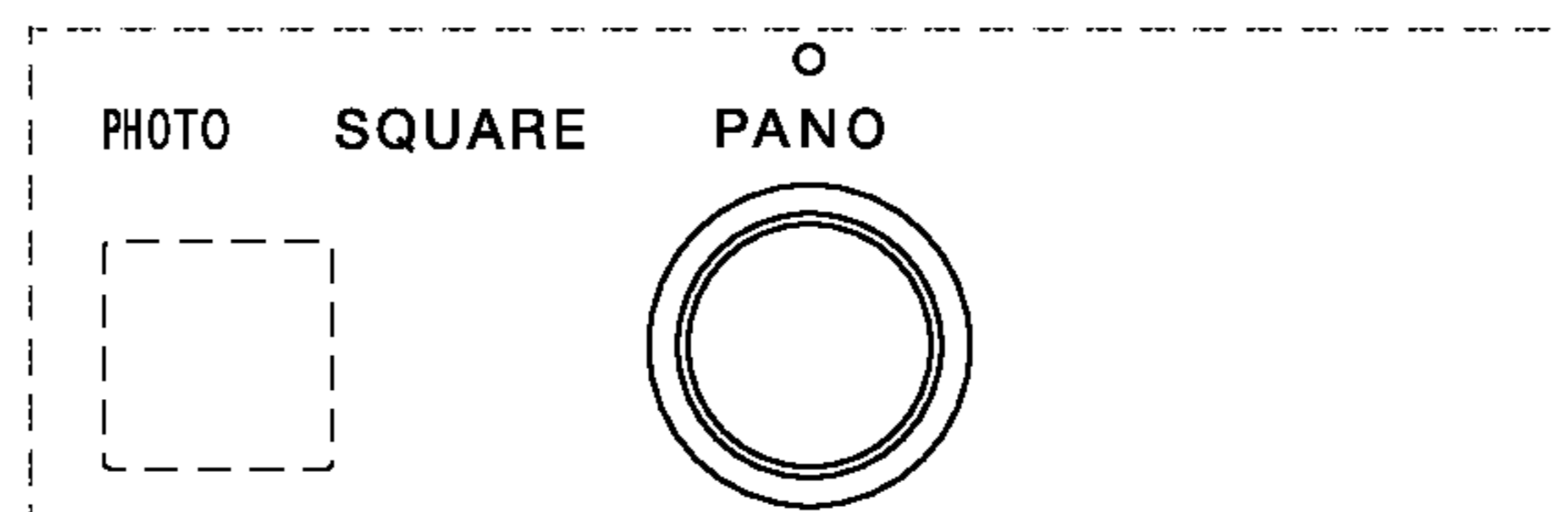

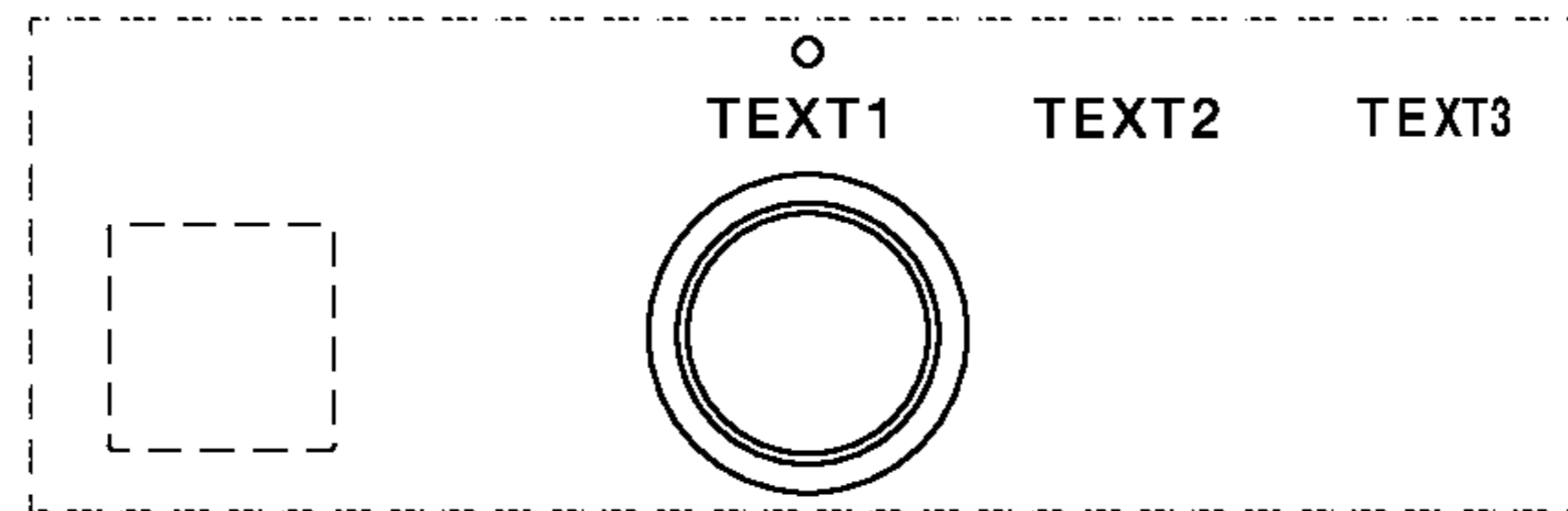

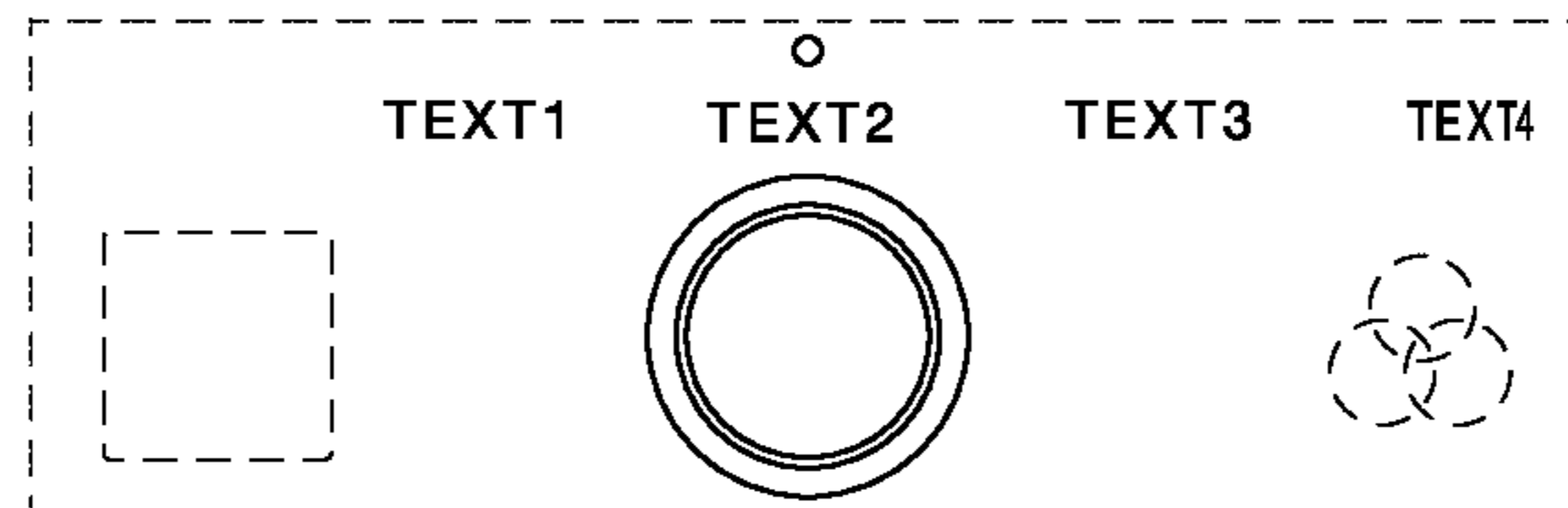

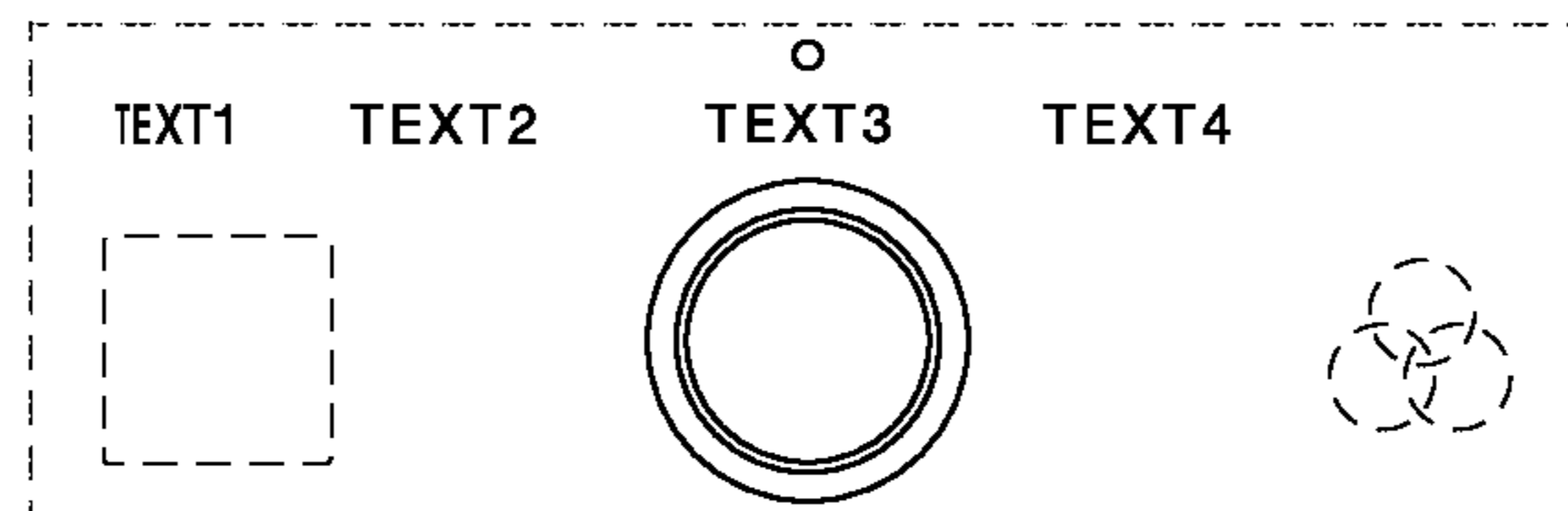

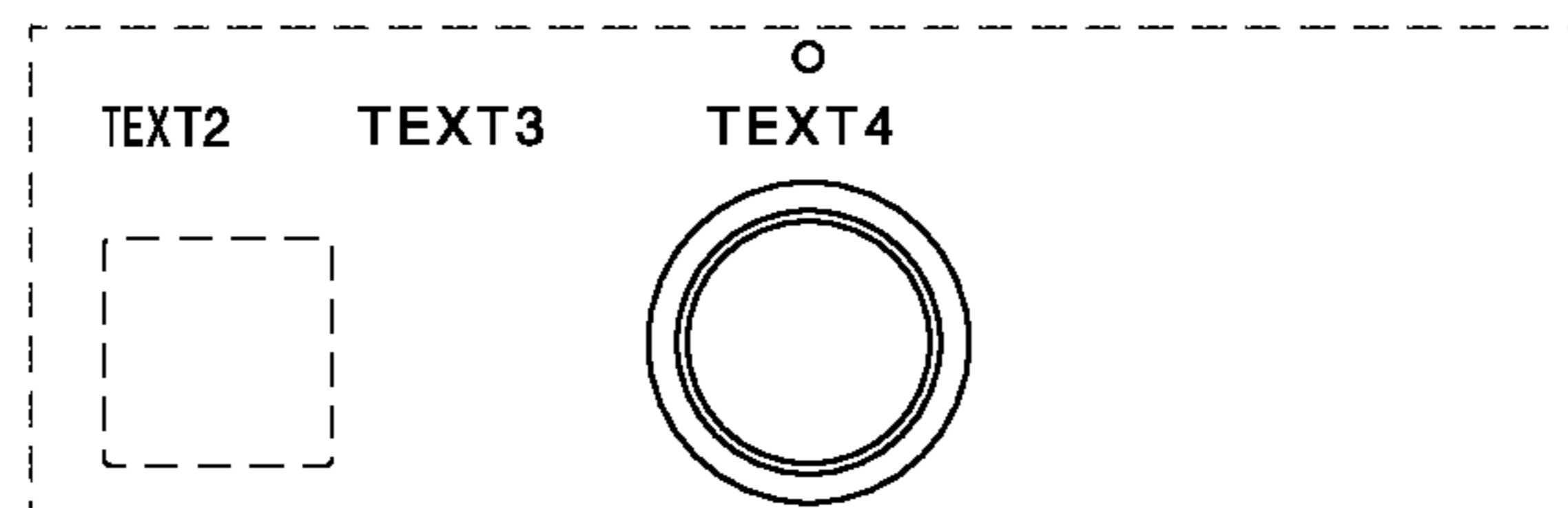
