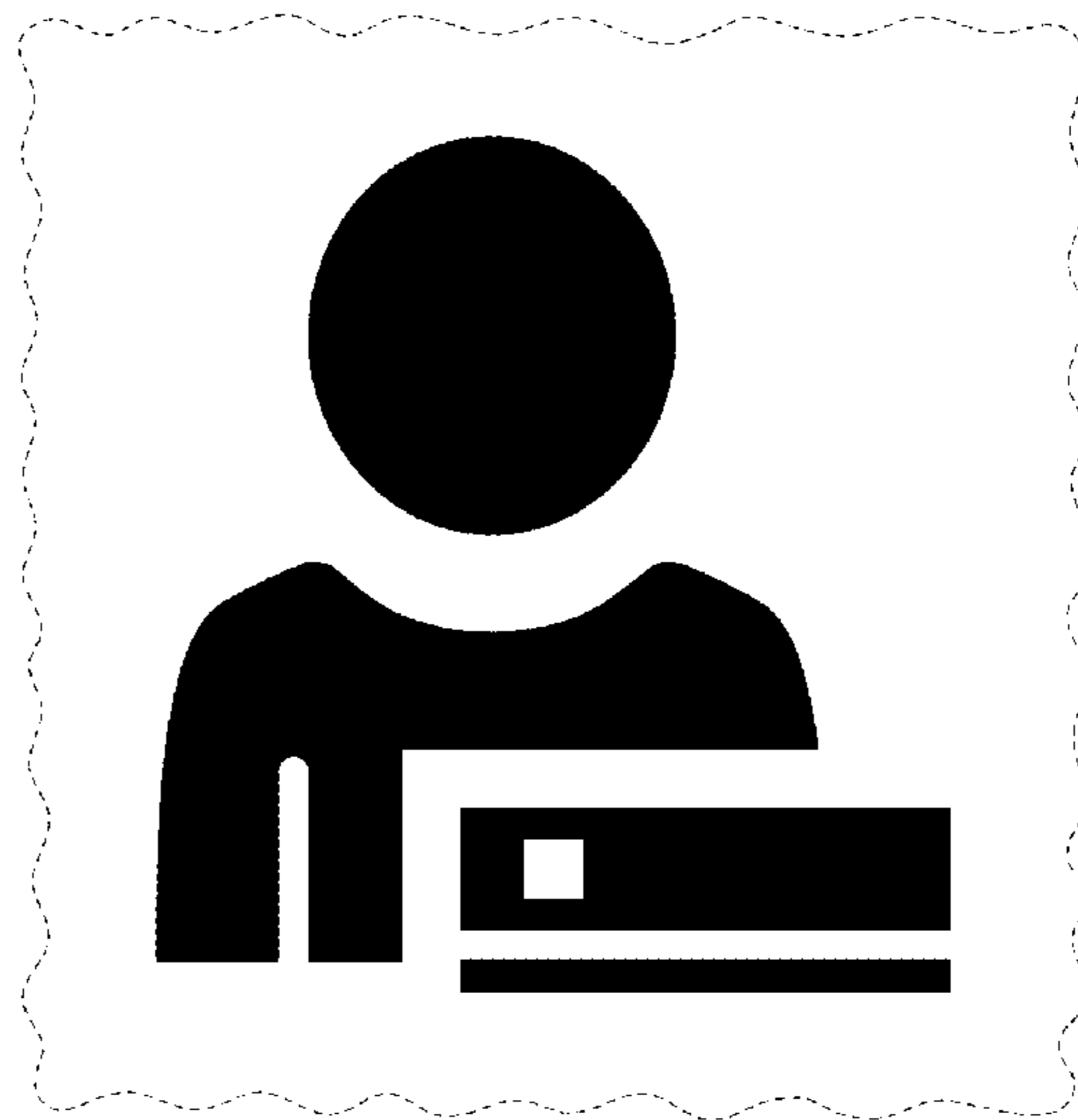
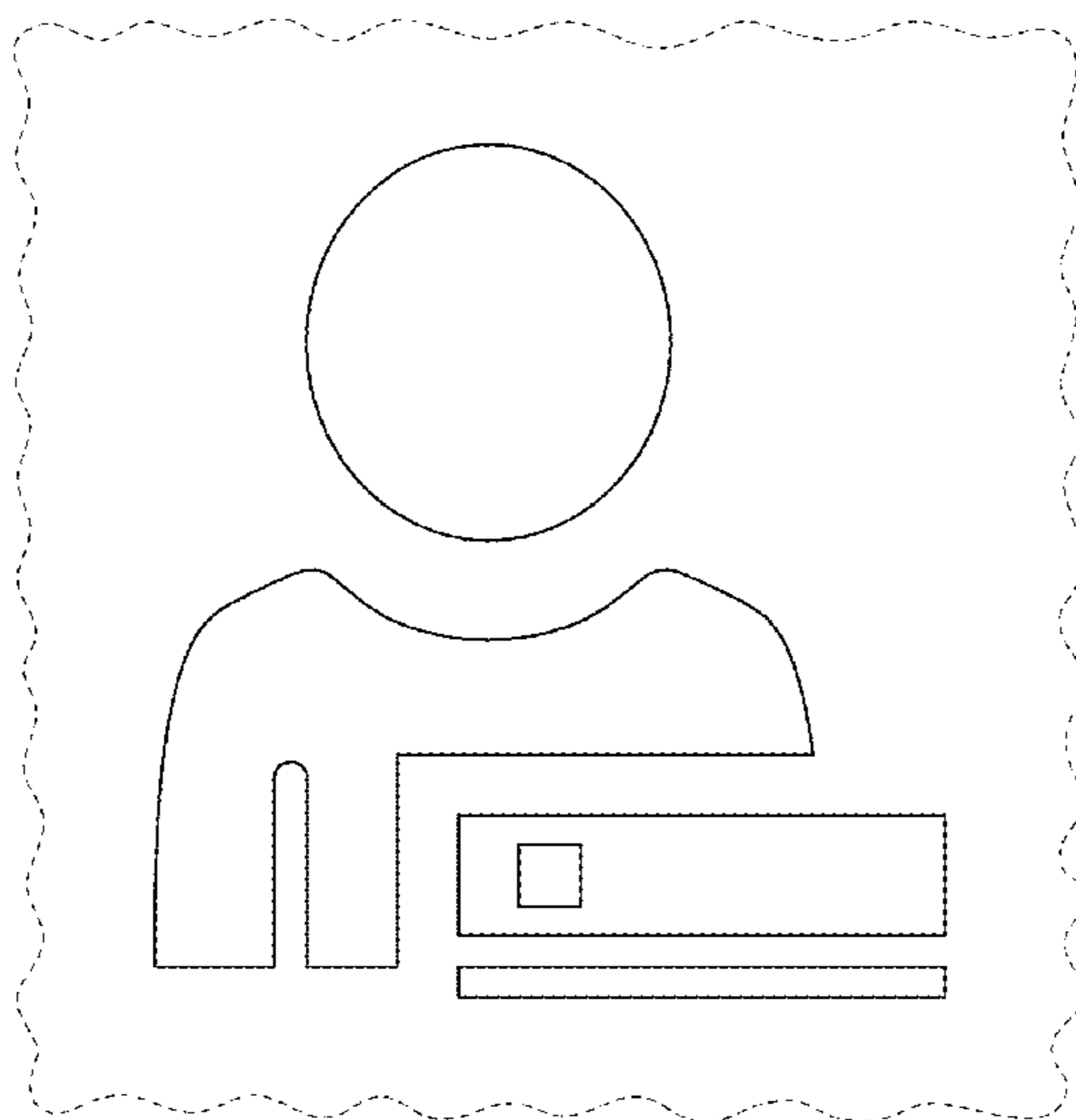
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a display screen with icon showing our new design;
FIG. 2 is a front view of the display screen with icon showing an alternative embodiment of our new design; and,

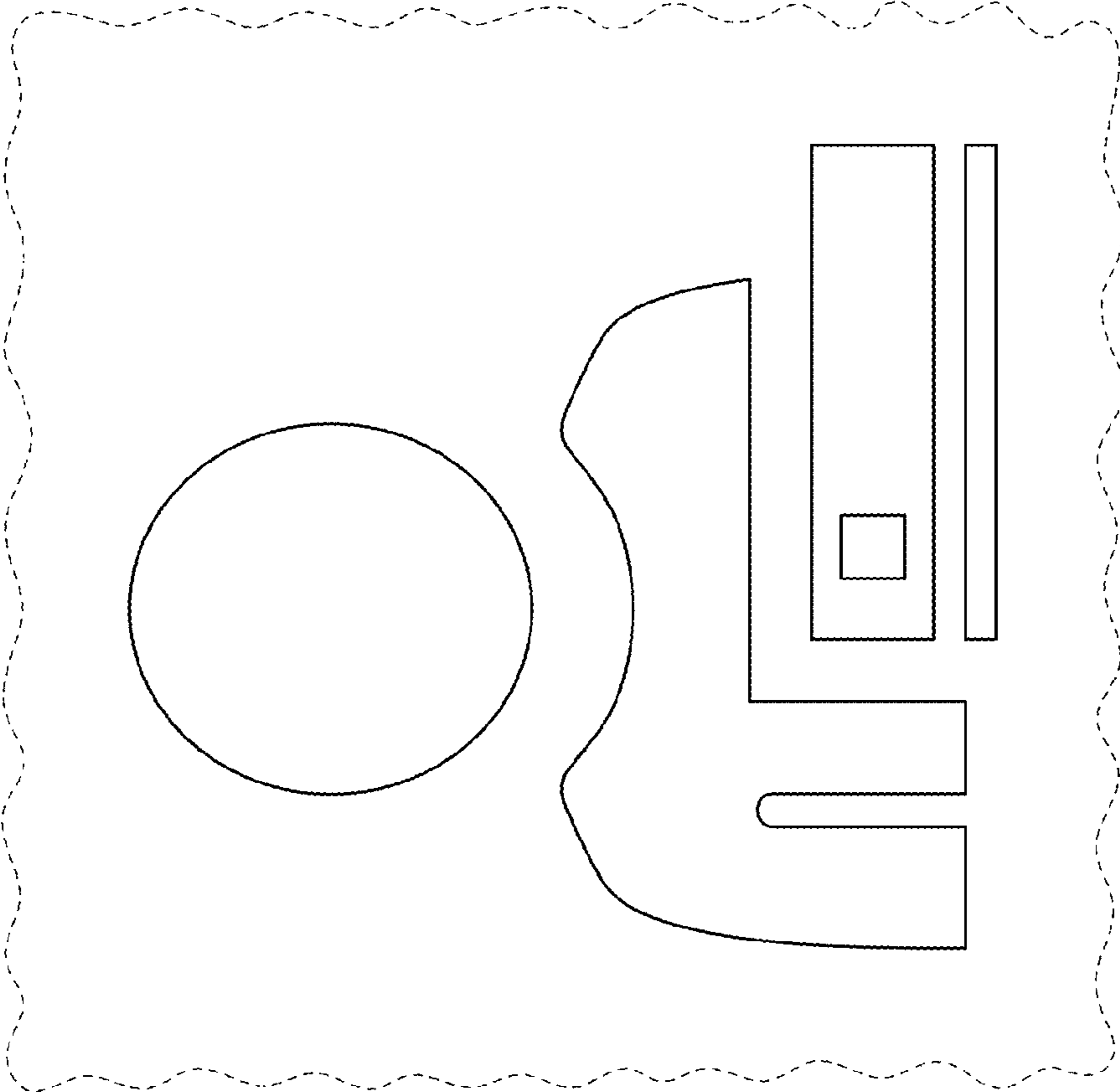

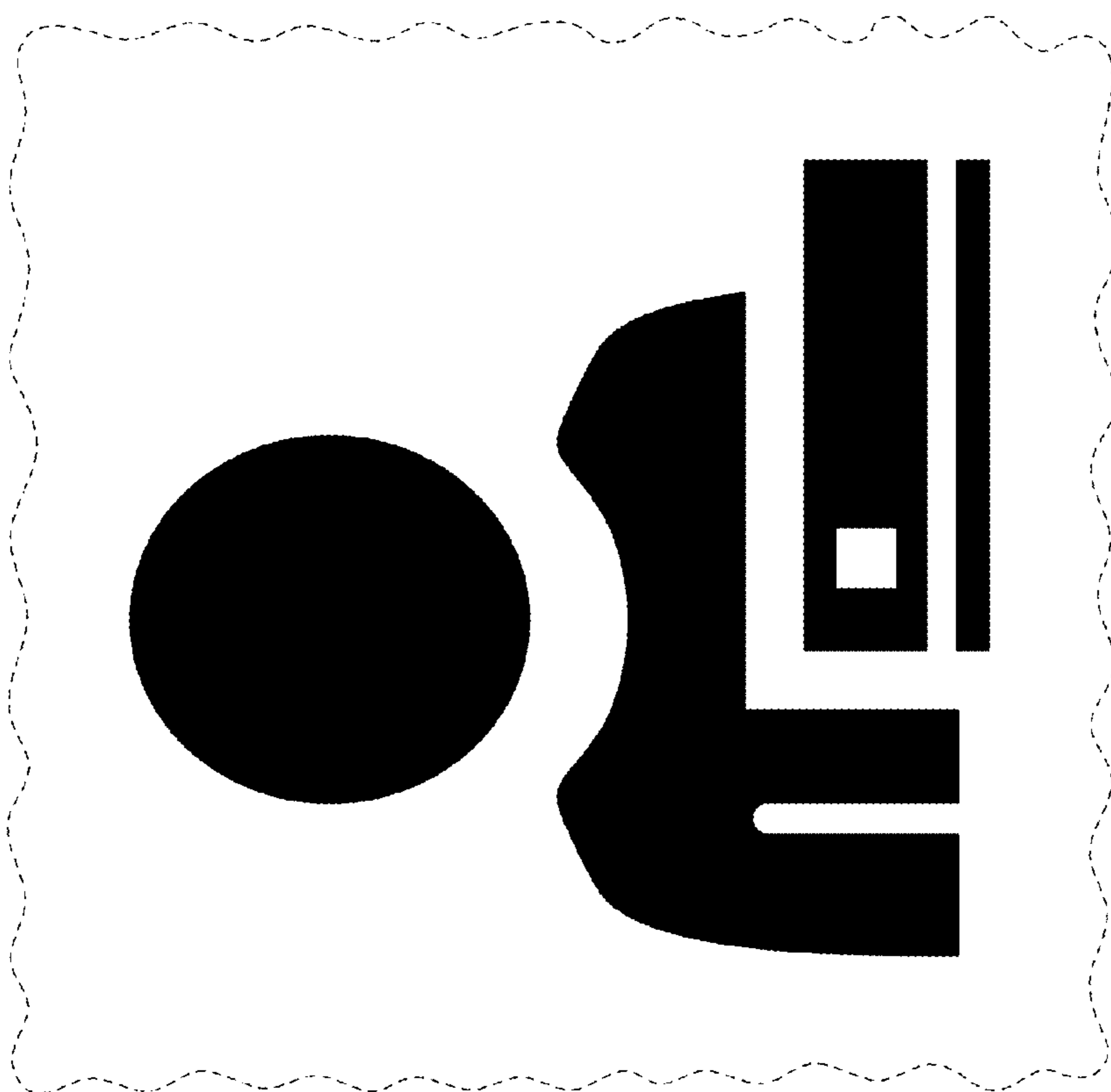

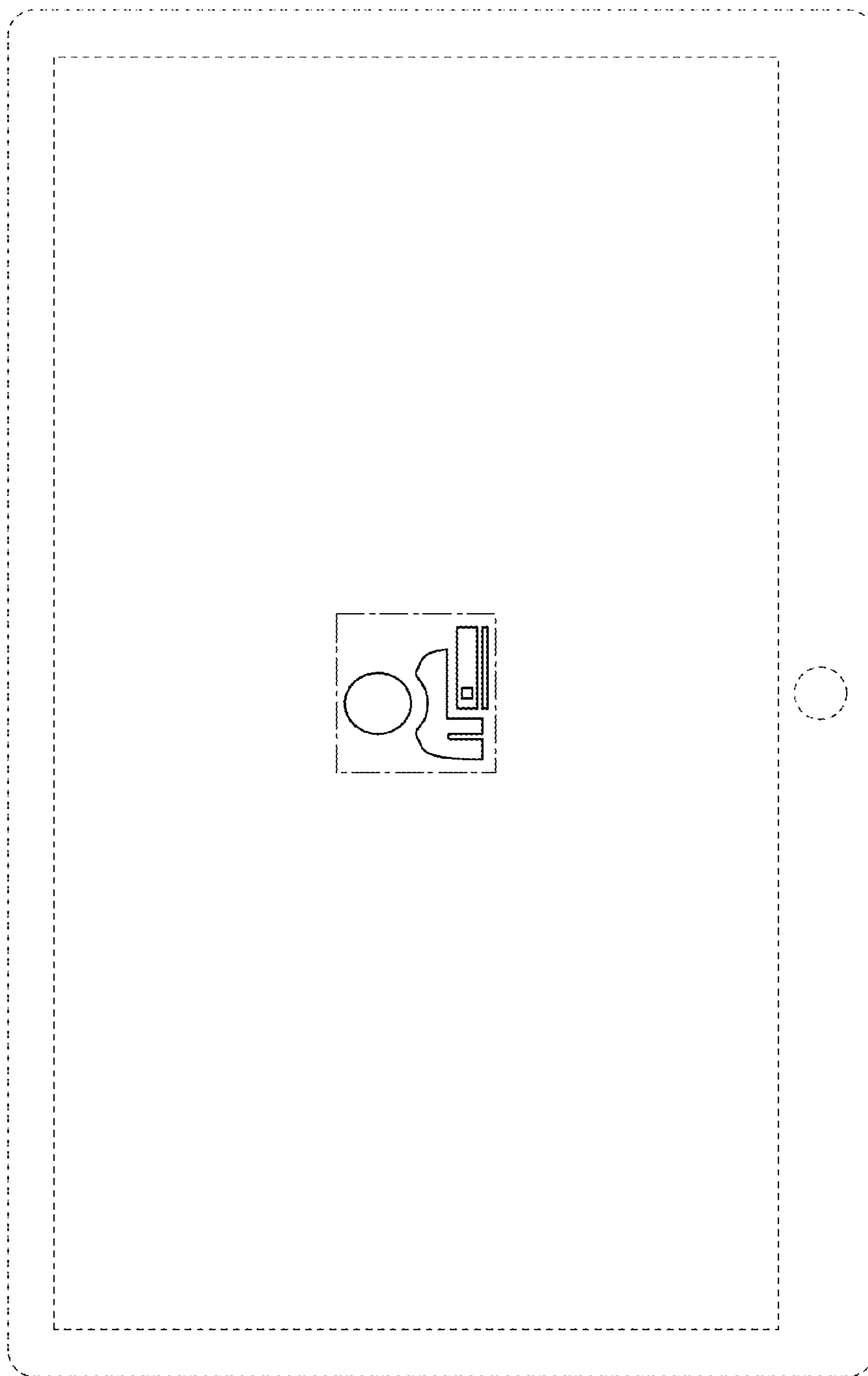
