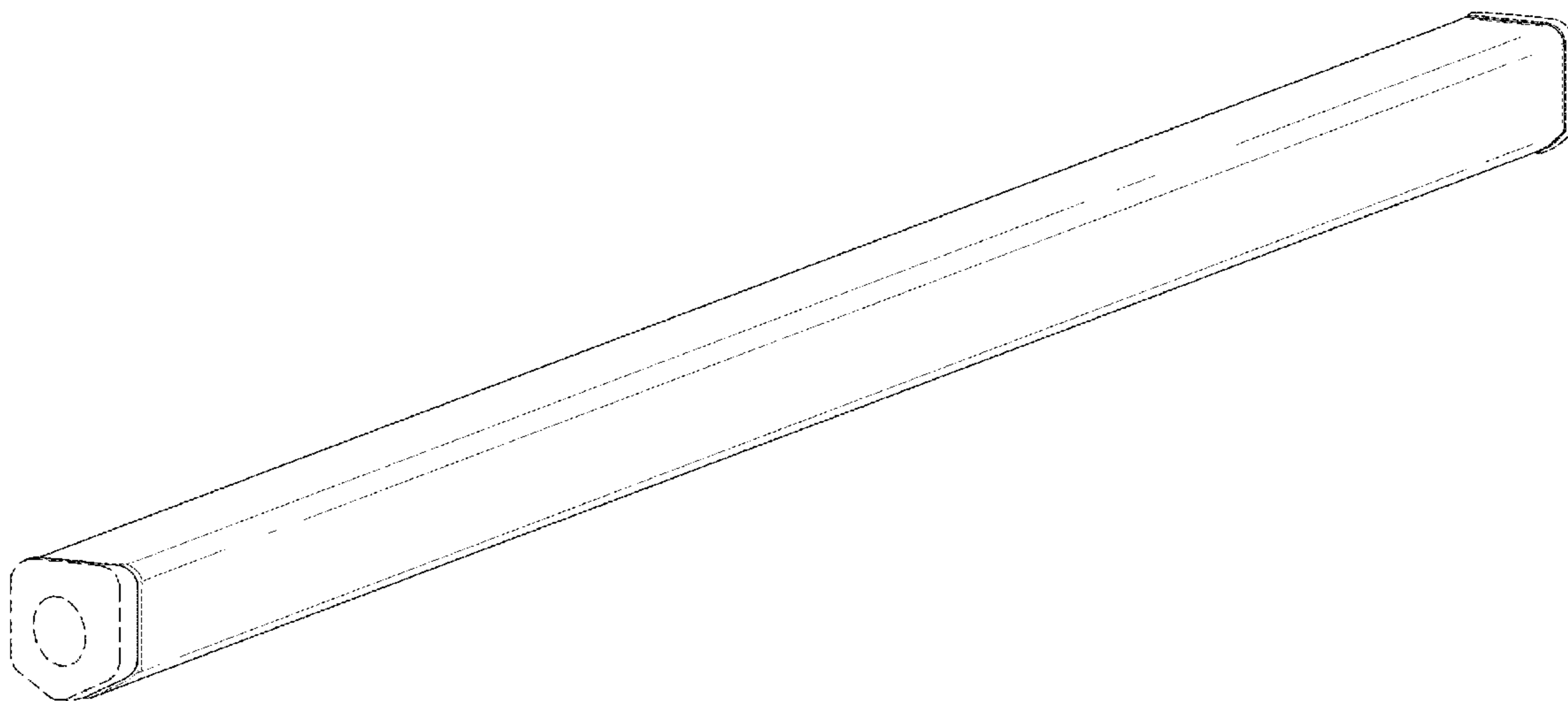
(57) **CLAIM**

The ornamental design for a golf putter grip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf putter grip;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof; the left side view is a mirror image thereof; and,  
FIG. 5 is a cross-sectional view along line 5-5 of FIG. 2.

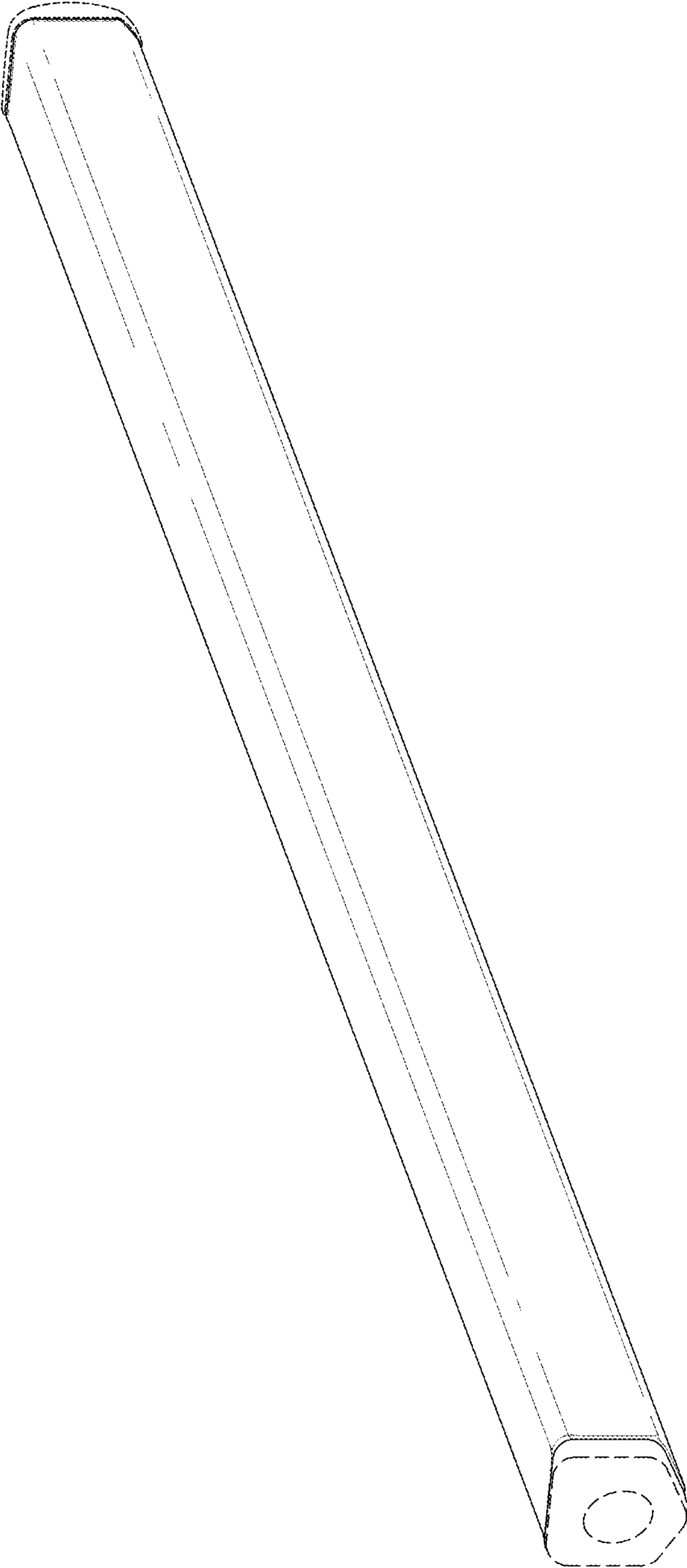

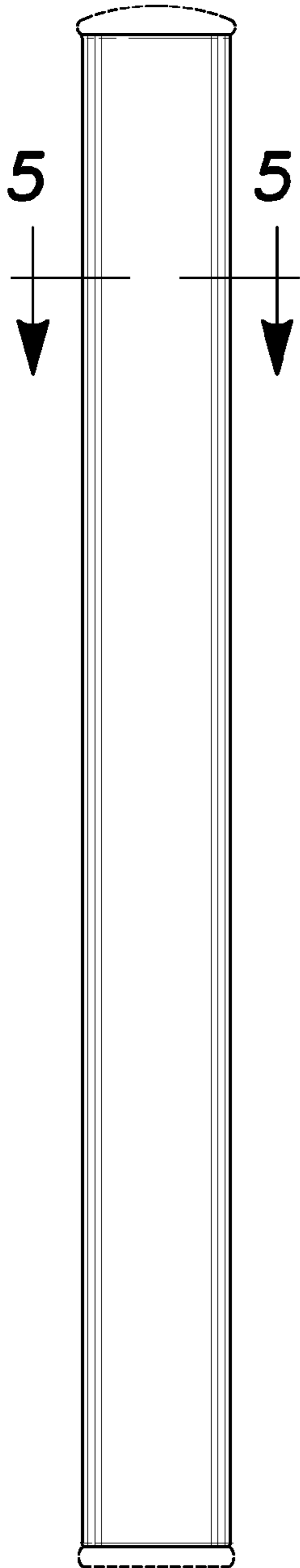

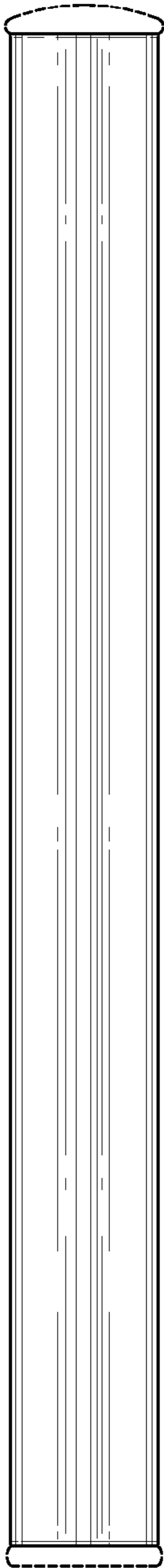

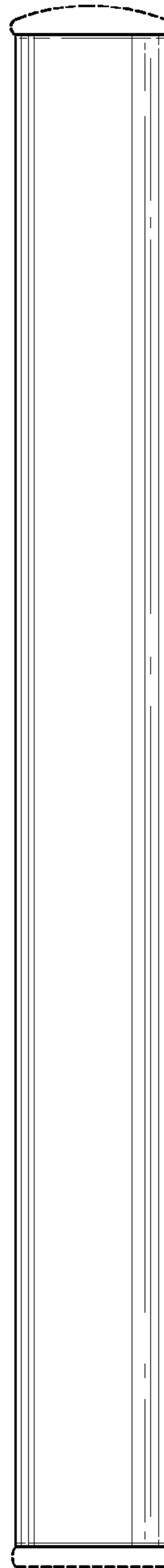

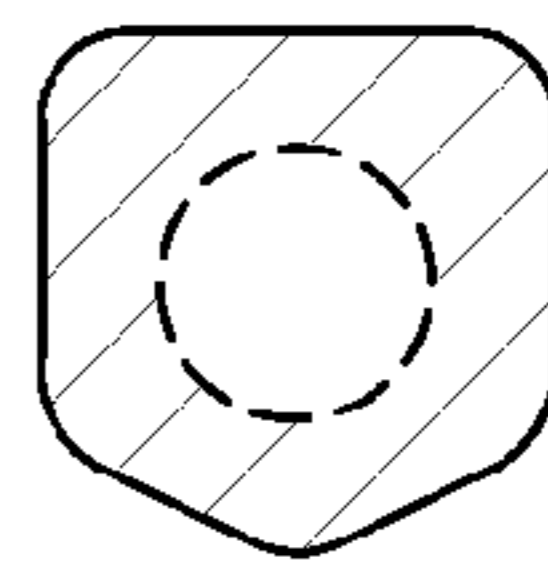
