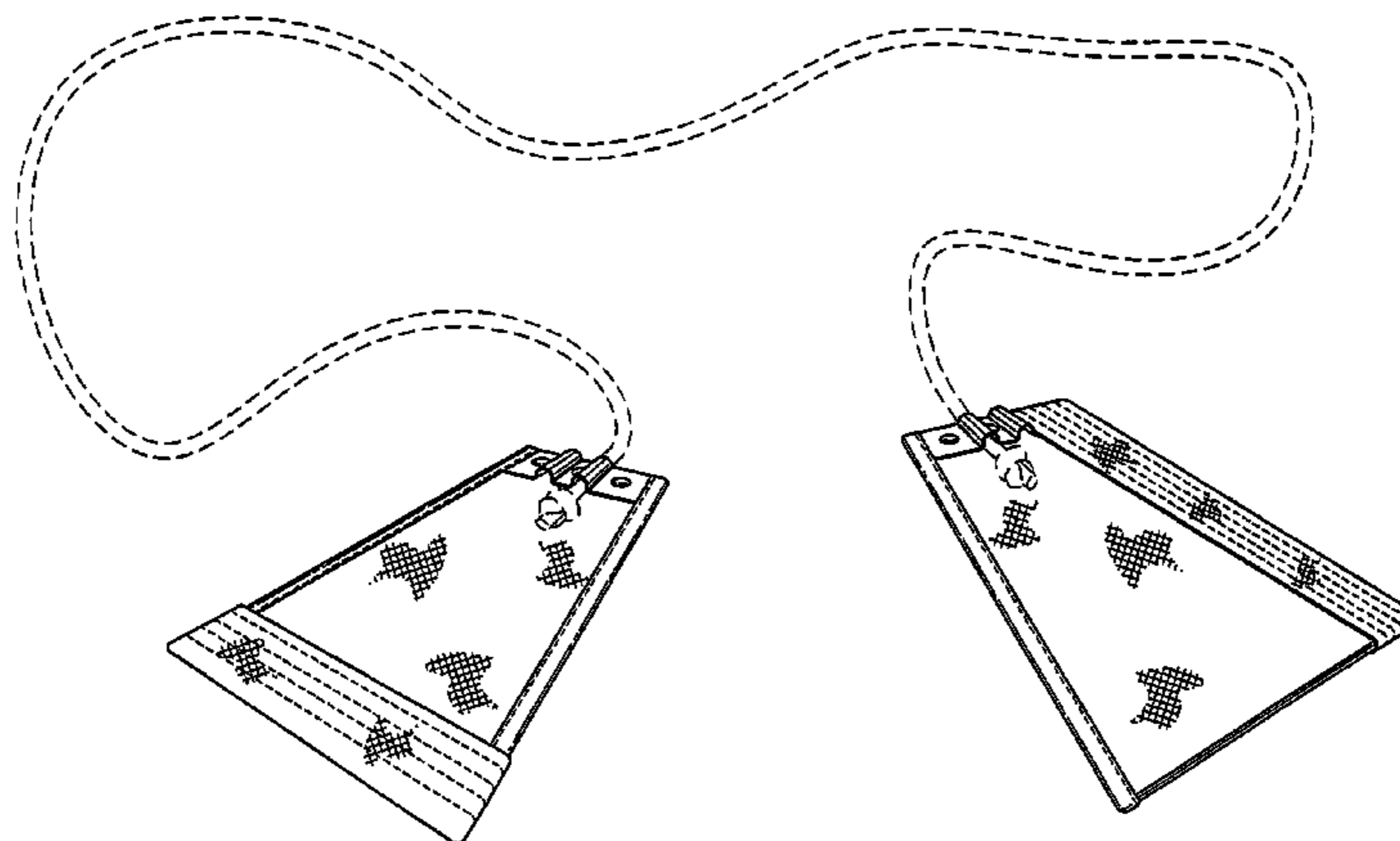
(57) **CLAIM**

The ornamental design for a judo exercise paddle pair, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first paddle of the judo exercise paddle pair showing my new design;
 FIG. 2 is a top plan view of the first paddle of the judo exercise paddle pair of my design;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a front elevation view of the first paddle of my paddle pair design;
 FIG. 5 is a rear elevation view thereof;
 FIG. 6 is a left side elevation view of the first paddle of my paddle pair design;
 FIG. 7 is a right side elevation view thereof;
 FIG. 8 is a top perspective view of a second paddle of the judo exercise paddle pair showing my new design;
 FIG. 9 is a top plan view of the second paddle of the judo exercise paddle pair of my design;
 FIG. 10 is a bottom plan view thereof;
 FIG. 11 is a front elevation view of the second paddle of my paddle pair design;
 FIG. 12 is a rear elevation view thereof;
 FIG. 13 is a left side elevation view of the second paddle of my paddle pair design;
 FIG. 14 is a right side elevation view thereof; and,
 FIG. 15 is a perspective view of both paddles of my judo exercise paddle pair, wherein the broken lines indicate an environment of use.
 The broken lines in FIG. 15 illustrate a connecting cord that forms no part of the claimed design. The smaller broken lines in all figures represent claimed stitching.

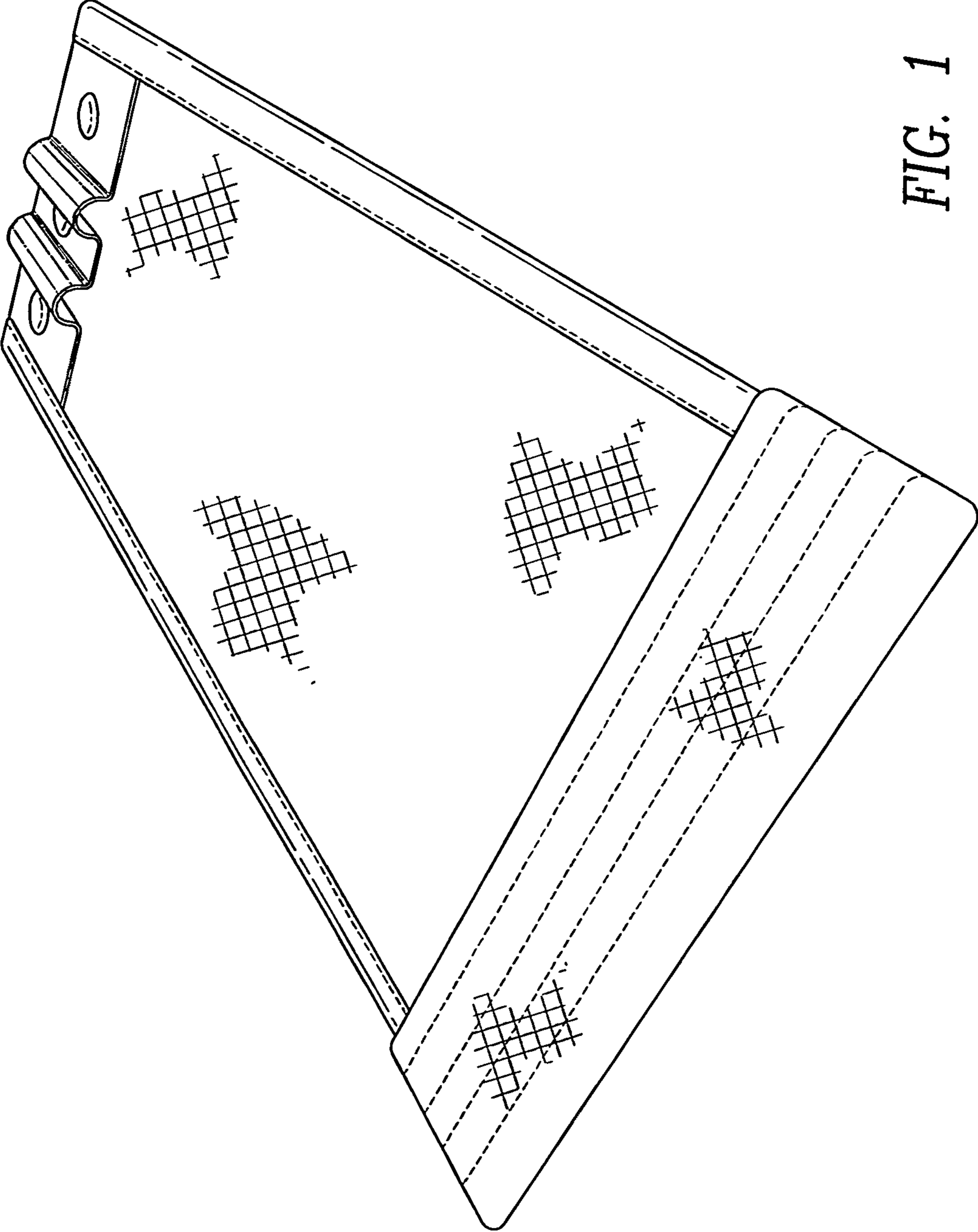

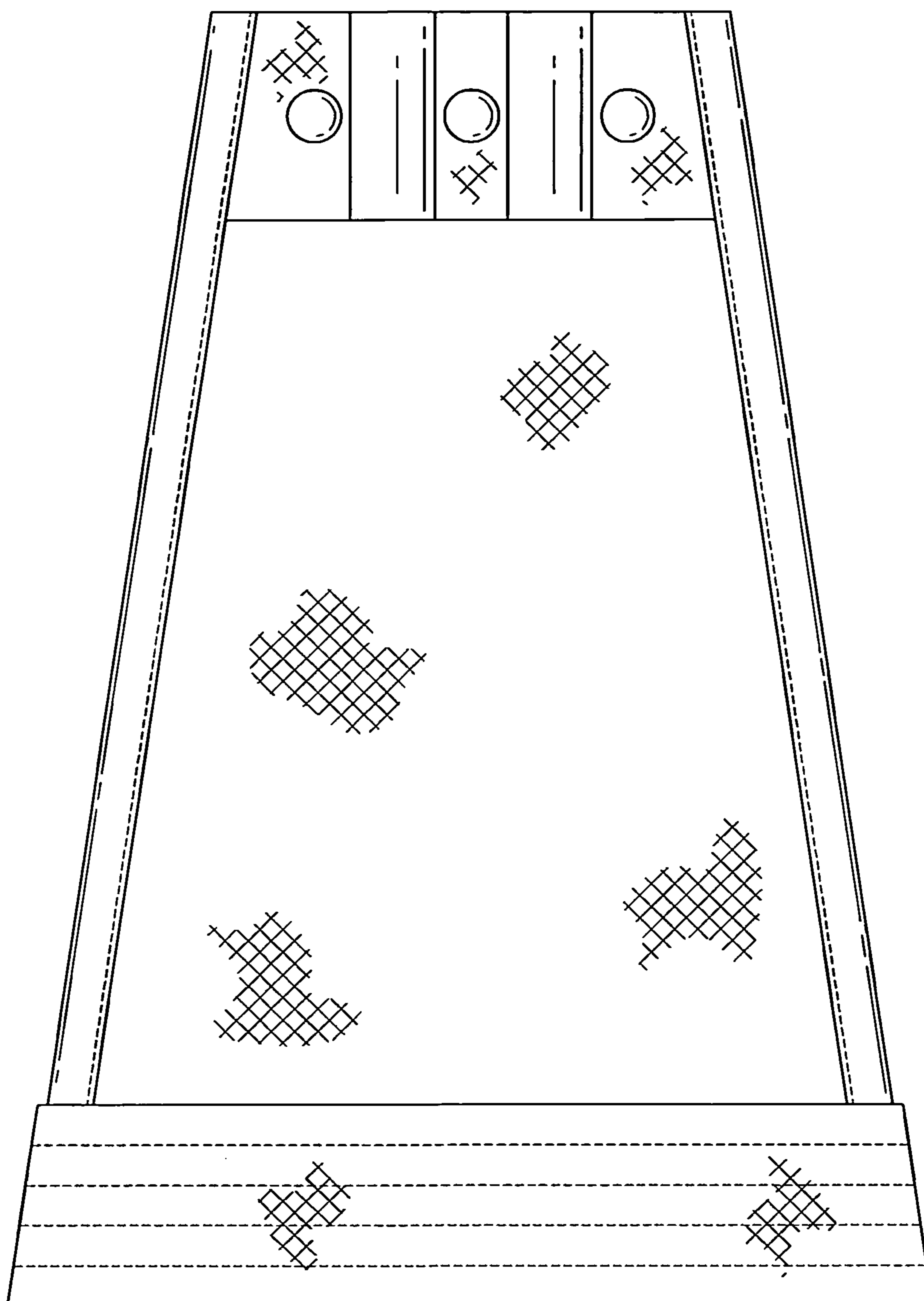

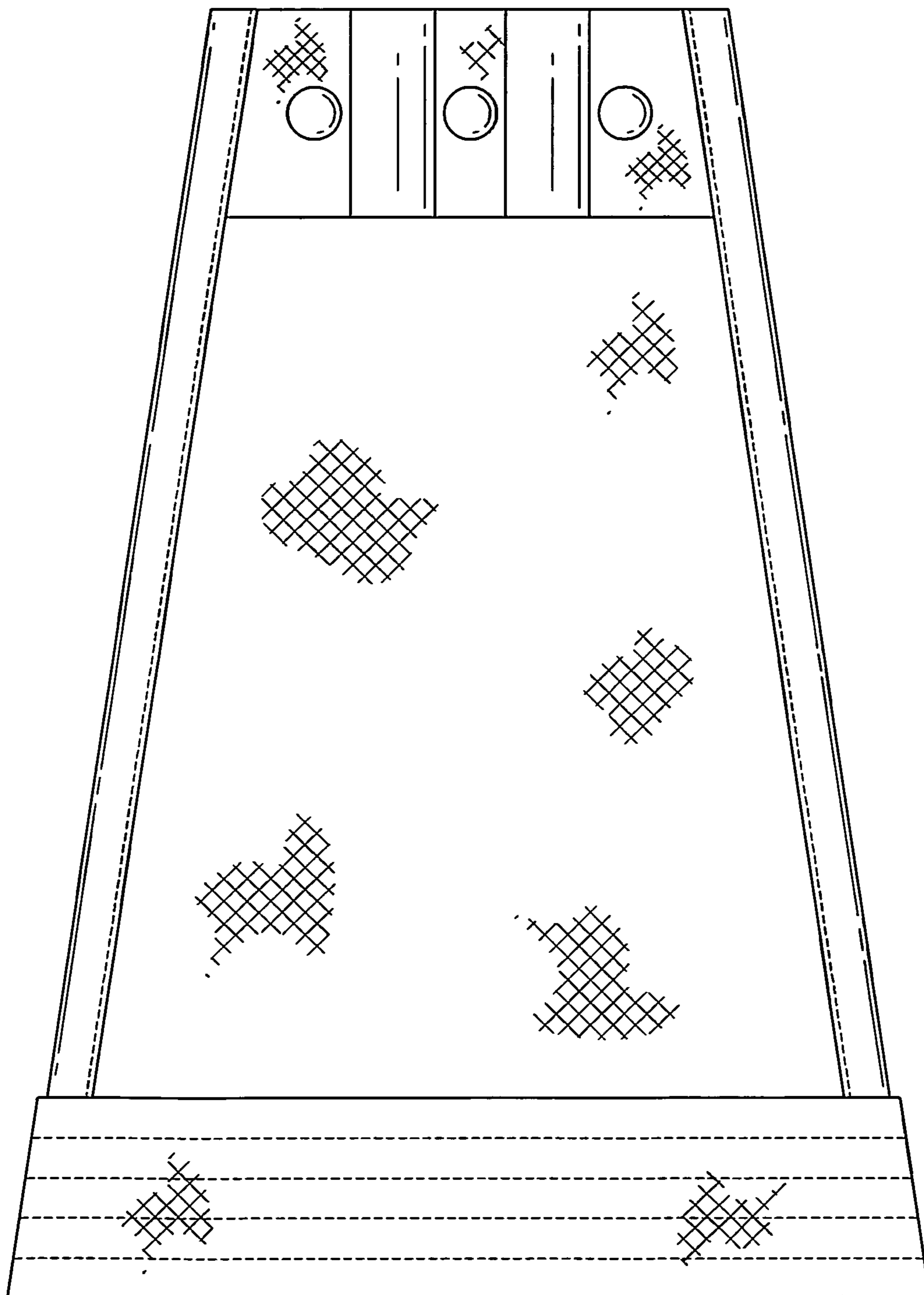

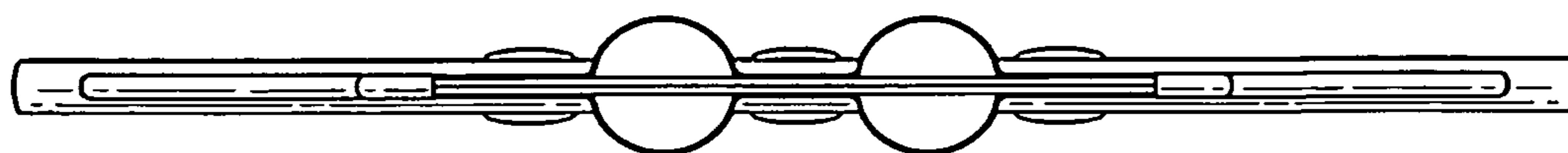

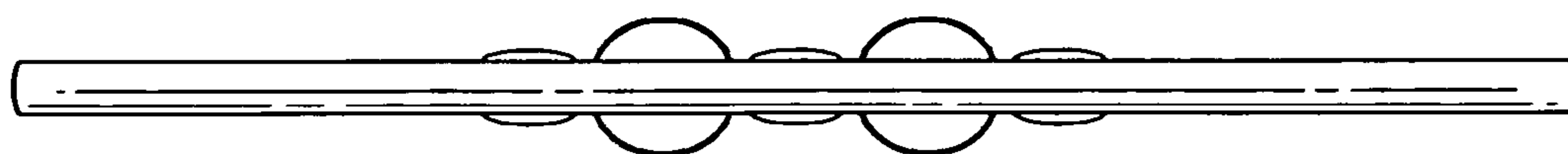

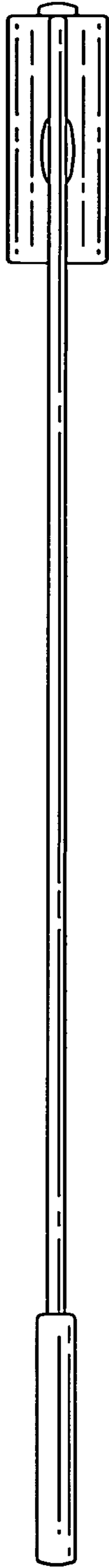

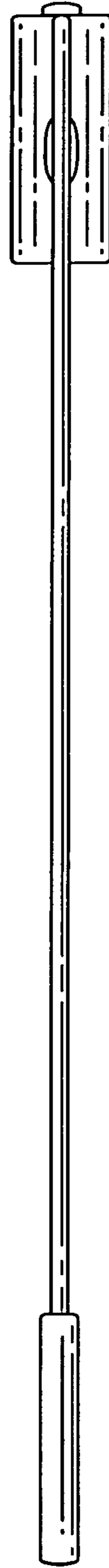

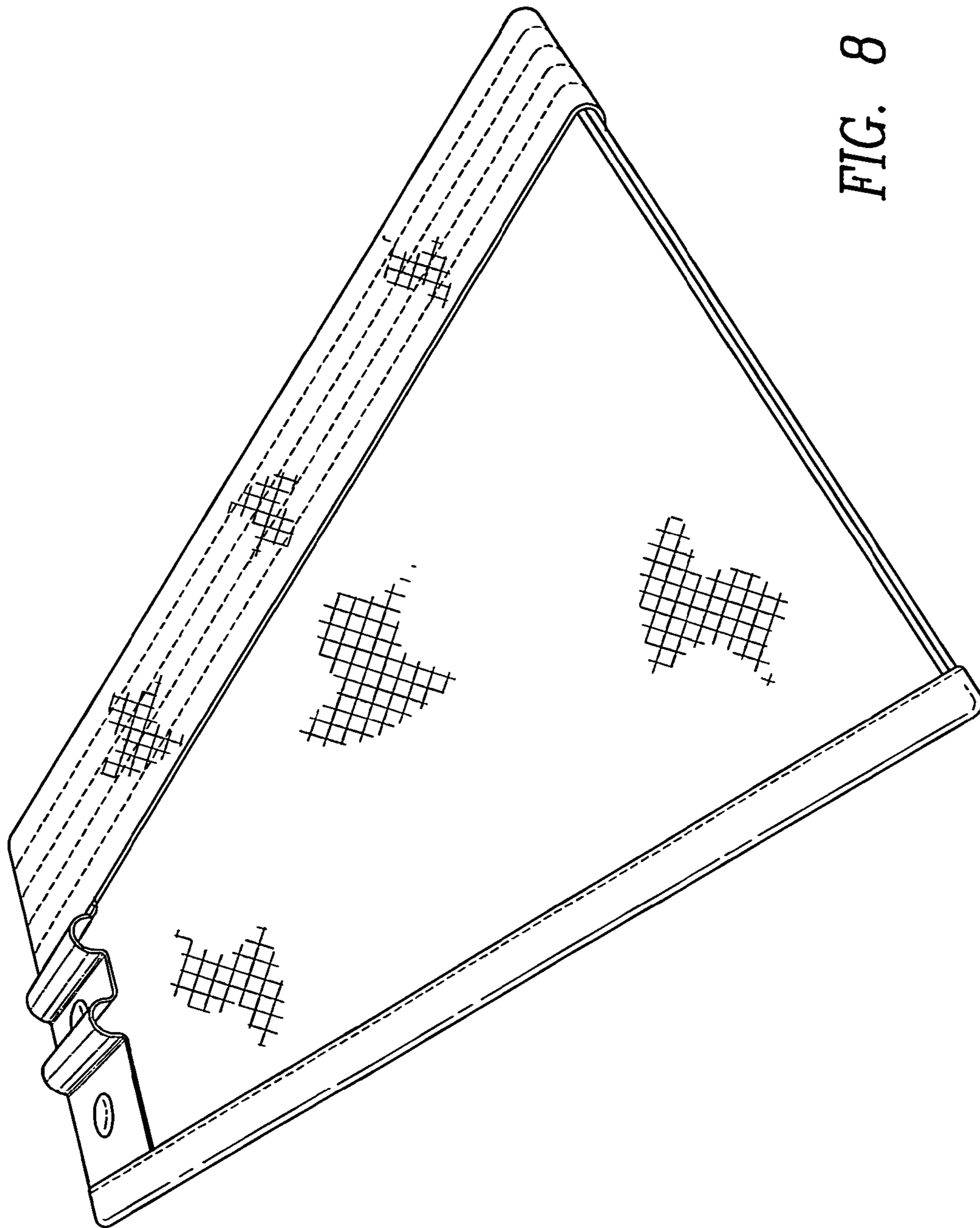

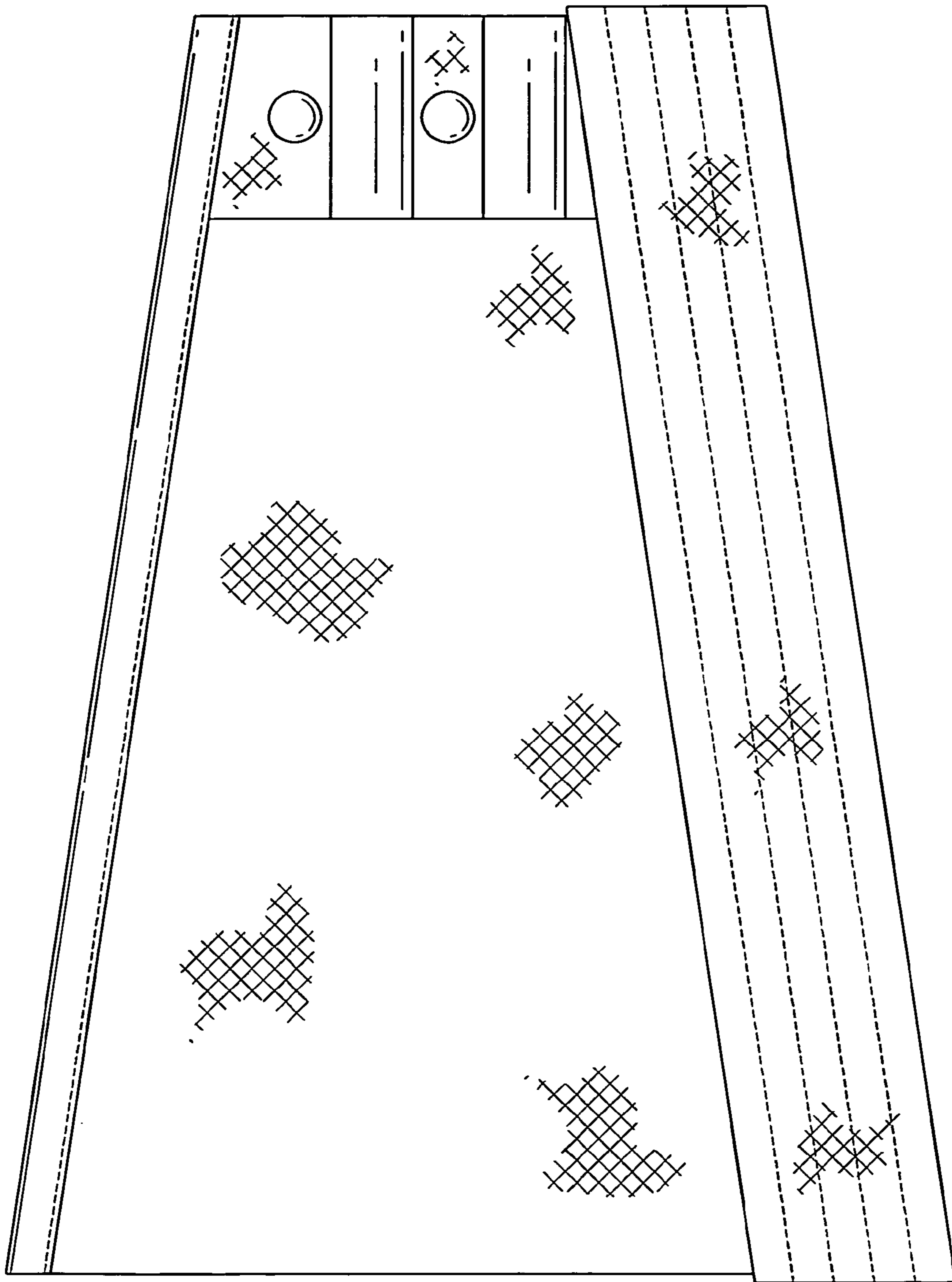

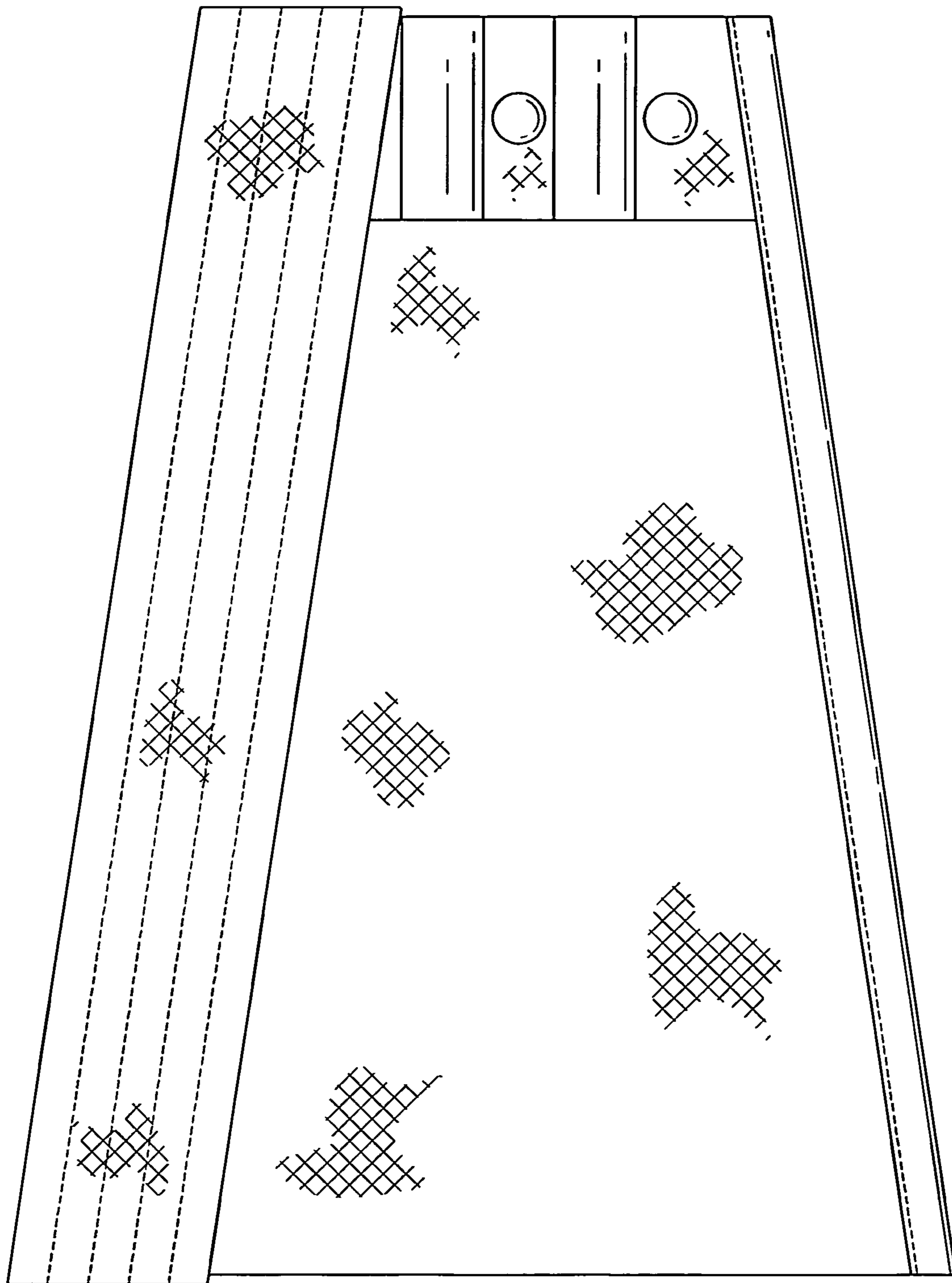

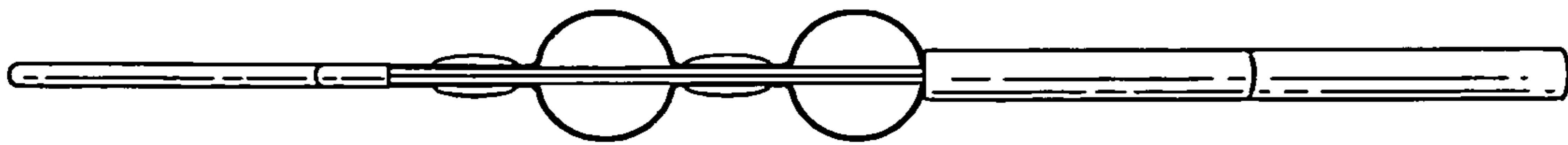

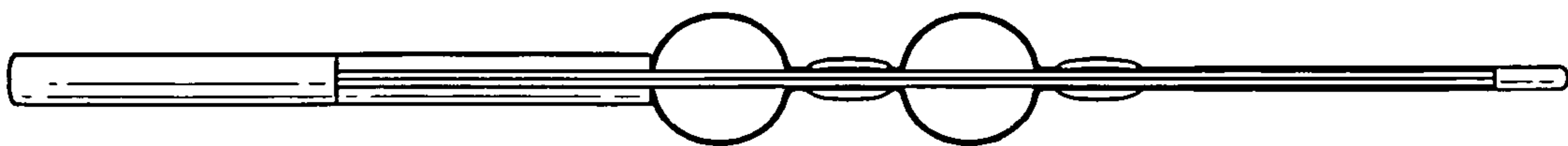

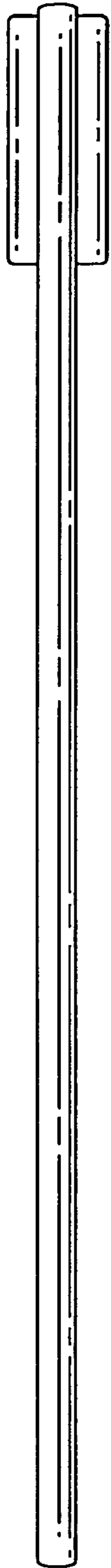

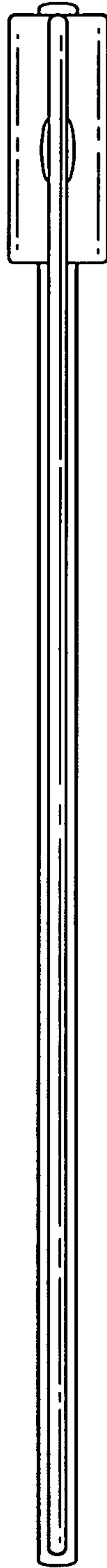

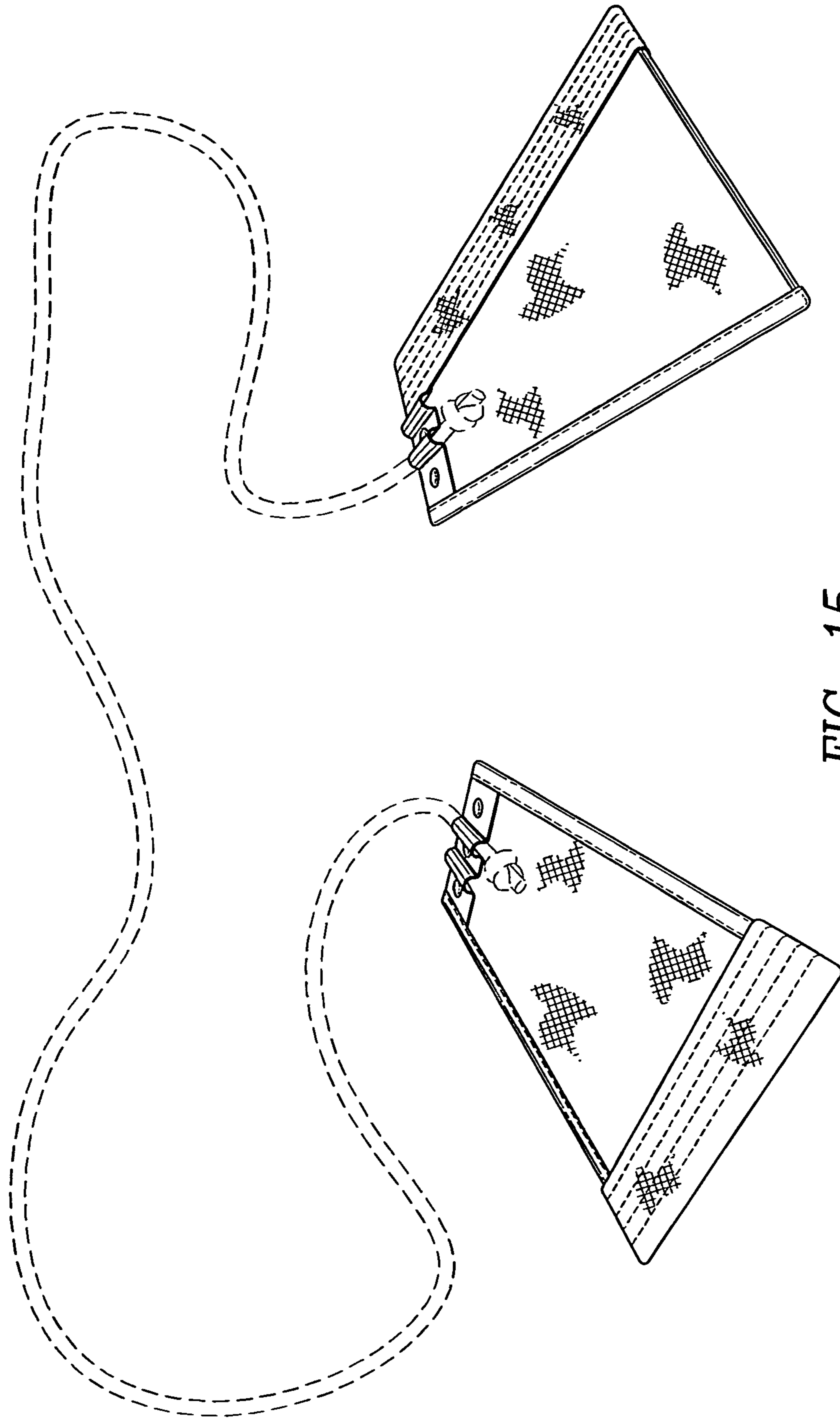
