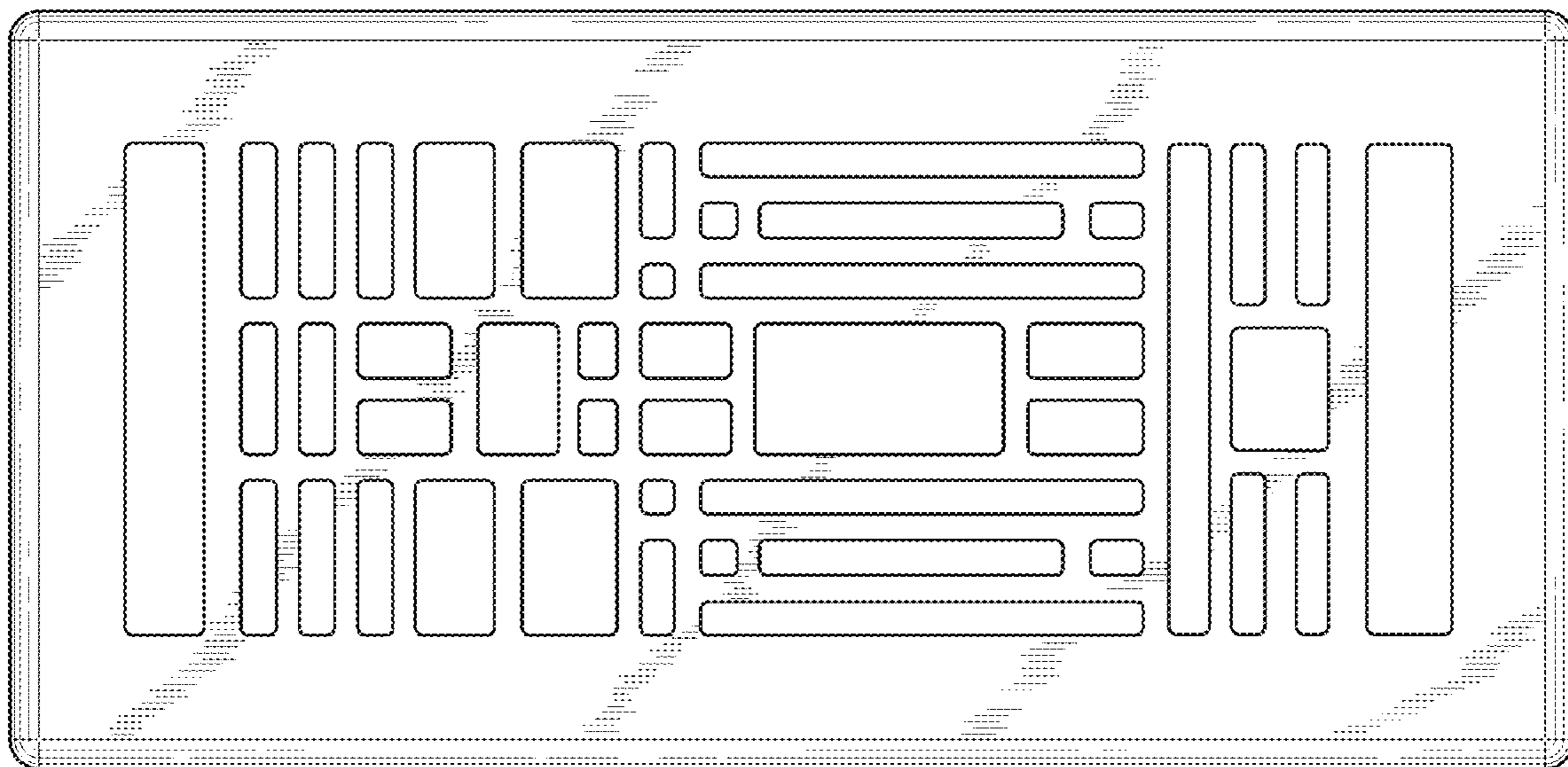
(57) **CLAIM**

The ornamental design for a floor register grille, as shown and described.

**DESCRIPTION**

FIG. 1 is a plan view of the present floor register grille; FIG. 2 is a side elevation of the floor register grille of FIG. 1, both sides being identical; and, FIG. 3 is an end elevation of the floor register grille of FIG. 1 both ends being identical.

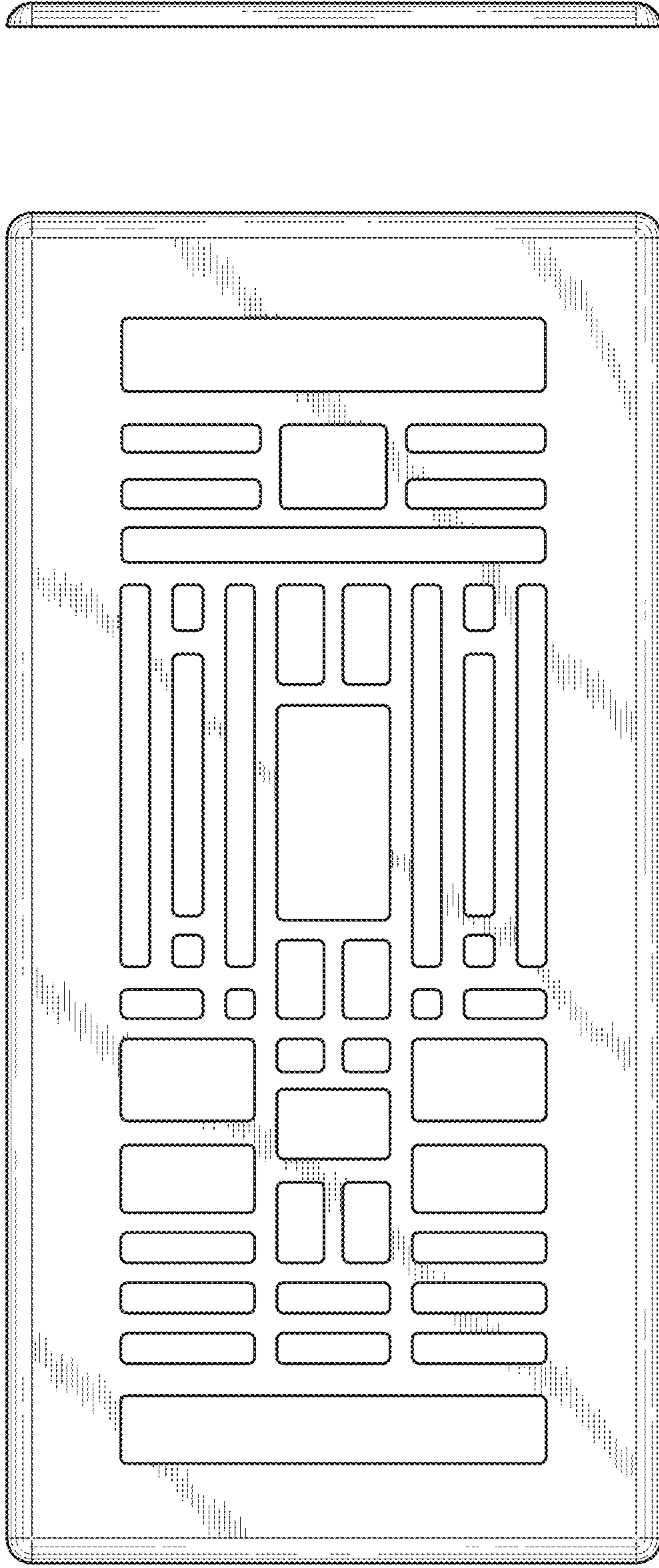

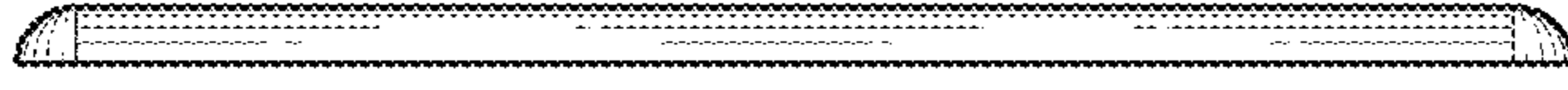
