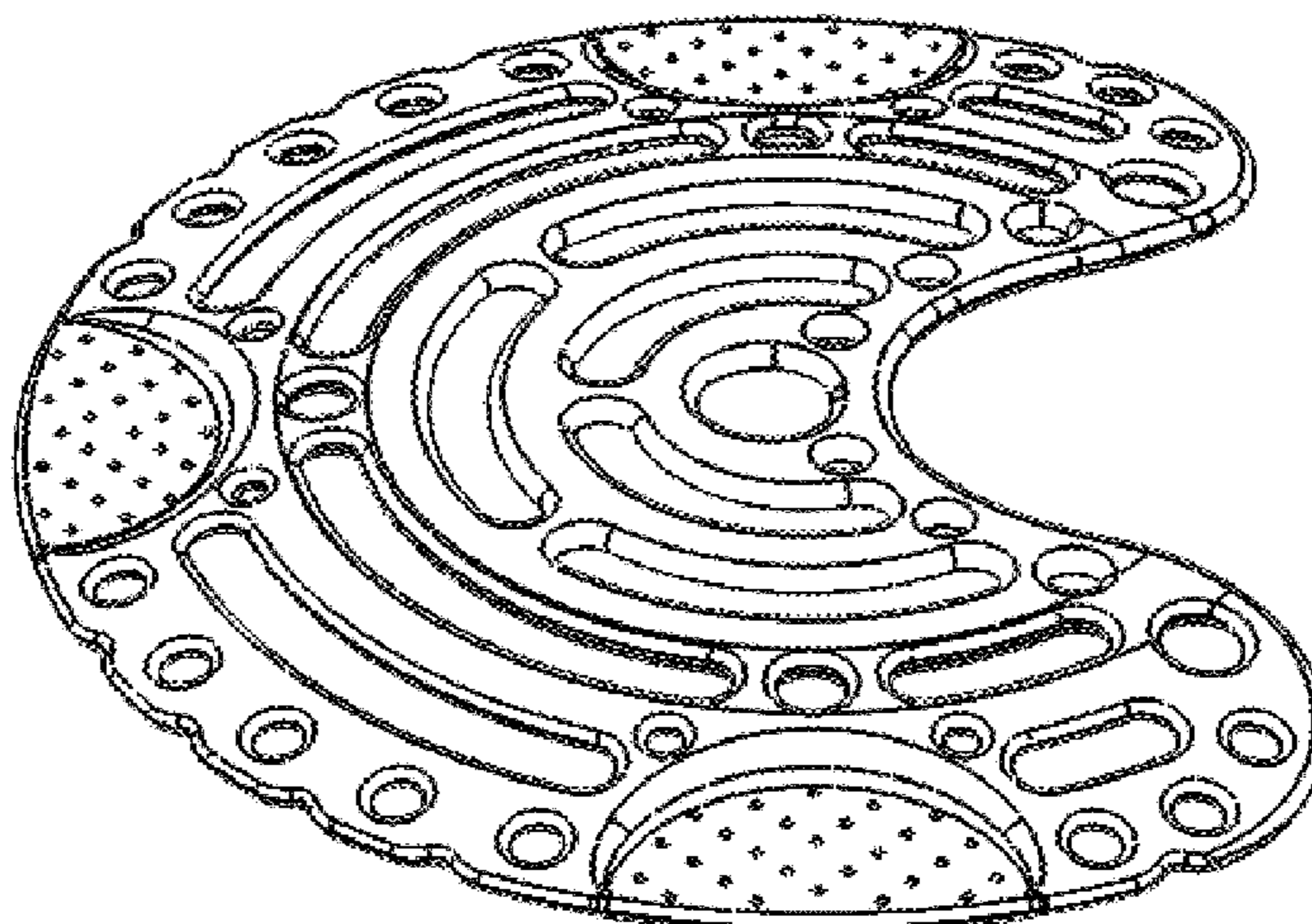
(57) **CLAIM**

I claim the ornamental design for a corner piece for reducing structural cracks in stucco at corners of doors and windows.

DESCRIPTION

FIG. 1 is a top perspective view of a corner piece for reducing structural cracks in stucco at corners of doors and windows; FIG. 2 is a top plan view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a front side view thereof; FIG. 6 is a back side view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a bottom perspective view thereof.

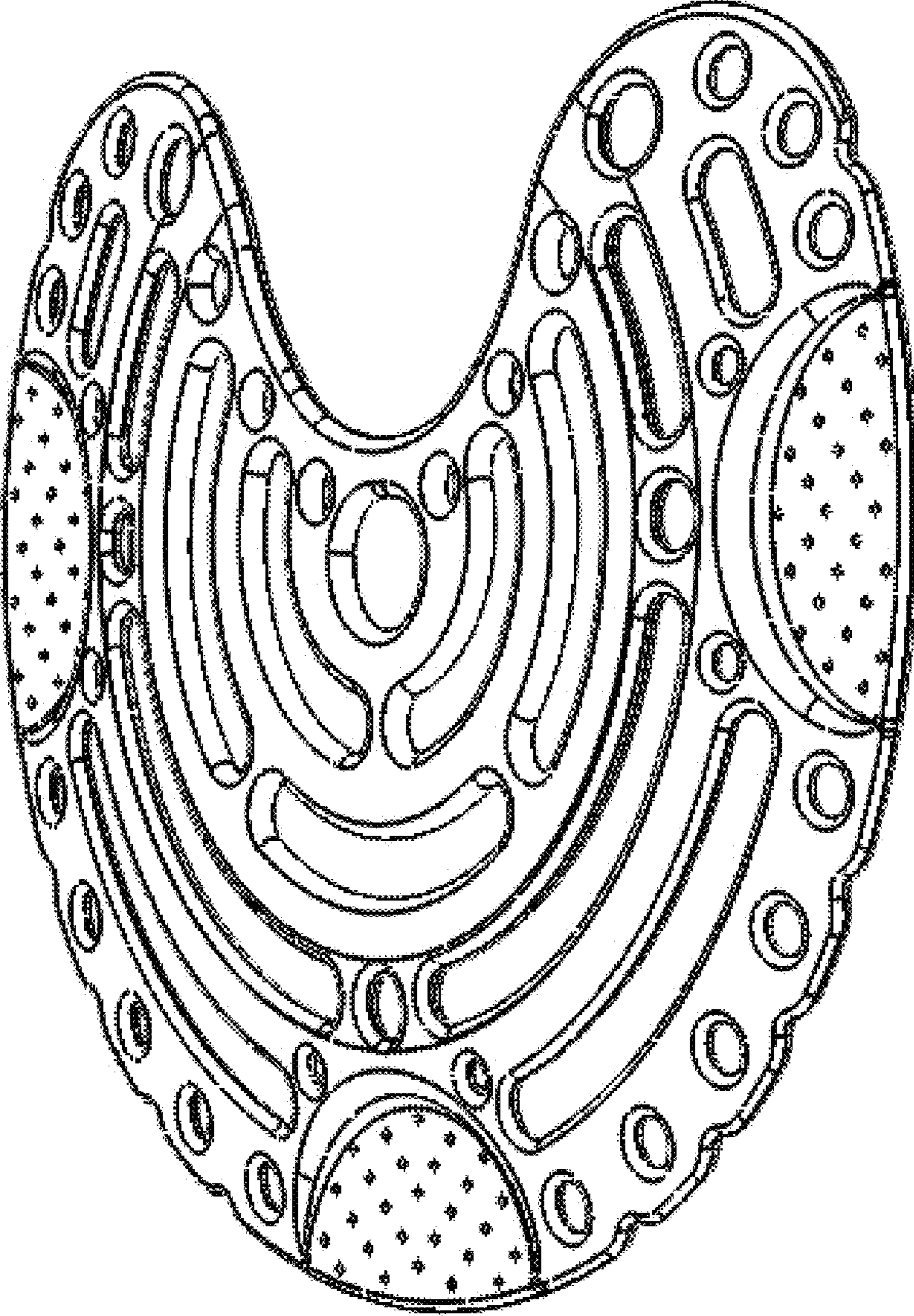

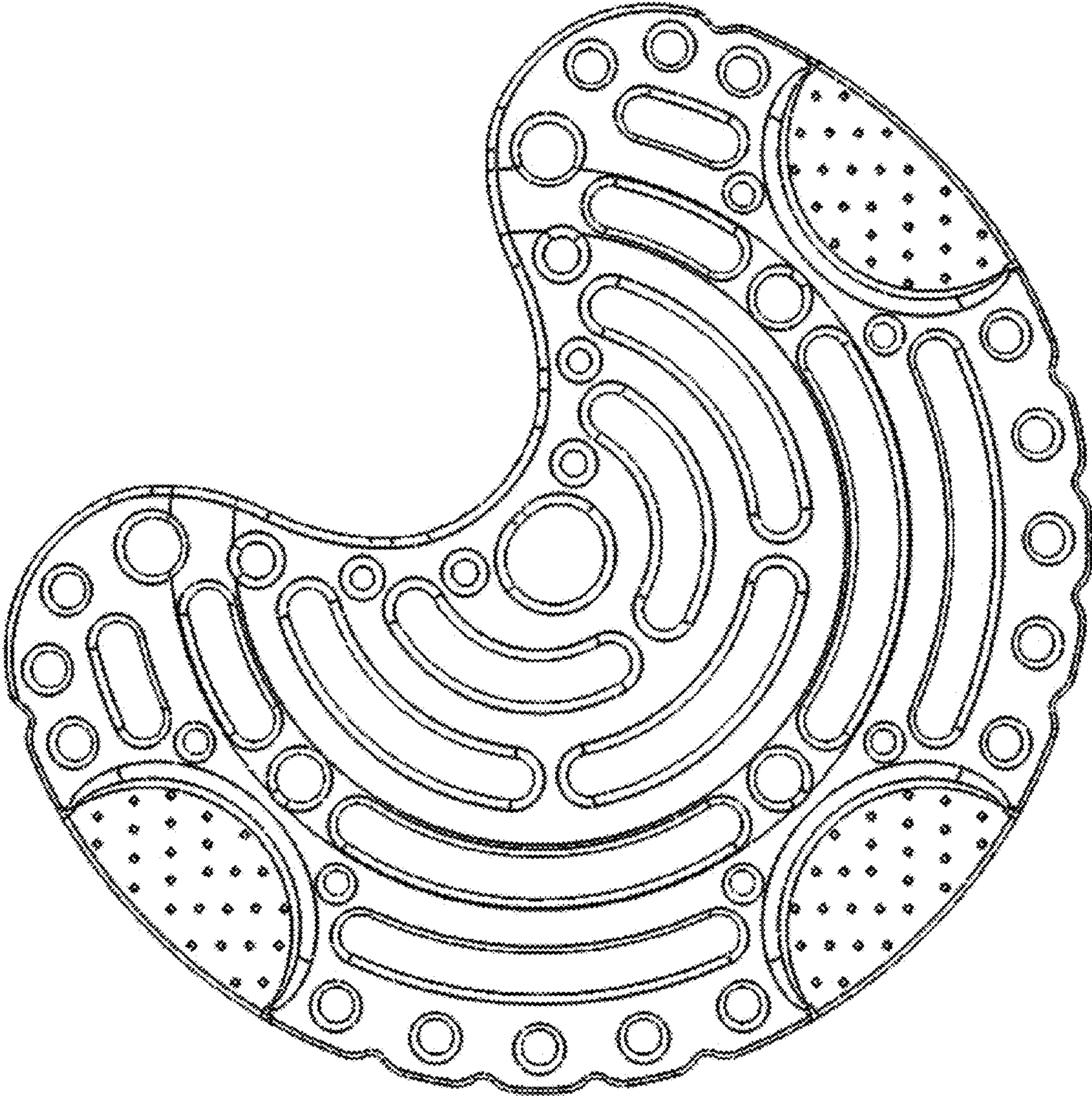

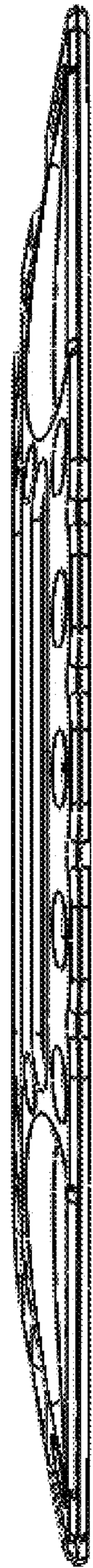

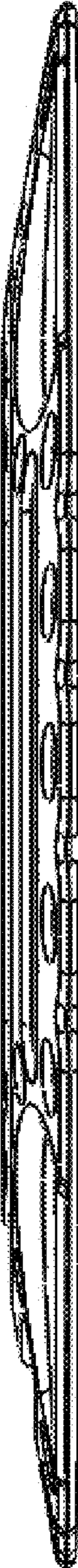
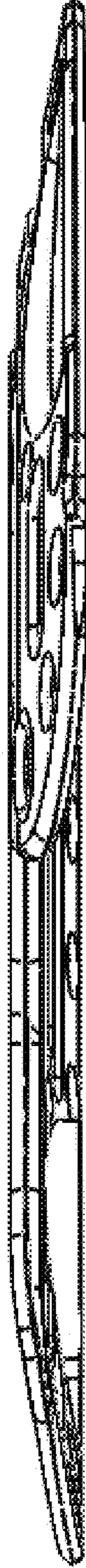

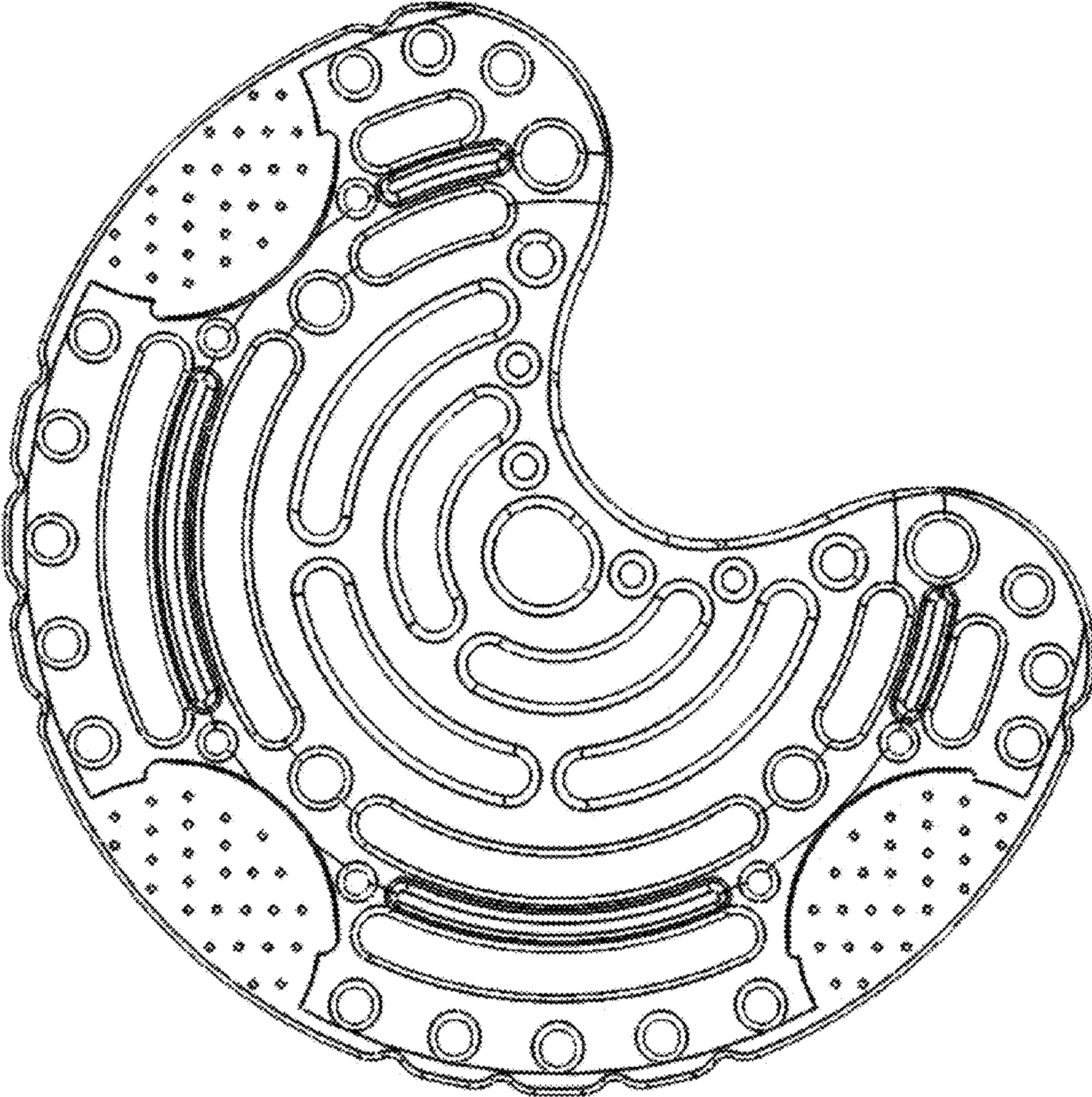

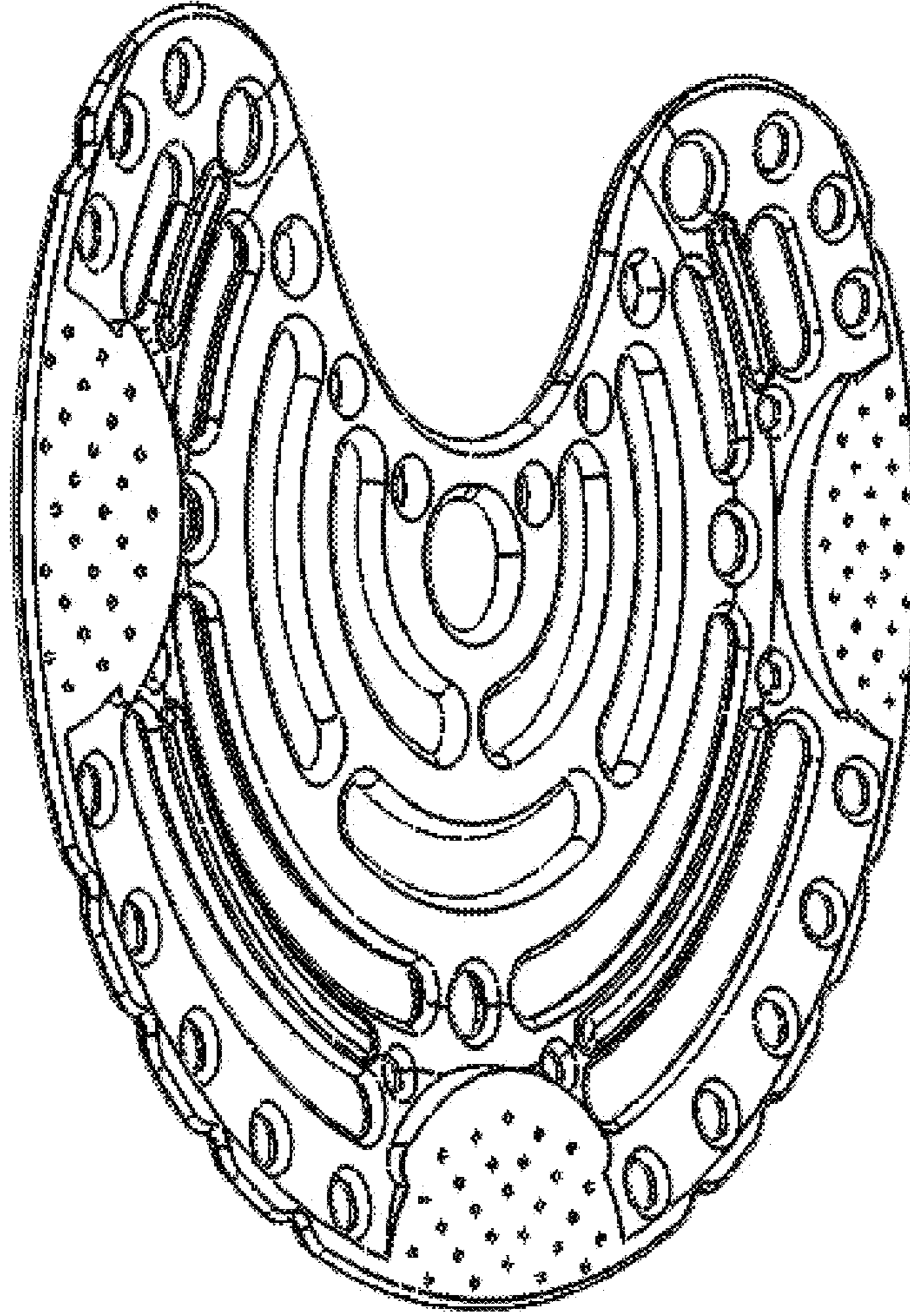
