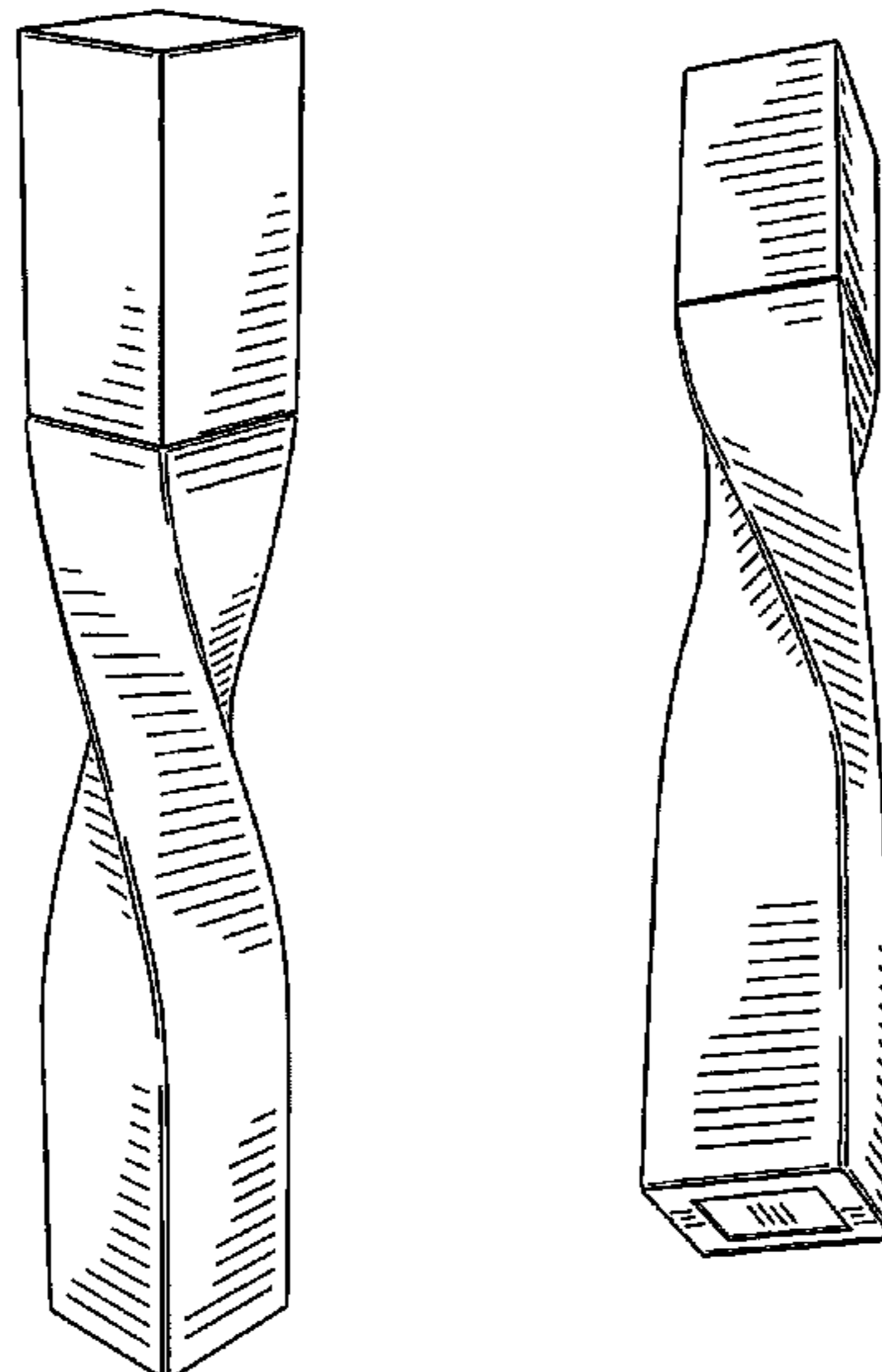
(57) **CLAIM**

The ornamental design for a mascara package, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of my new design for a mascara package;
 FIG. 2 is a bottom, front and right side perspective view of the mascara package shown in FIG. 1;
 FIG. 3 is a right side elevation view of the mascara package shown in FIG. 1, the left side elevation view, the front elevation view and the rear elevation view, being identical thereto;
 FIG. 4 is a top plan view of the mascara package shown in FIG. 1; and,
 FIG. 5 is a bottom plan view of the mascara package shown in FIG. 1.

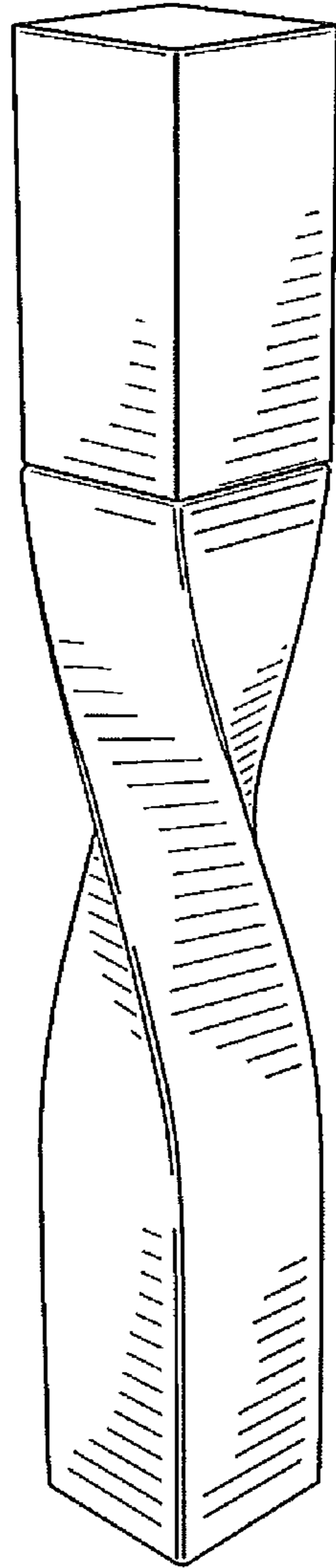

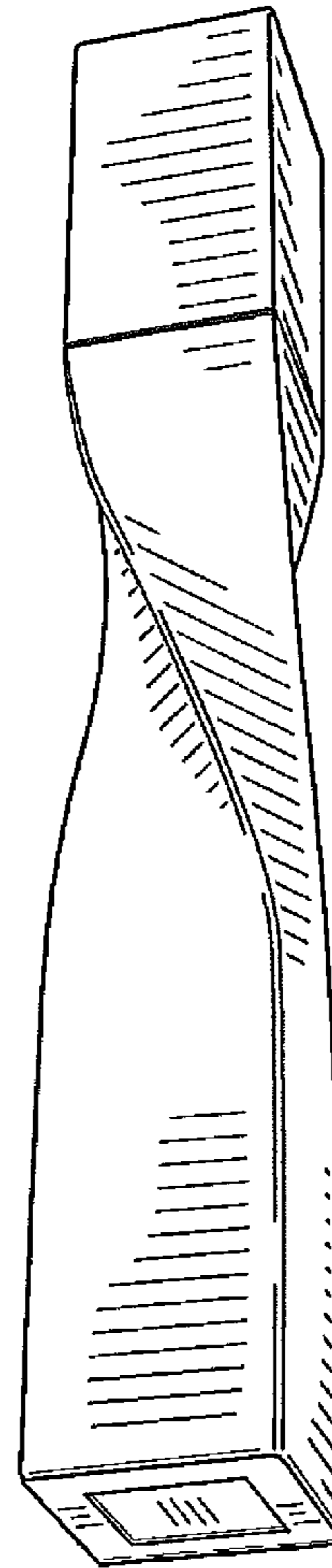

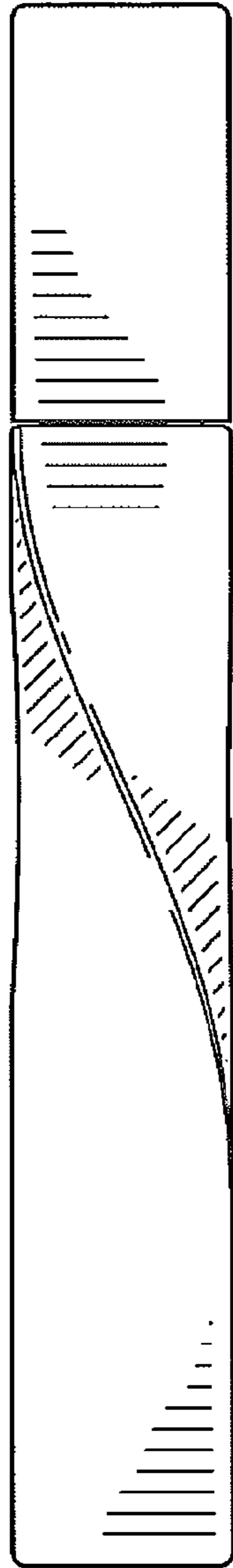

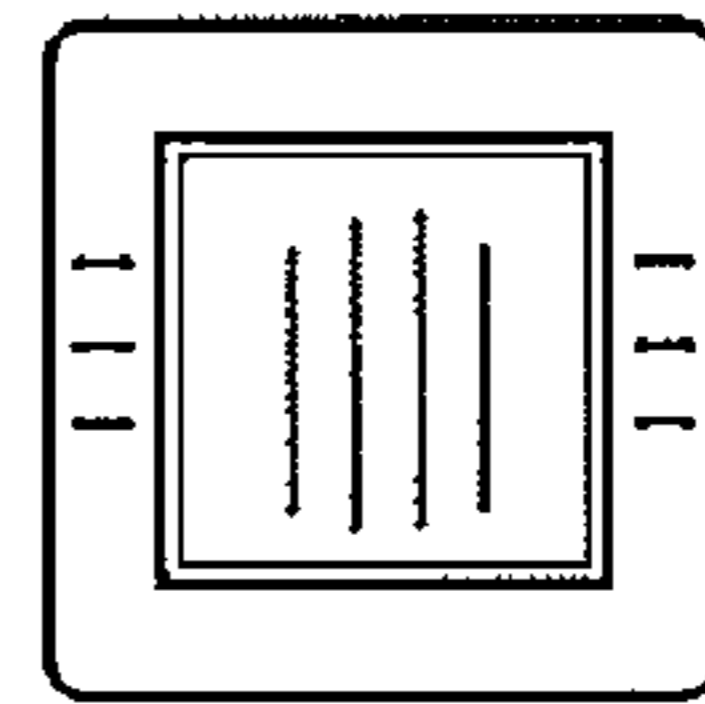
