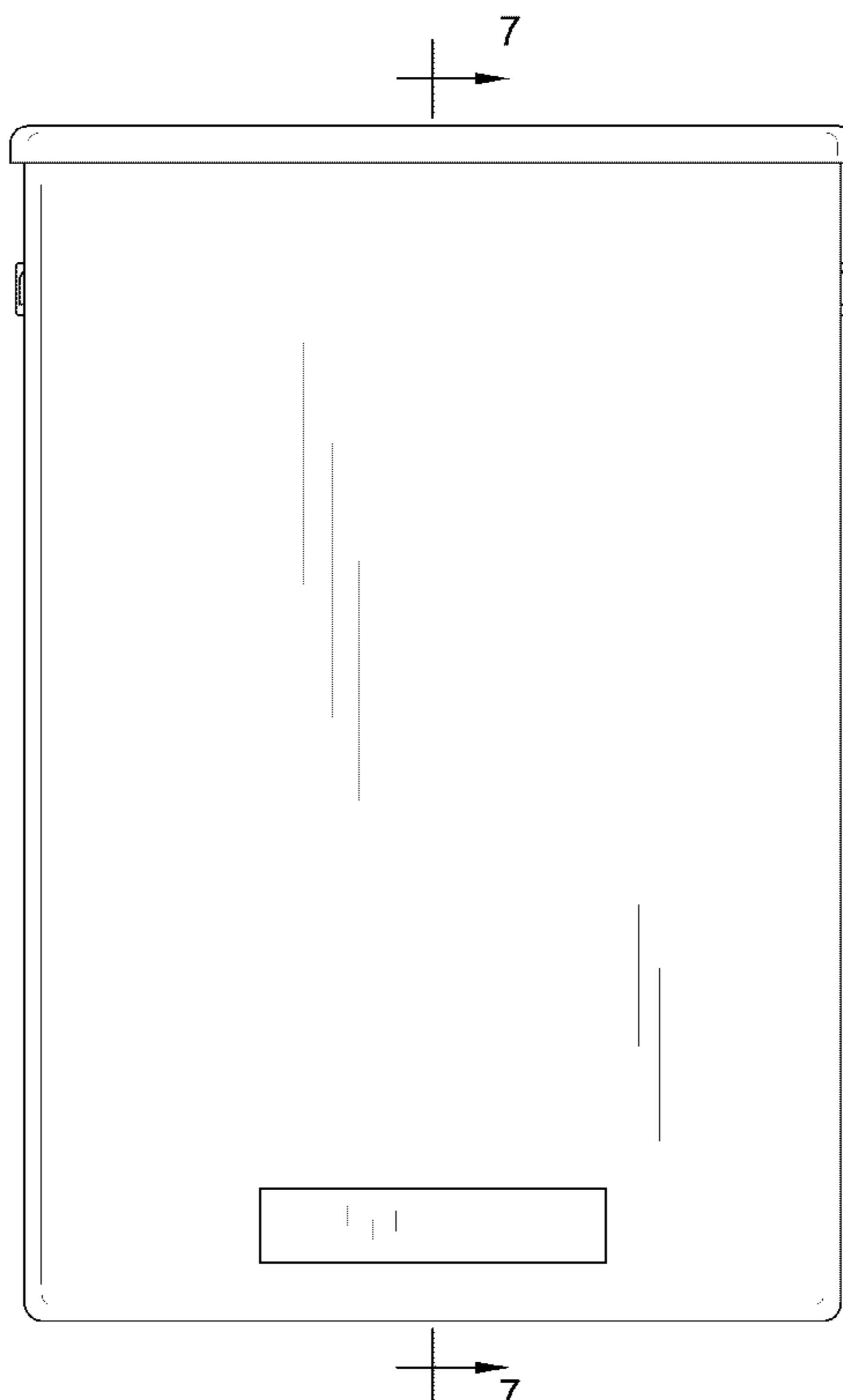
(57) **CLAIM**

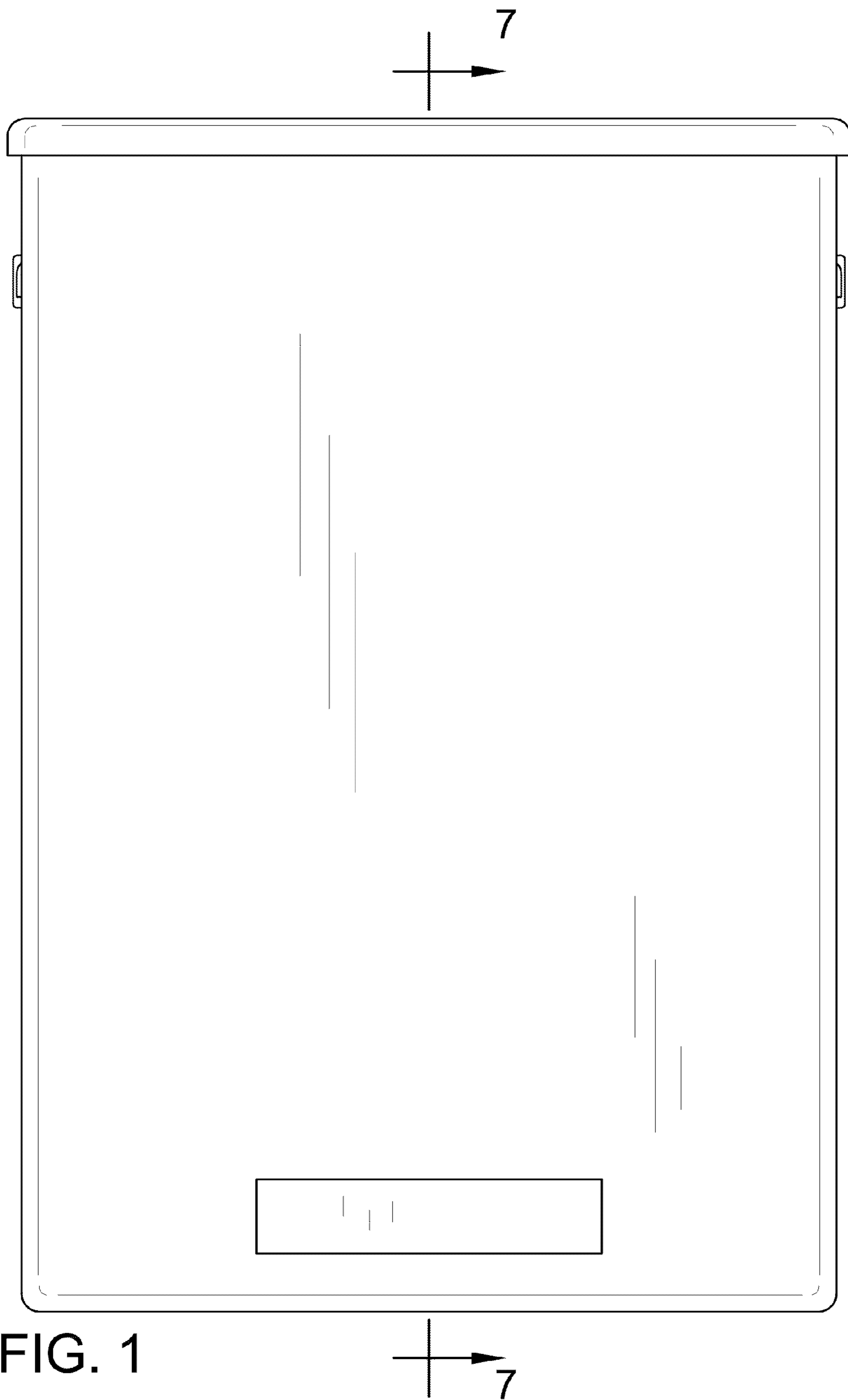
The ornamental design for a waste receptacle with bag dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear elevation view of a waste receptacle with bag dispenser showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a left side elevation view thereof, the opposite side being a mirror image of the shown; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is an isometric view thereof; and, FIG. 7 is a cross-sectional view thereof taken along line 7-7 of FIG. 1.

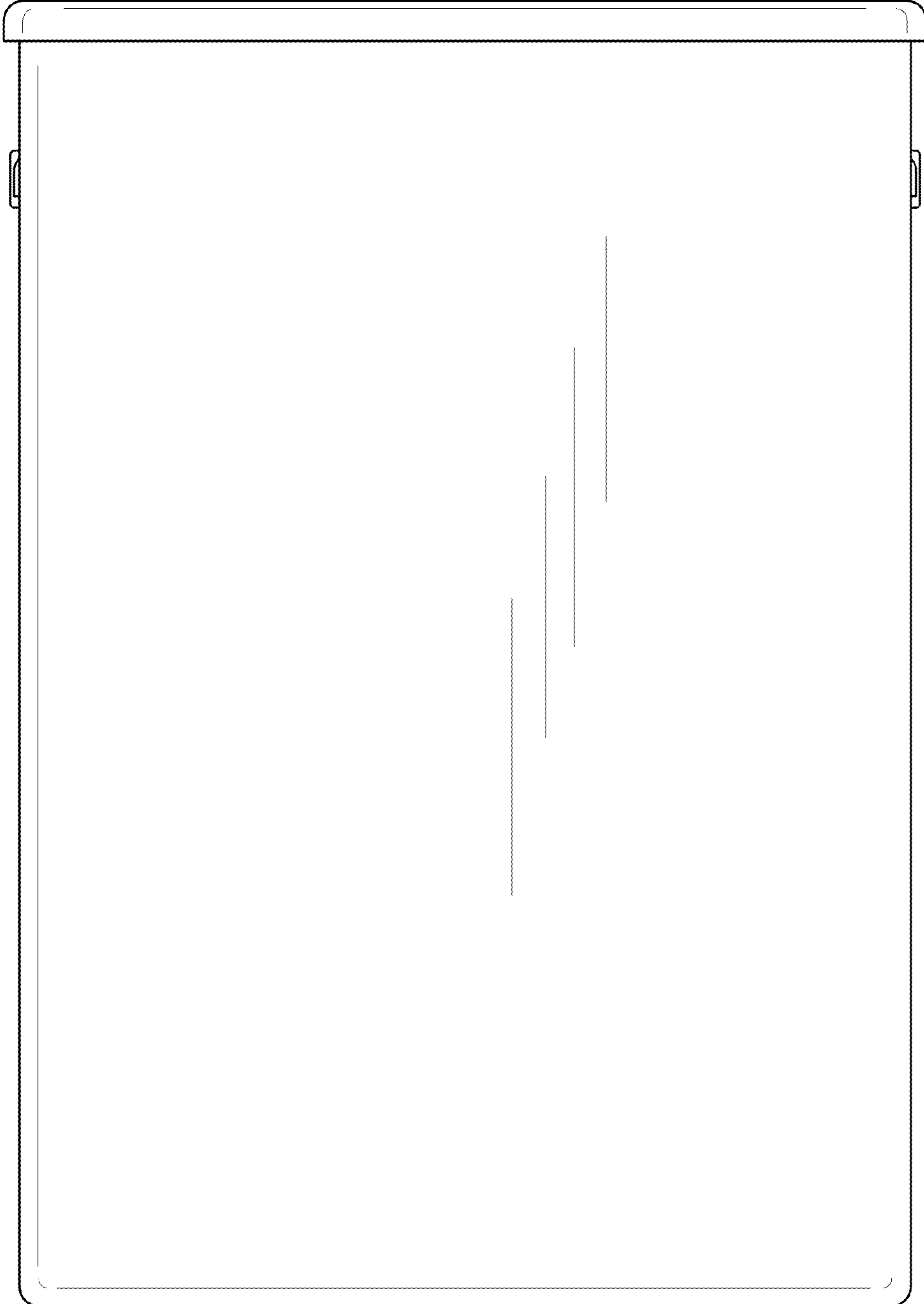

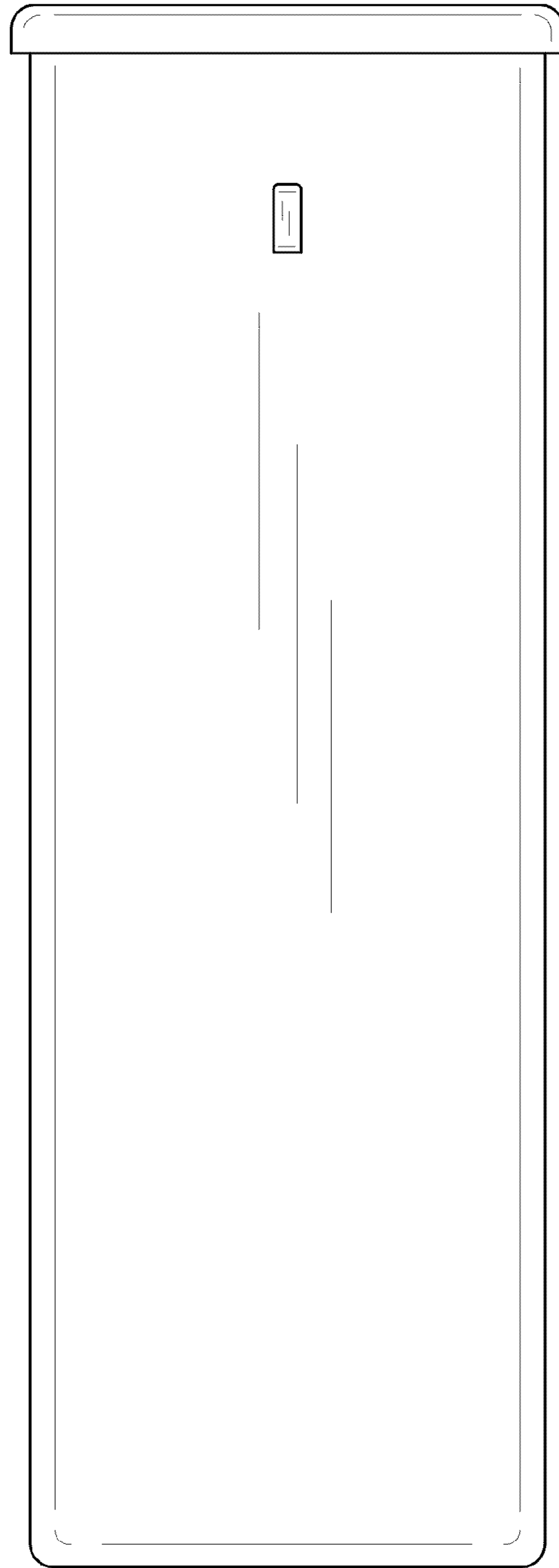

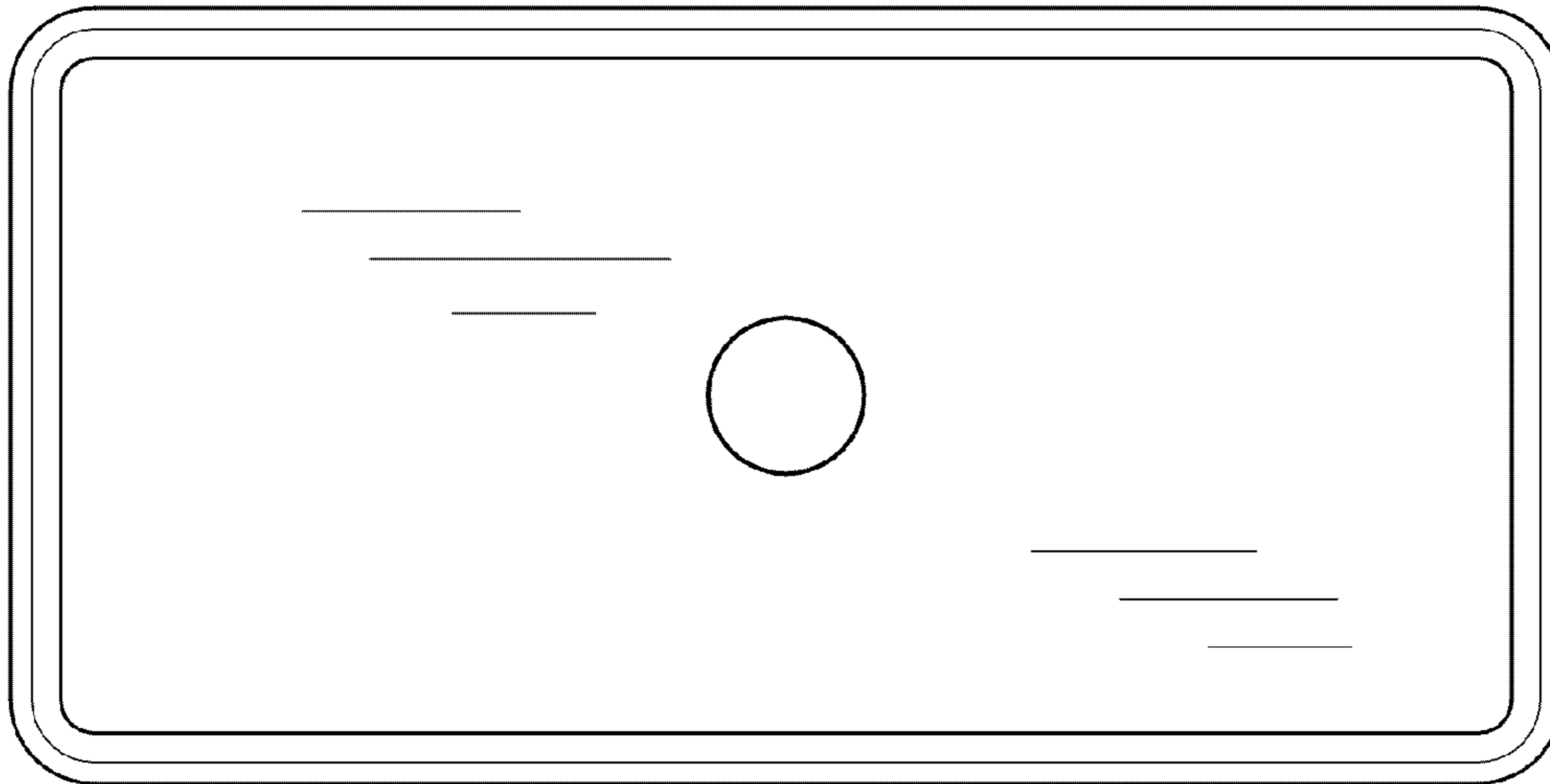

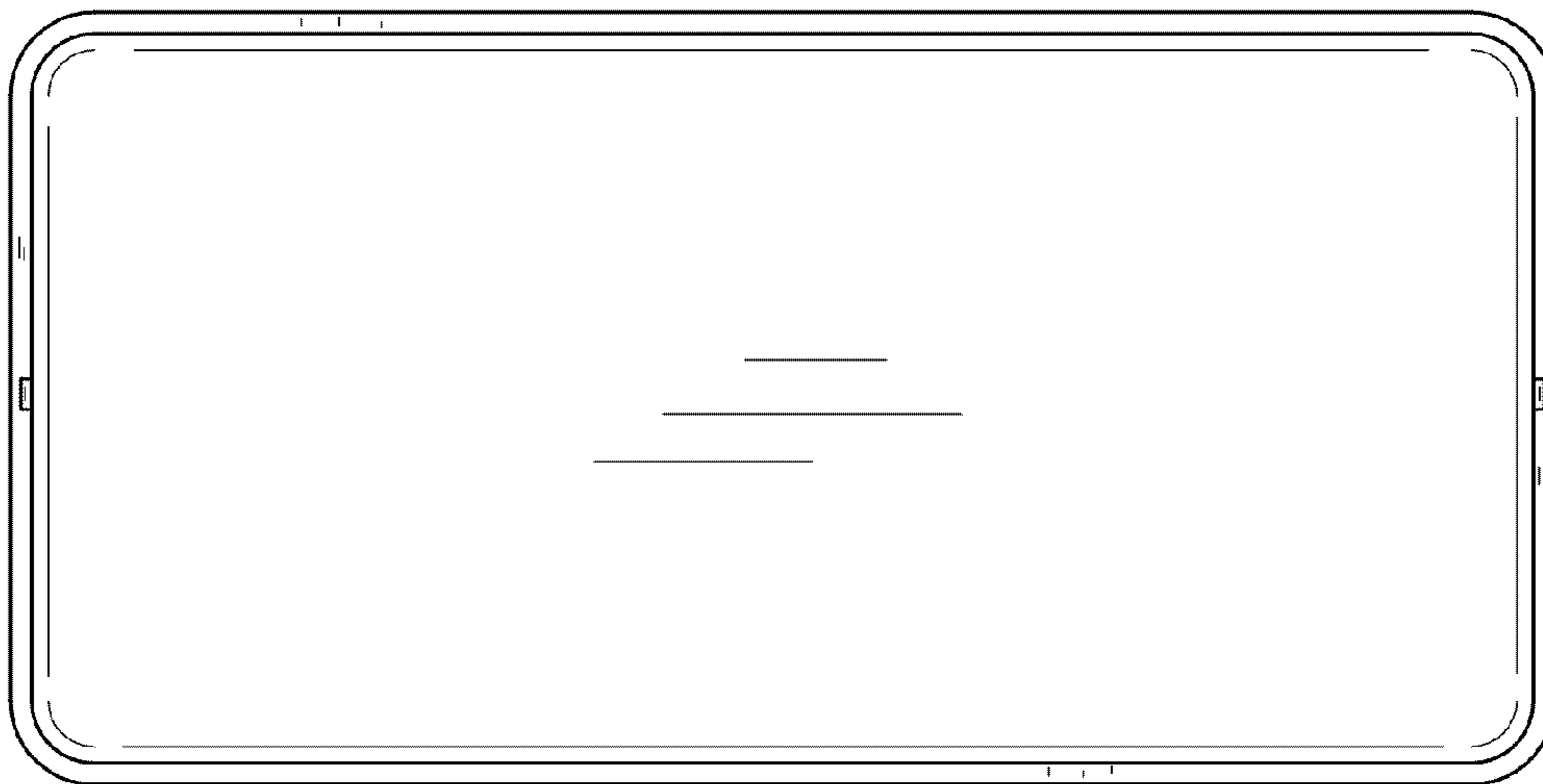

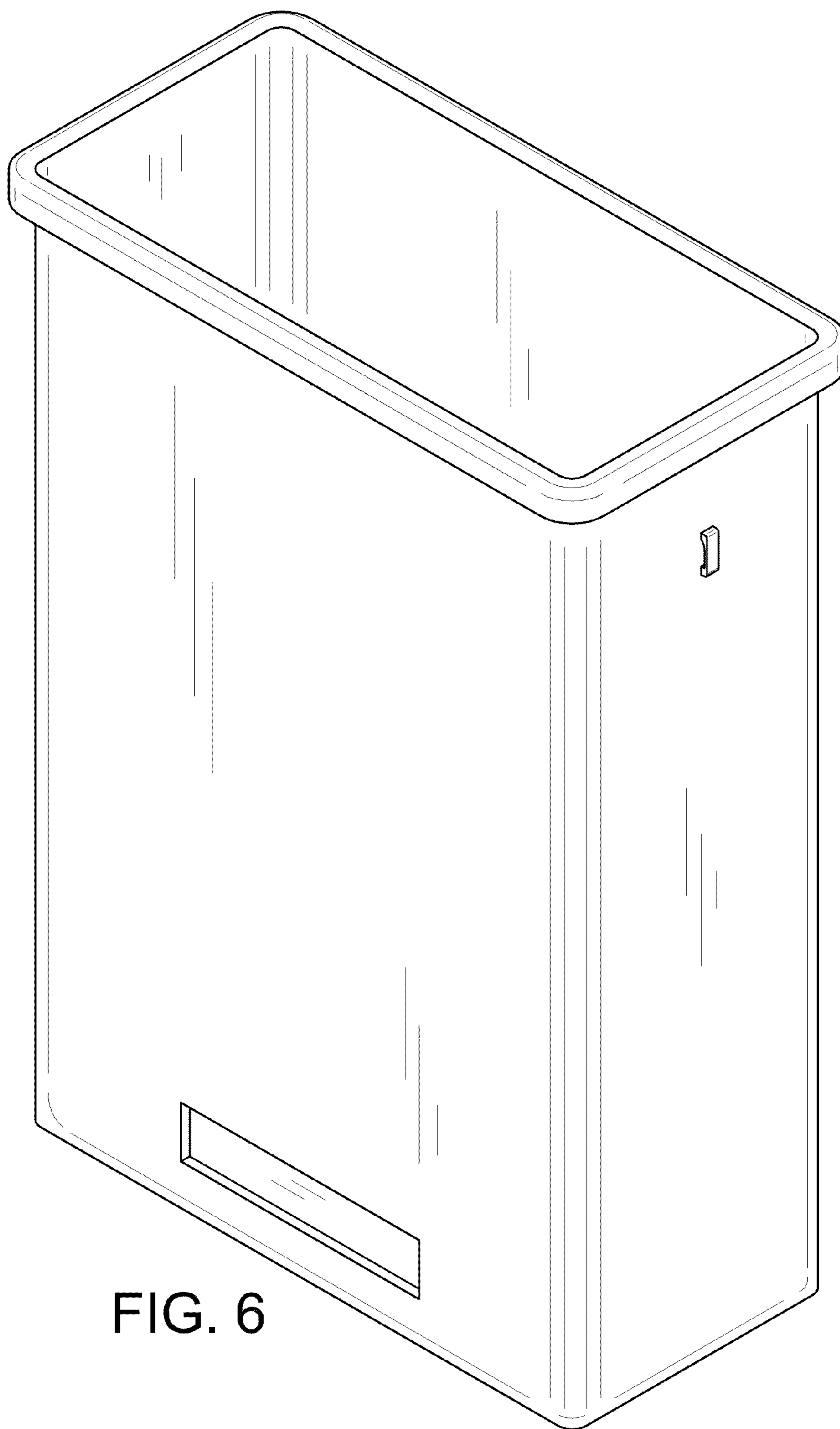

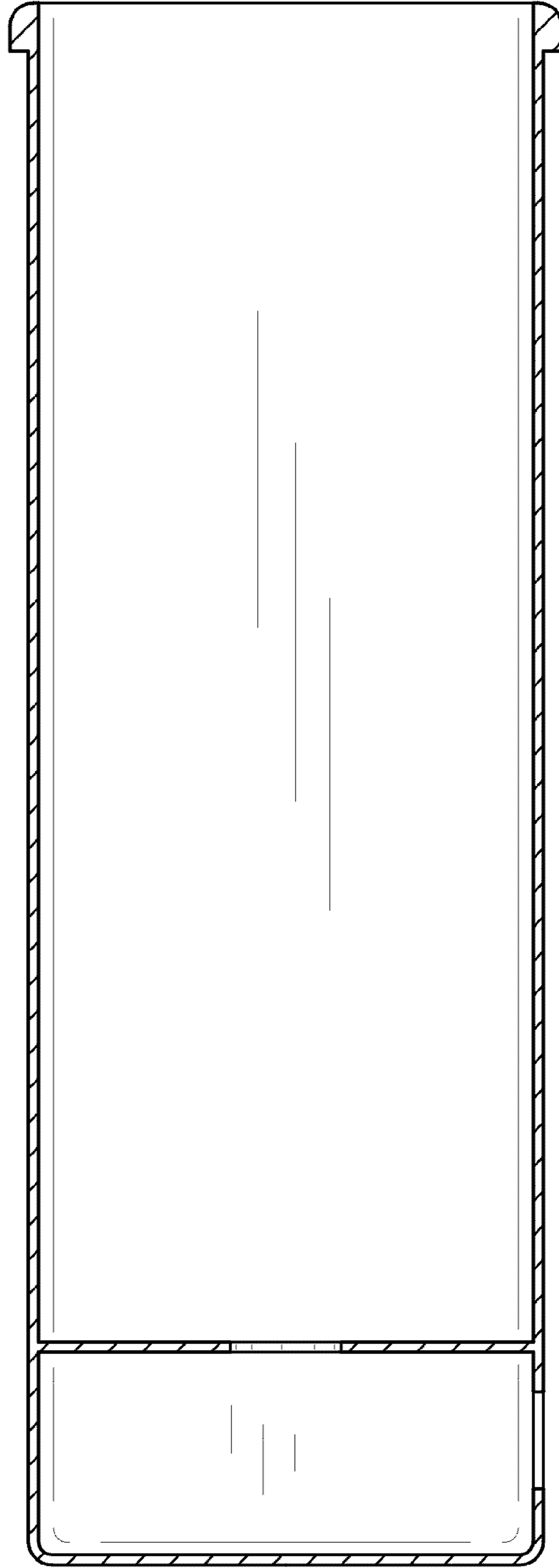
