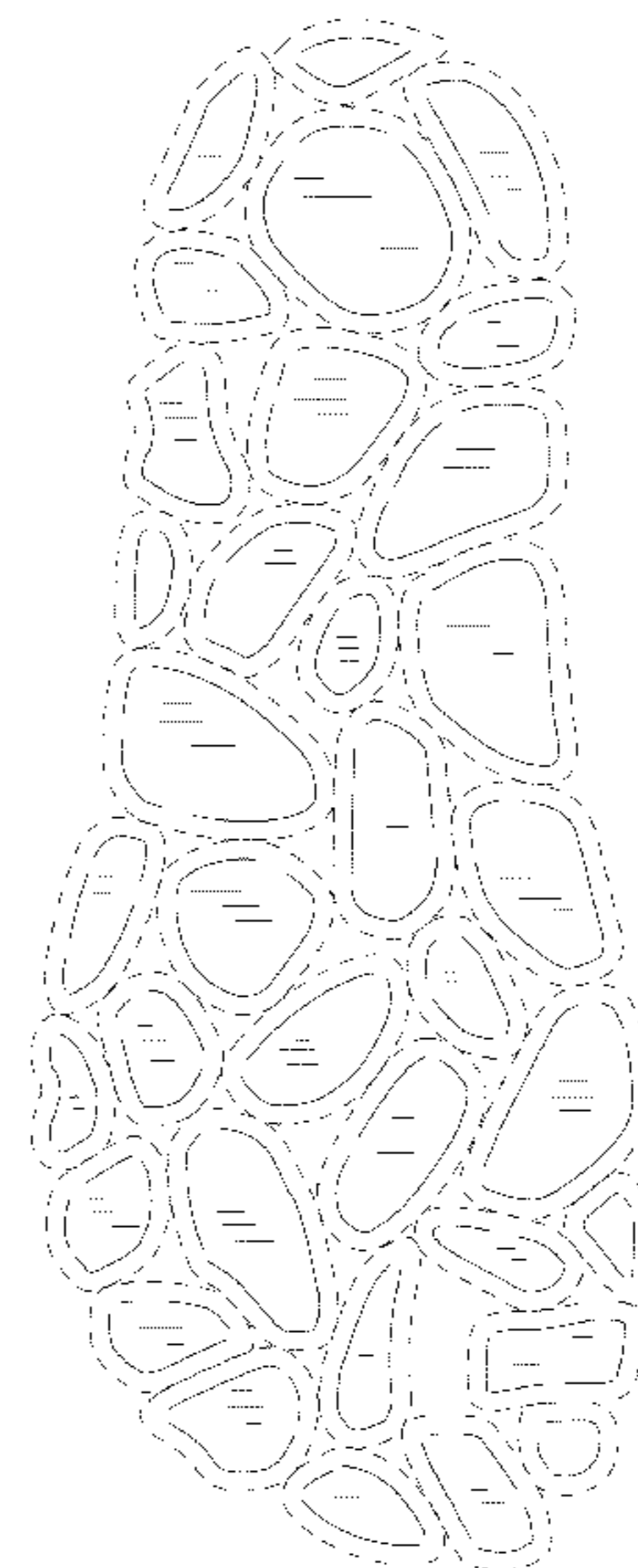
The ornamental design for footbed, as shown and described.

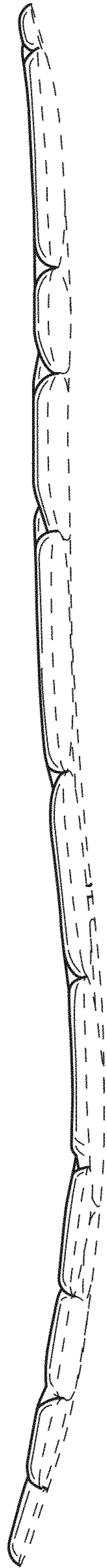

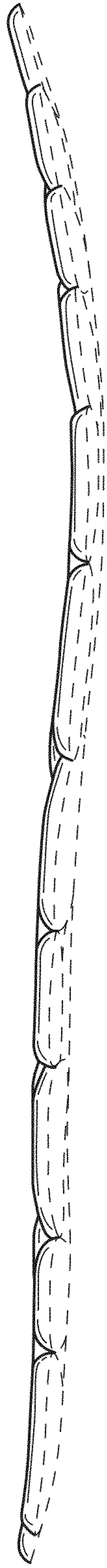

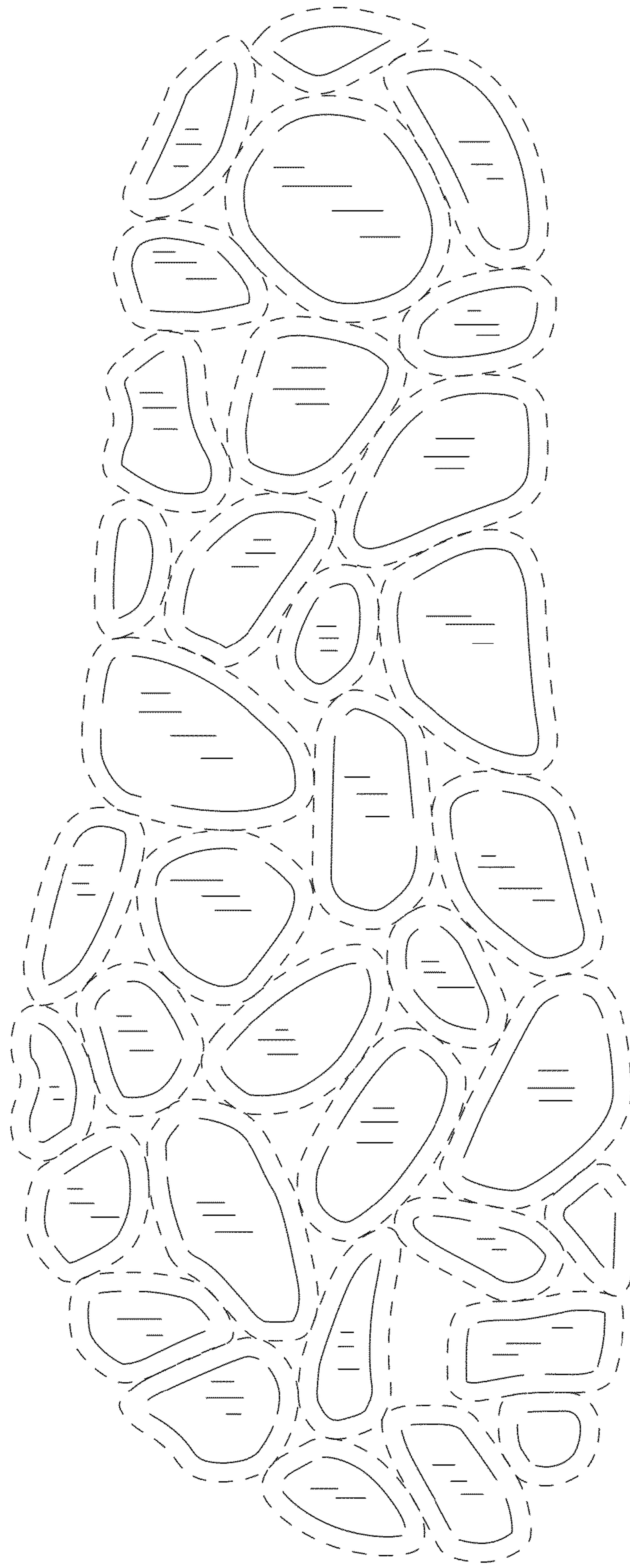

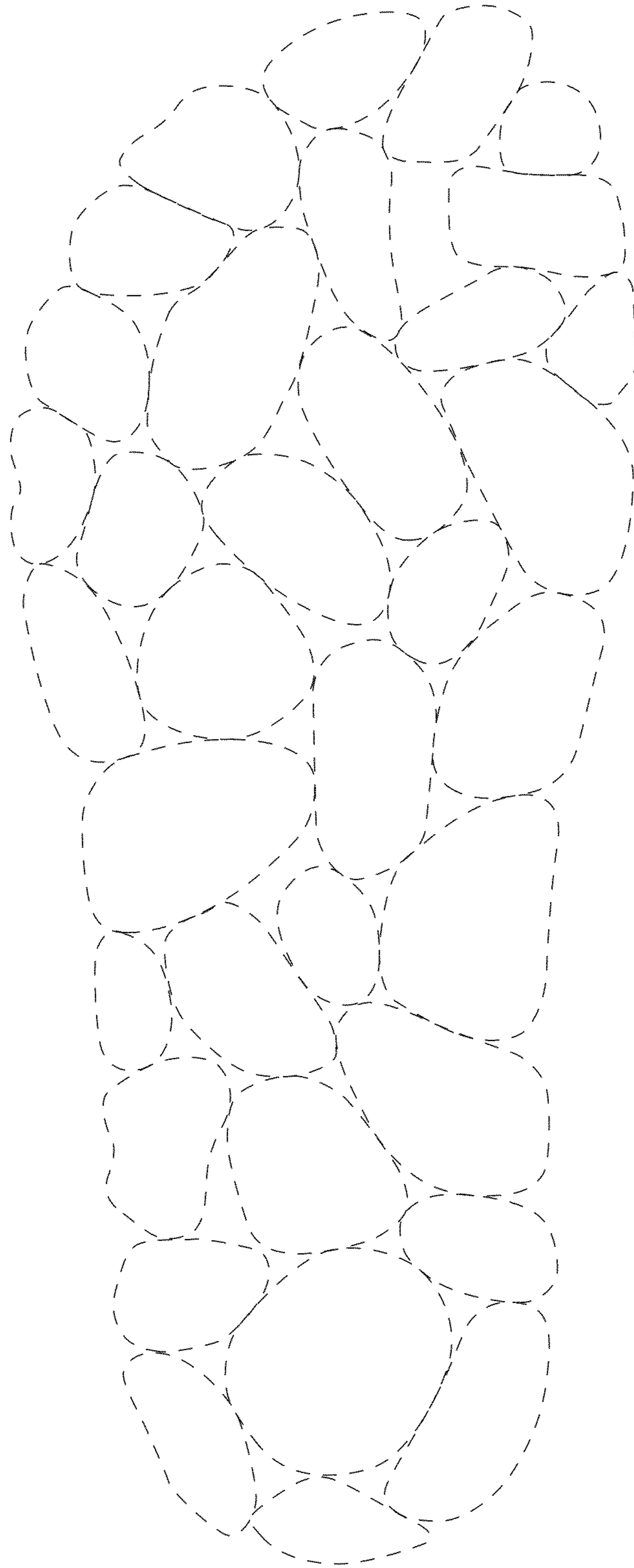
