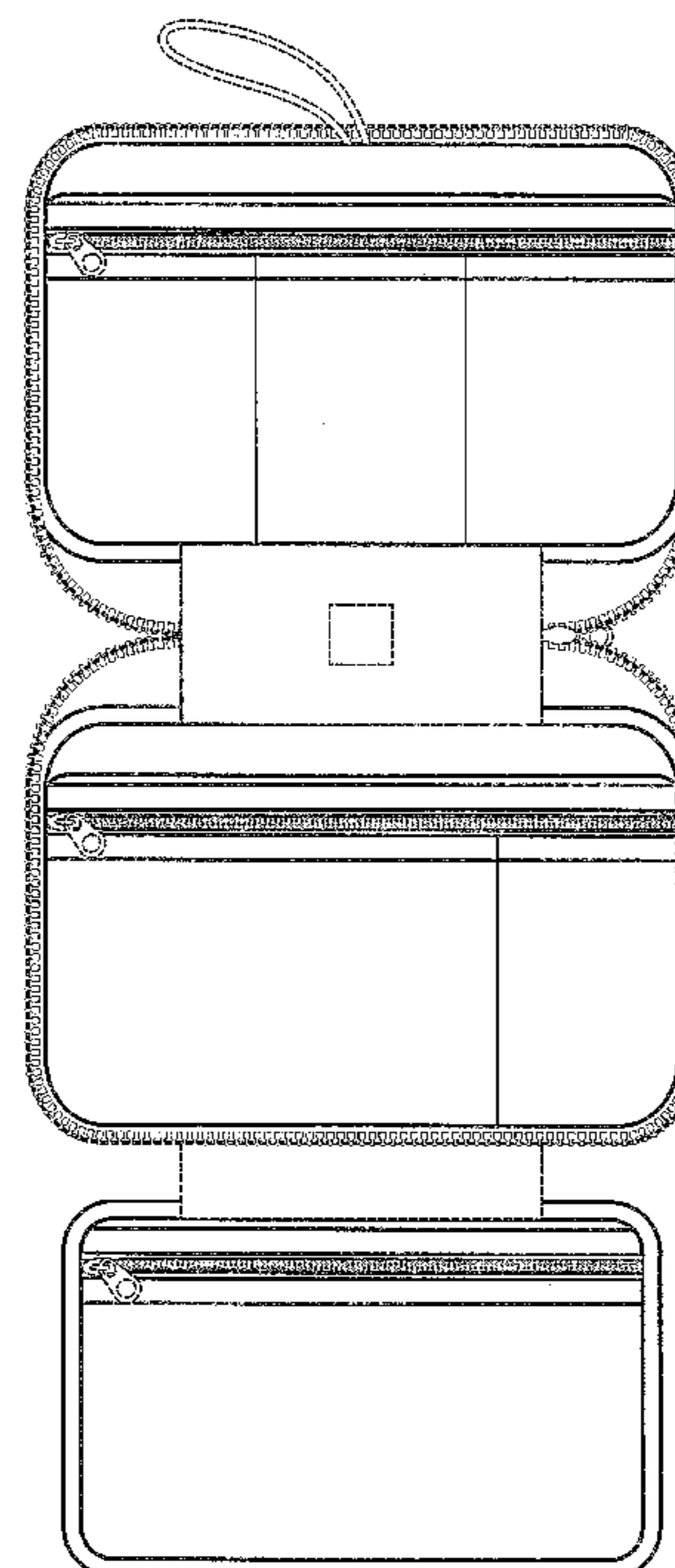
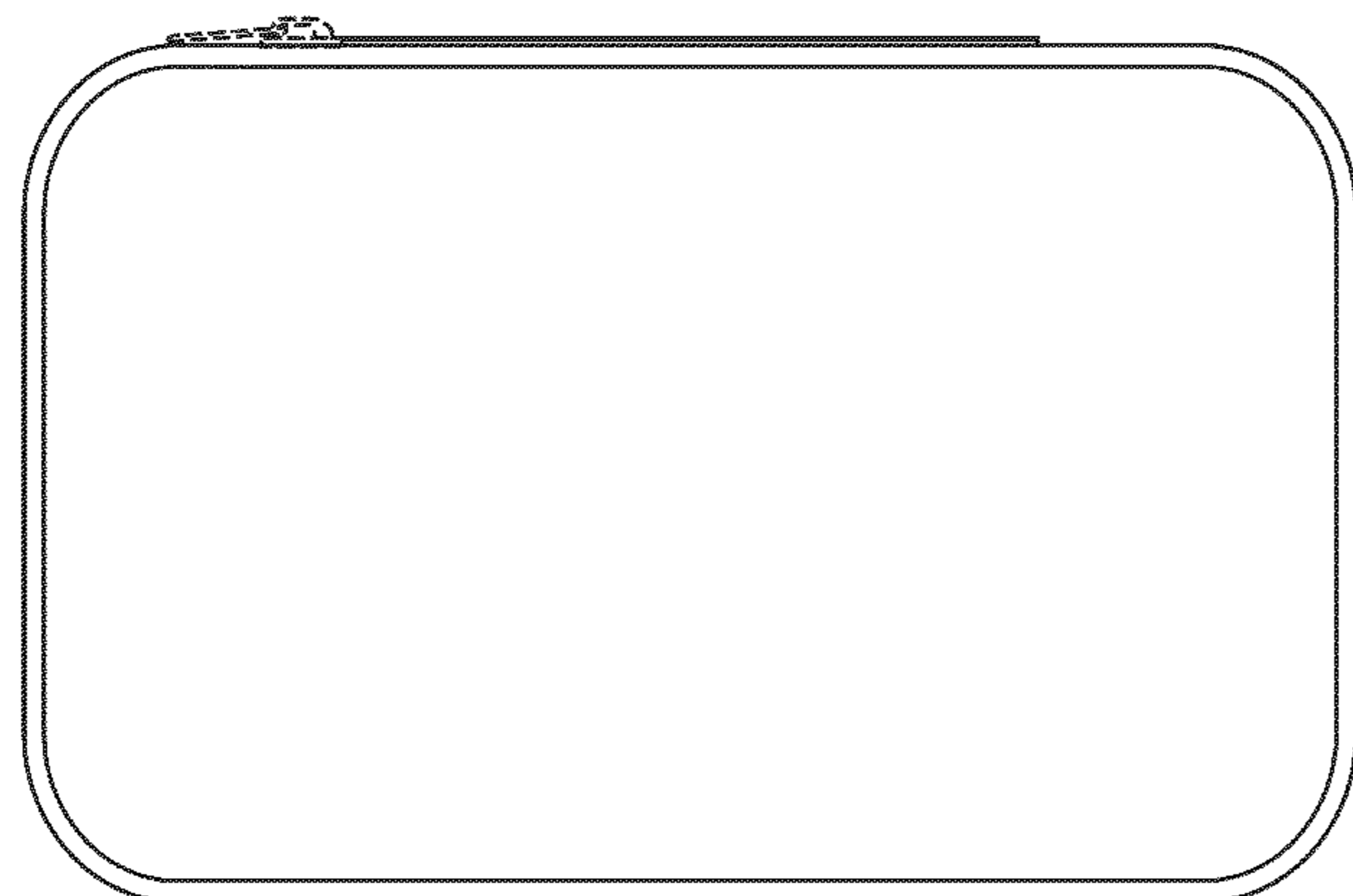
(57) **CLAIM**

DESCRIPTION

FIG. 1 illustrates a front elevation view of the case in a closed configuration;
 FIG. 2 is a right side view of the case in FIG. 1;
 FIG. 3 is a left side view of the case in FIG. 1;
 FIG. 4 is a front view of the case in FIG. 1 in an open configuration;
 FIG. 5 is a back view of the case in FIG. 1;

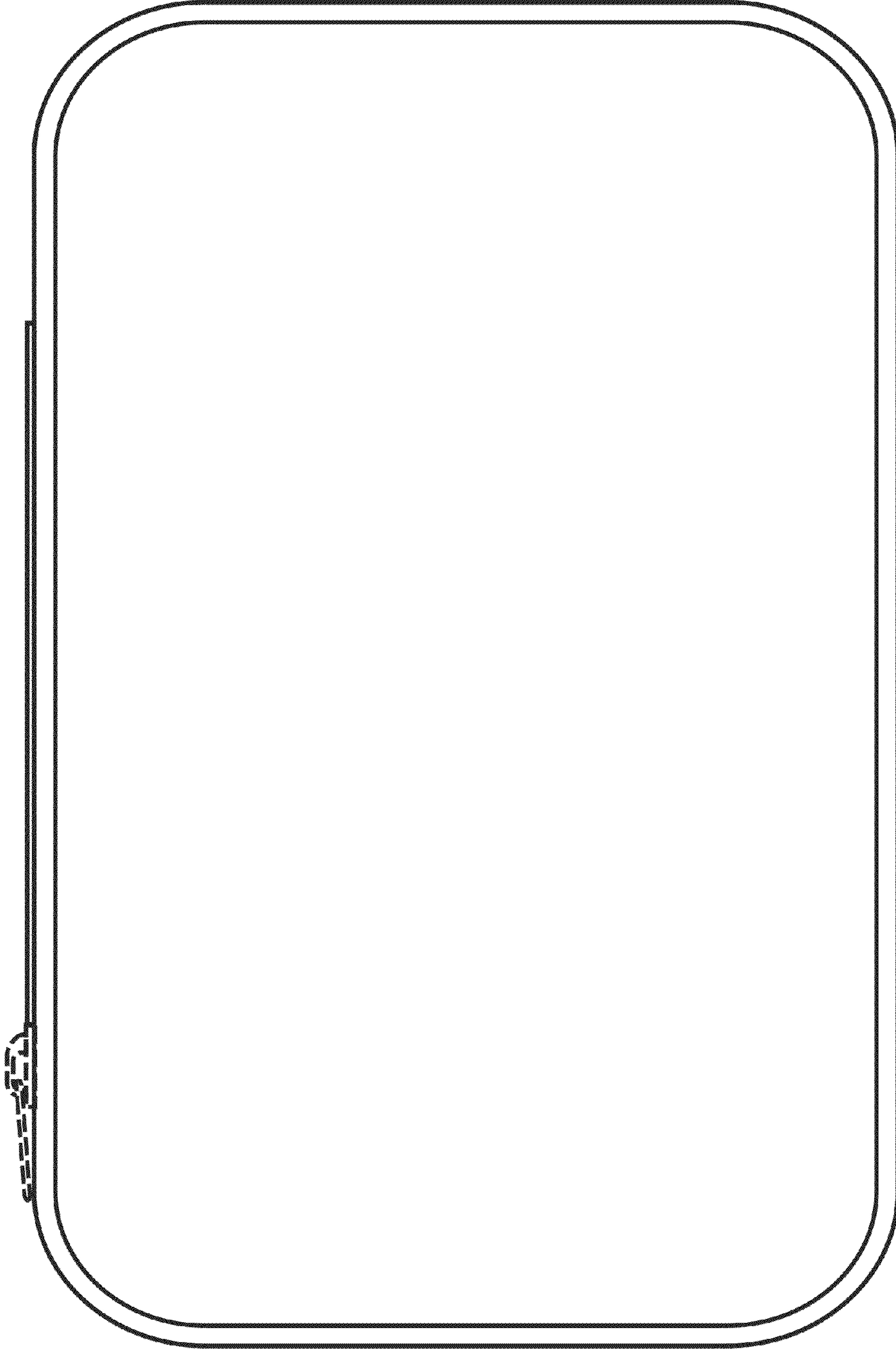

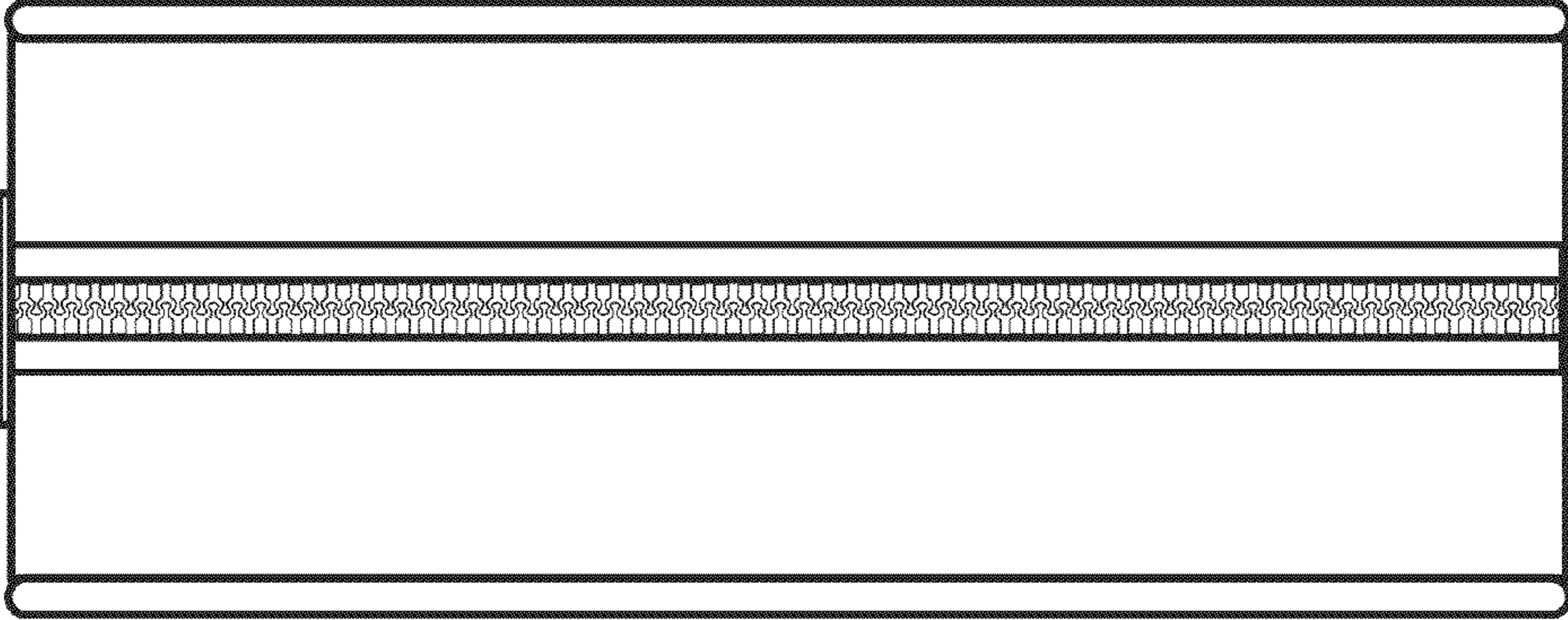

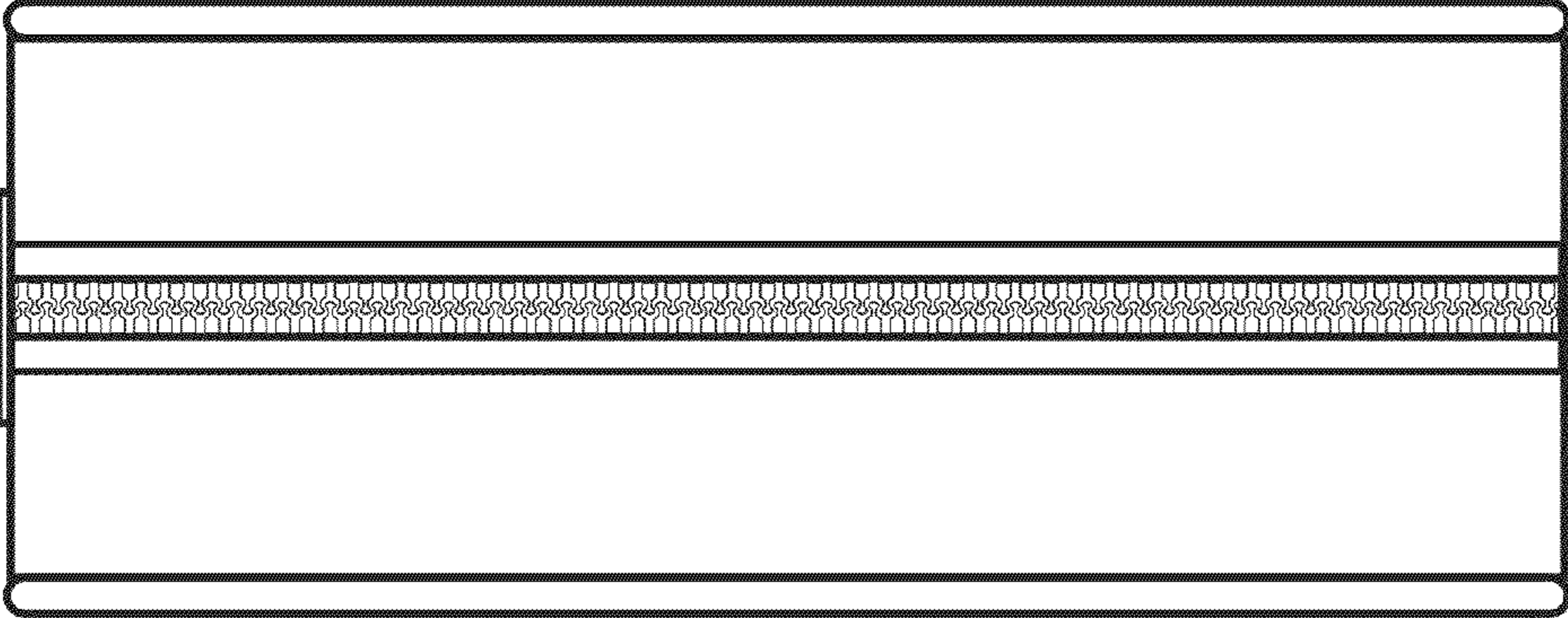

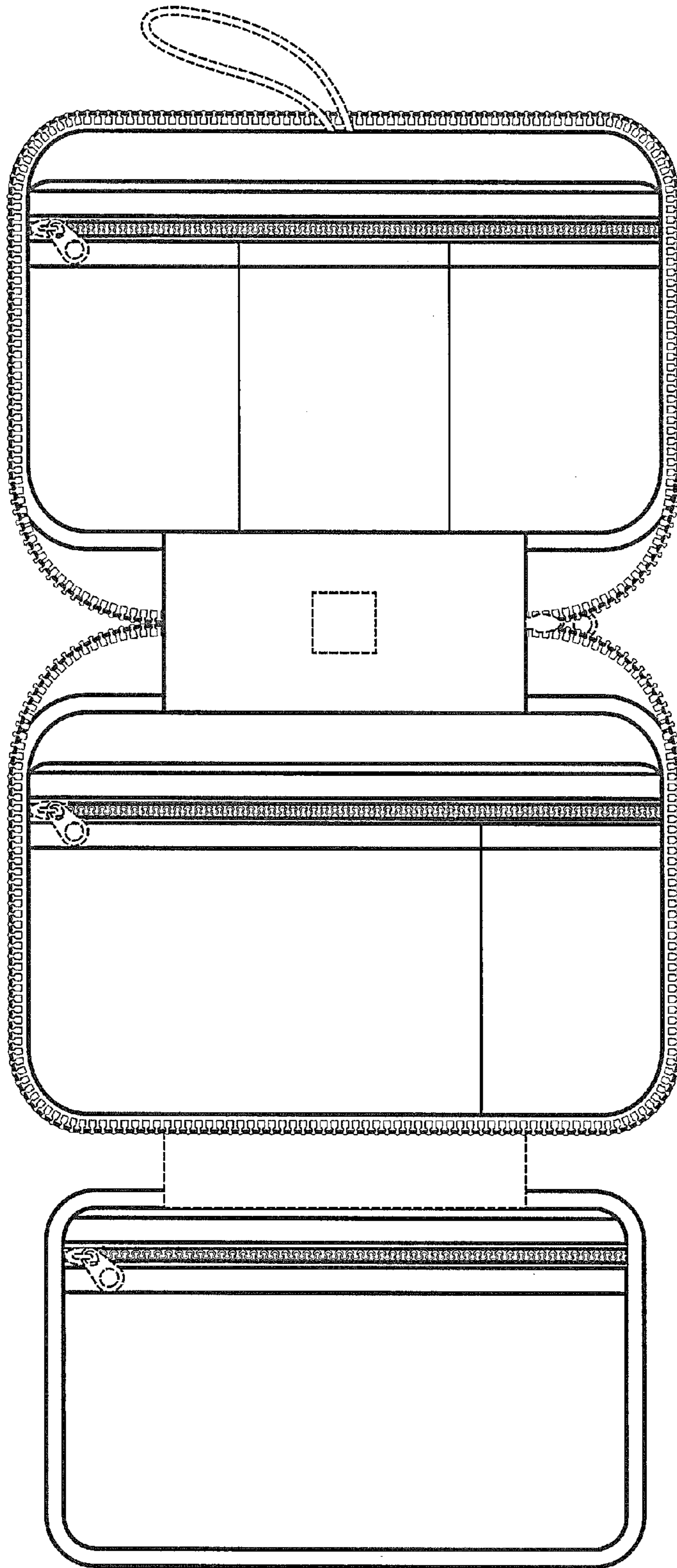

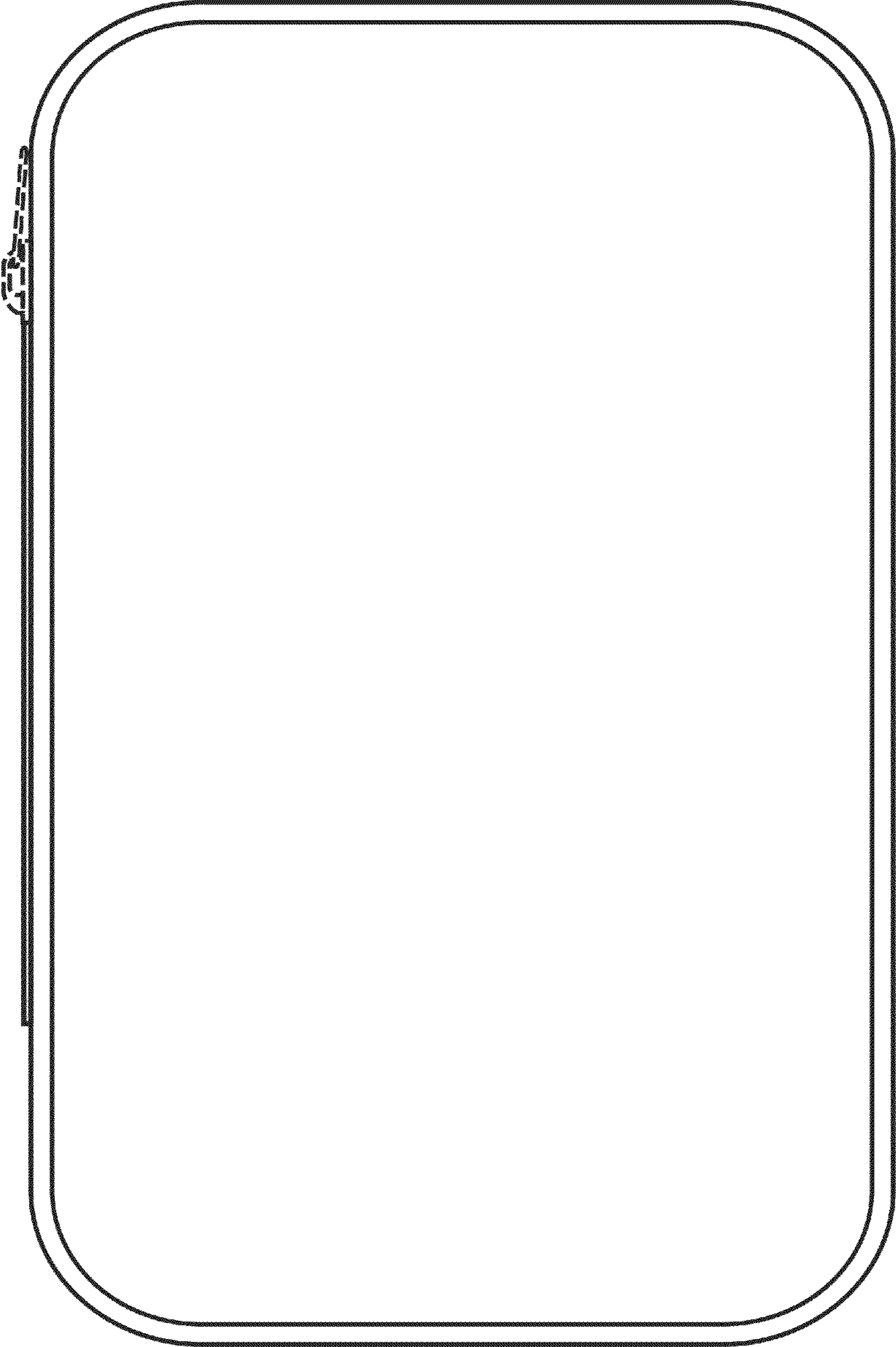

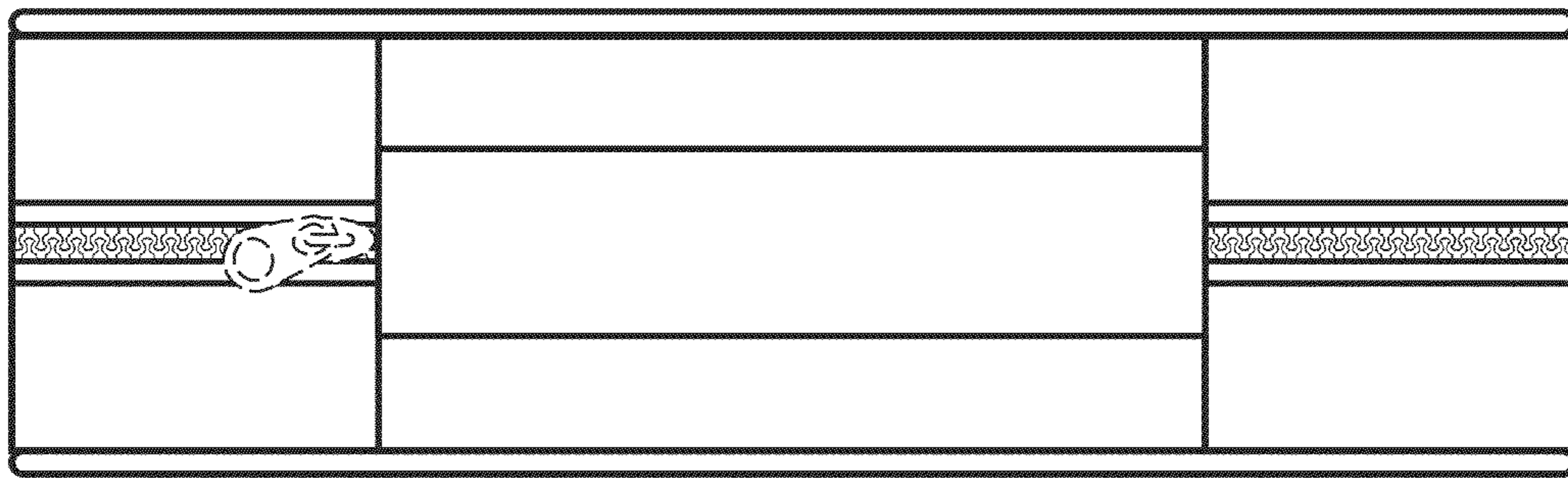

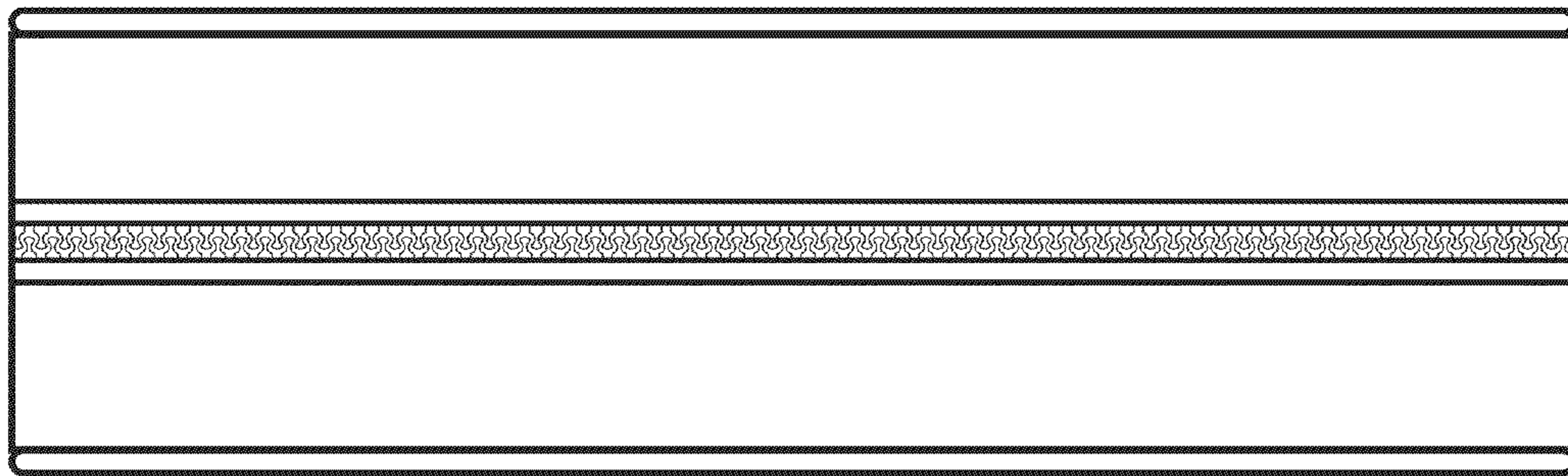
