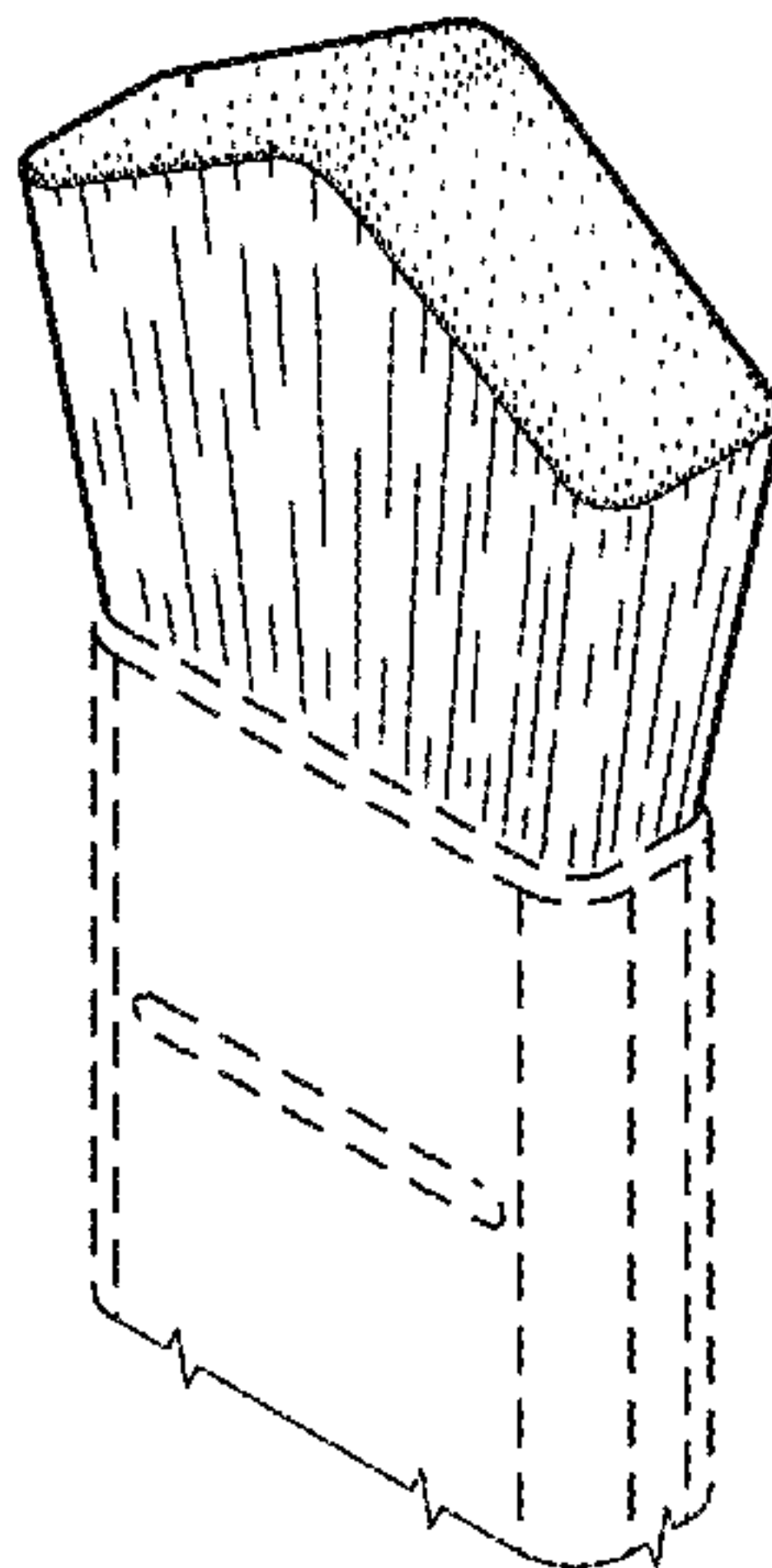
(57) **CLAIM**

The ornamental design for a polyhedral brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a polyhedral brush;  
 FIG. 2 is a front elevation view of the polyhedral brush of FIG. 1, the back elevation view being identical to the front elevation view;  
 FIG. 3 is a left-side elevation view of the polyhedral brush of FIG. 1, the right-side elevation view being identical to the left-side elevation view;  
 FIG. 4 is a top plan view of the polyhedral brush of FIG. 1; and,  
 FIG. 5 is a bottom plan view of the polyhedral brush of FIG. 1.  
 The broken lines are directed to unclaimed portions and form no part of the claimed design.

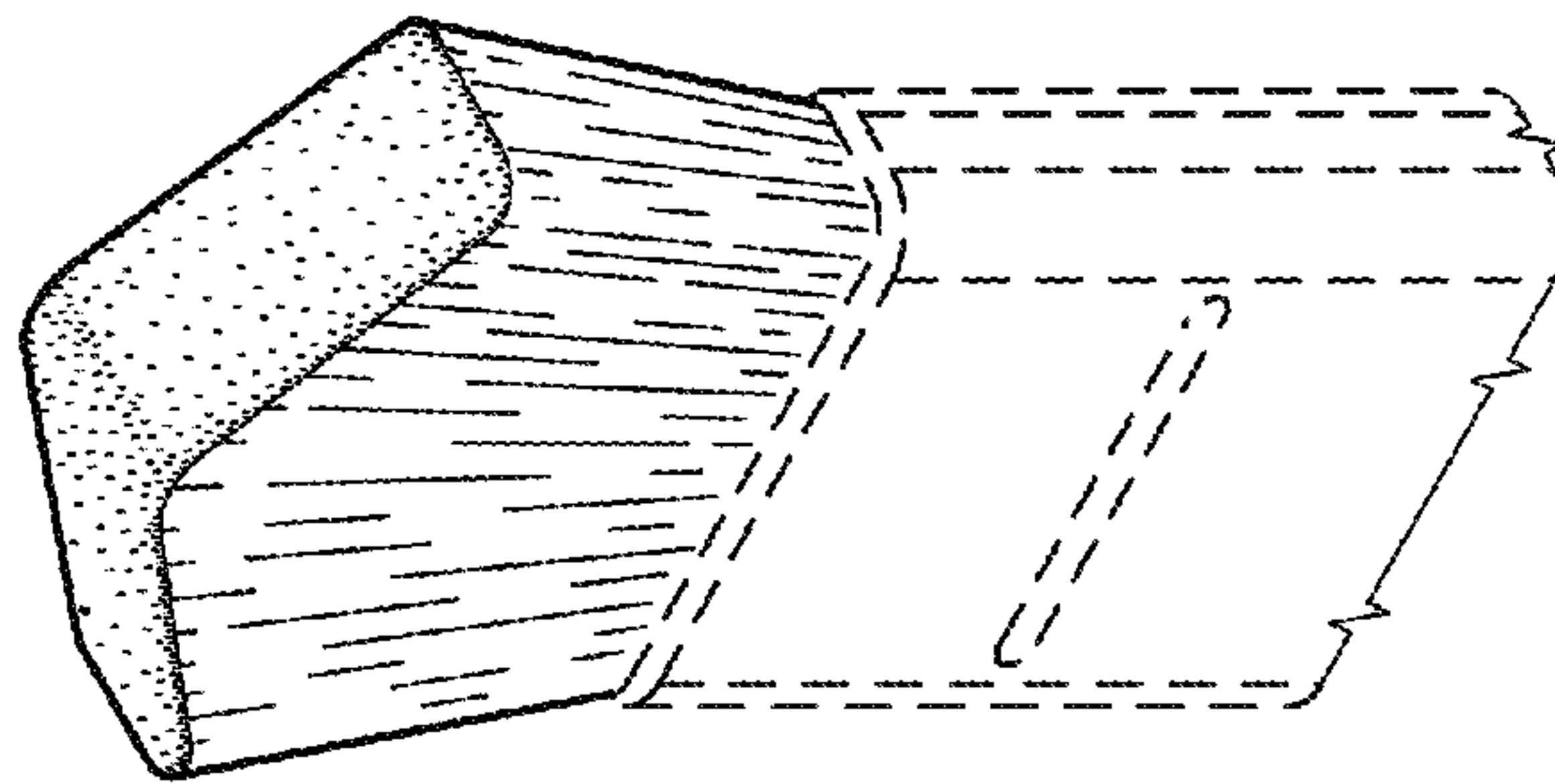

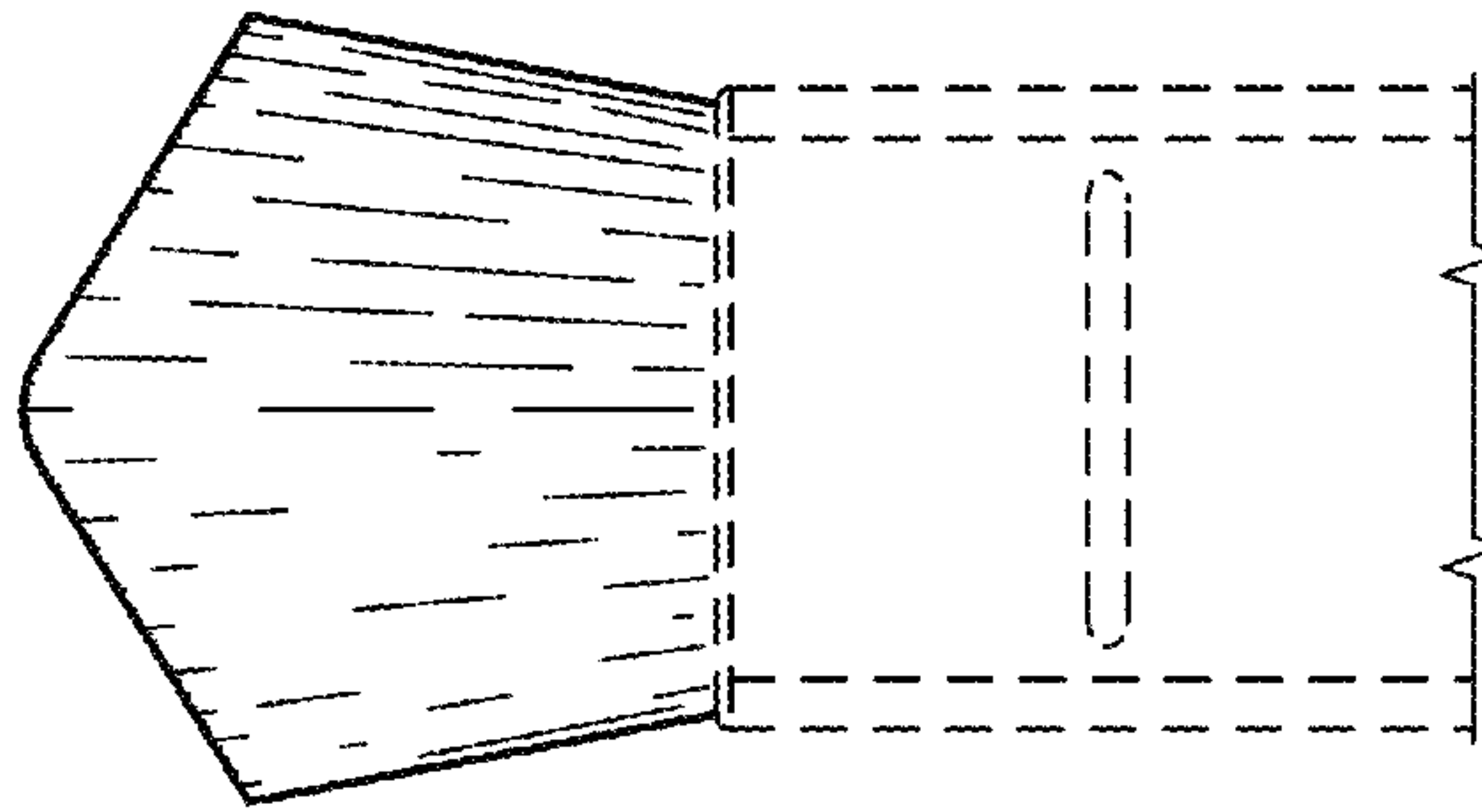

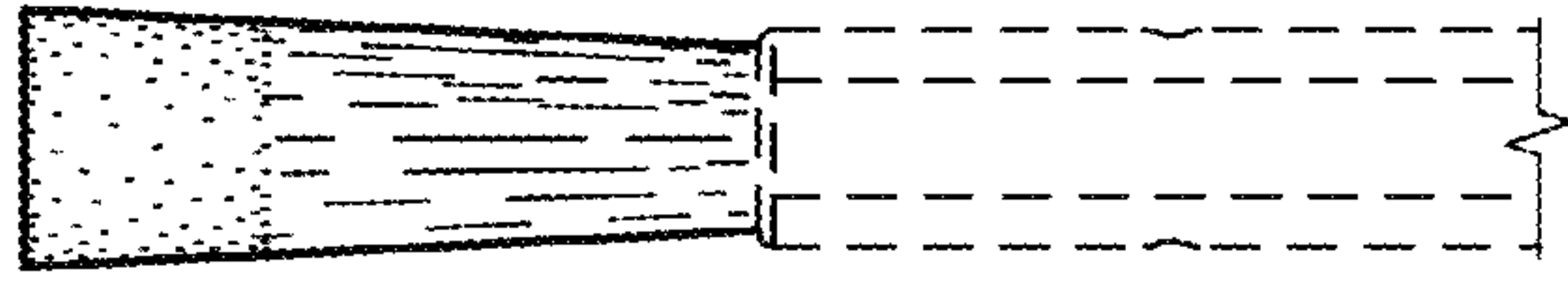

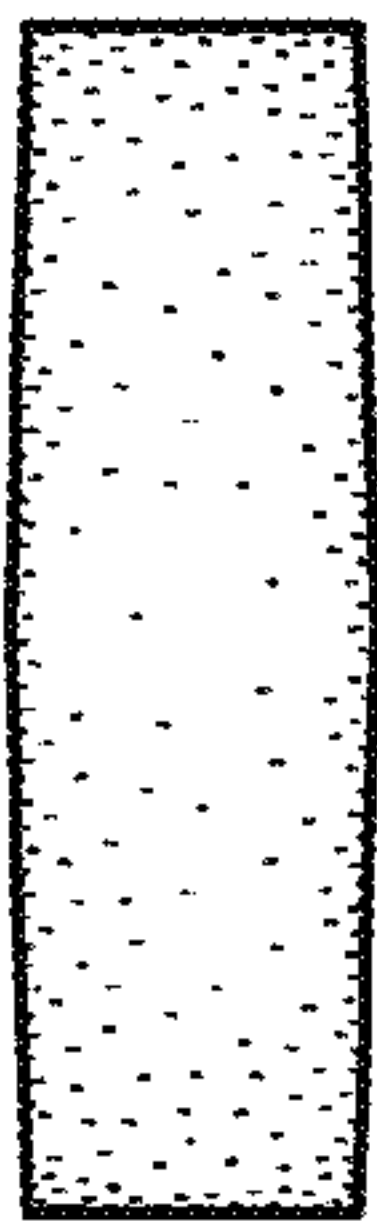

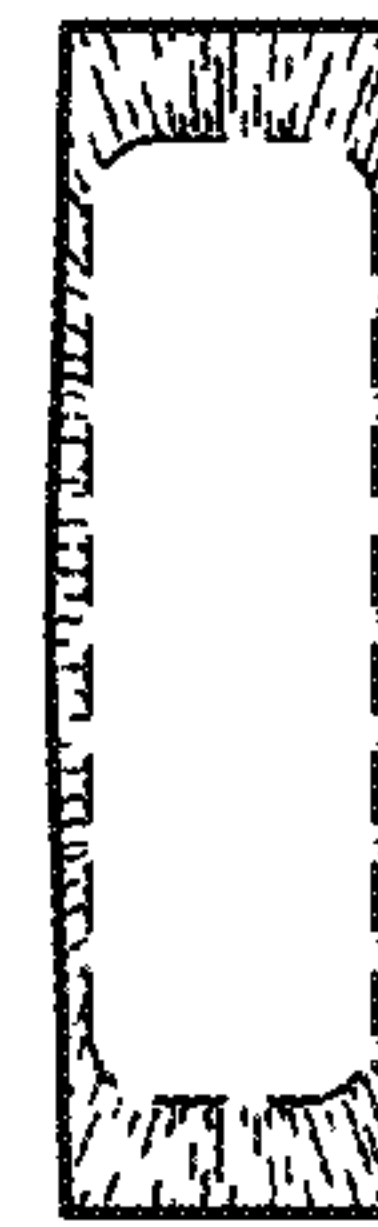
