FIG. 3 is a rear view.

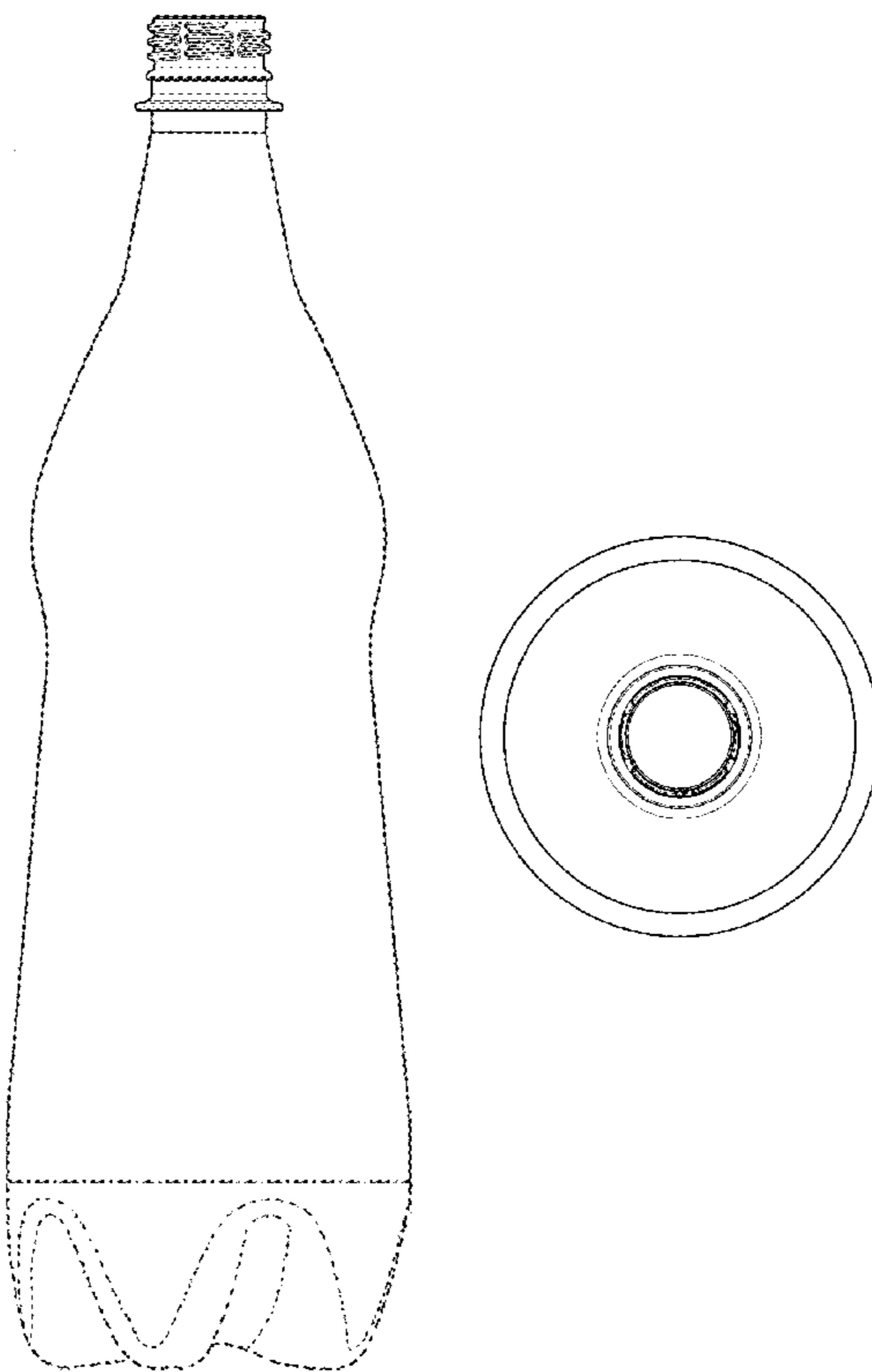
FIG. 4 is a left side view.

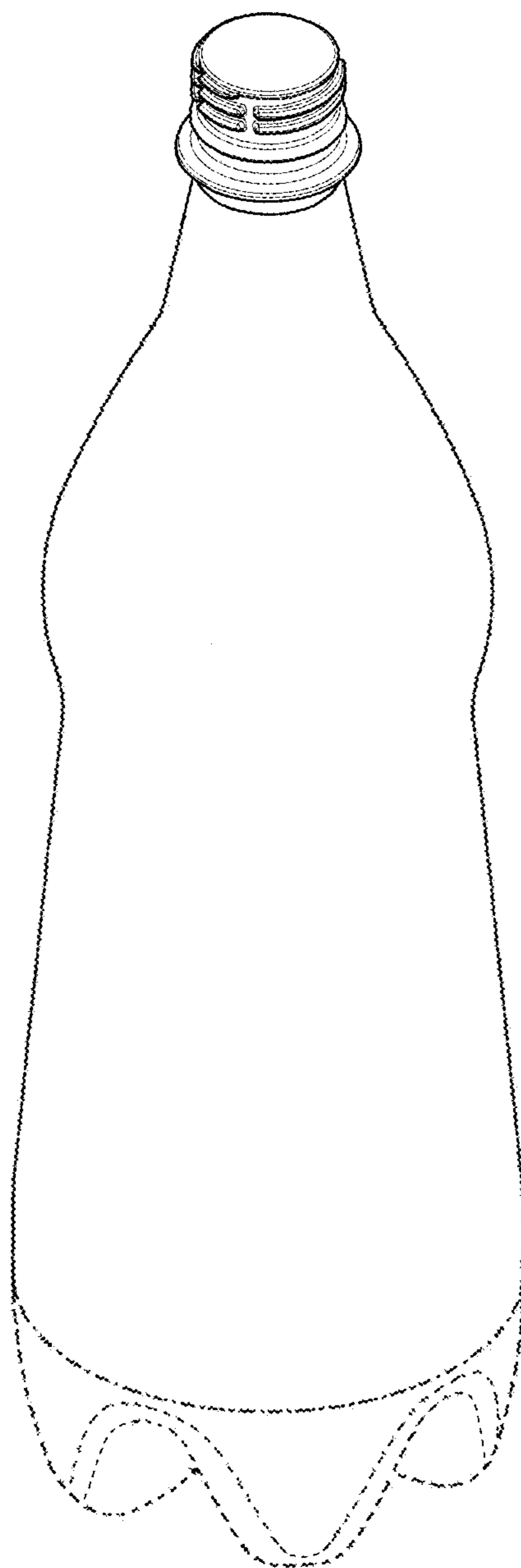

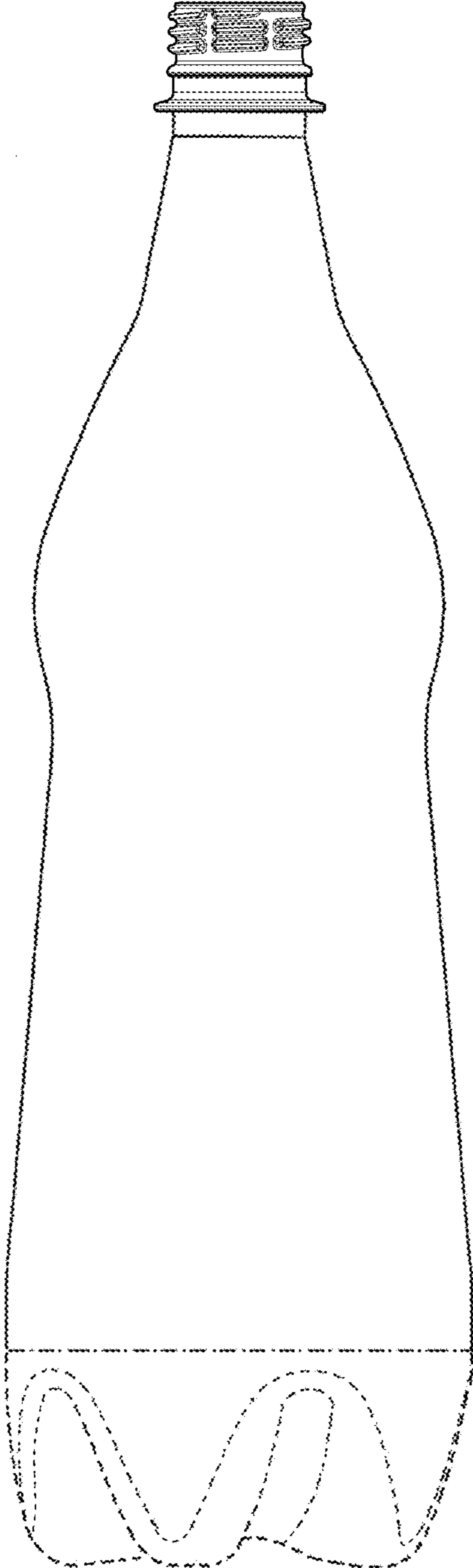

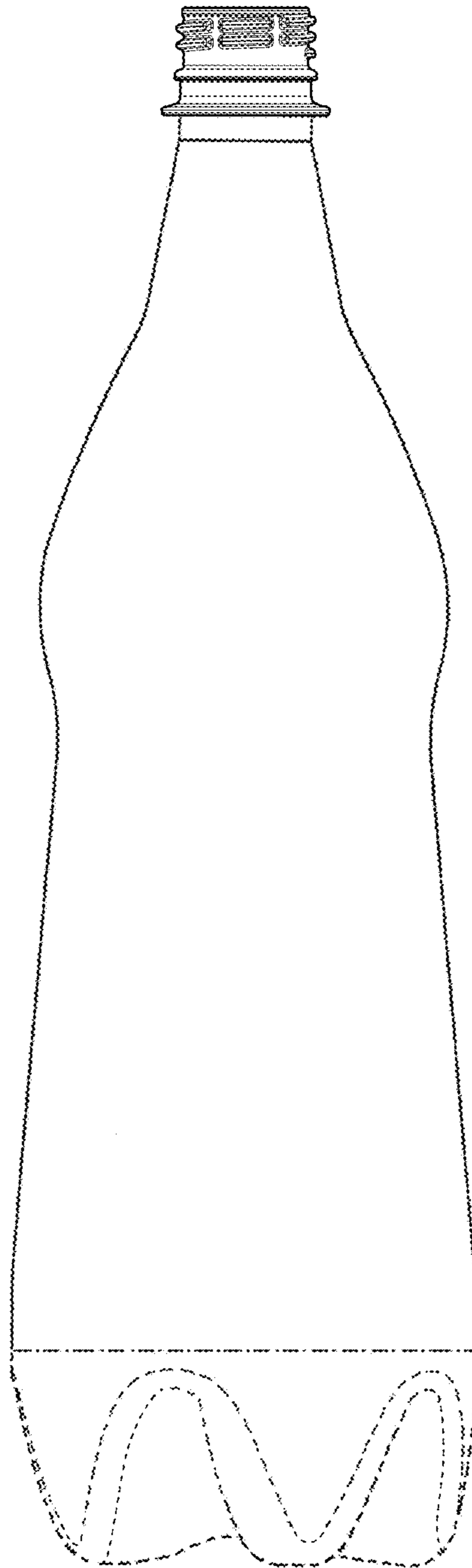

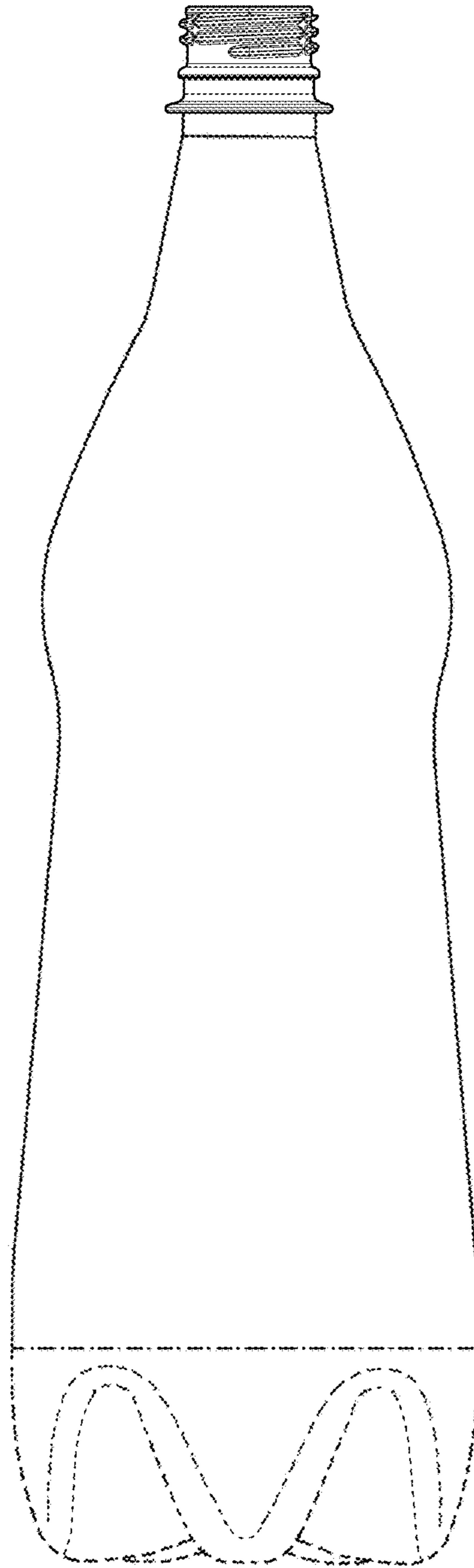

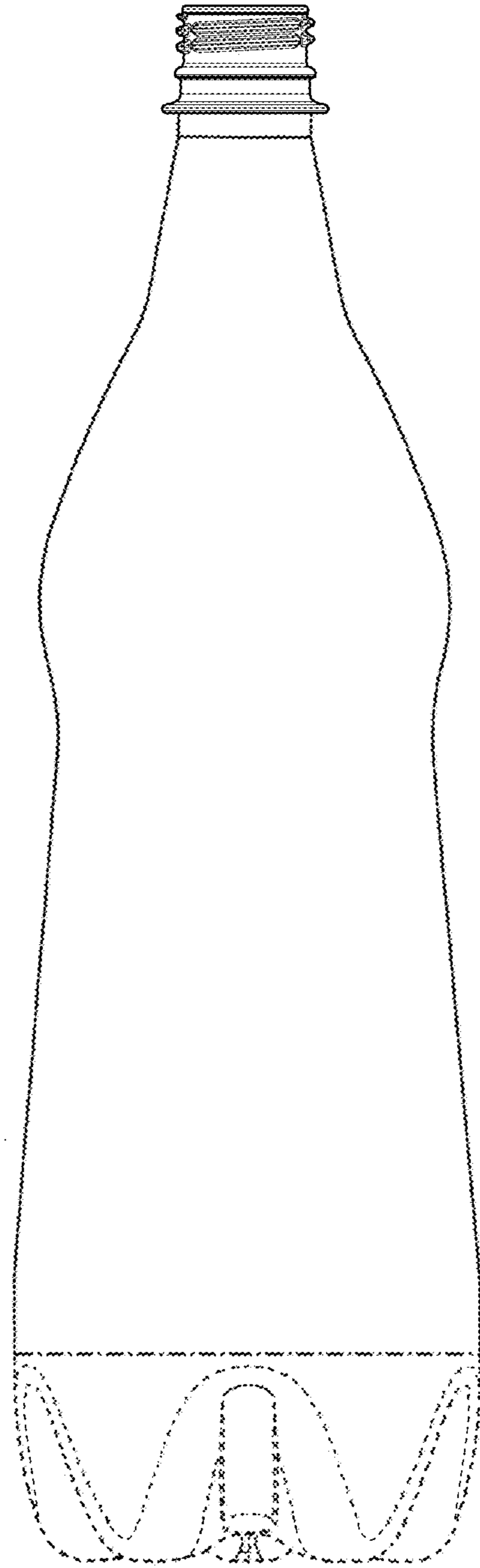

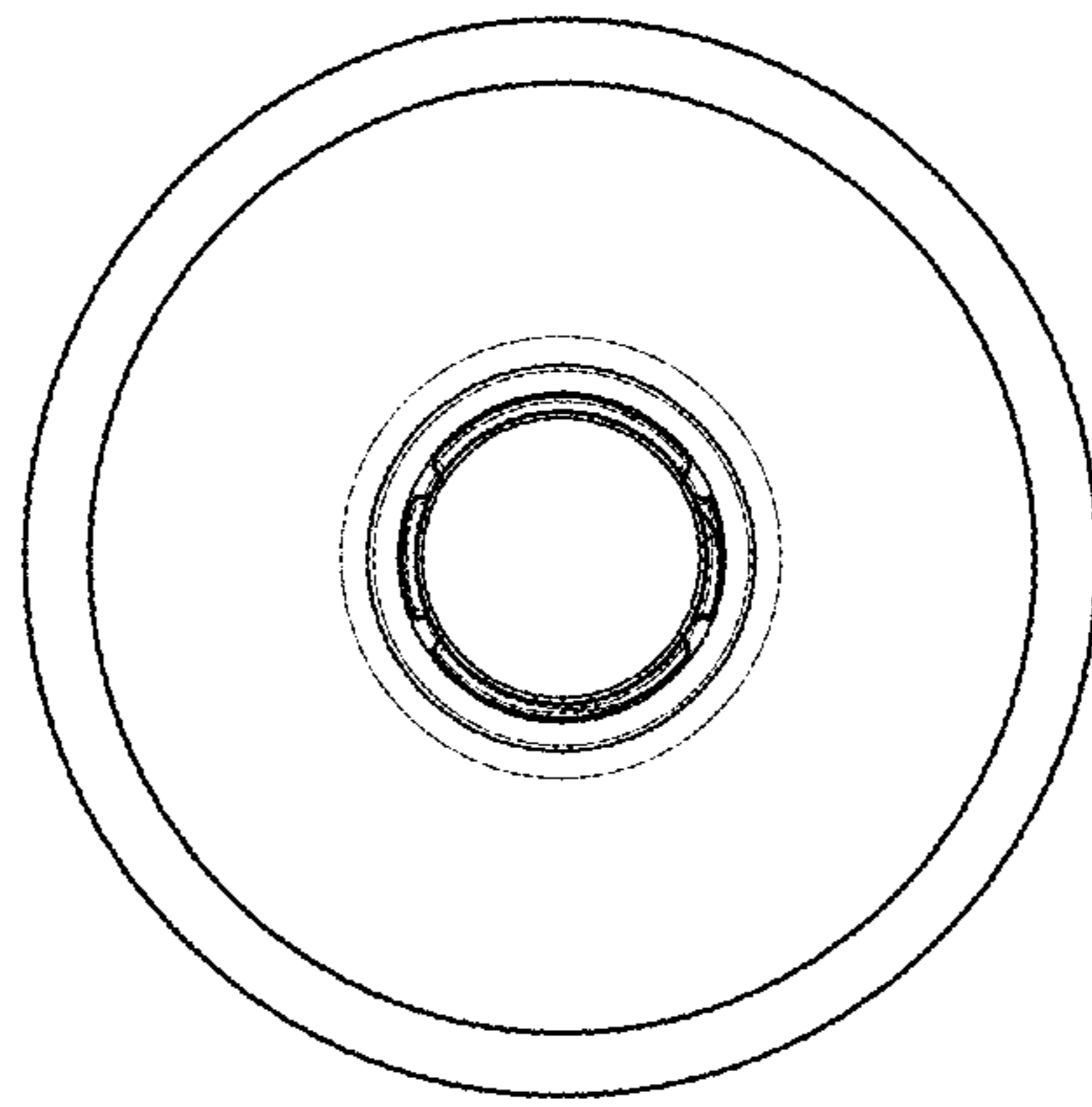
