The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, right, front perspective view of a bottle embodying my new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image of the front view shown except for the unclaimed threads;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

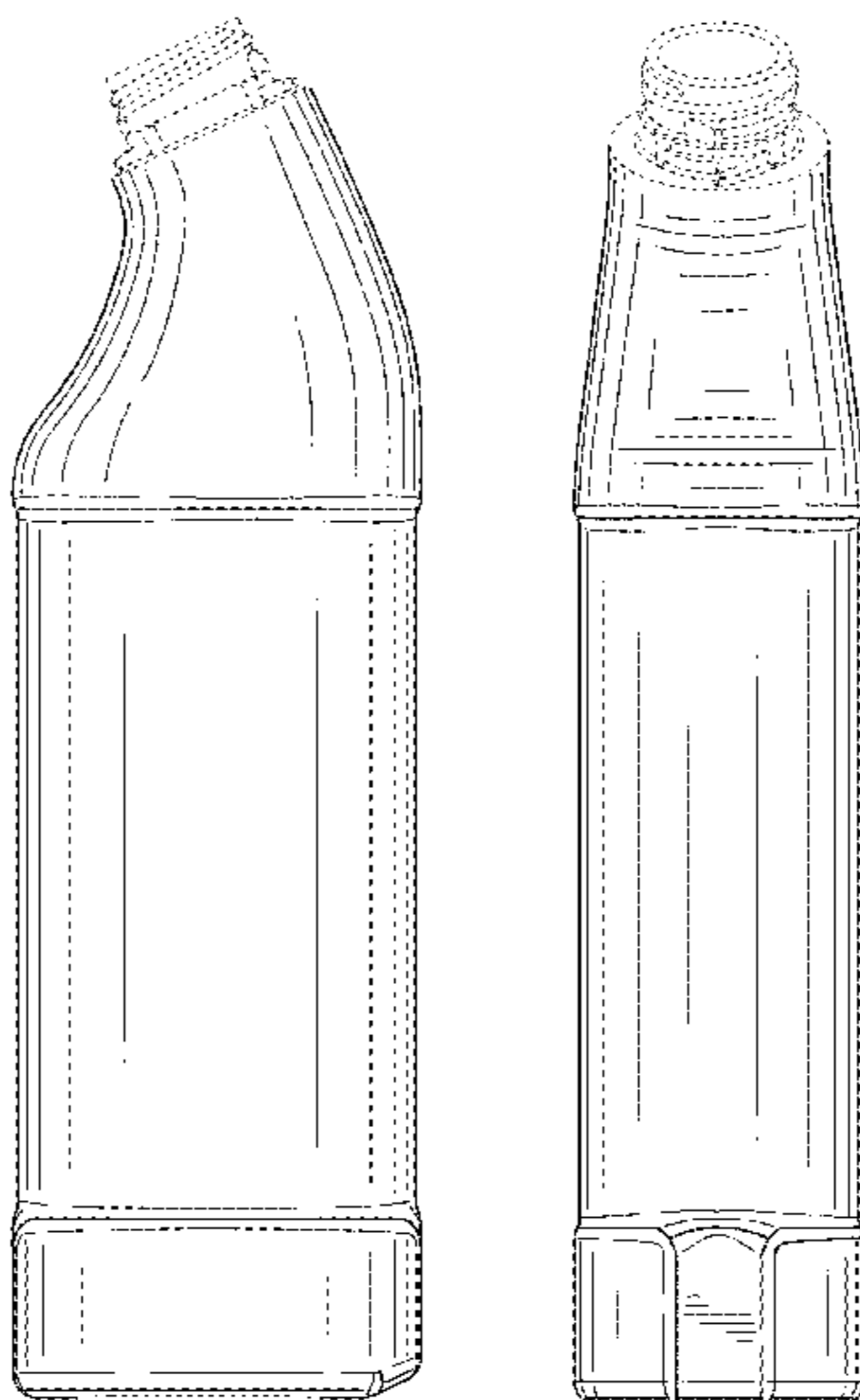
FIG. 5 is a top plan view thereof; and,

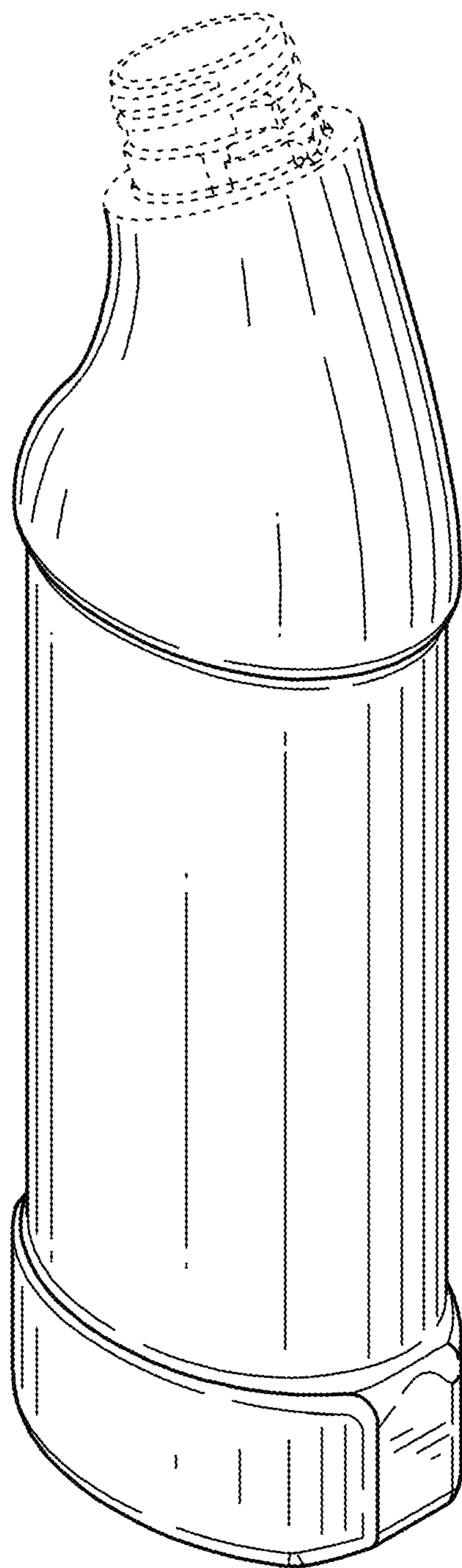
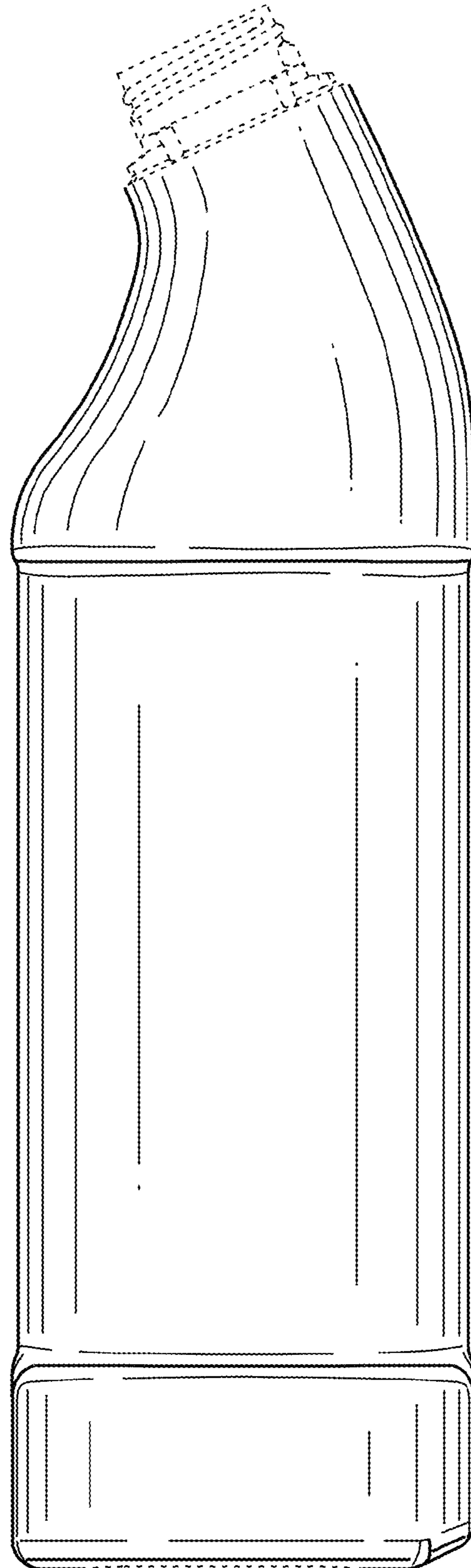

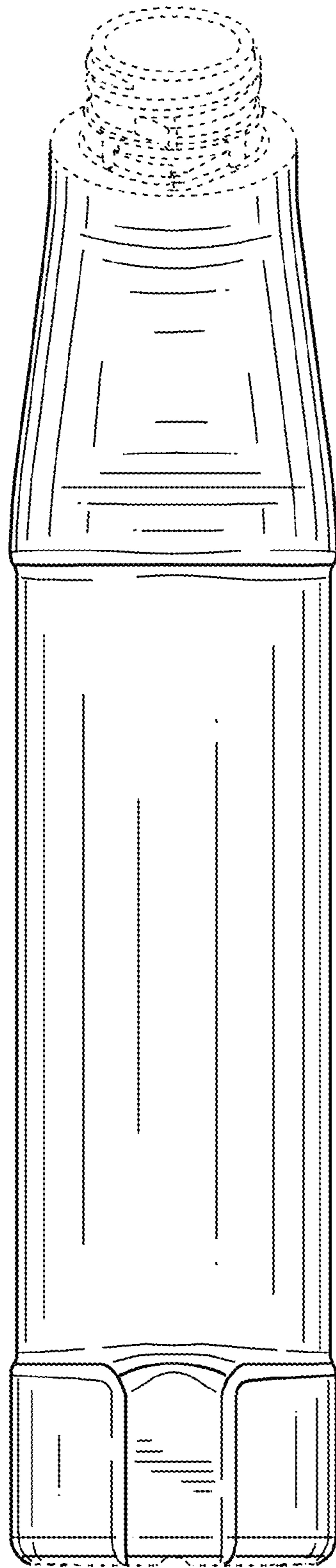

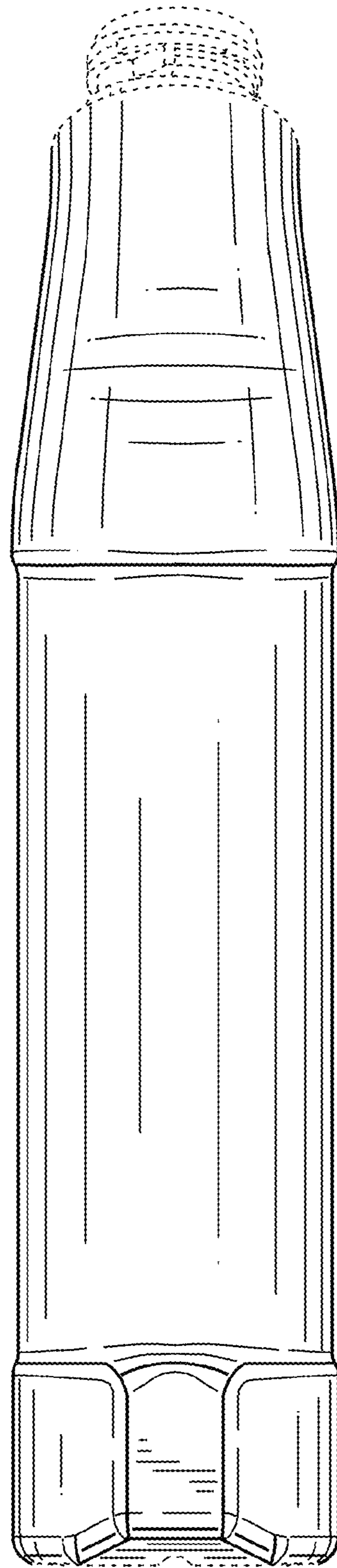

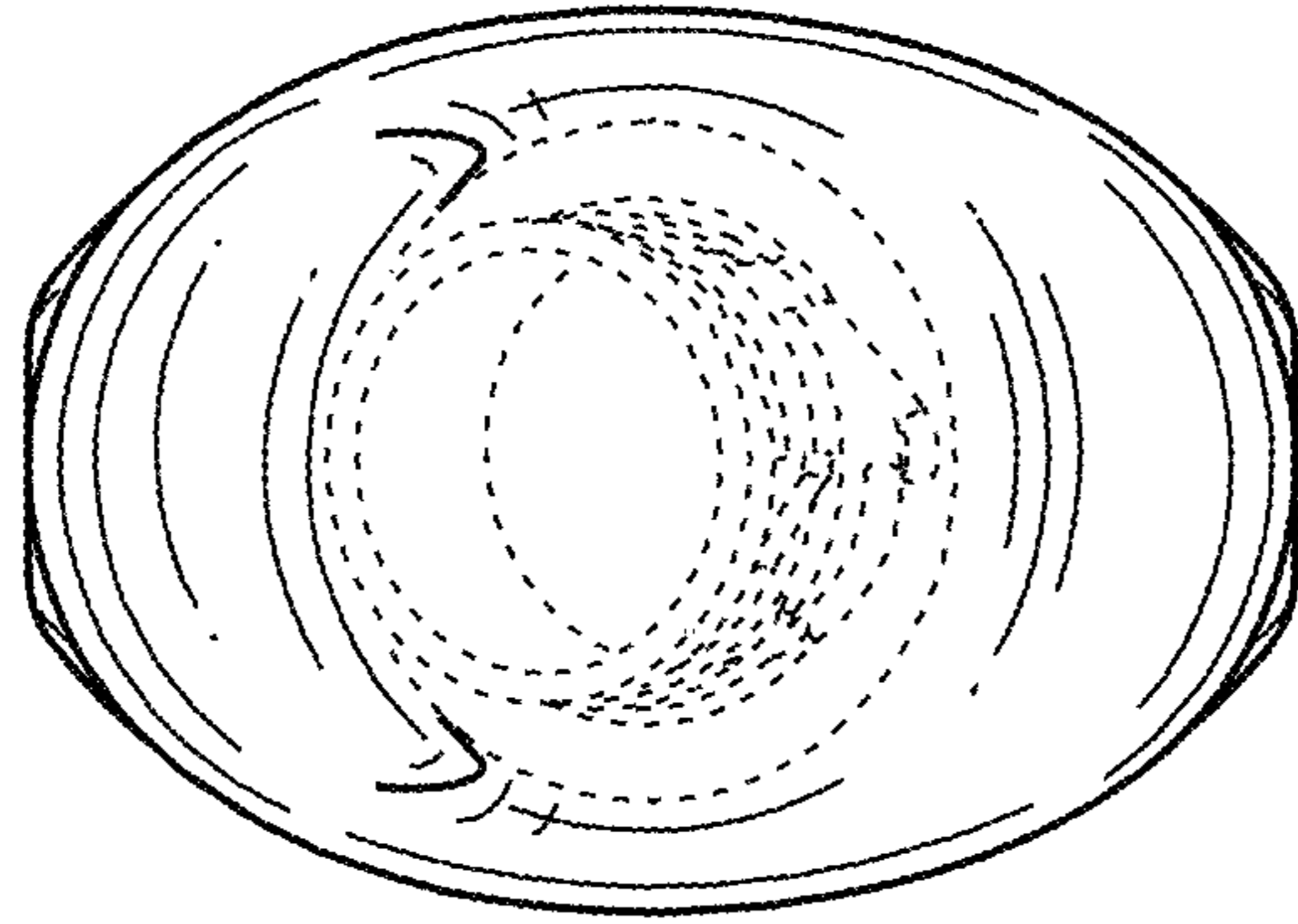

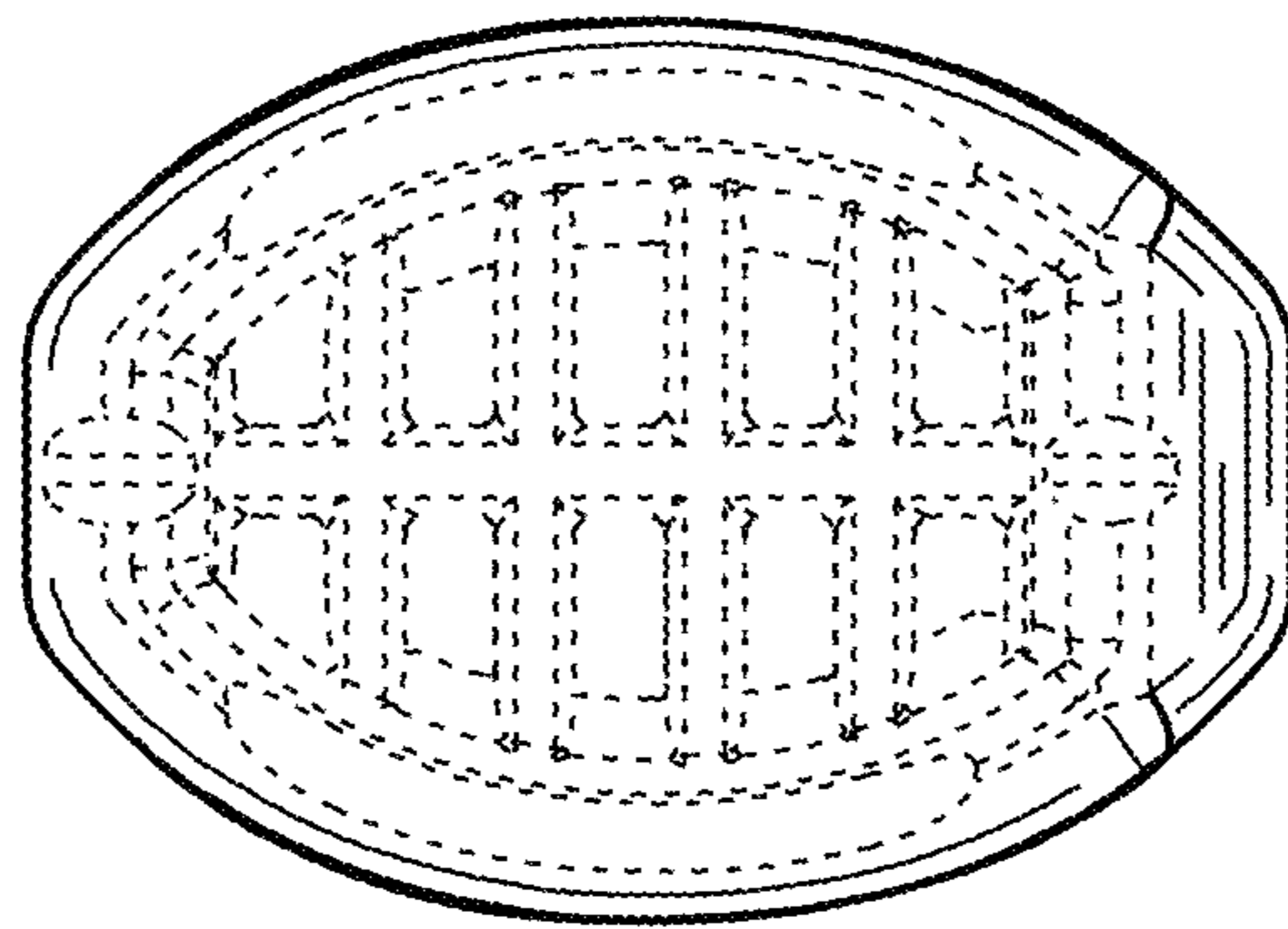
