DESCRIPTION

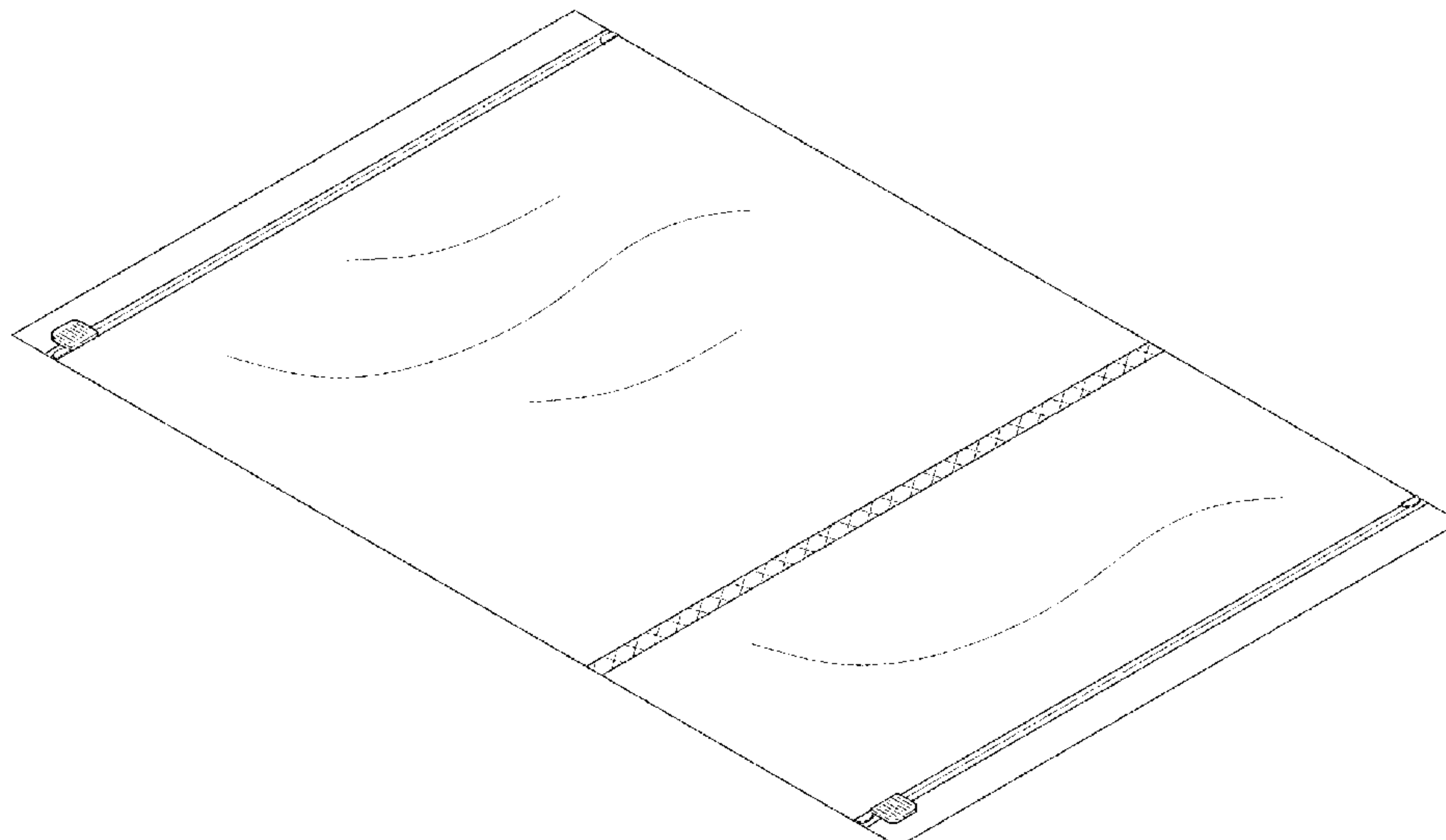
FIG. 1 is a perspective view of a container bag with multiple sealable locks showing my new design.

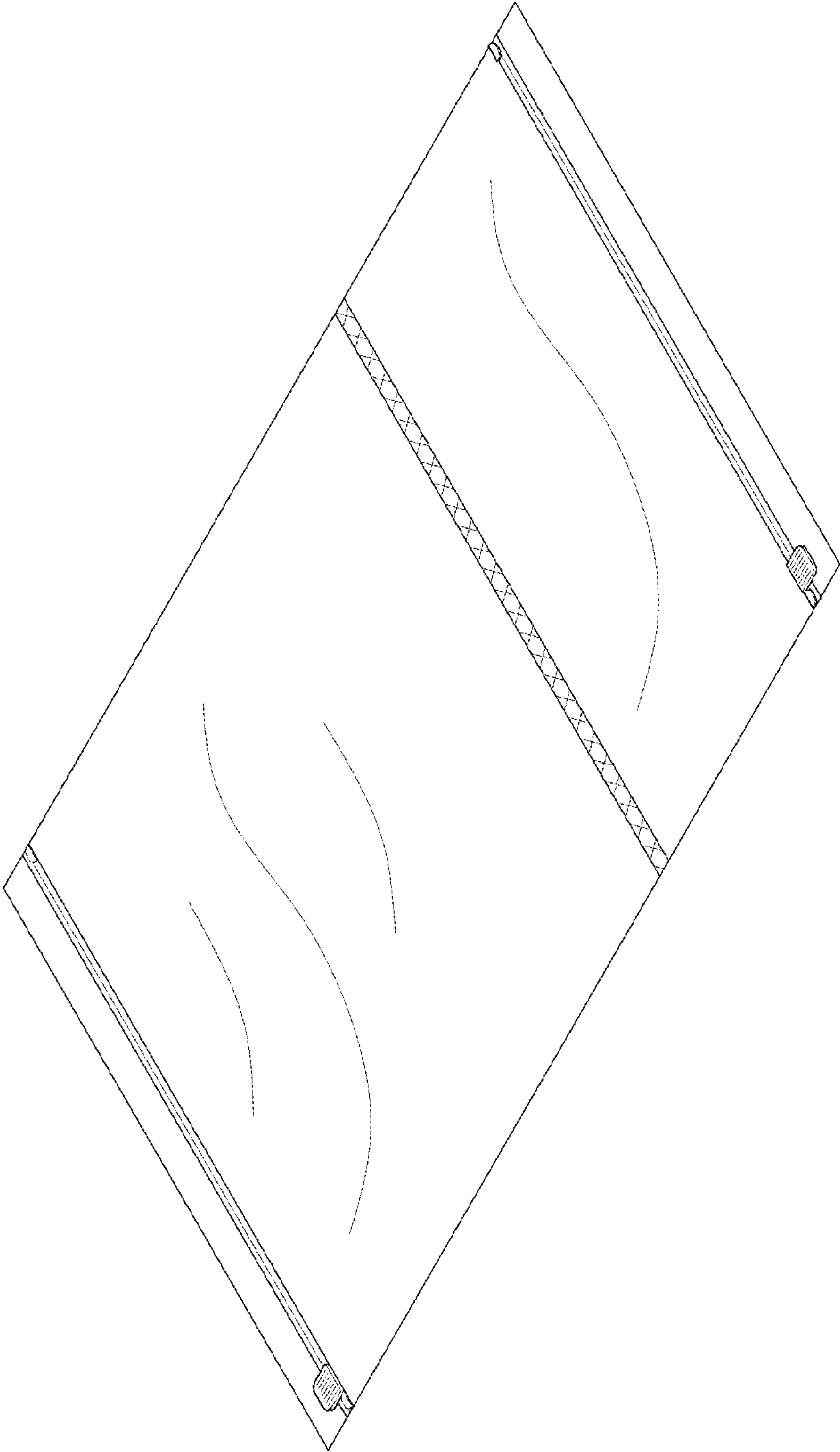

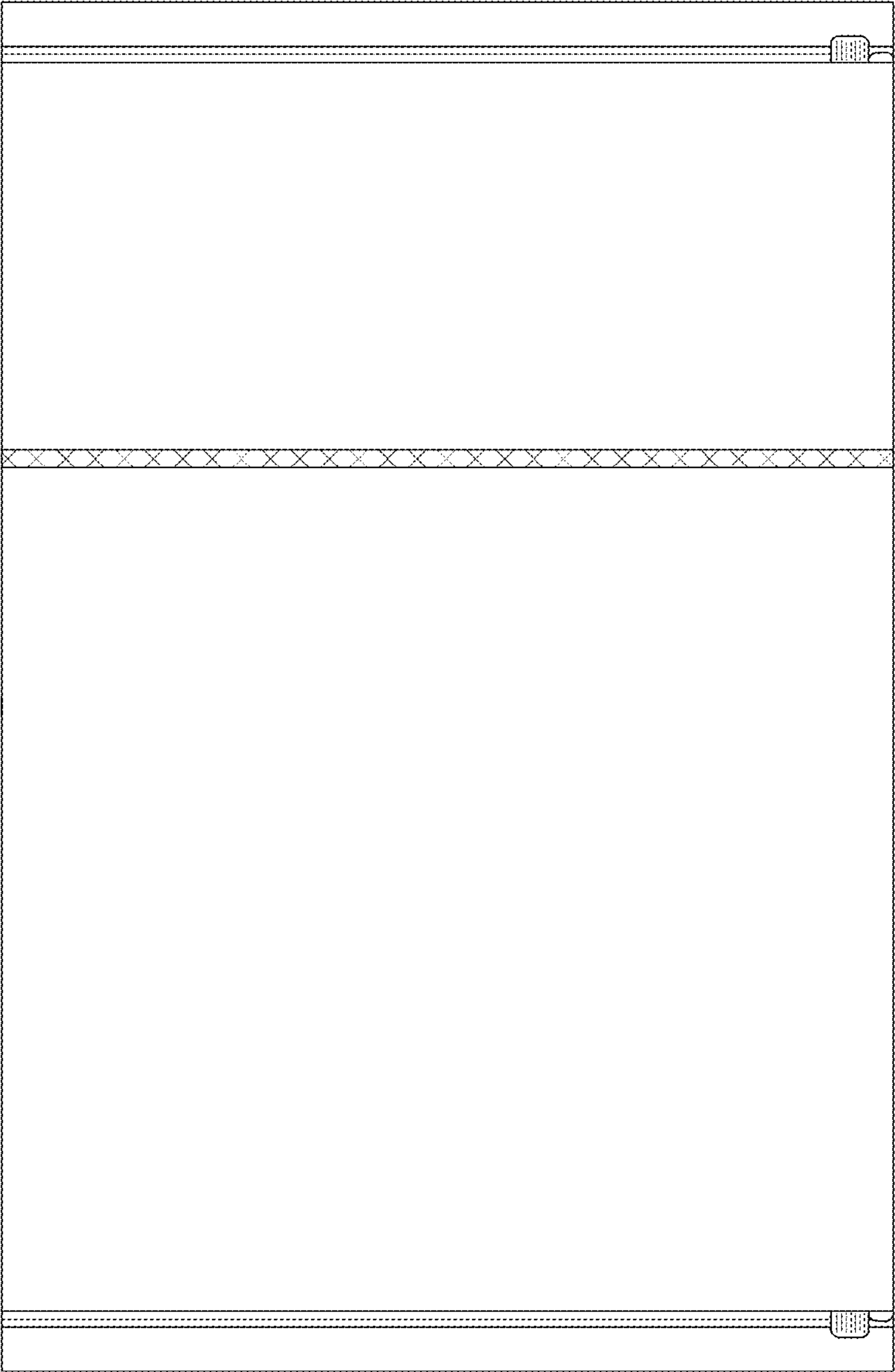

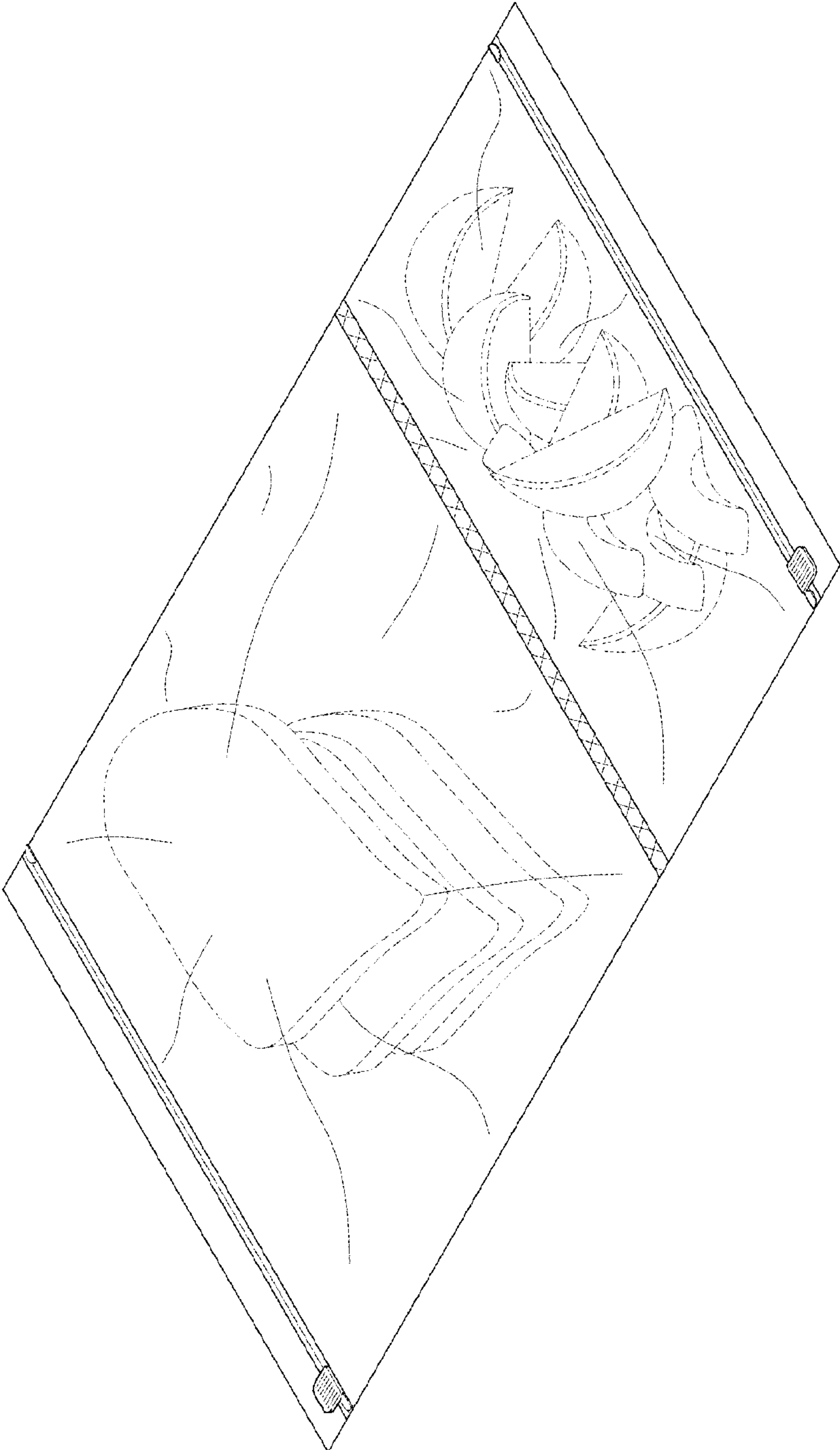
