(57) **CLAIM**

The ornamental design for a tray with finger pockets, shown and described.

DESCRIPTION

FIG. 16 is a cross-sectional elevation view along line 16-16 shown in FIG. 11;




FIG. 17 is a top perspective view of a third embodiment for a tray with finger pockets showing our new design;






















































































































































