(57) **CLAIM**

The ornamental design for a carton, as shown and described.

DESCRIPTION

FIG. 1 is a top front right perspective view of a carton, showing our new design.

FIG. 2 is a top front right perspective view thereof, in an open condition with the interior thereof facing downwardly.

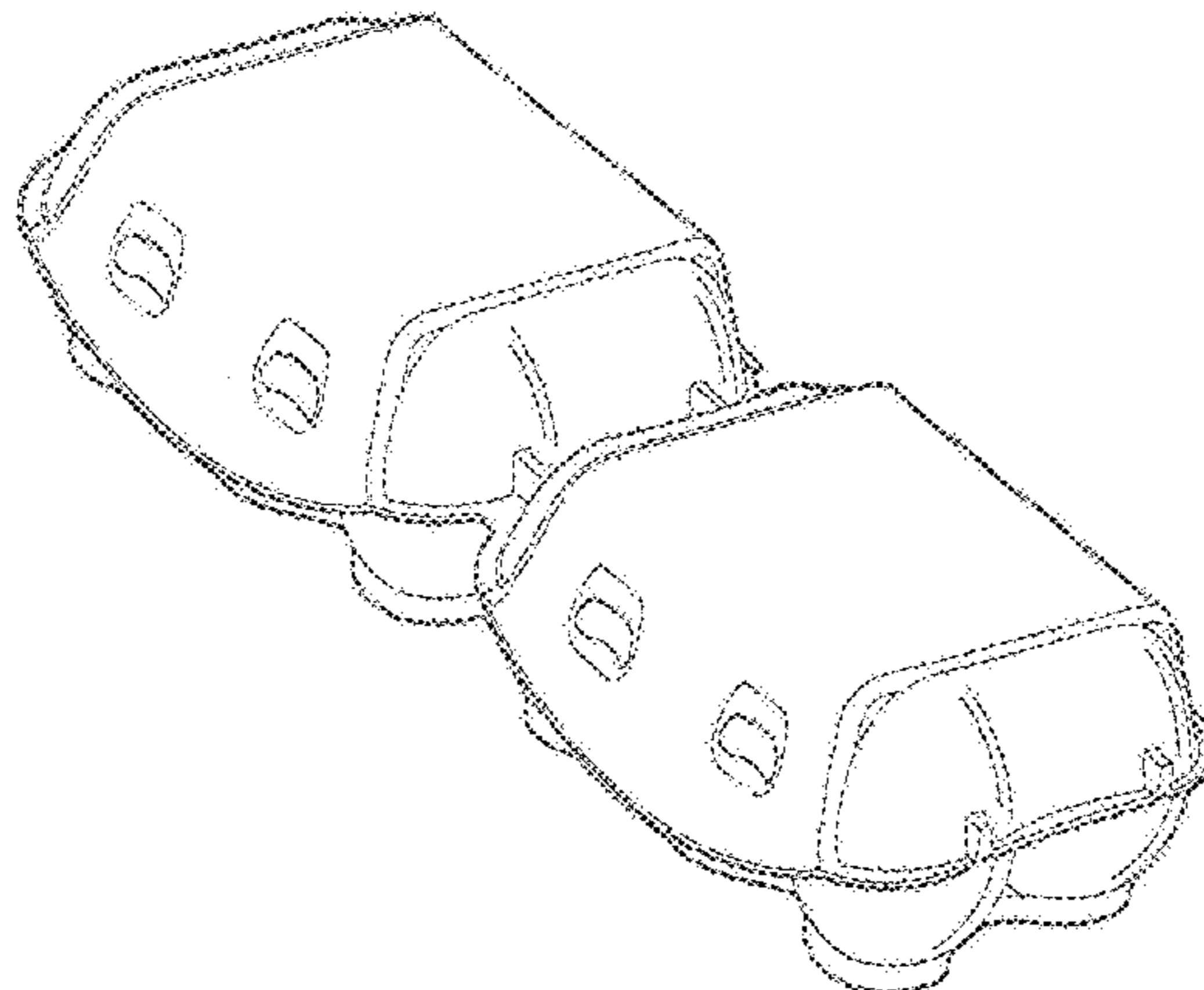
FIG. 3 is a top front left perspective view thereof in an open condition with the interior thereof facing downwardly.

FIG. 4 is a top front right perspective view of a part of FIG. 1. FIG. 5 is a top front right perspective view of only the top part of FIG. 4.

FIG. 6 is a top front right perspective view similar to FIG. 4 with graphics in the form of a label on the top part thereof.

The interior of the carton and the rear edge of the carton form no part of the claimed design.

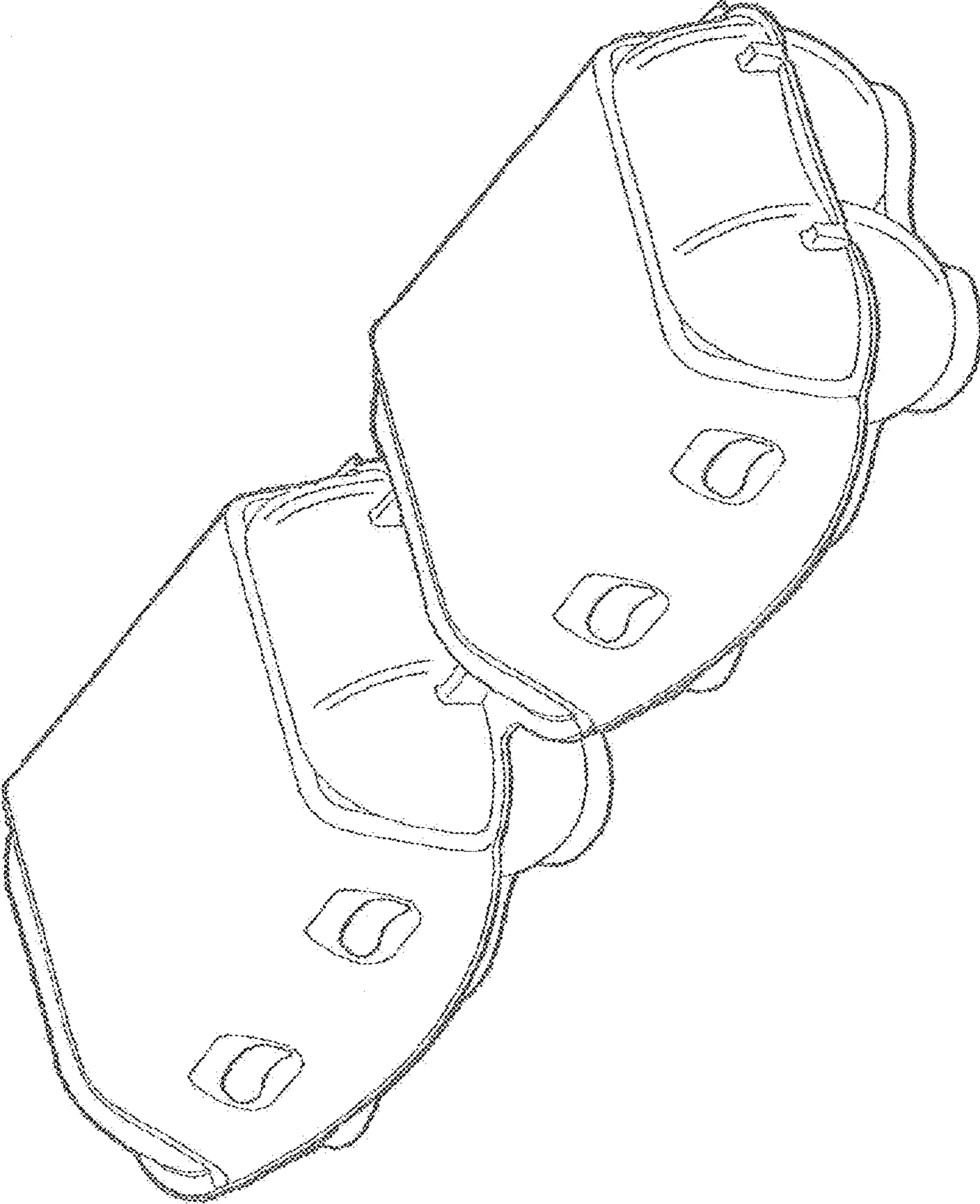

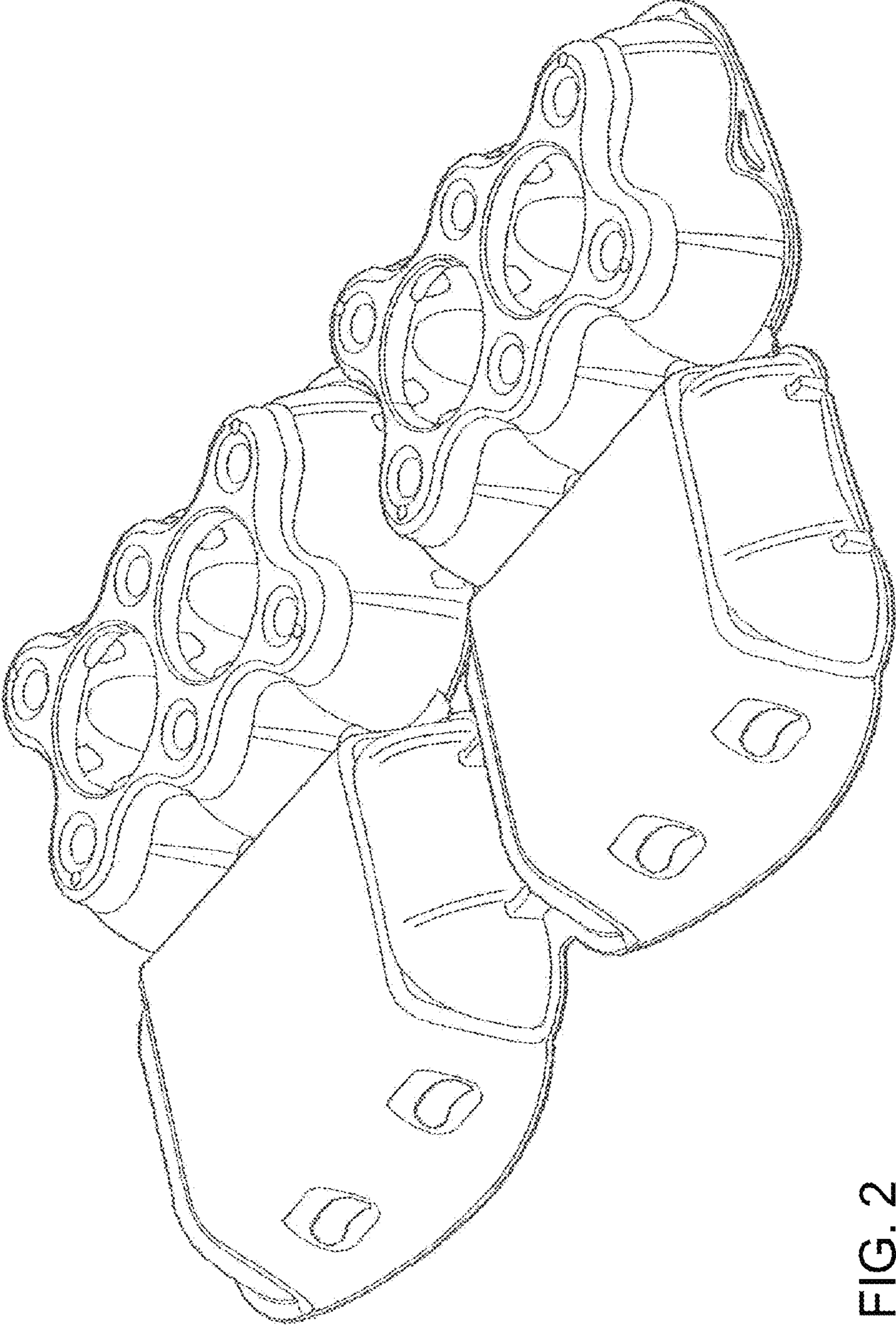

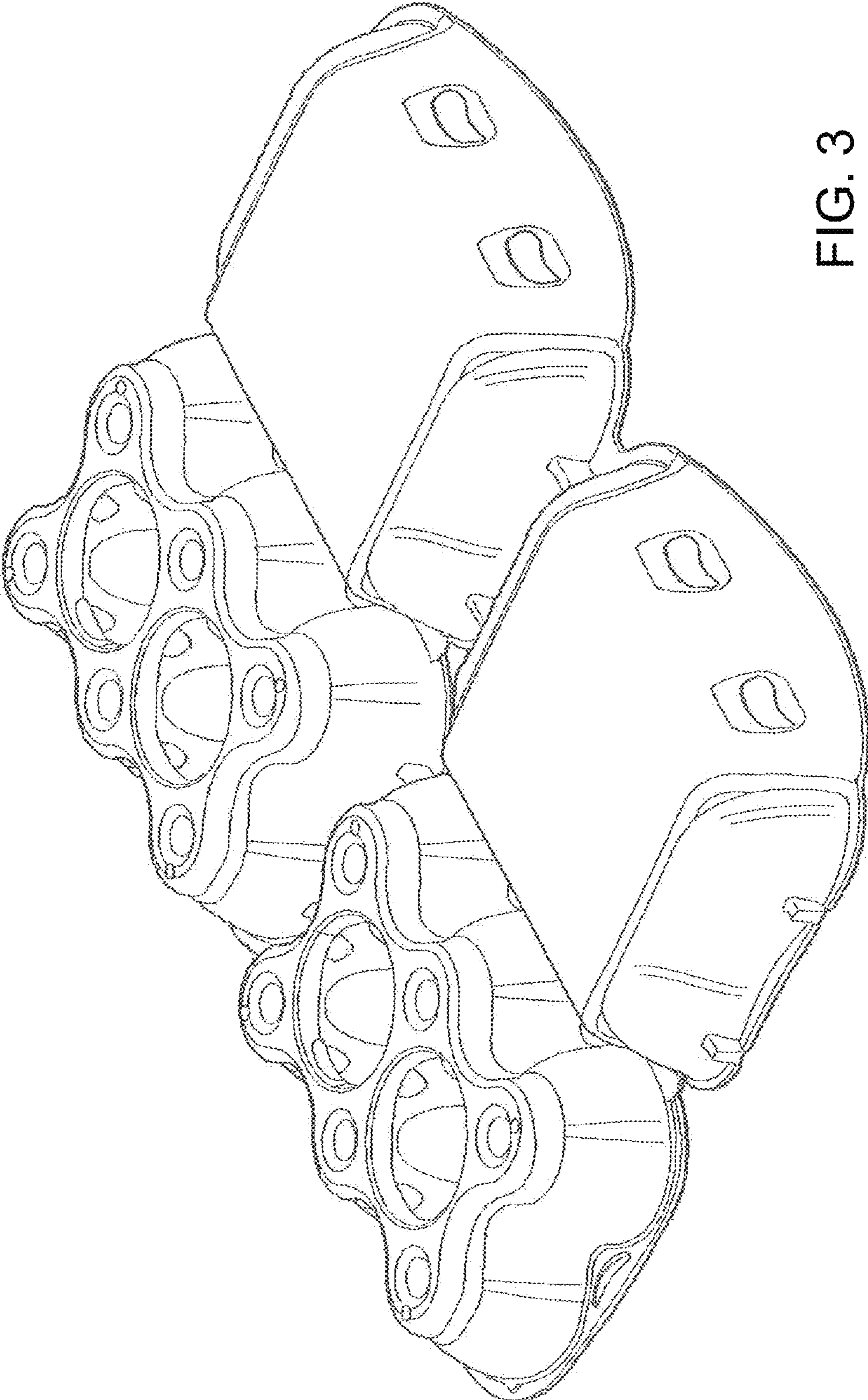

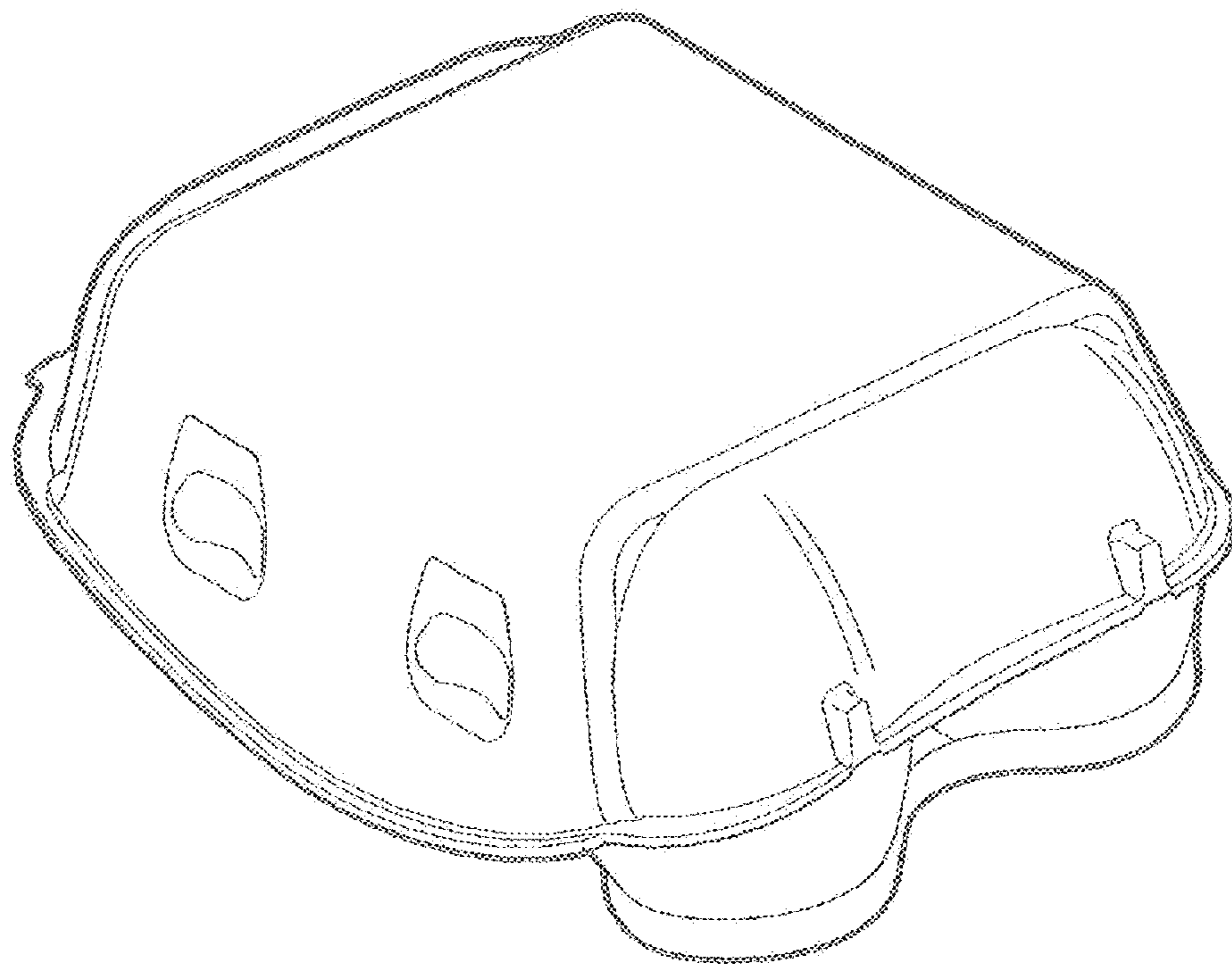

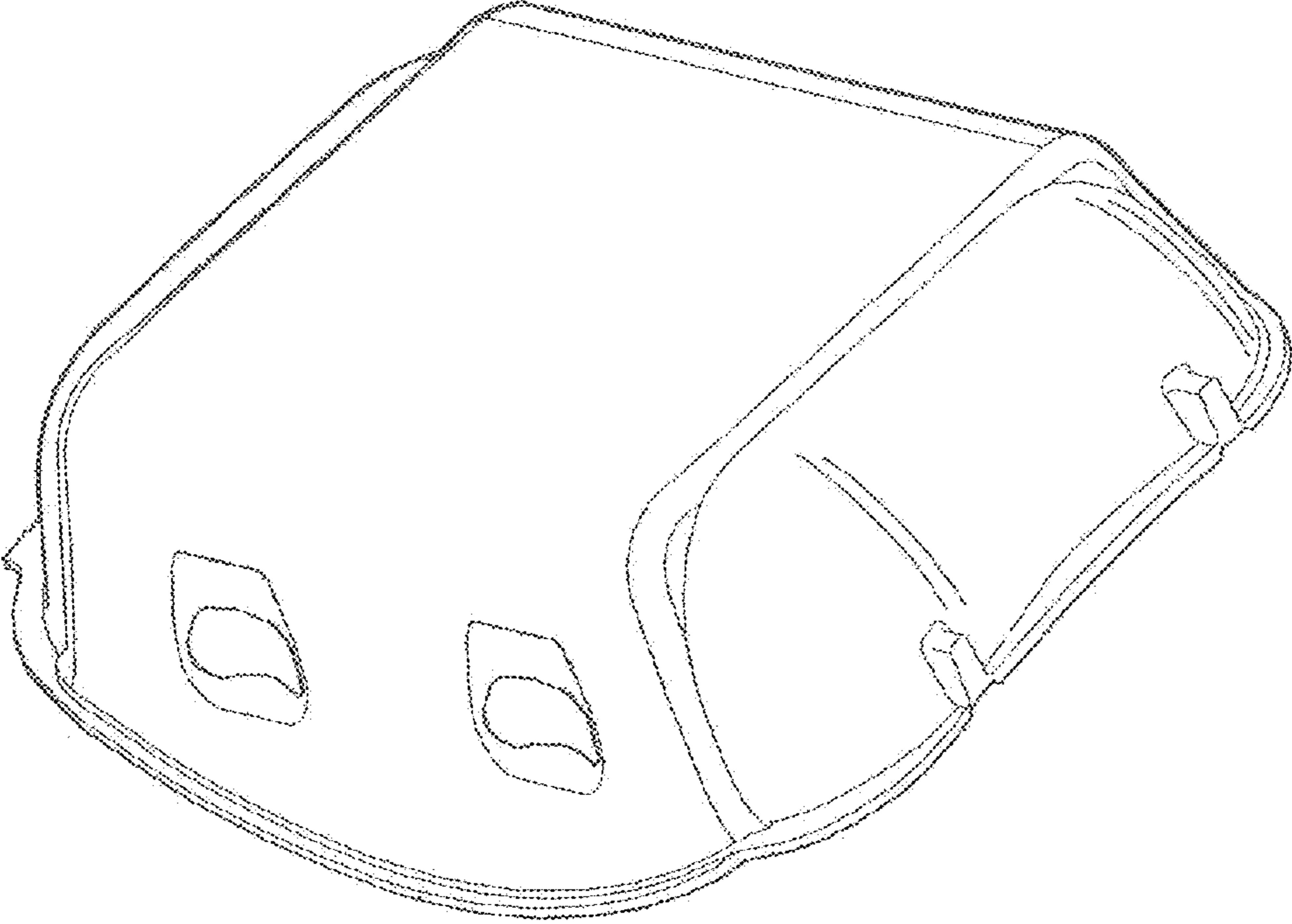

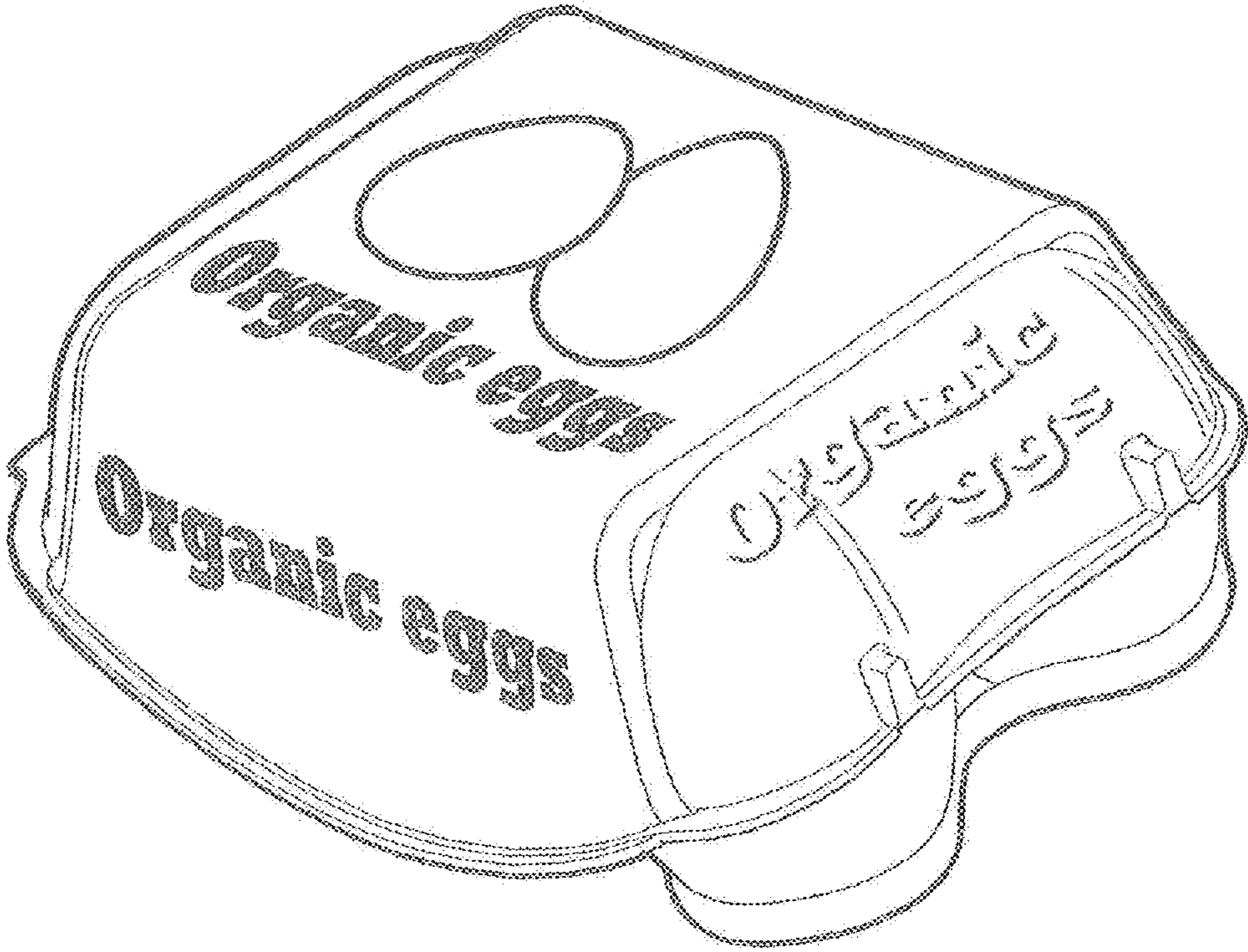
