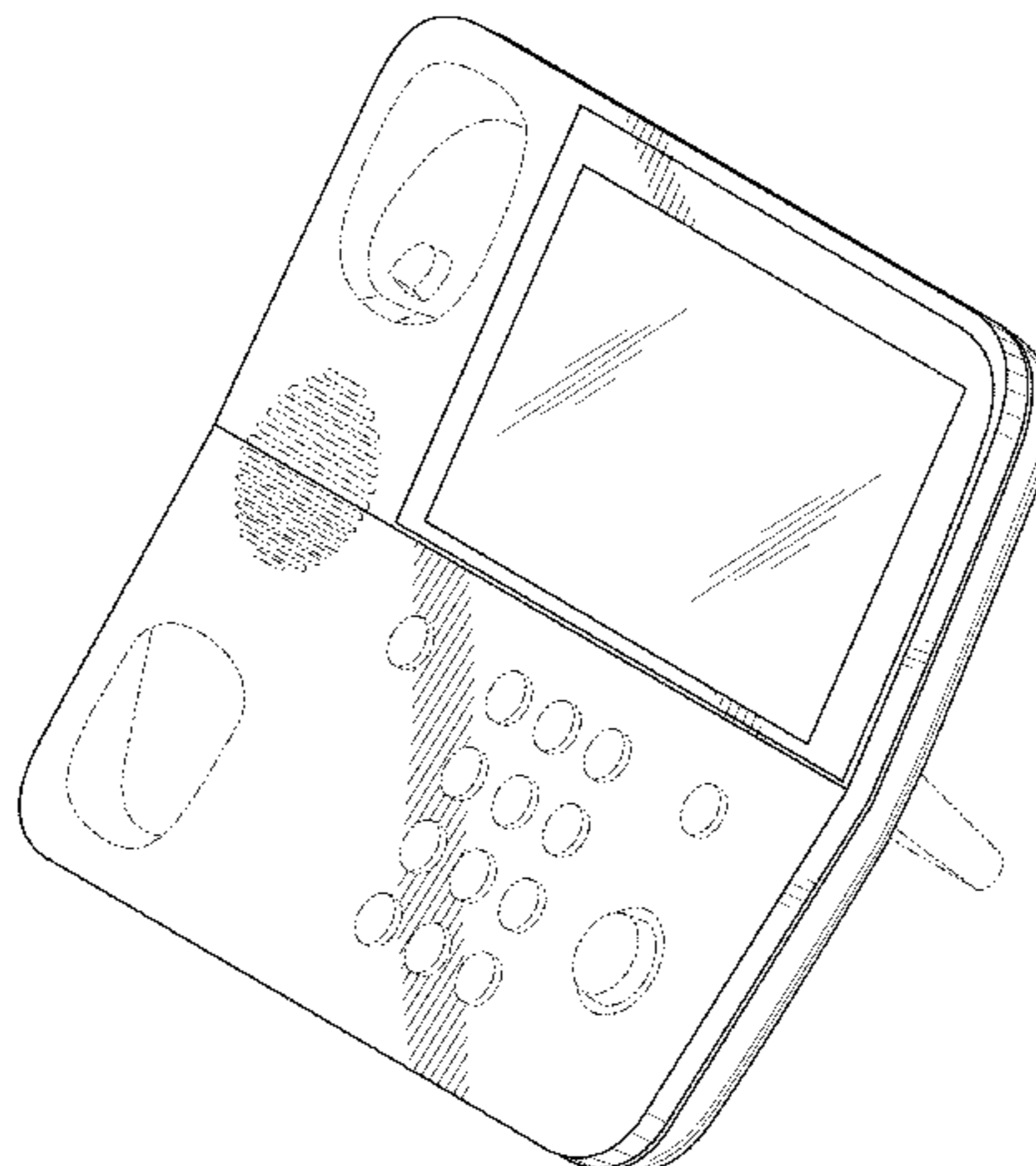
(57) **CLAIM**

The ornamental design for a captioning communication device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a captioning communication device;
FIG. 2 is a front view of the captioning communication device shown in FIG. 1;
FIG. 3 is a rear view of the captioning communication device shown in FIG. 1;
FIG. 4 is a right side view of the captioning communication device shown in FIG. 1;
FIG. 5 is a left side view of the captioning communication device shown in FIG. 1;
FIG. 6 is a top view of the captioning communication device shown in FIG. 1; and,
FIG. 7 is a bottom view of the captioning communication device shown in FIG. 1.
The broken lines in FIGS. 1-7 depict parts of the captioning communication device that form no part of the claimed design.

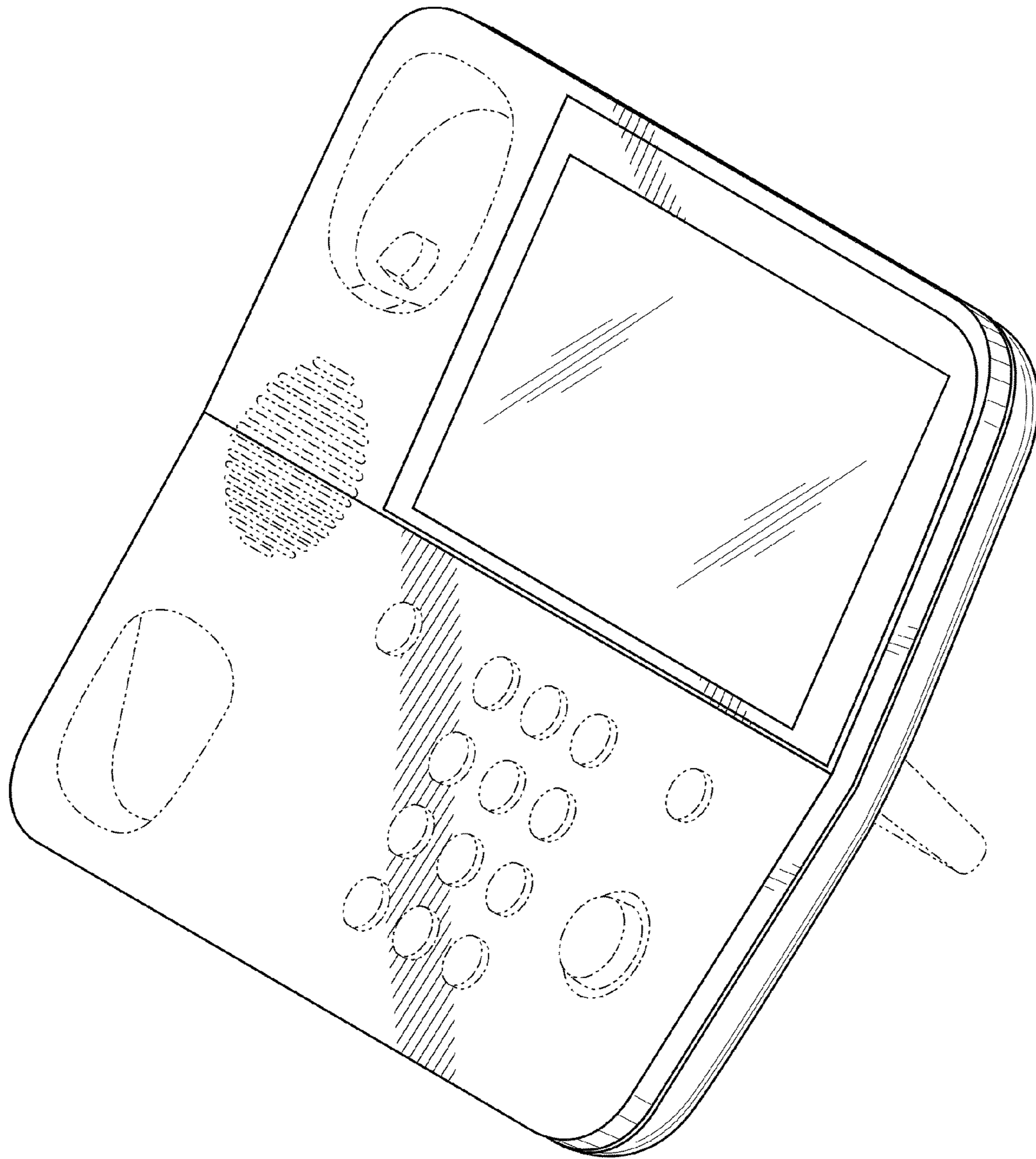

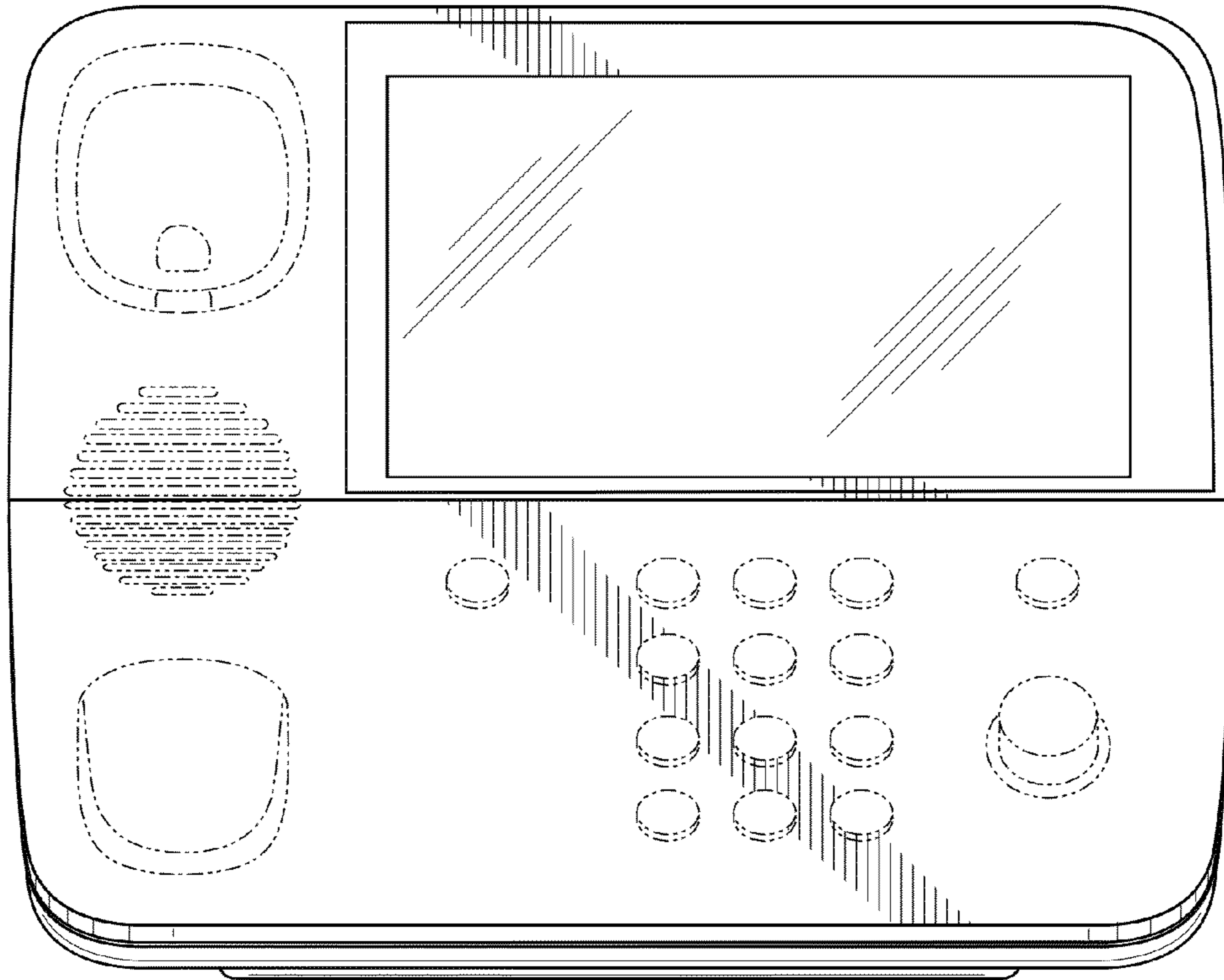

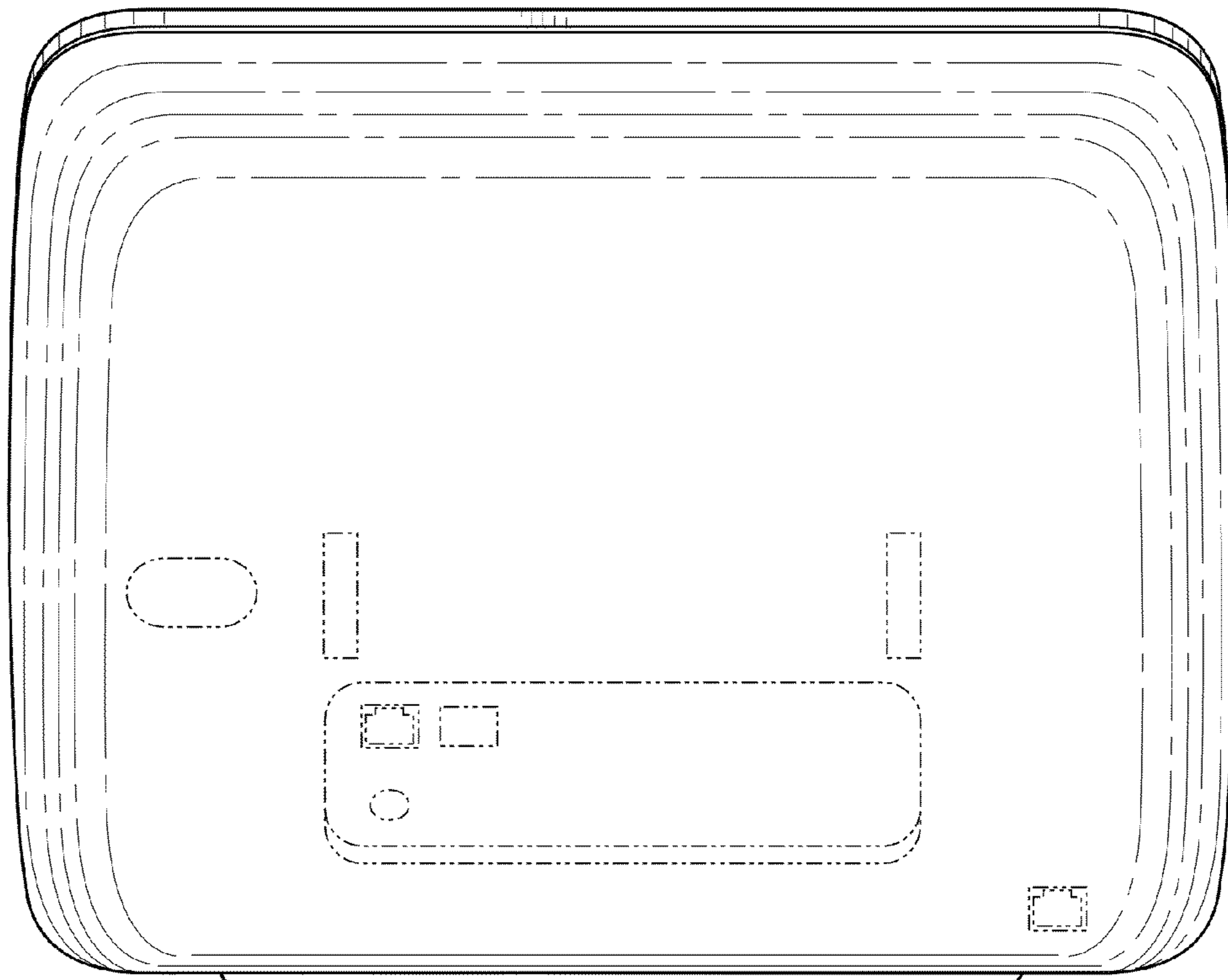

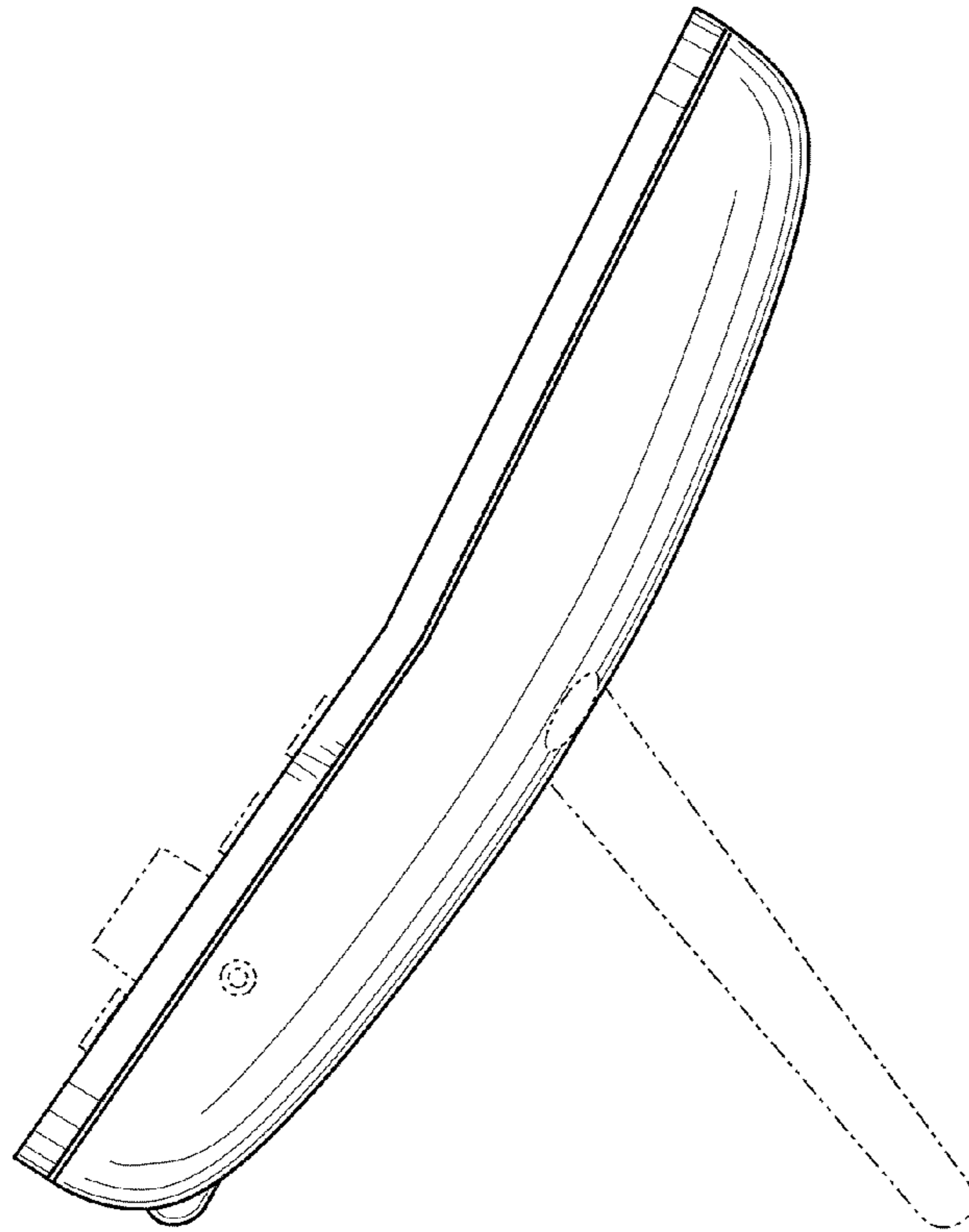

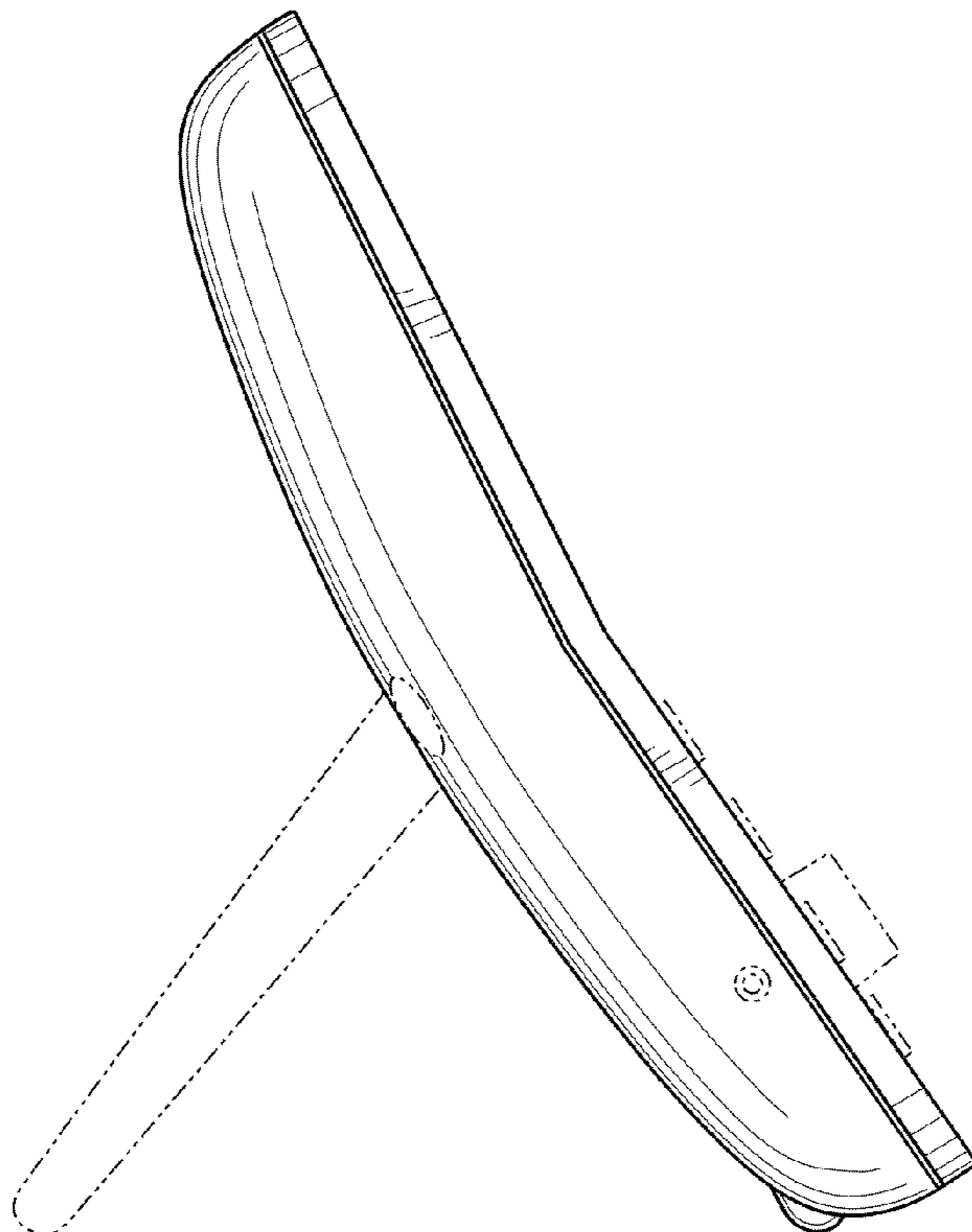

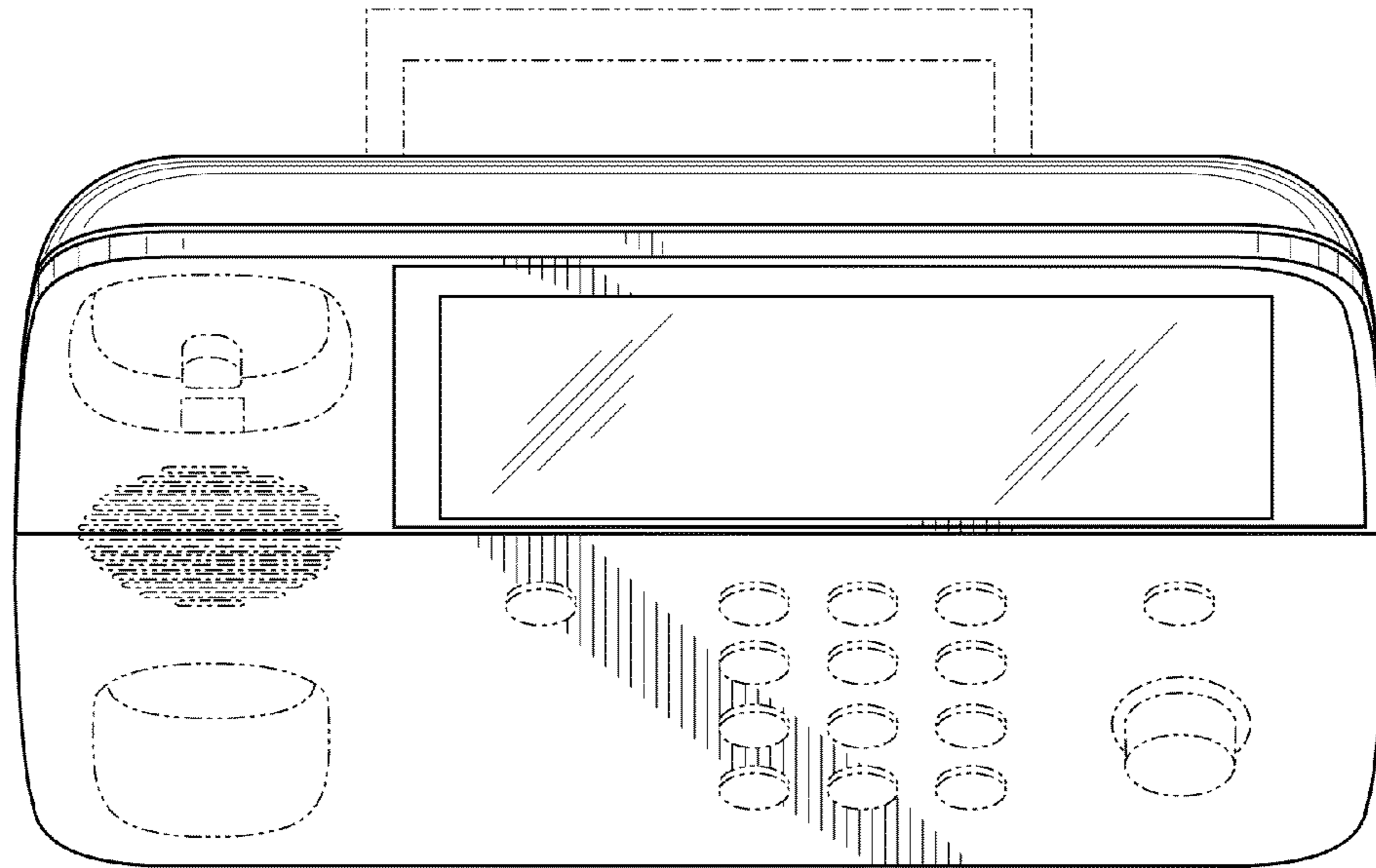

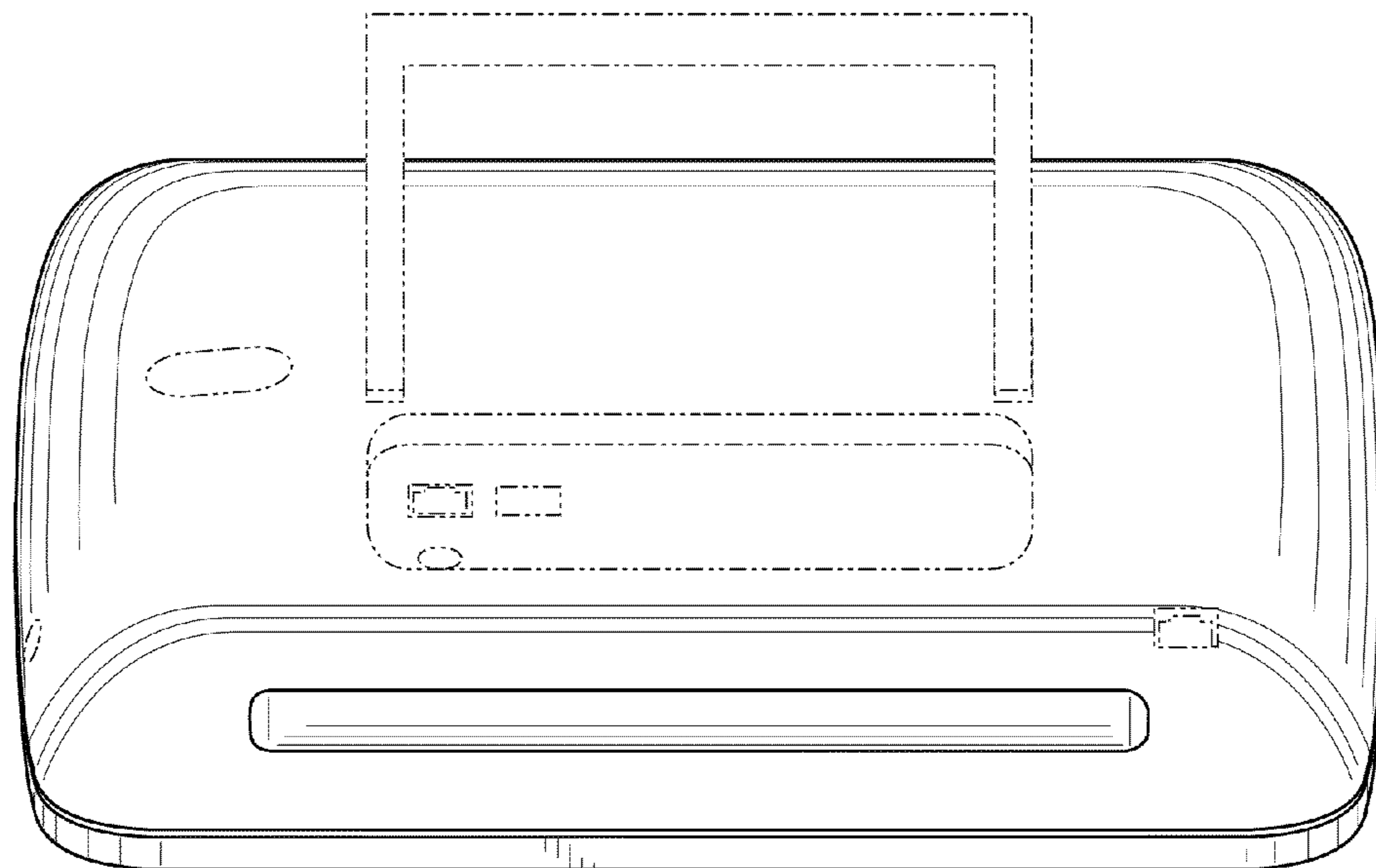
