The ornamental design for a stand for TV receiver, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right side, perspective view of a stand for TV receiver showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof;  
FIG. 8 is a front, right side, perspective view with an unclaimed TV receiver thereof; and,  
FIG. 9 is a rear, left side, perspective view with the unclaimed TV receiver thereof.  
The broken lines depict portions of the stand for TV receiver that form no part of the claimed design.

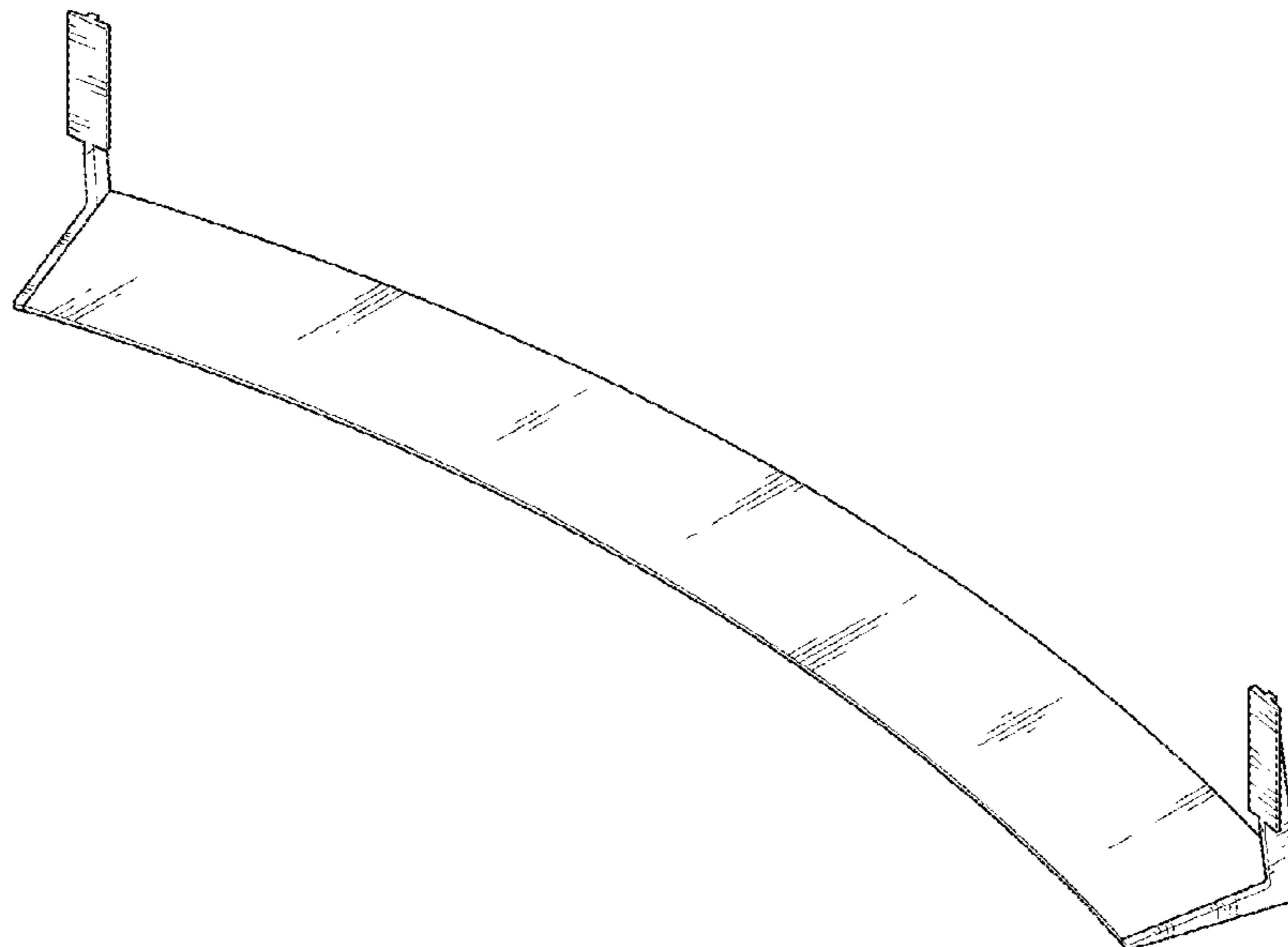

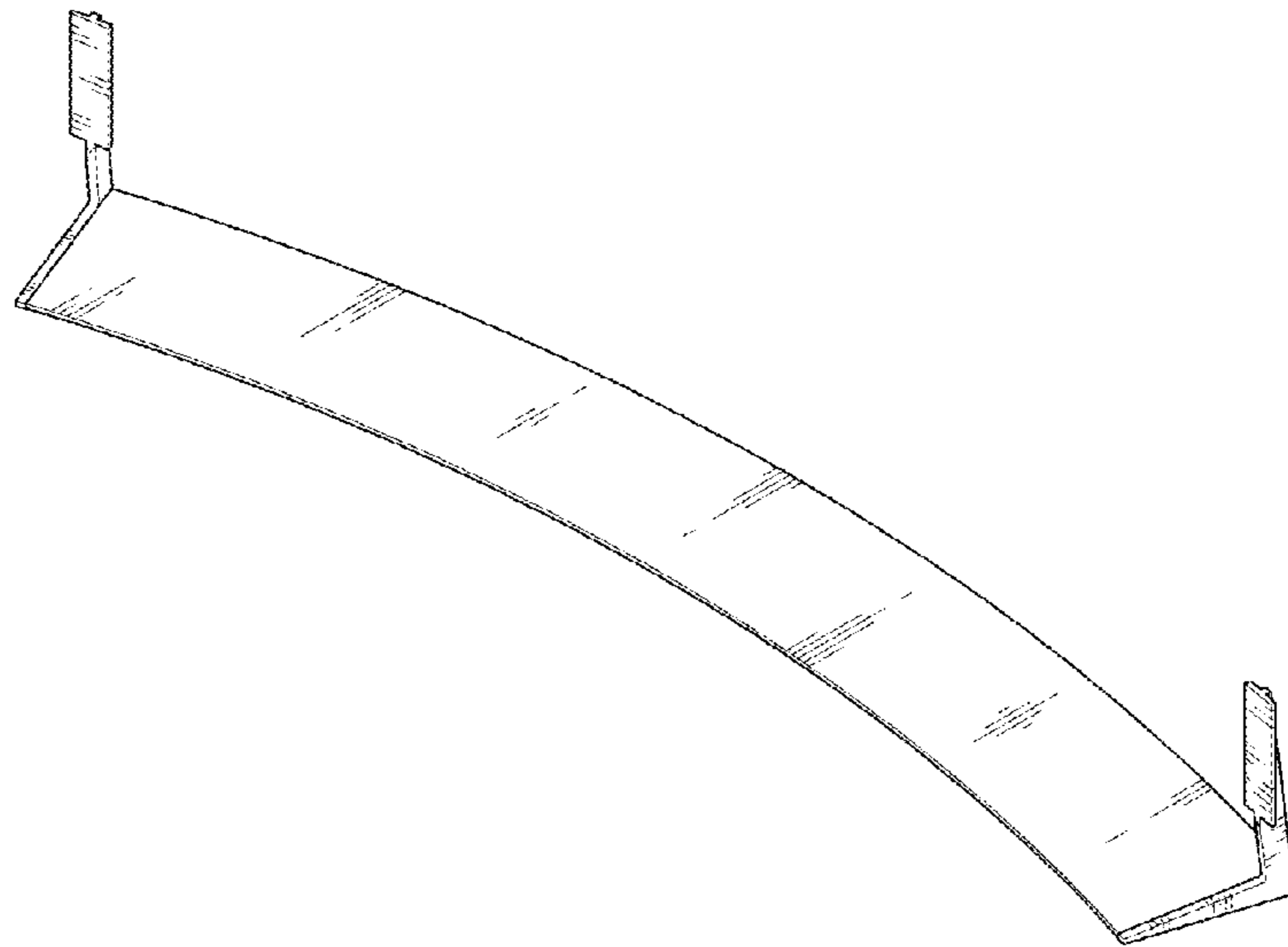

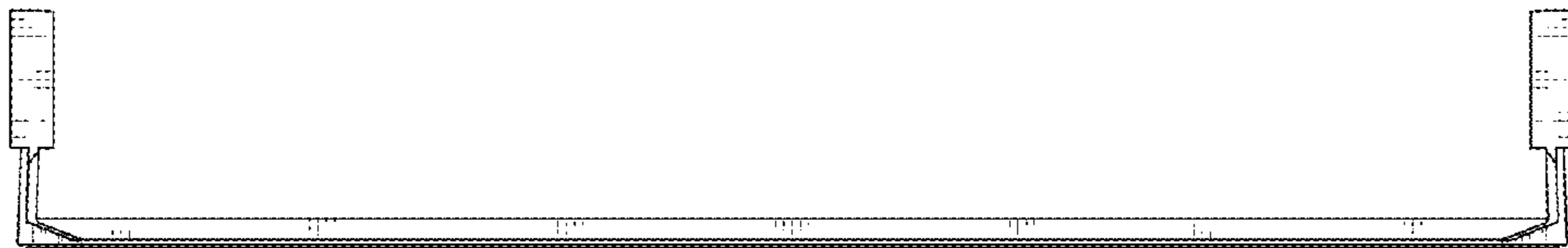

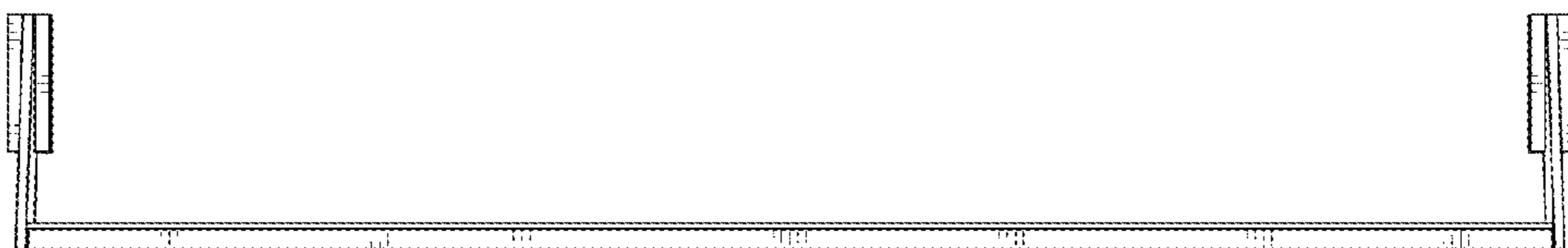

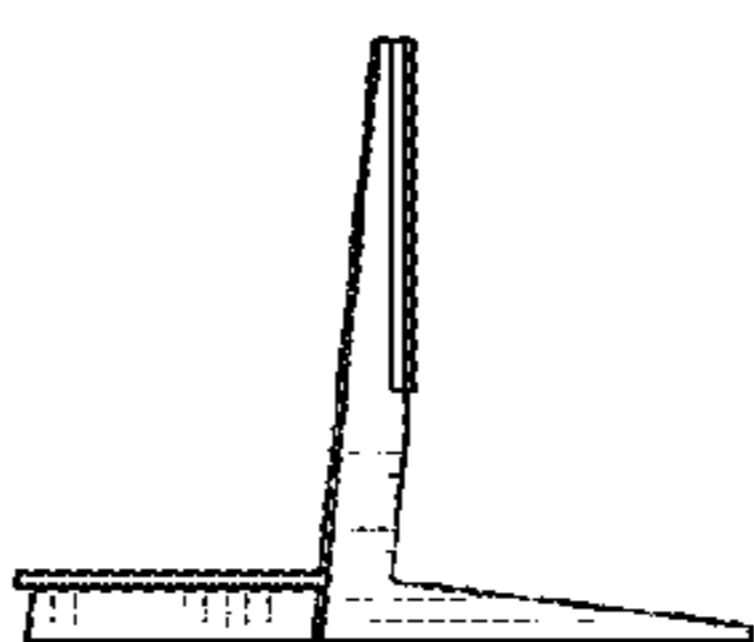

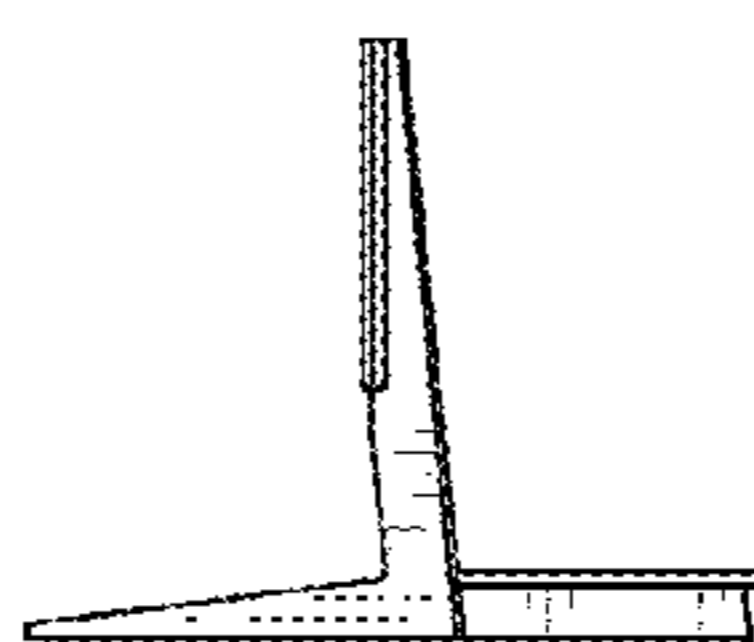

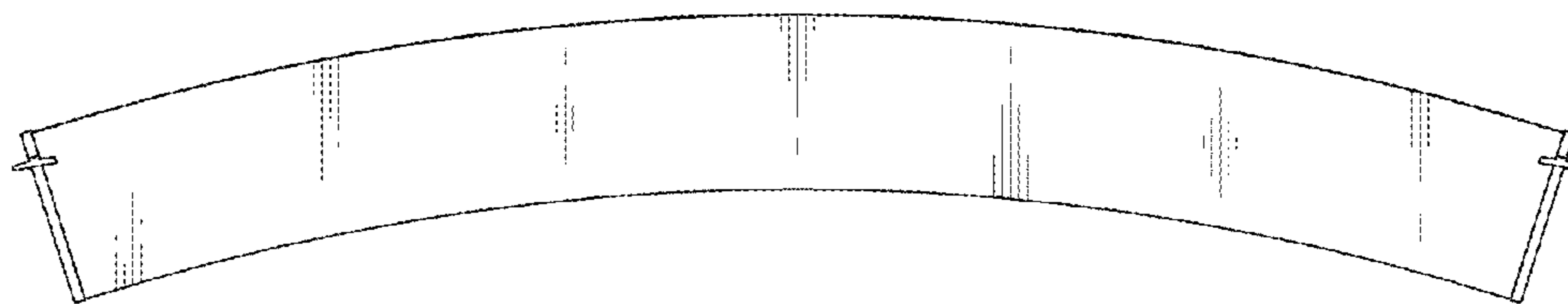

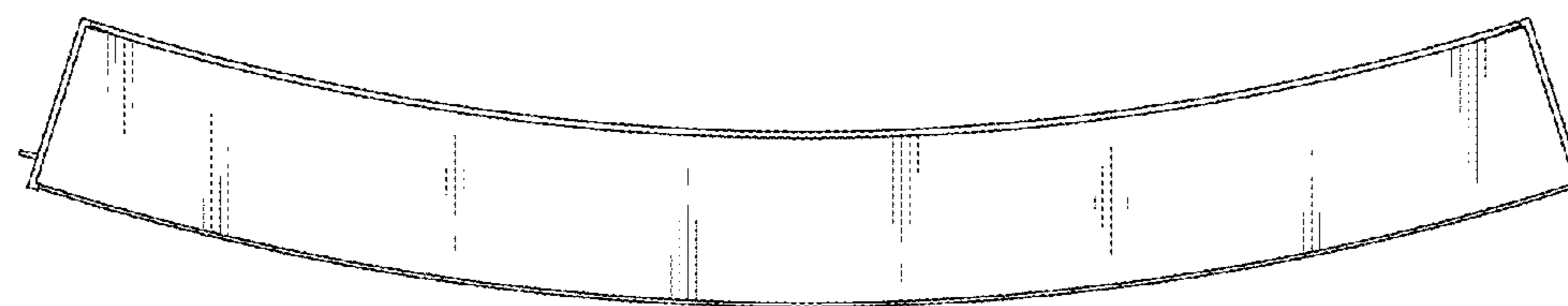

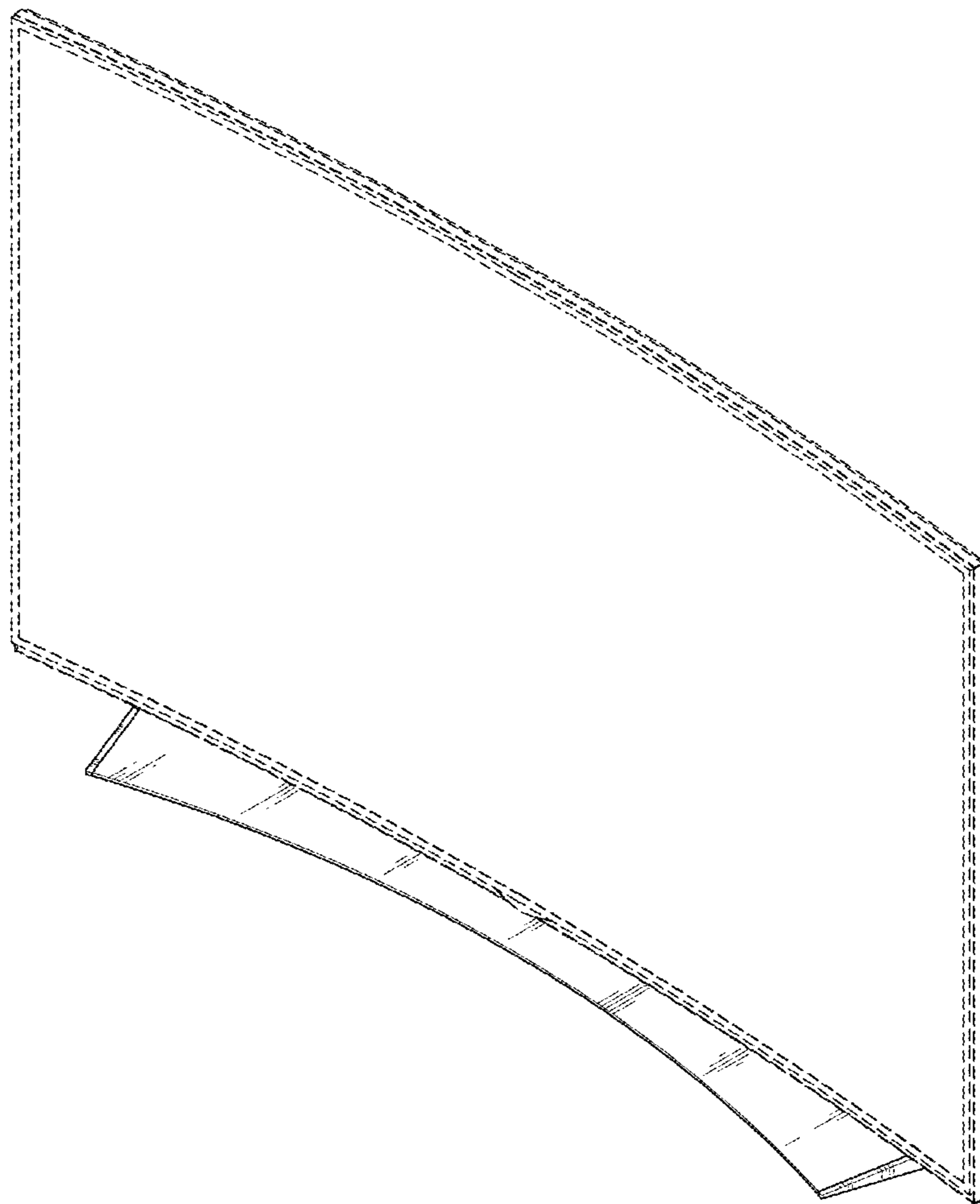
