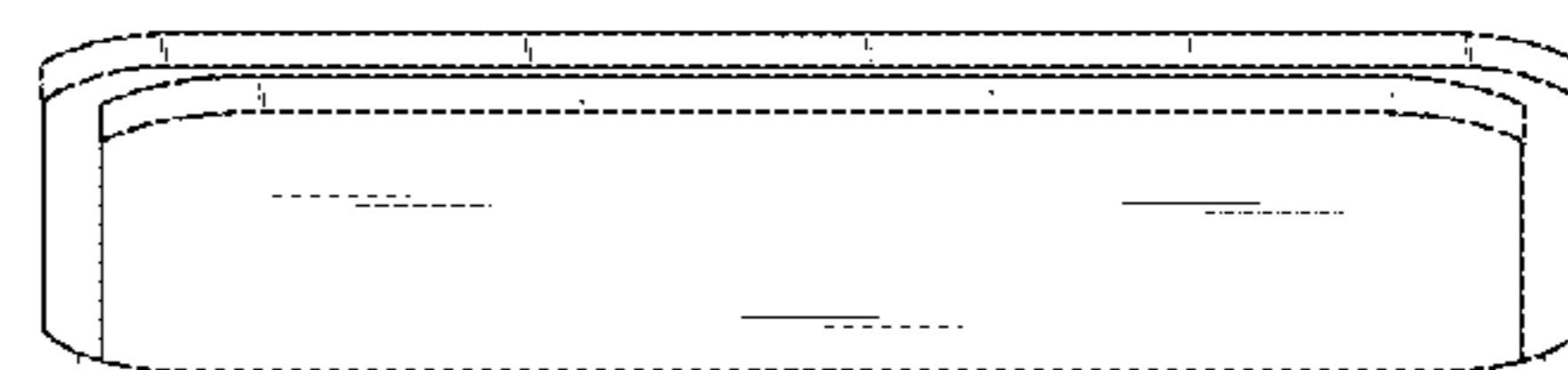
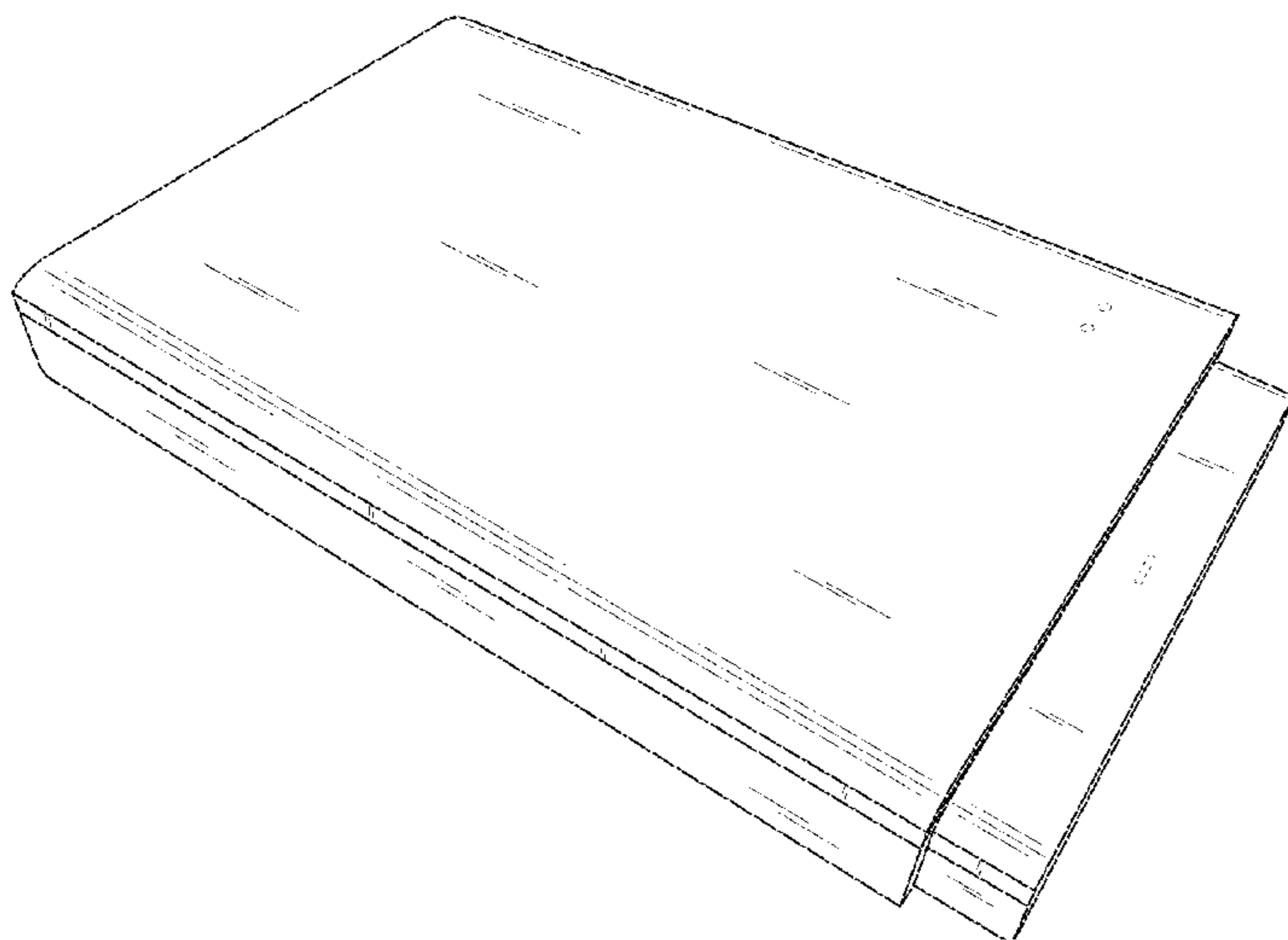
(57) **CLAIM**

The ornamental design for a combined wireless drive and adapter, as shown and described.

DESCRIPTION

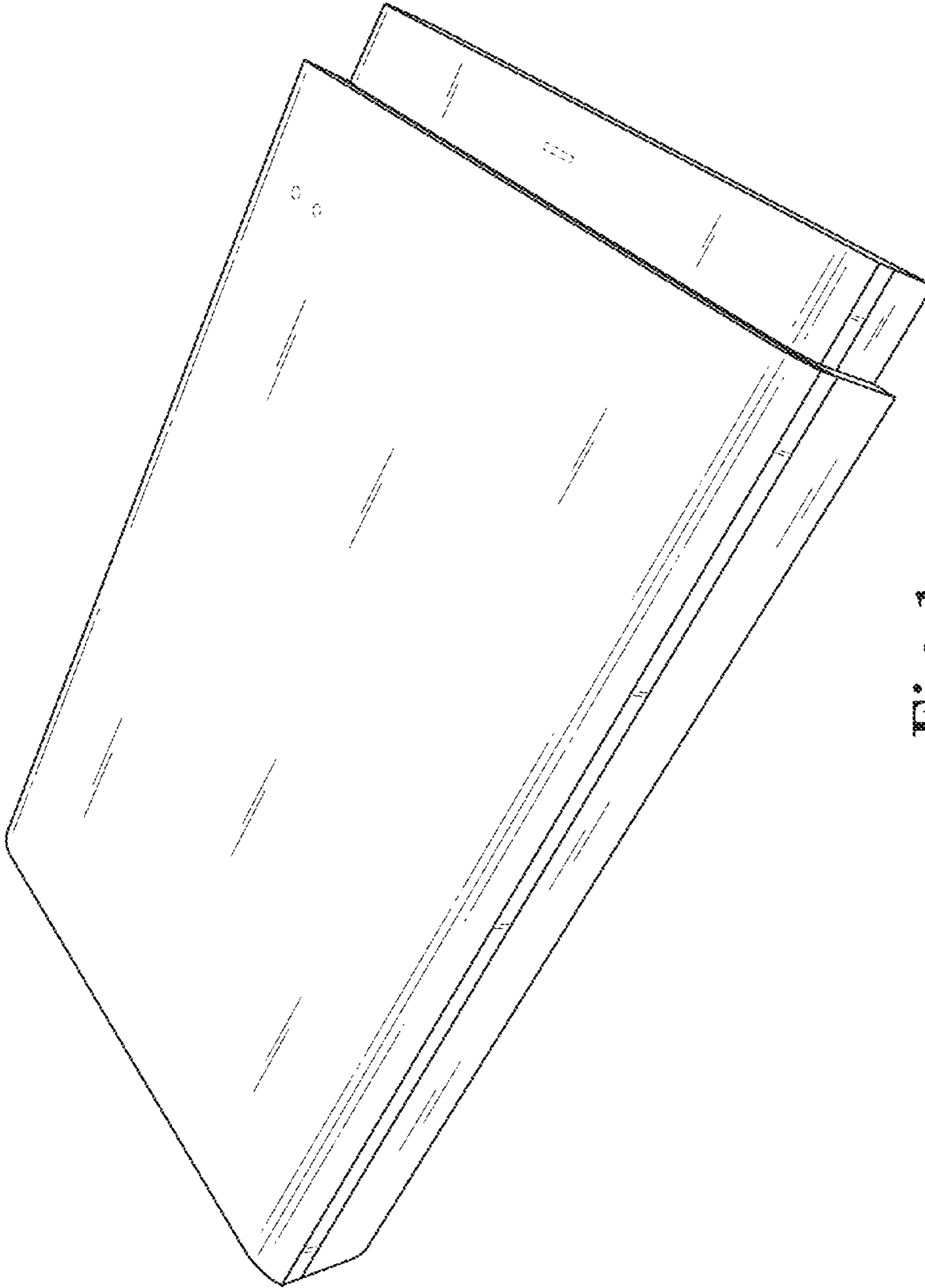

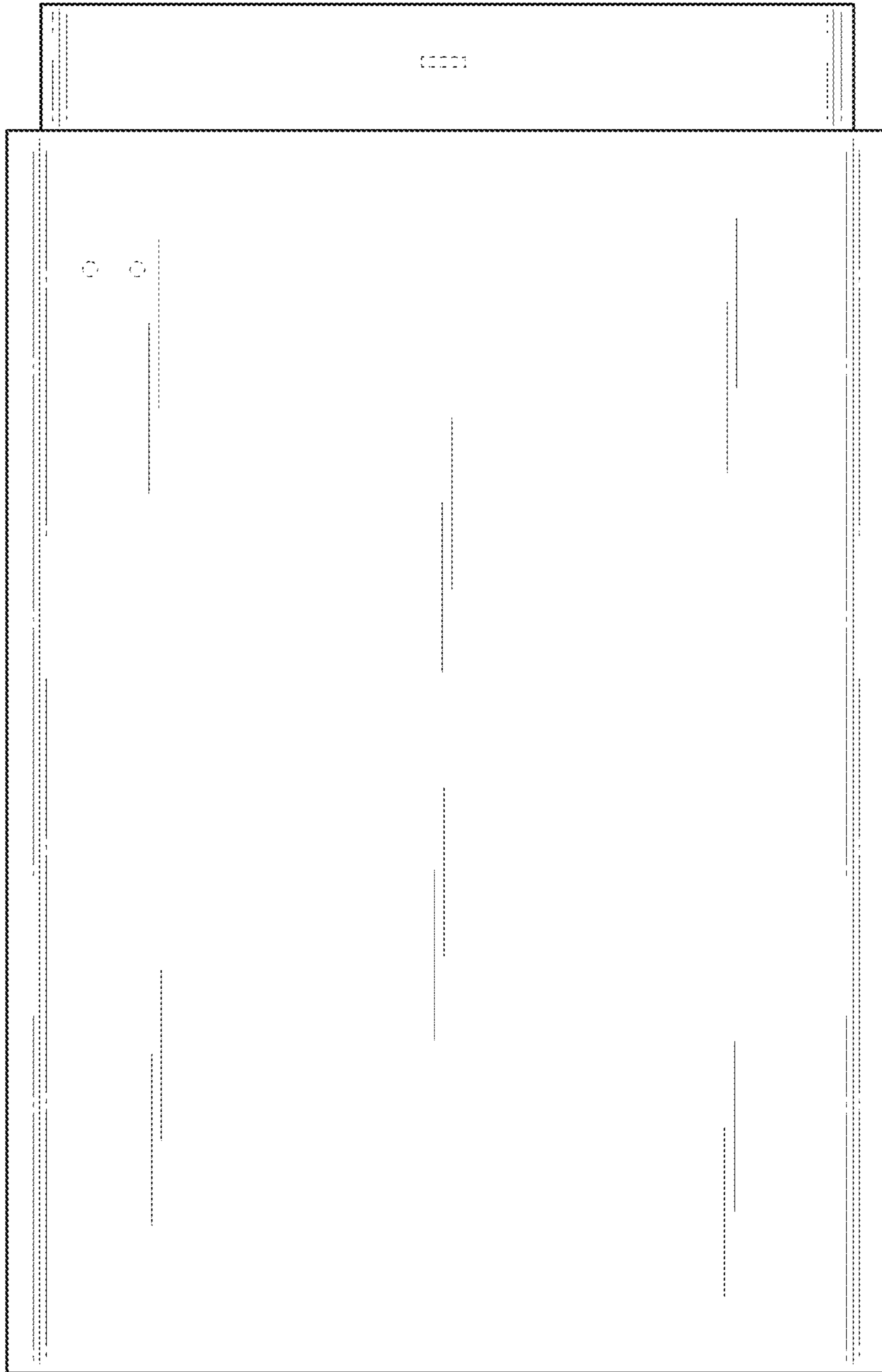

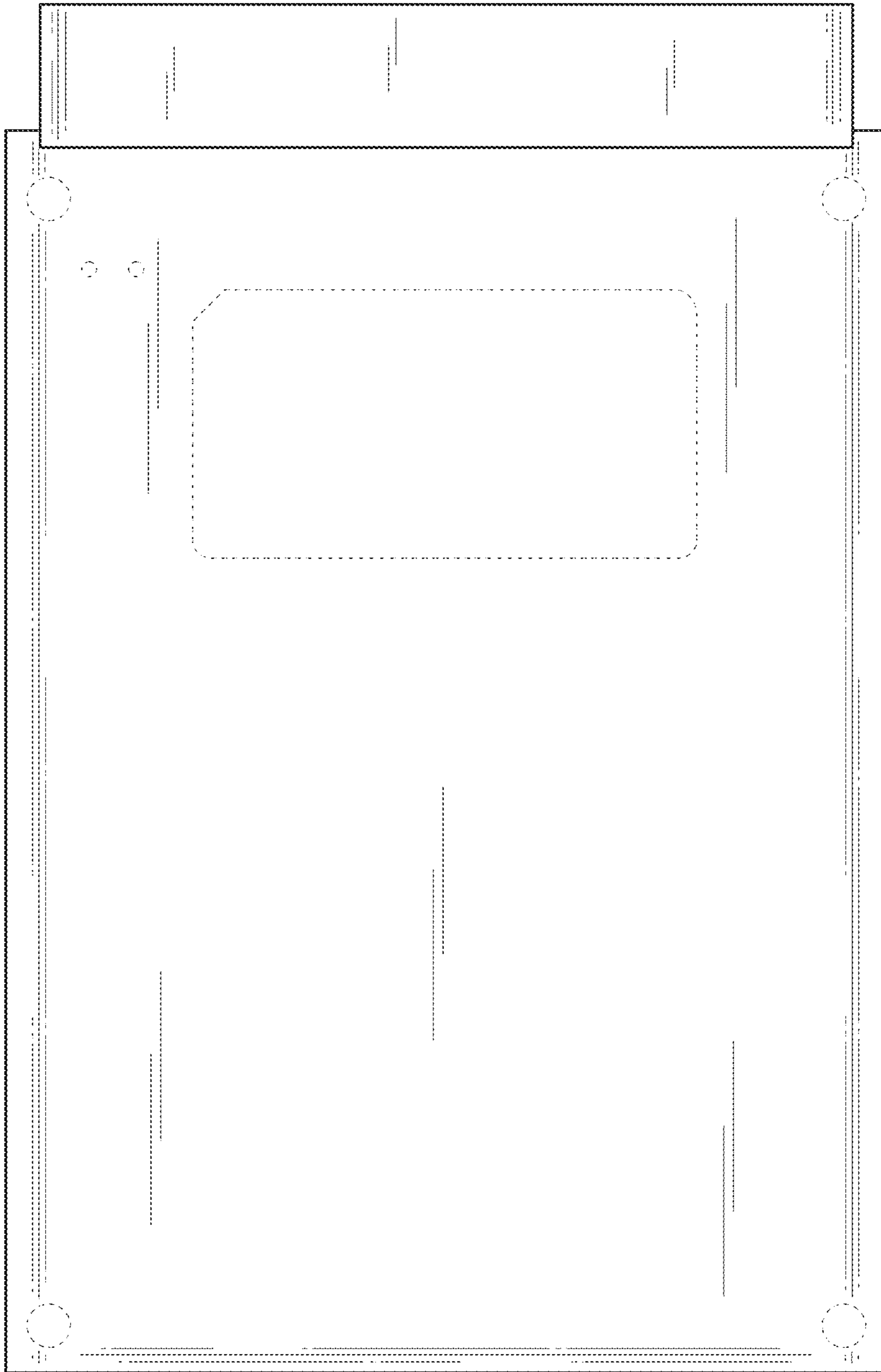

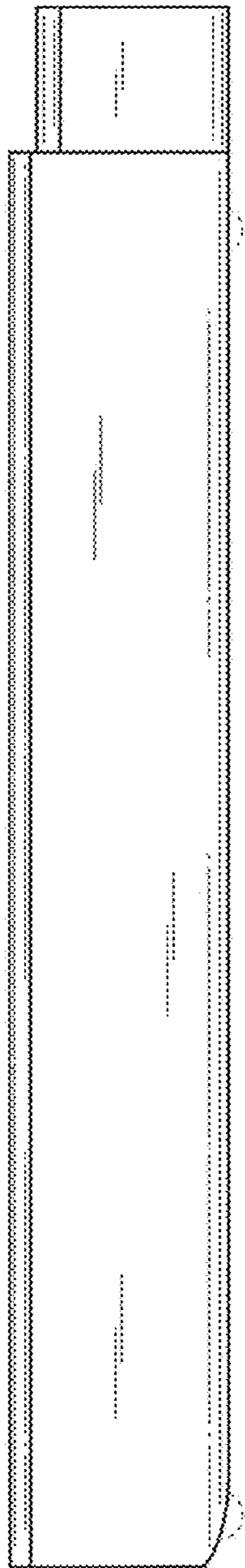

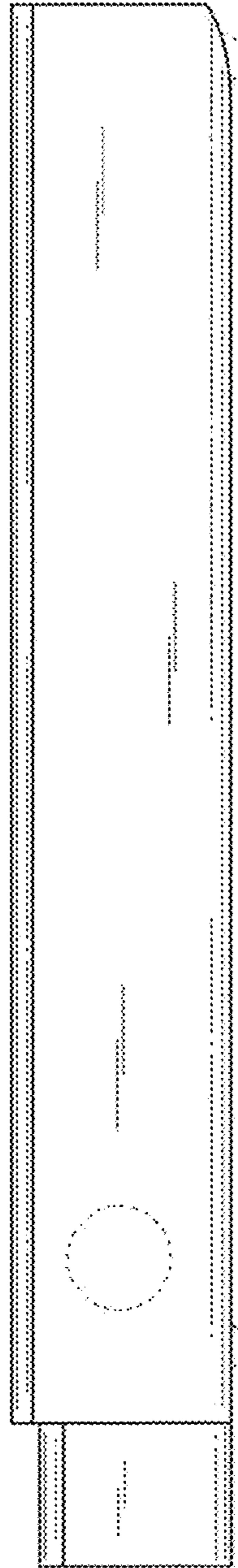

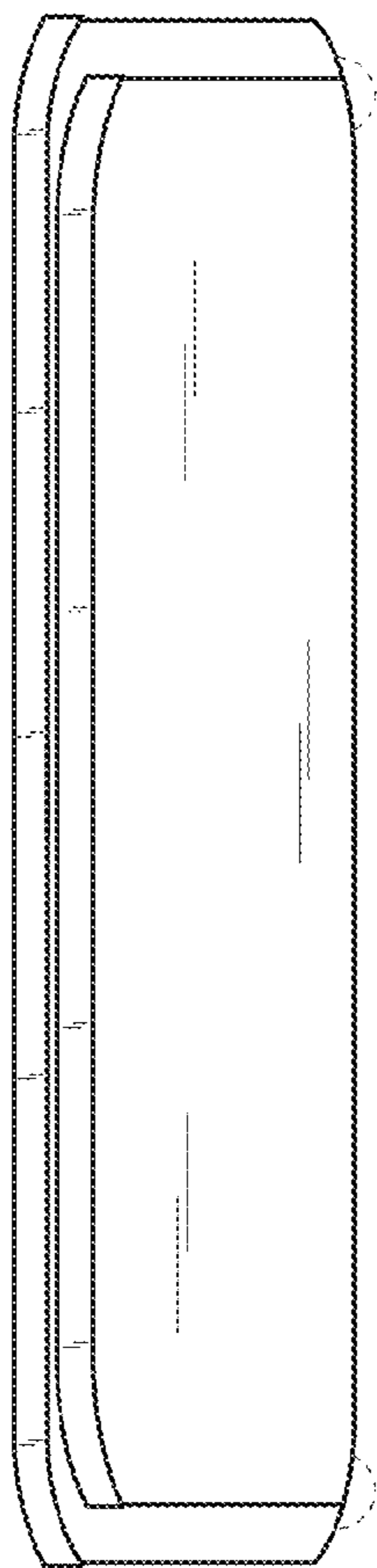

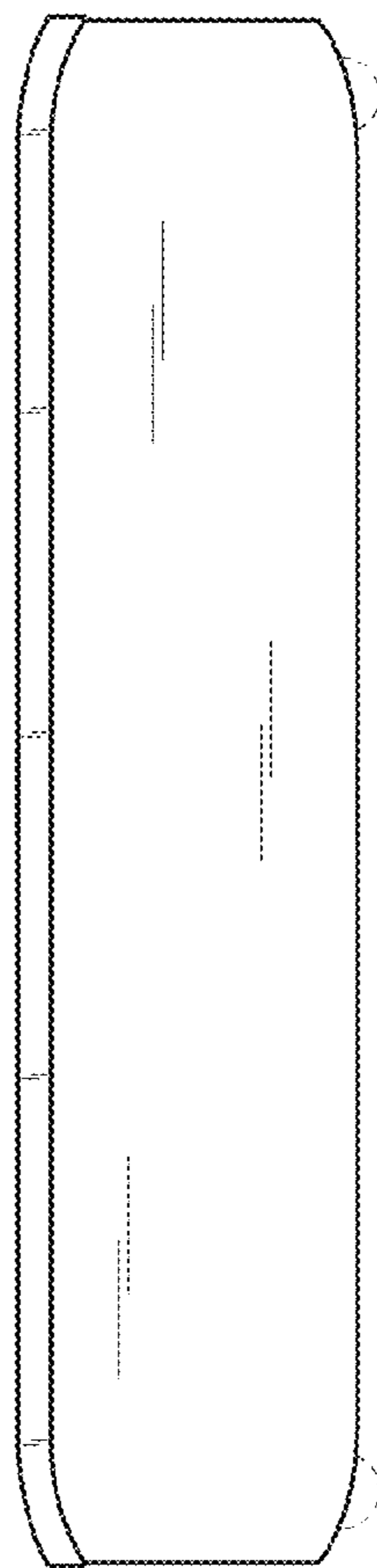

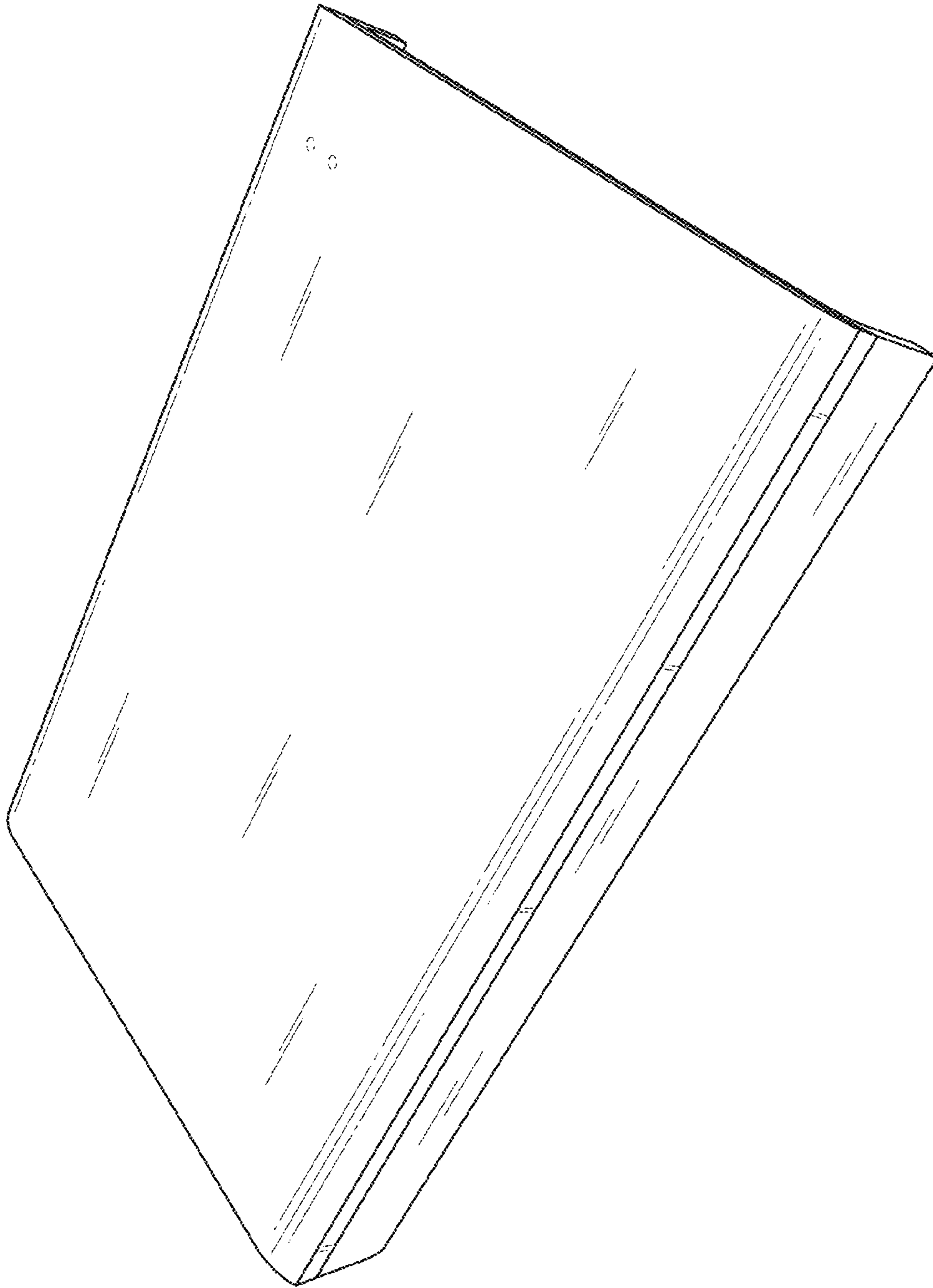

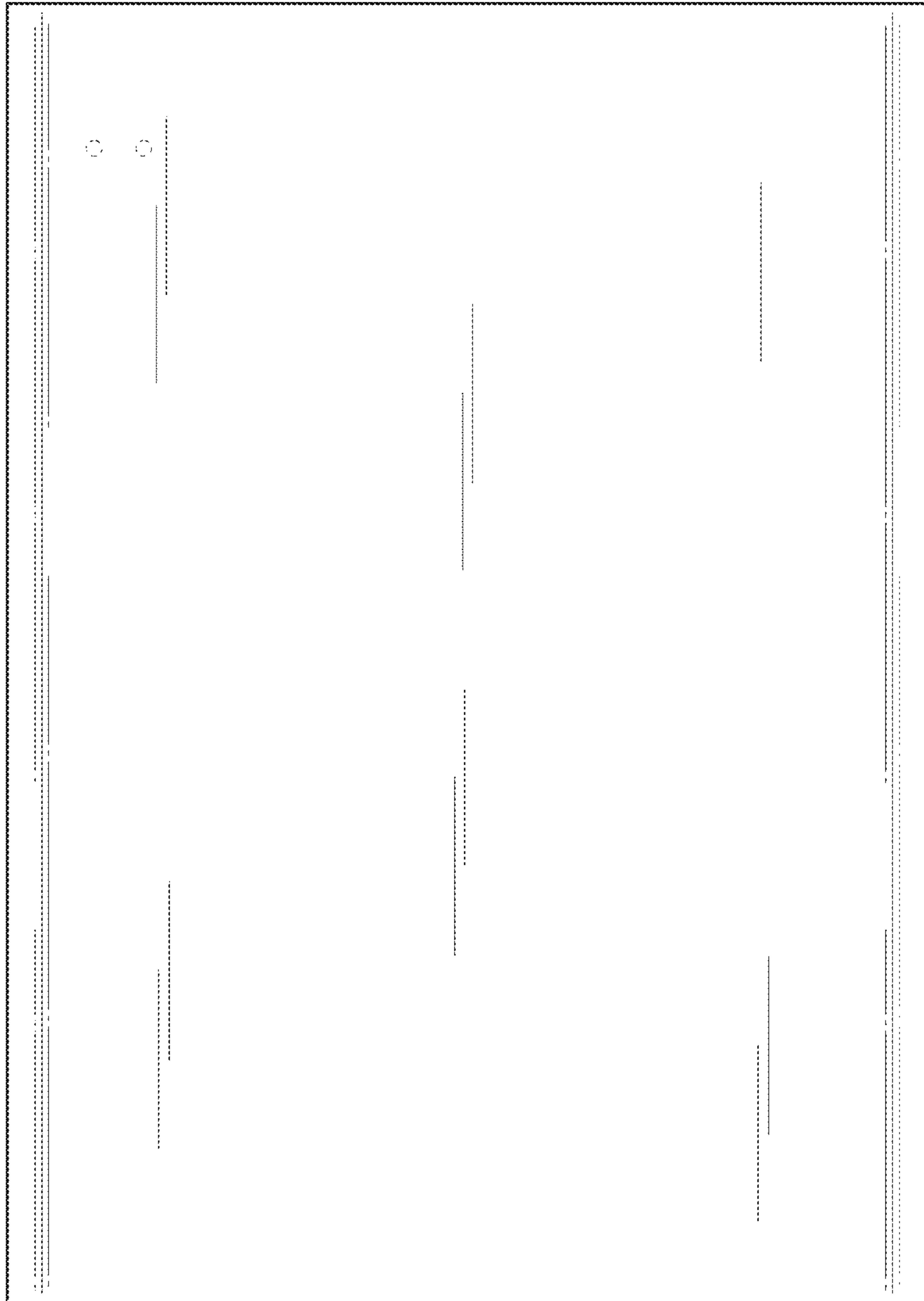

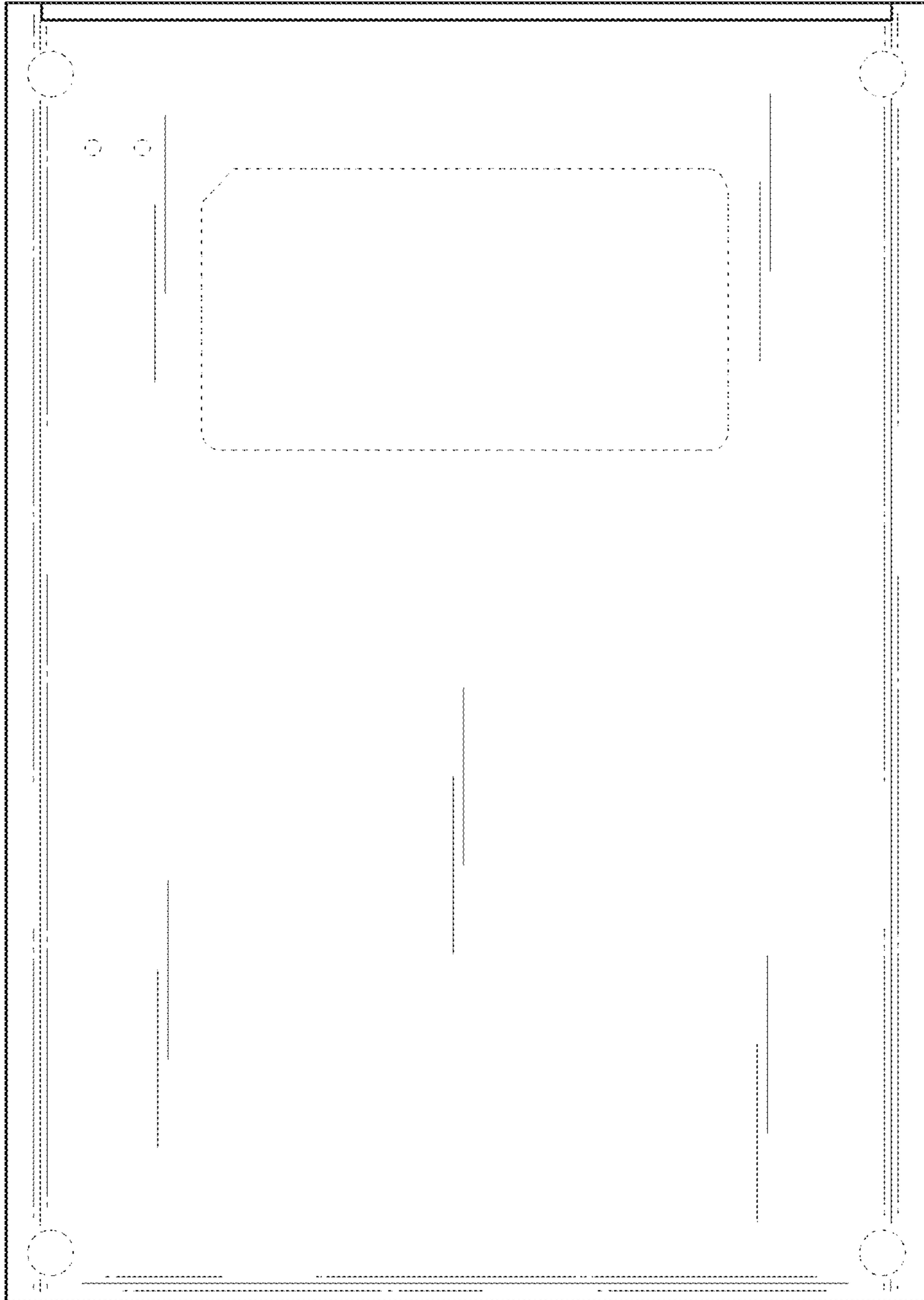

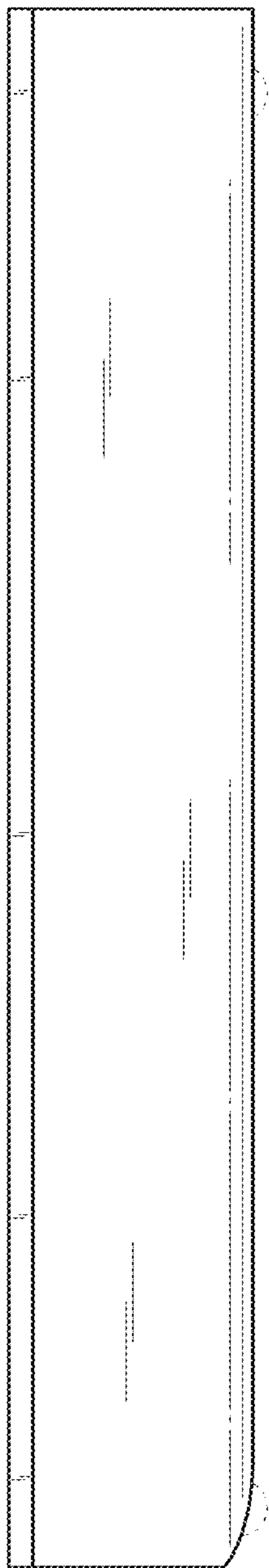

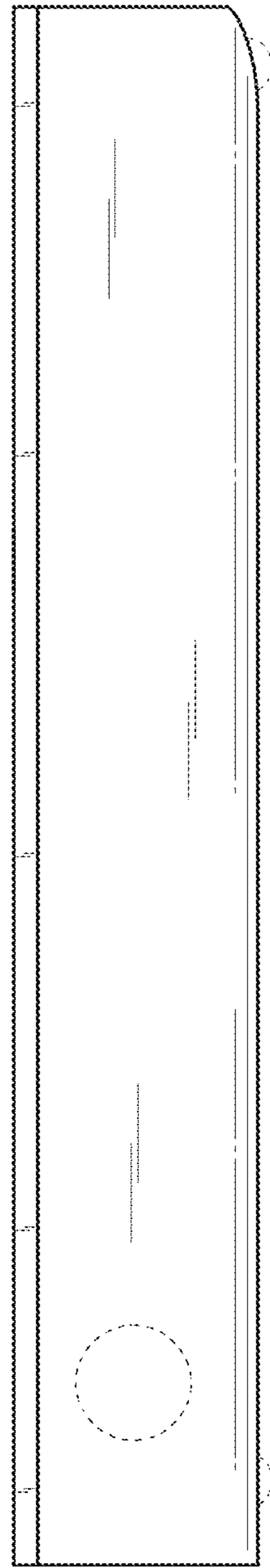

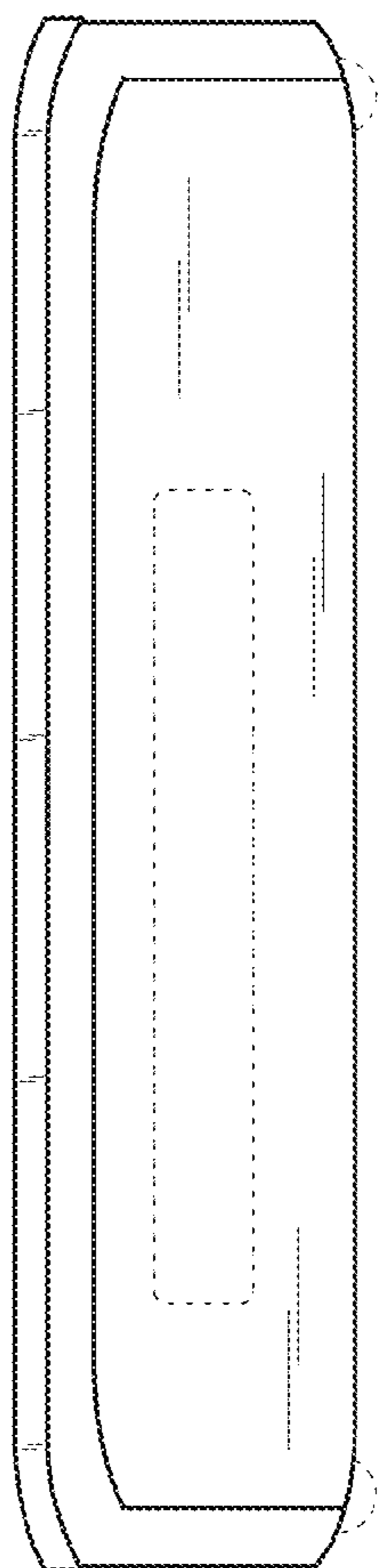

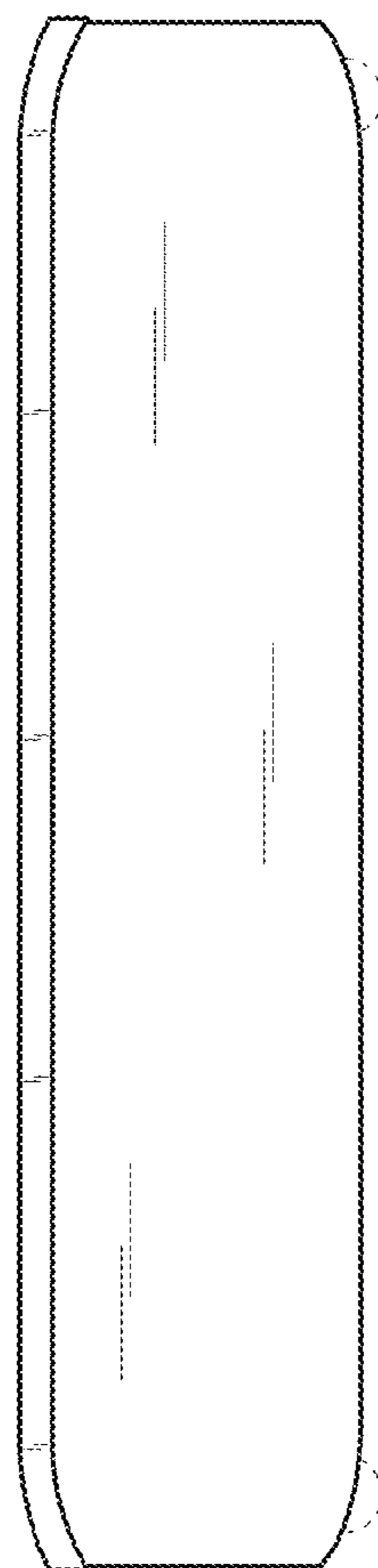
