DESCRIPTION

FIG. 1 is a top perspective view of a docking station showing our new design;

FIG. 4 is a right side view thereof;

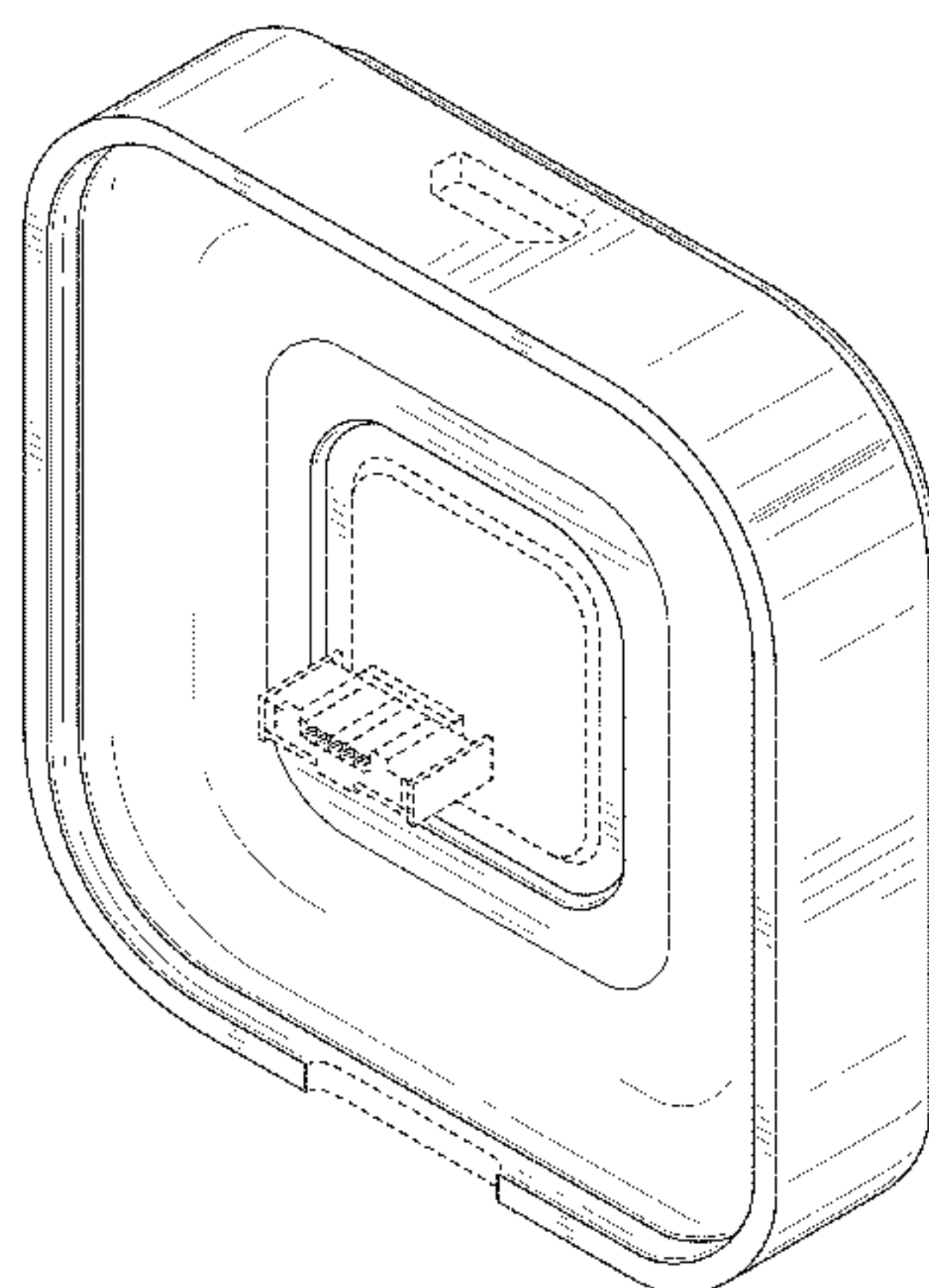
FIG. 5 is a left side view thereof;

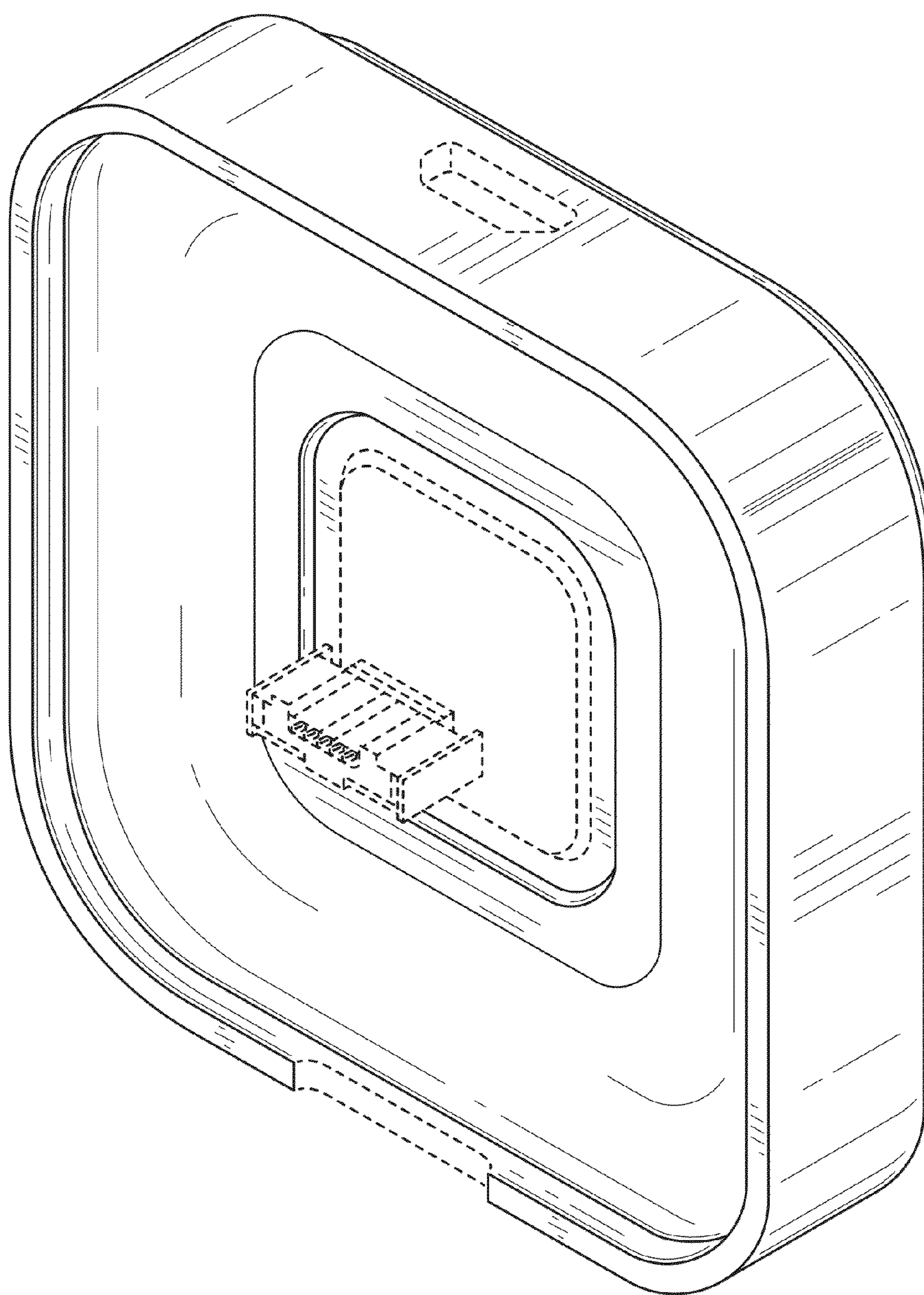

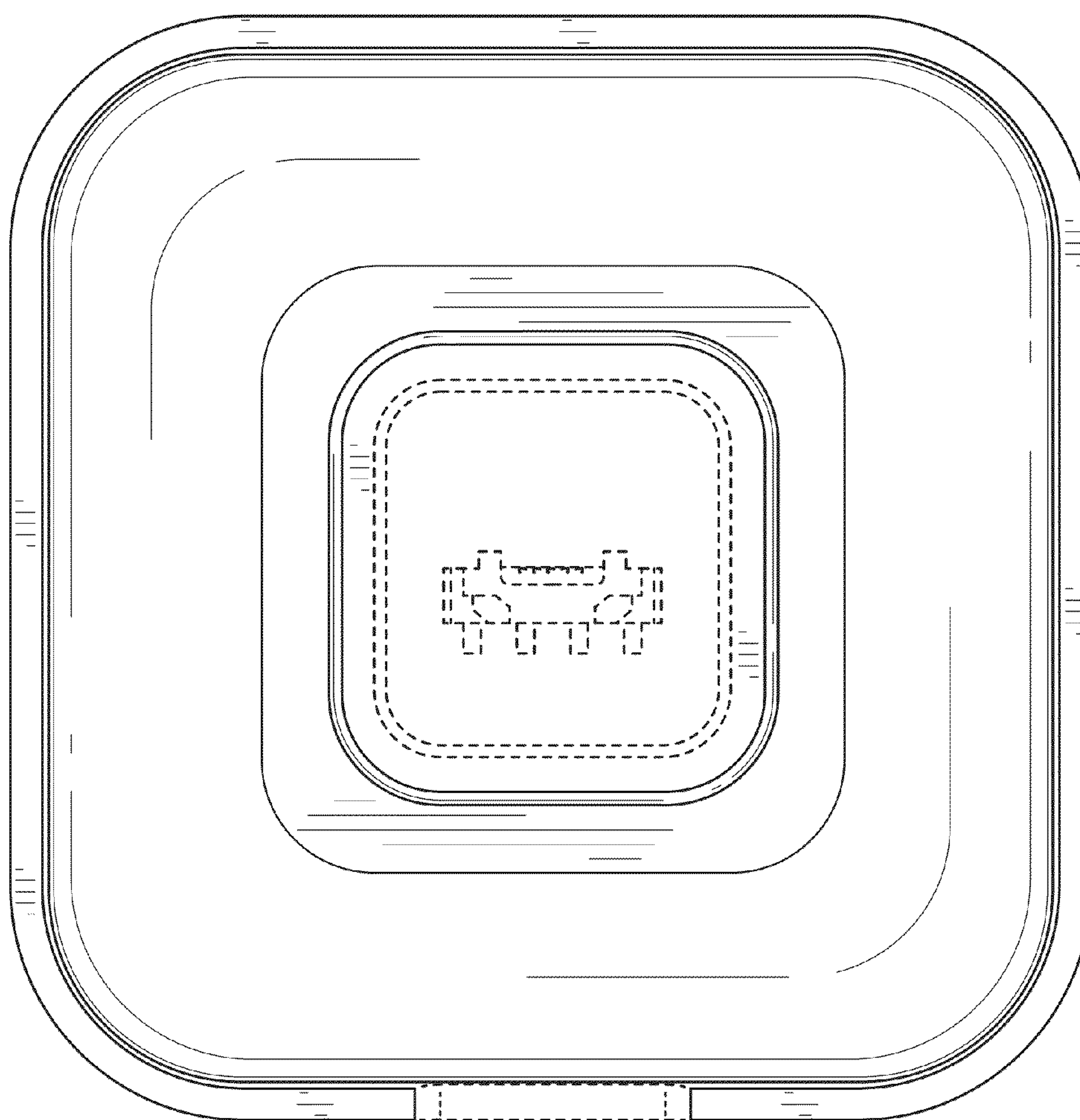

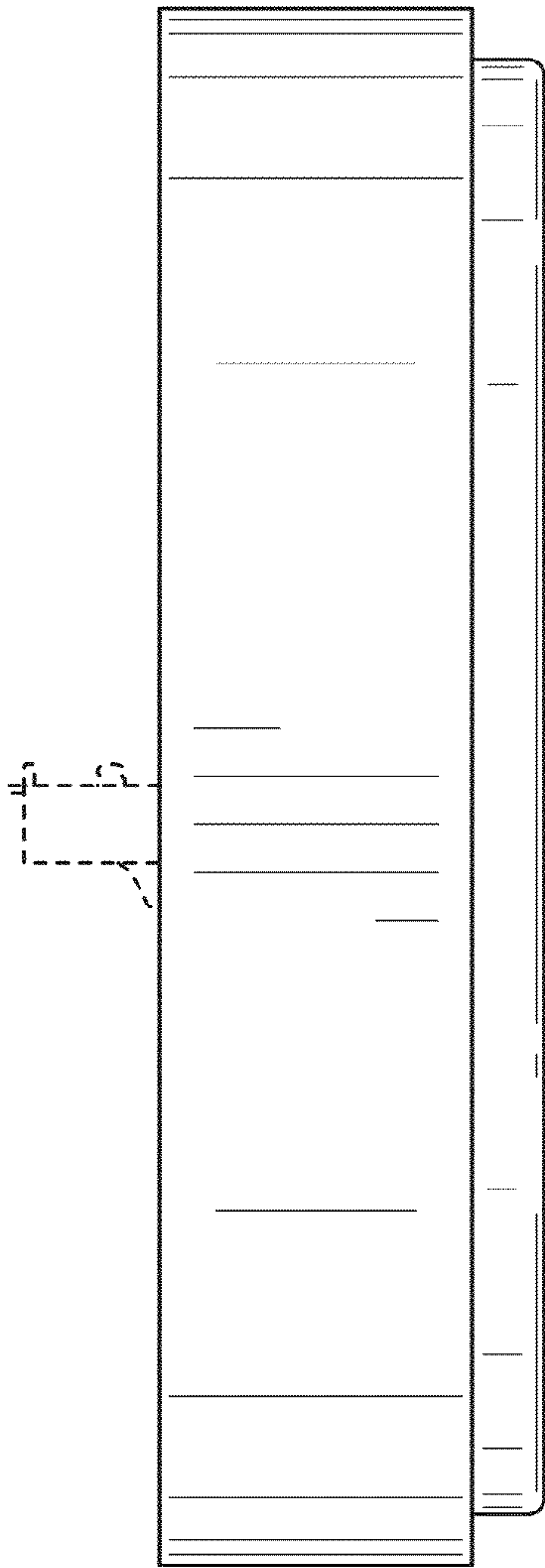

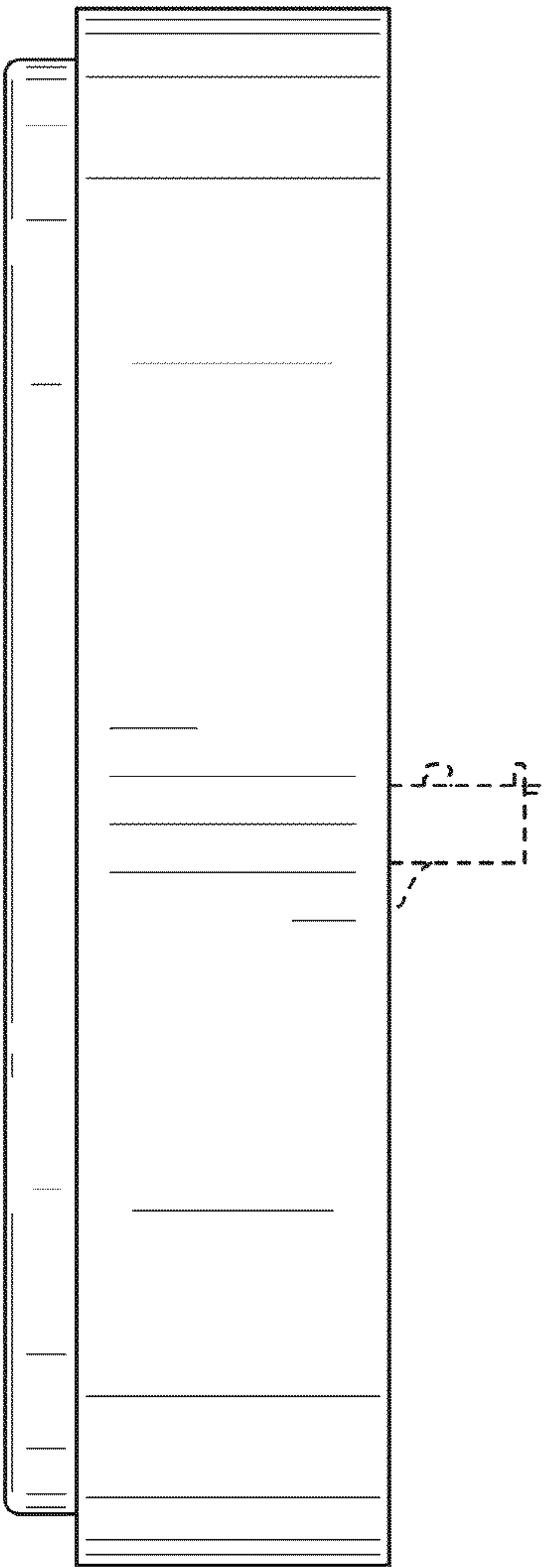

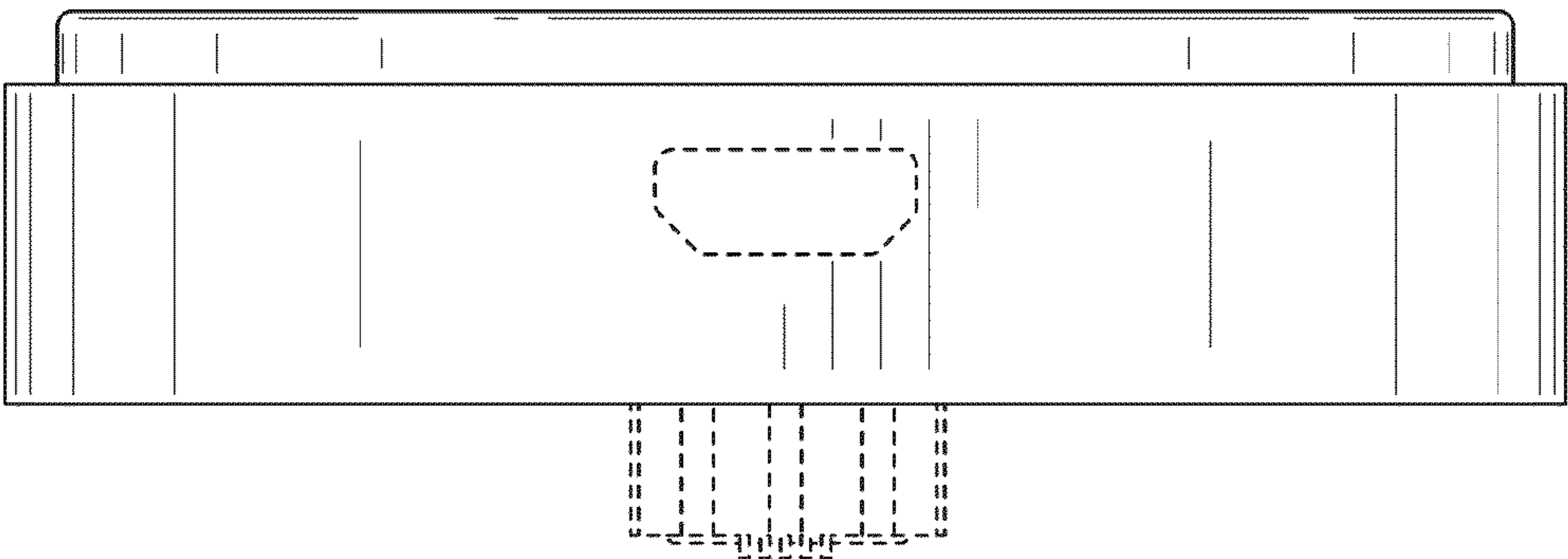

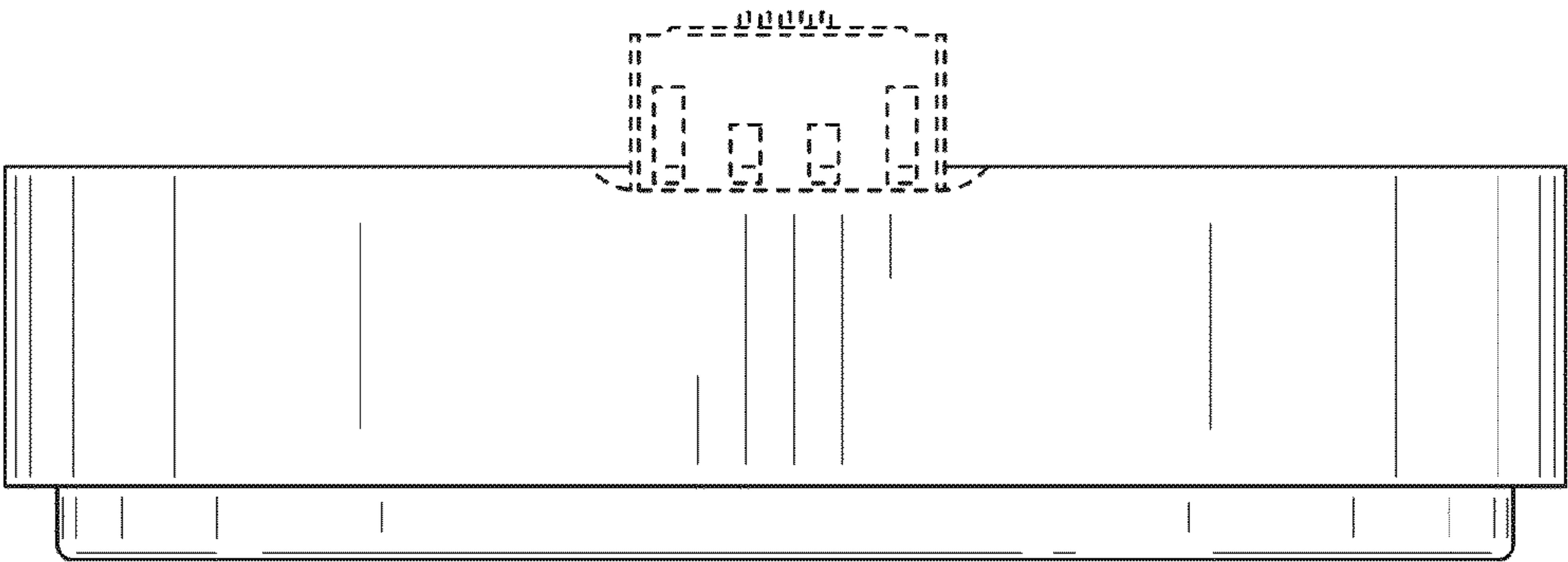
