(57) **CLAIM**

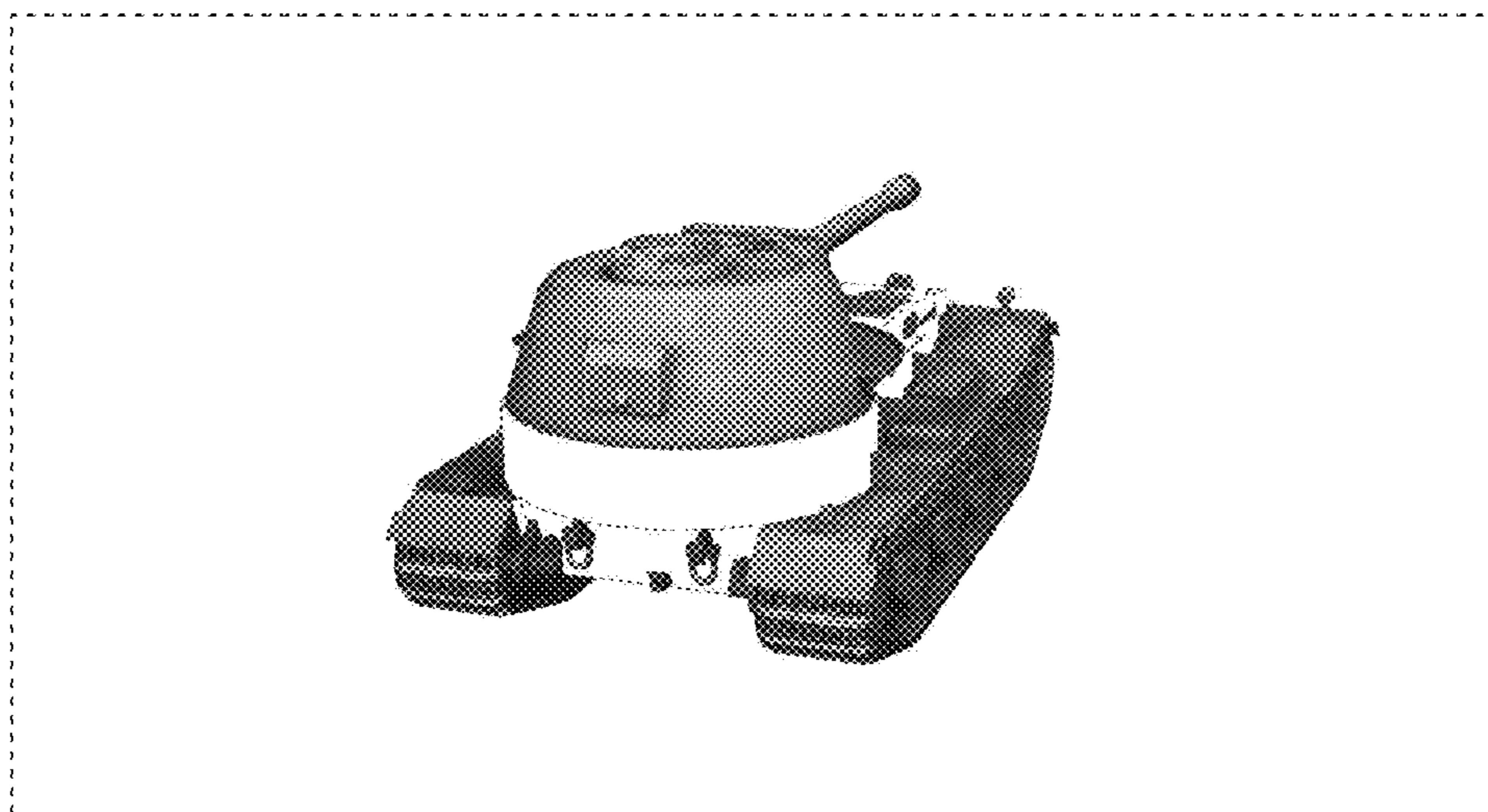
The ornamental design for a display device portion with a graphical user interface showing an armored vehicle, as shown and described.
