**DESCRIPTION**

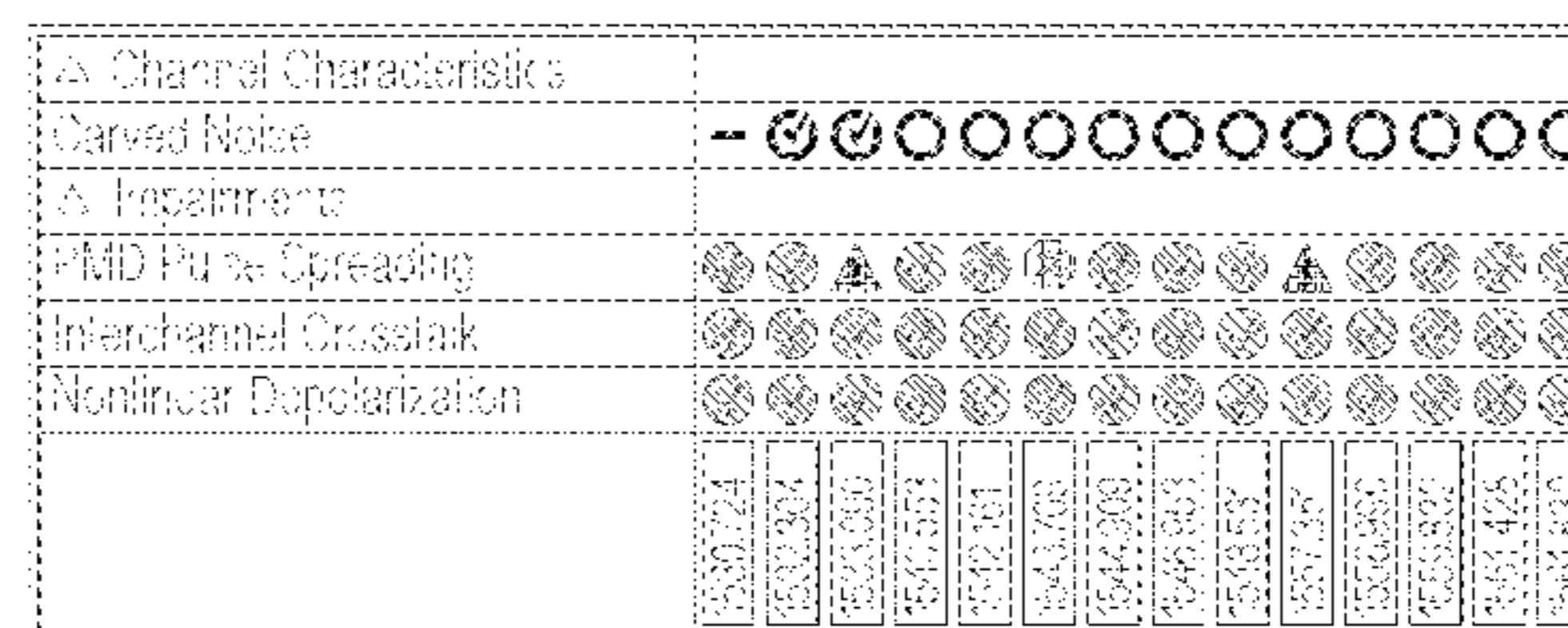
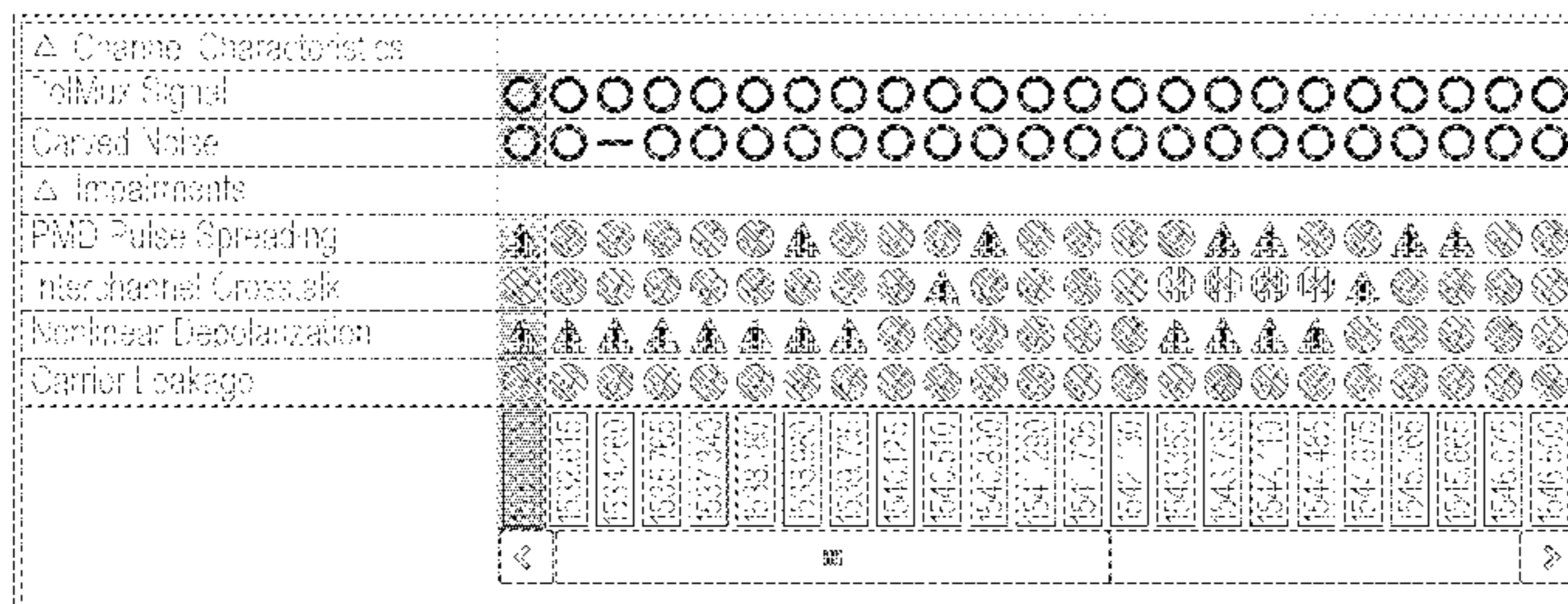
FIG. 1 is a front view of display screen or portion thereof with graphical user interface, showing our new design;
