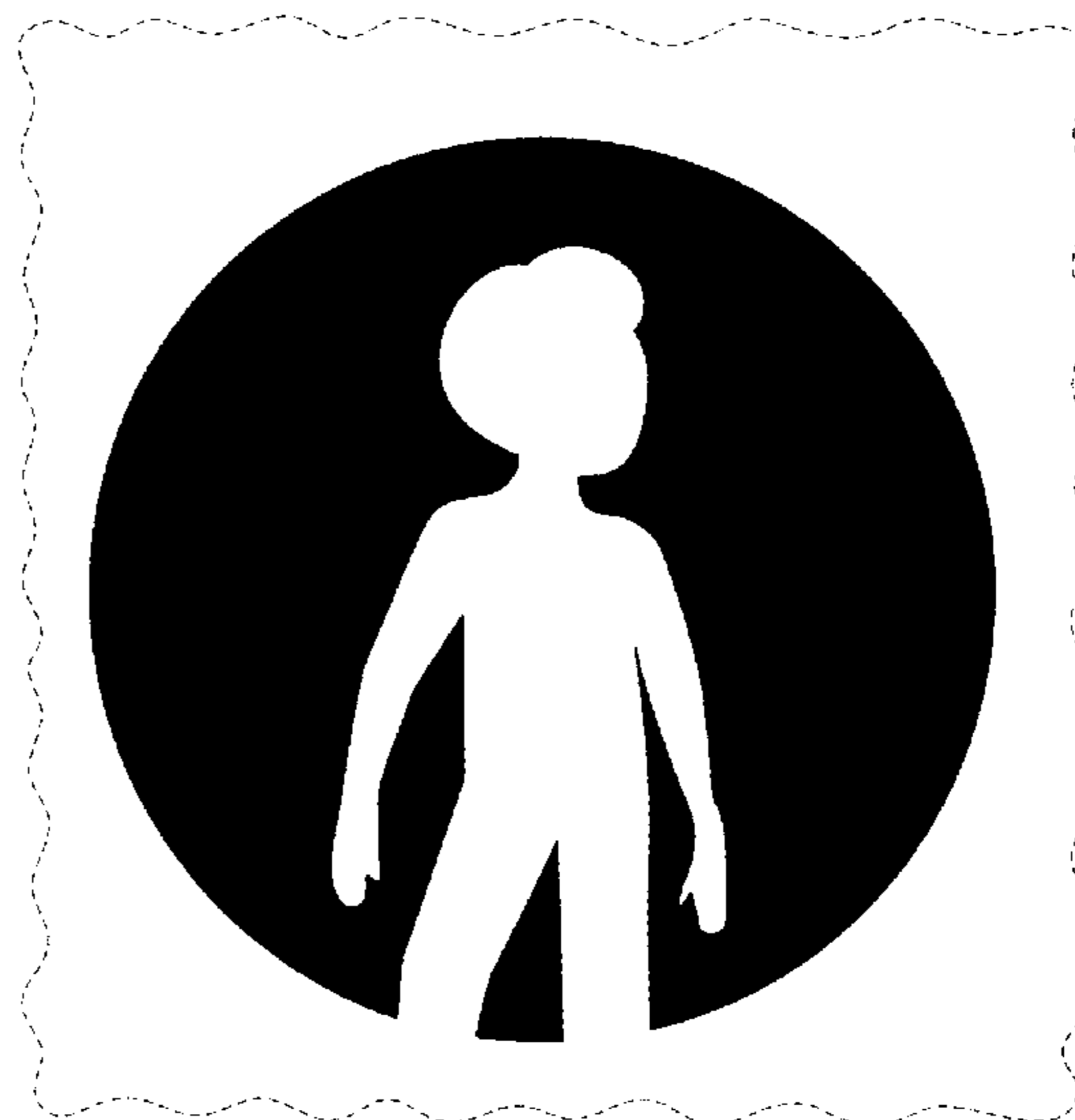
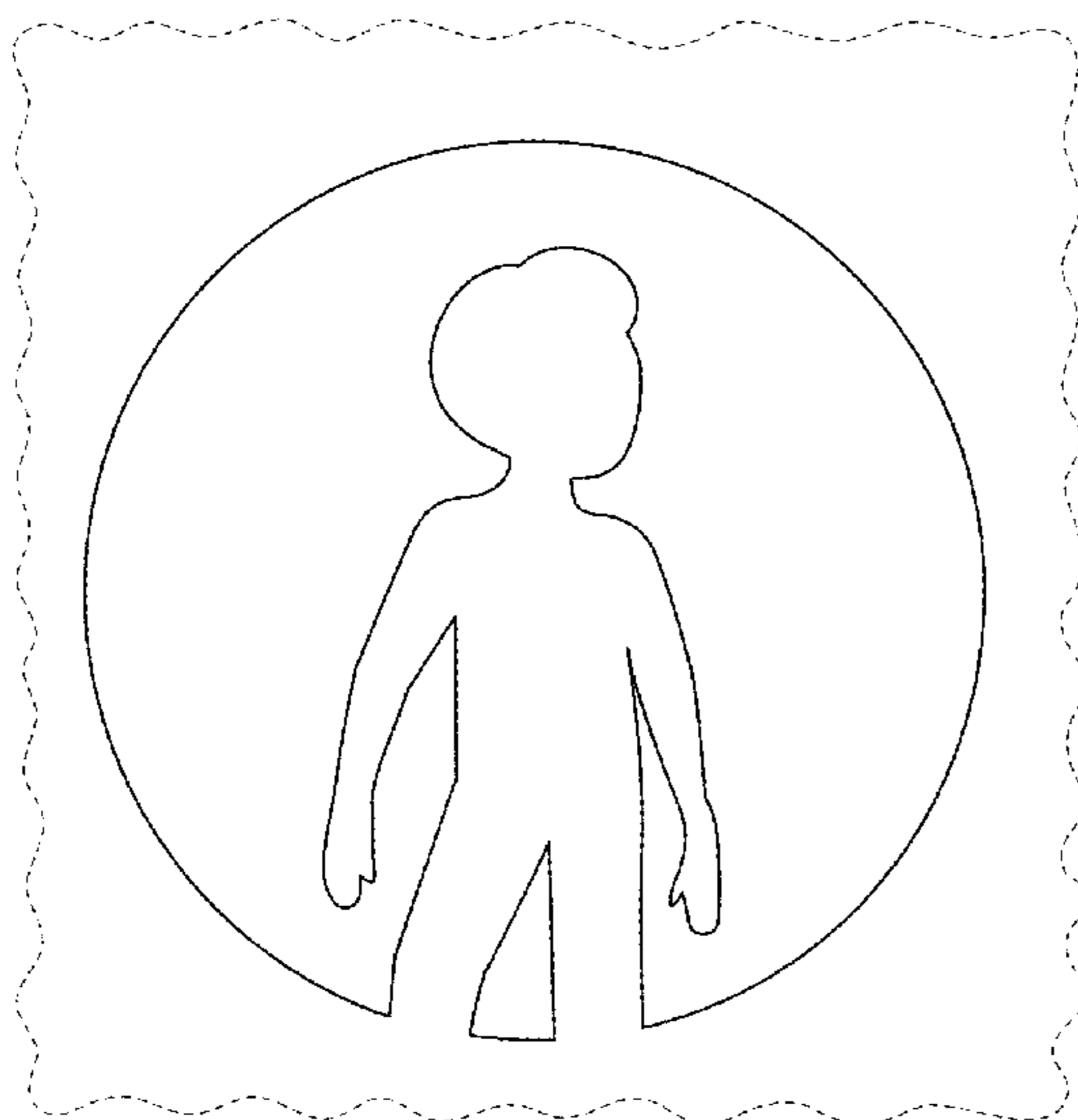
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of a display screen with icon showing my/our new design; FIG. 2 is a front view of the display screen with icon showing an alternative embodiment of the new design; and, FIG. 3 is a front view of the display screen with icon of FIG. 1 shown on a device. 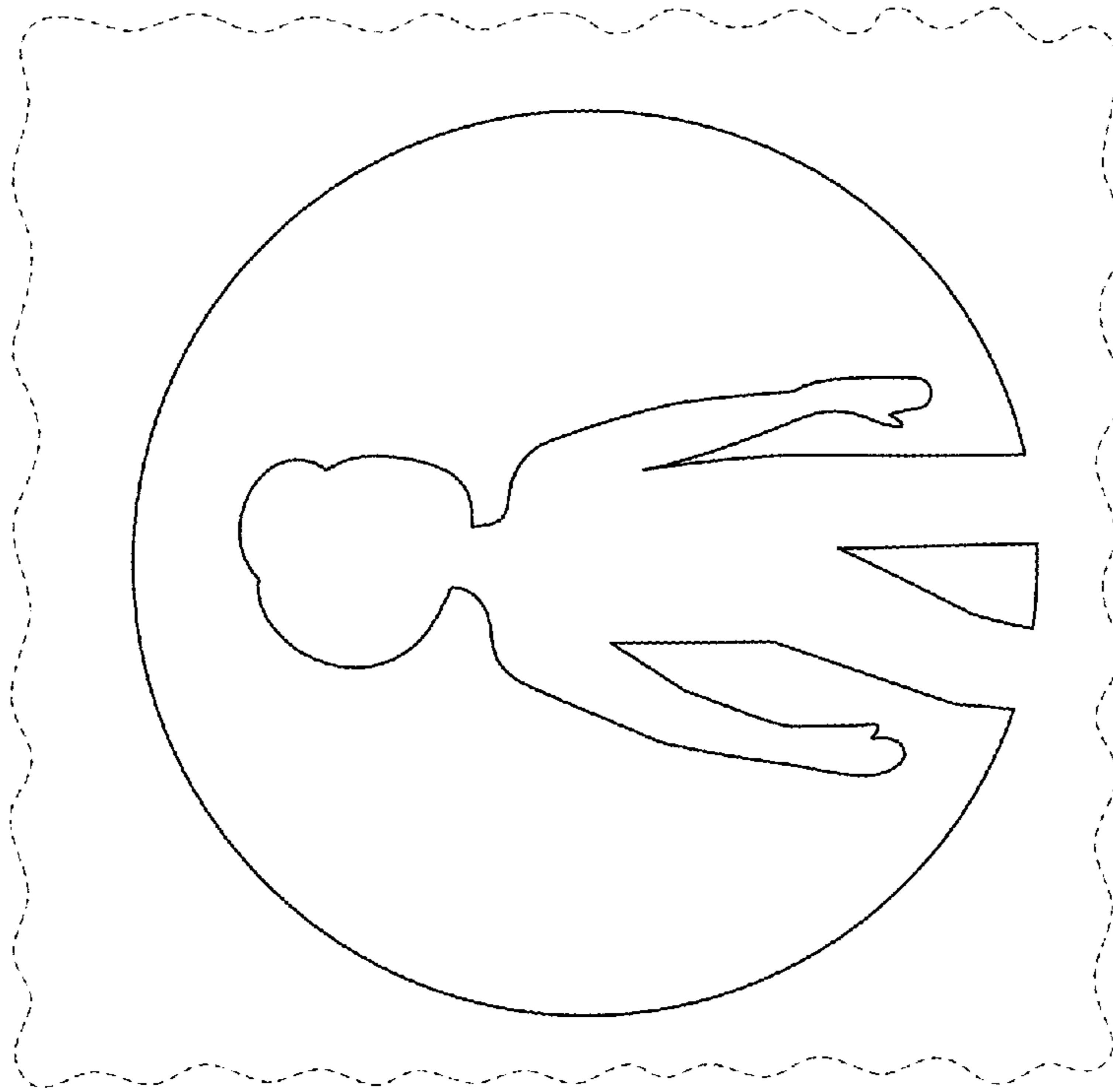

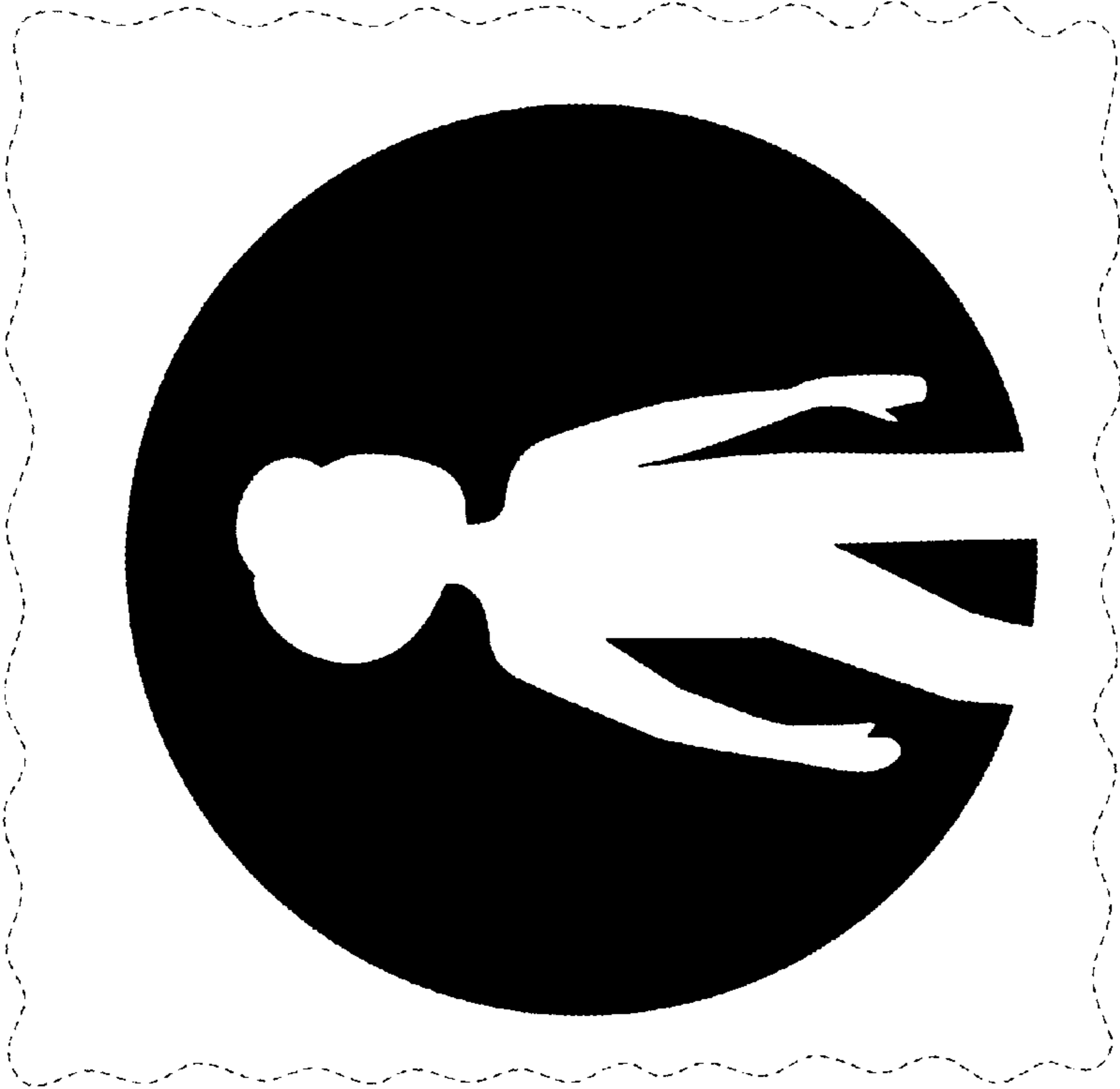

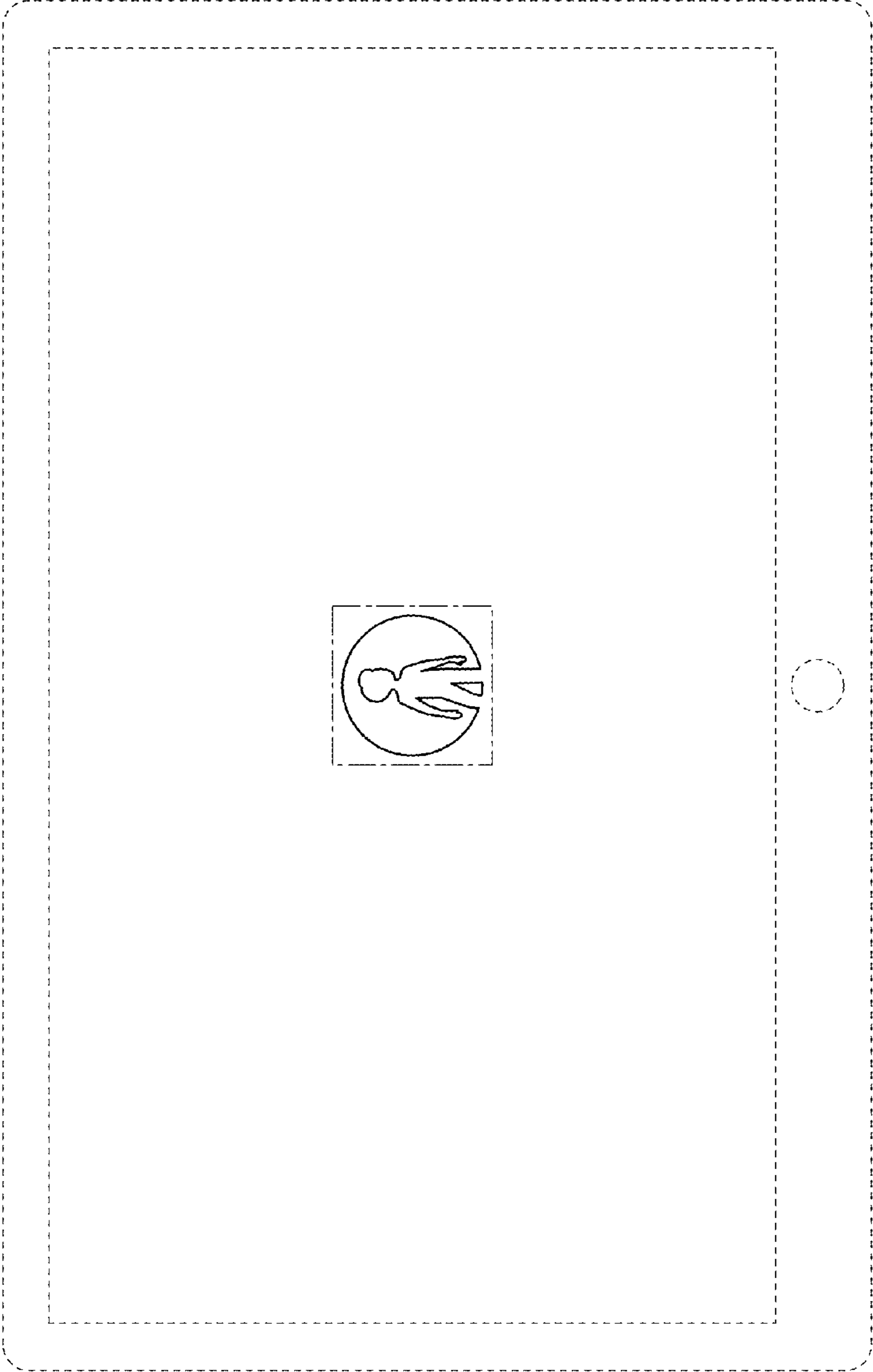
