(57) **CLAIM**

The ornamental design for a vertical pocket folder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of vertical pocket folder, showing the flap partially open.

FIG. 2 is a second perspective view of vertical pocket folder, showing the flap completely open.

FIG. 3 is an interior view of the vertical pocket folder showing the flap, midsection, pocket section and flaps in a flat orientation; and,

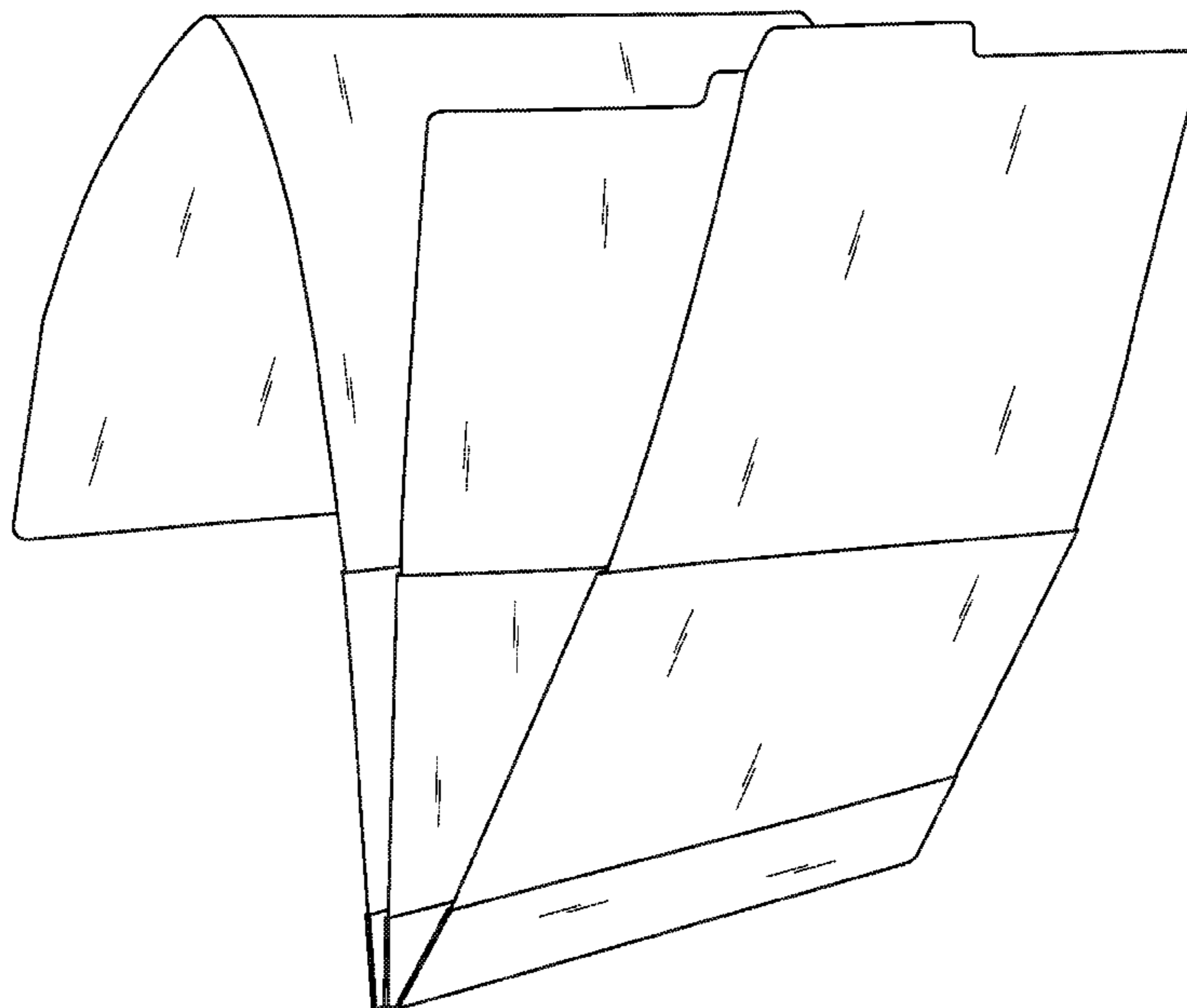
FIG. 4 is a second interior view of the vertical pocket folder, like FIG. 3, showing the flaps folded away.

The folder is symmetric with respect to left and rights sides. The broken lines in the drawings illustrate portions of the vertical pocket folder and form no part of the claimed design.

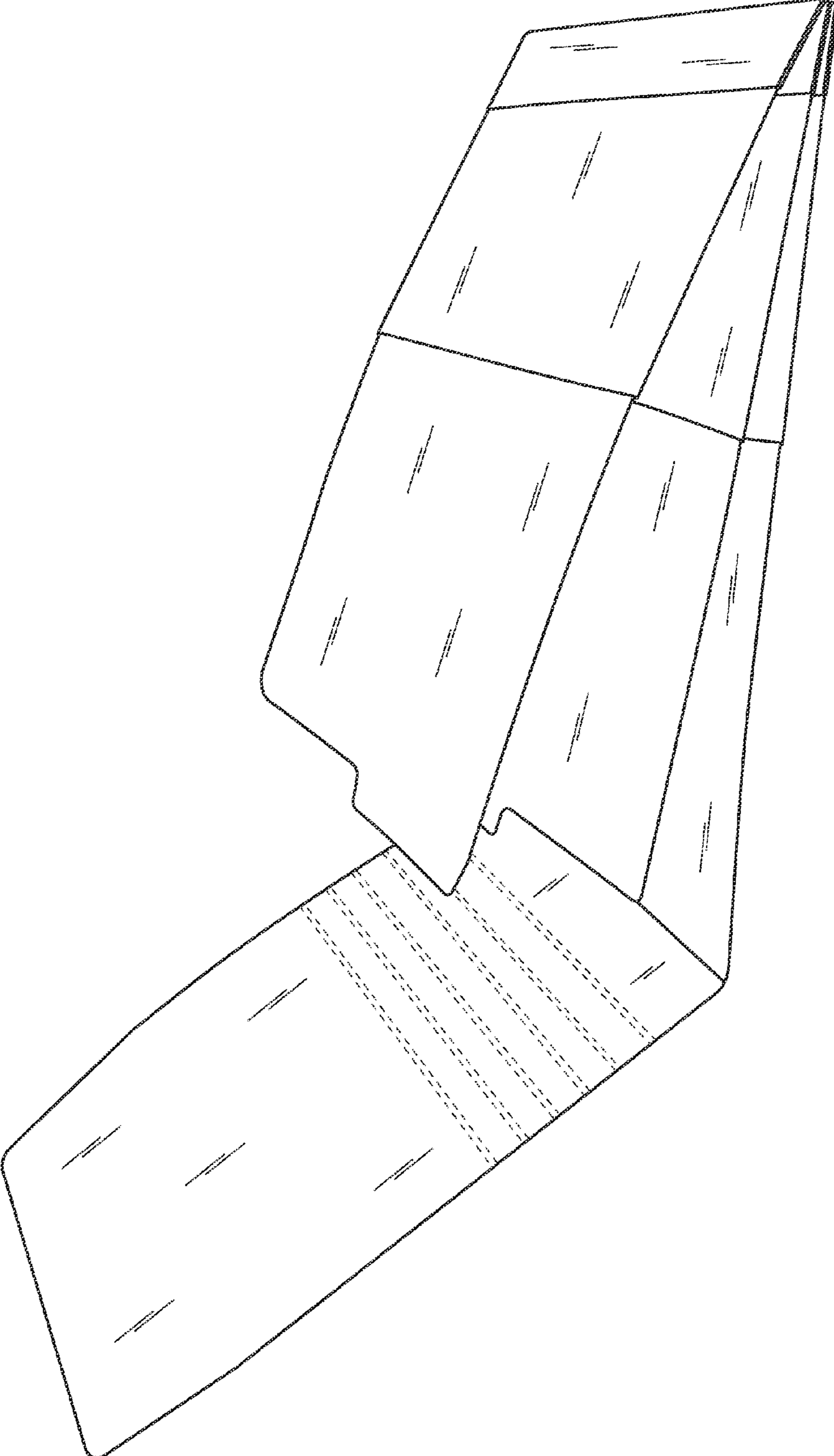

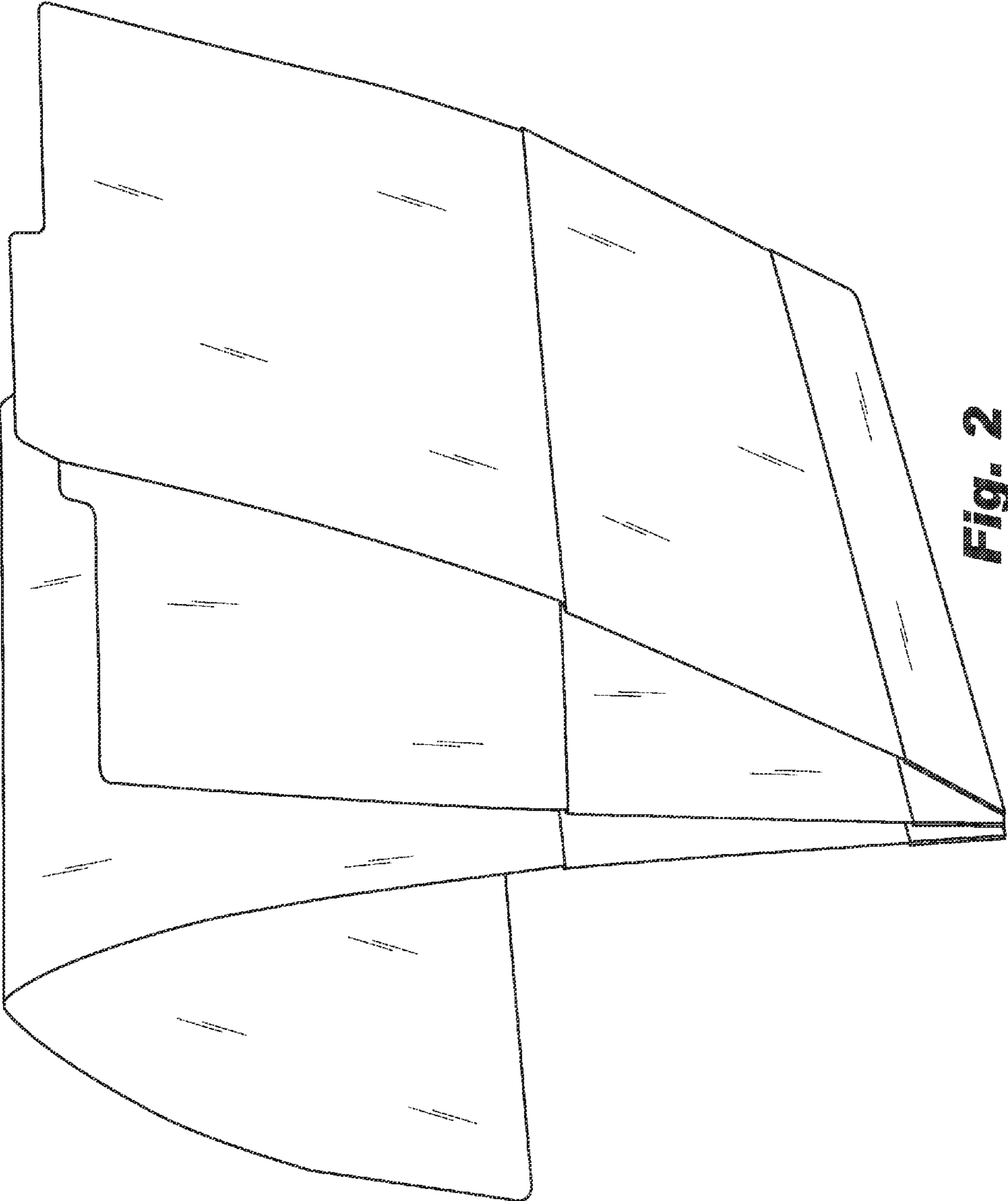

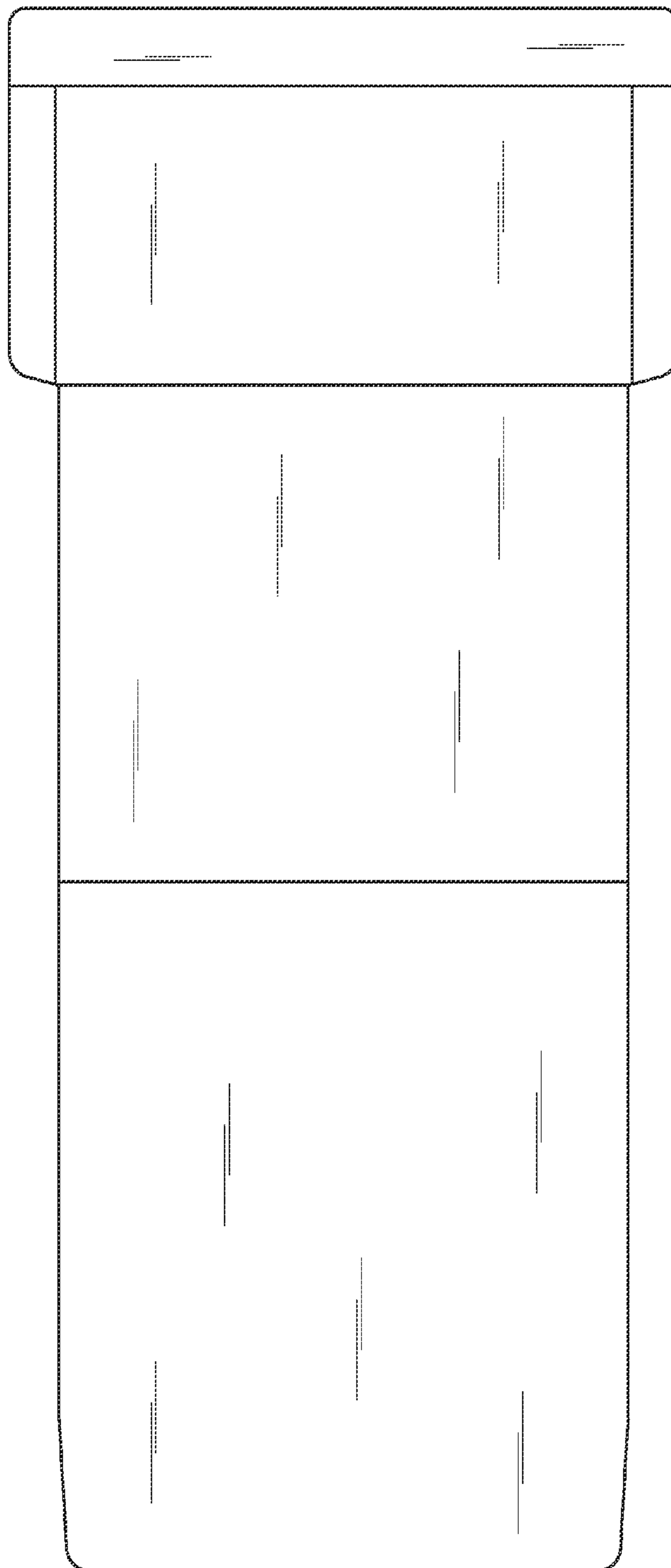

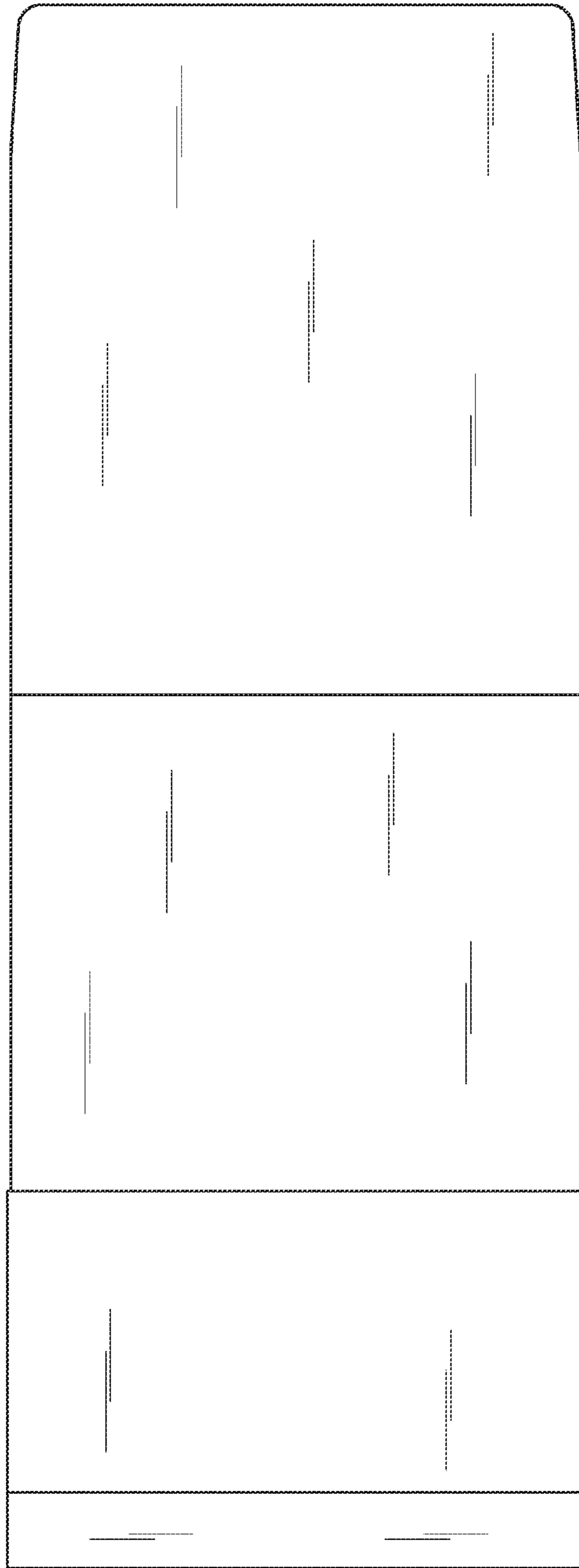
