(57) **CLAIM**

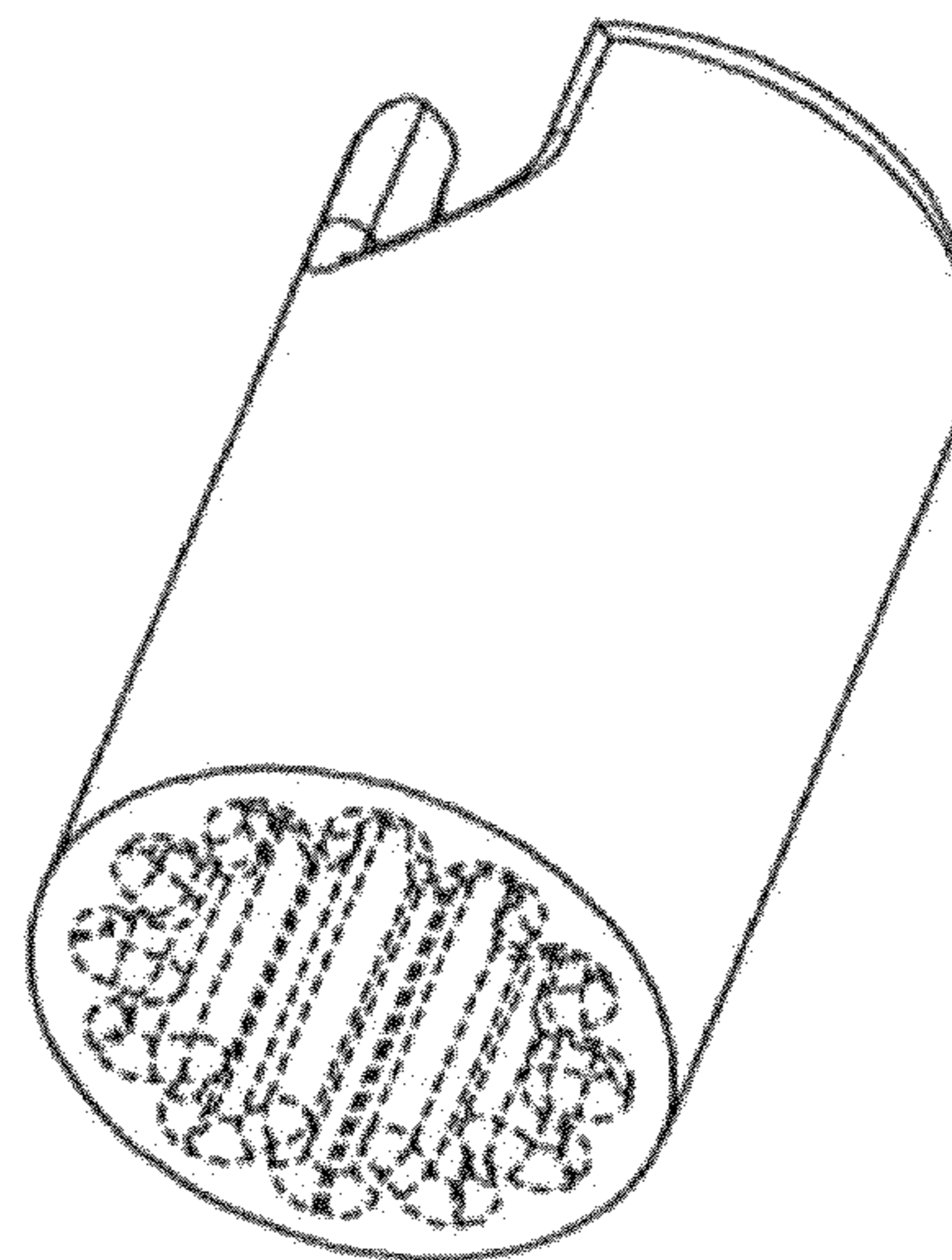
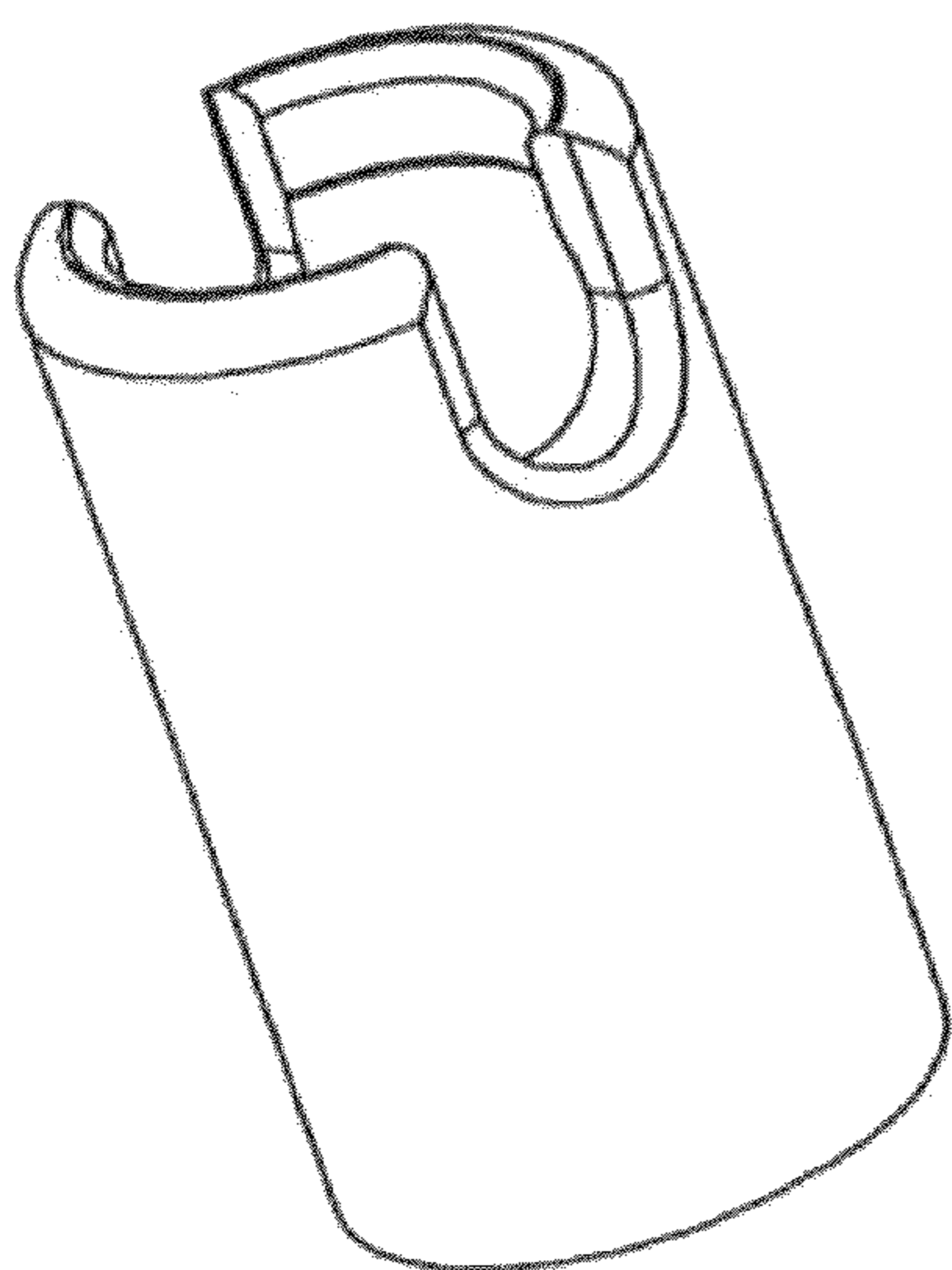
We claim the ornamental design for a toy building block, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a toy building block embodying our design;
FIG. 2 is a bottom perspective view of FIG. 1;
FIG. 3 is a side view of FIG. 1;
FIG. 4 is a side view of FIG. 3 rotated 90 degrees;
FIG. 5 is a side view of FIG. 4 rotated 180 degrees;
FIG. 6 is a top plan view of FIG. 1; and,
FIG. 7 is a bottom view of FIG. 1.

The broken lines illustrate a portion of a toy building block that forms no part of the claimed design.

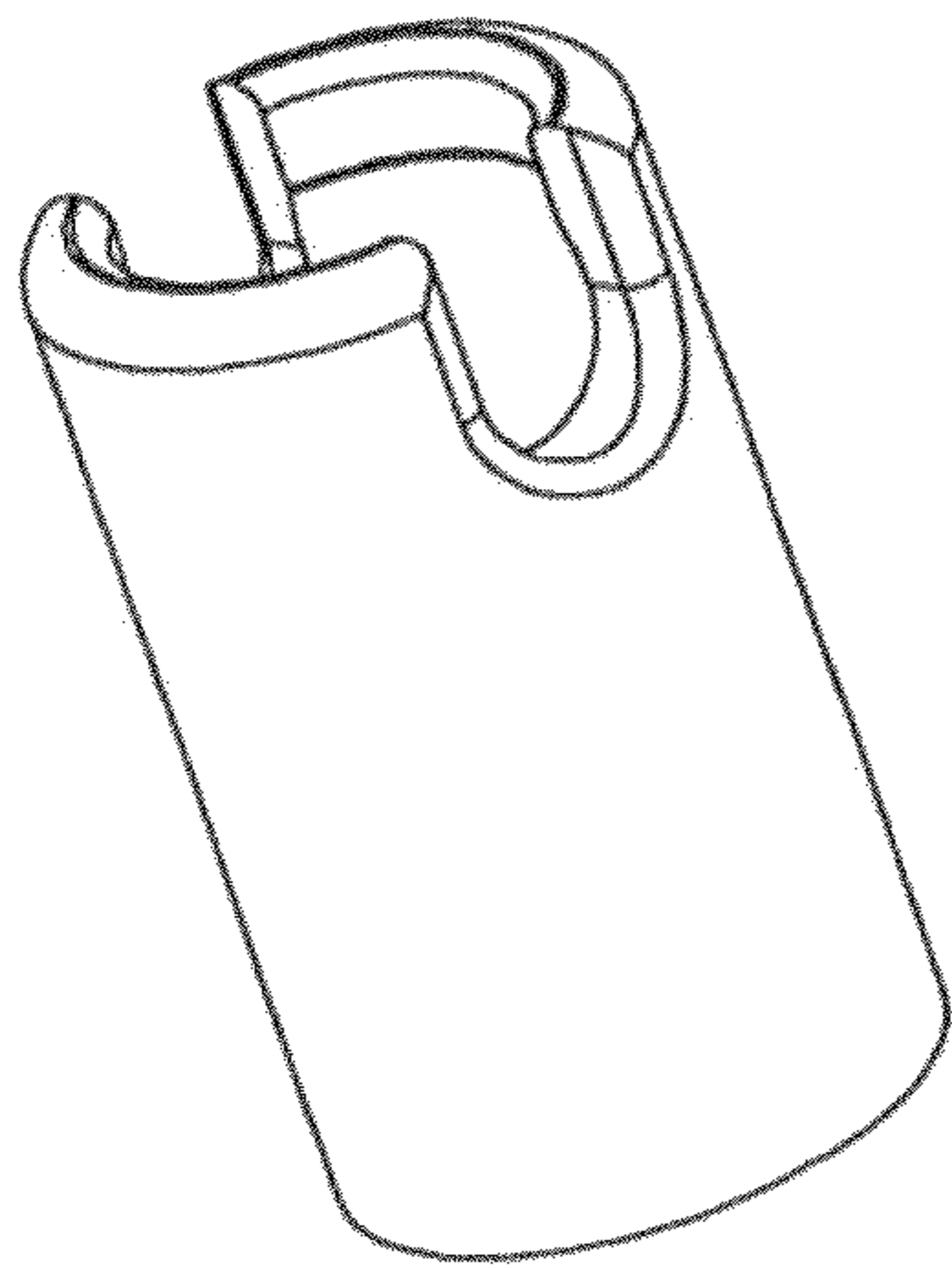

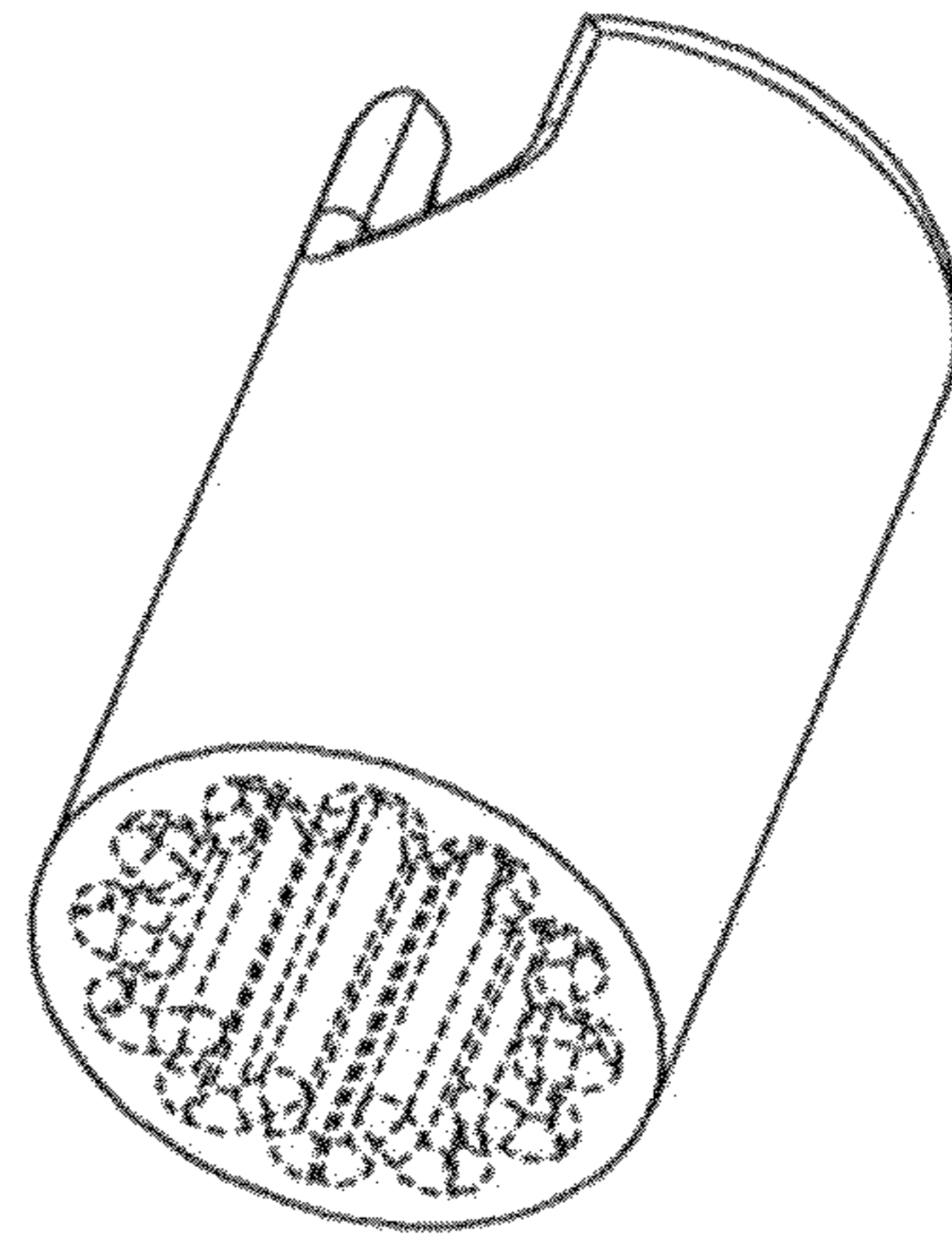

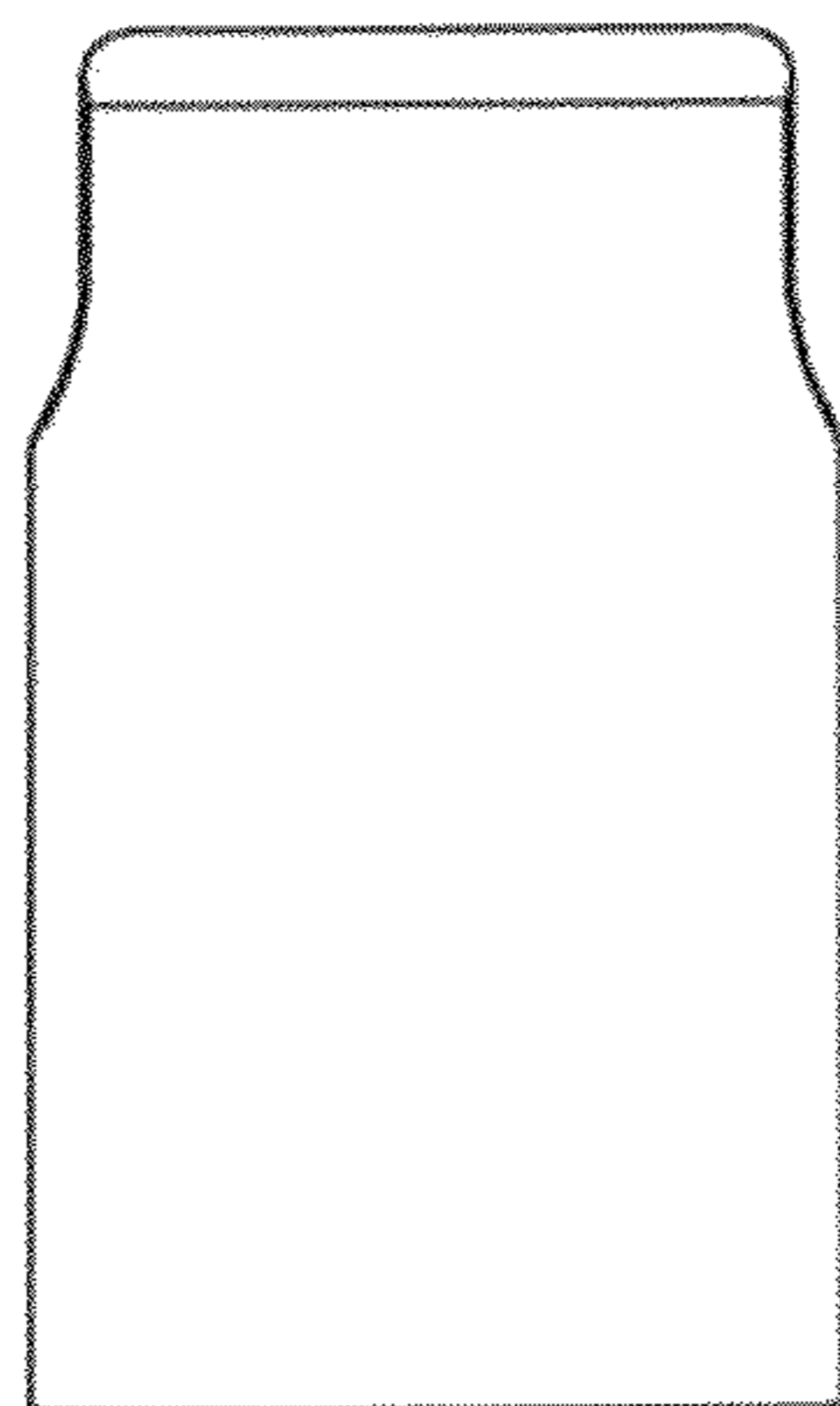

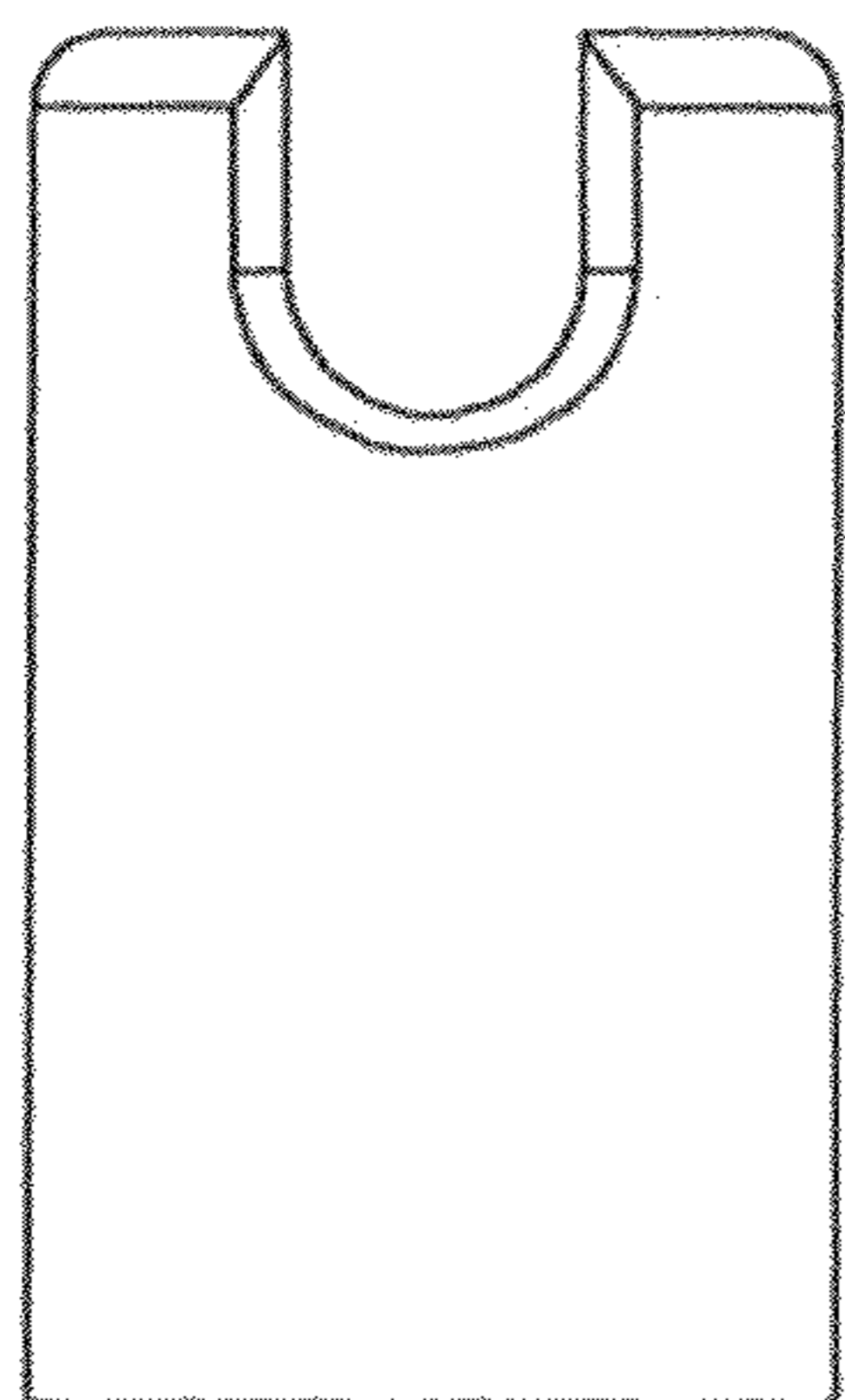

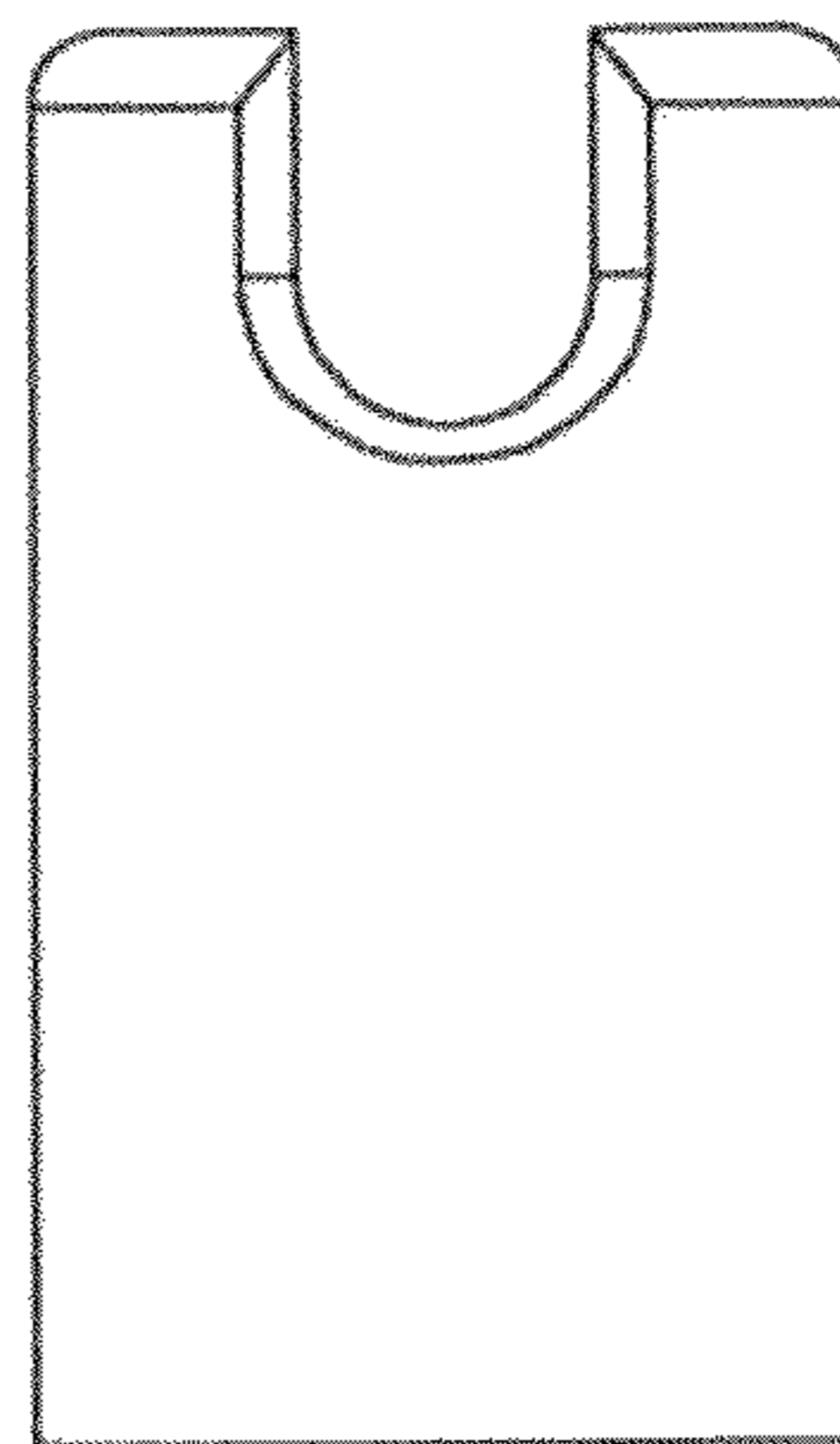

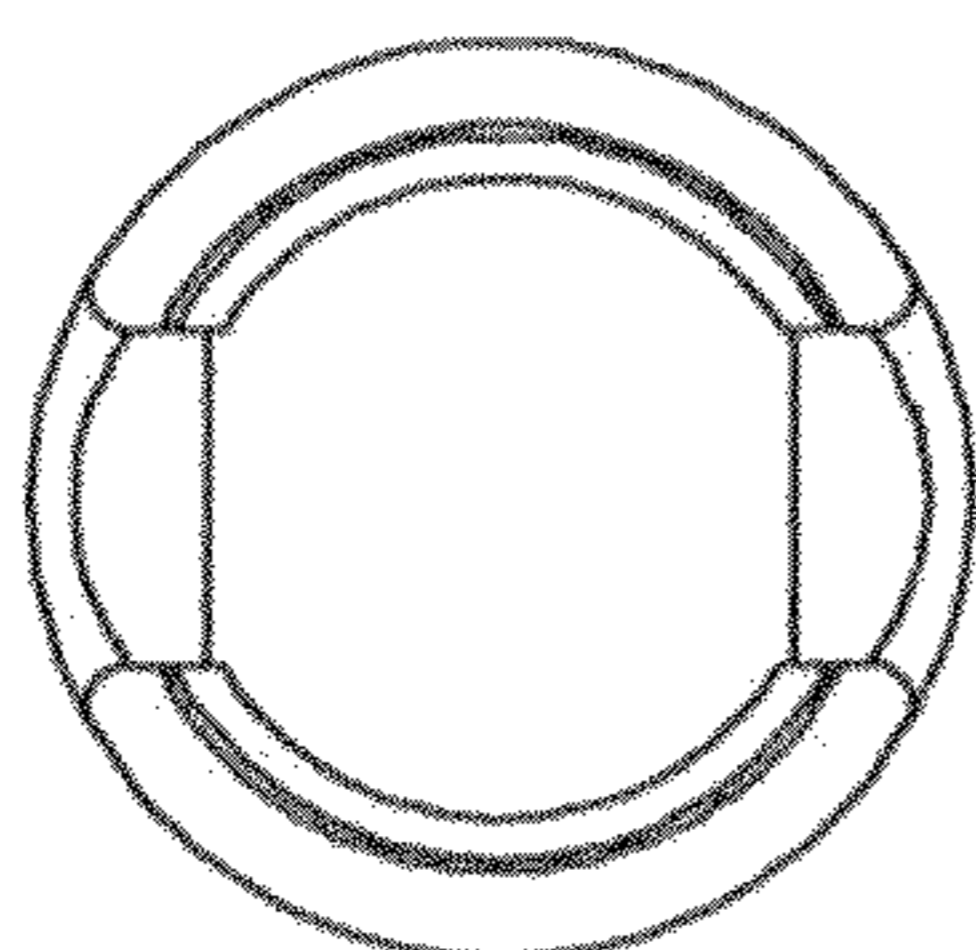

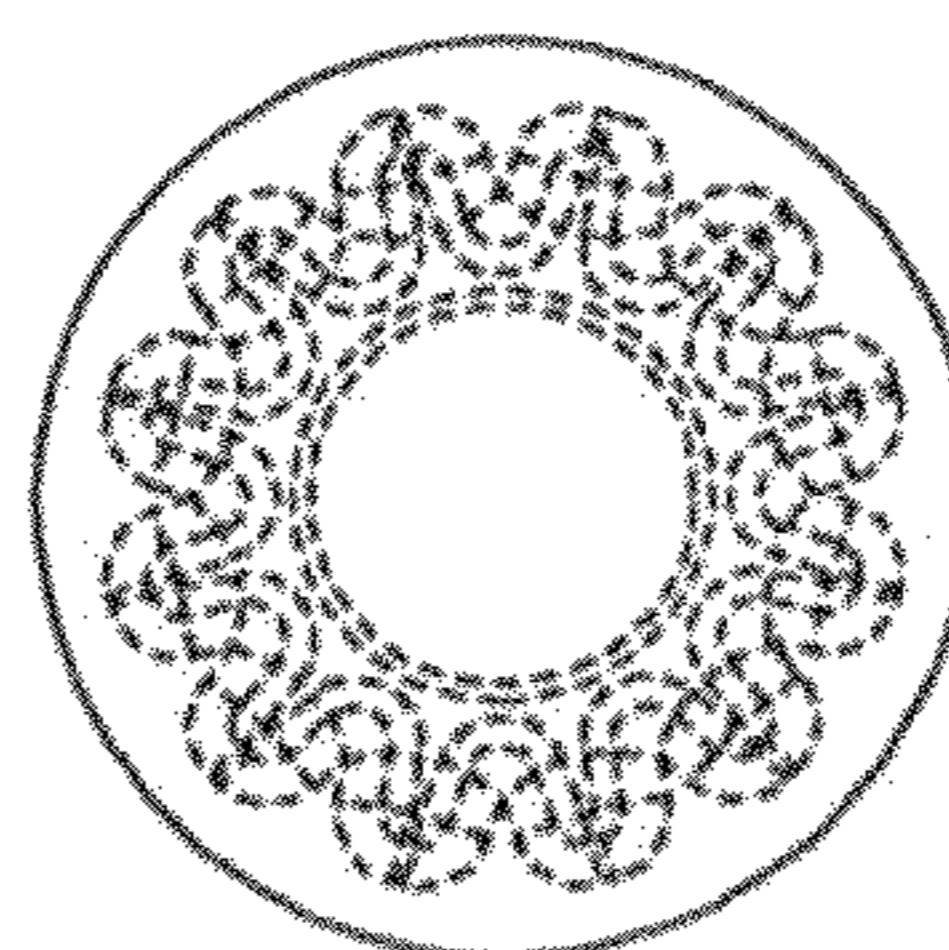
