FIG. 3 is a perspective view showing the article in an alternate state of use with a lid.

FIG. 4 is a top perspective view of the article as shown in FIG. 3.

FIG. 5 is a side view of the front of the new grease containment bucket design.

FIG. 6 is a side view of a first side of new grease containment bucket design.

FIG. 7 is a side view of a second, opposite side of new grease containment bucket design.

FIG. 8 is a rear perspective view of the article as shown in FIG. 3.

FIG. 9 is a bottom view of the new grease containment bucket design.

FIG. 10 is an enlarged top perspective view of the interior of the grease containment bucket.

FIG. 11 is an alternative perspective view of the lower portion of FIG. 10.

FIG. 12 is another alternative perspective view of FIG. 10; and,

FIG. 13 is an enlarged perspective view of the interior element of the grease containment bucket.

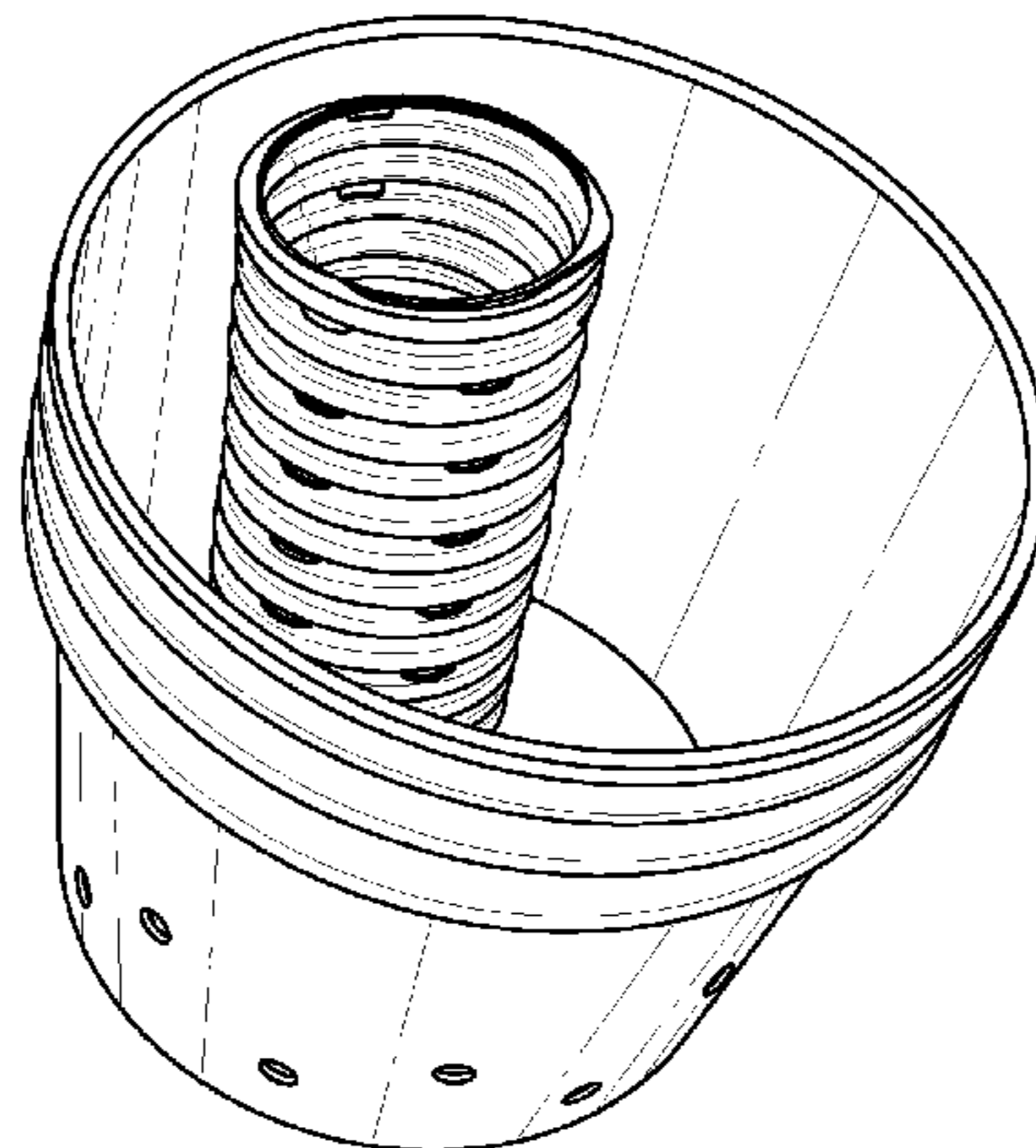

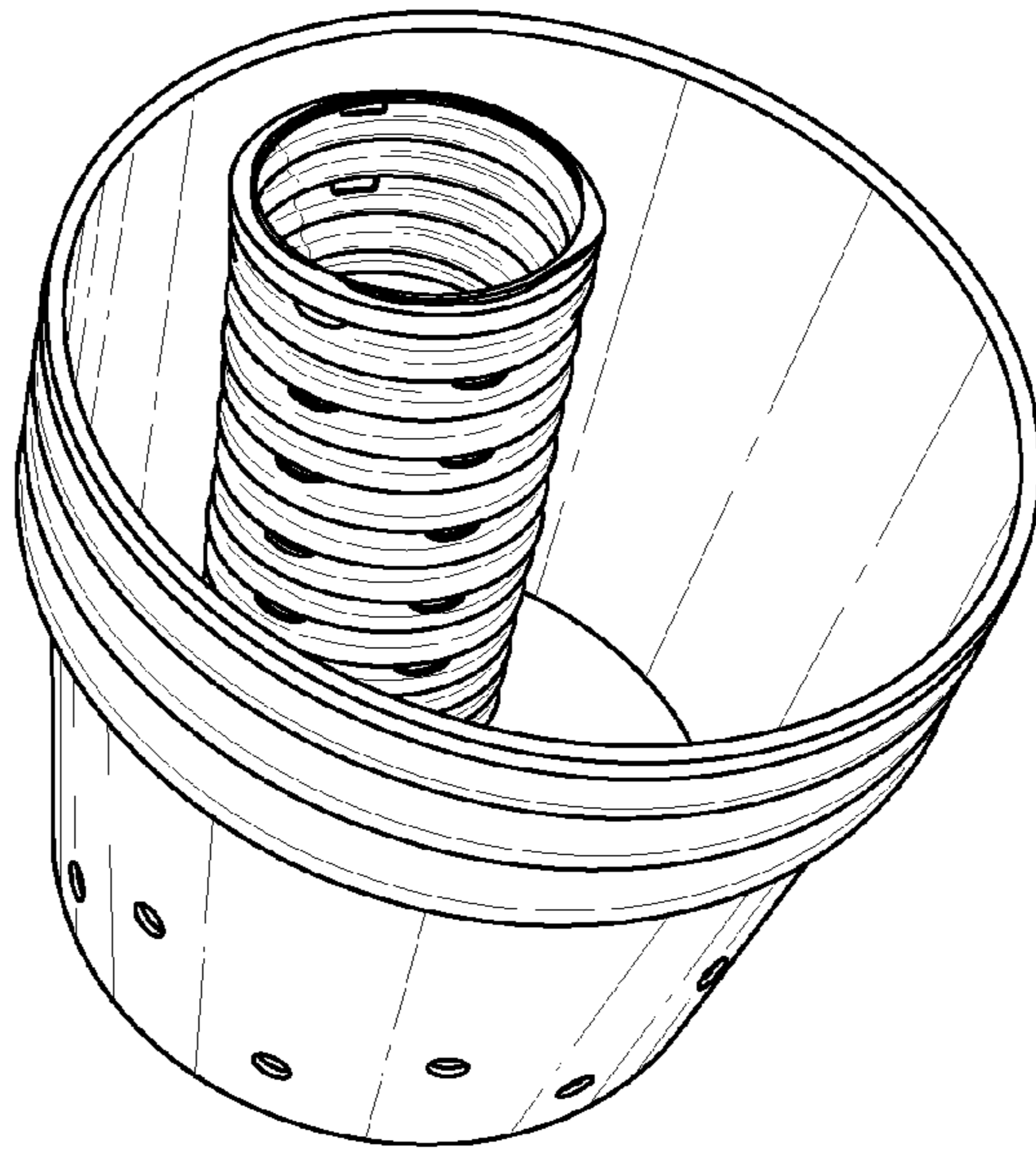

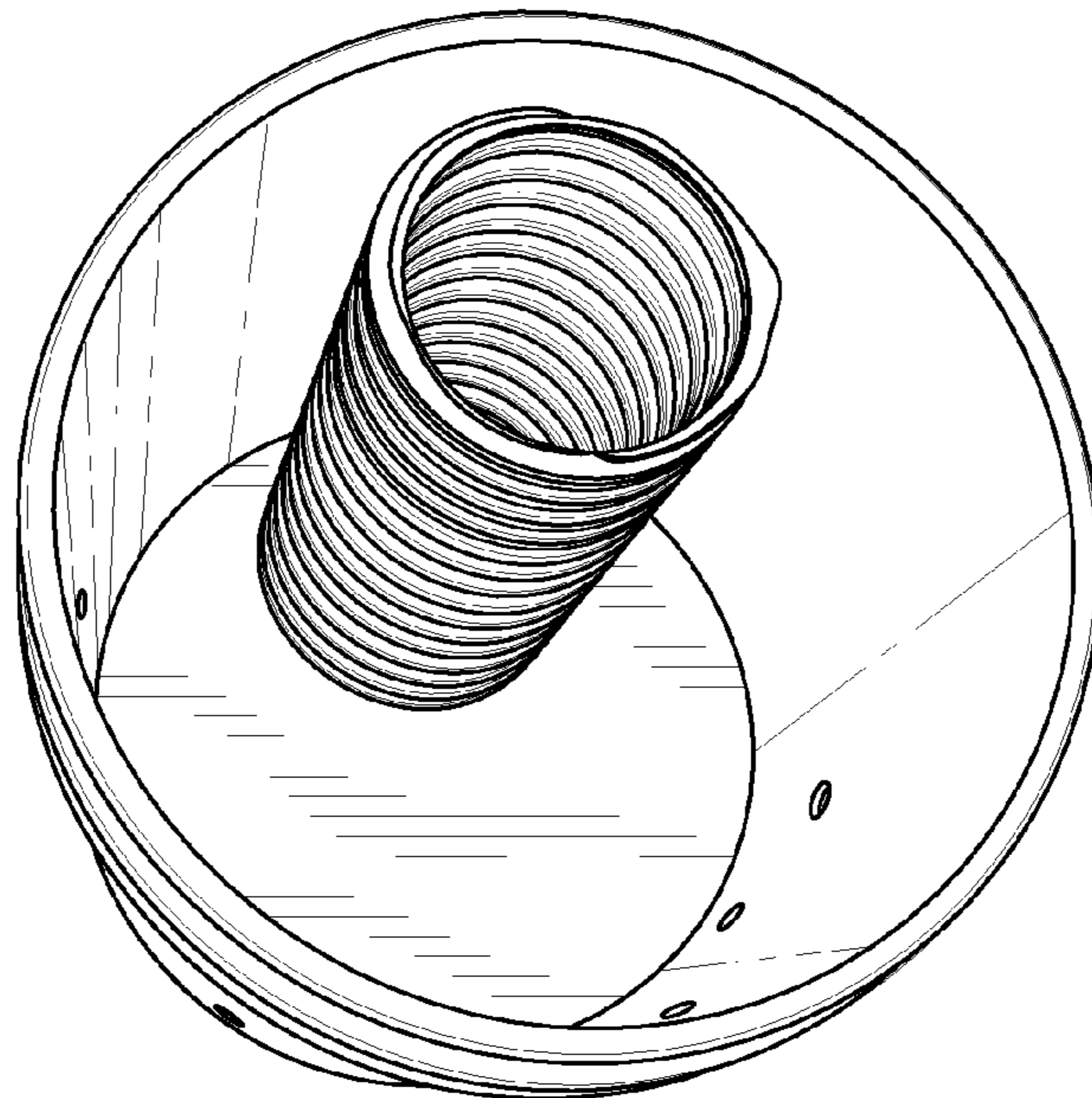

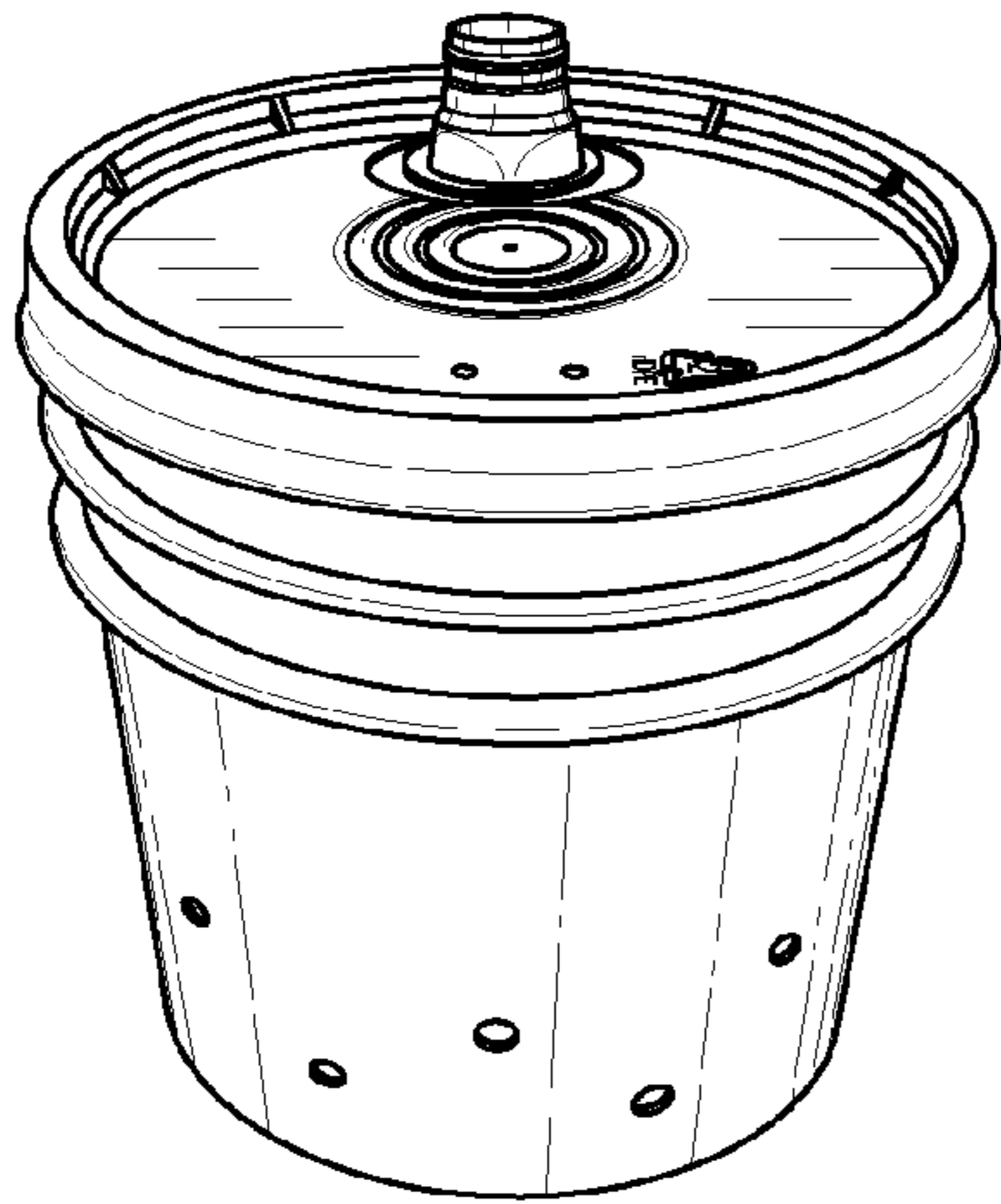

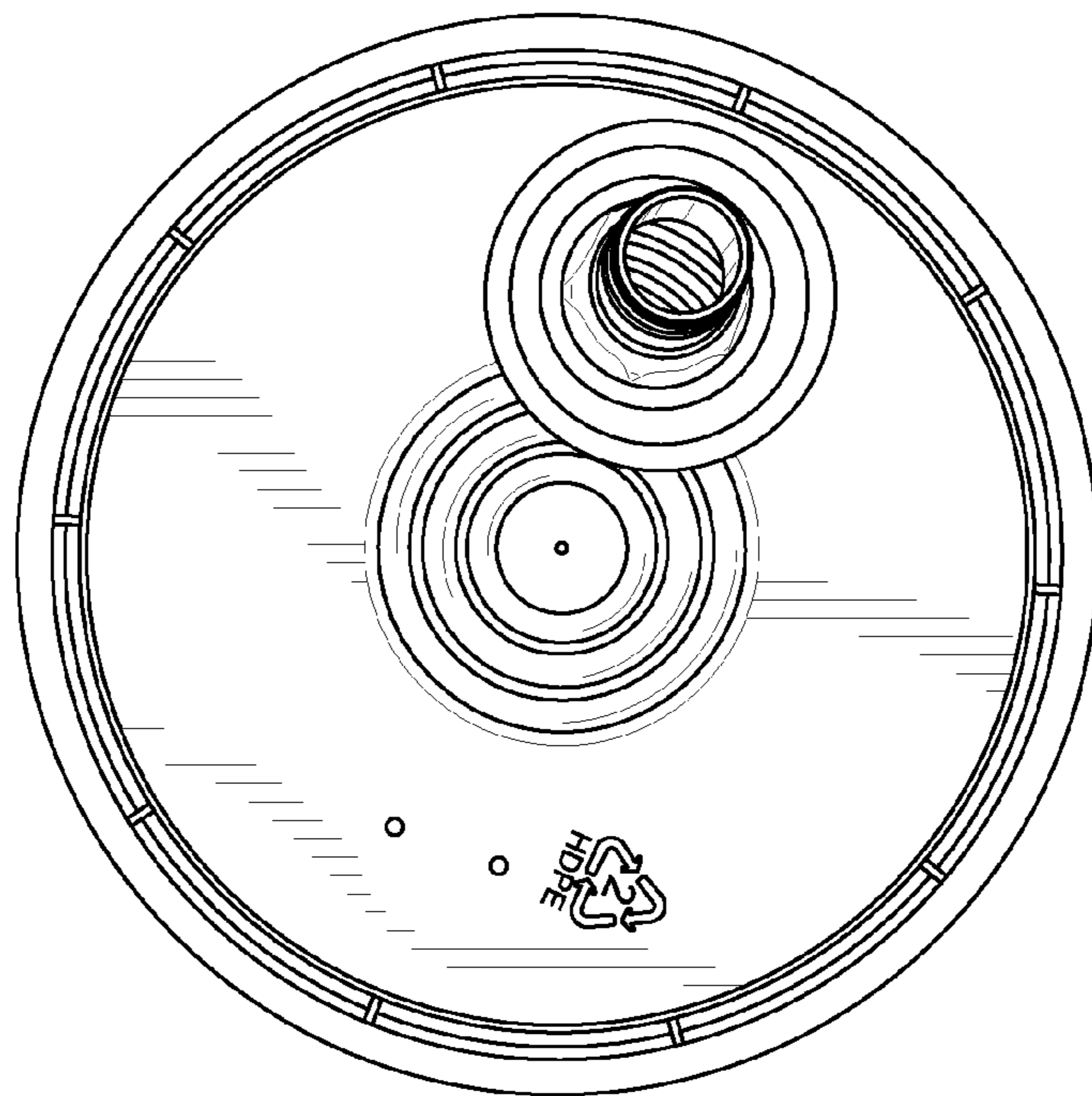

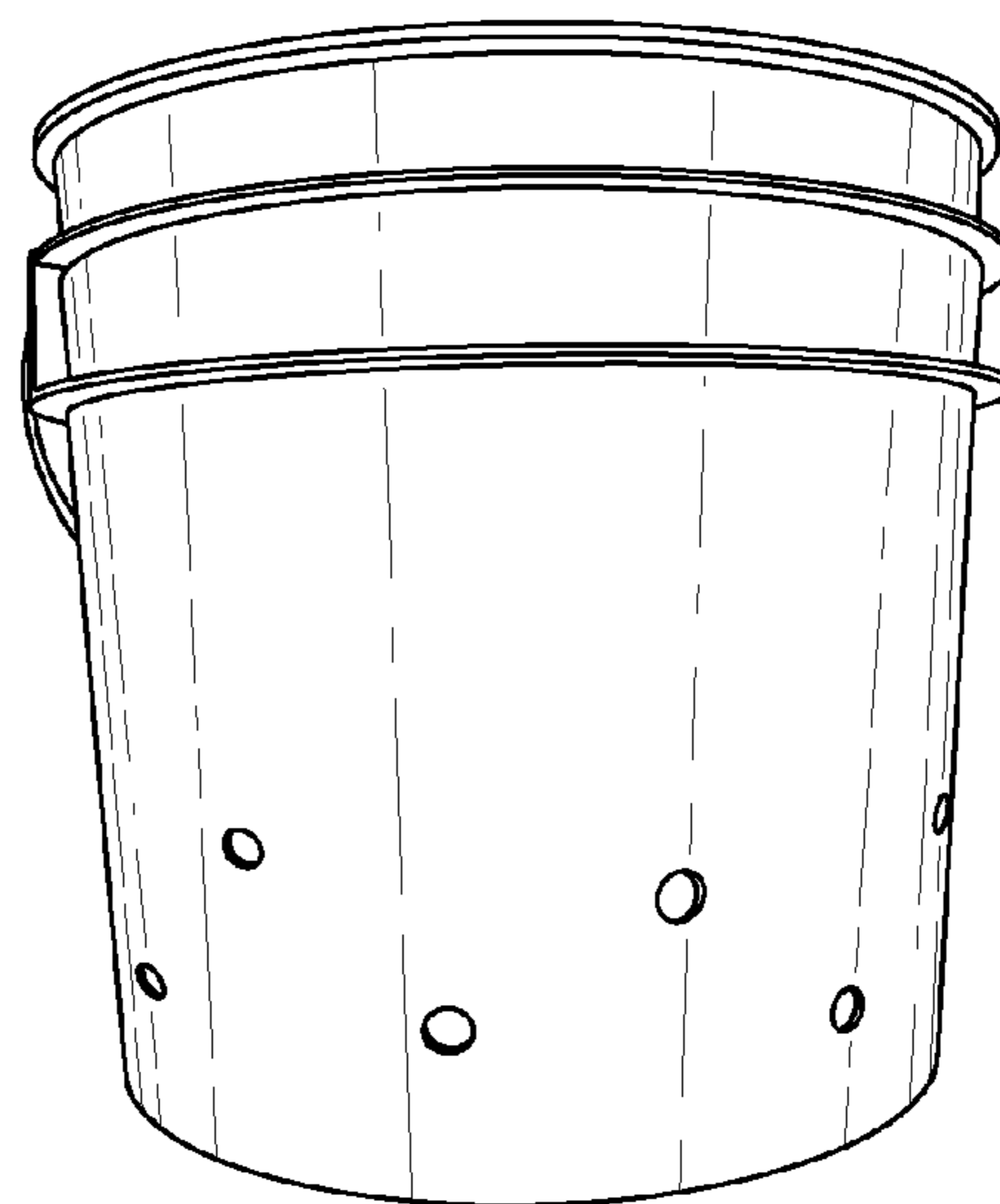

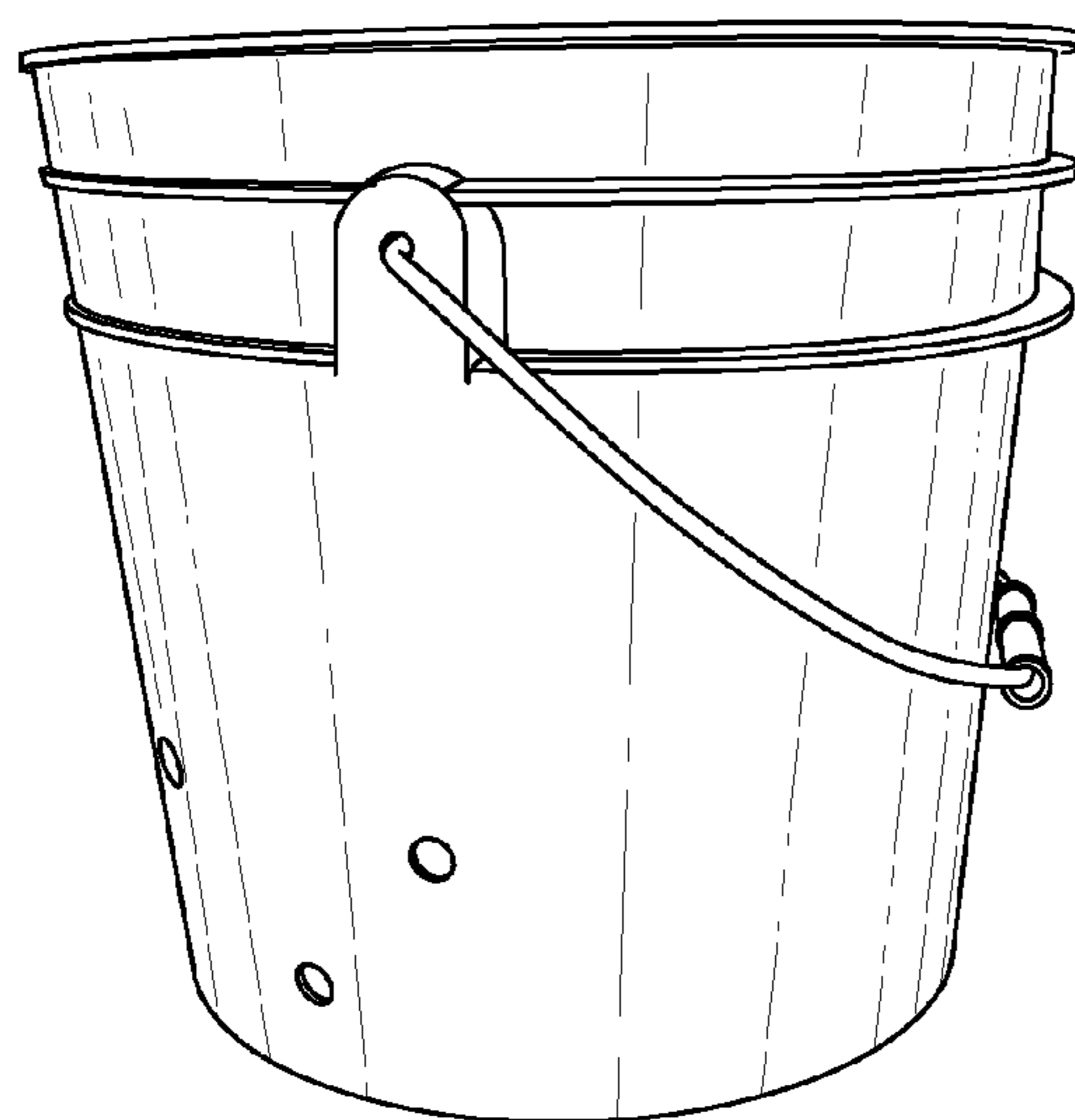

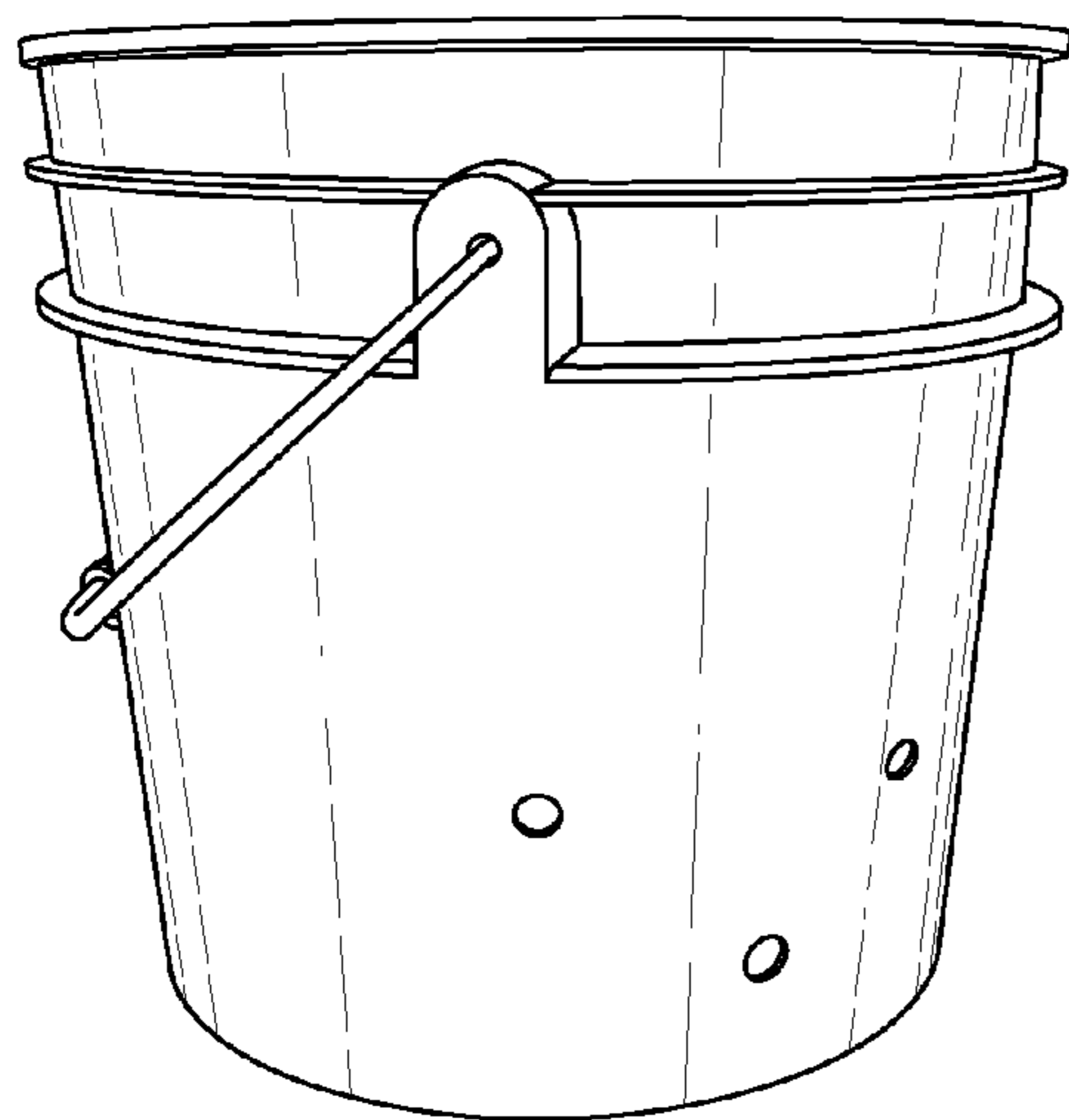

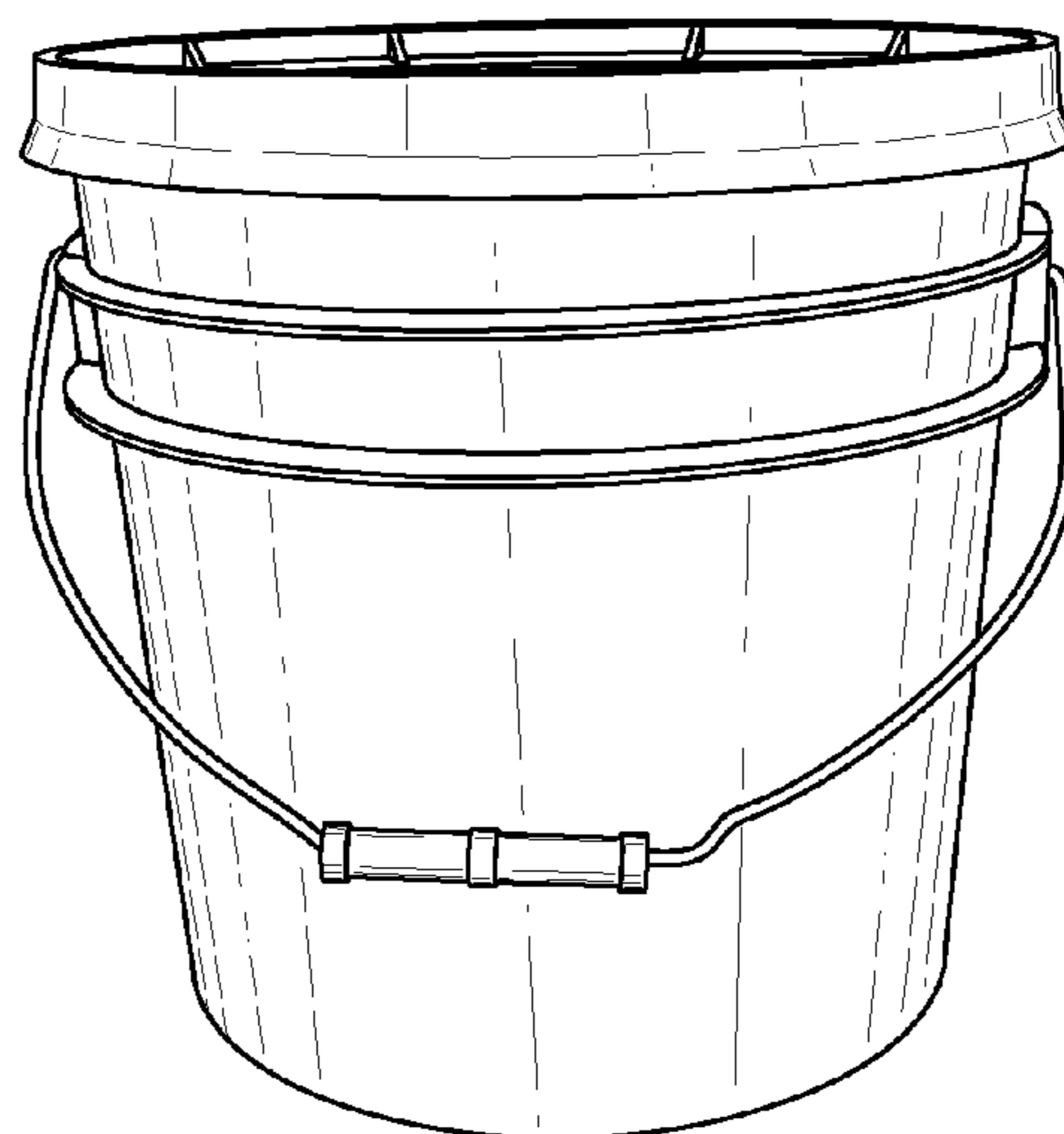

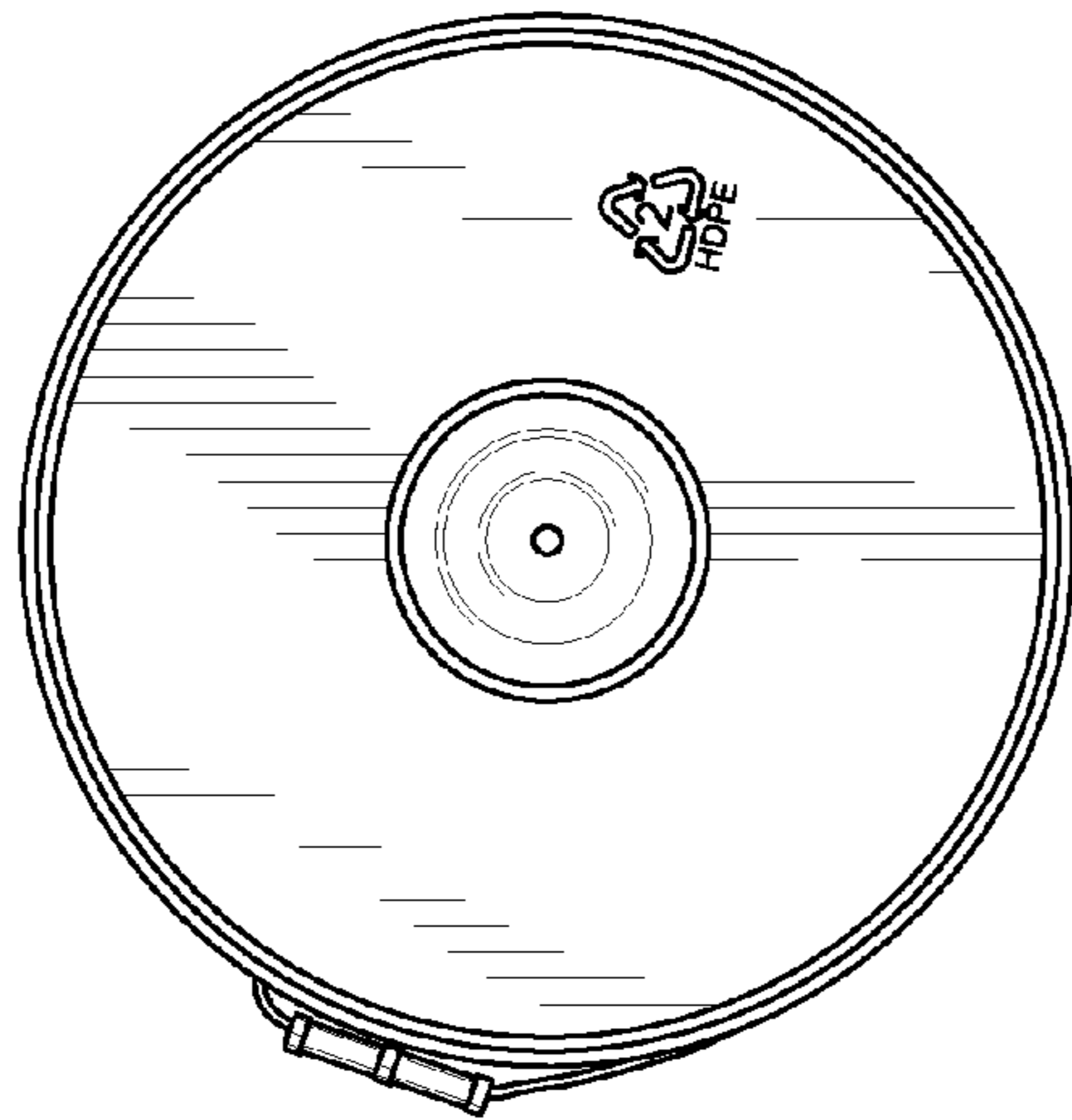

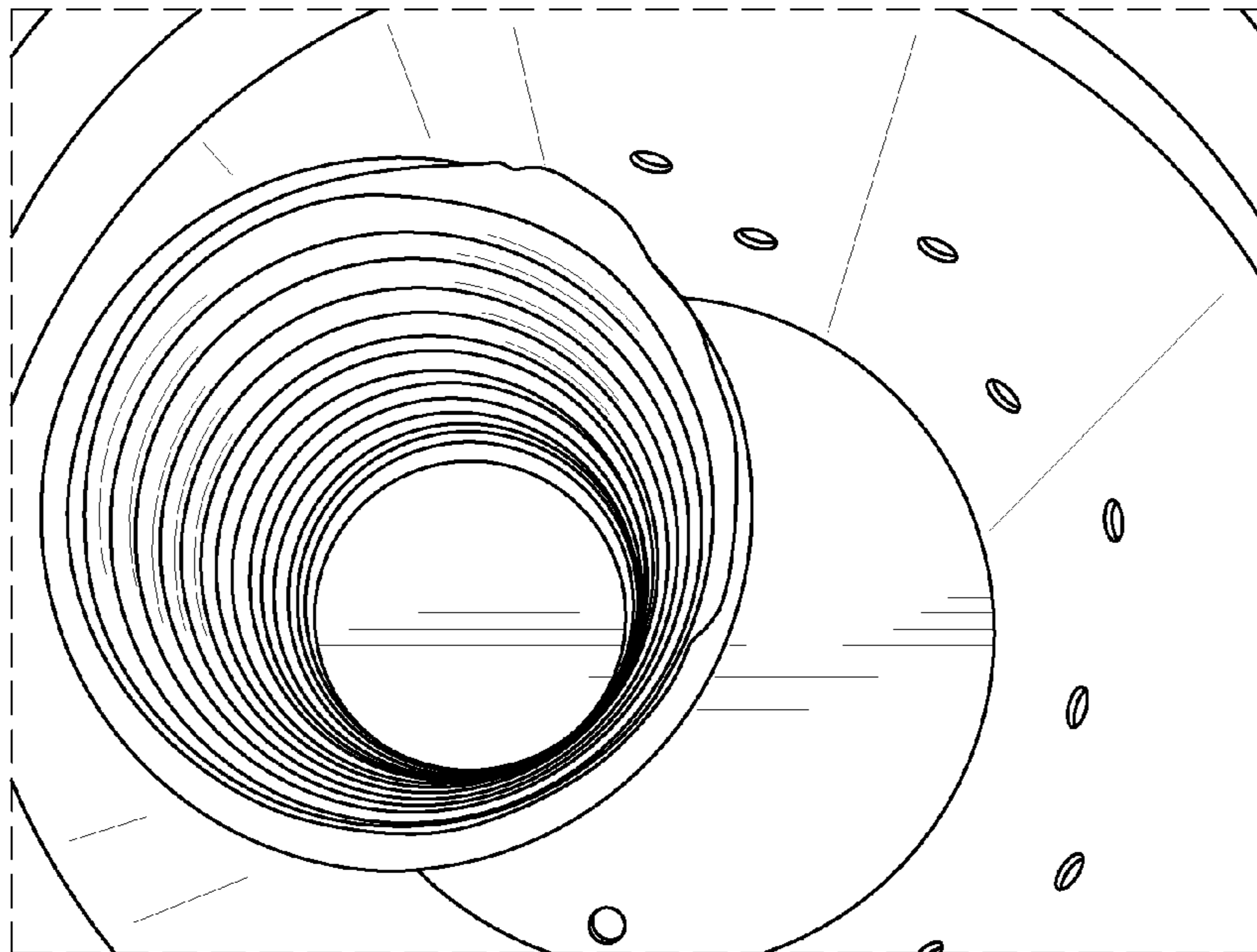

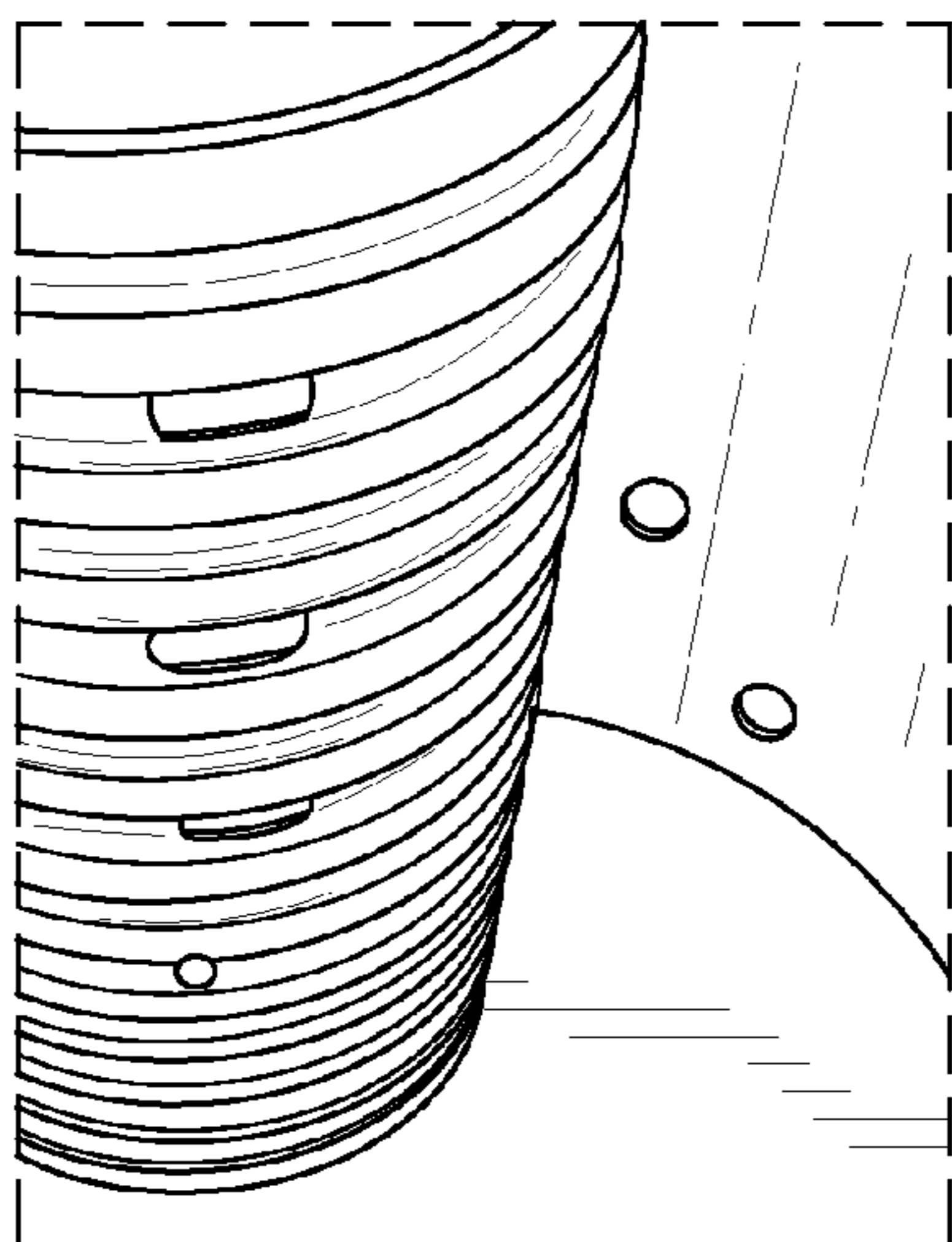

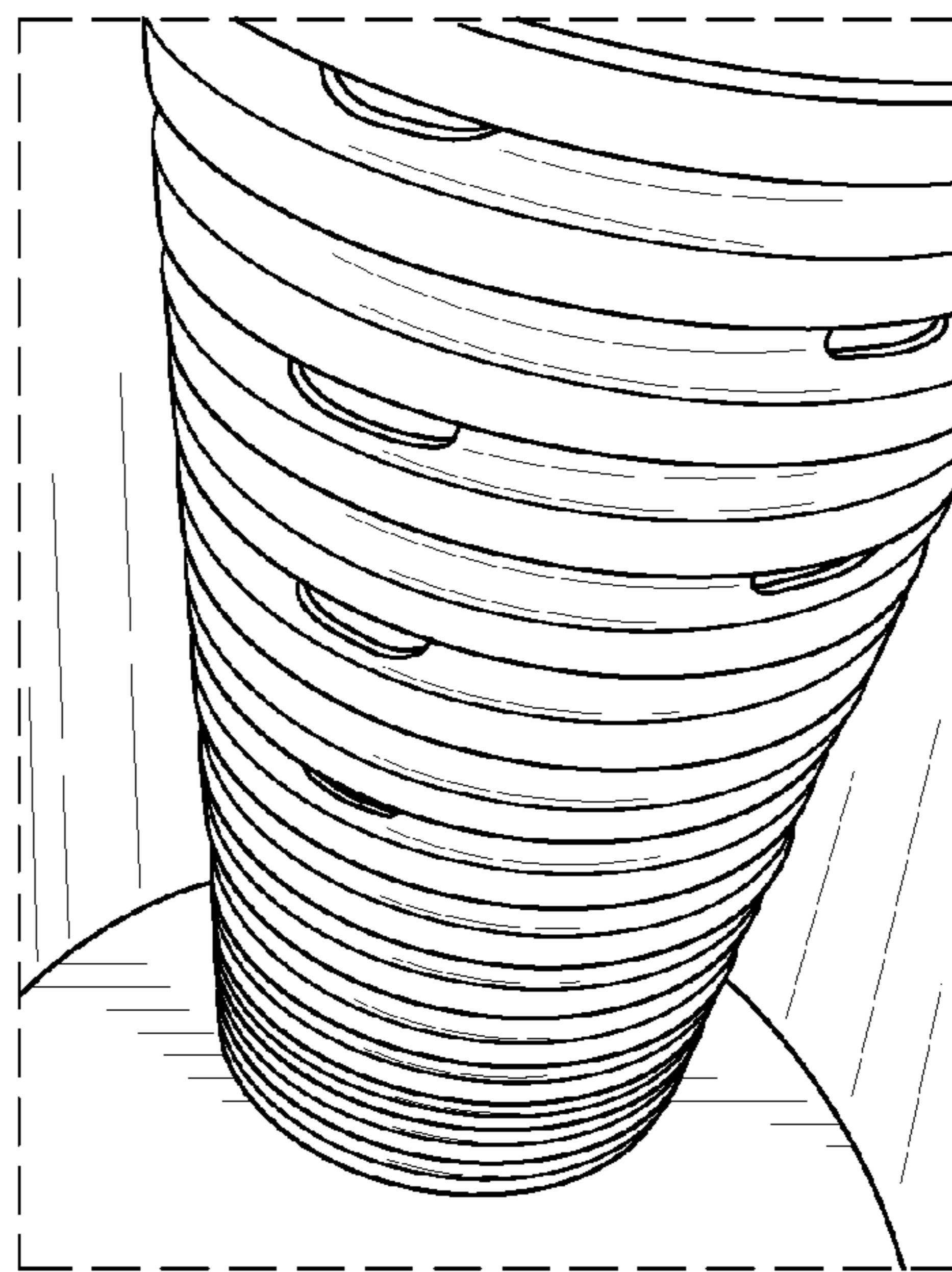

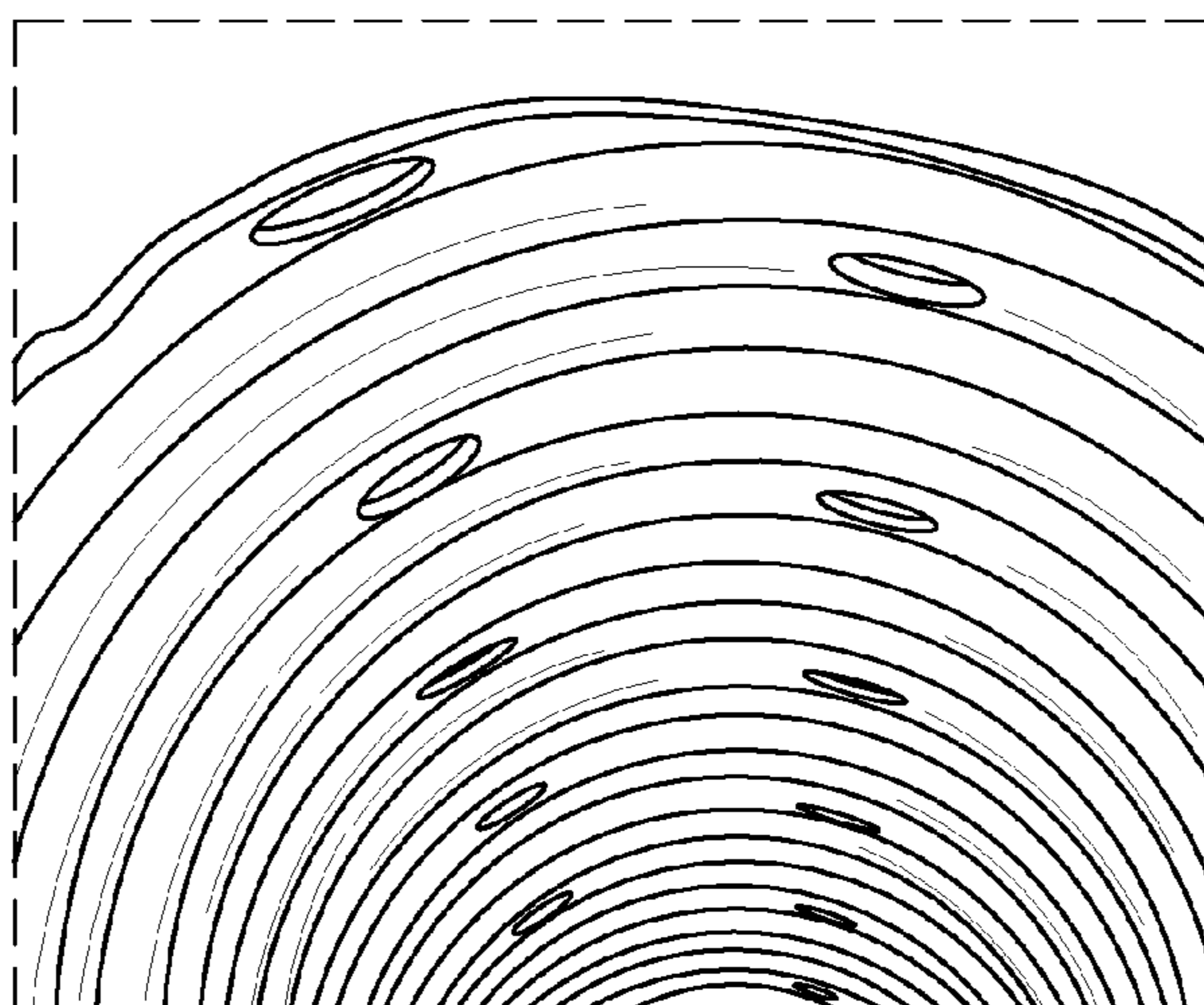
