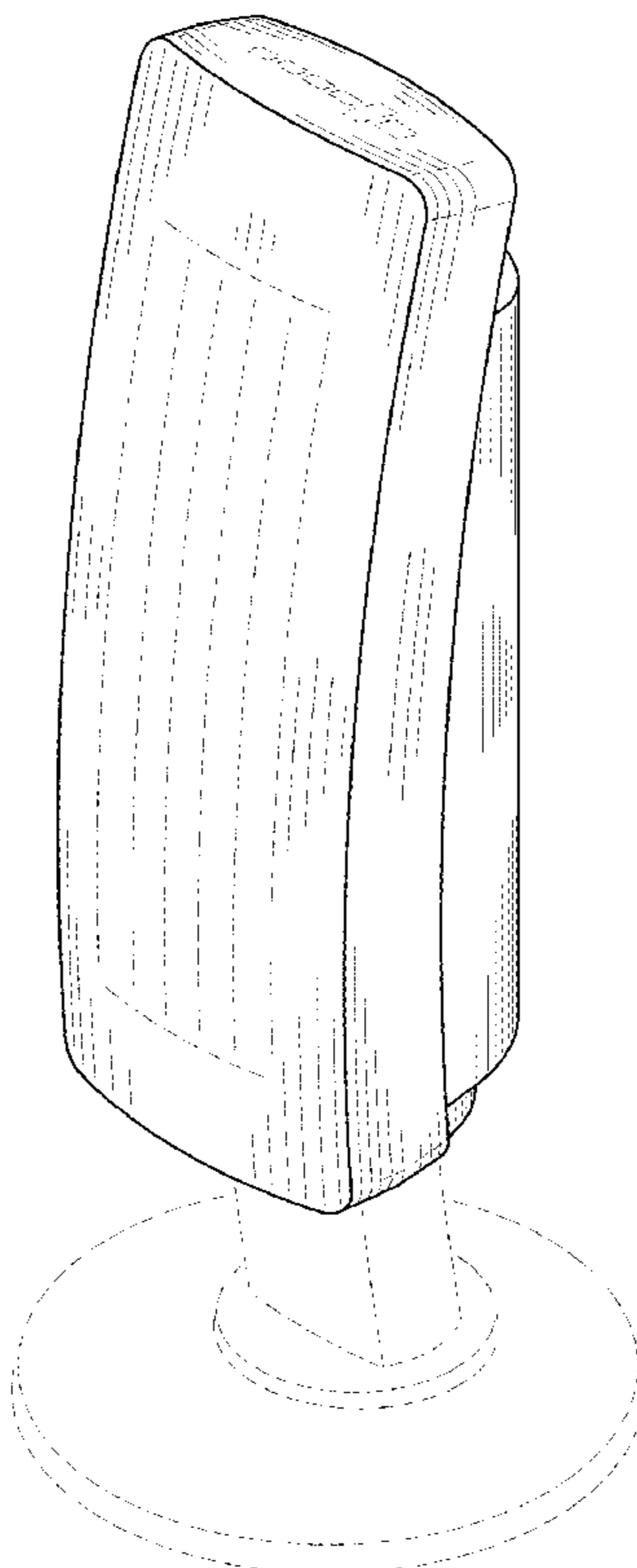

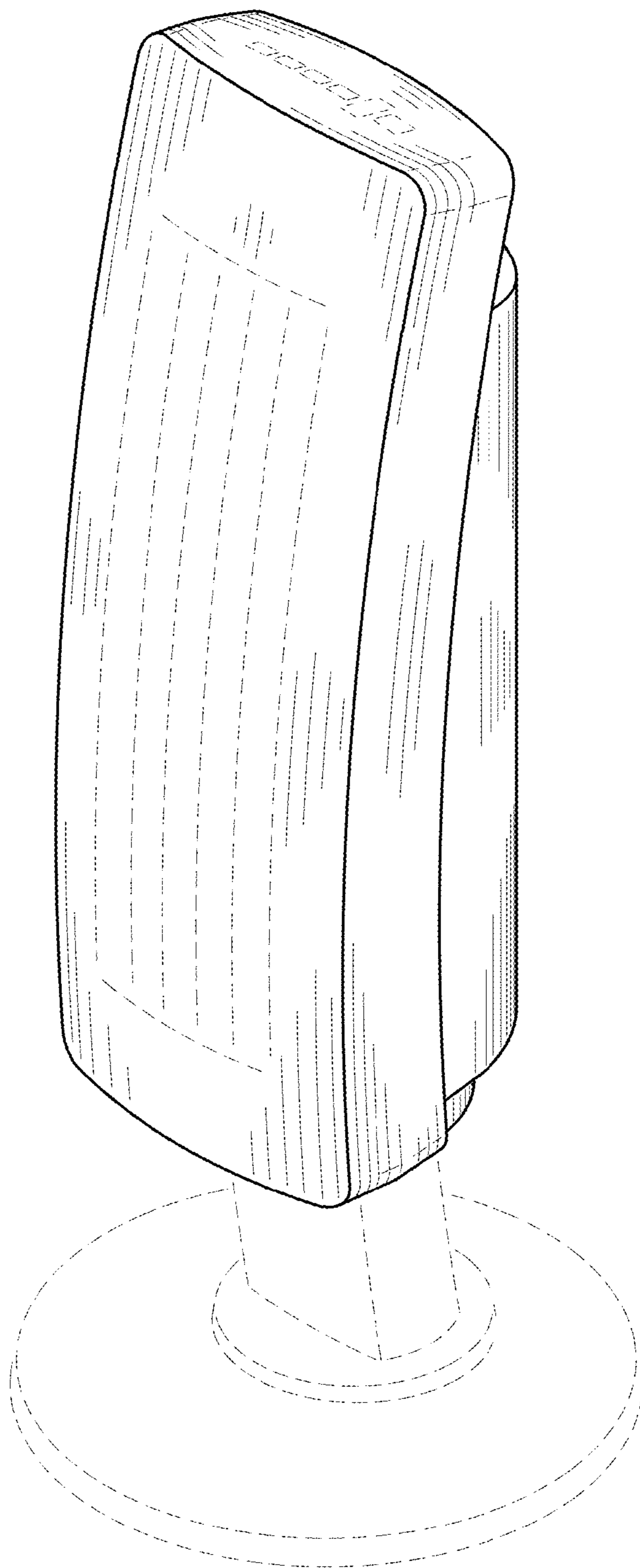
FIG. 7 is an enlarged top plan view thereof.

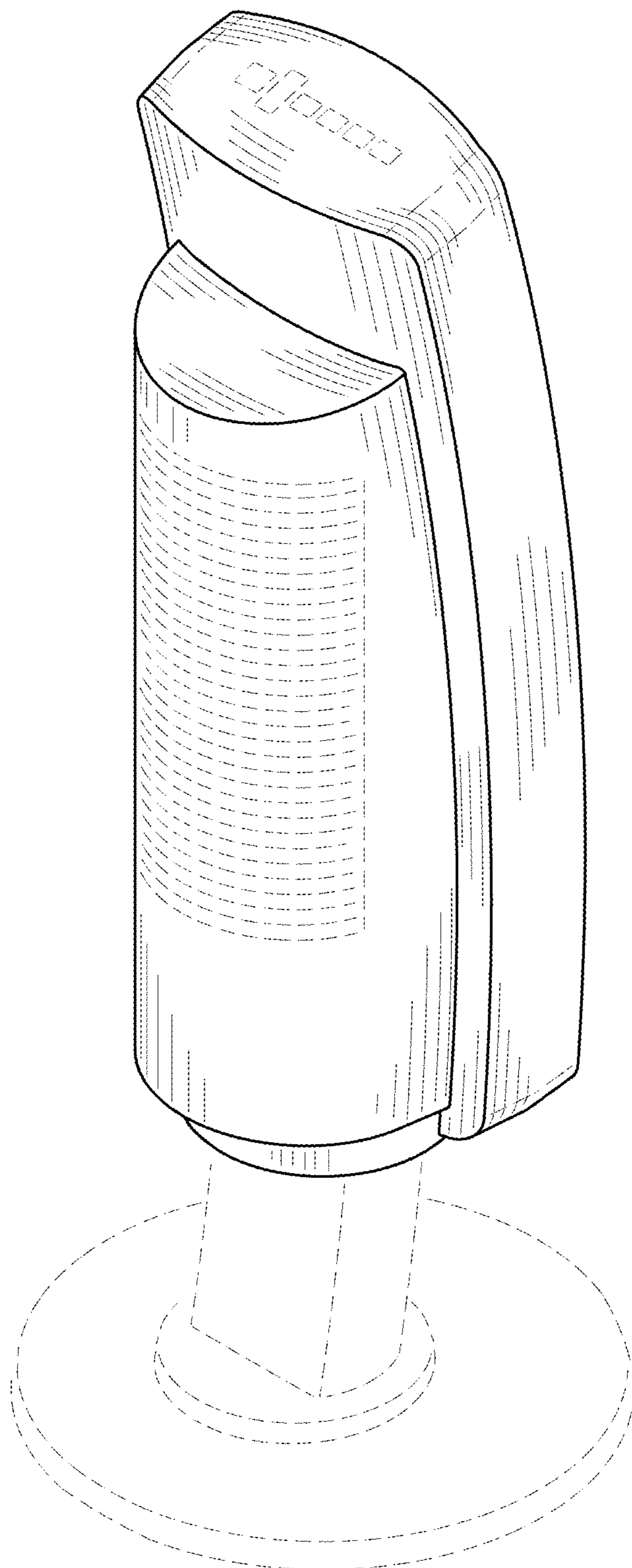
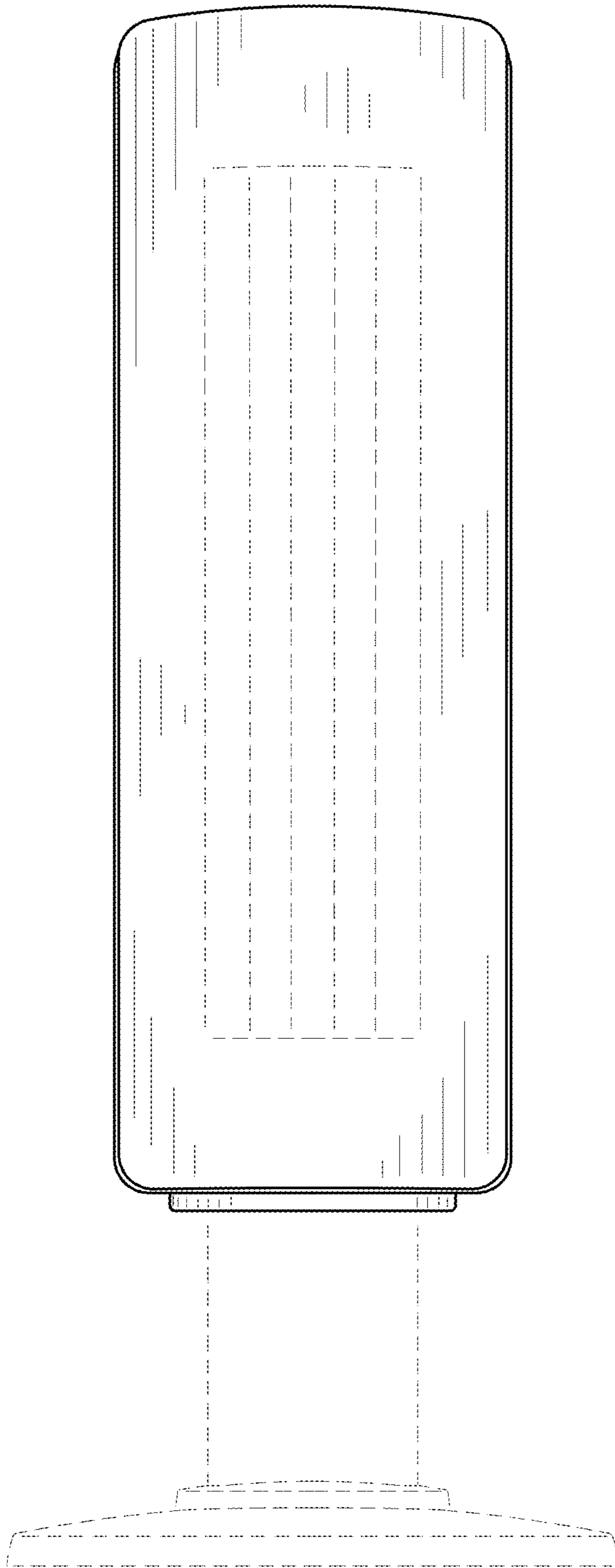

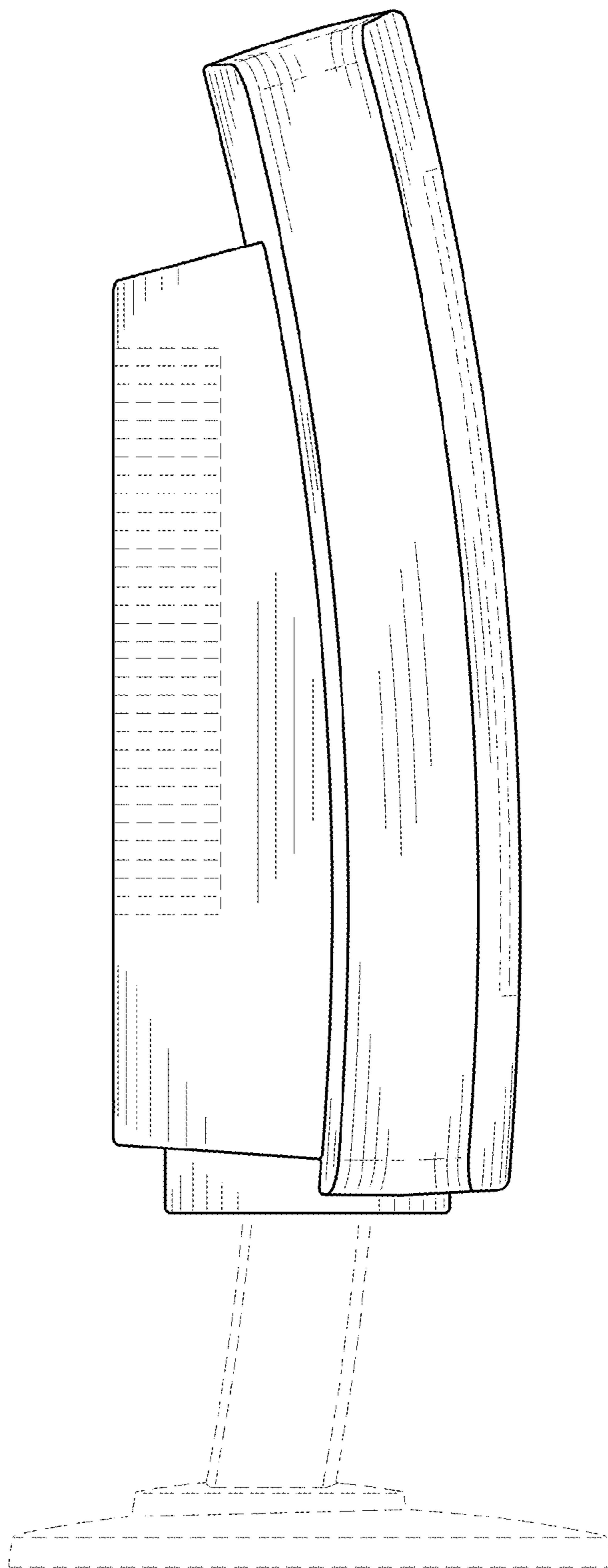

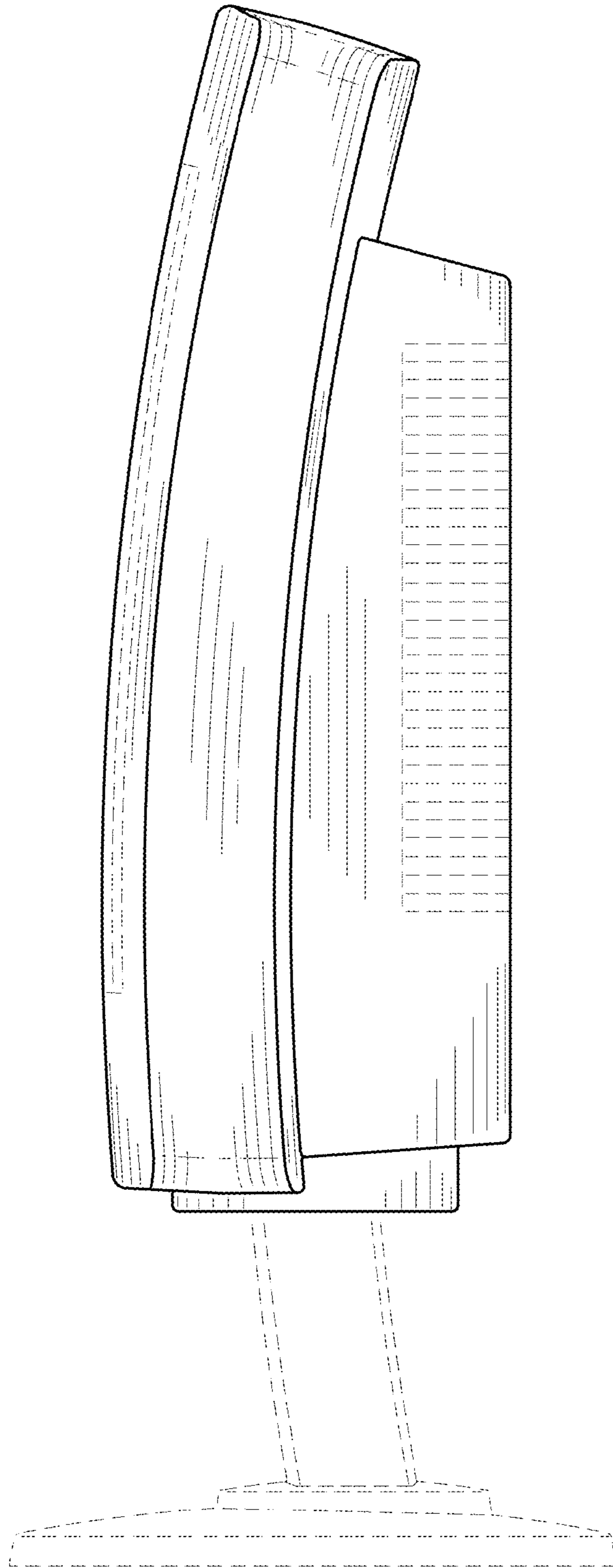

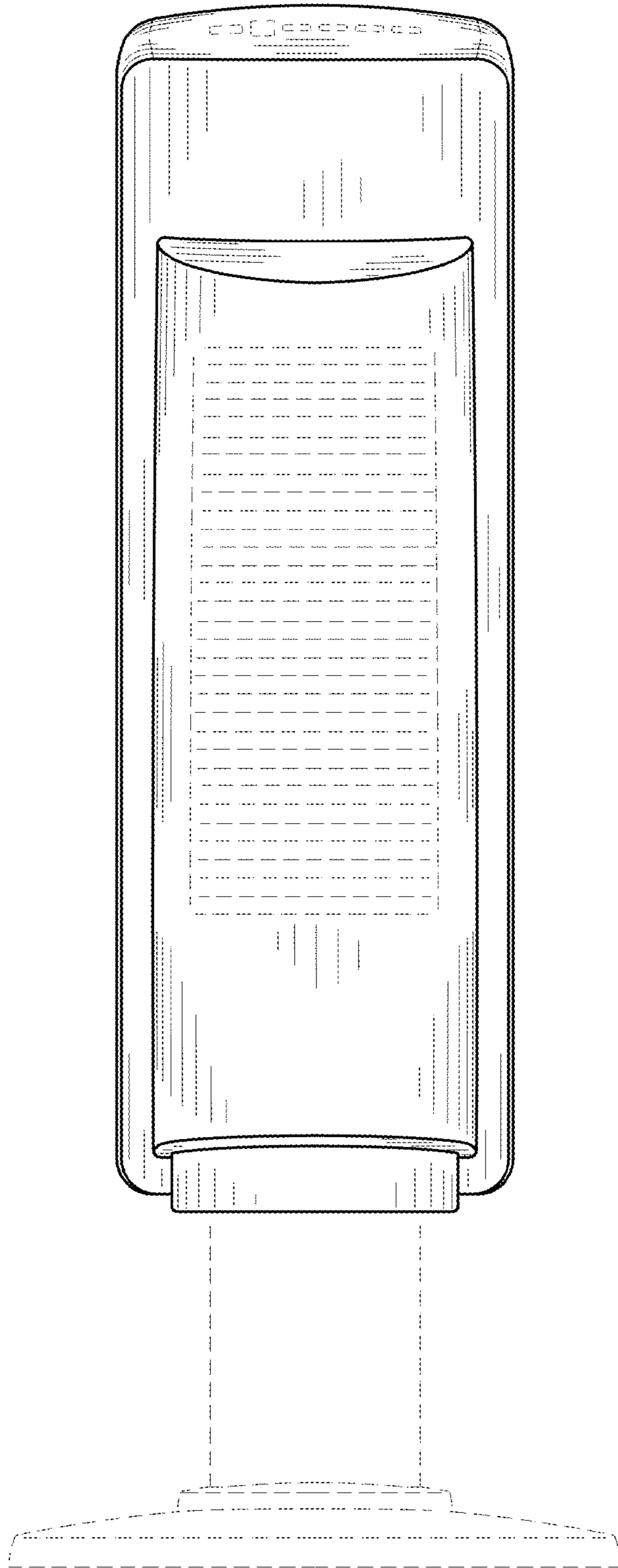

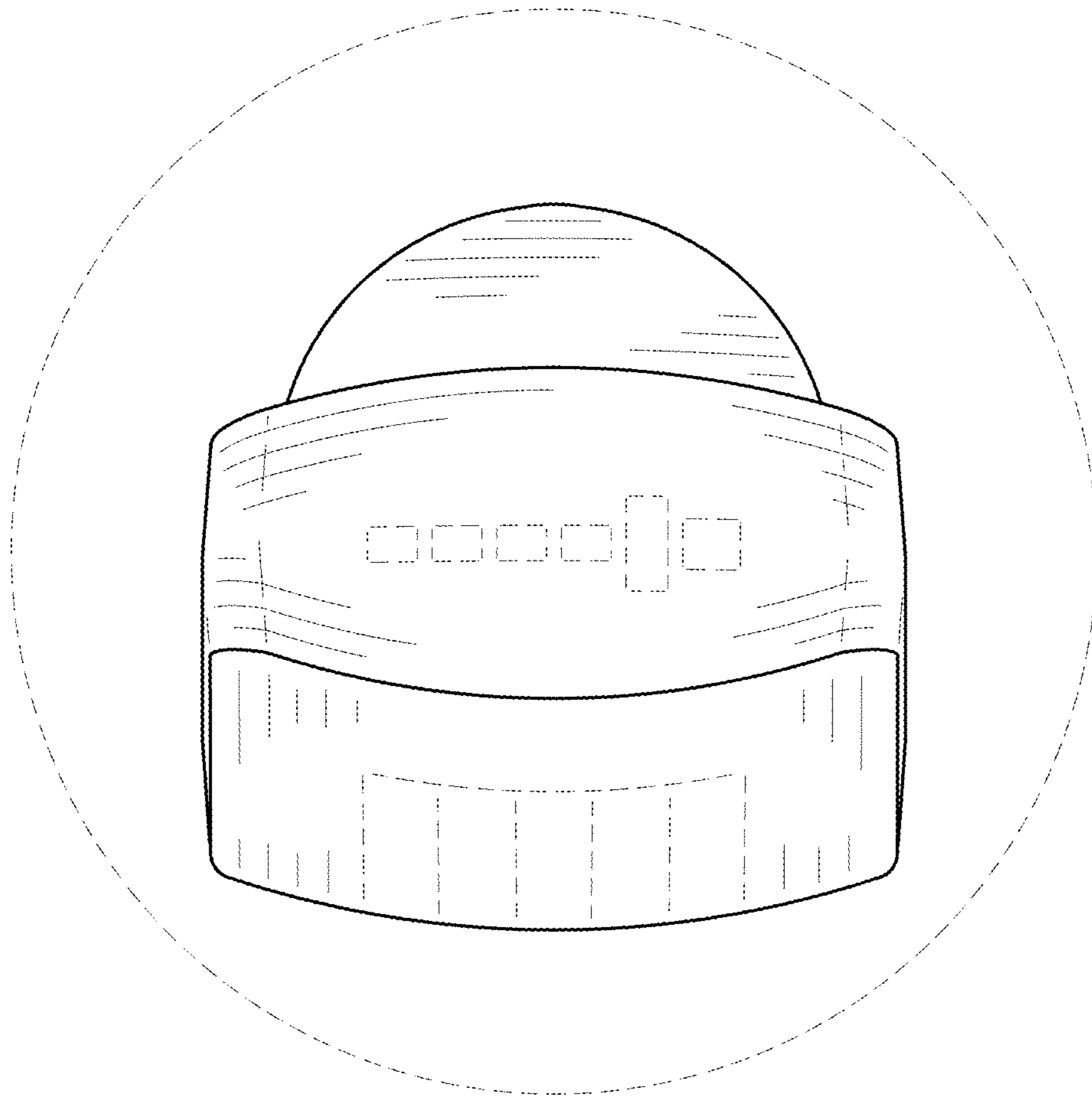
