(57) **CLAIM**

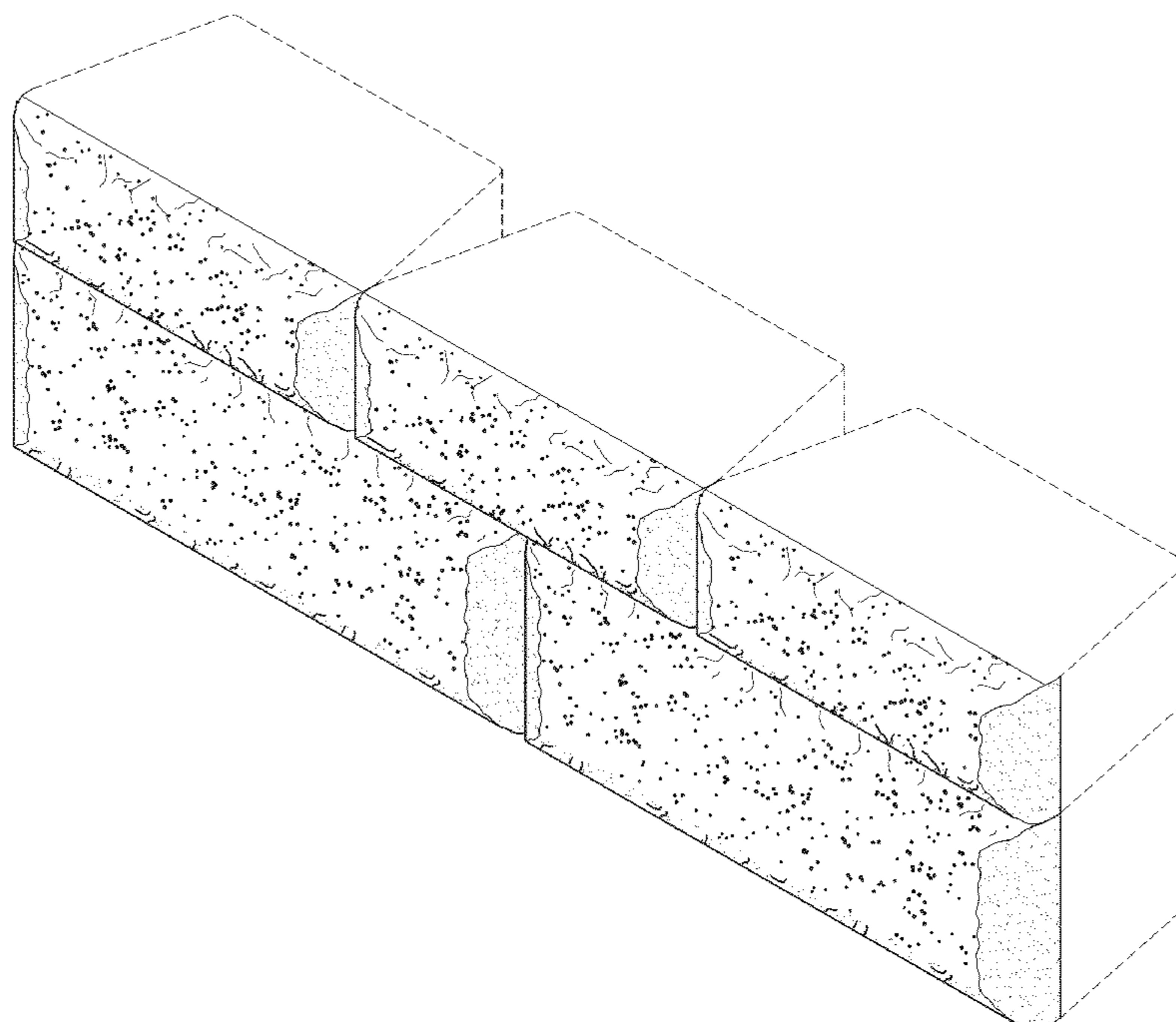
The ornamental design for a front portion of a retaining wall,

DESCRIPTION

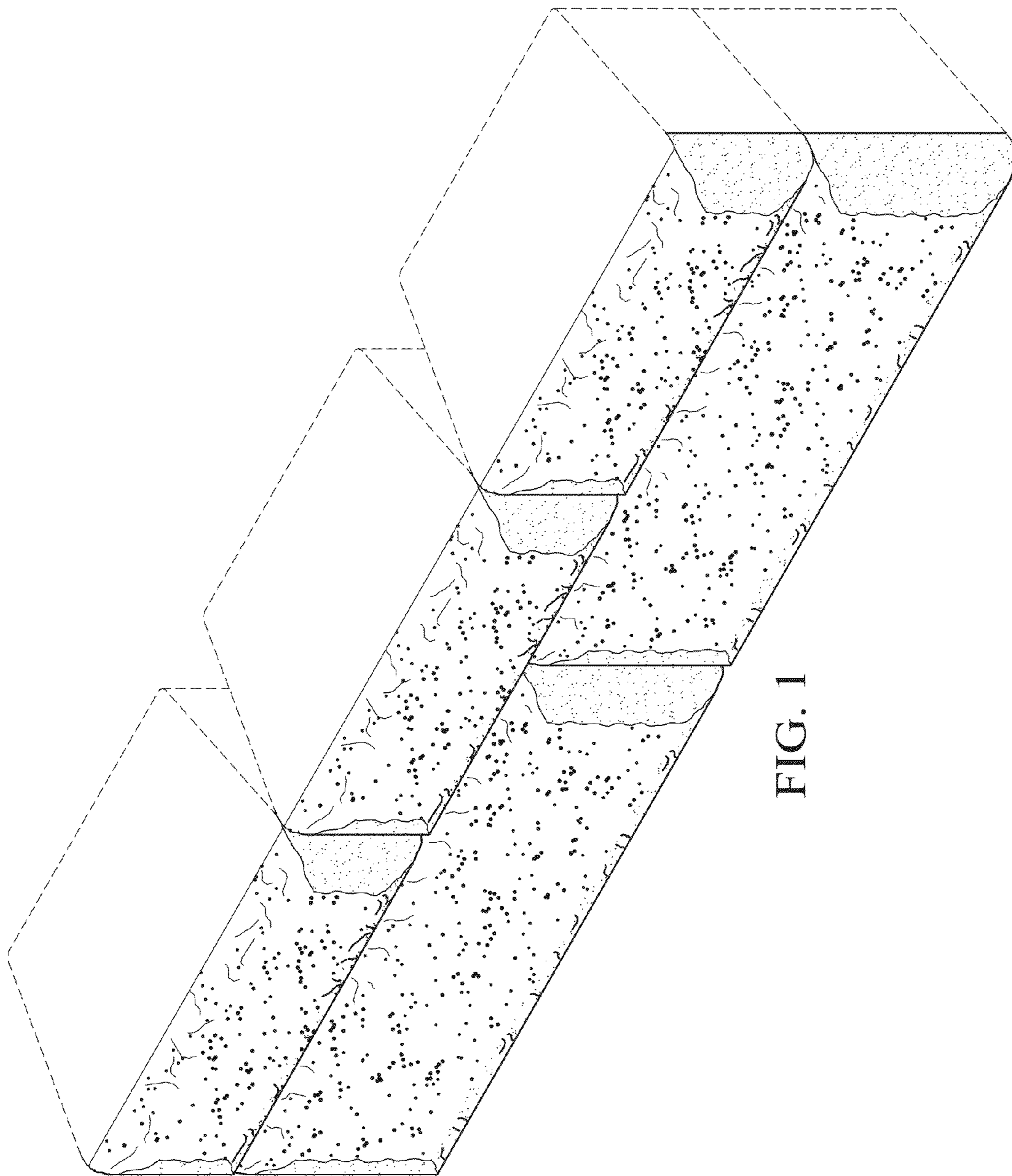

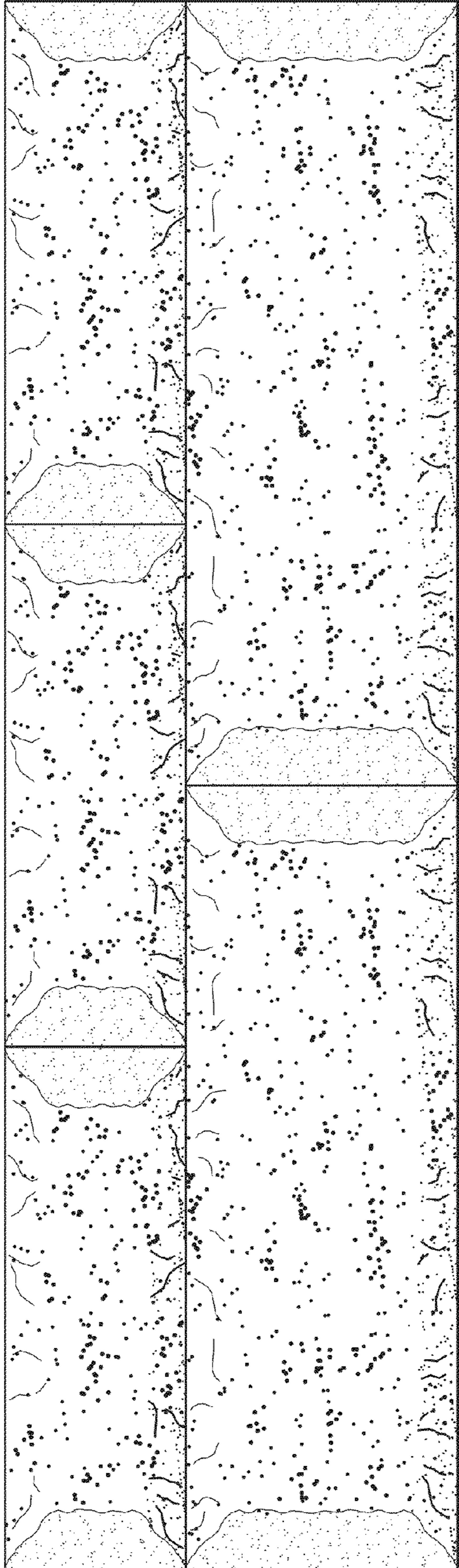
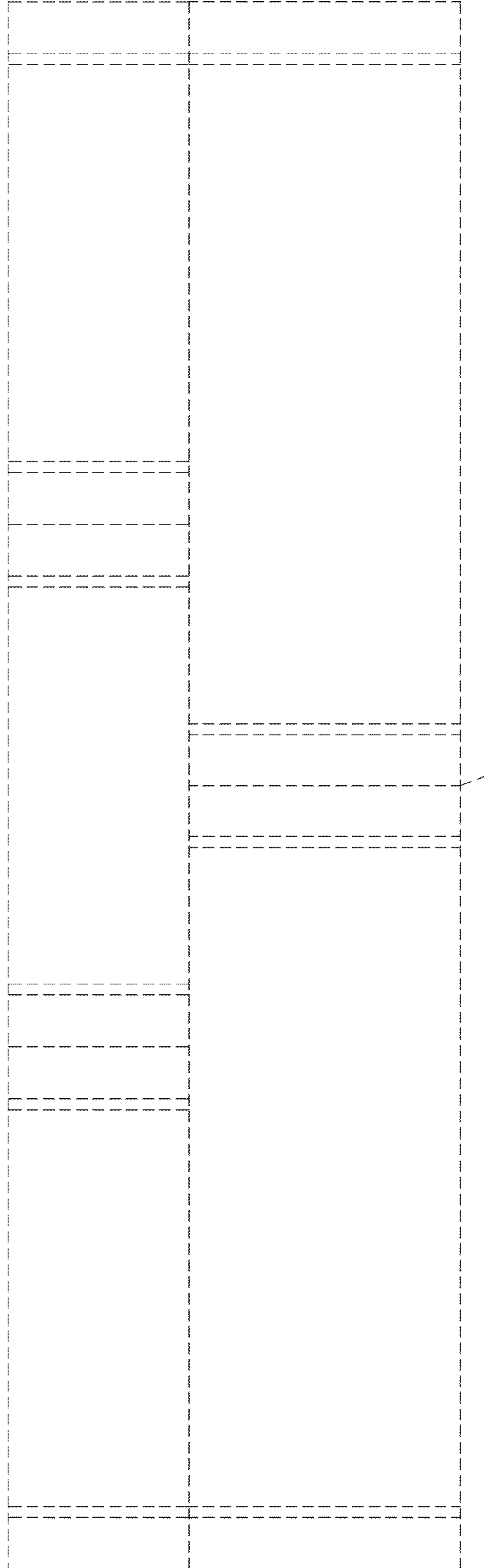

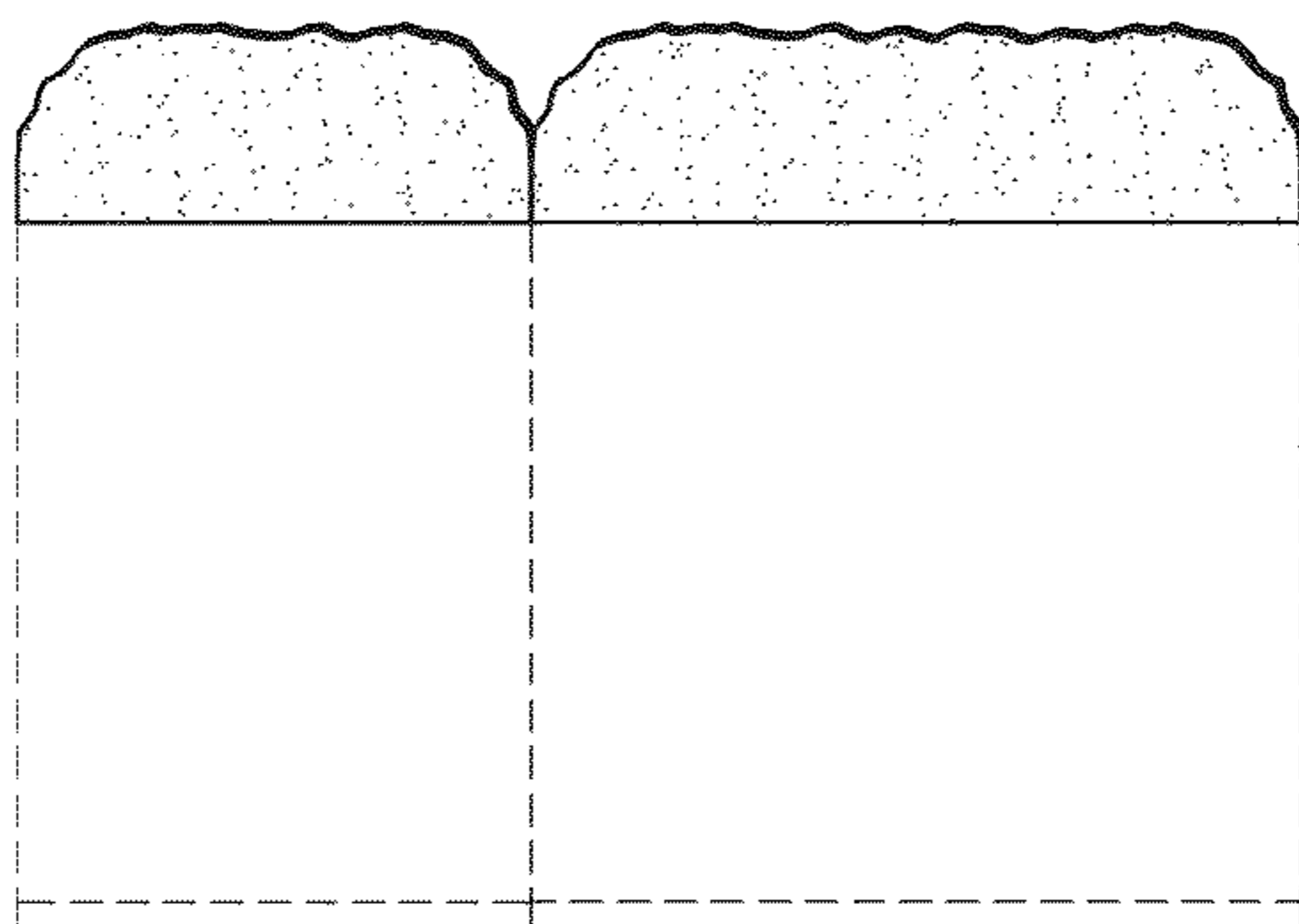

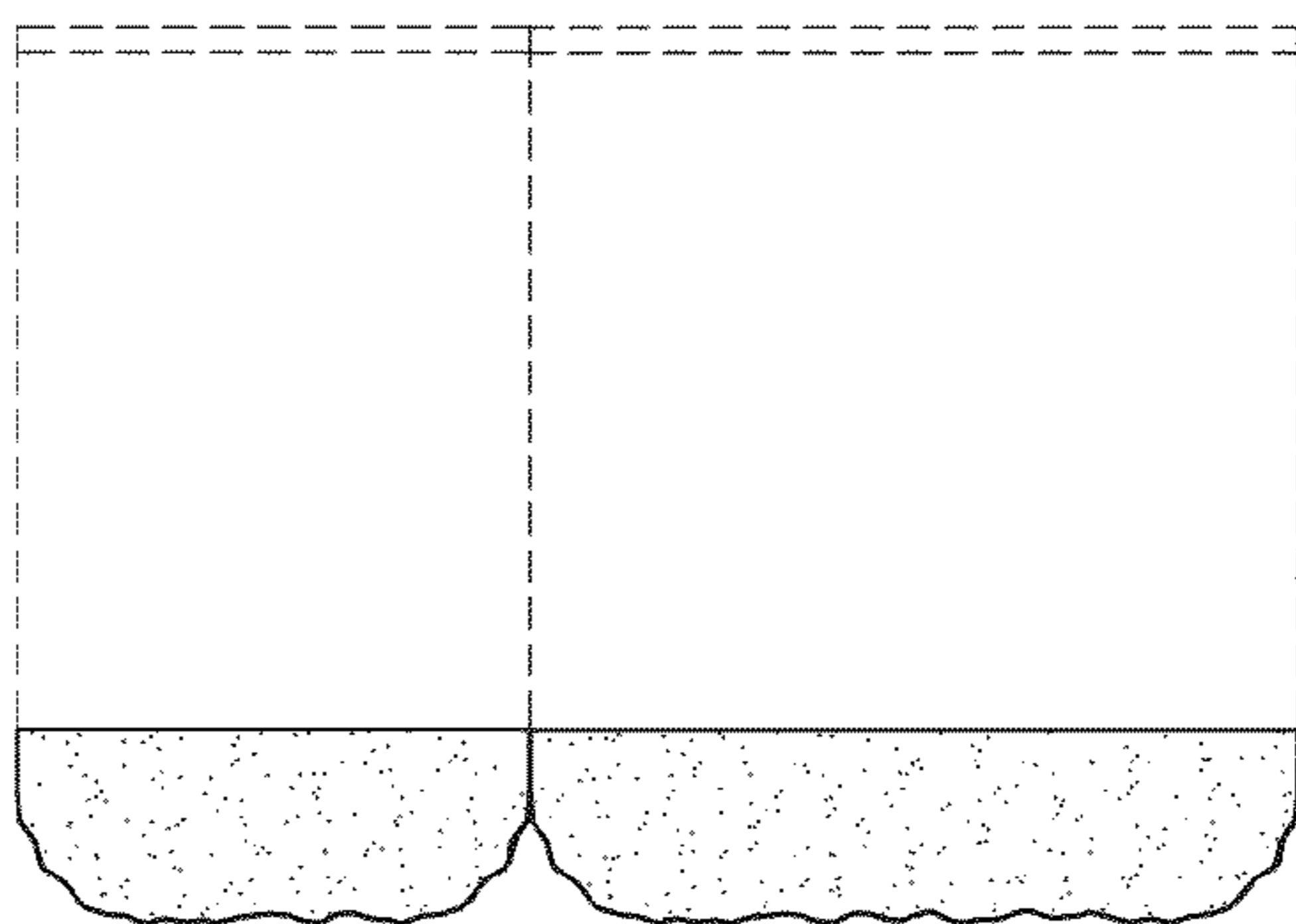

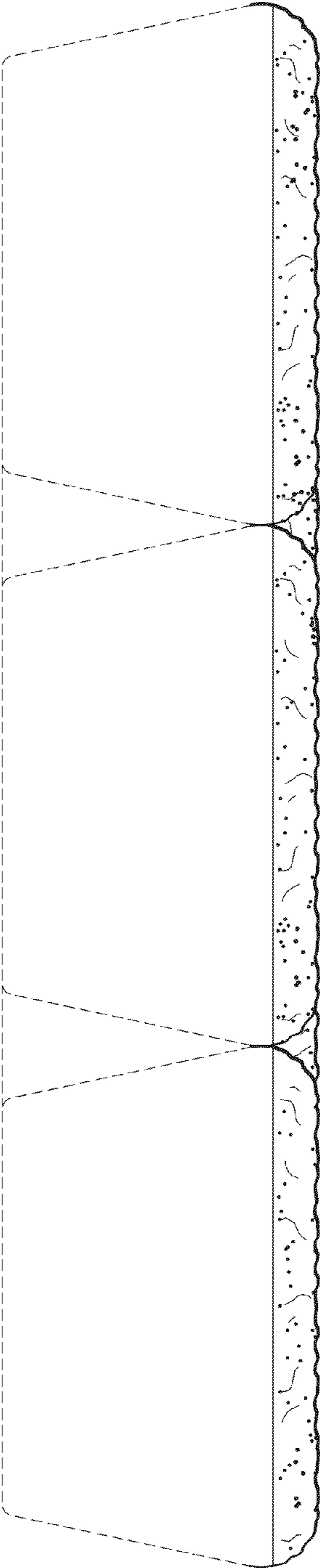

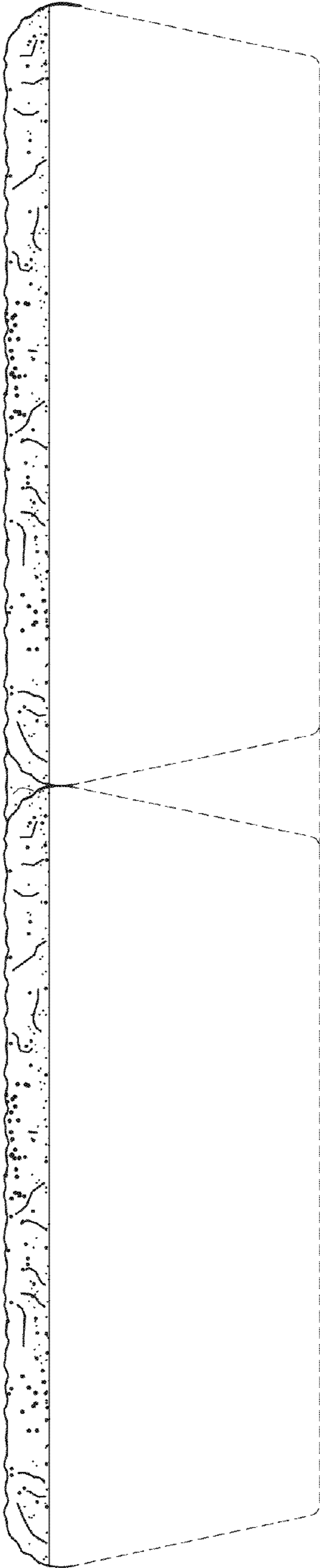
